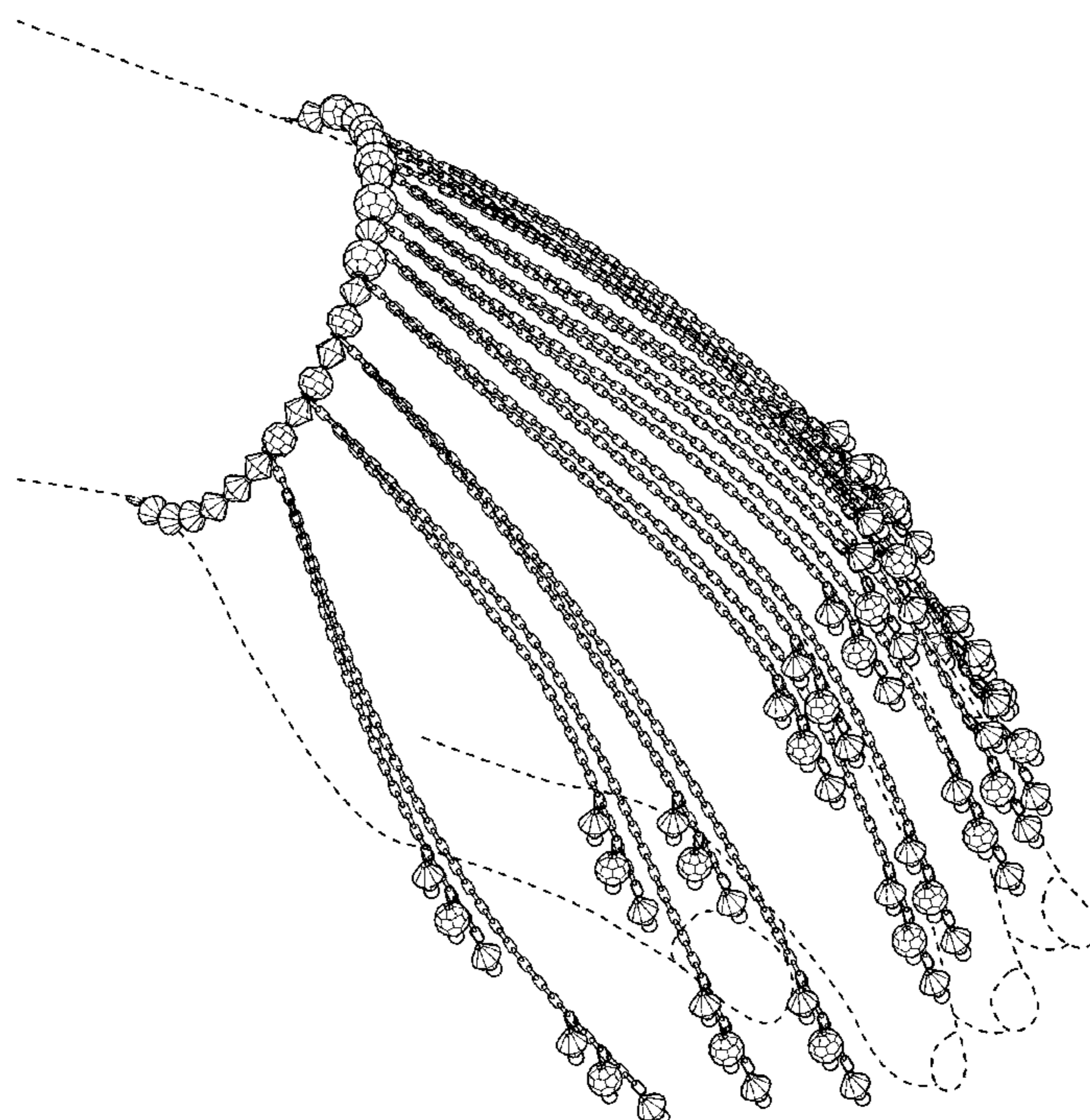
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, side perspective view of a bracelet, showing my new design in an environment of use.

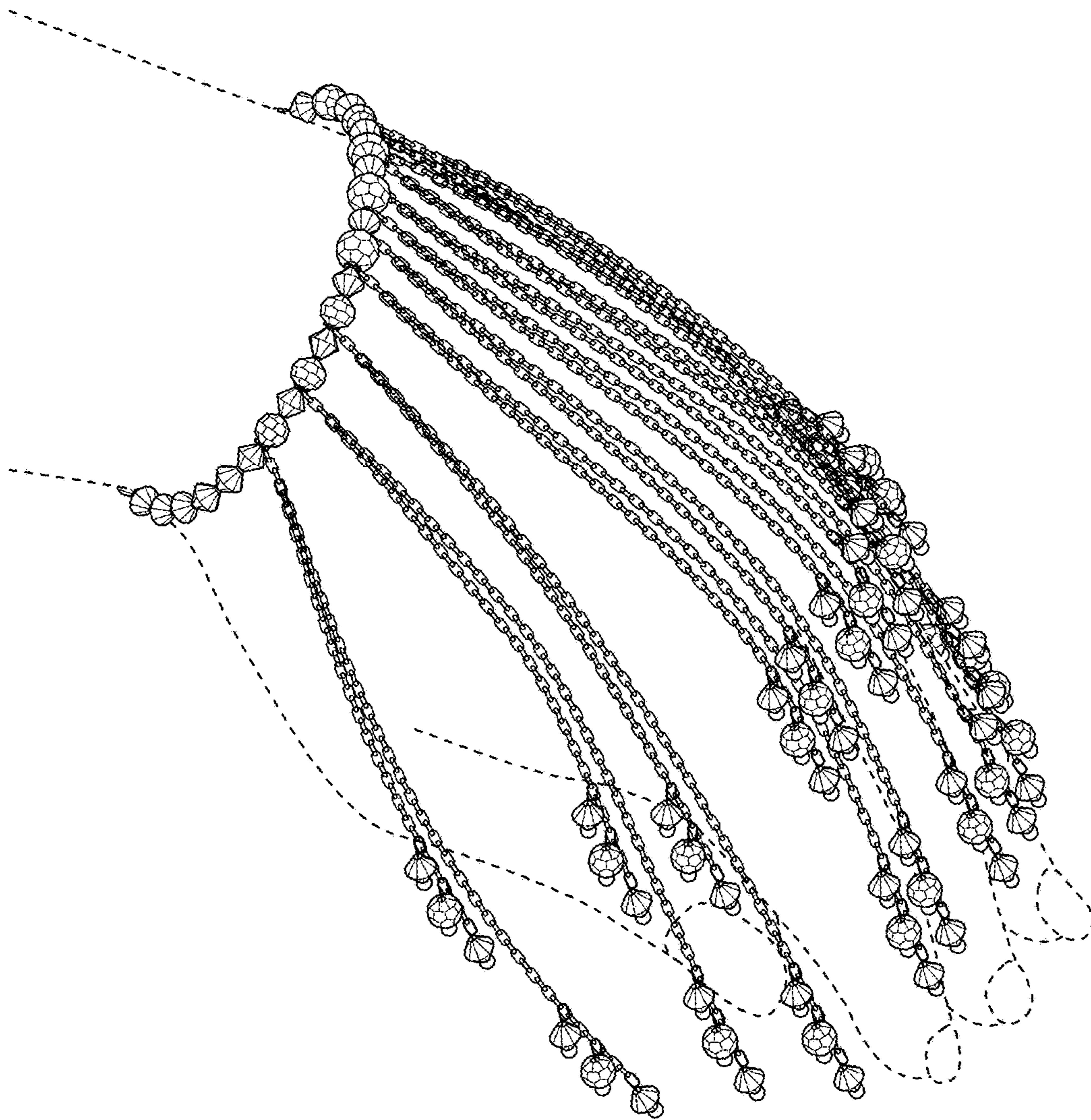

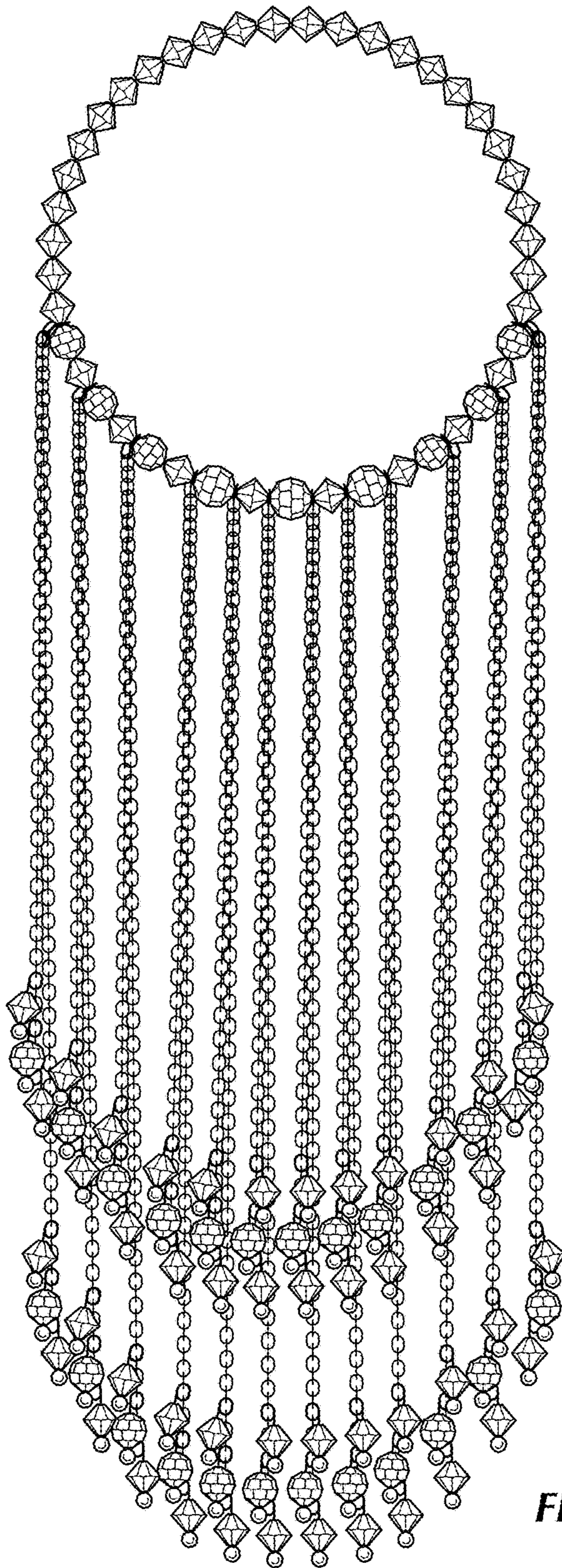

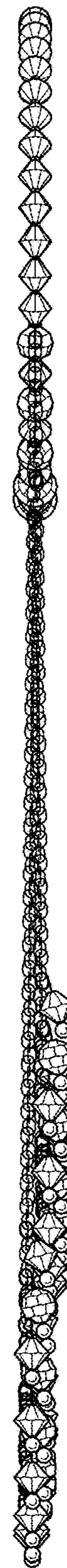

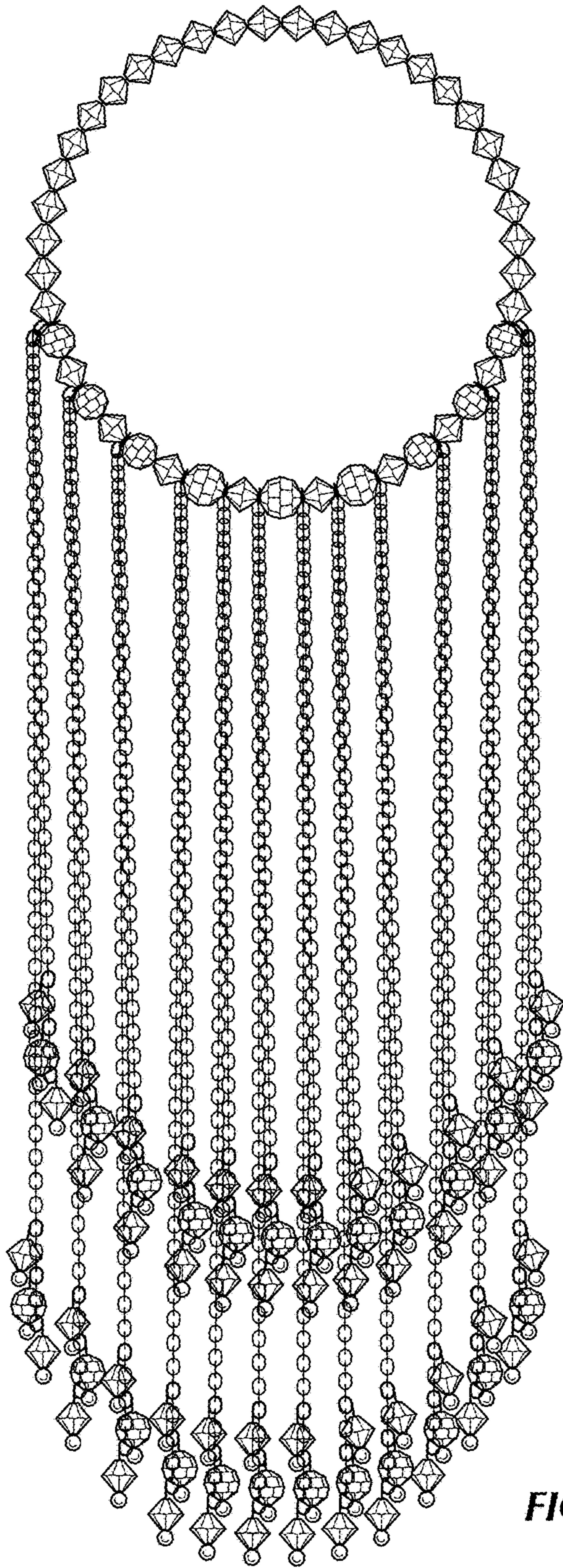

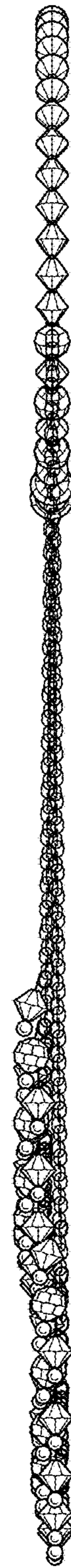

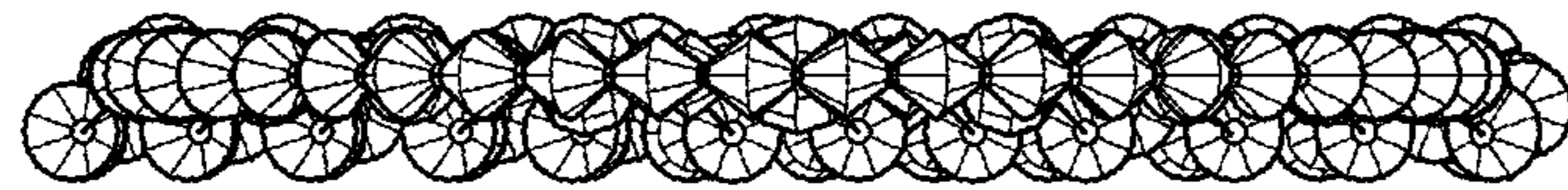

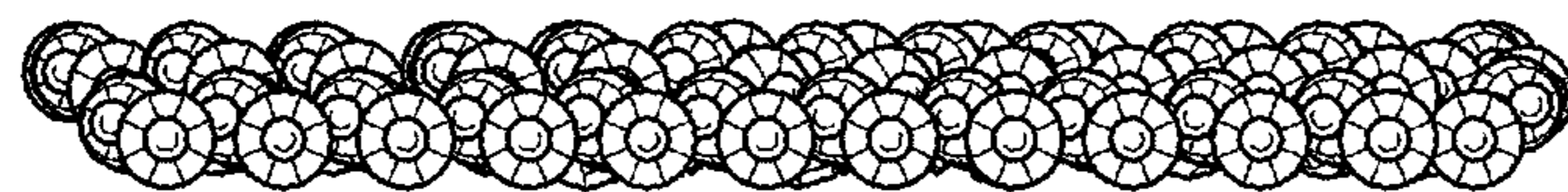
