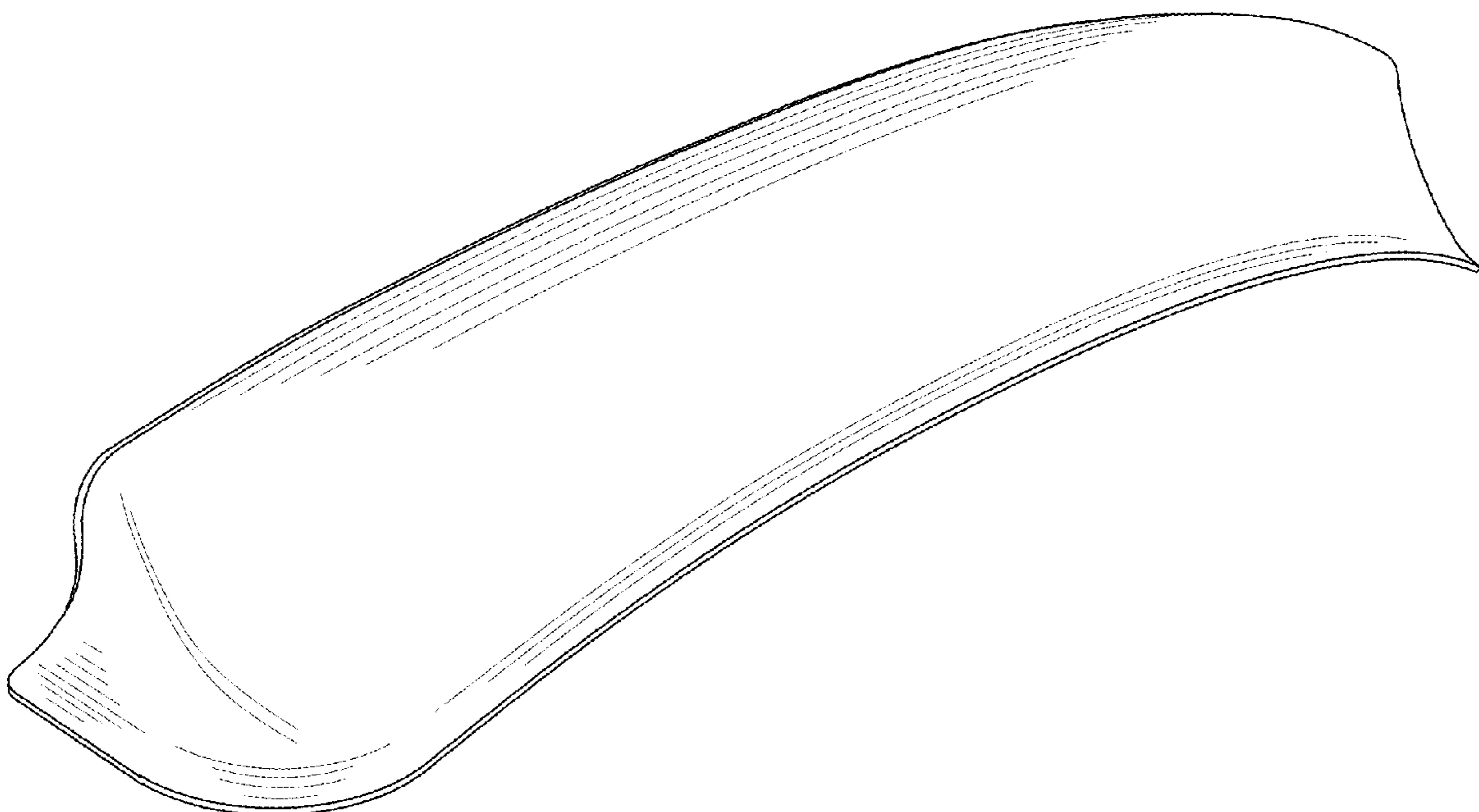
FIG. 1 is top-right perspective view of an automobile rear

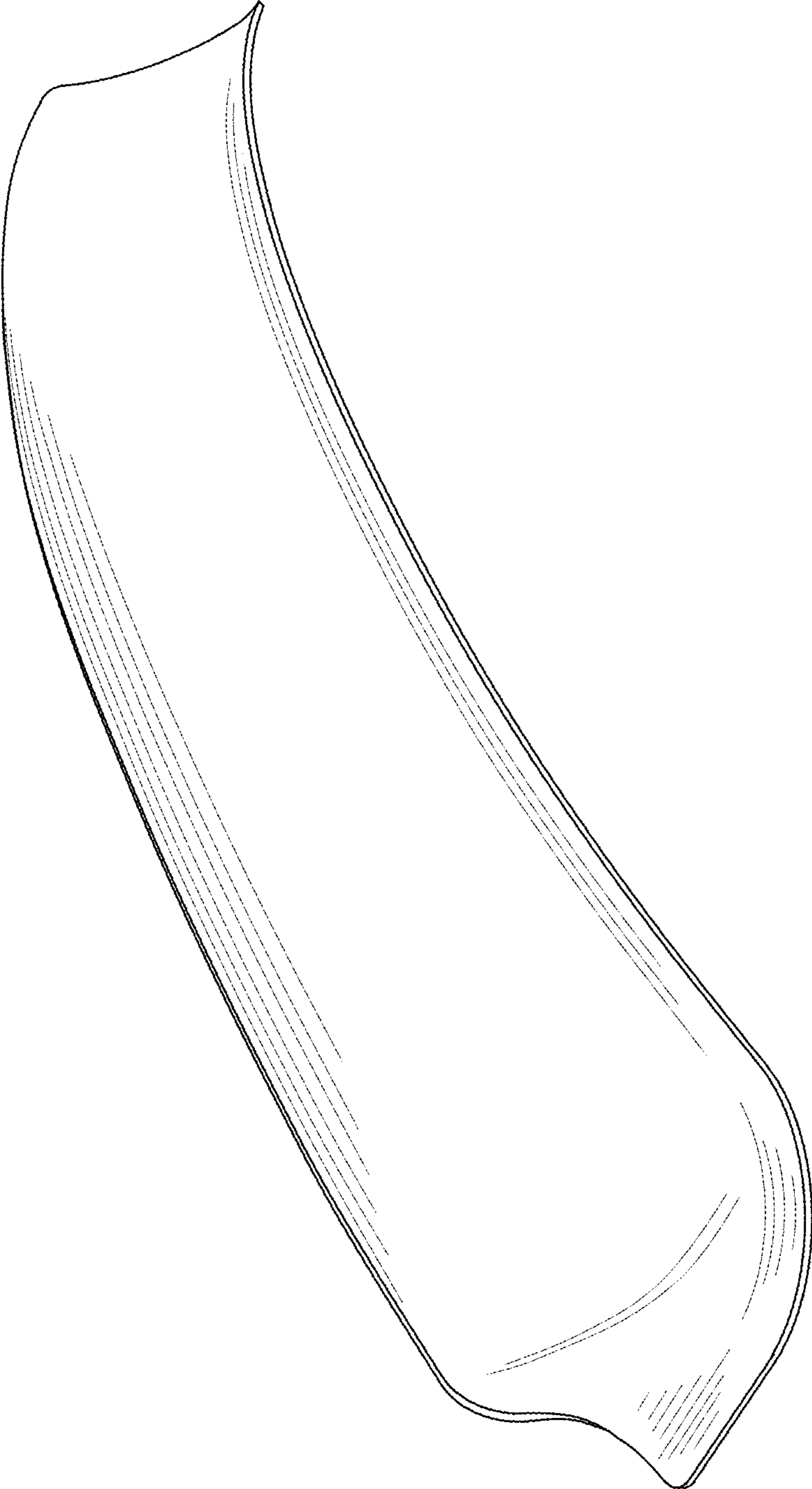

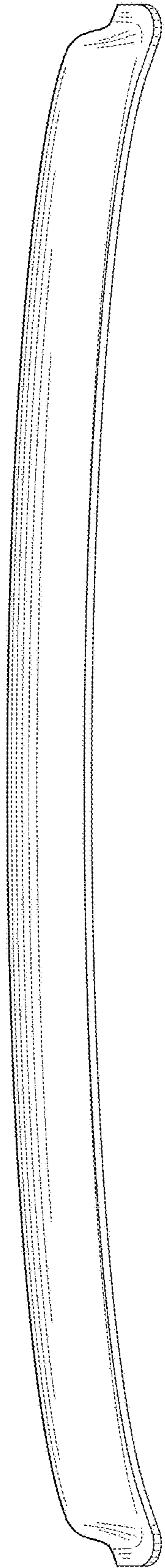

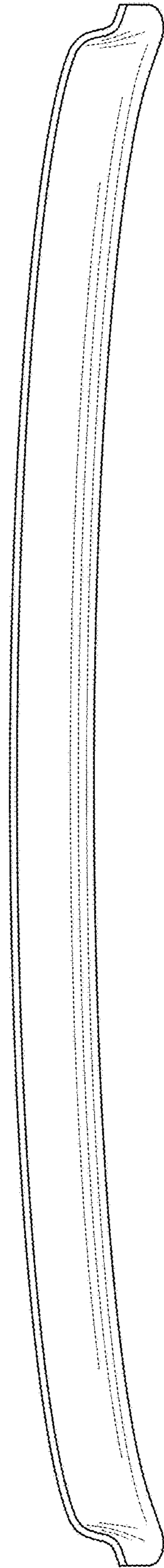

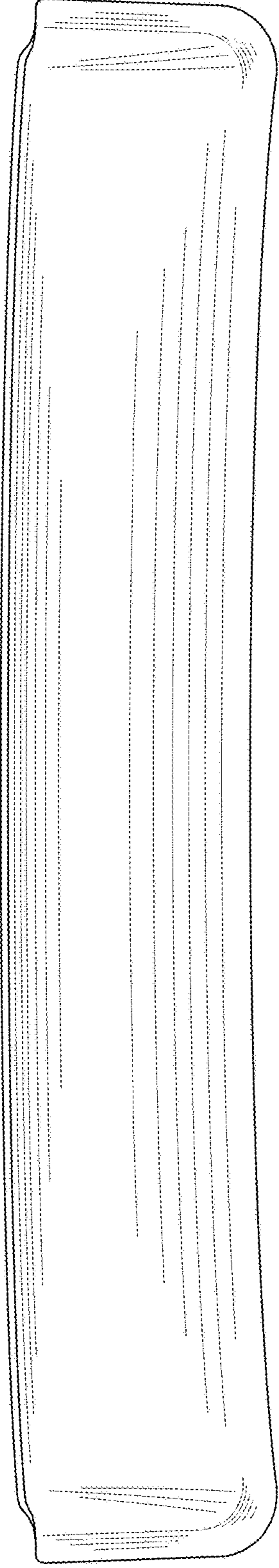

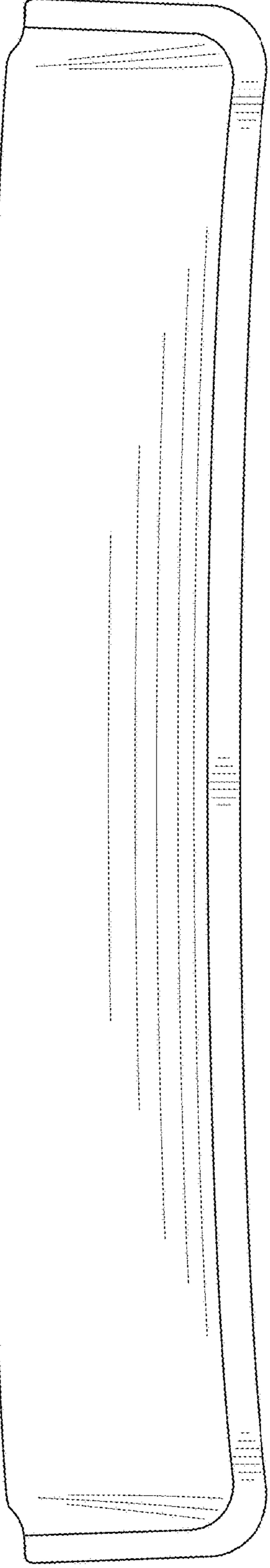

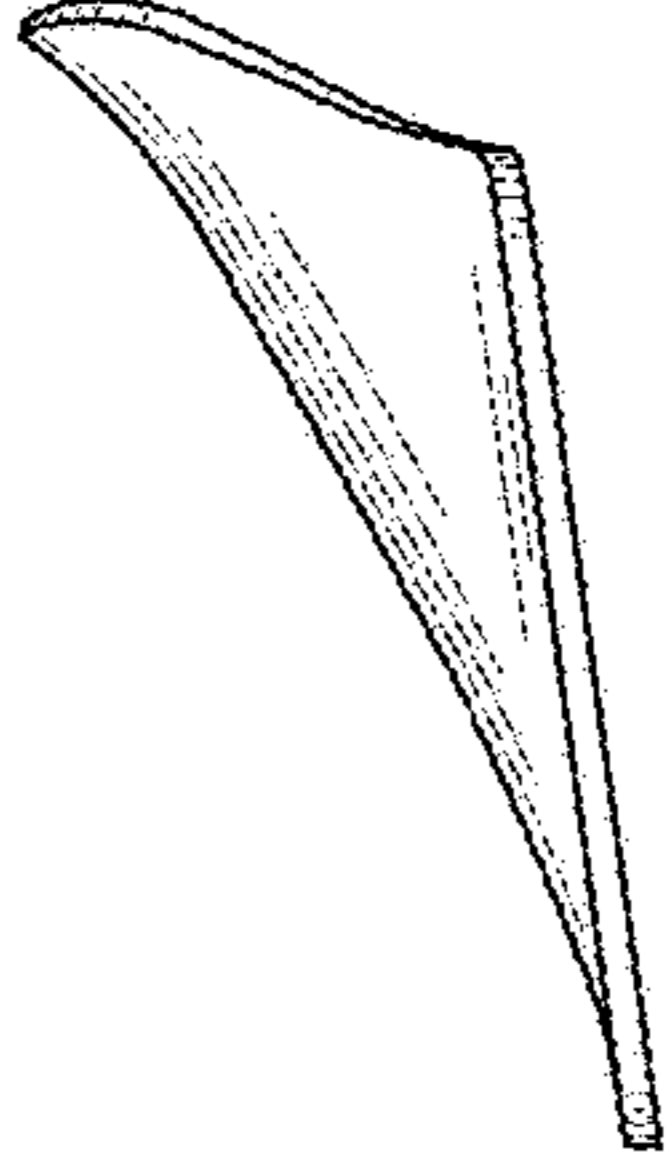

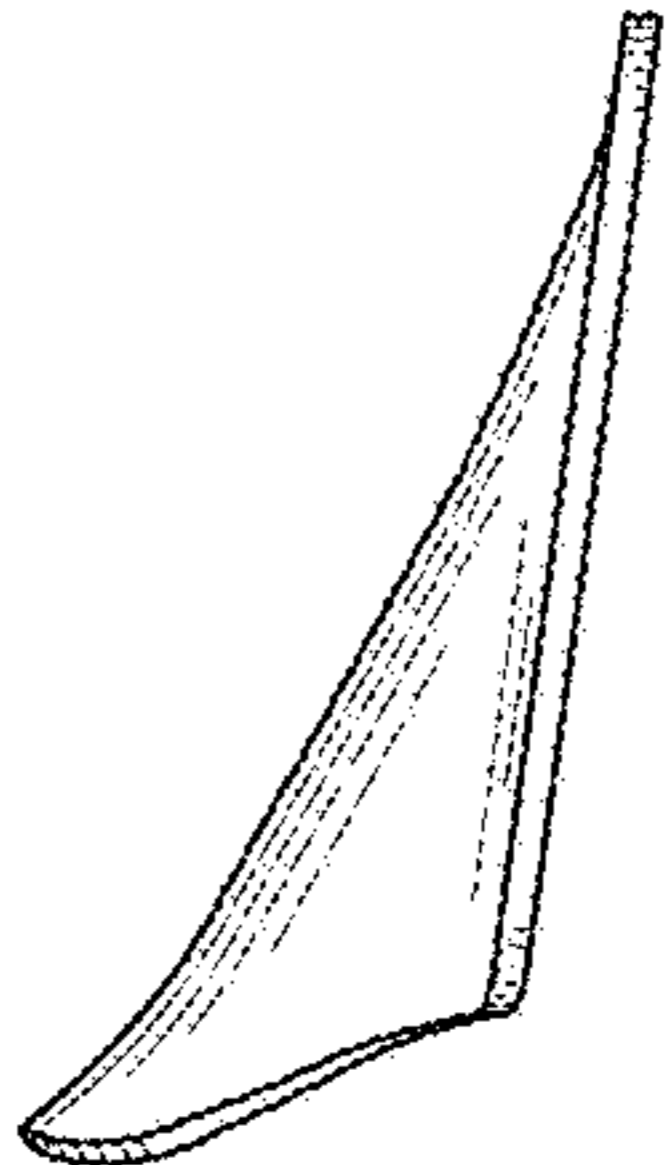
