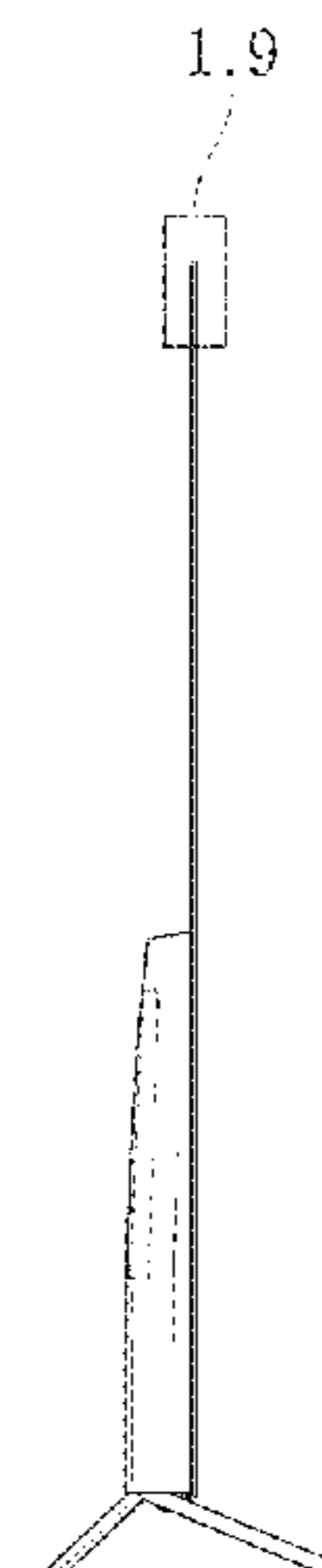
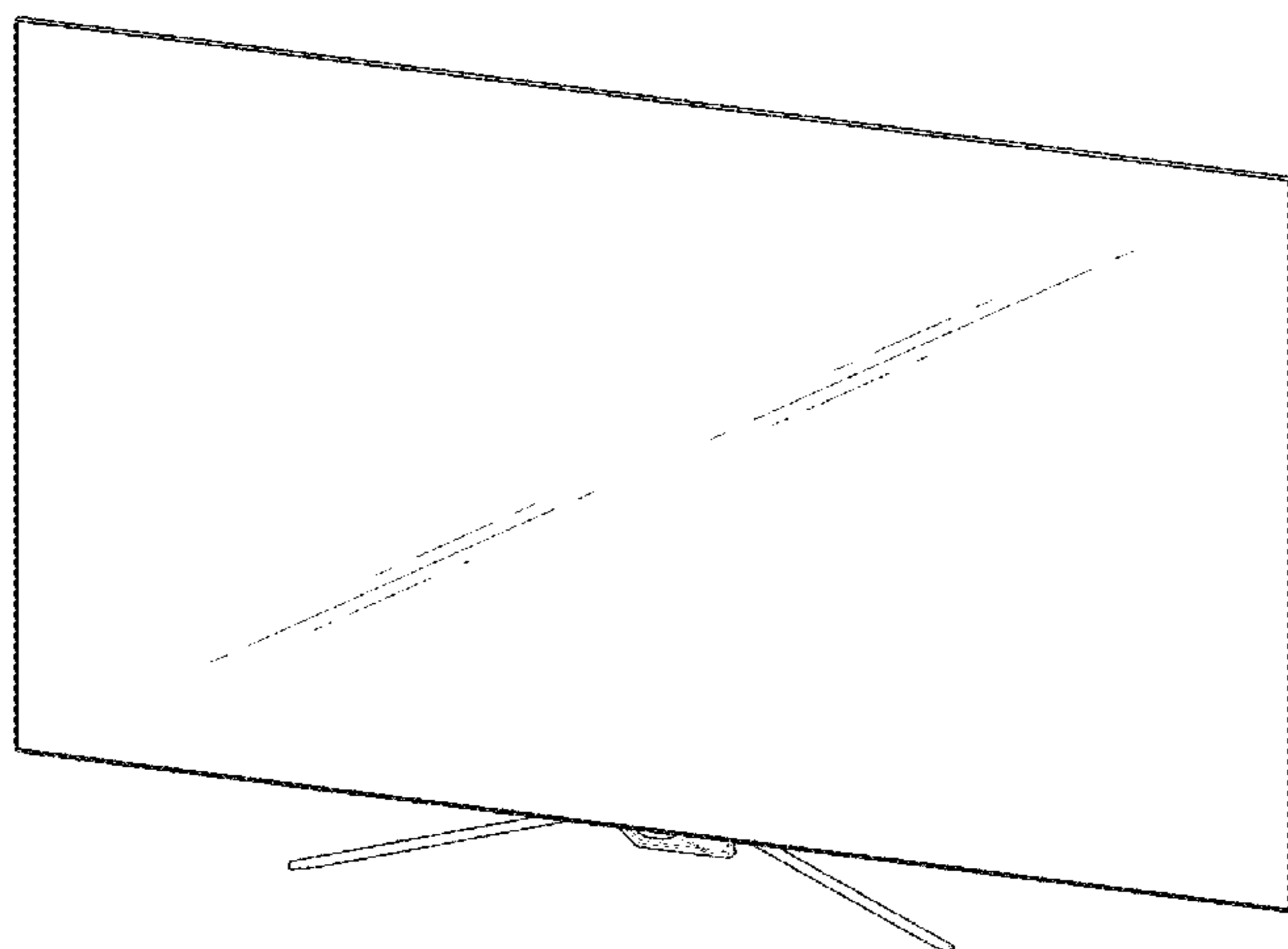
The ornamental design for a TV receiver, as shown and described.

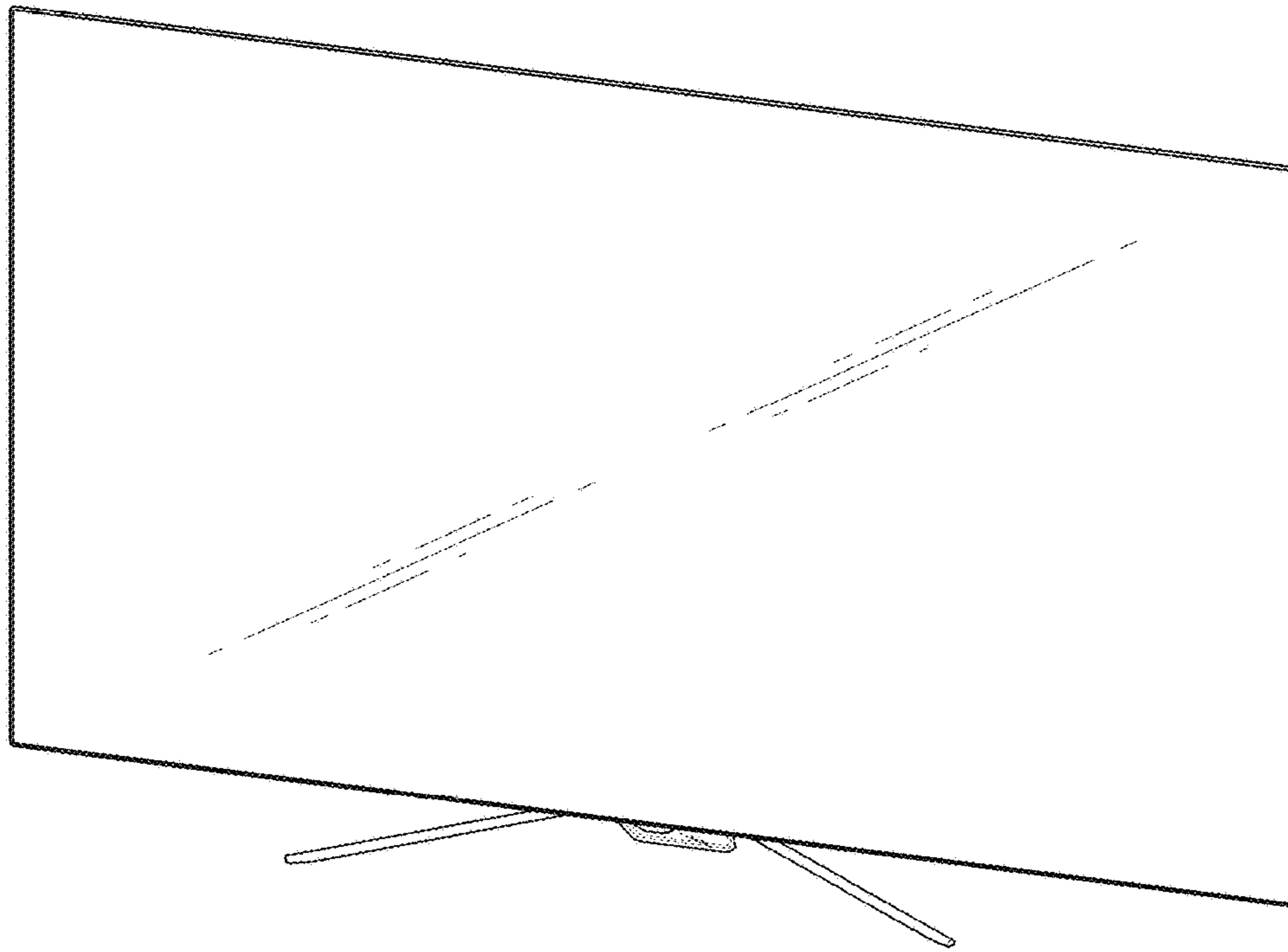

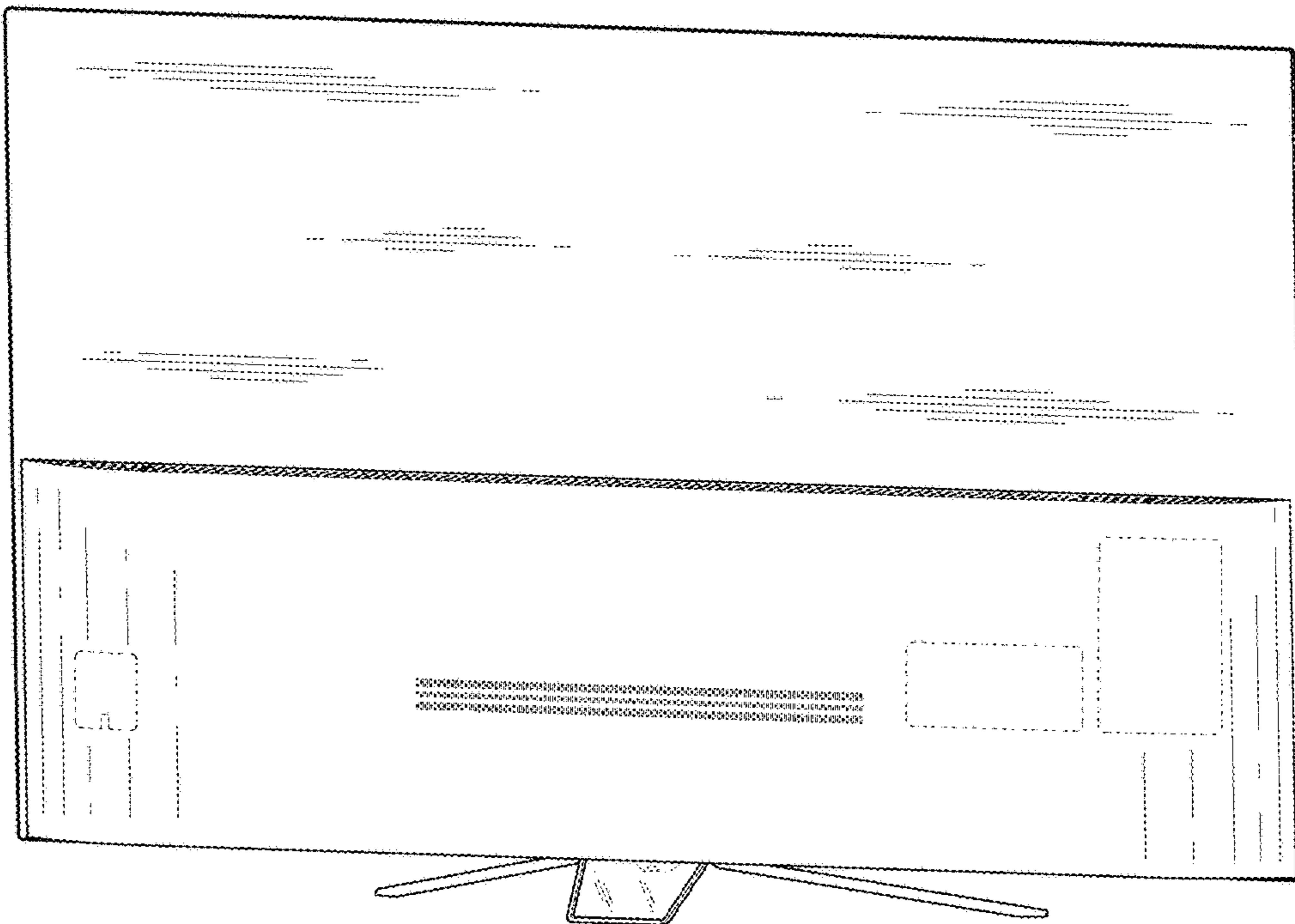

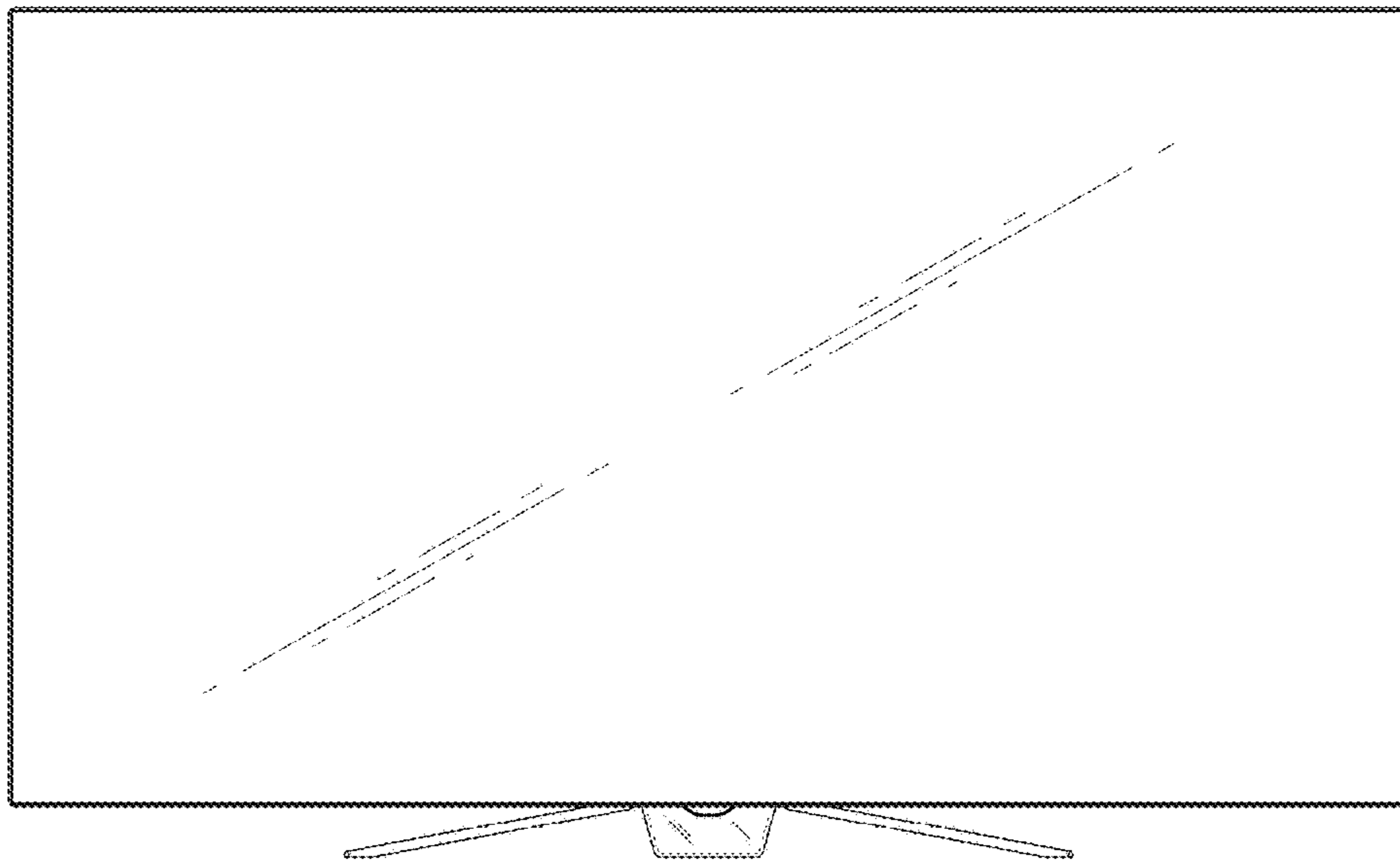

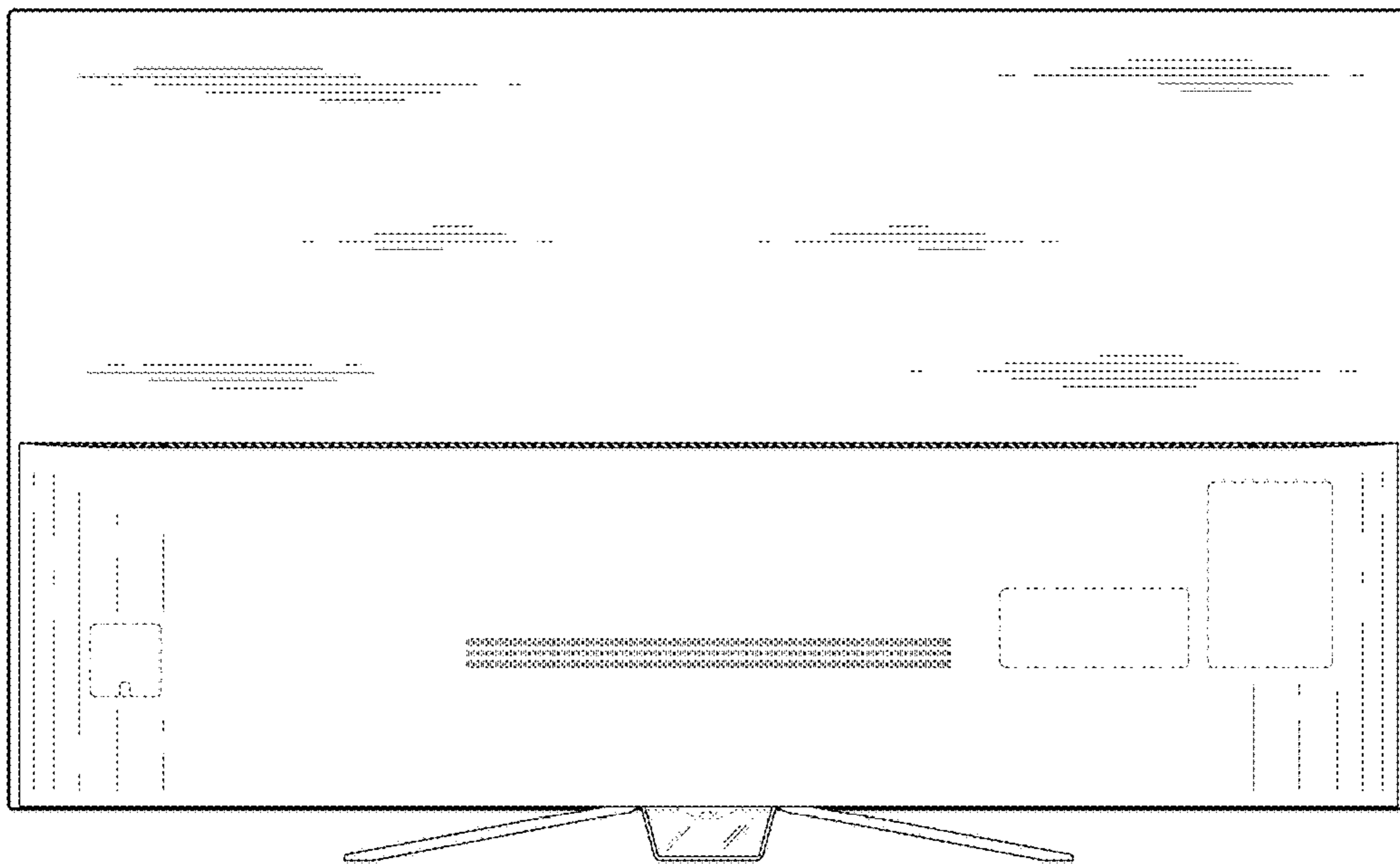

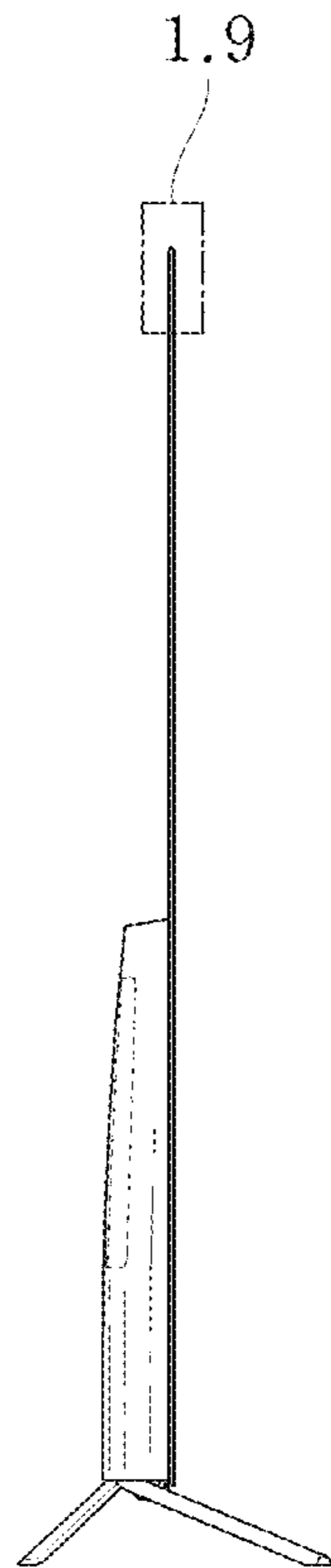

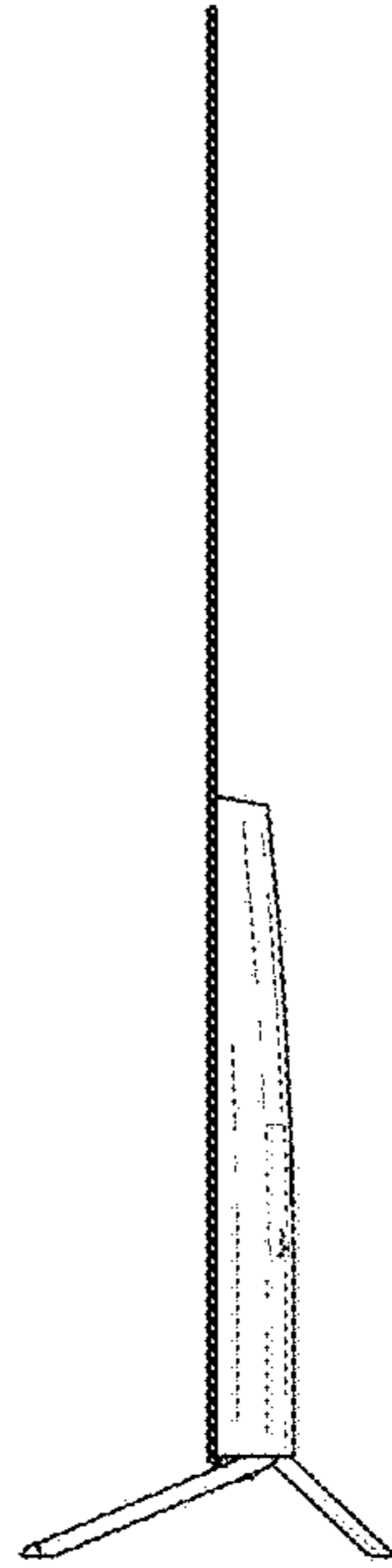

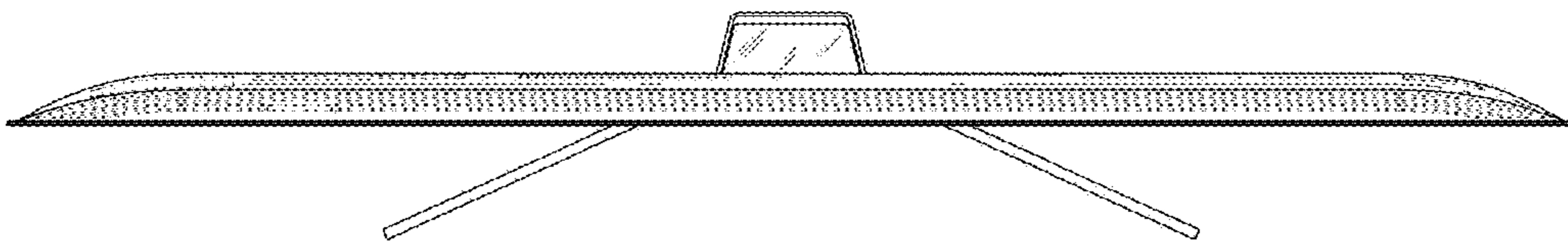

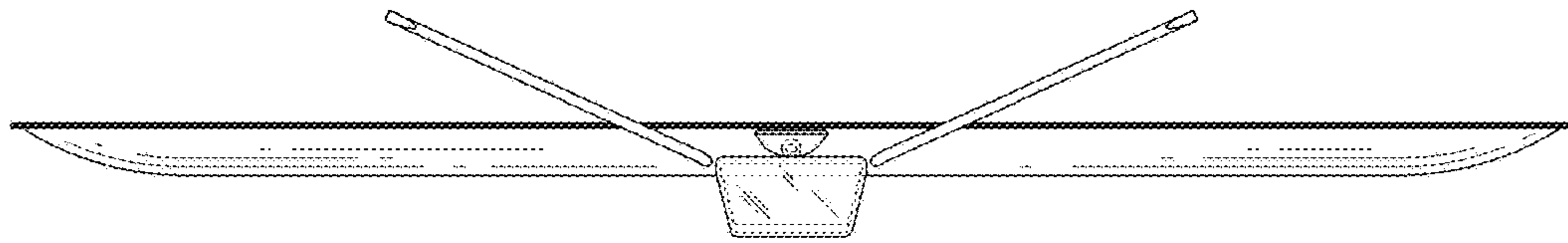
