(57) **CLAIM**

The ornamental design for a computer mouse, substantially as shown.

DESCRIPTION

FIG. 1 is a view in perspective of a computer mouse viewed from the front left quarter and showing my new design; FIG. 2 is a view in perspective thereof viewed from the rear left quarter; FIG. 3 is a view in rear elevation thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a view in front elevation thereof; FIG. 6 is a view in right side elevation thereof; FIG. 7 is a view in left side elevation thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a view in perspective thereof viewed from the rear left quarter; and, FIG. 10 is view in perspective thereof viewed from the front right quarter.

The broken line forms no part of the claimed design.

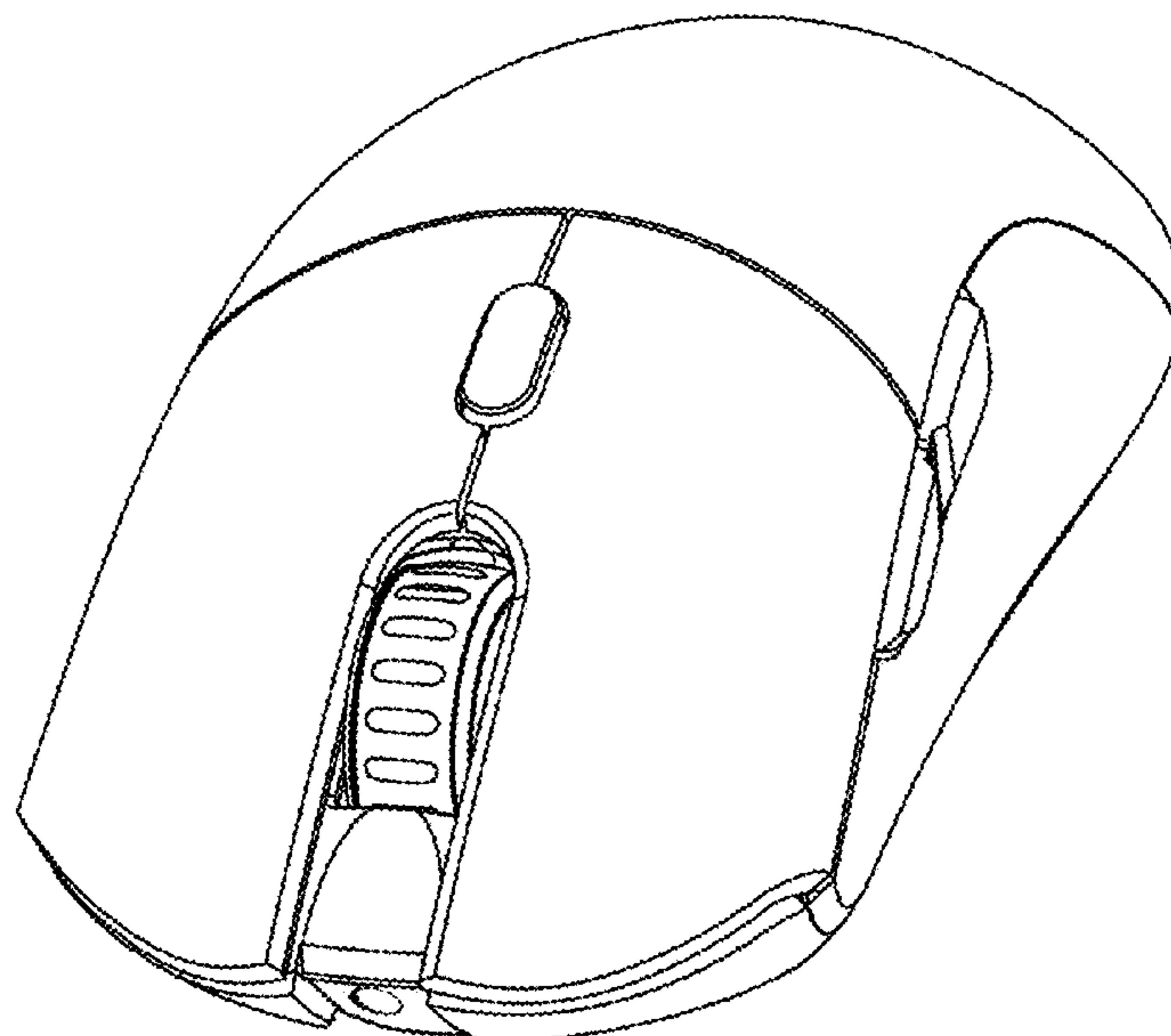

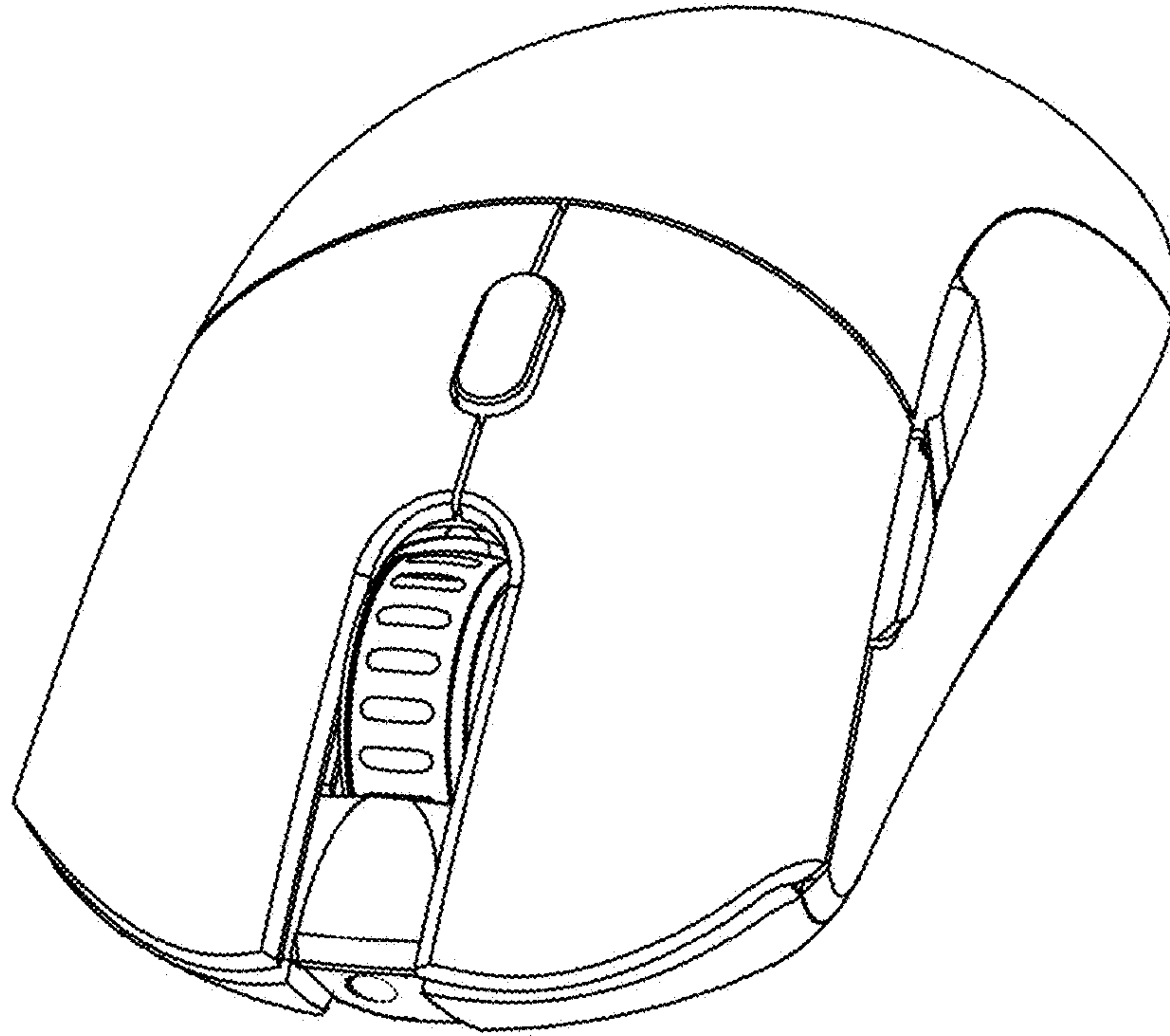

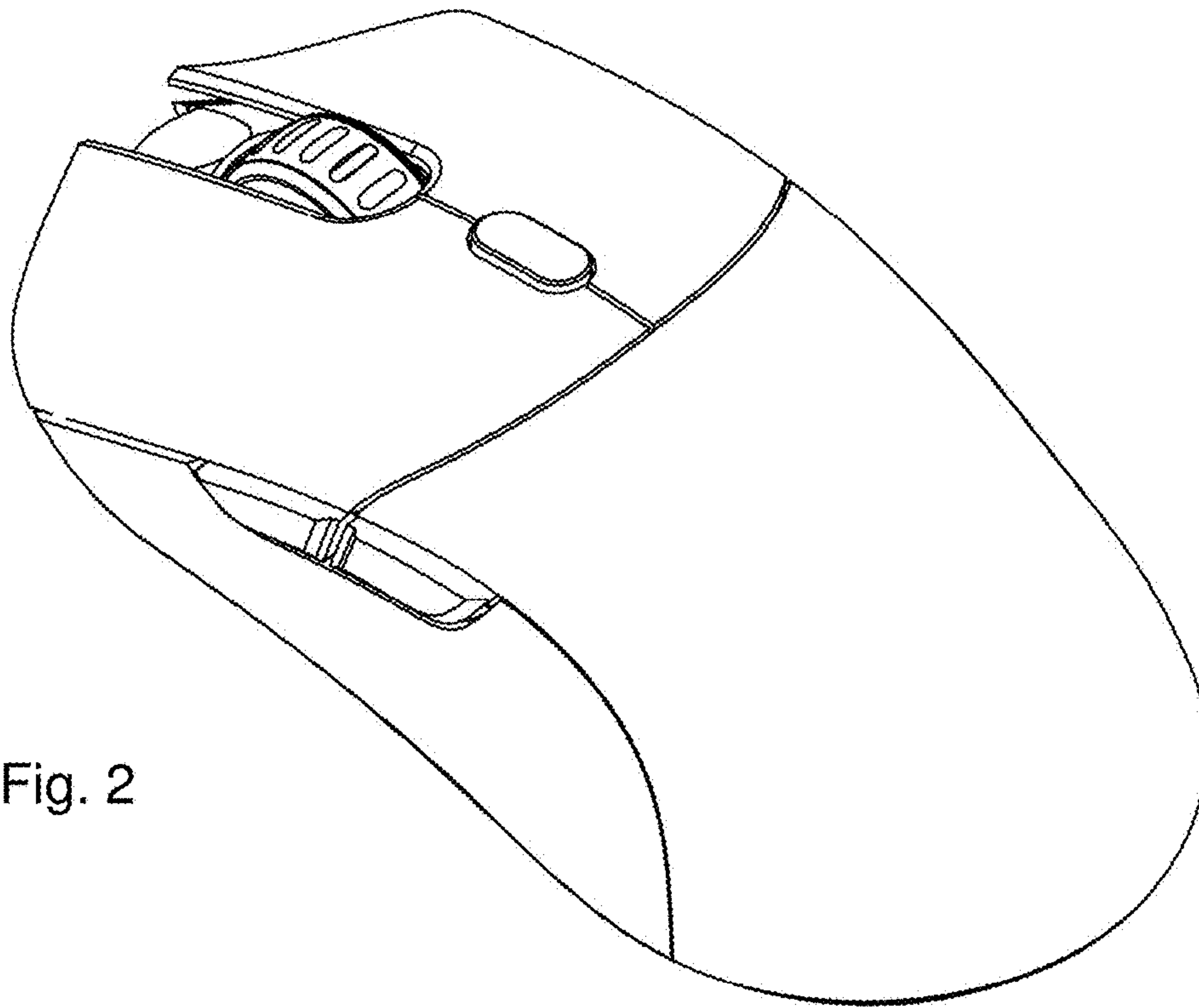

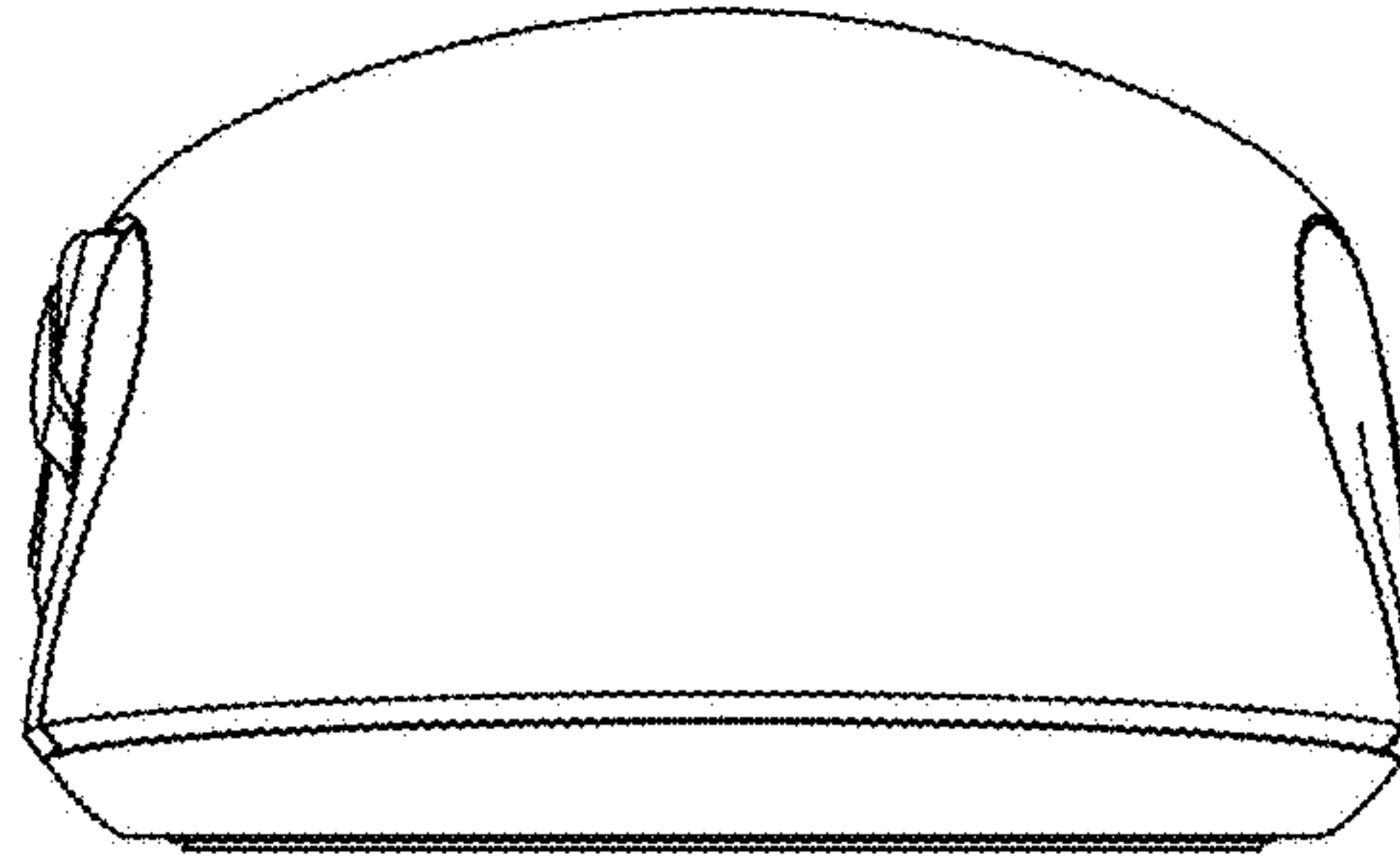

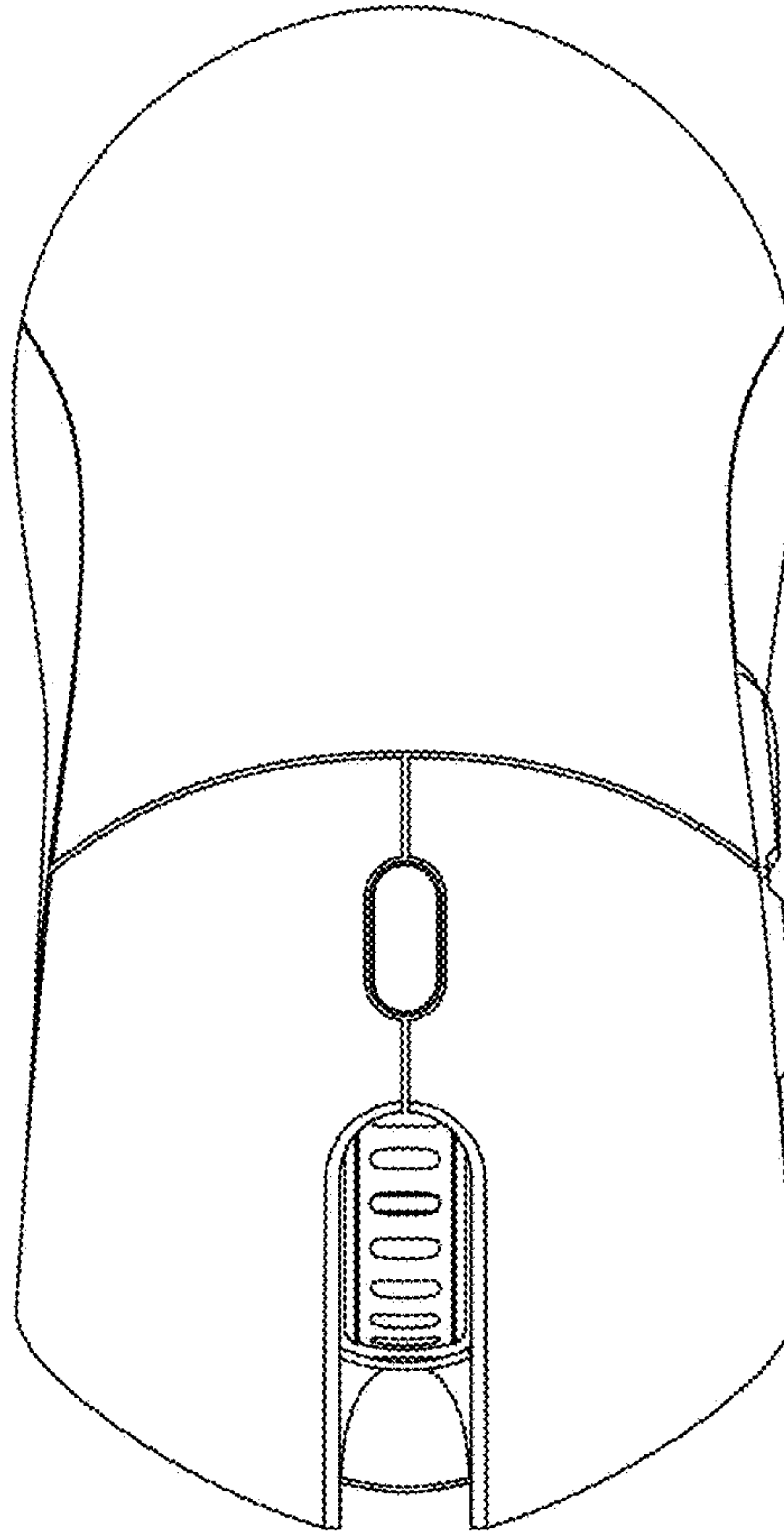

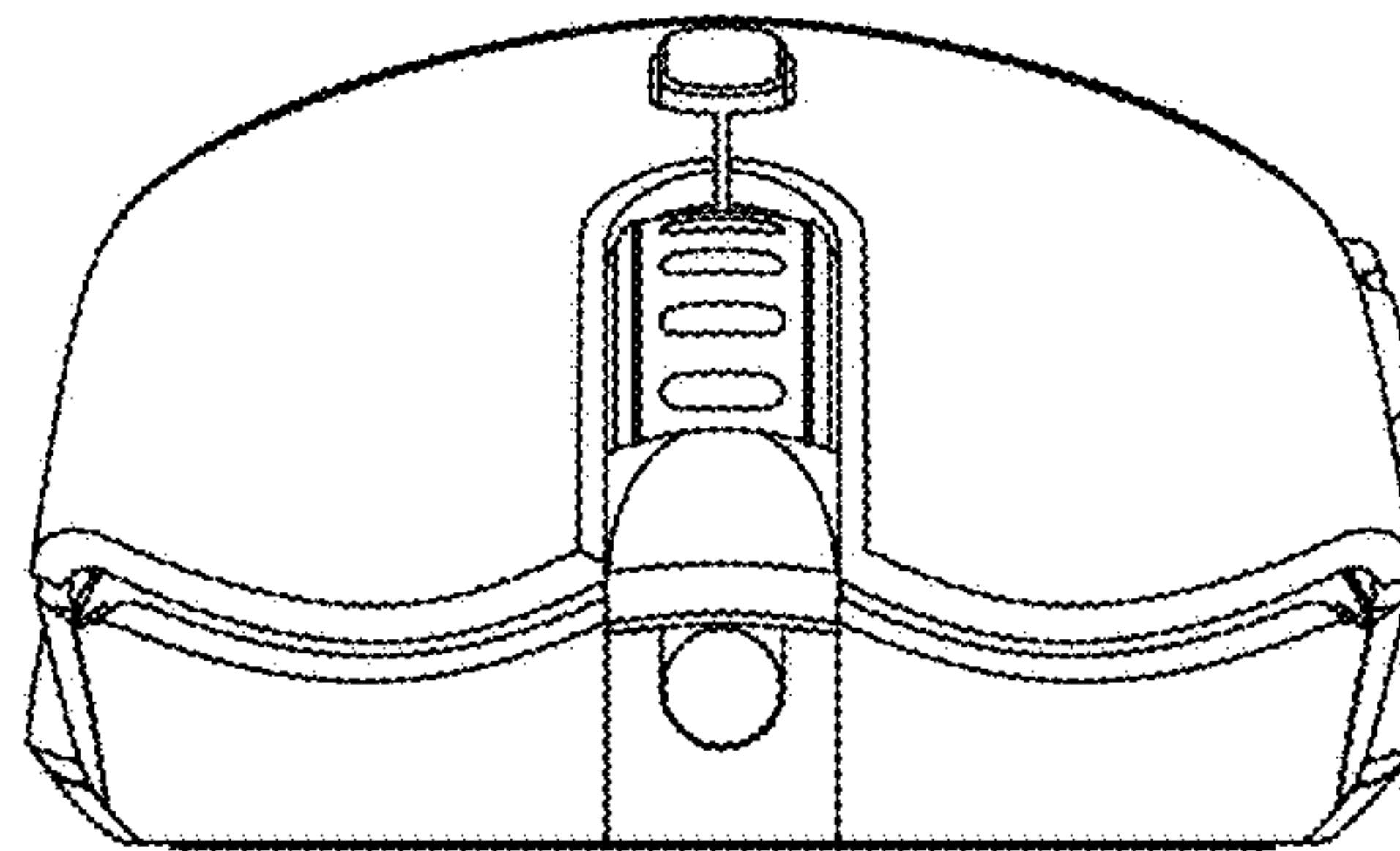

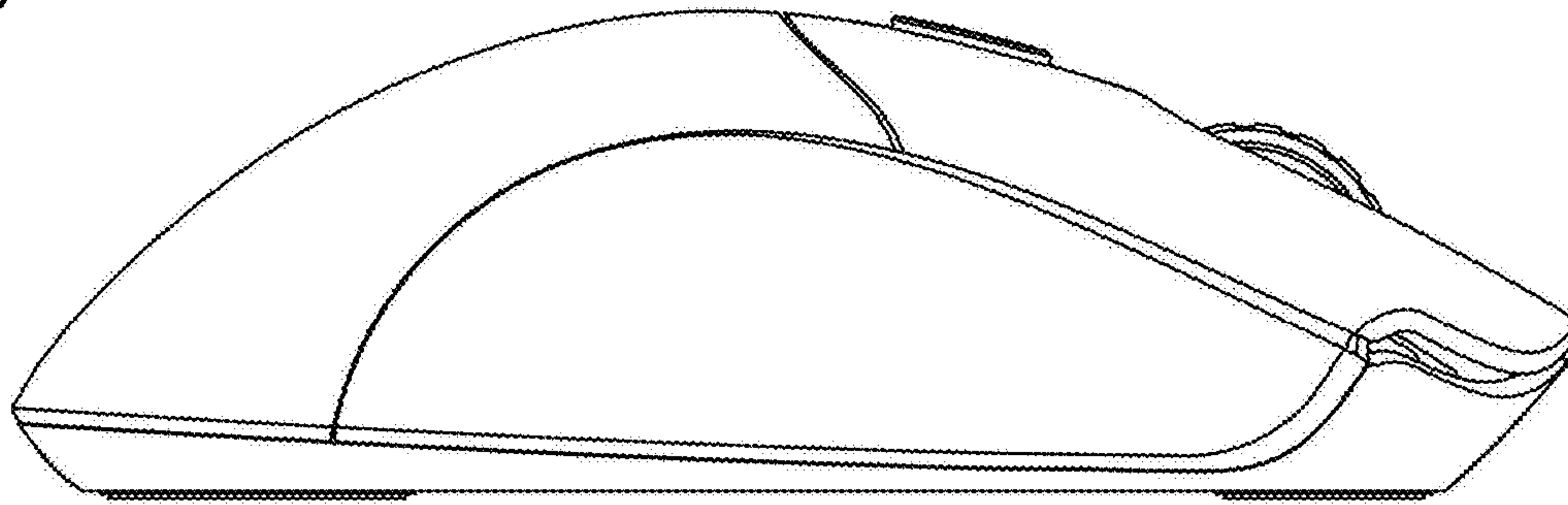

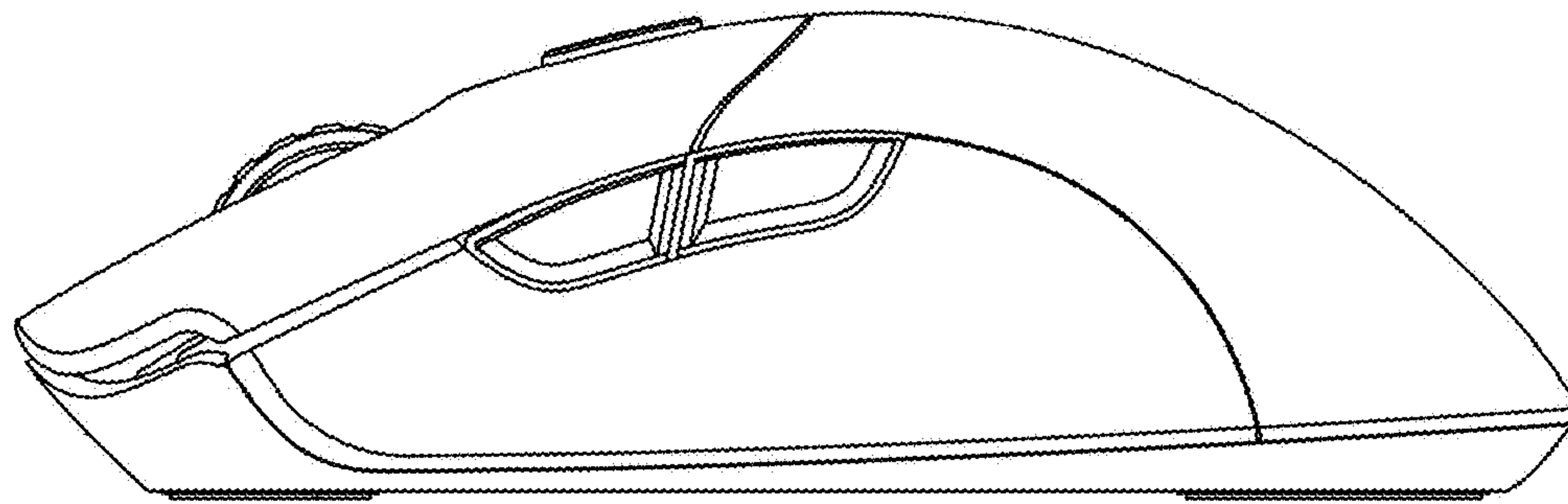

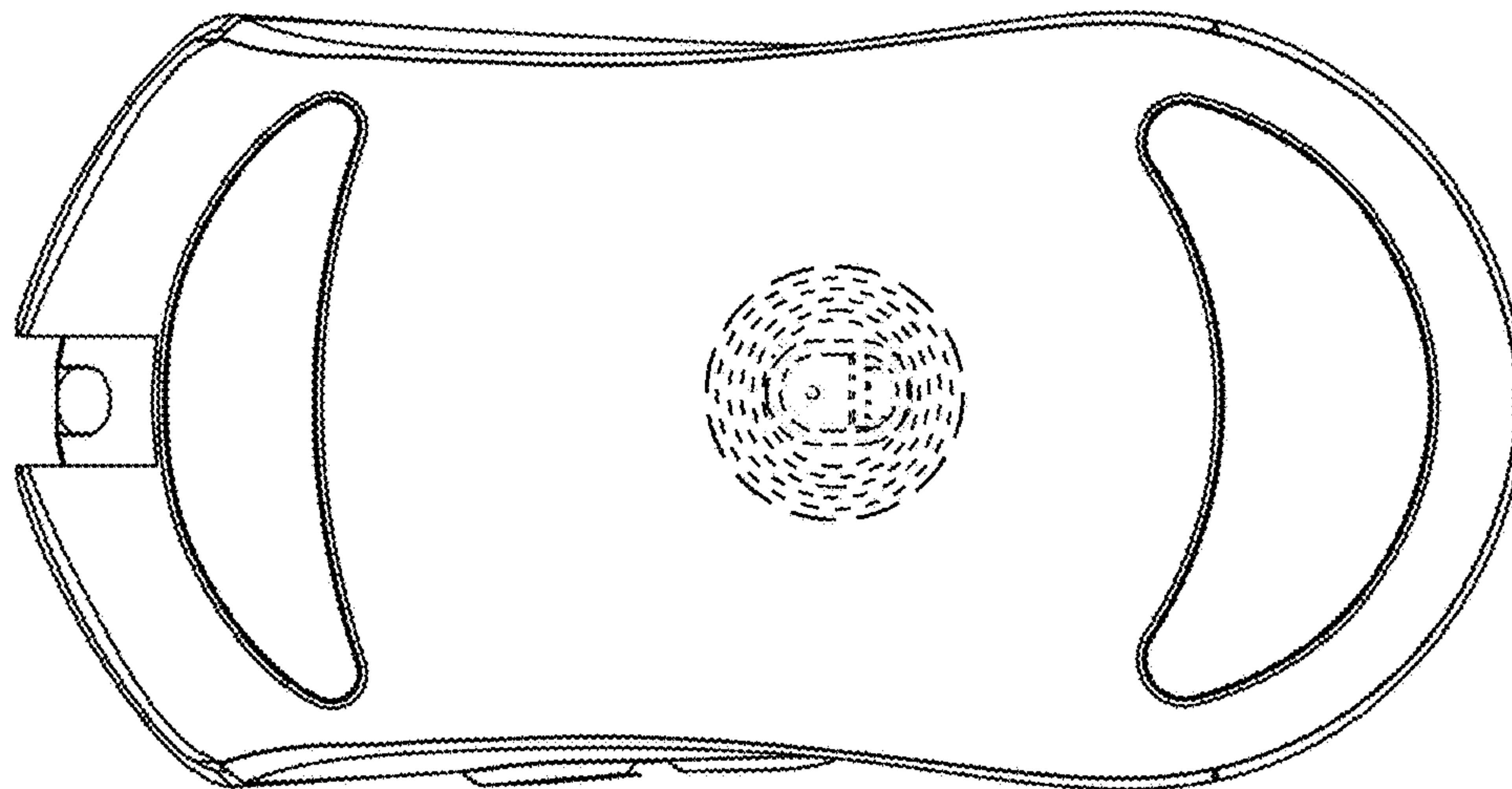

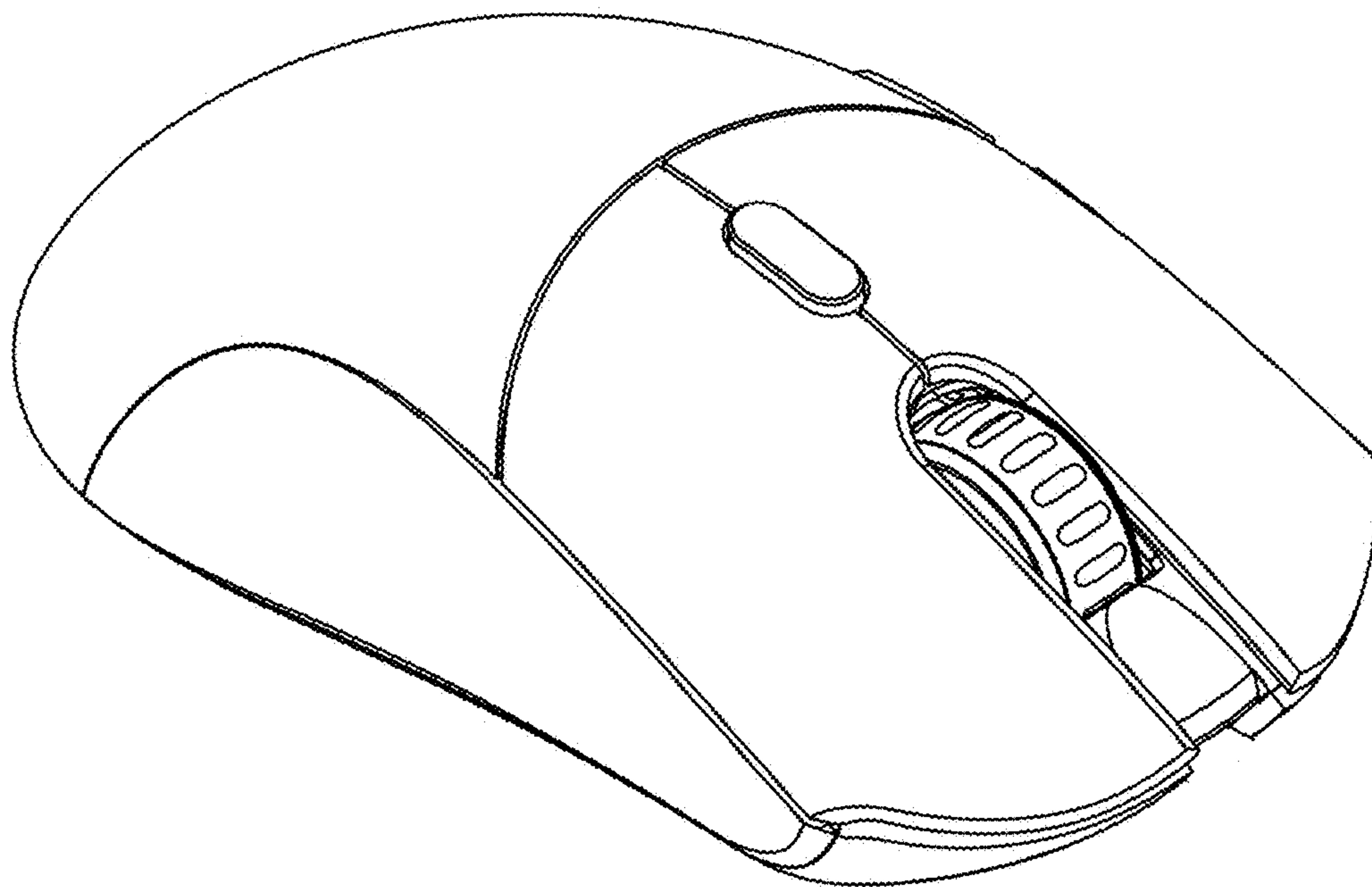
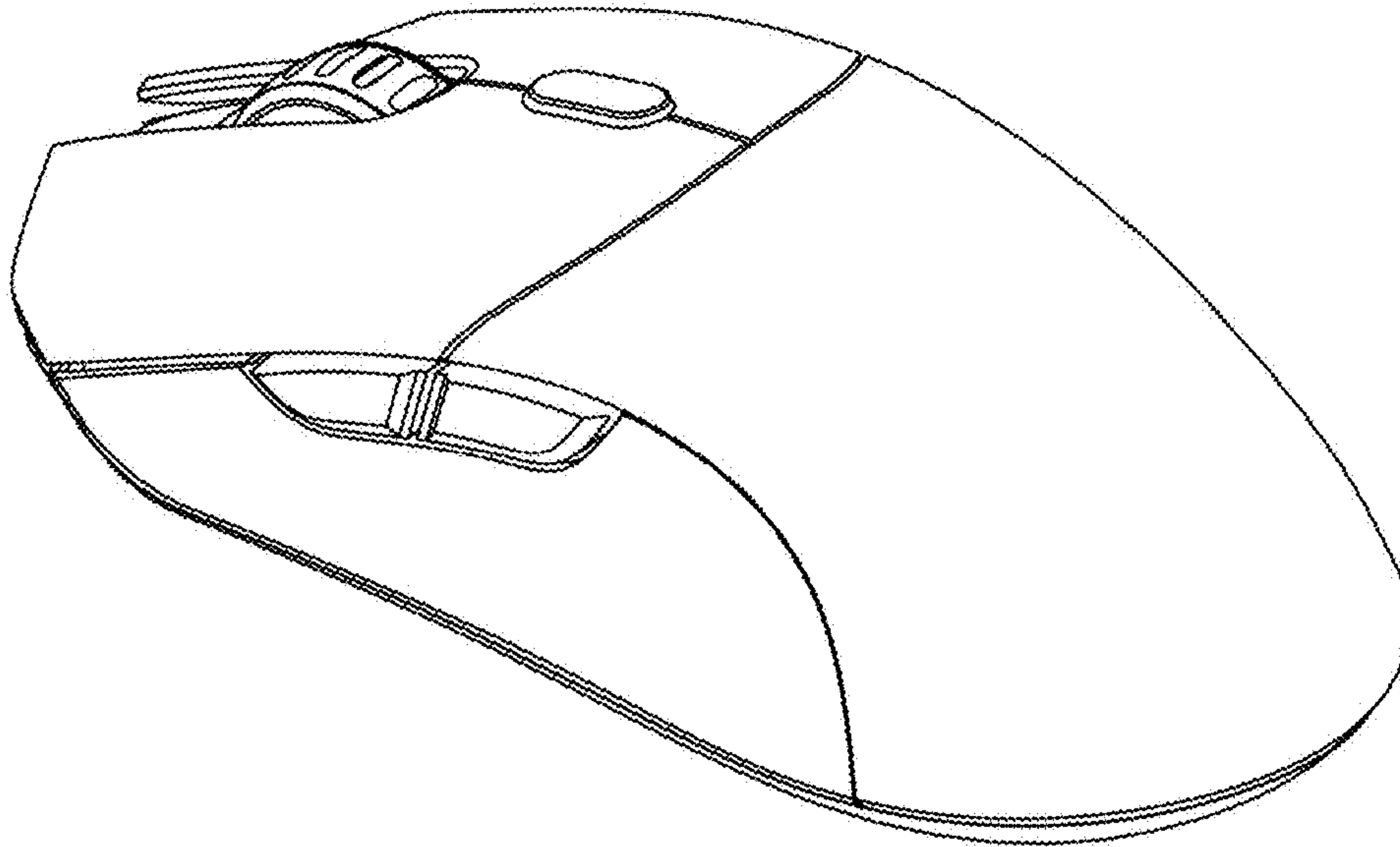
