(57) **CLAIM**

The ornamental design for a shower mixer trim, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shower mixer trim according to the present invention.

FIG. 2 is a front view of the shower mixer trim of FIG. 1.

FIG. 3 is a rear view of the shower mixer trim of FIG. 1.

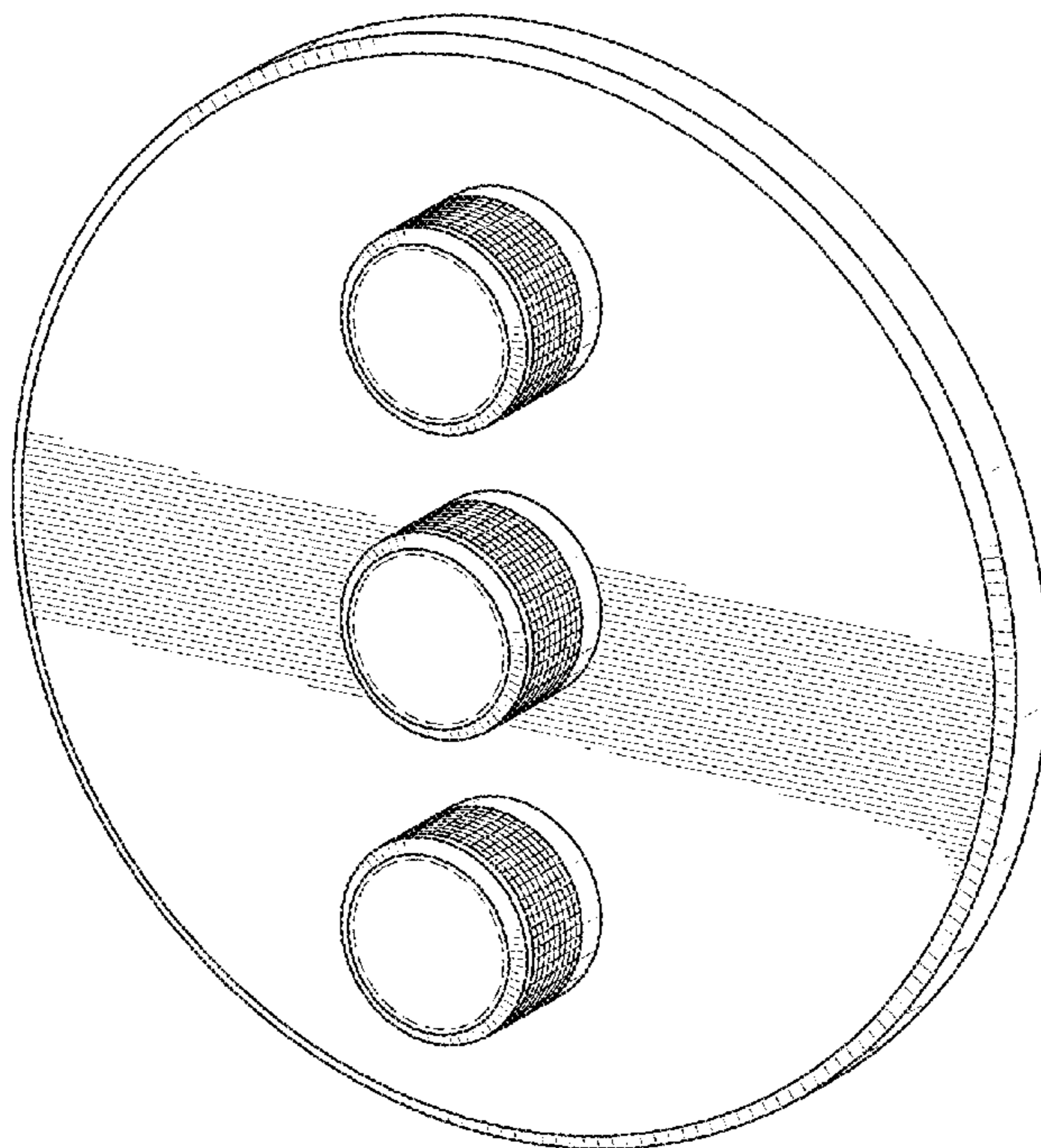
FIG. 4 is a left side view of the shower mixer trim of FIG. 1.

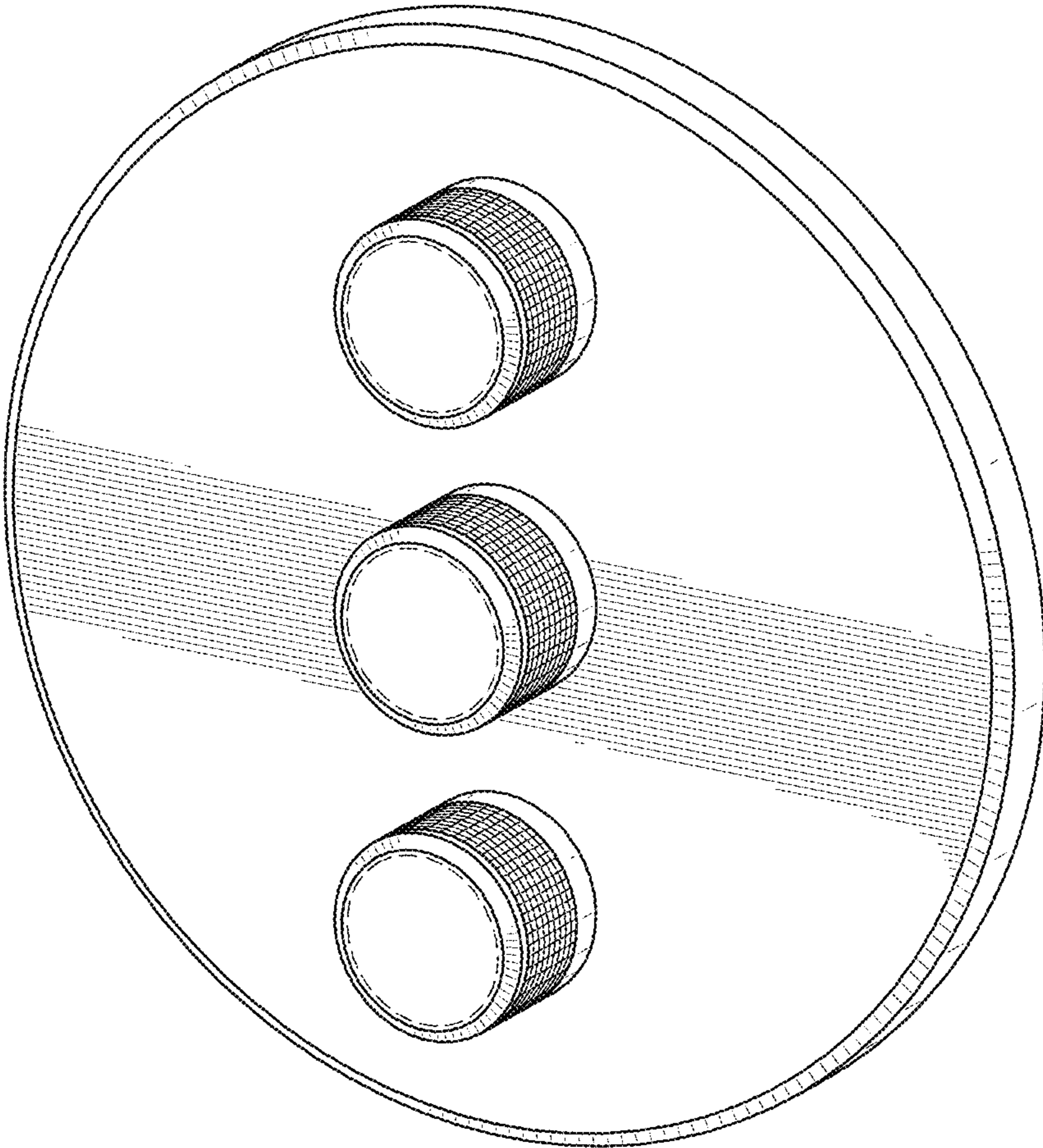

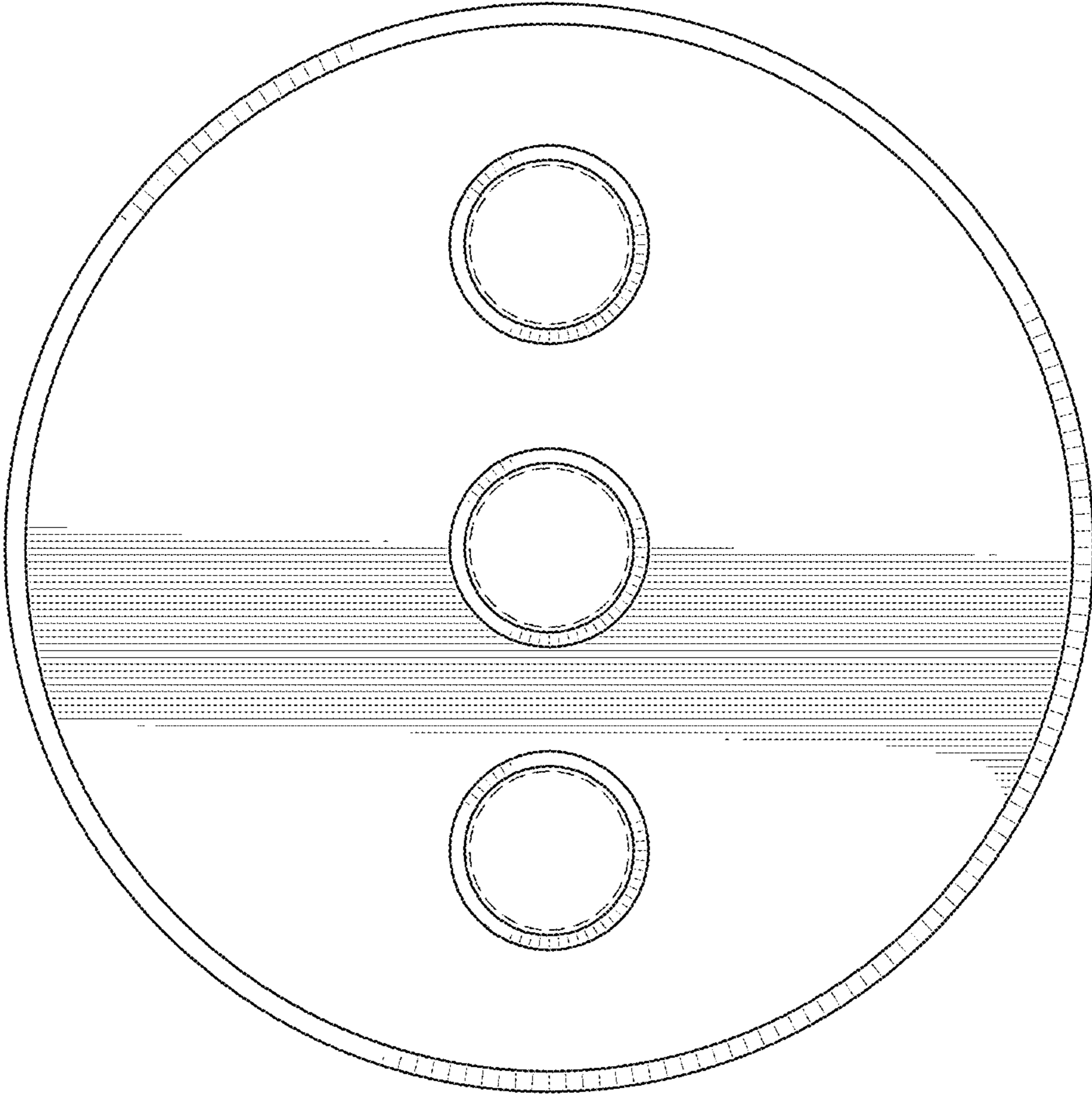

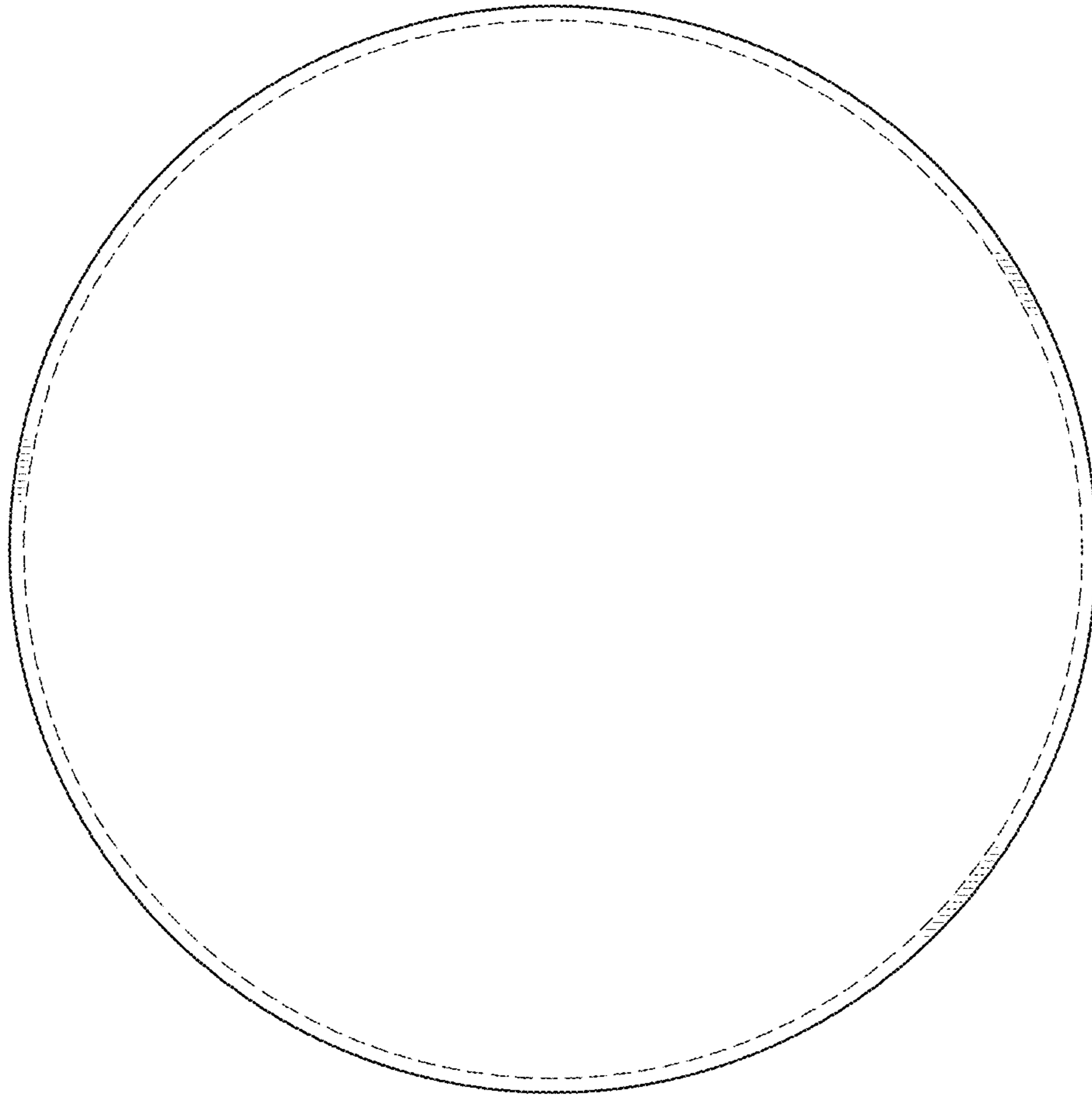

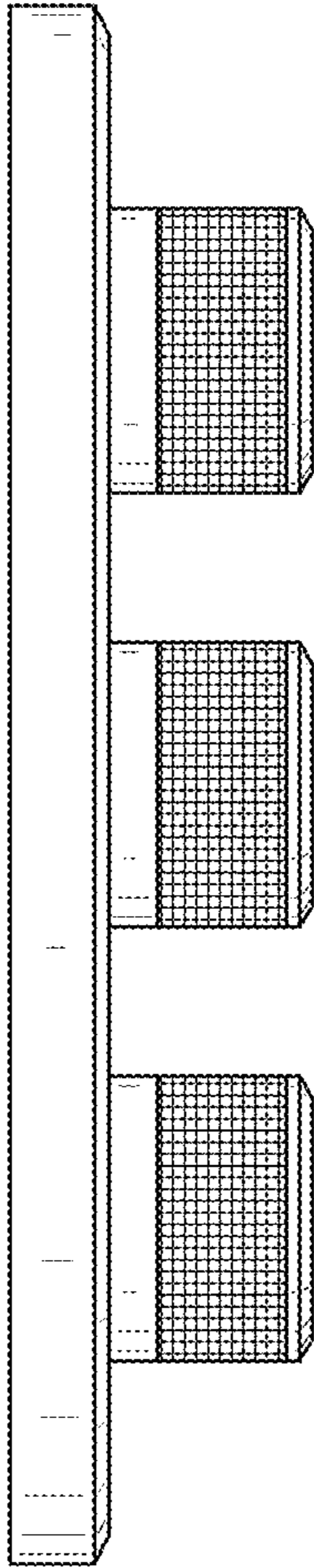

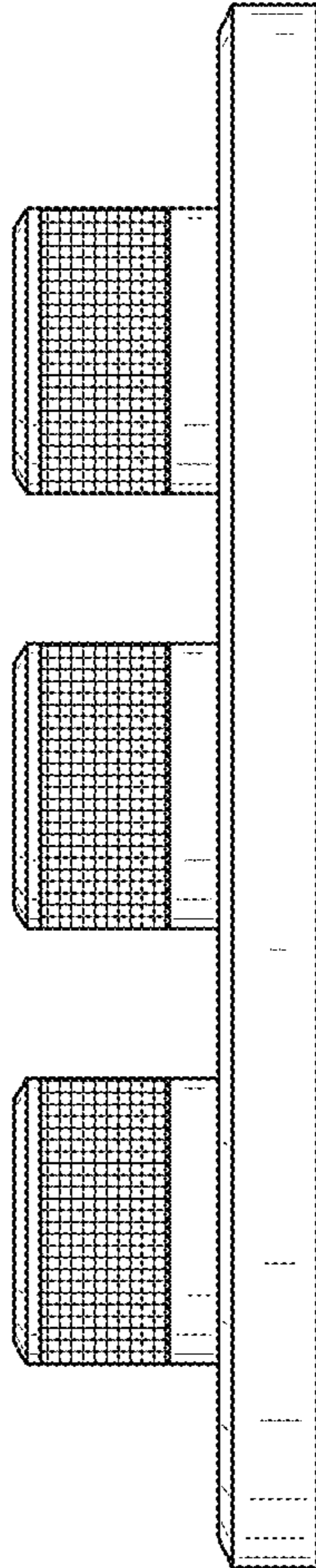

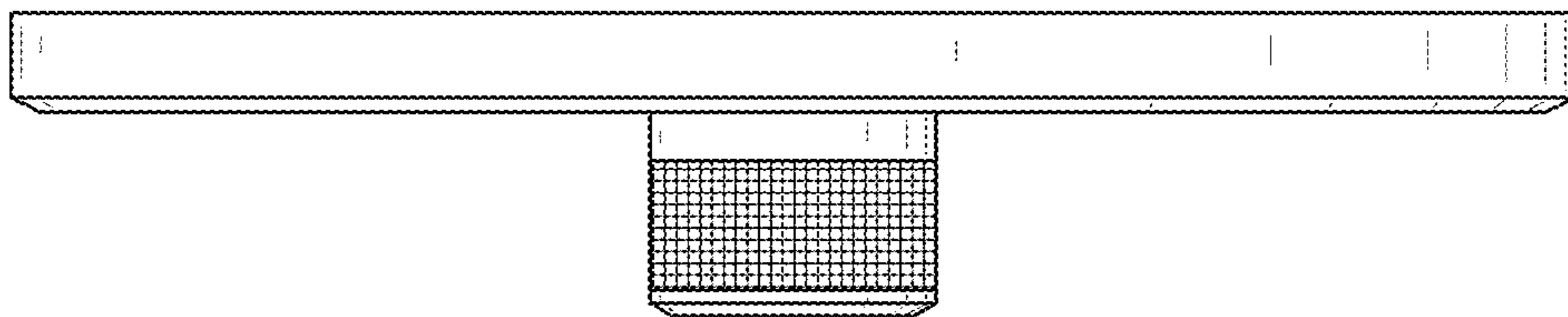

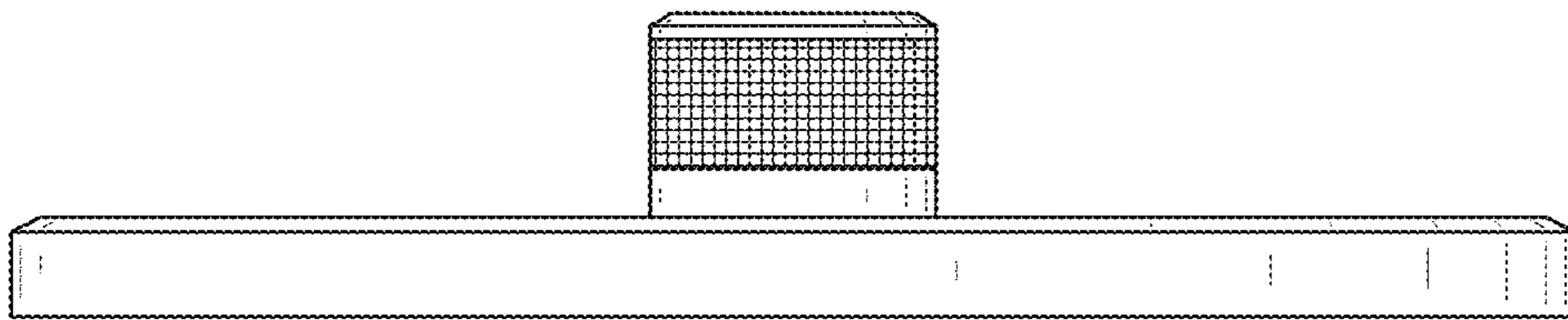
