The broken away symbols in FIGS. 7-10 indicate the appearance of any portion of the article between the break lines forms no part of the claimed design.

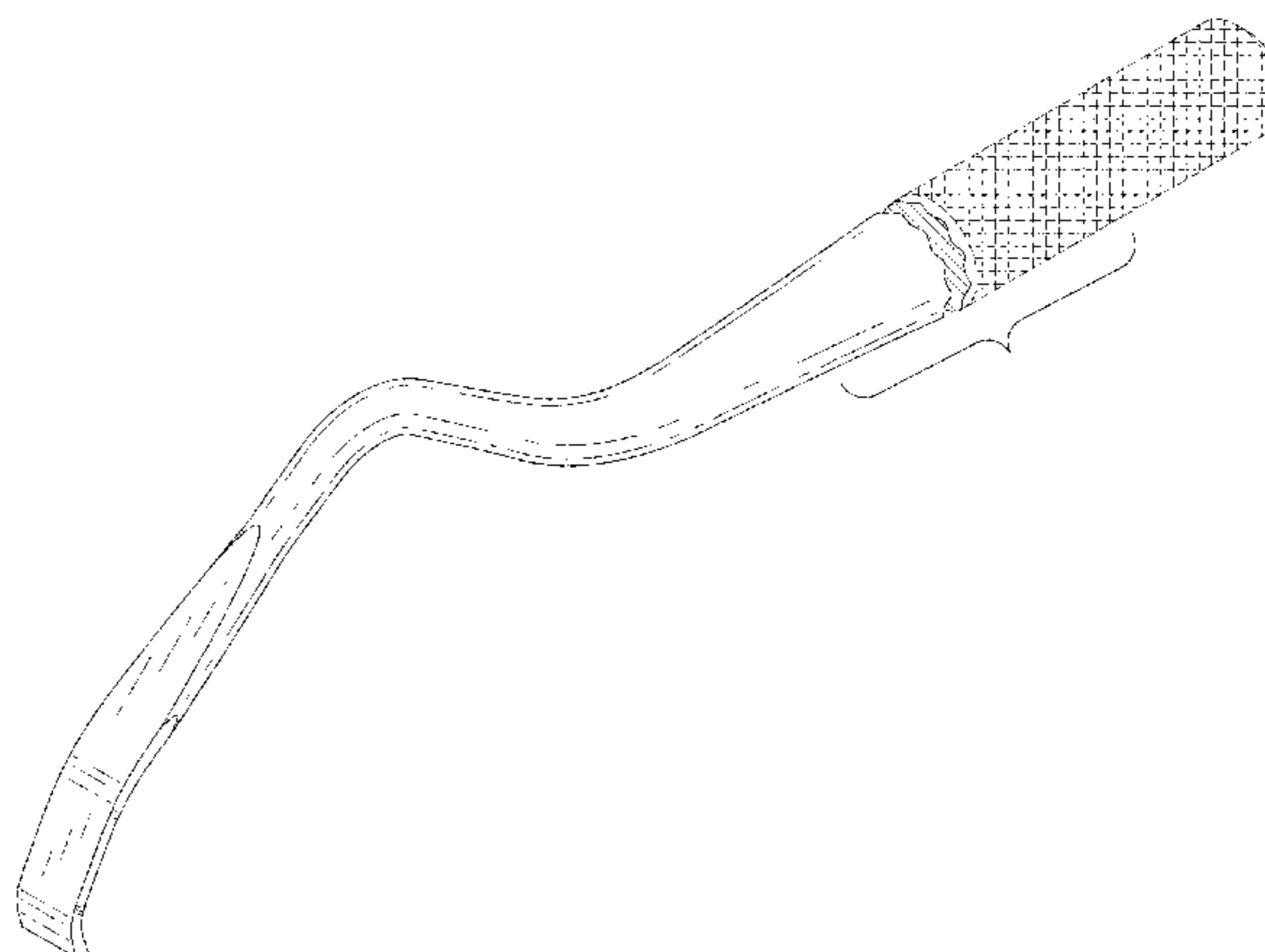
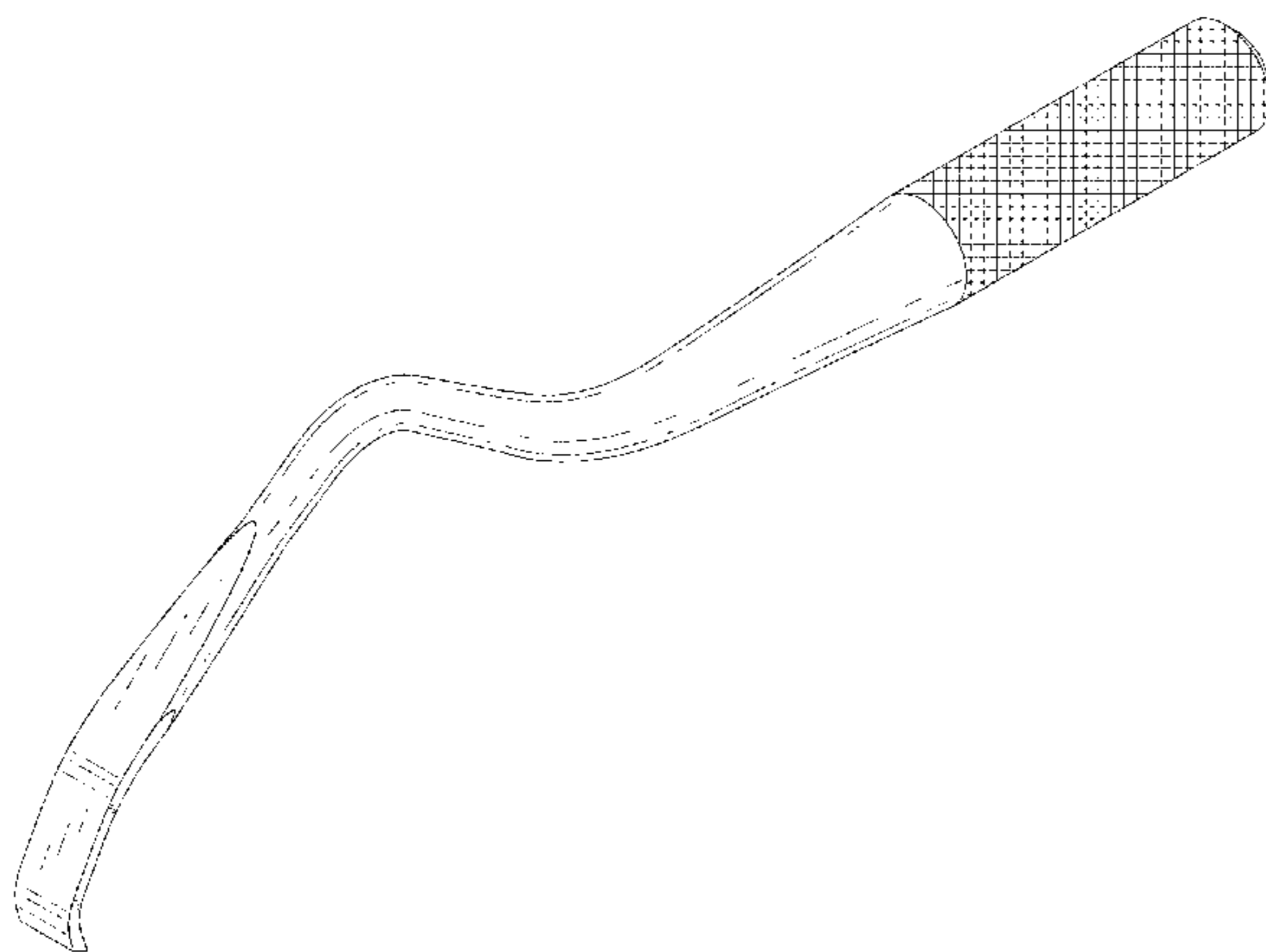

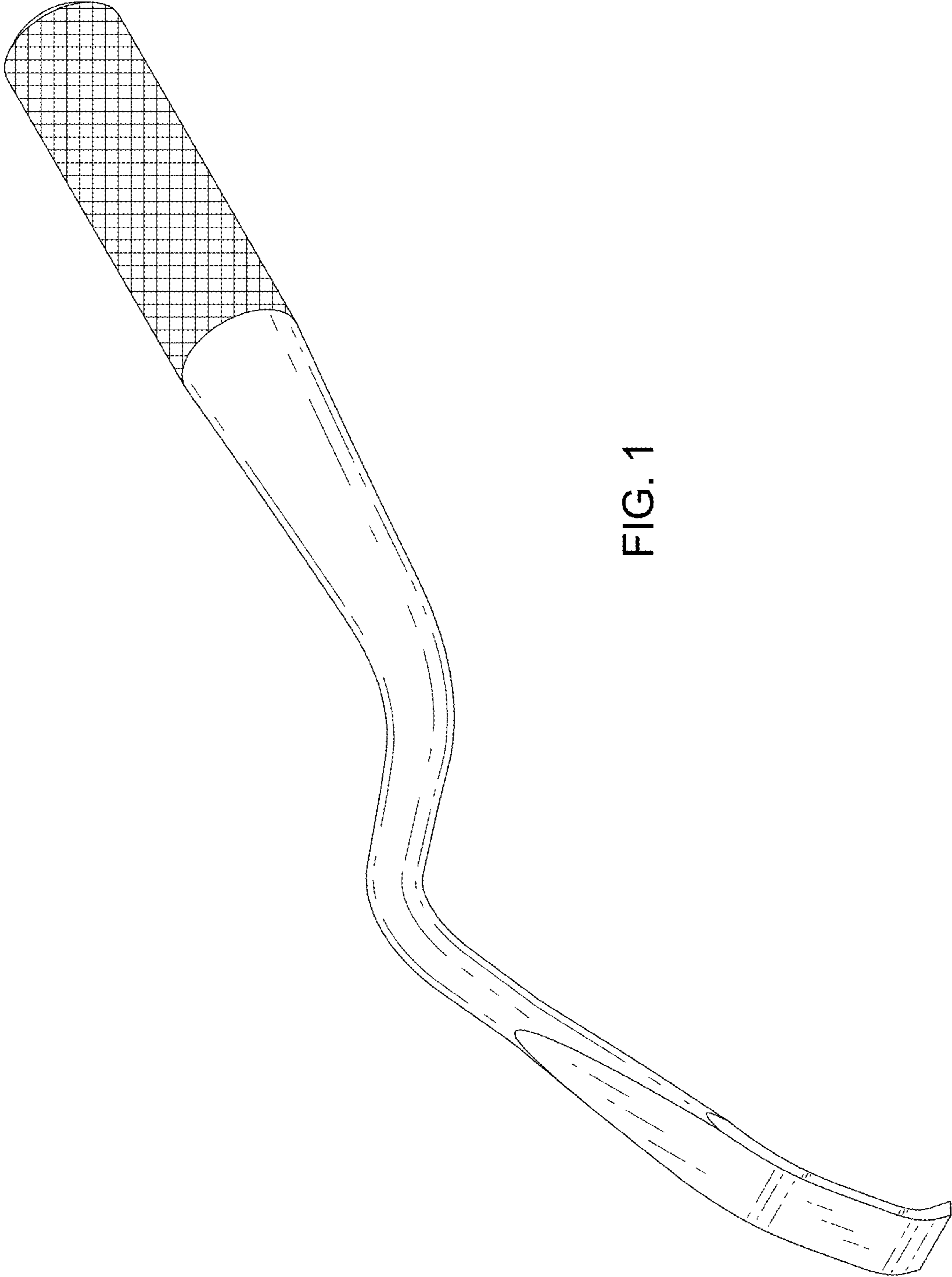

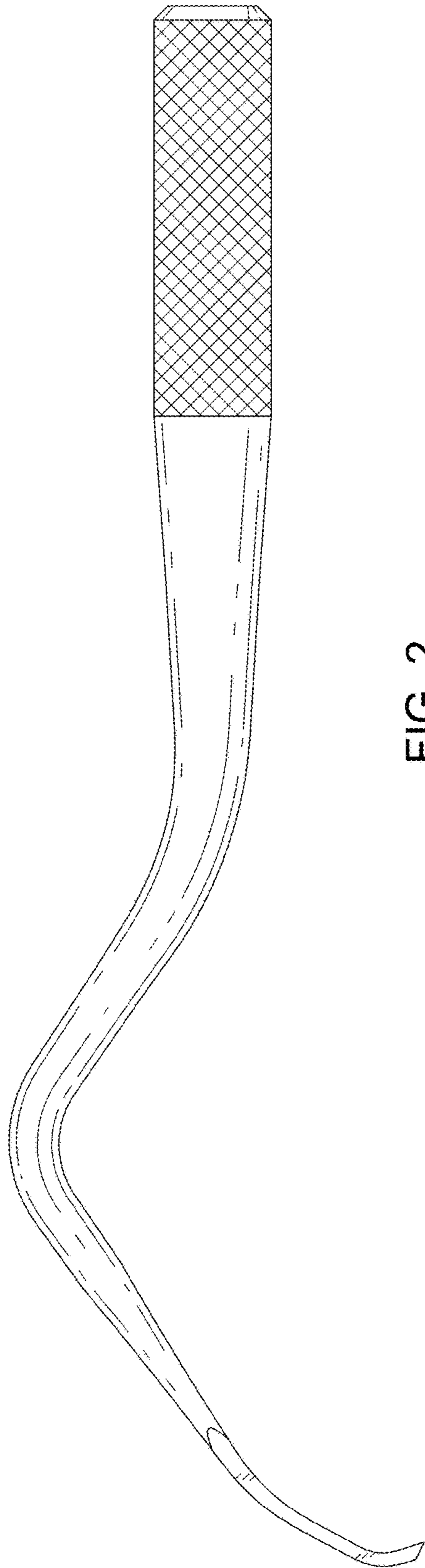

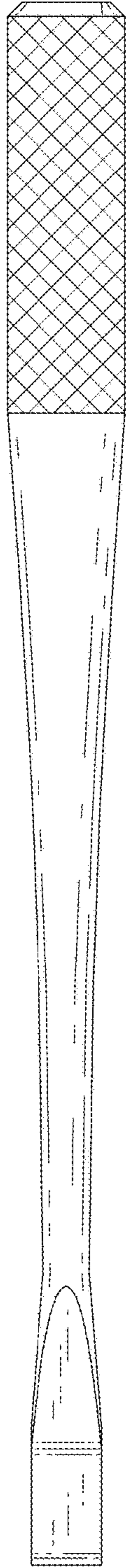

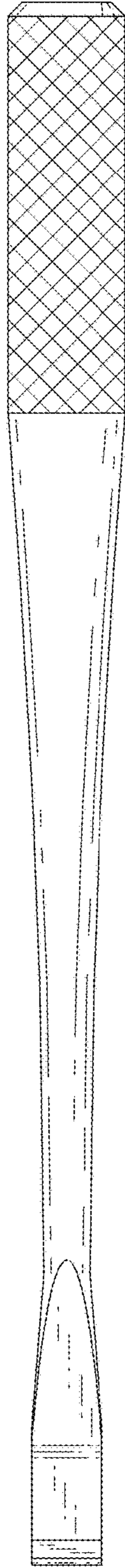

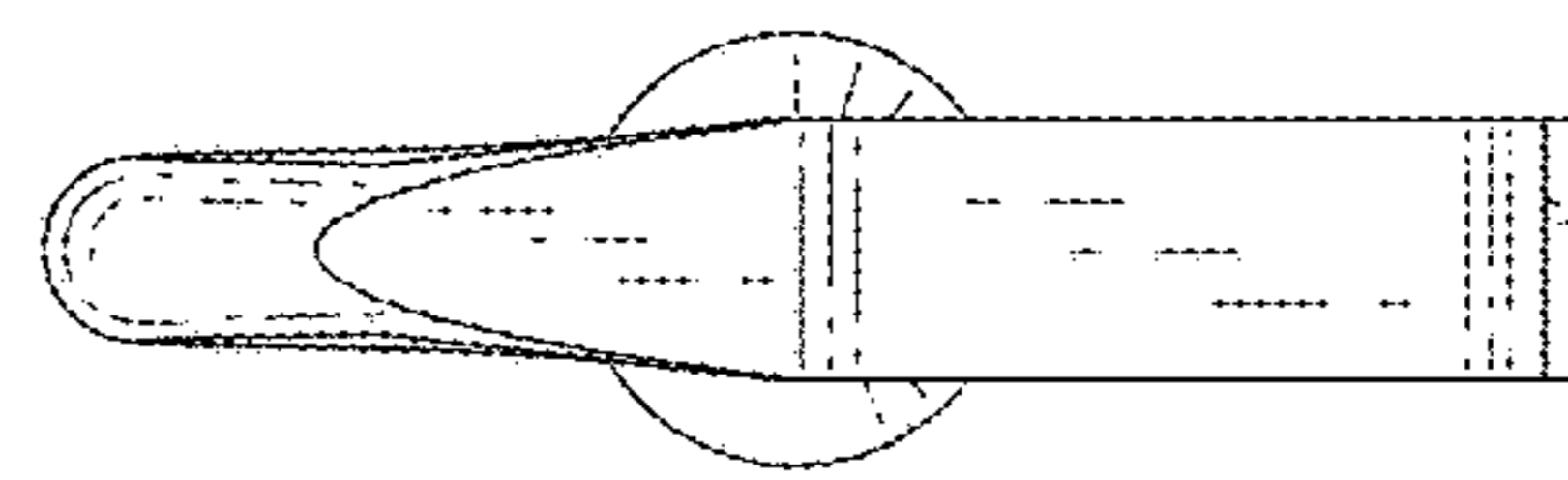

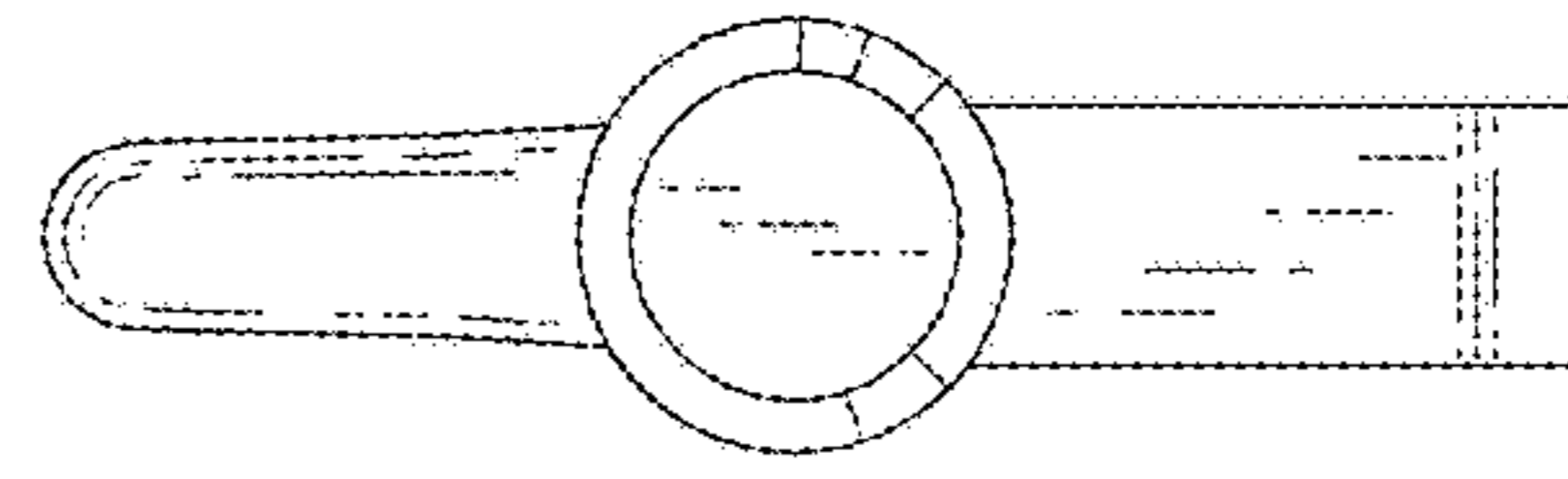

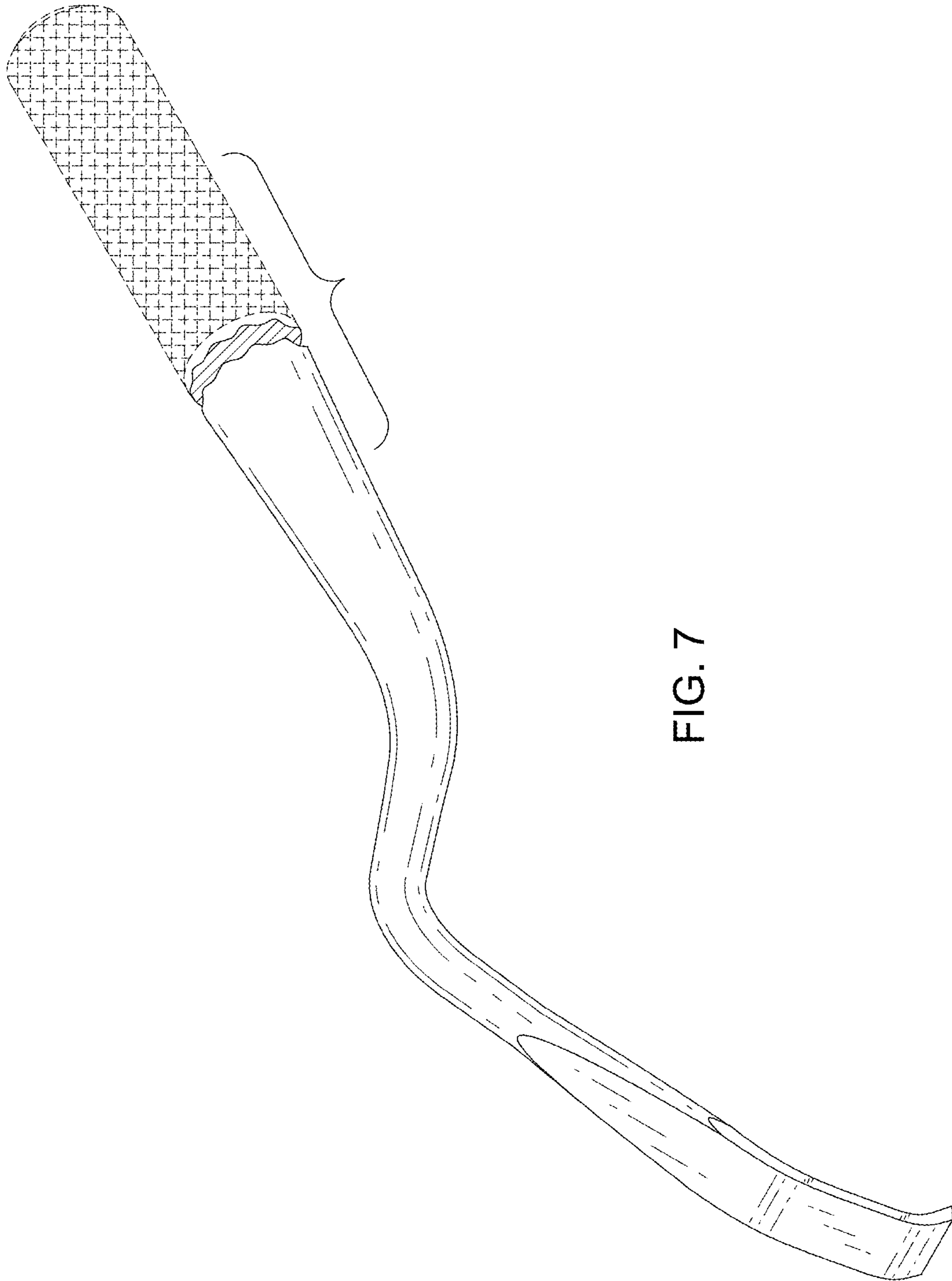

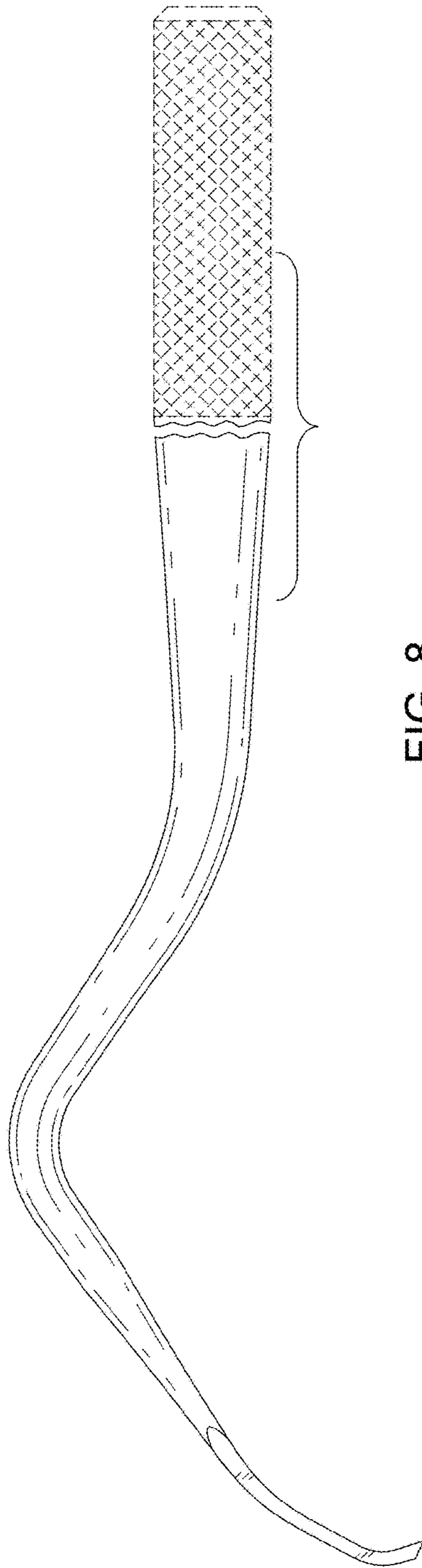

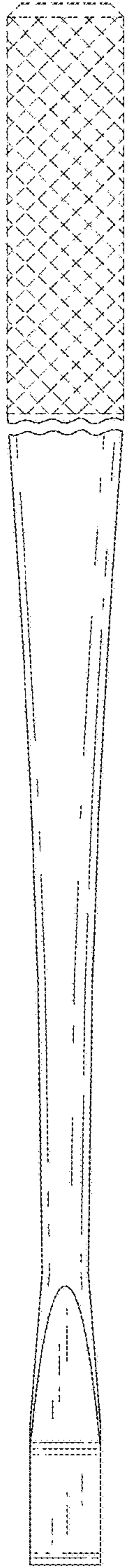

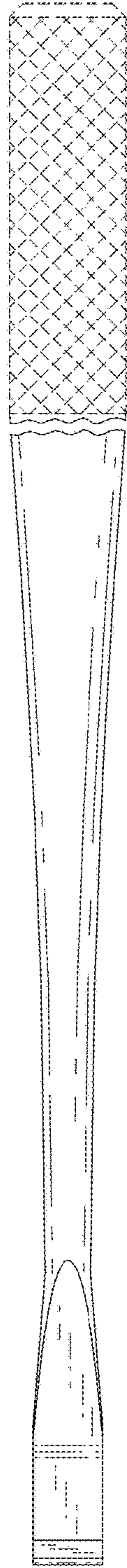

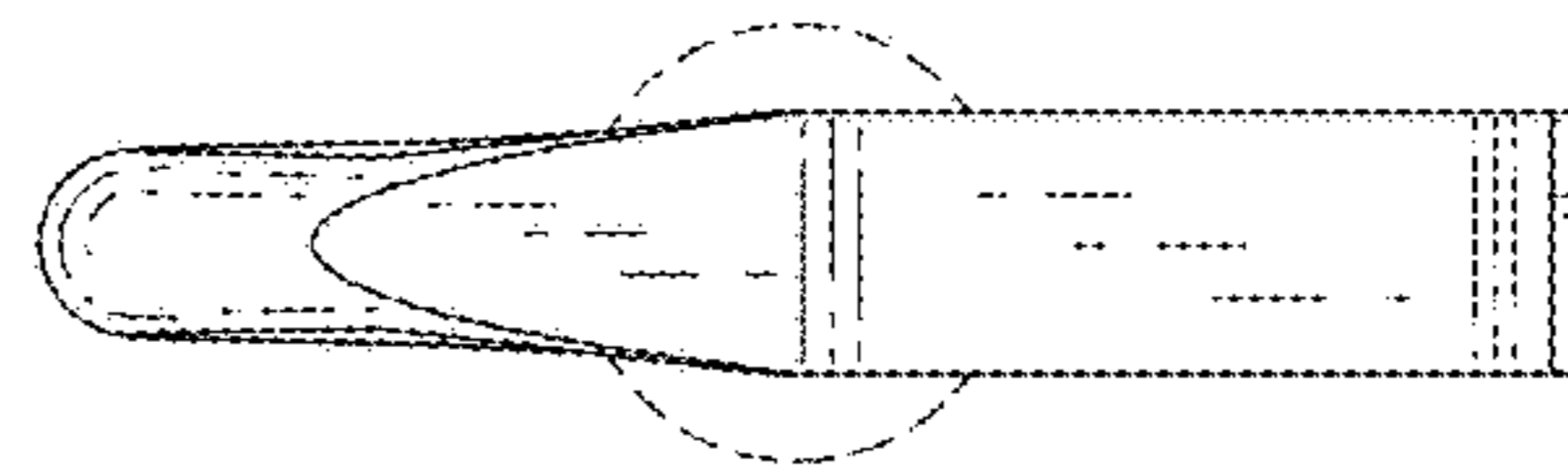

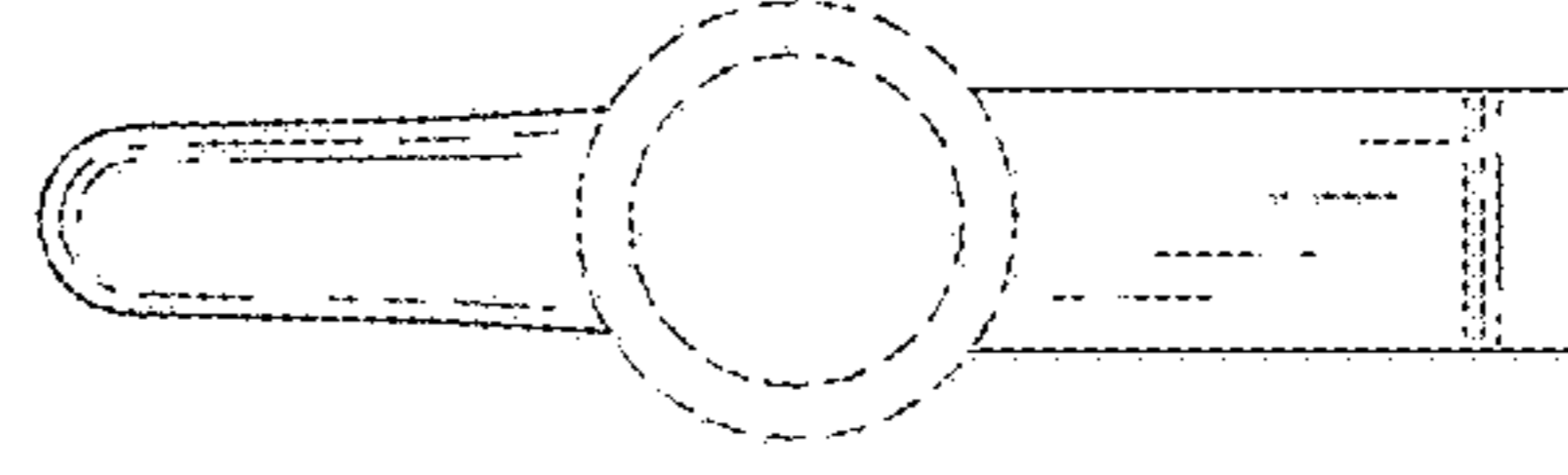
