FIG. 7 is a left side view thereof.

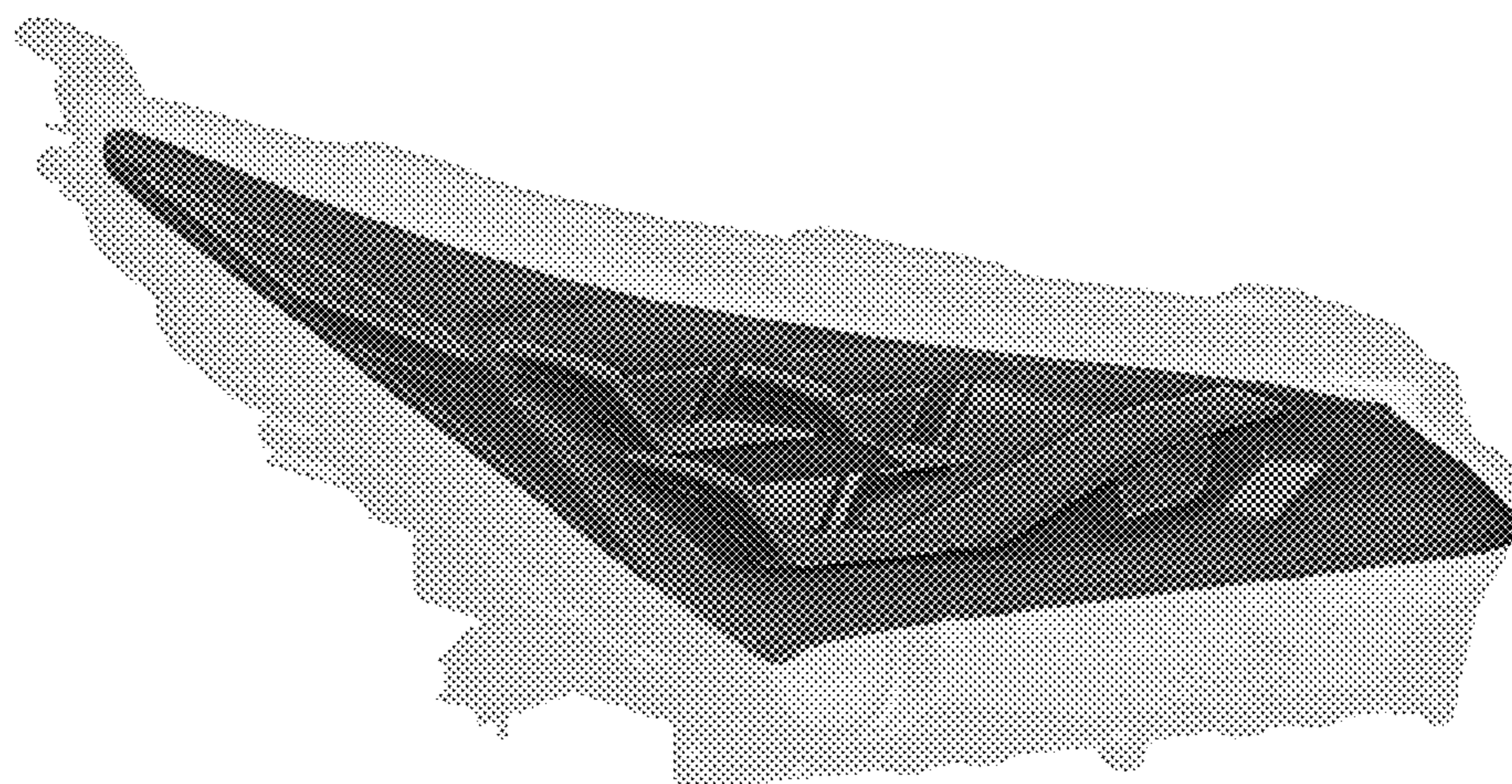
The claimed design is indicated by the relatively dark

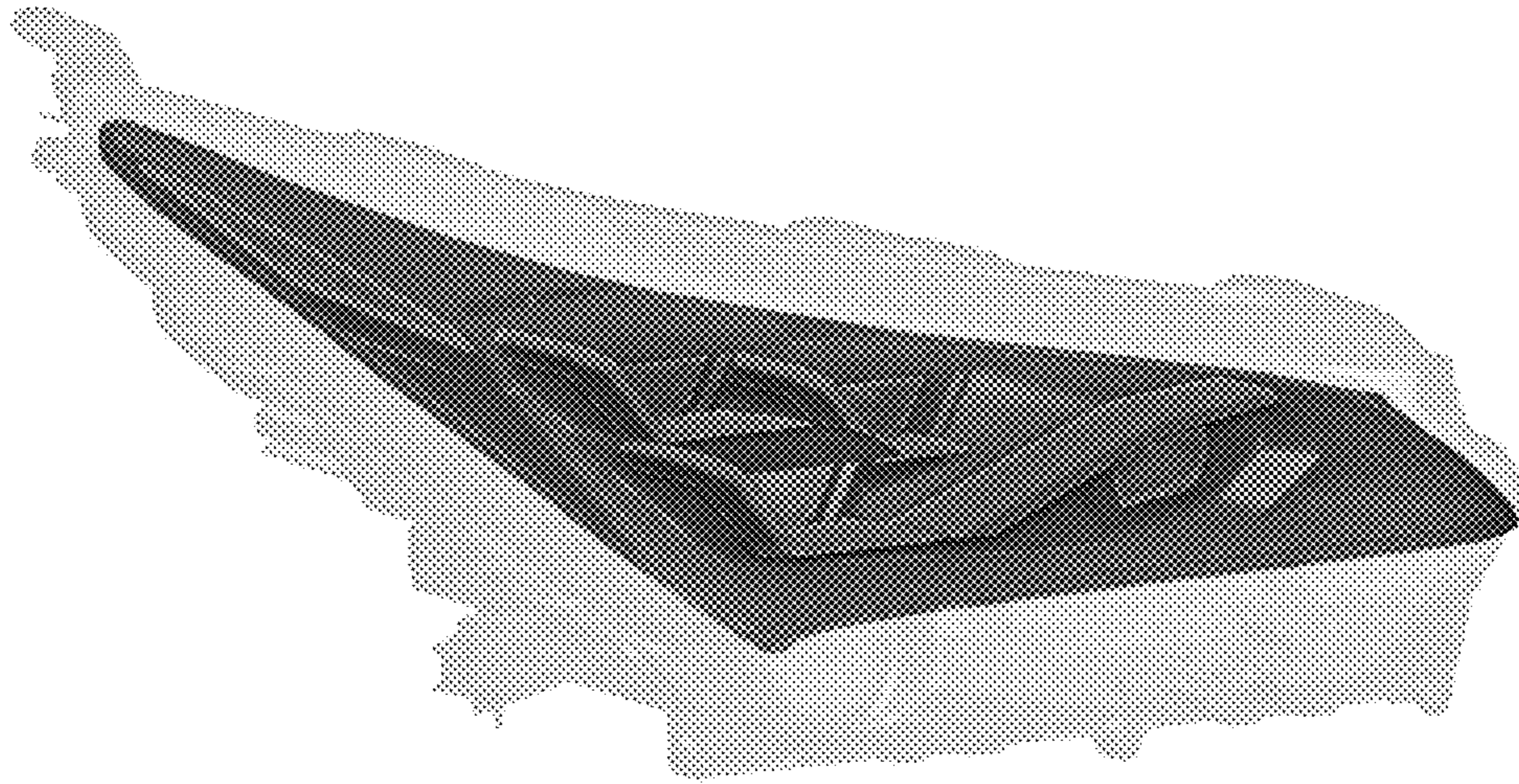

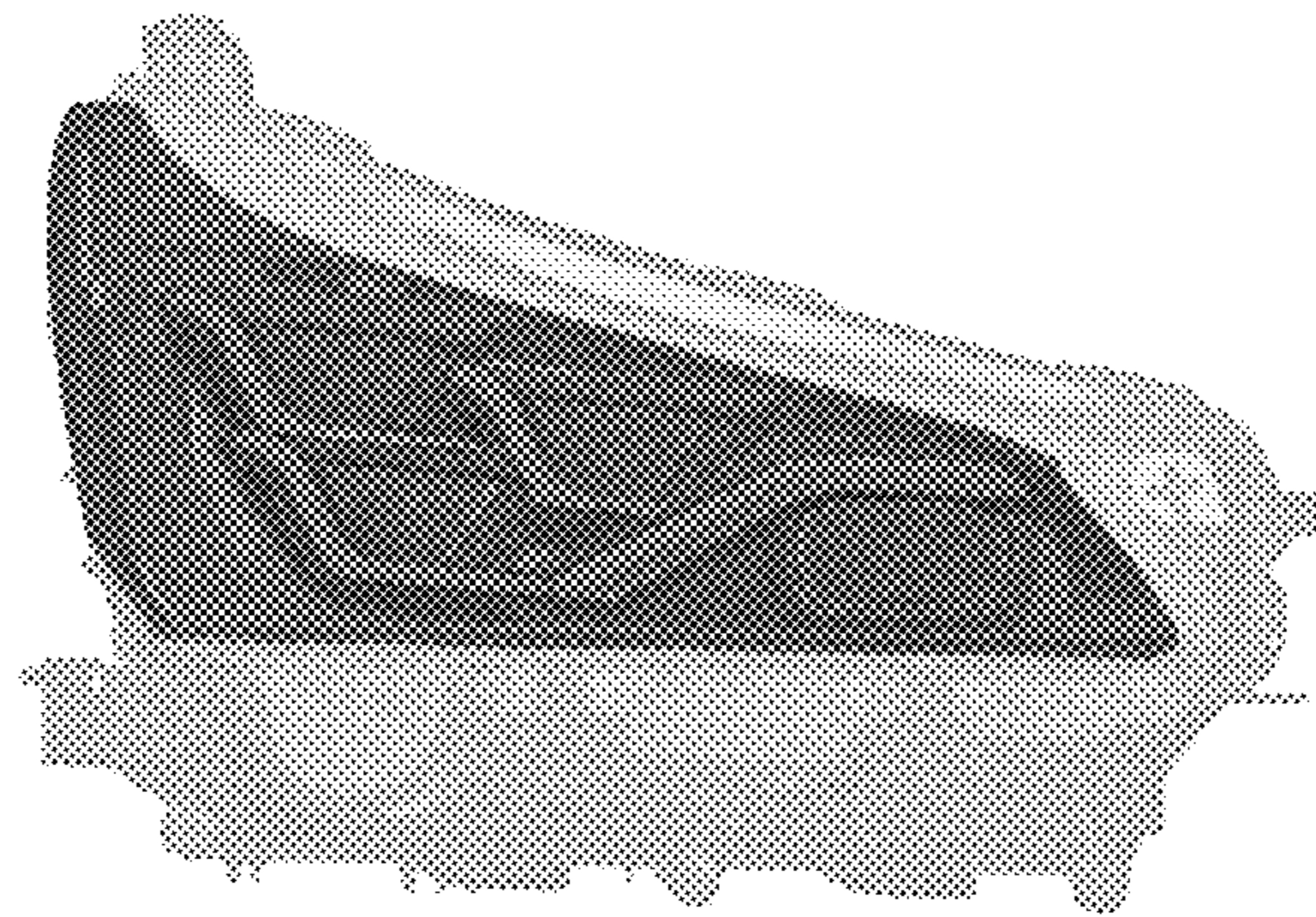

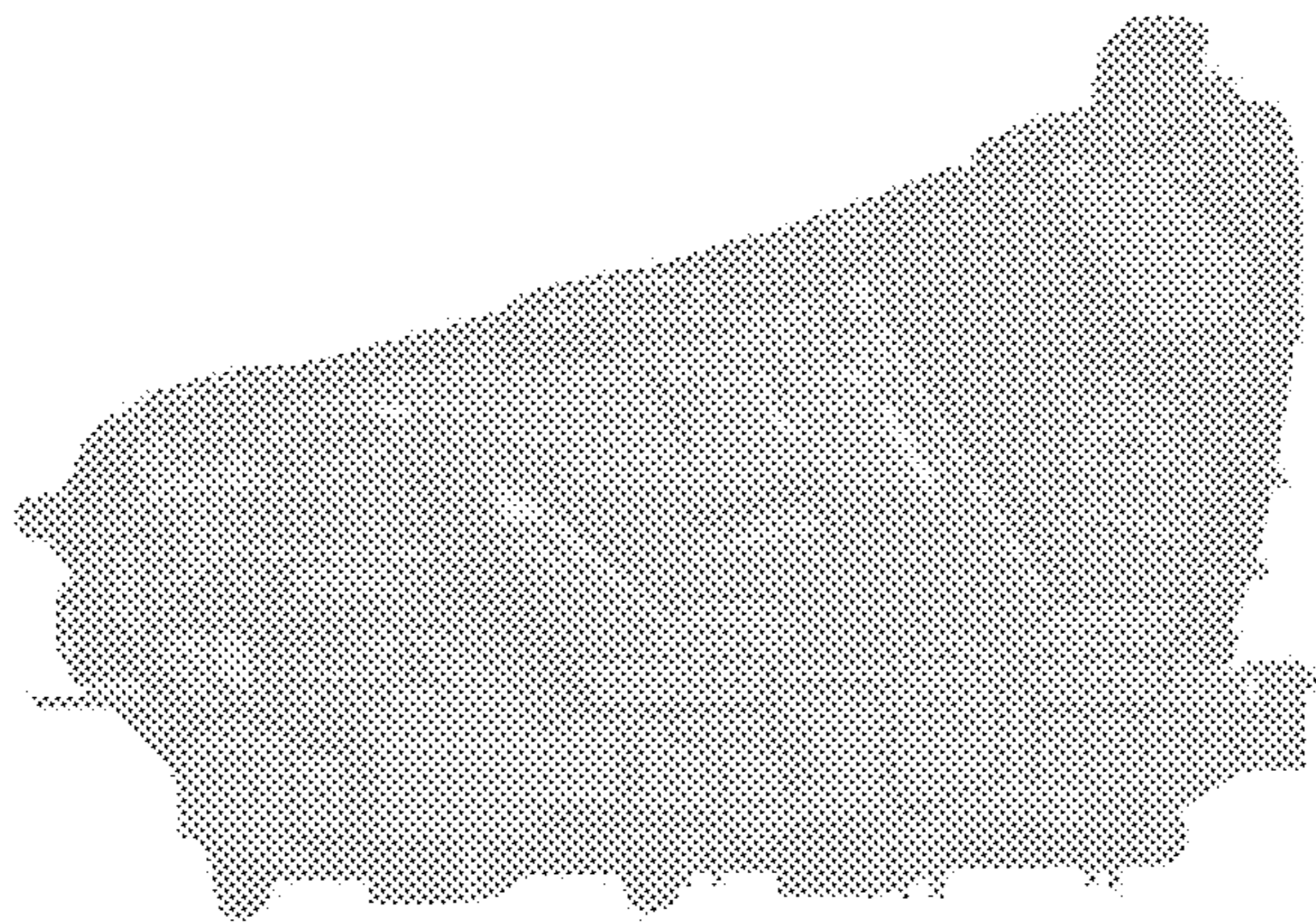

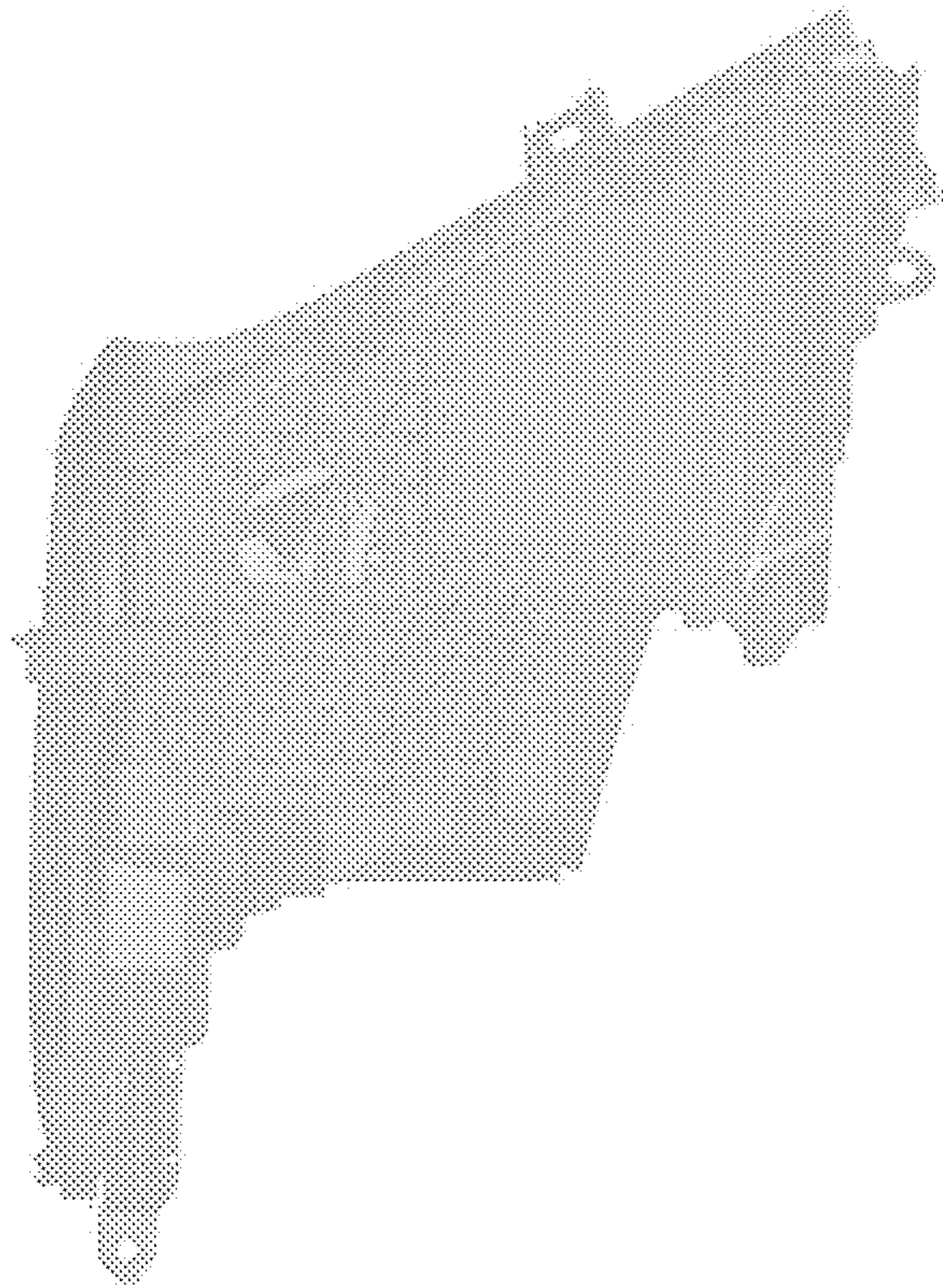

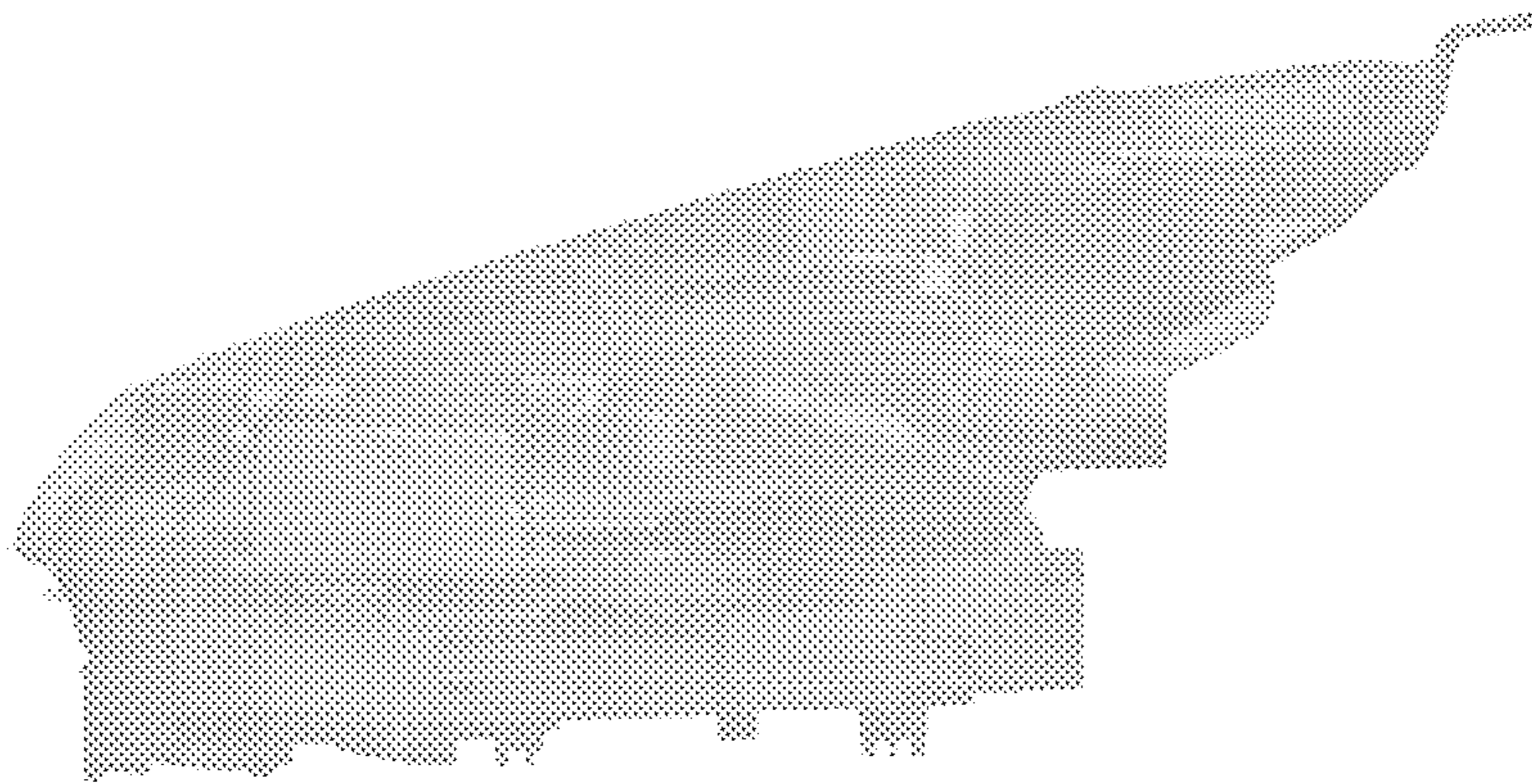

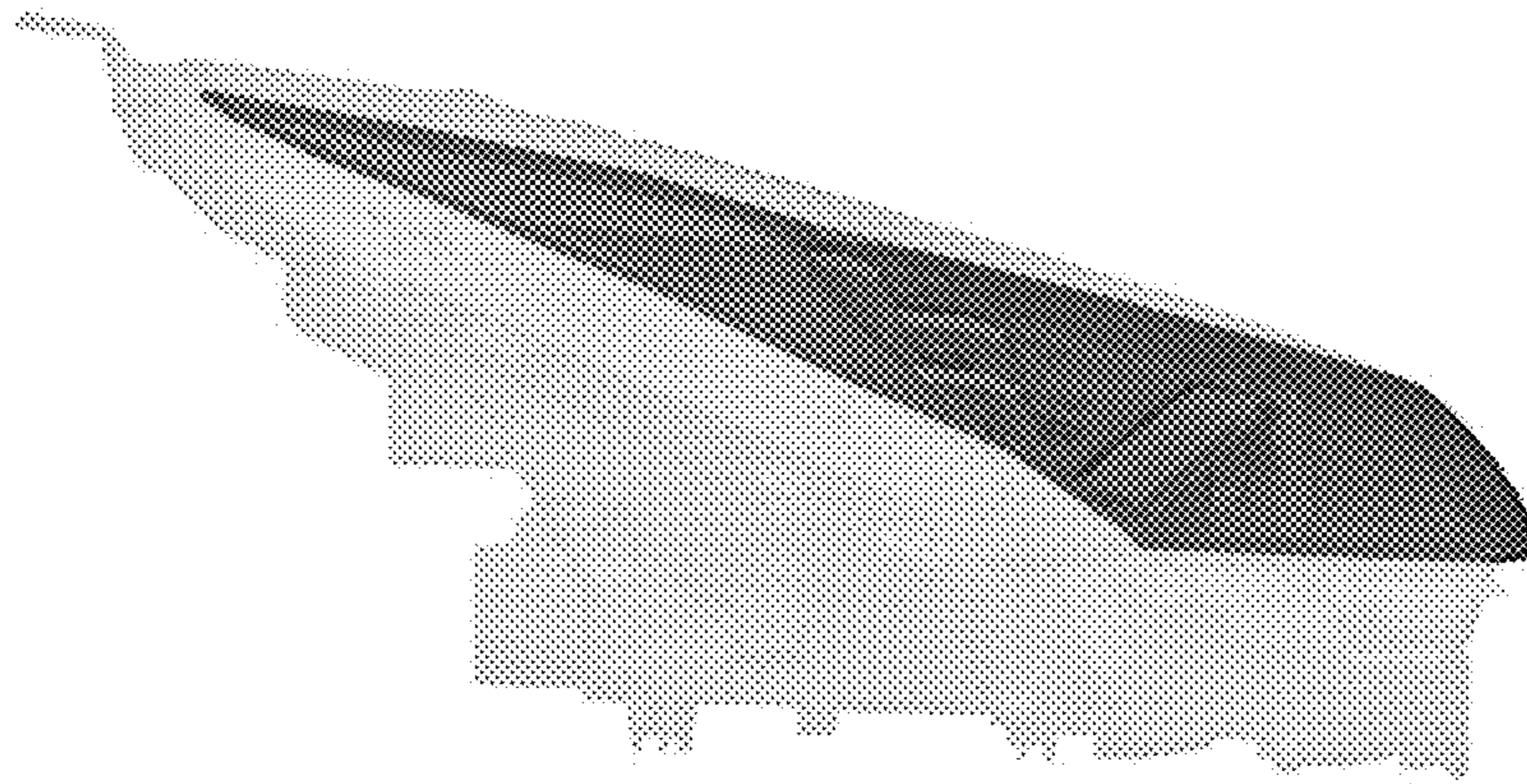
