DESCRIPTION

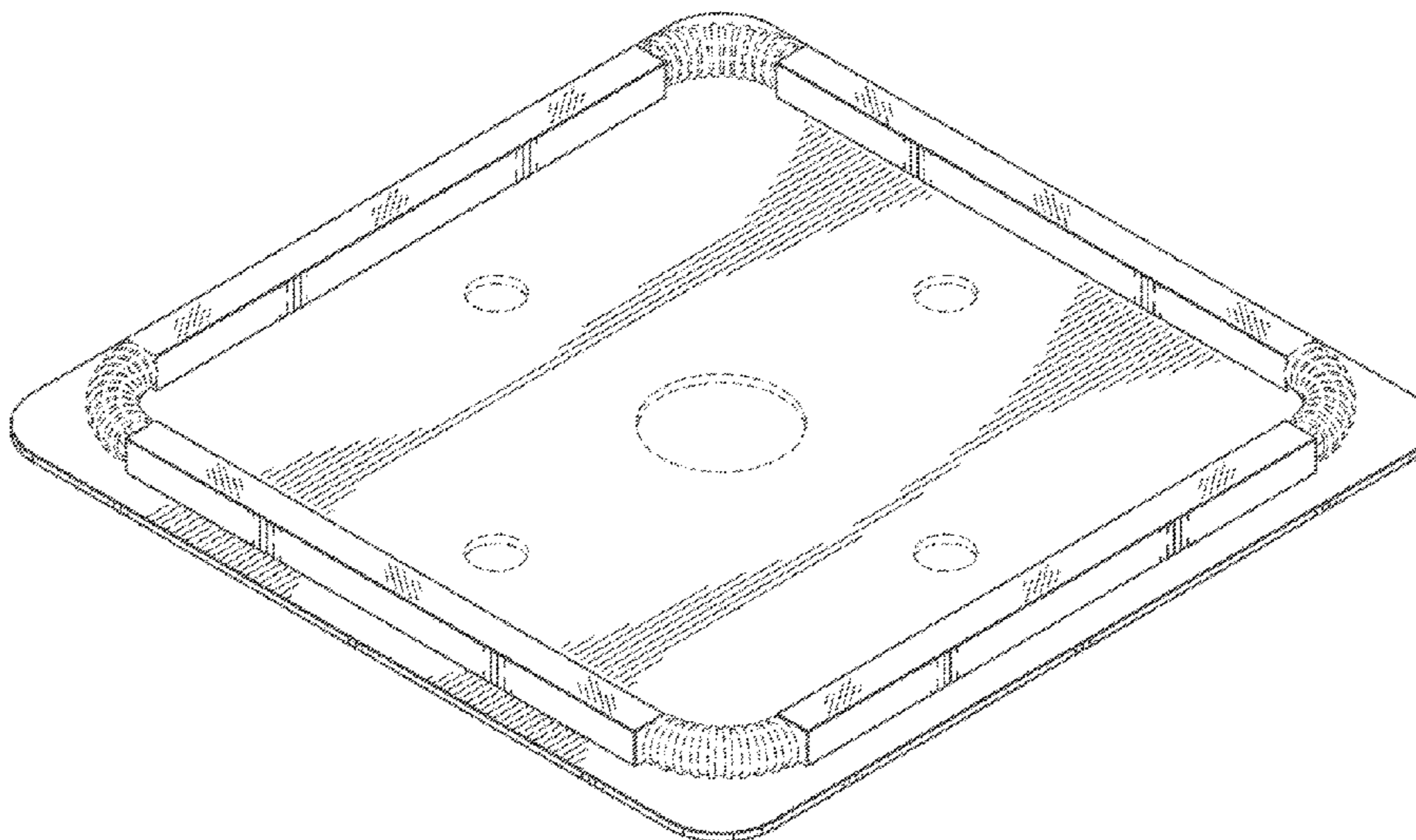
FIG. 1 is a front perspective view of a light fixture showing my new design.

FIG. 8 is a front perspective view thereof connected to a luminaire.

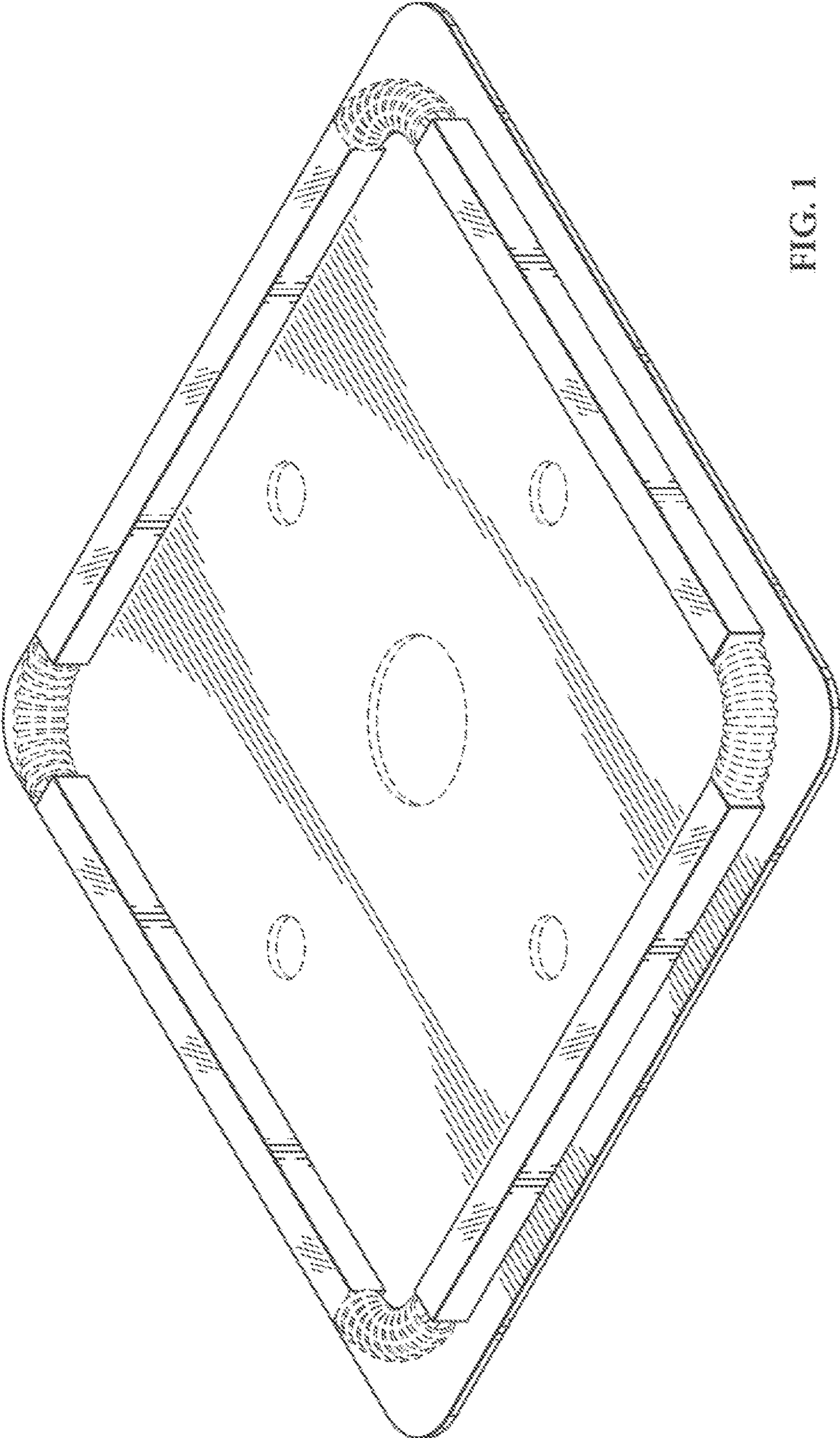

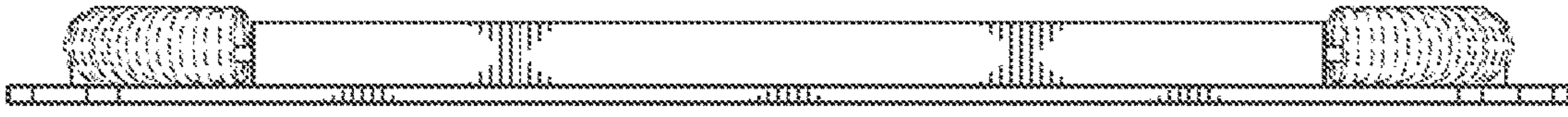

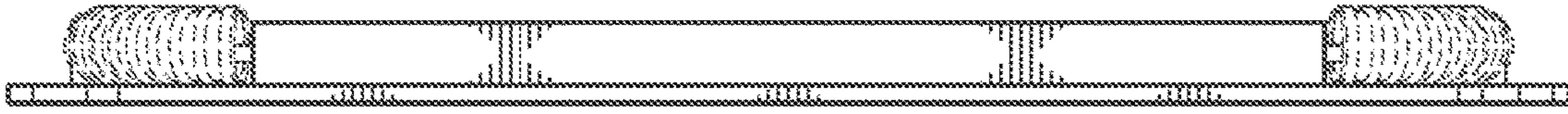

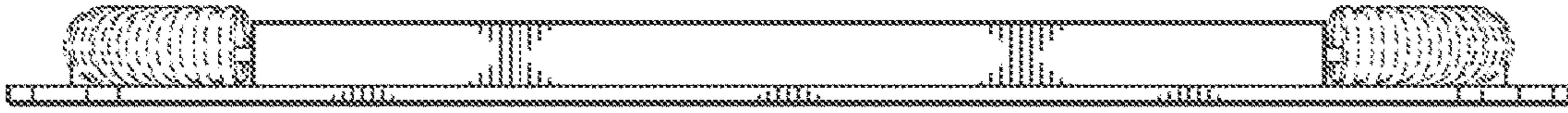

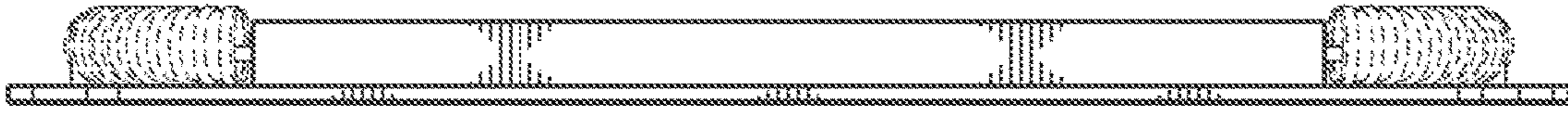

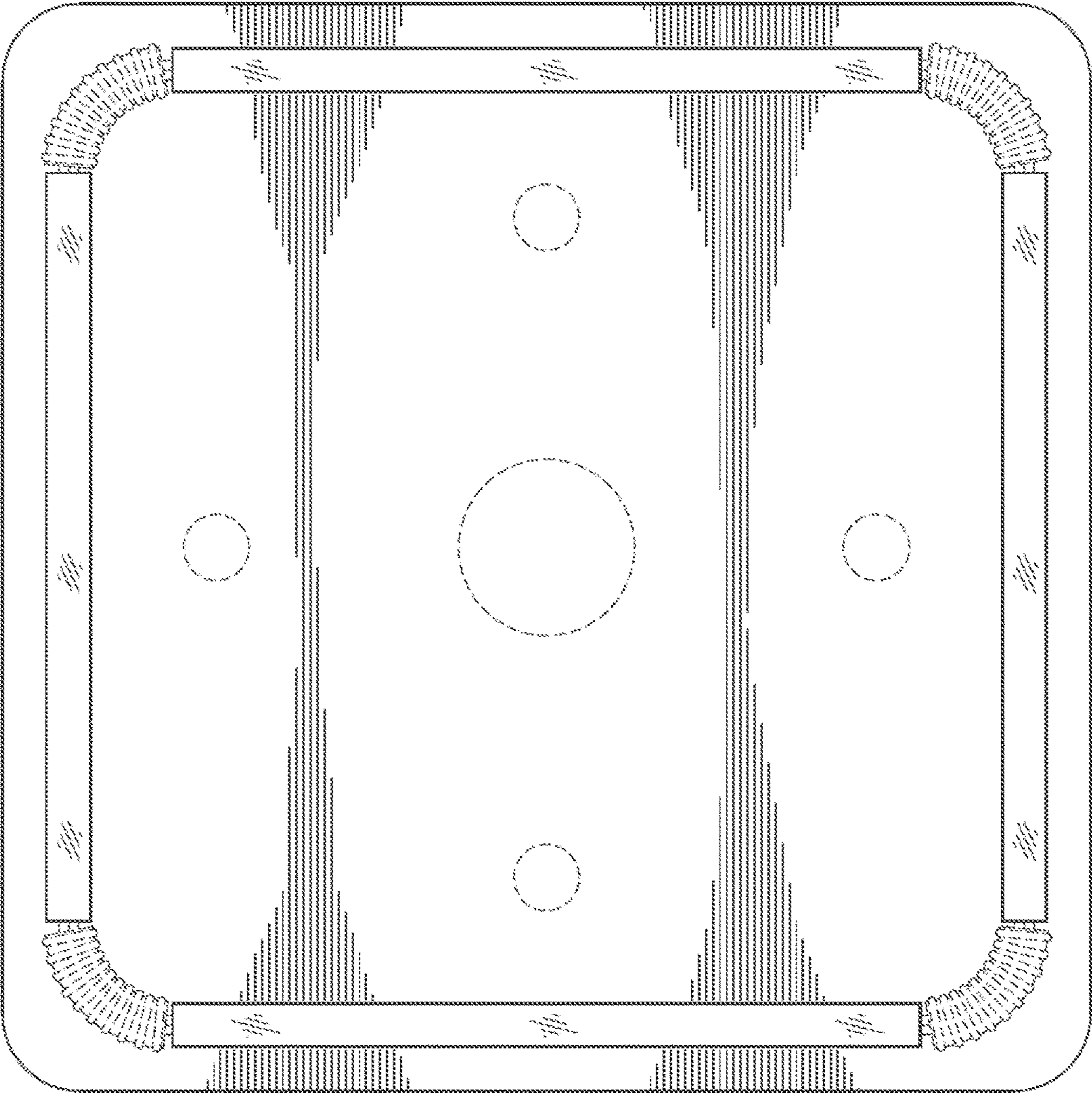
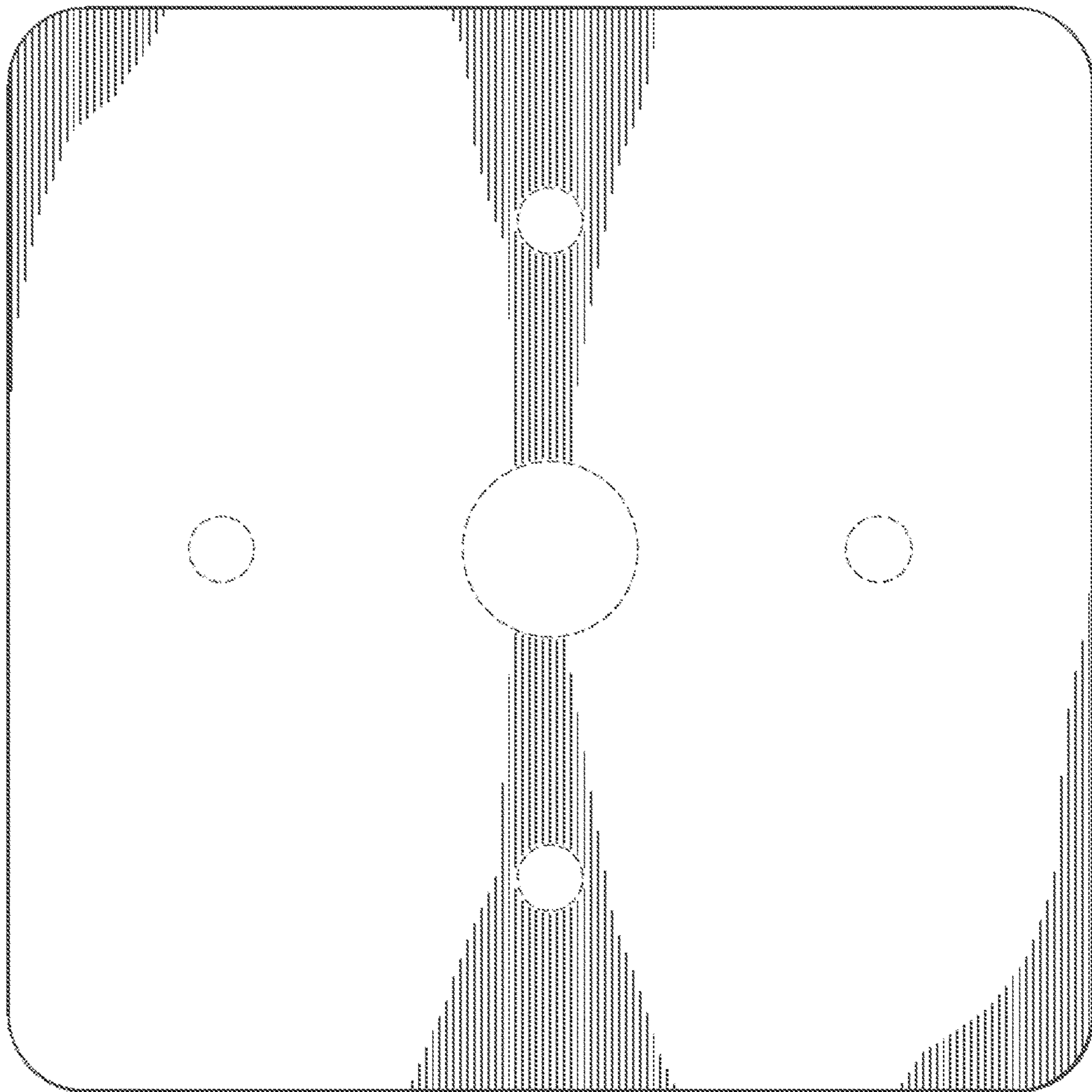

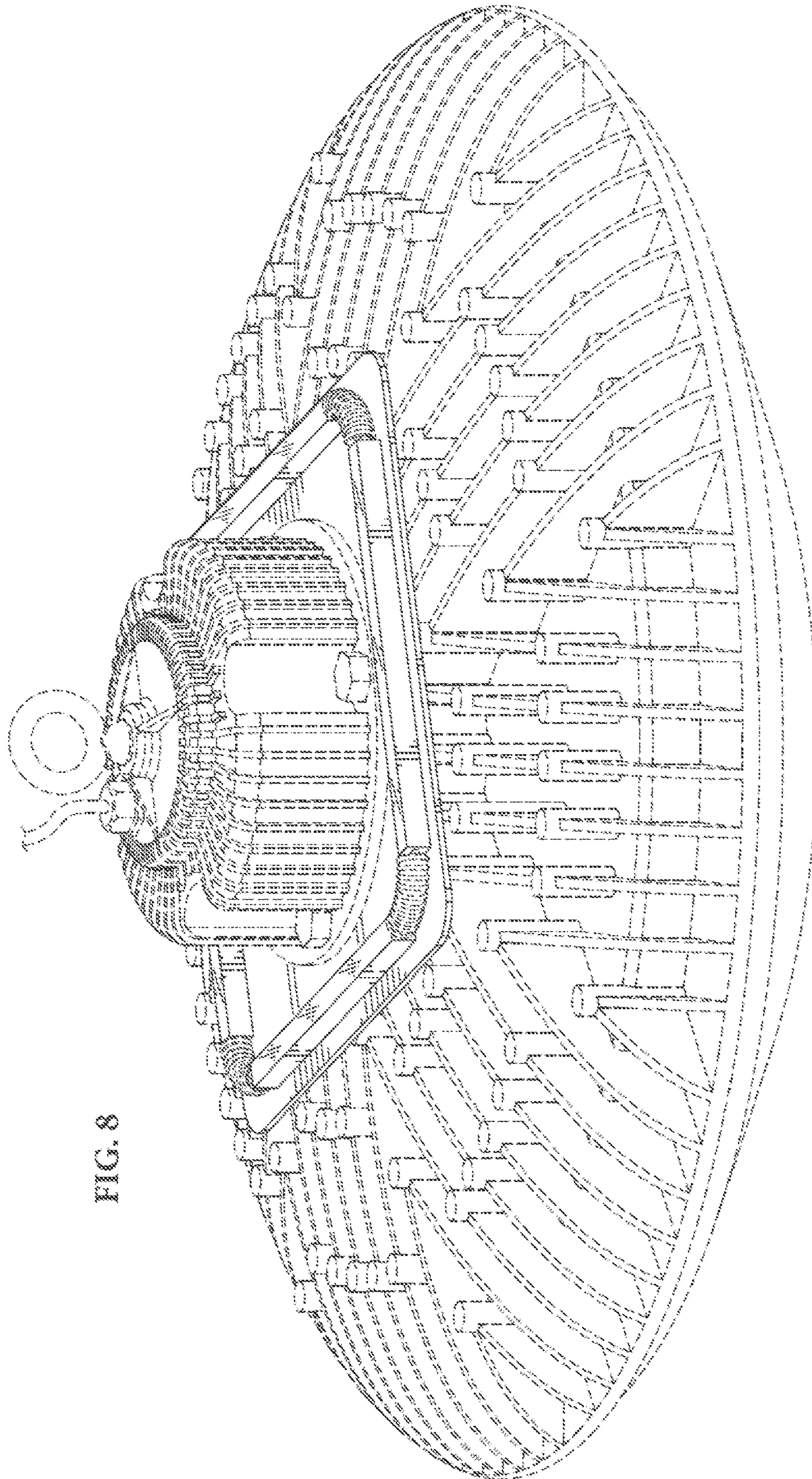
