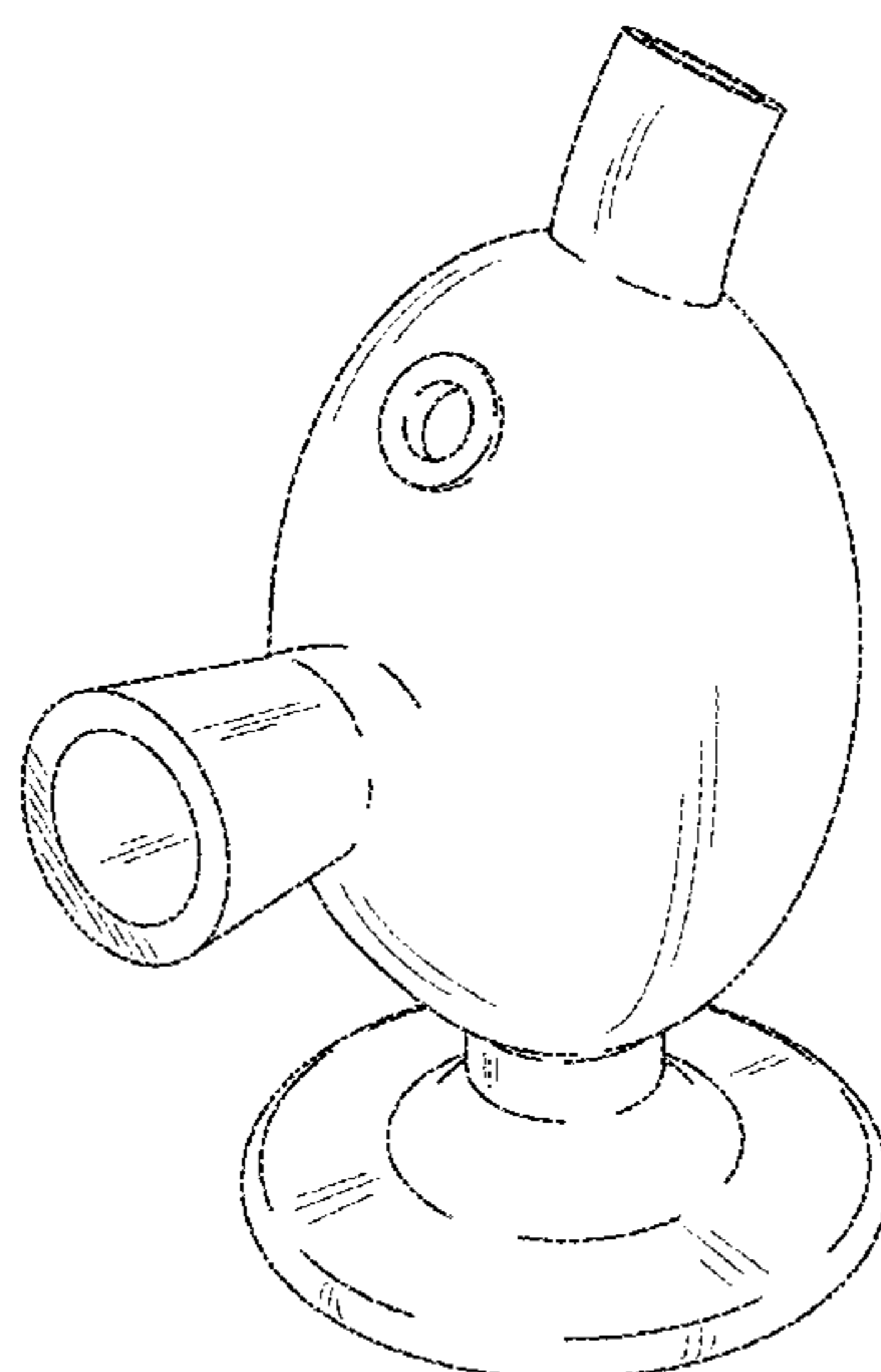
(57) **CLAIM**

I claim the ornamental design for a water filter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a water filter;
FIG. 2 is a front view of the water filter of FIG. 1;

FIG. 4 is a side view of the water filter of FIG. 1;
FIG. 5 is an additional side view of the water filter of FIG. 1;

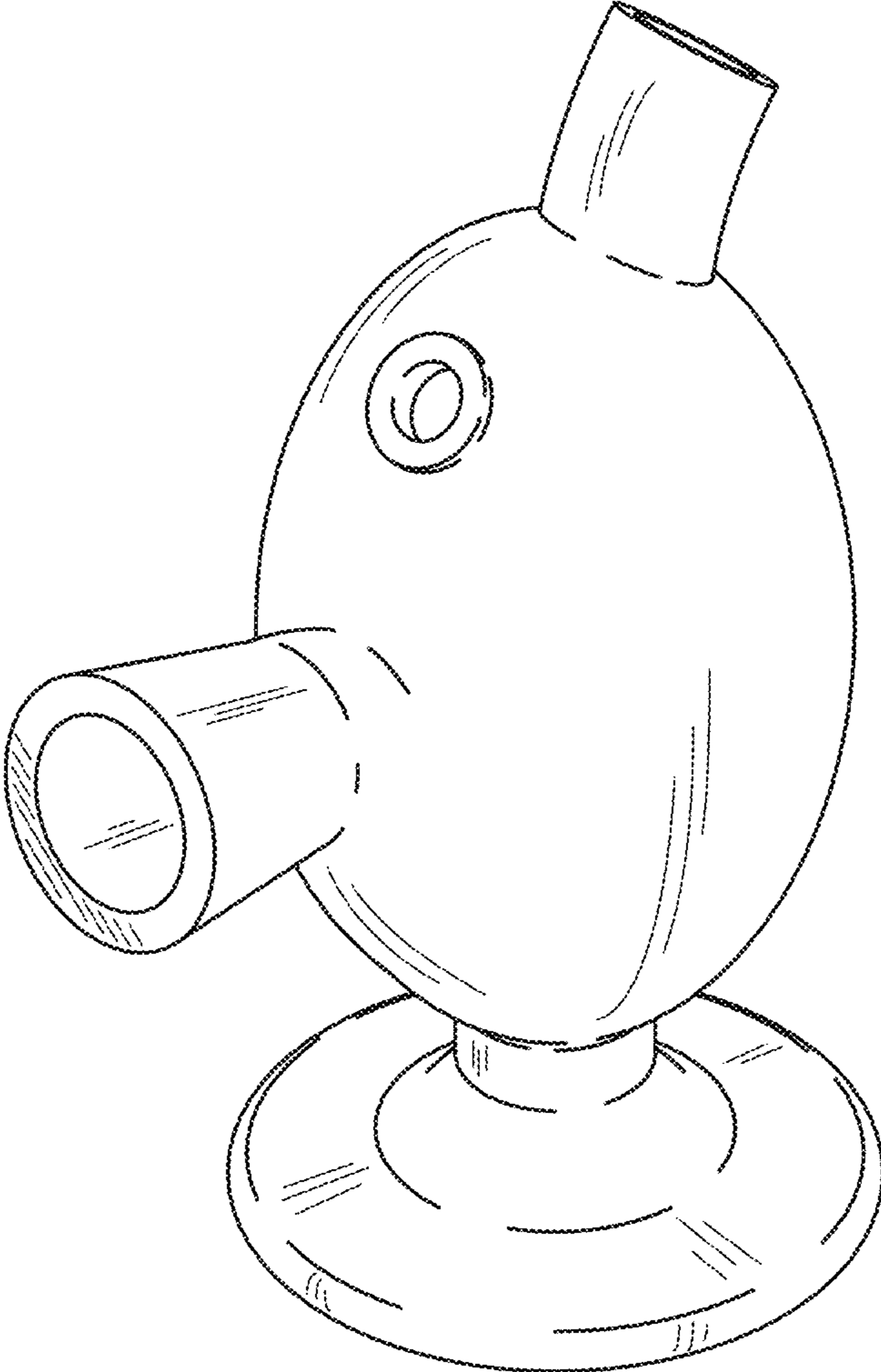

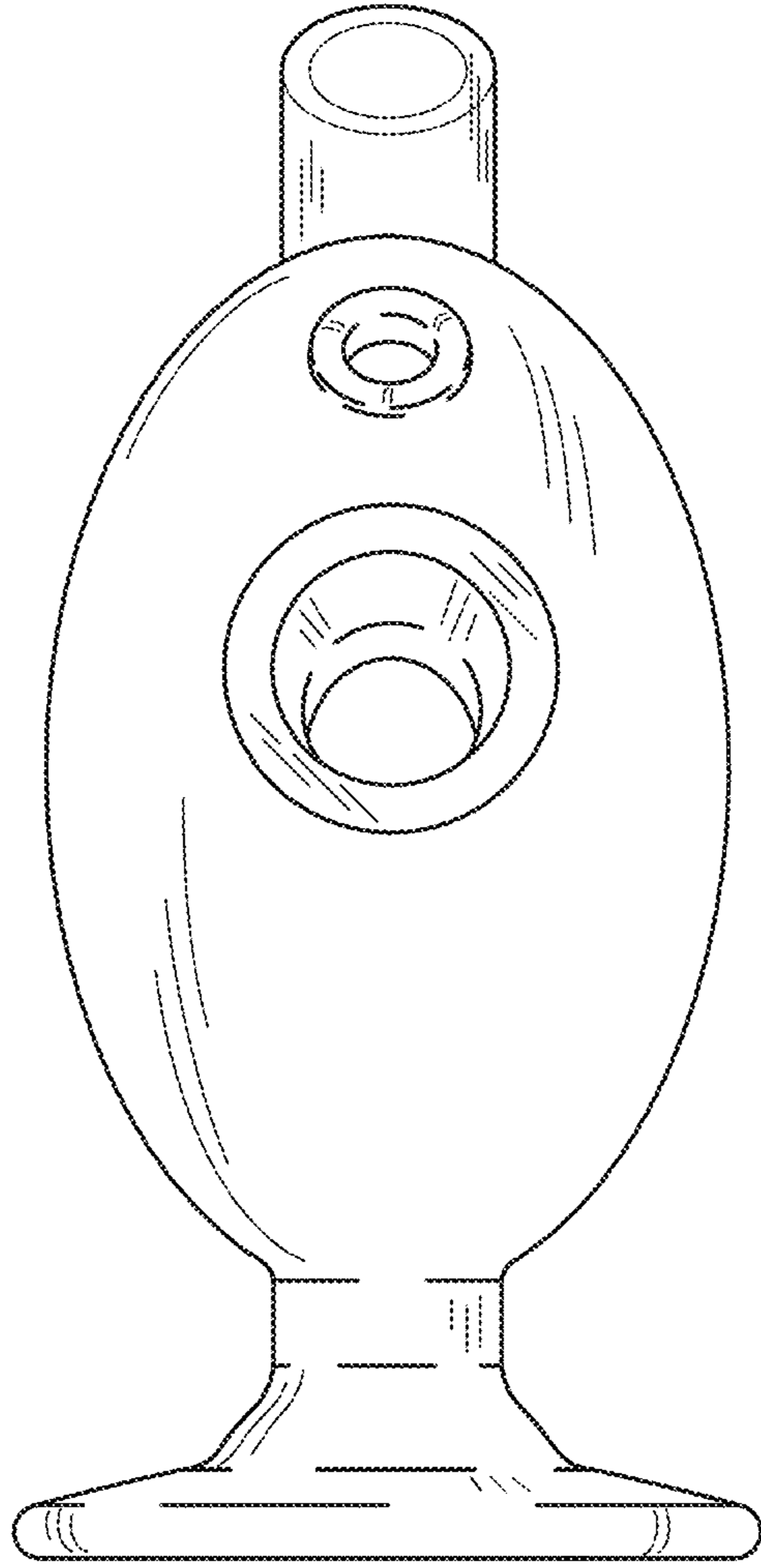

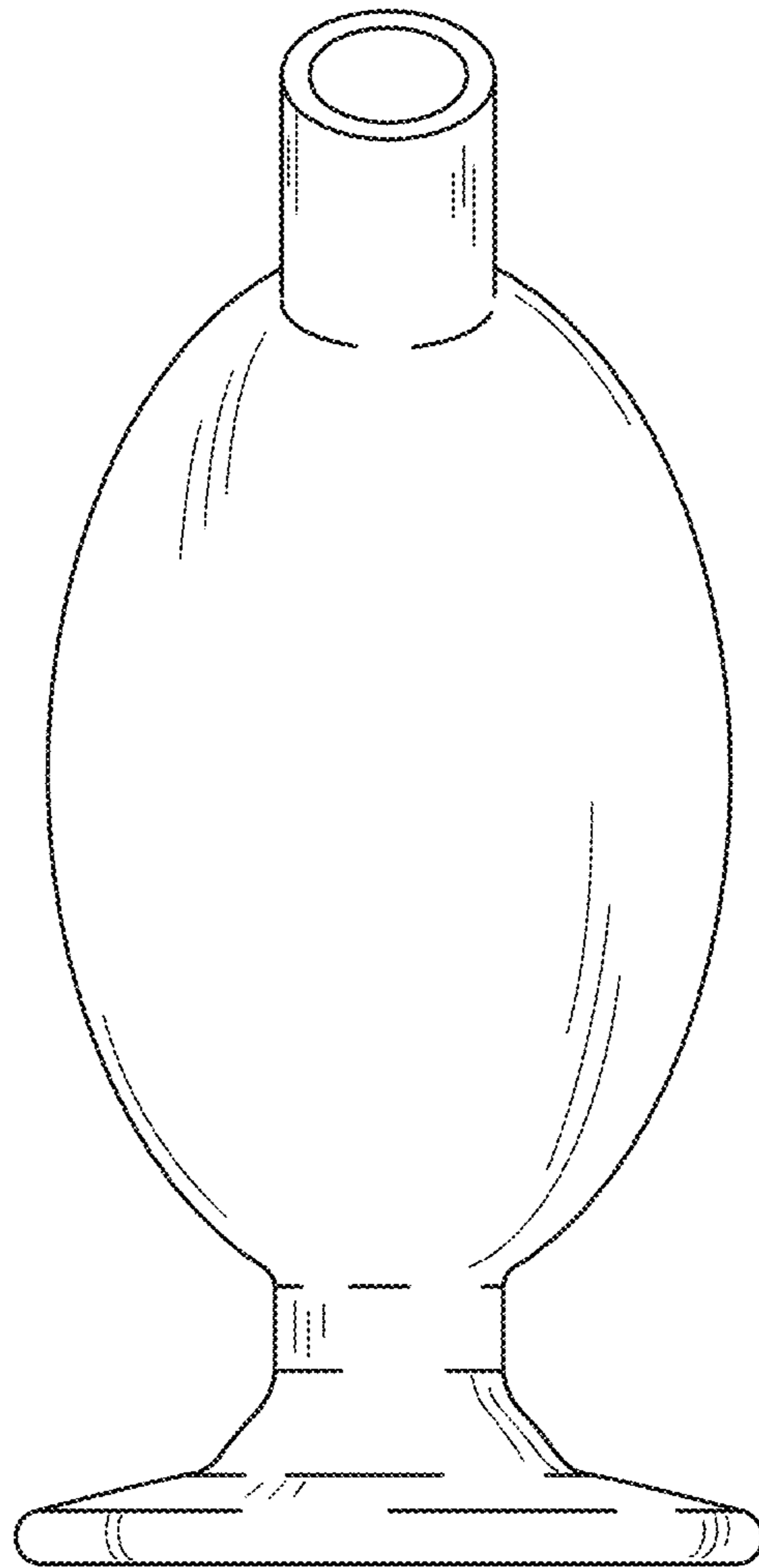

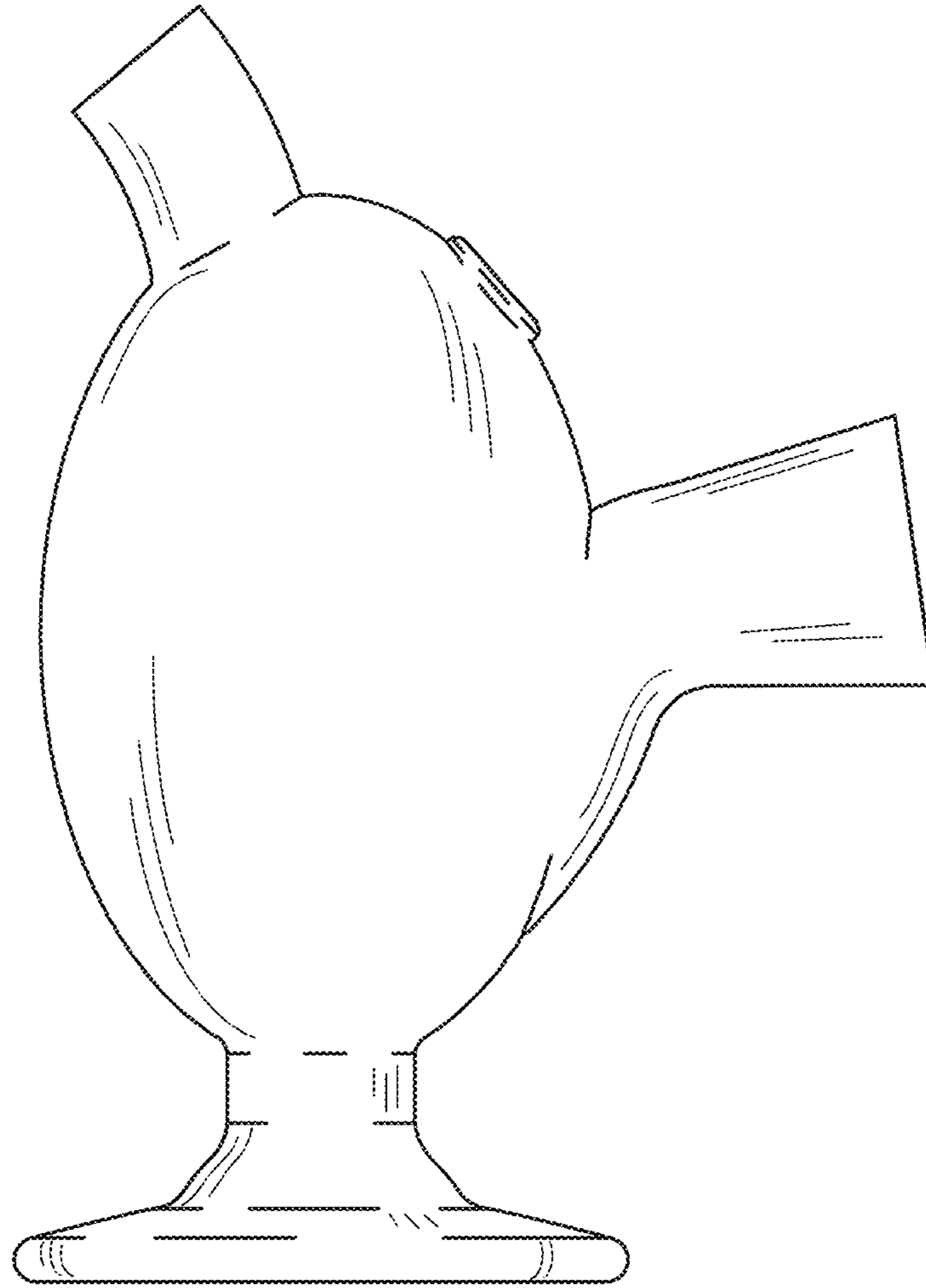

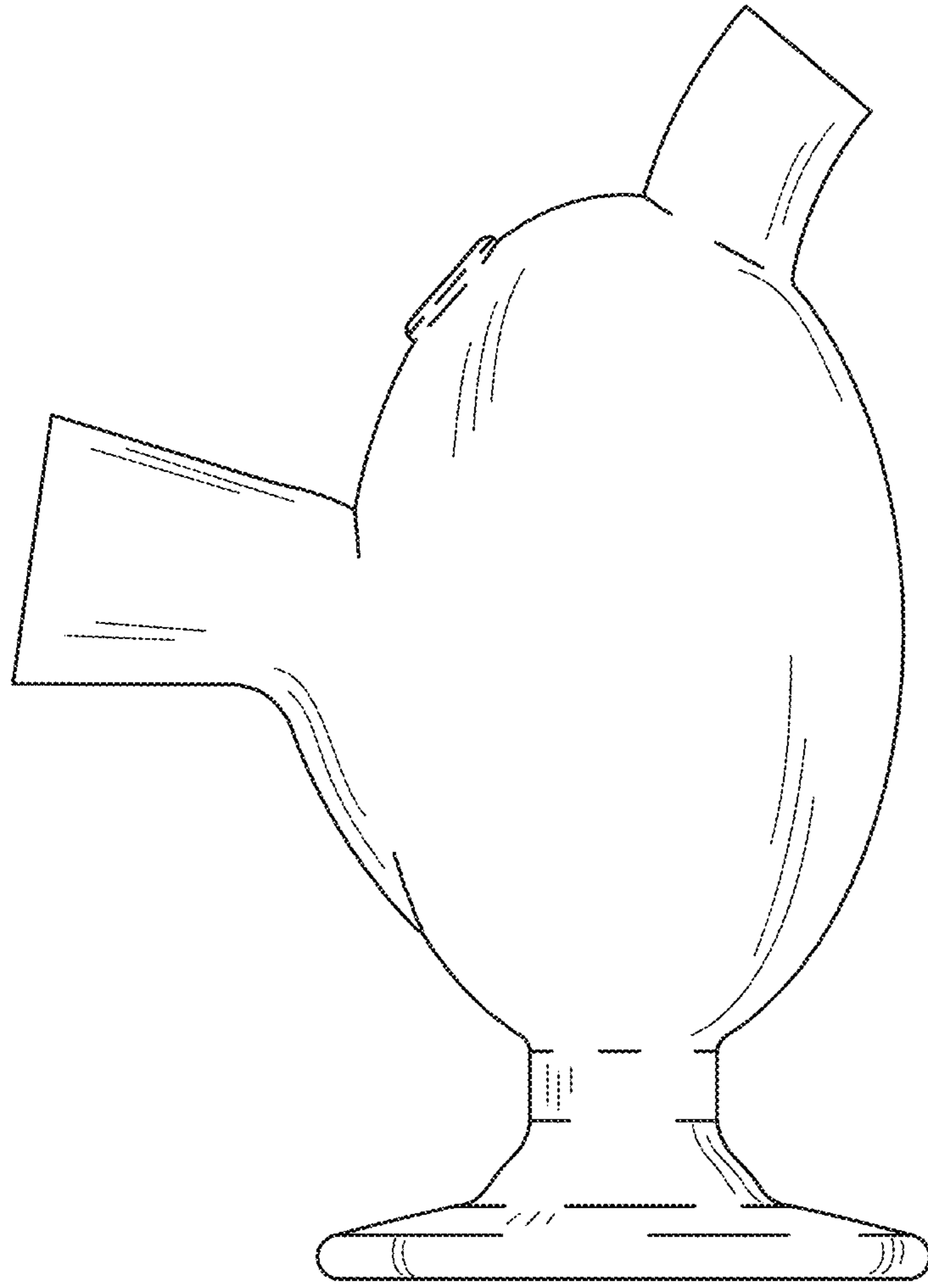

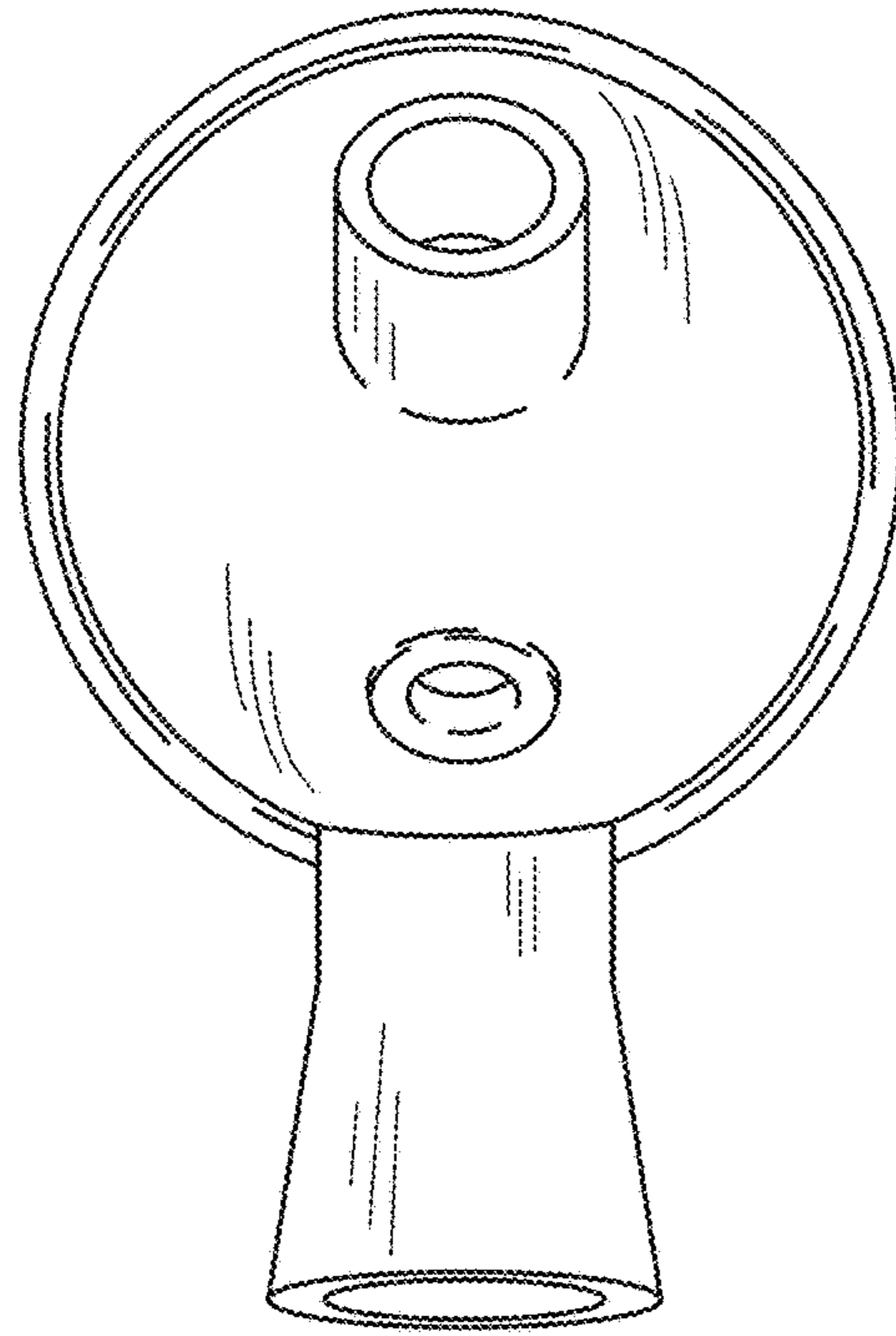

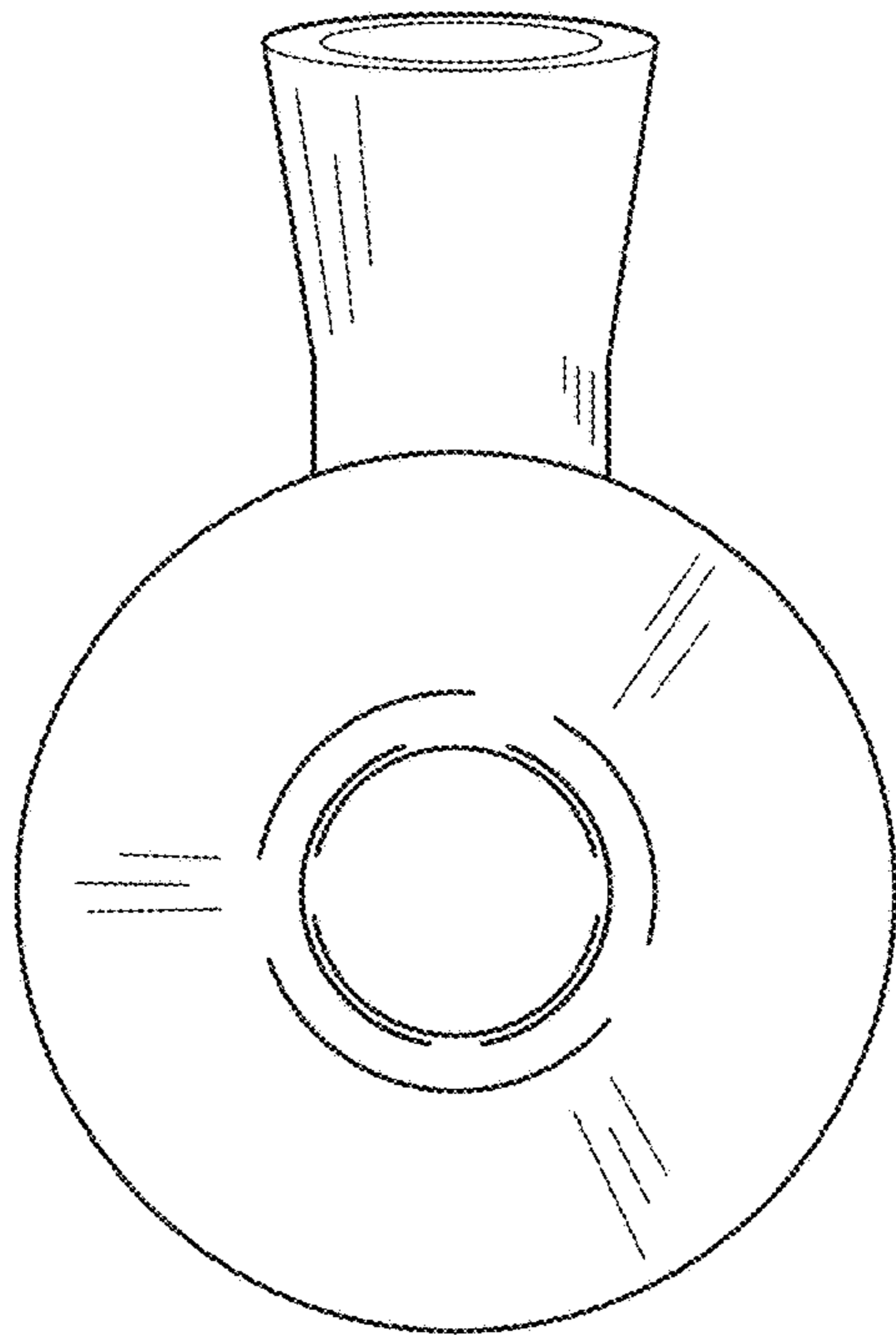
