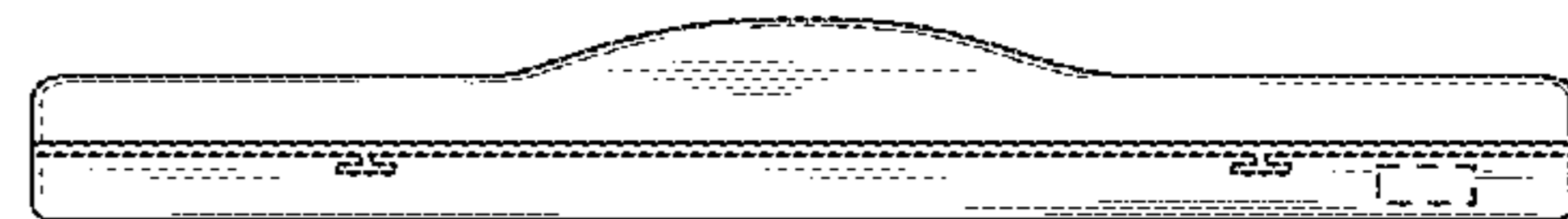
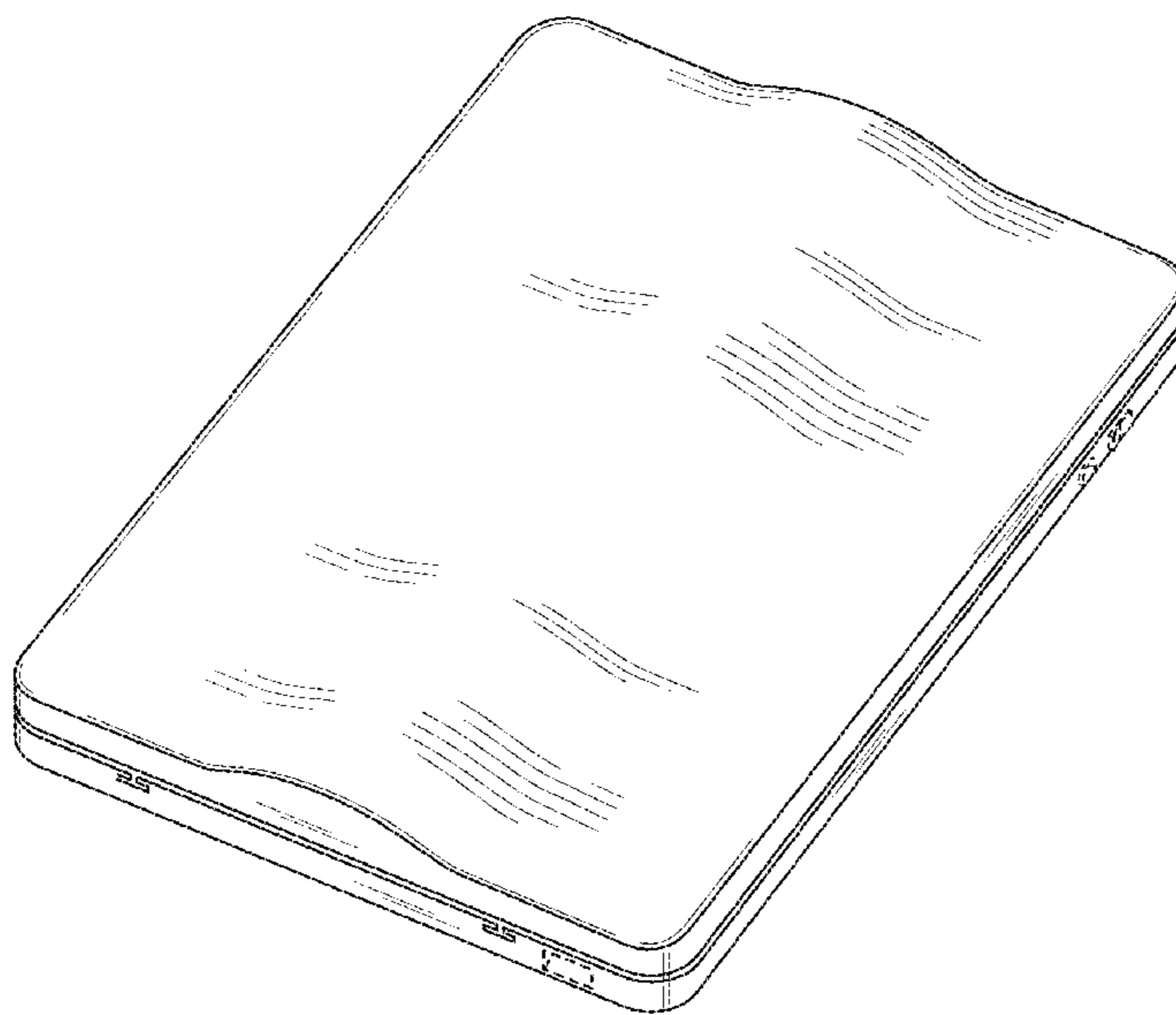
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a wall-mounted back
scrubber, showing our new design.
FIG. 2 is a front elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top plan view thereof; and,

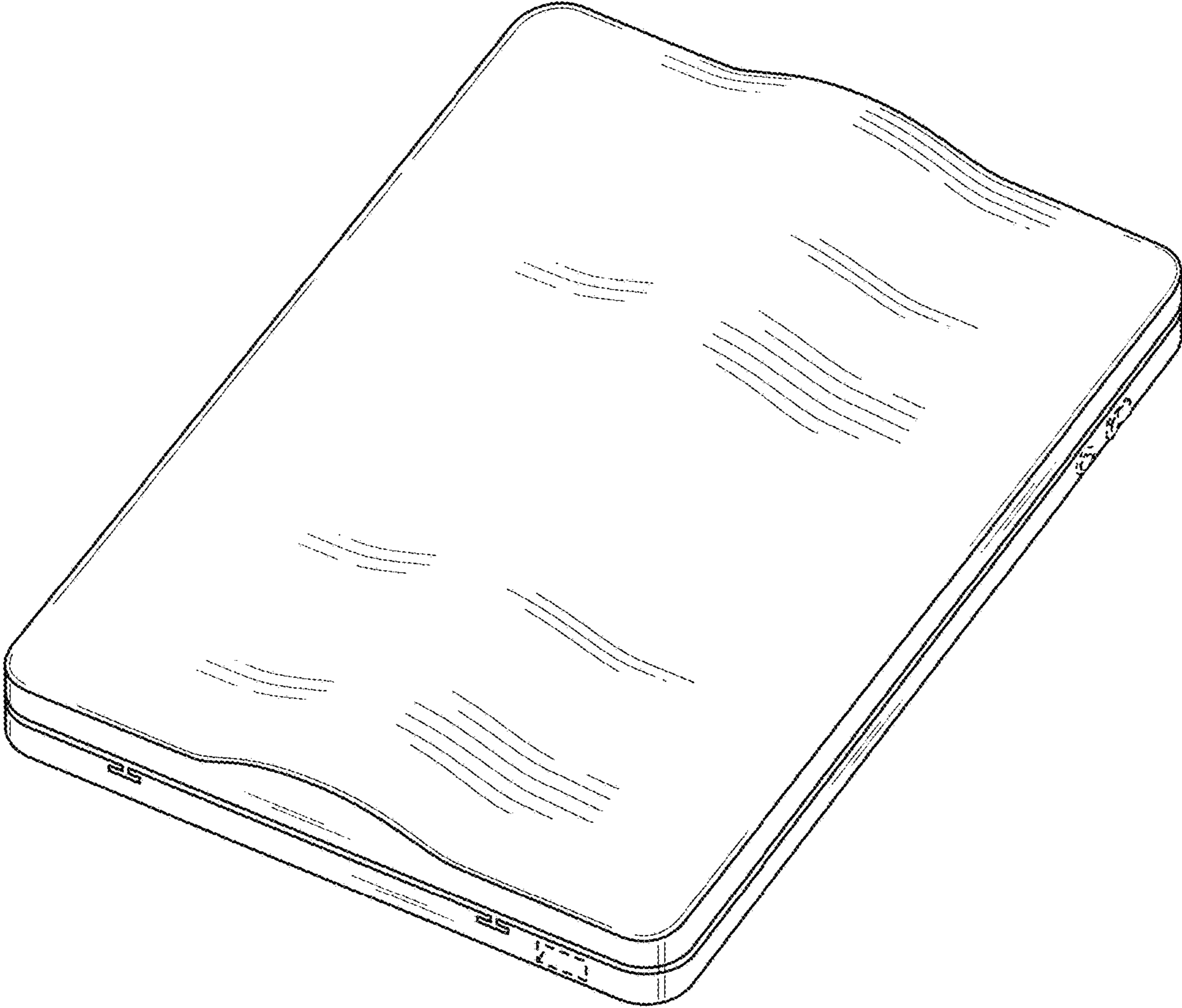

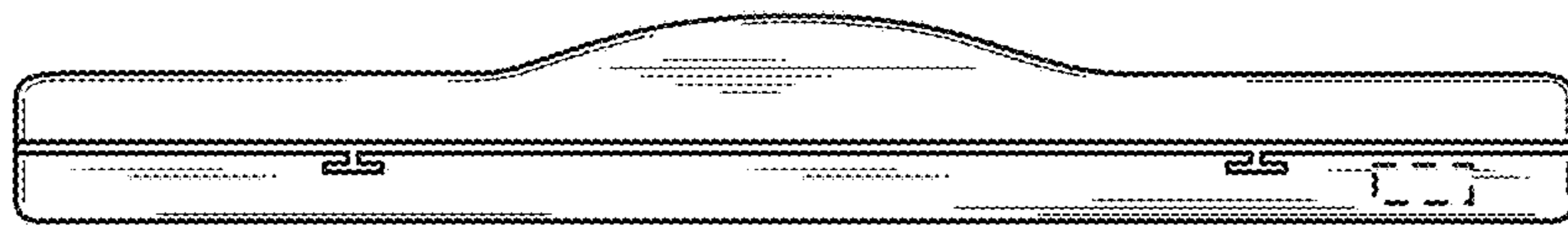

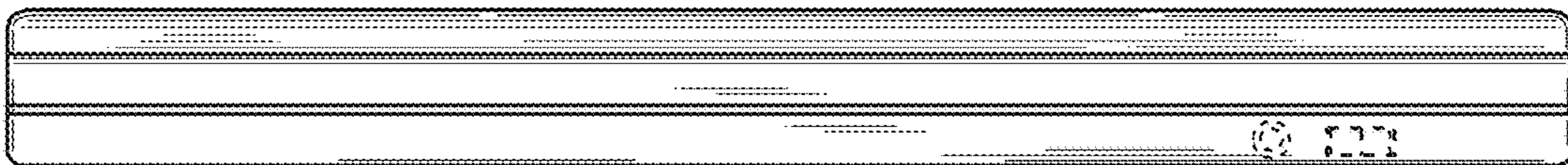

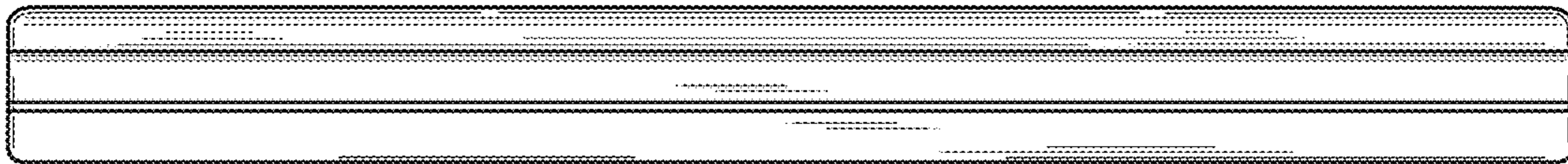

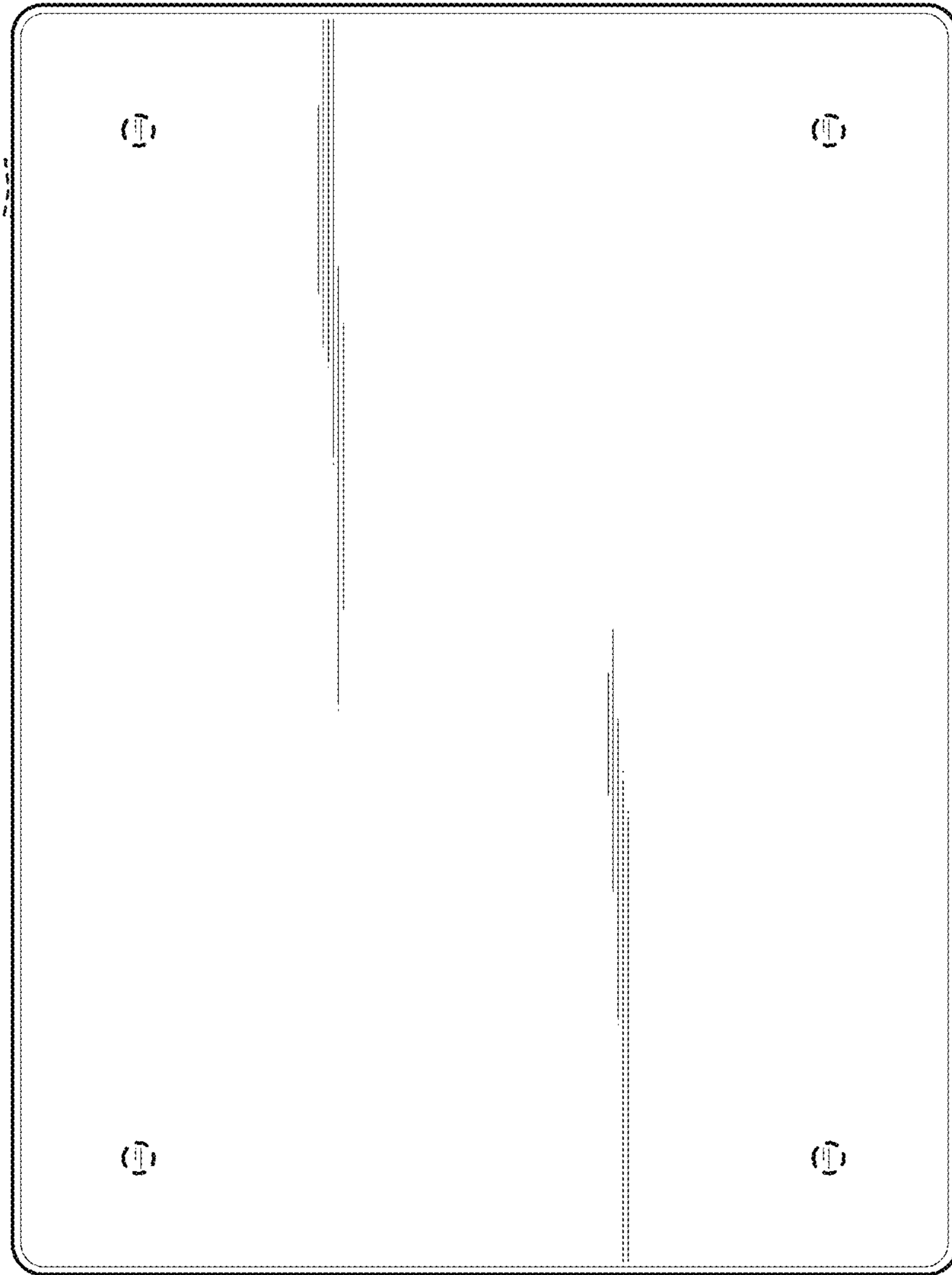

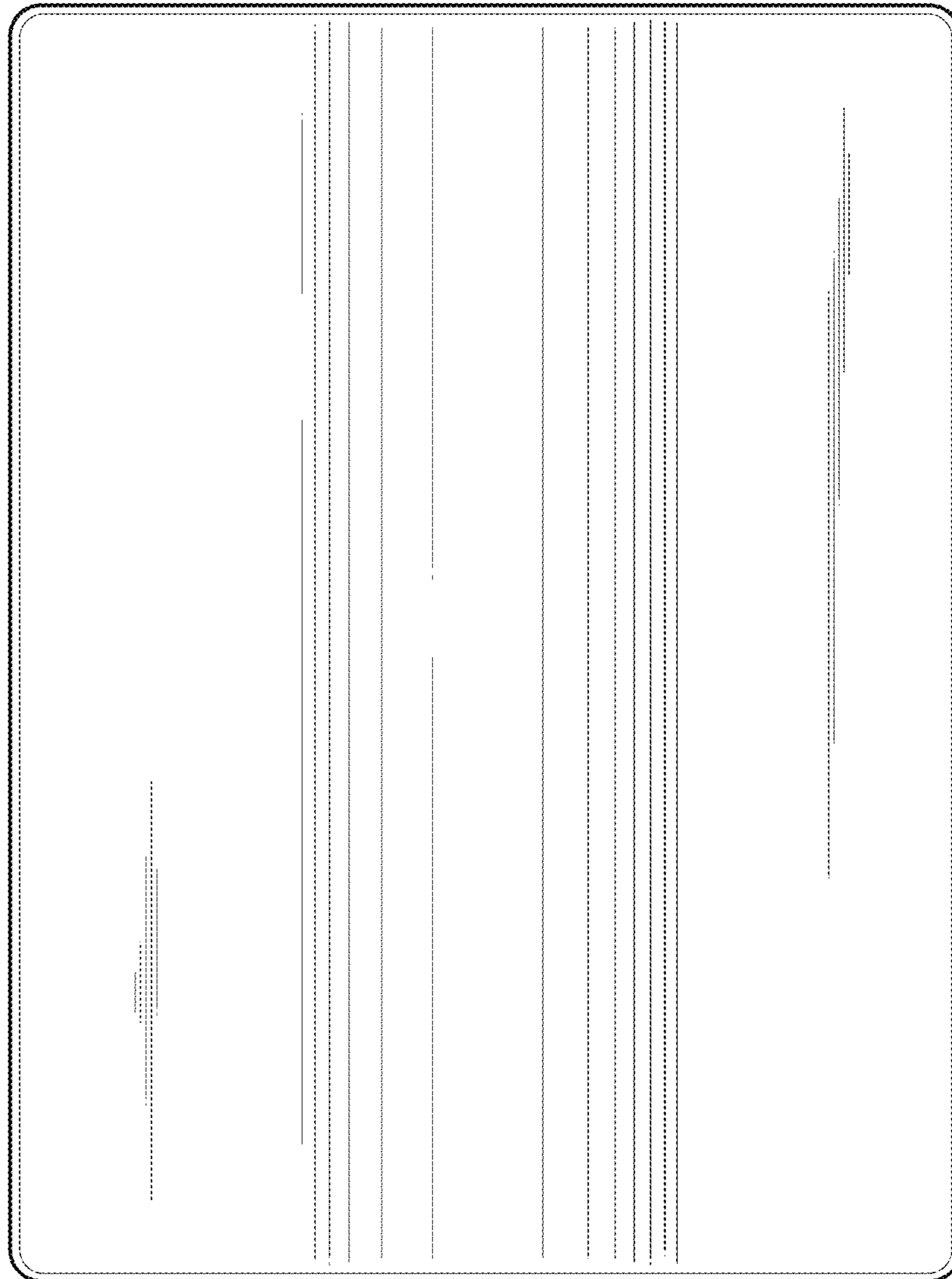

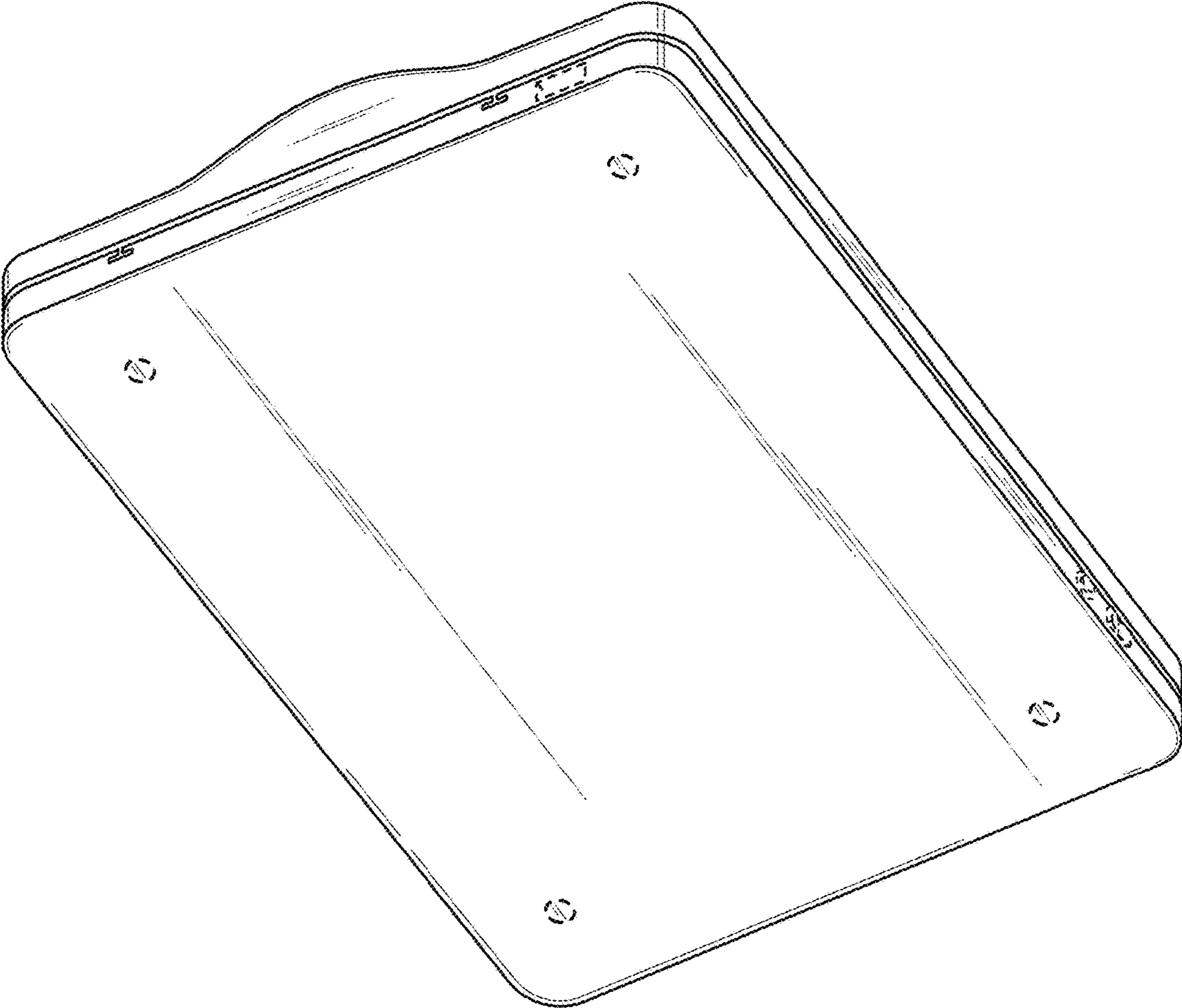
