We claim the ornamental design for a pet dish with paw prints, as shown and described.

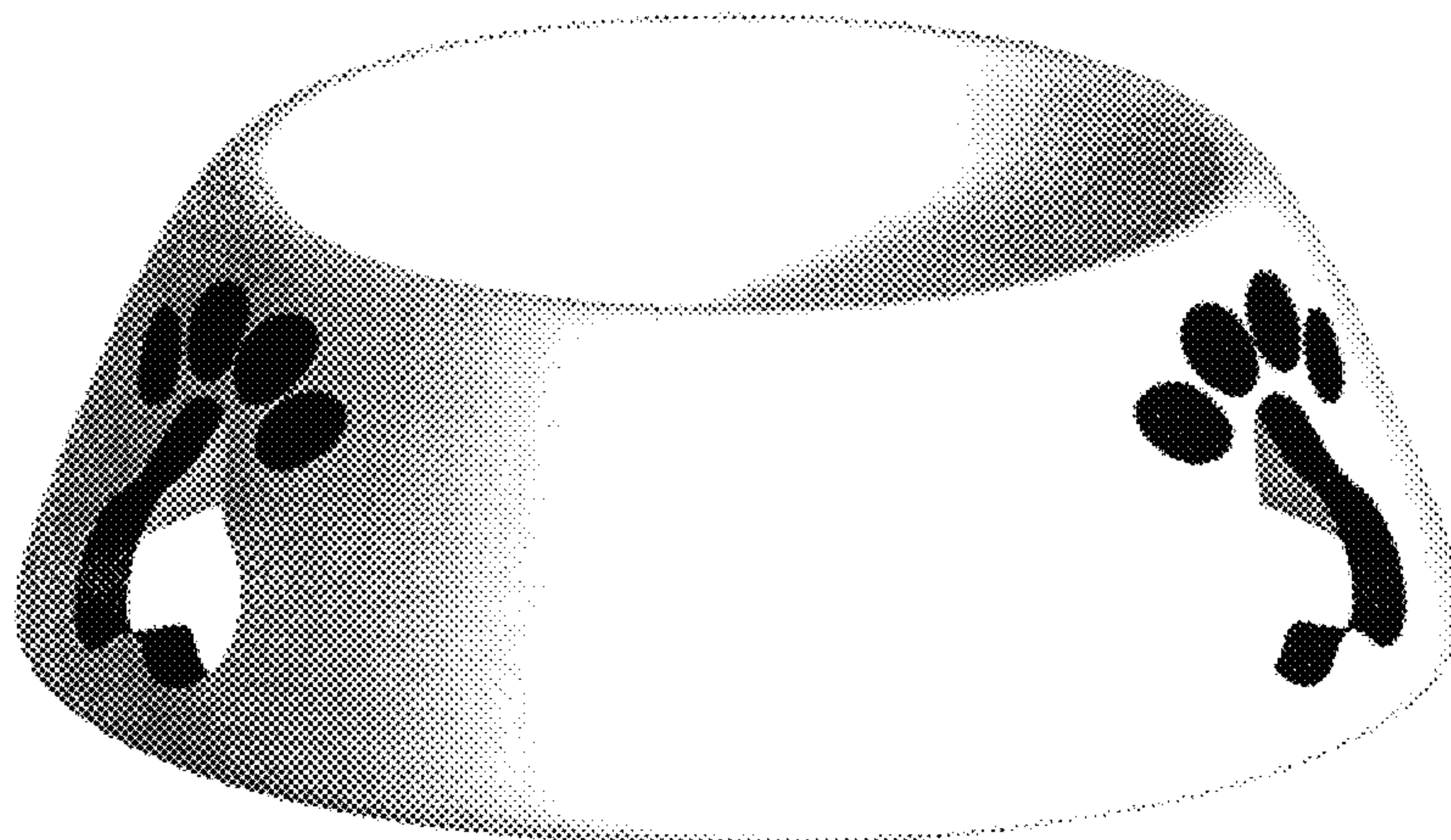
**DESCRIPTION**

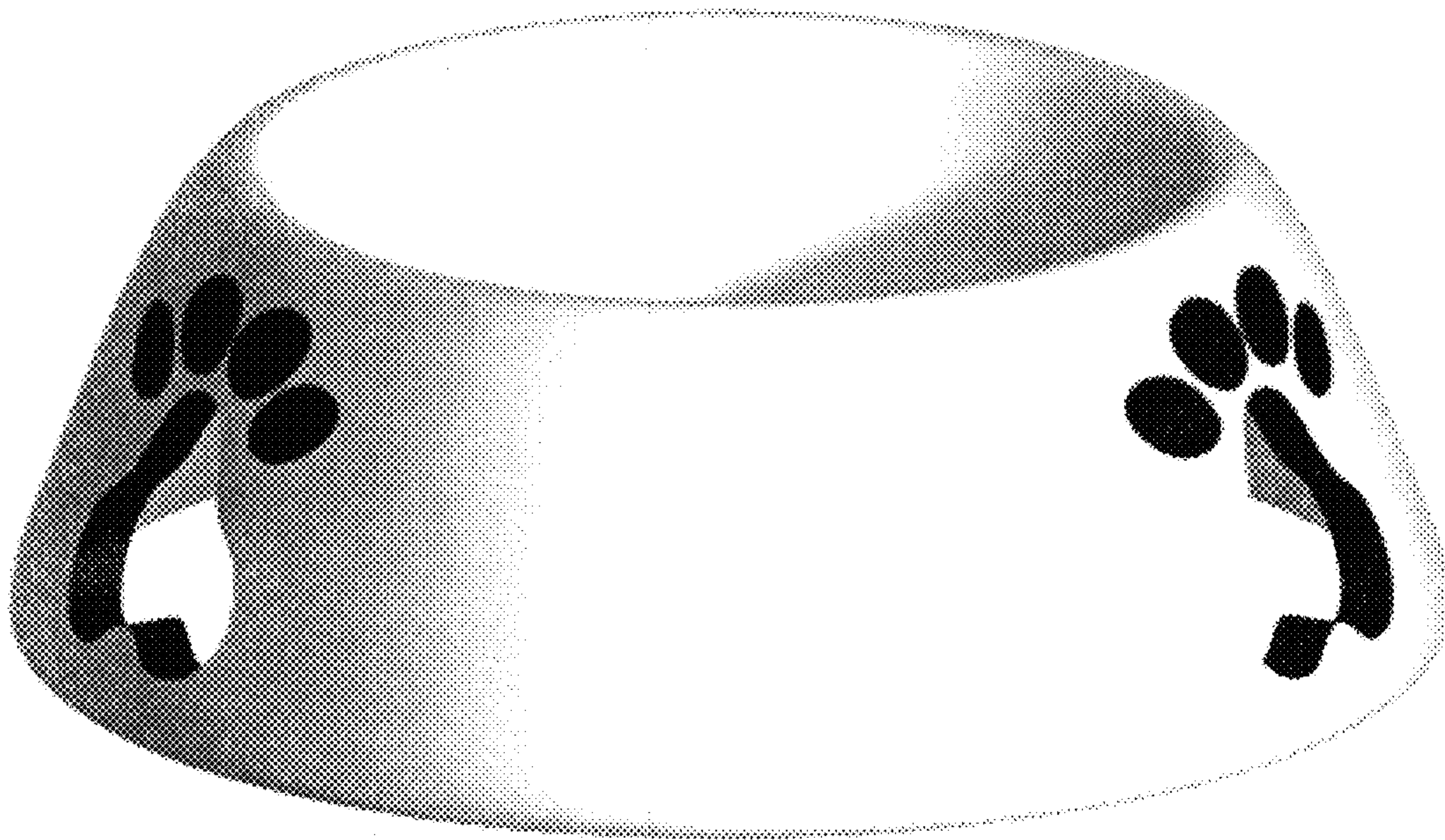

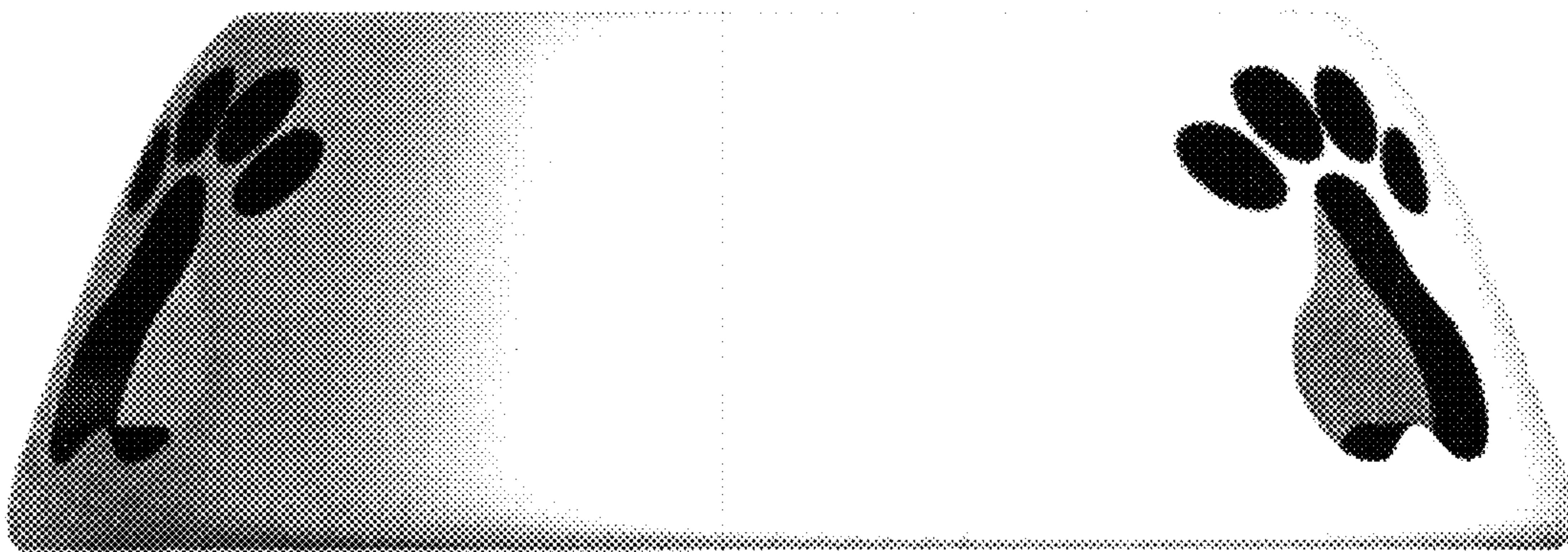
