The ornamental design for a pet bowl holder, as shown and described.

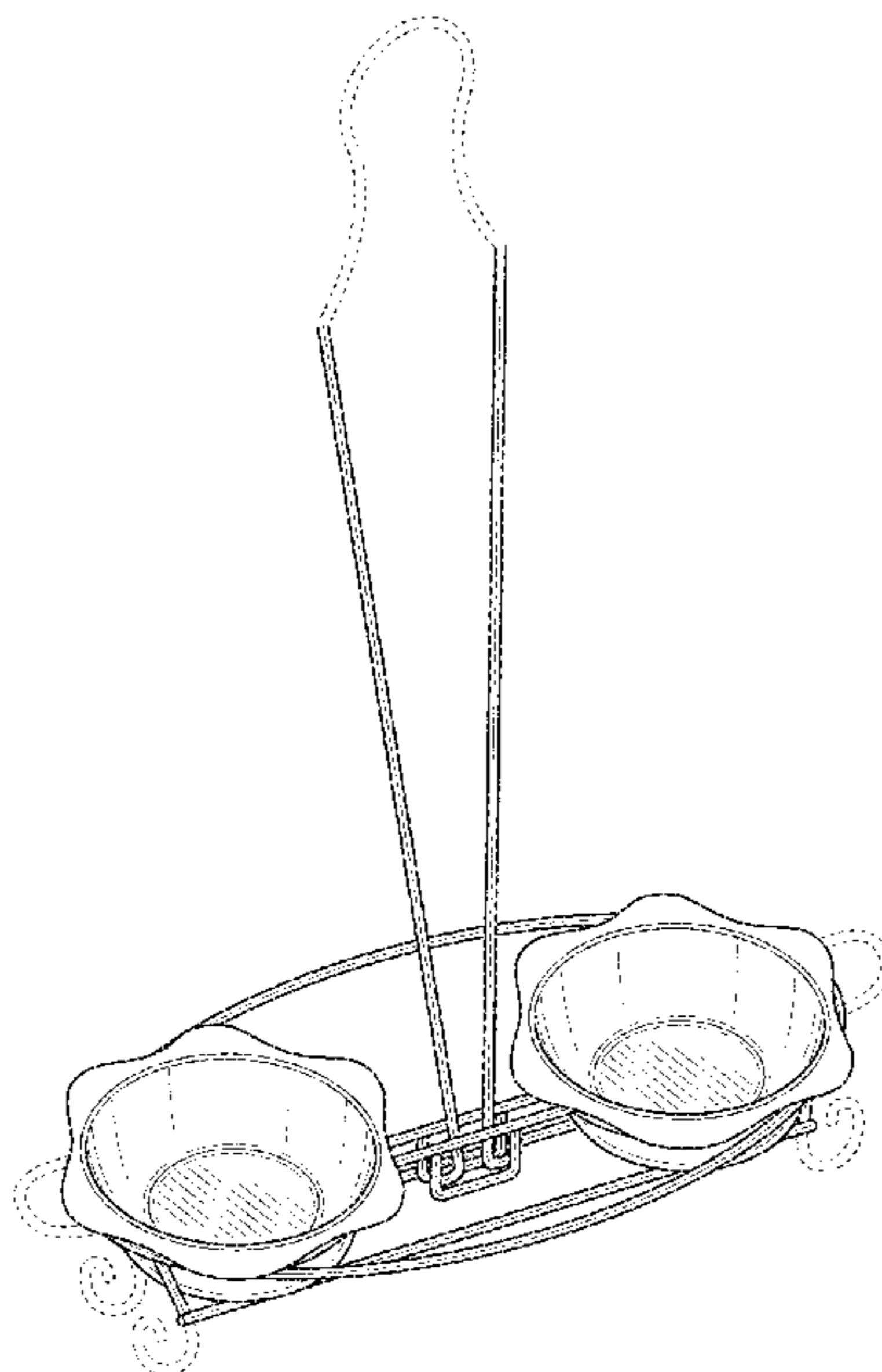
DESCRIPTION

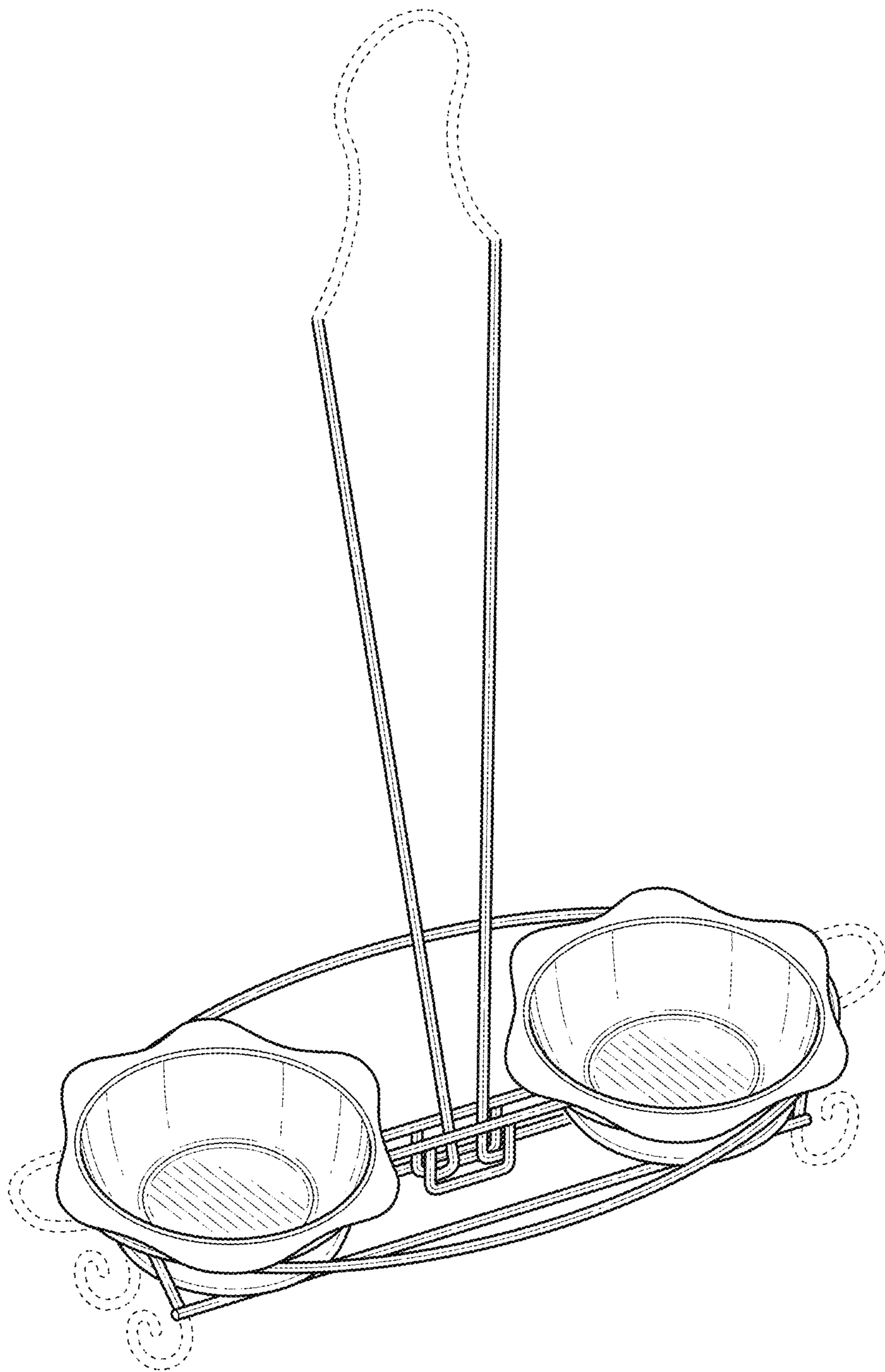

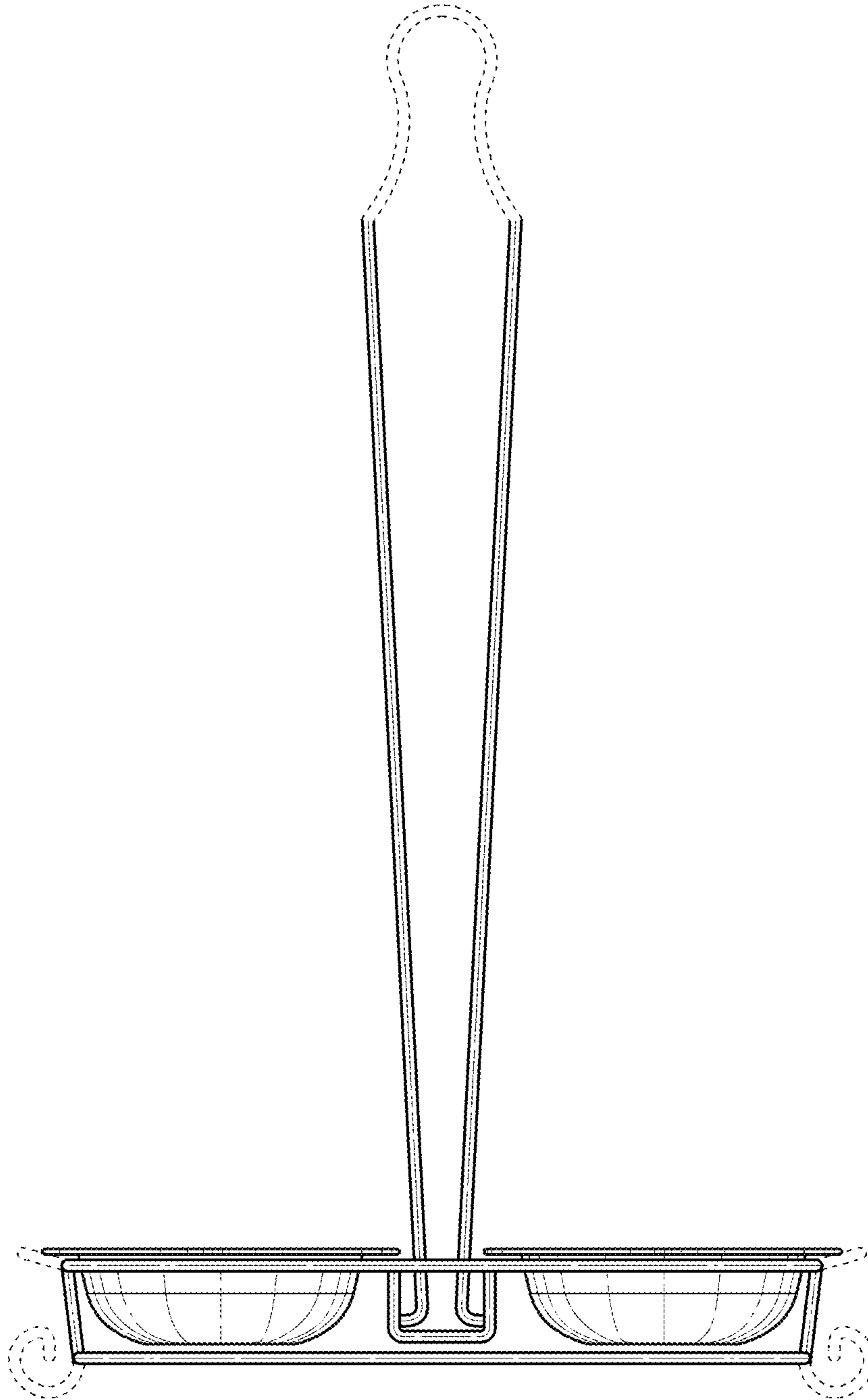

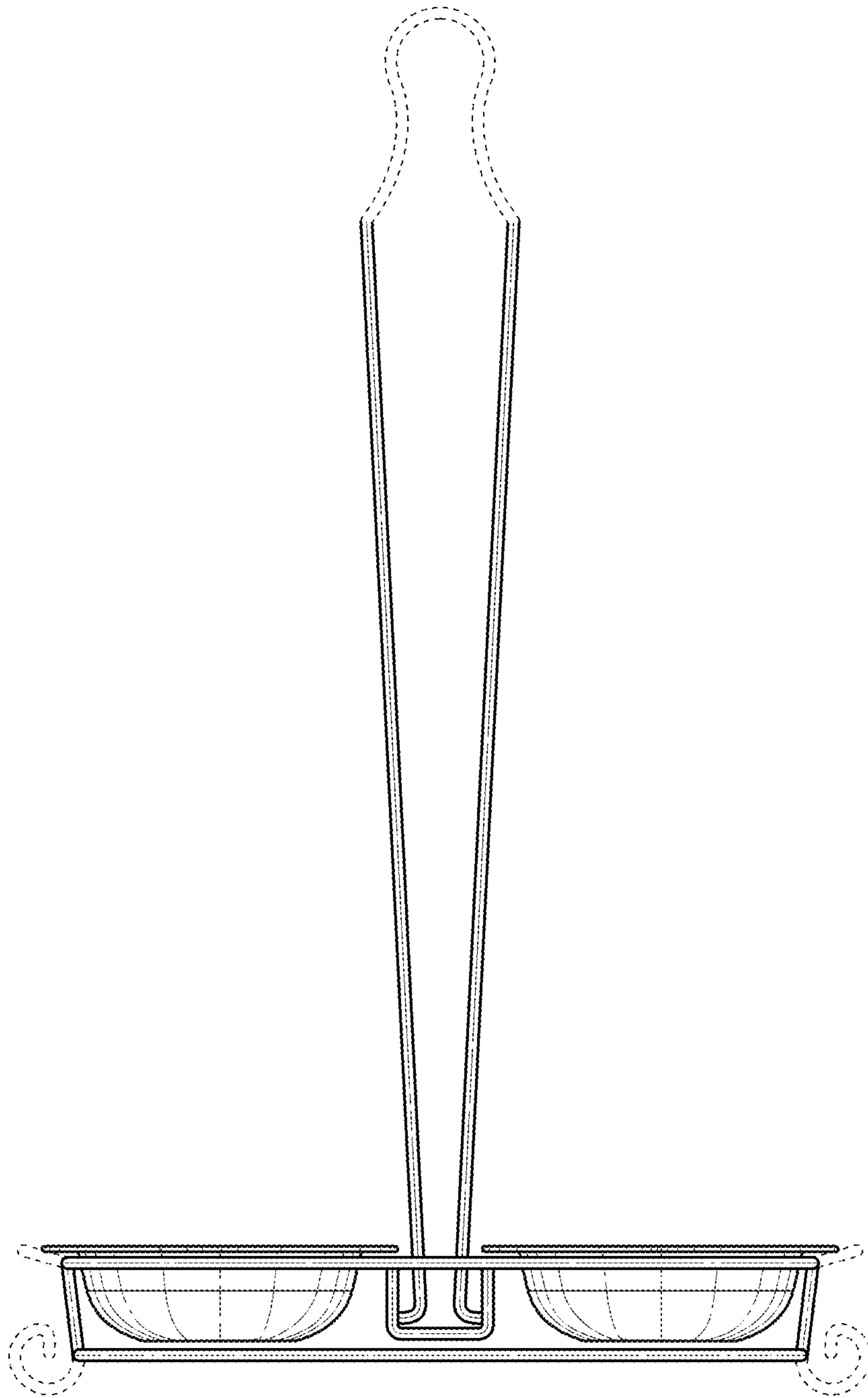

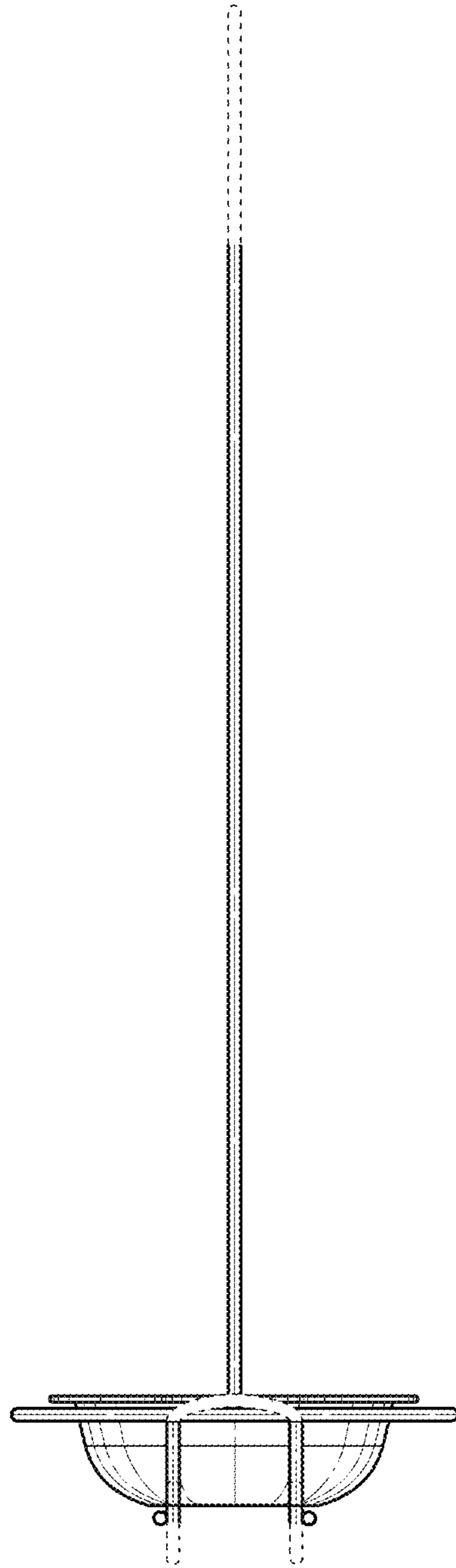

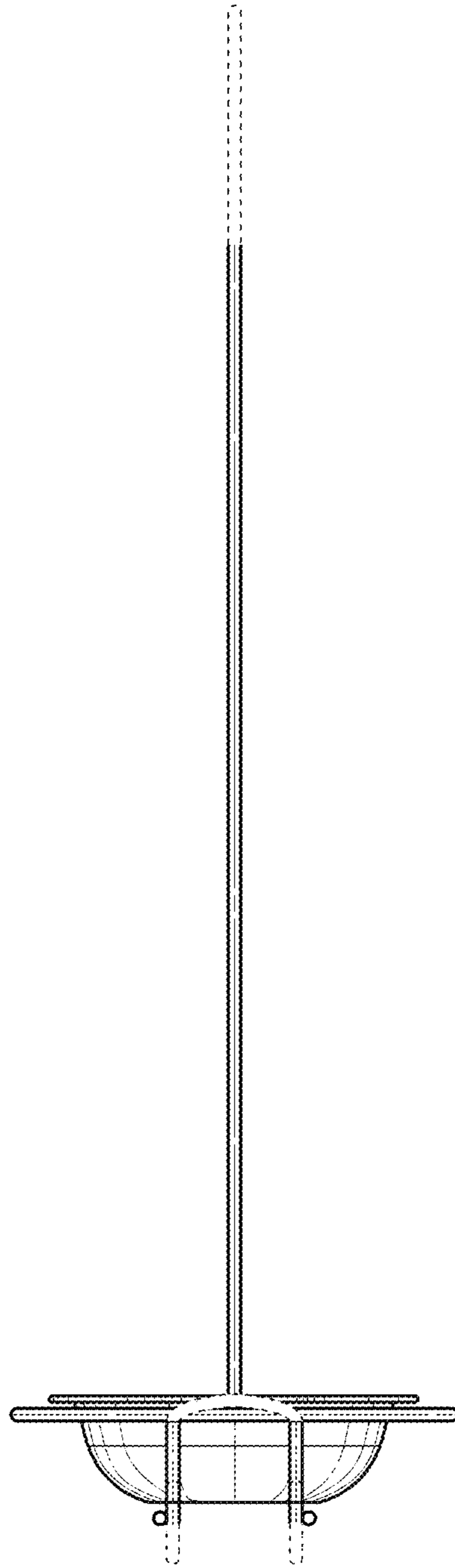

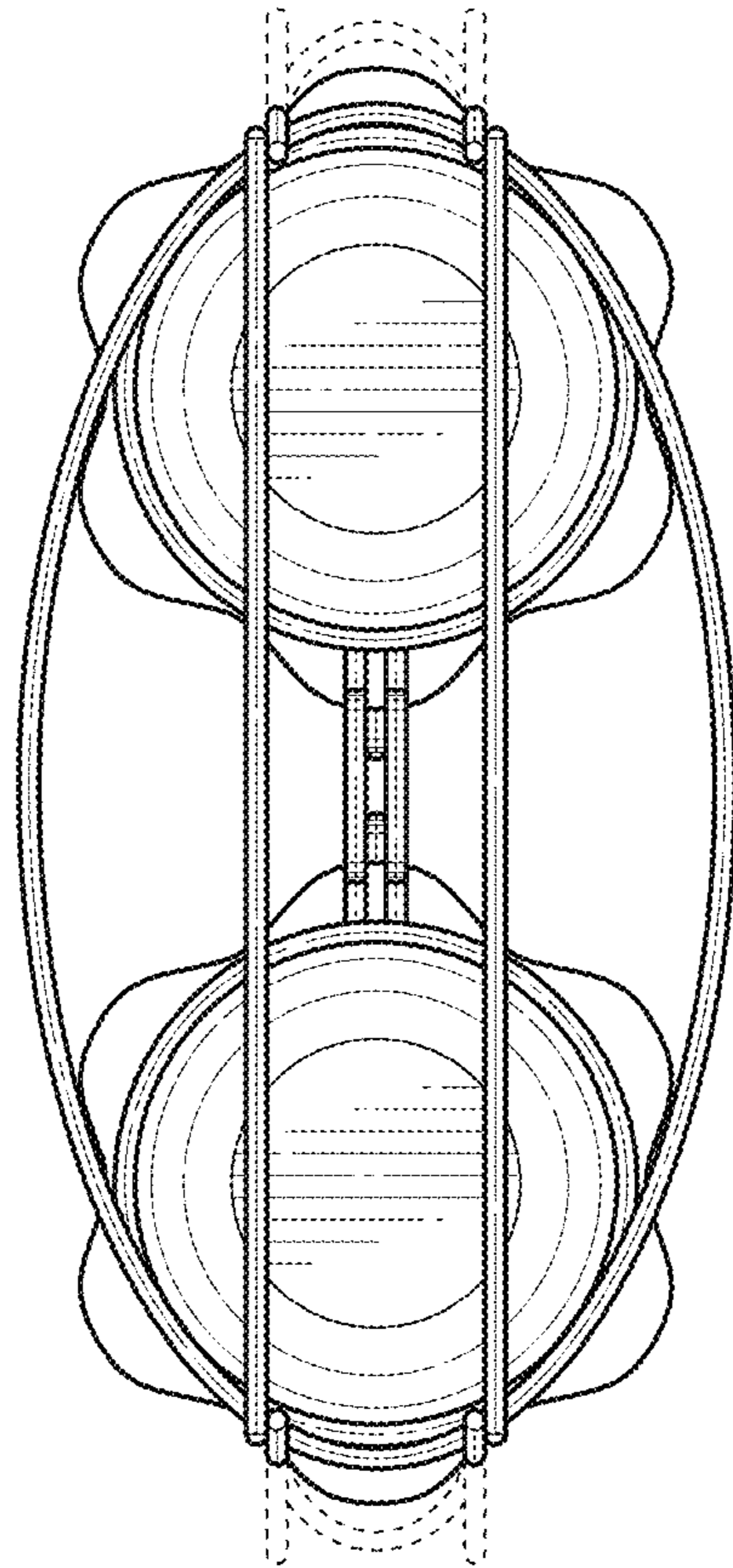

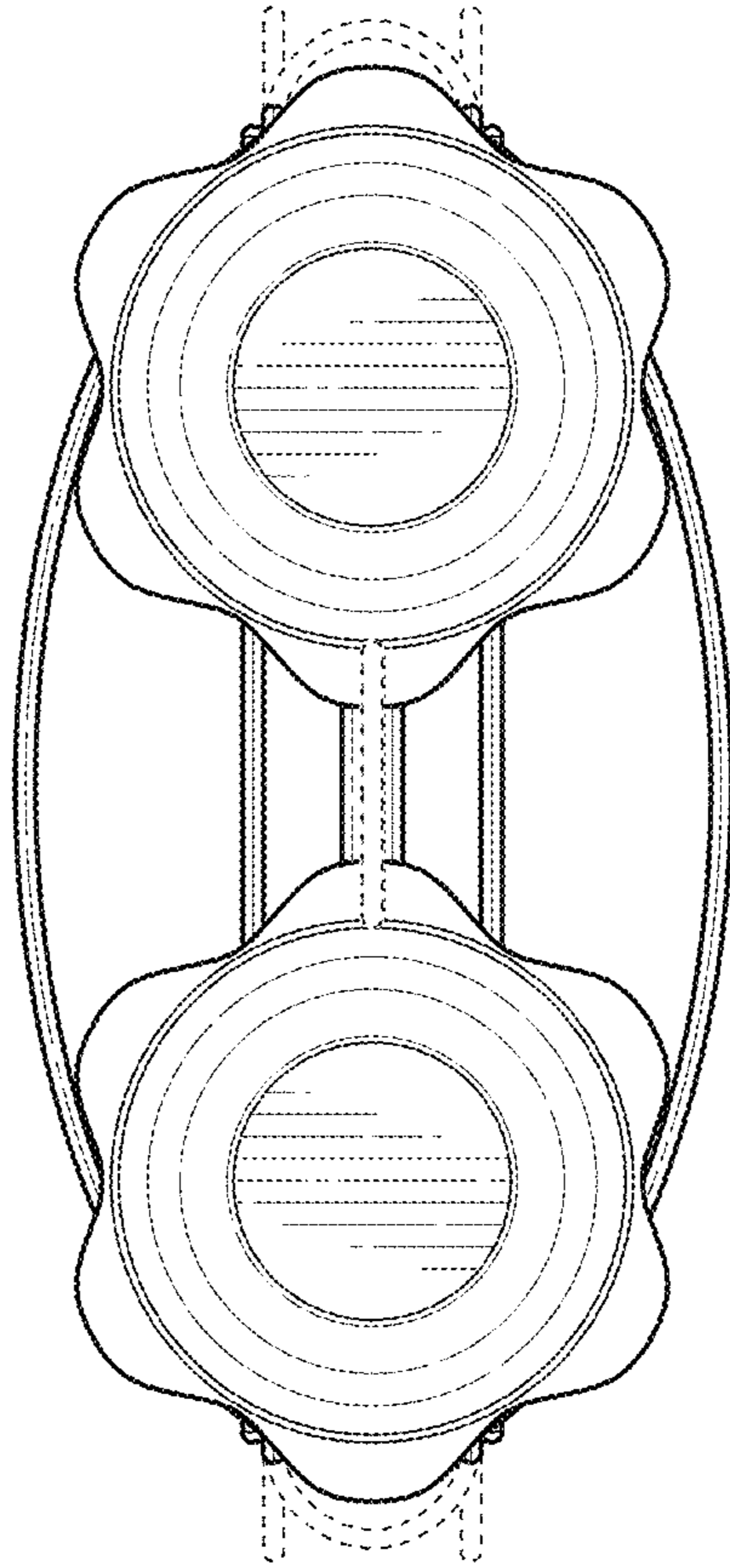
