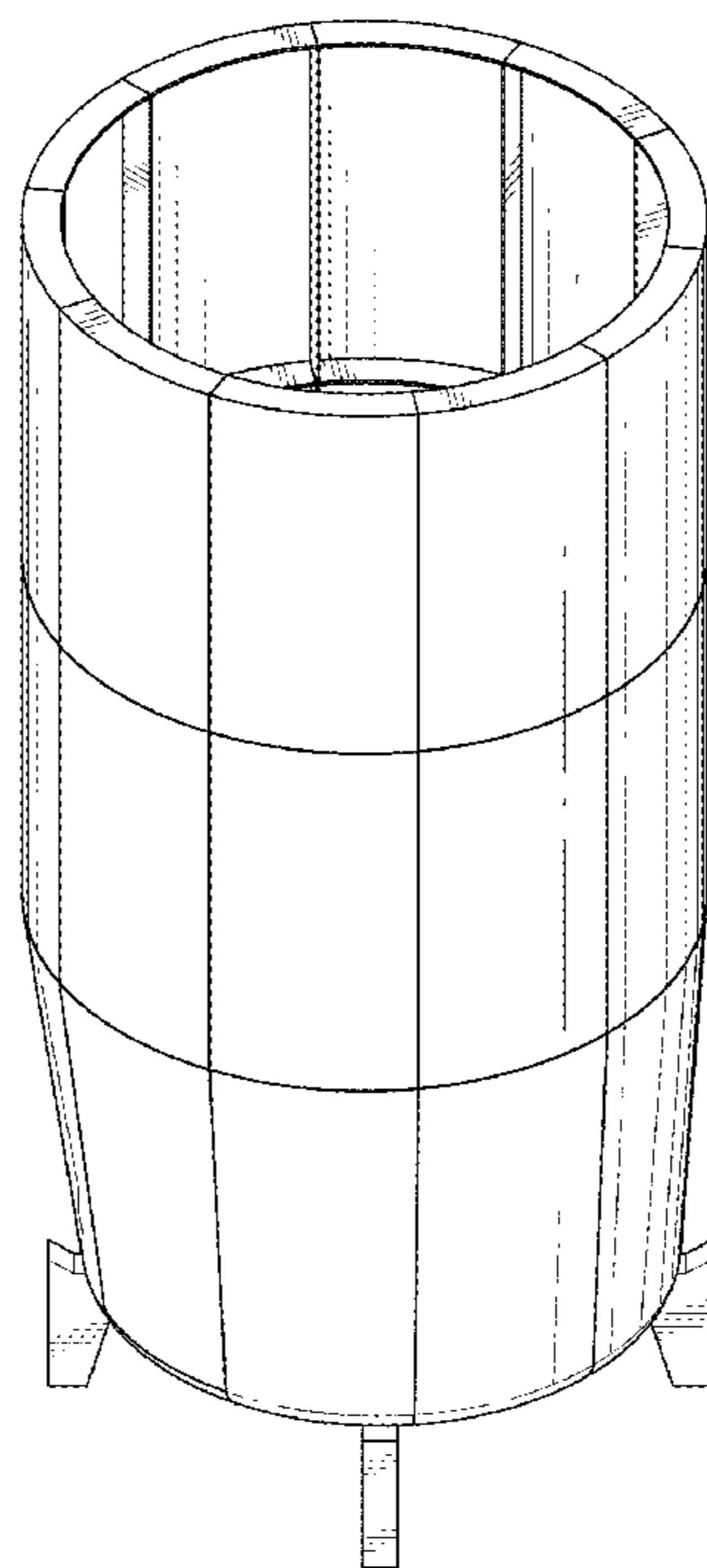
(57) **CLAIM**

We claim the ornamental design for a cask, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of a cask embodying our design;  
FIG. 2 is a rear, bottom, and left side perspective view thereof;

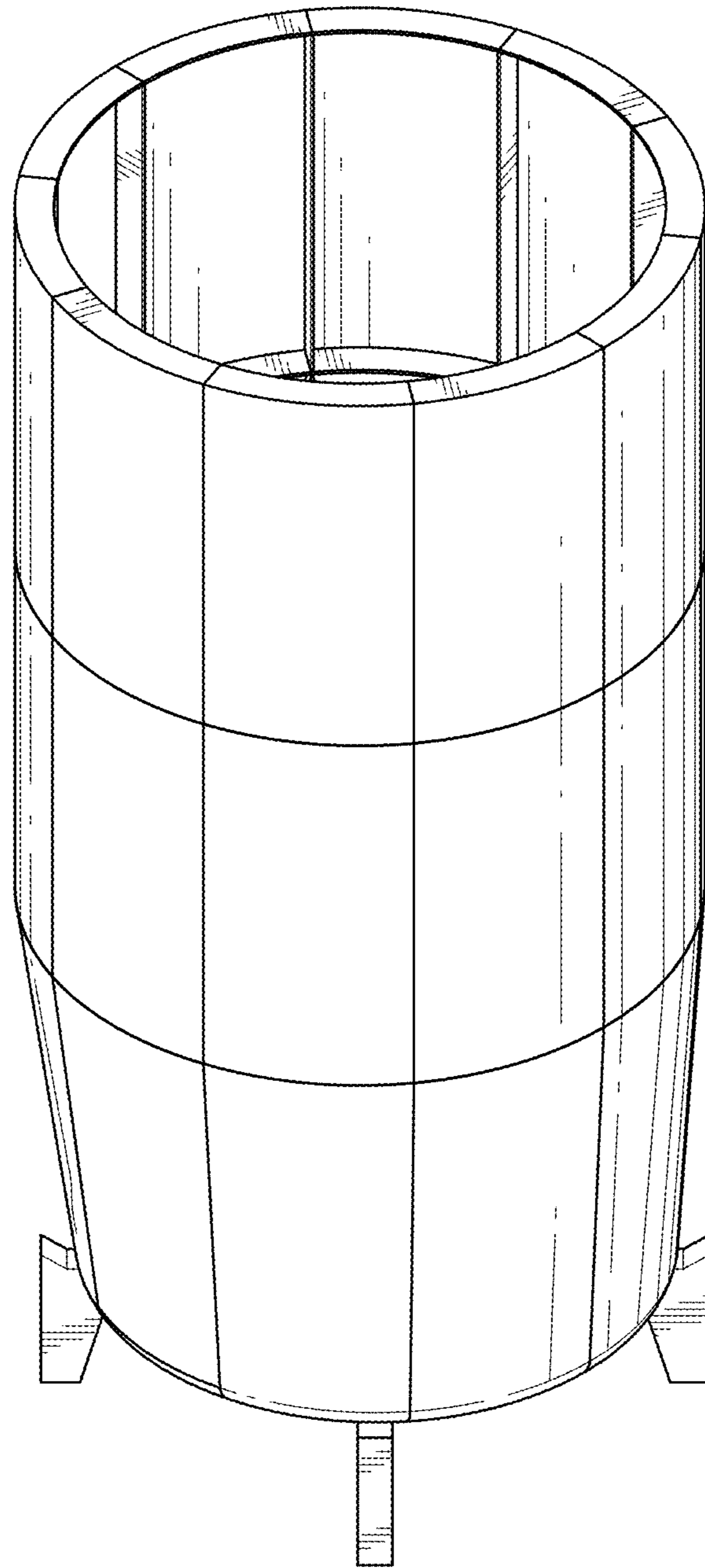

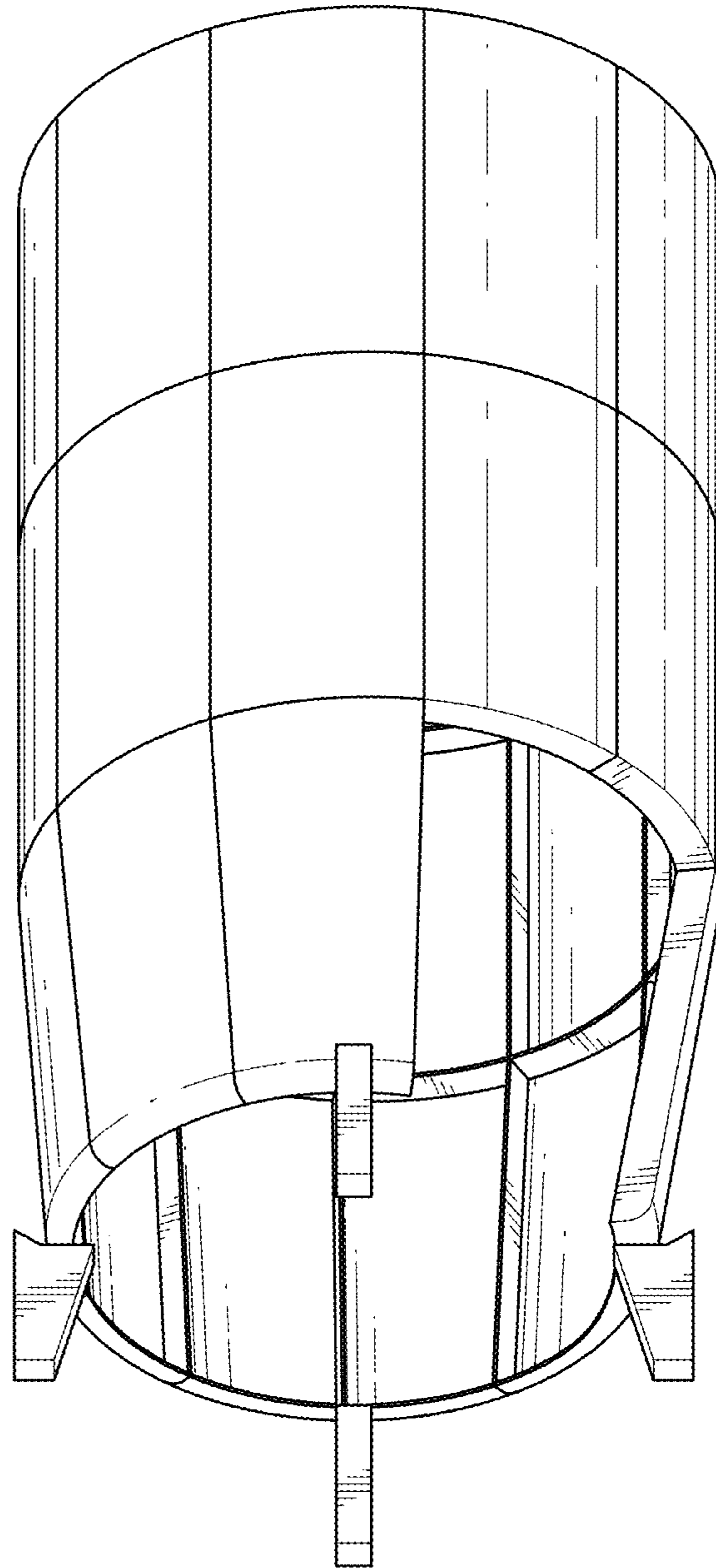

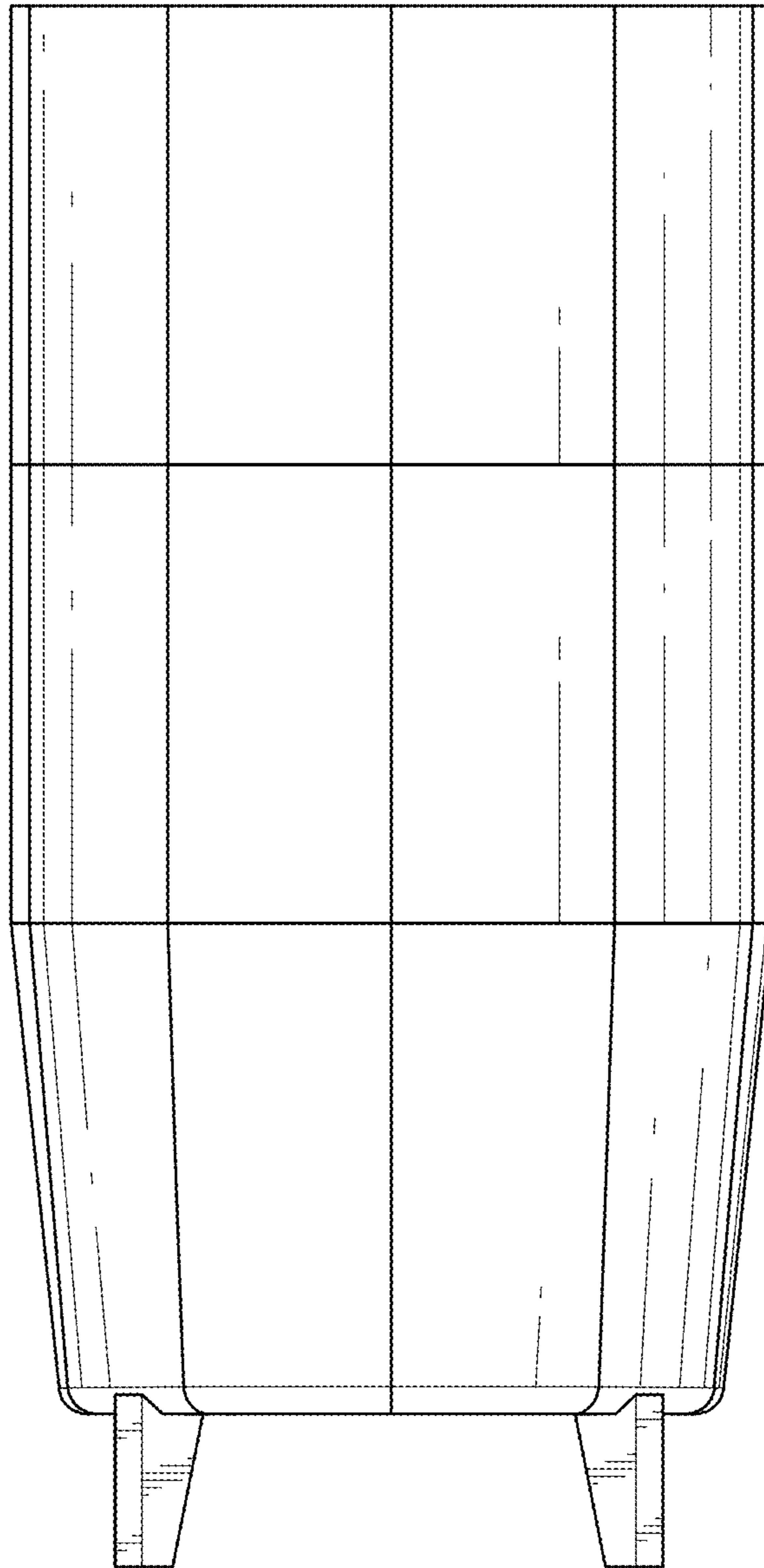

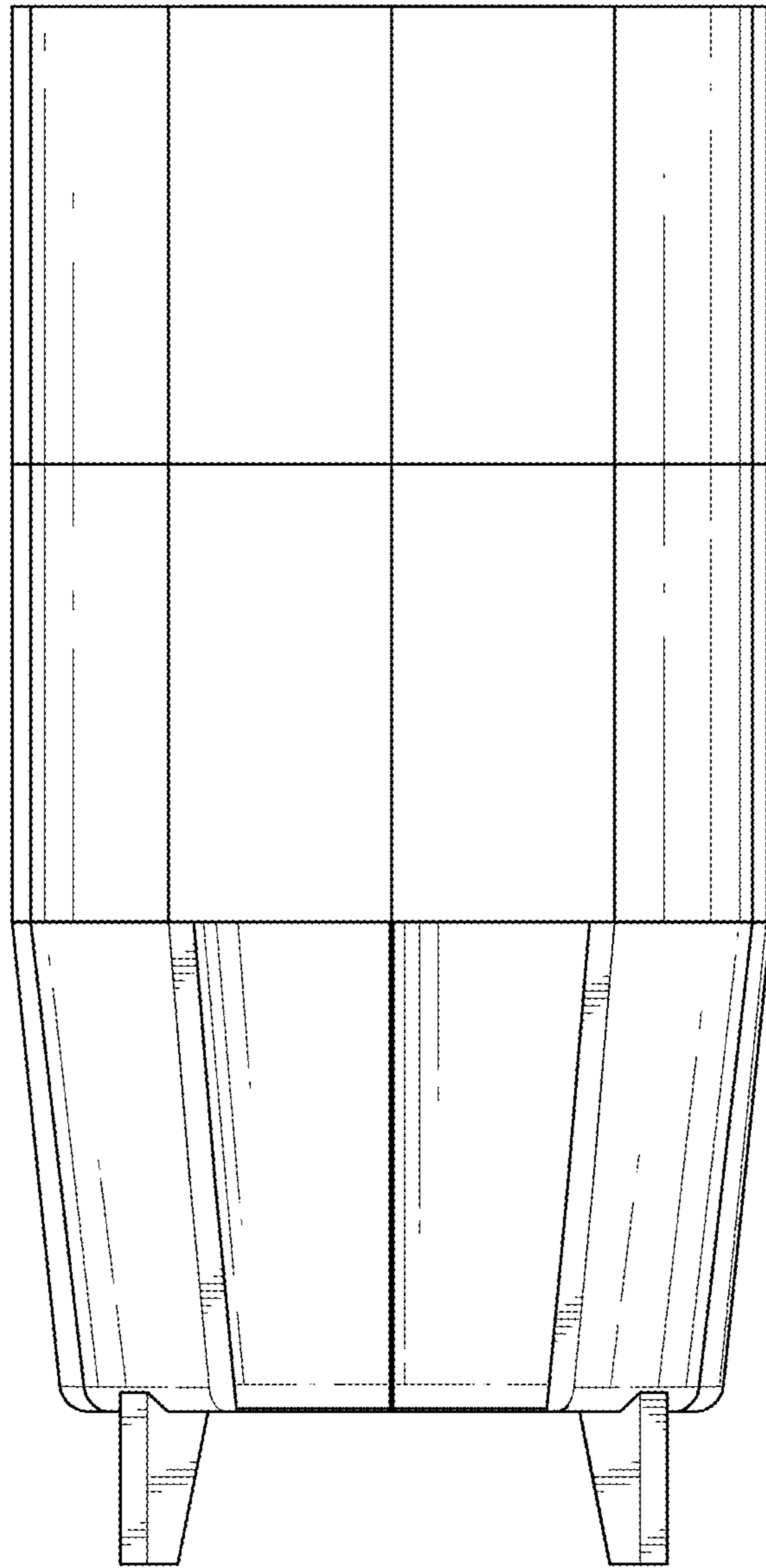

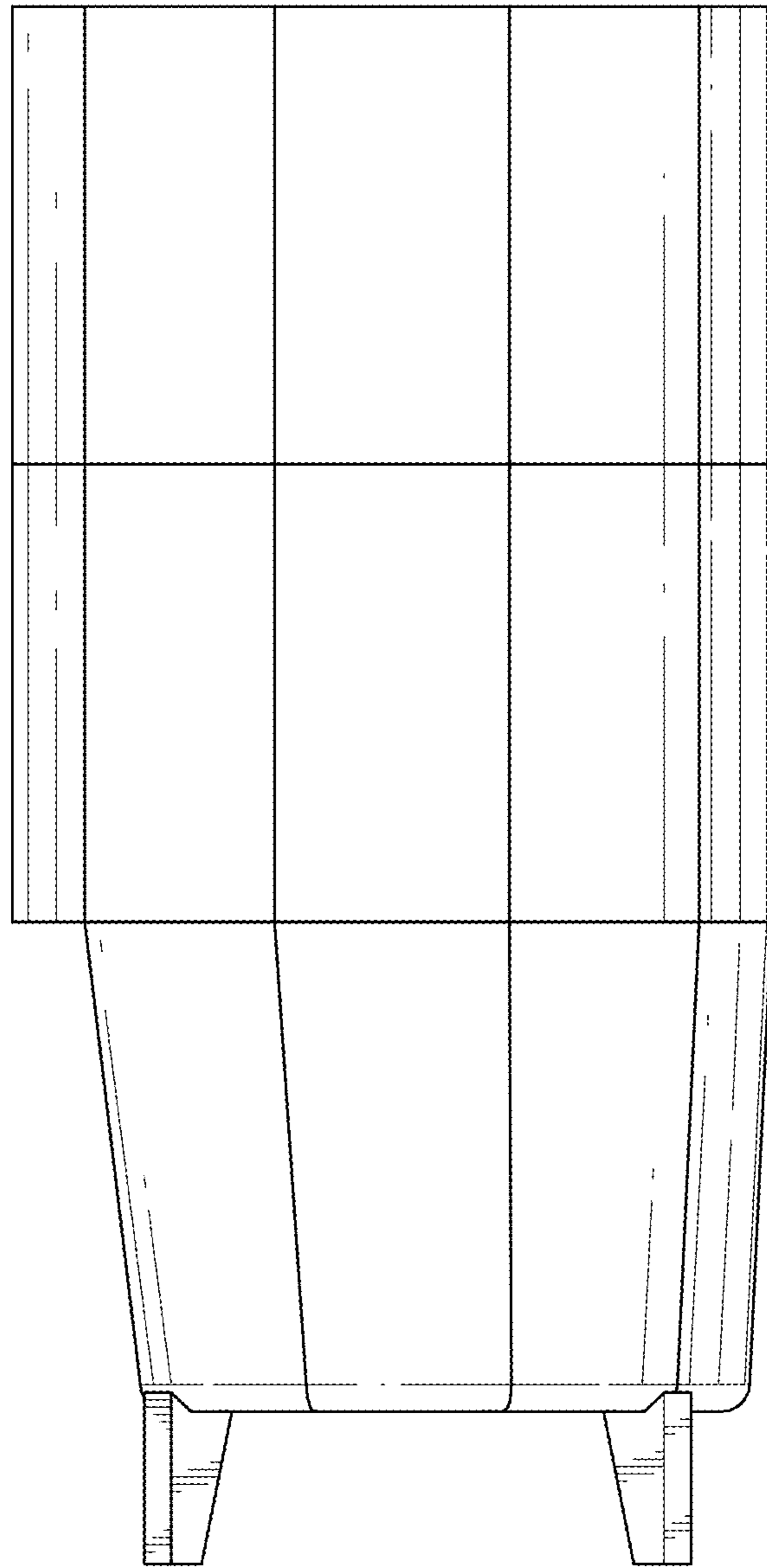

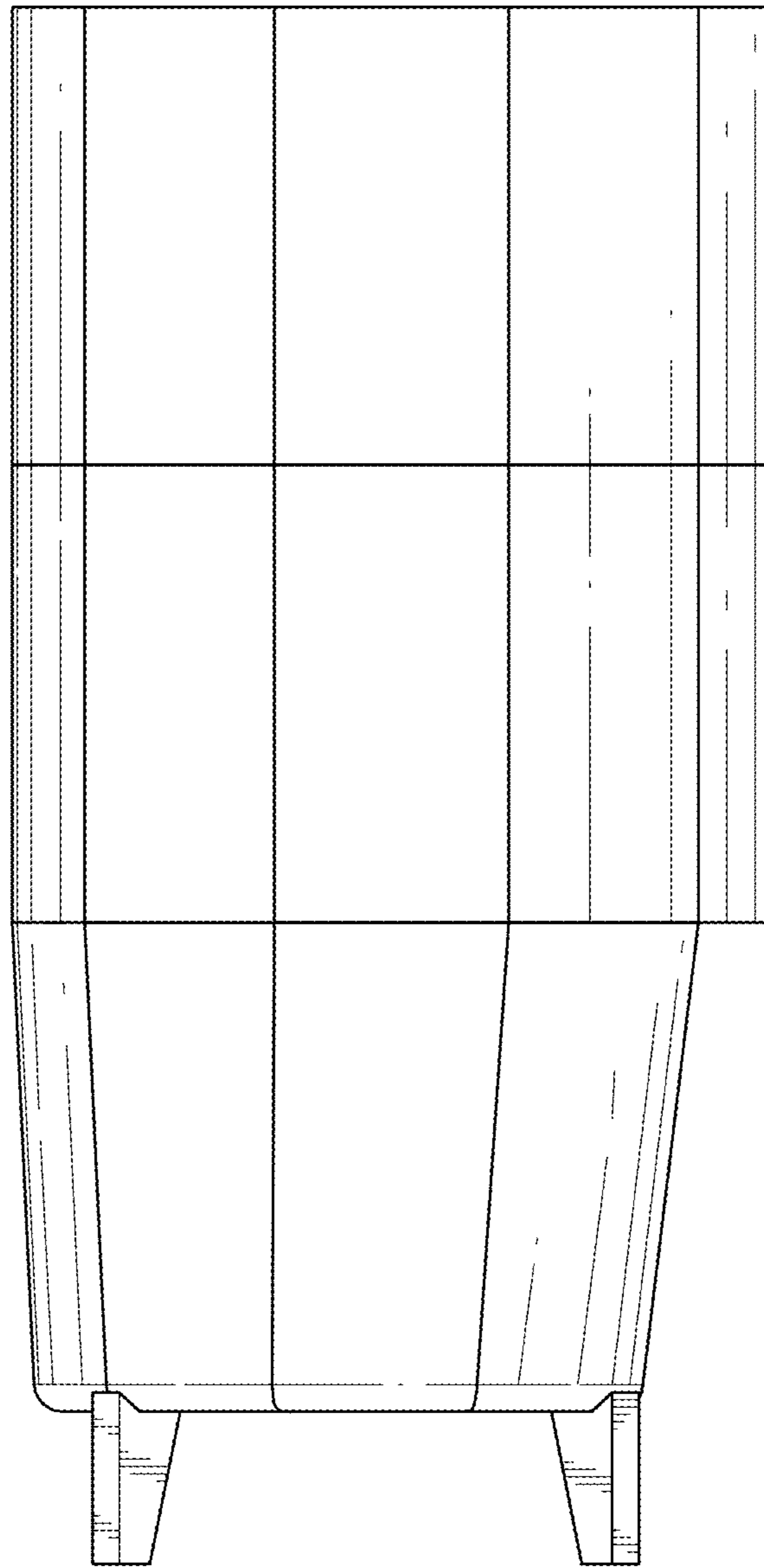

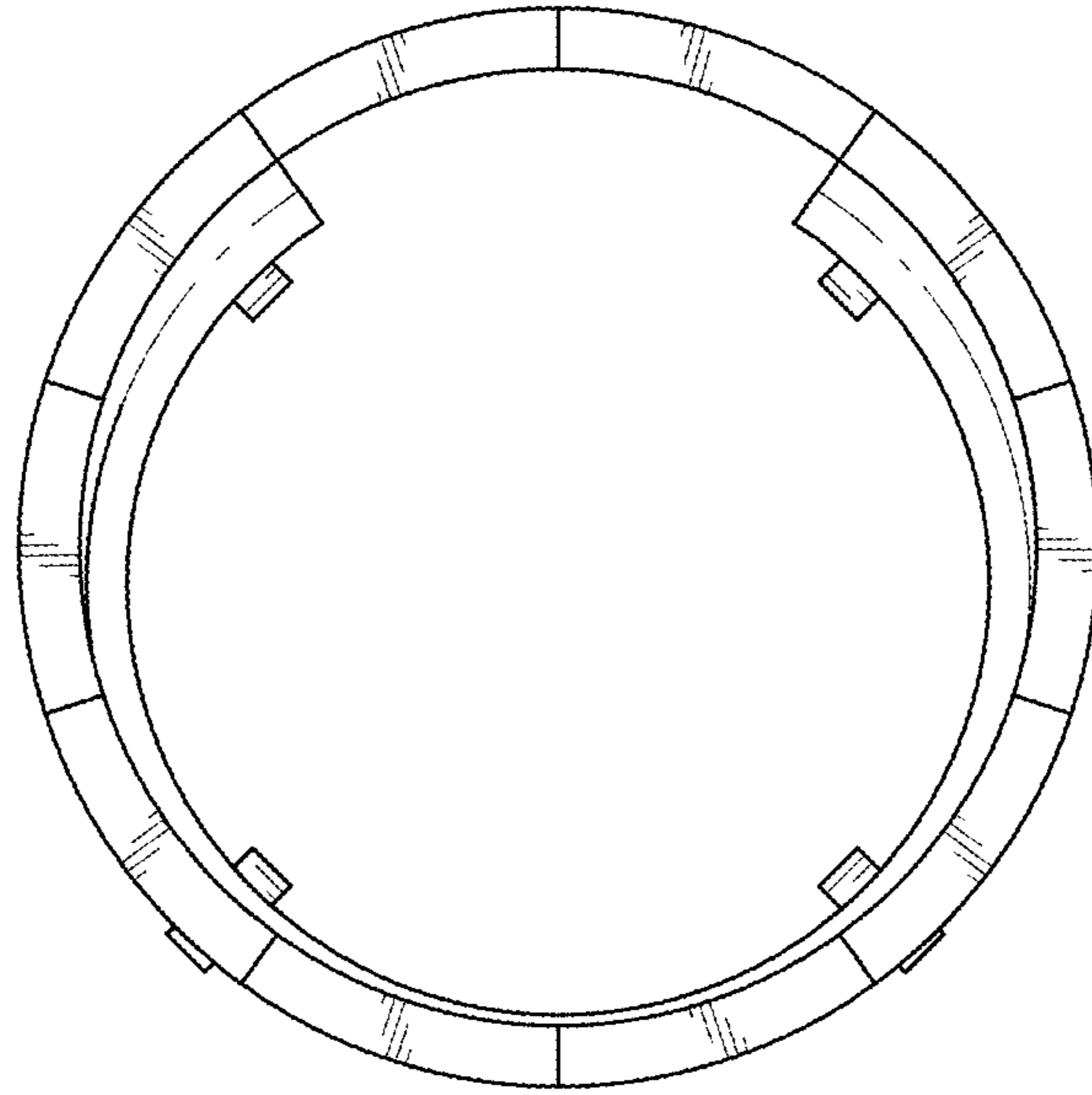

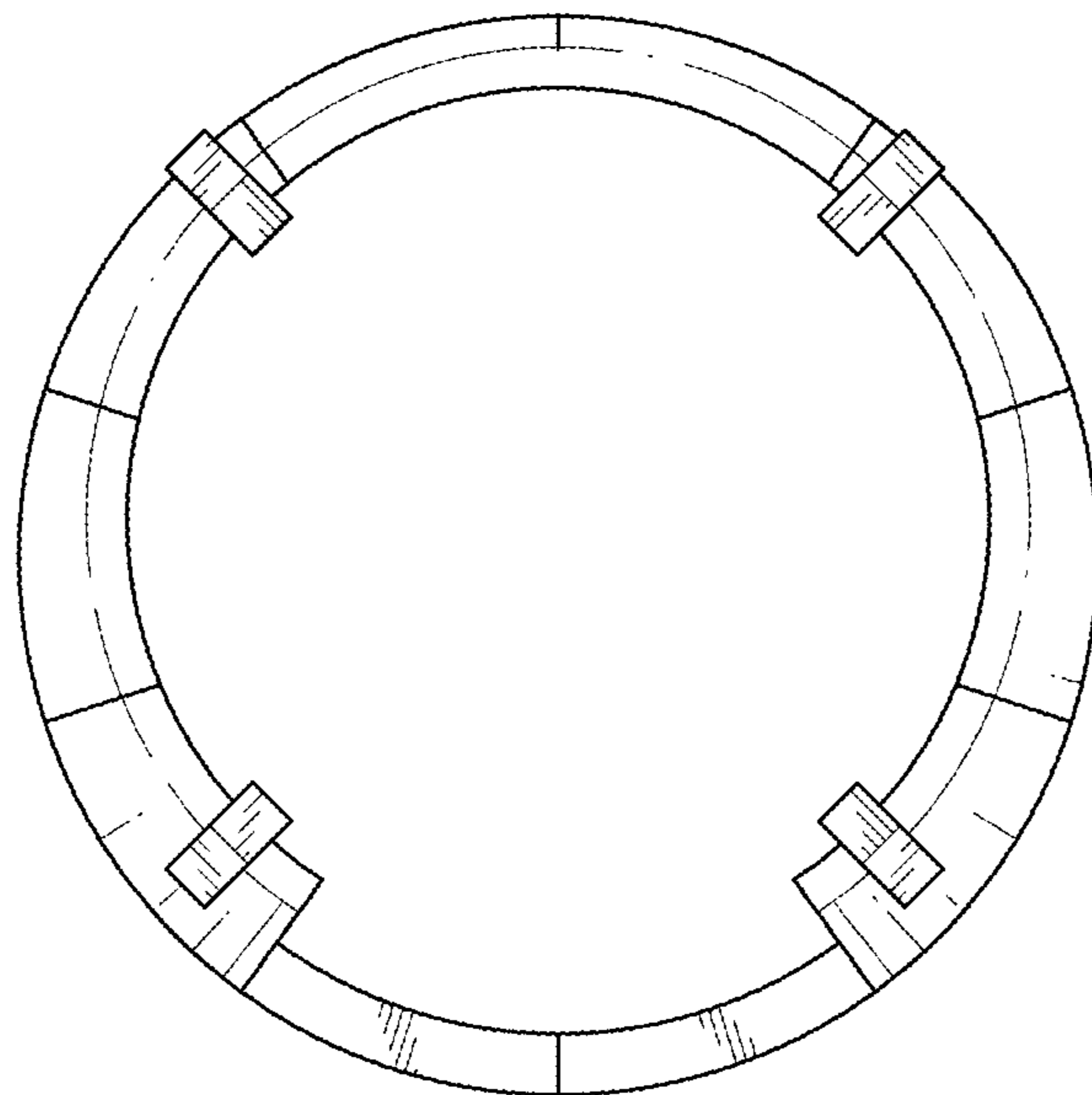
