(57) **CLAIM**

The ornamental design for breeches with calf panels, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a clothing bottom in a flat orientation and showing the design.

FIG. 2 is a rear elevation view of the clothing bottom of FIG. 1.

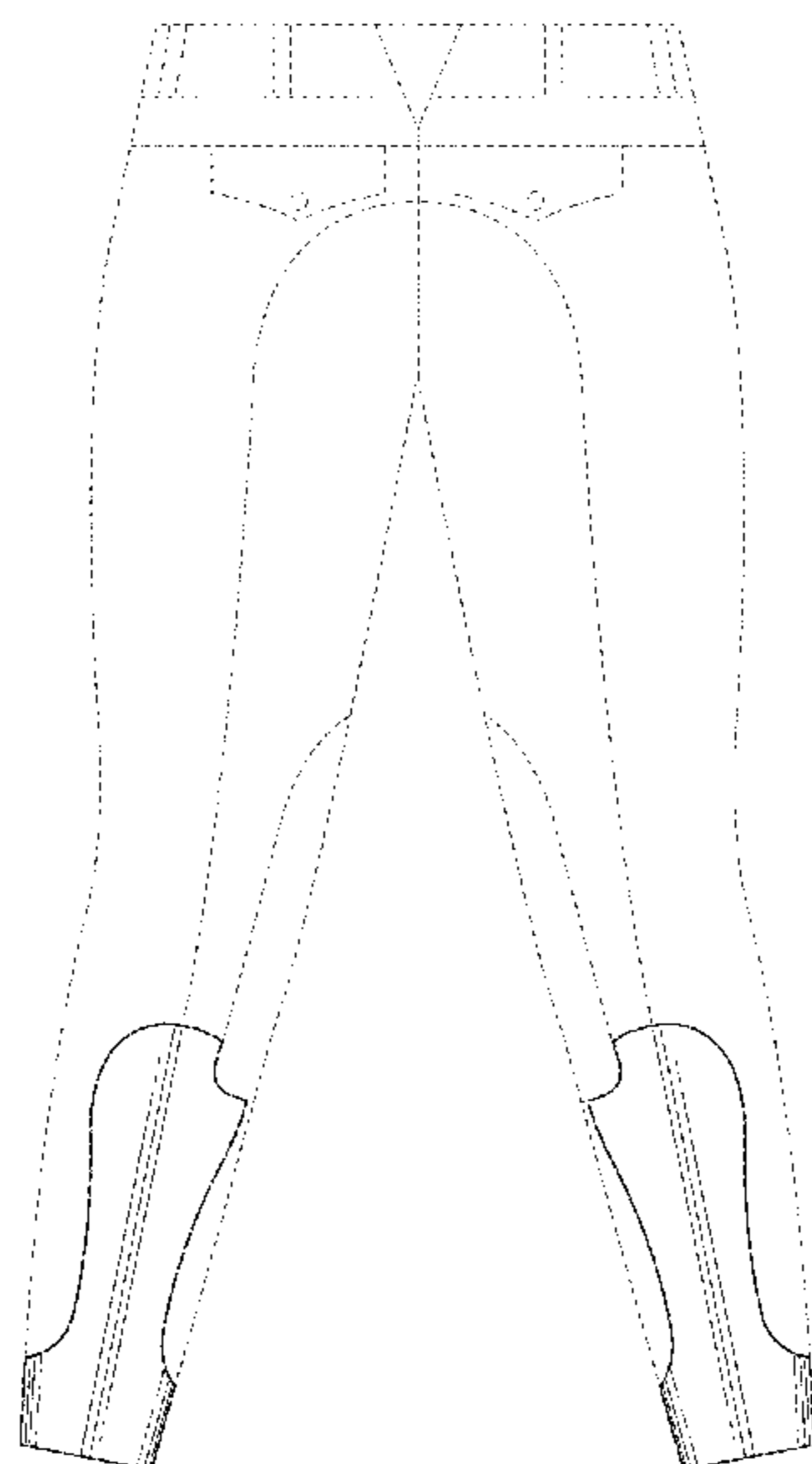
FIG. 3 is a top plan view of the clothing bottom of FIG. 1. FIG. 4 is a bottom plan view of the clothing bottom of FIG. 1.

FIG. 5 is a left side view of the clothing bottom of FIG. 1. FIG. 6 is a right side view of the clothing bottom of FIG. 1; and,

FIG. 7 is a perspective view of the clothing bottom of FIG. 1 in a non-flat orientation.

The dashed lines shown in the drawings illustrate portions of the clothing bottom that are not presently claimed and thus form no part of the presently claimed design. The shading lines shown in the drawings represent the approximate three-dimensional contour of the claimed design and are not intended to indicate surface decoration.

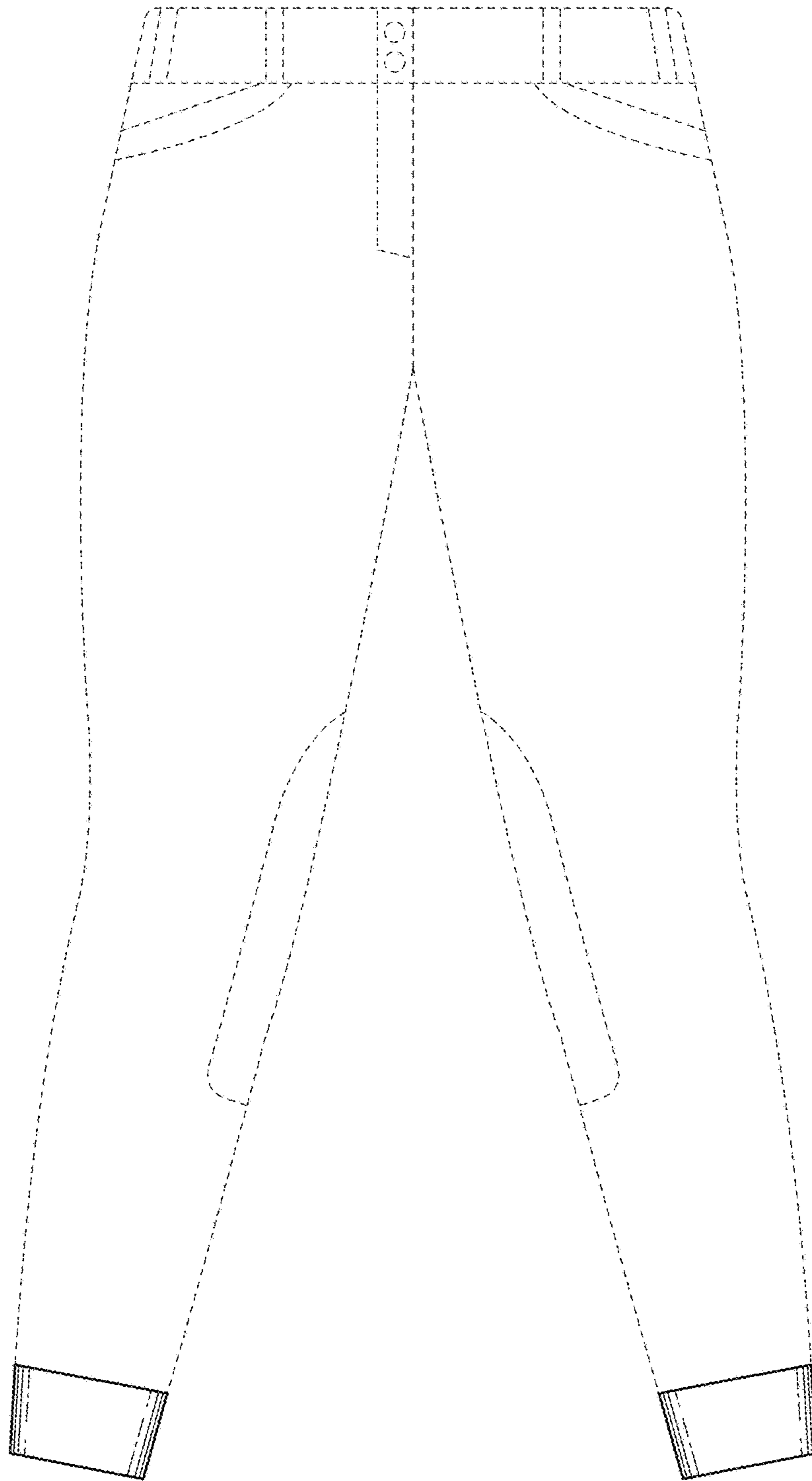

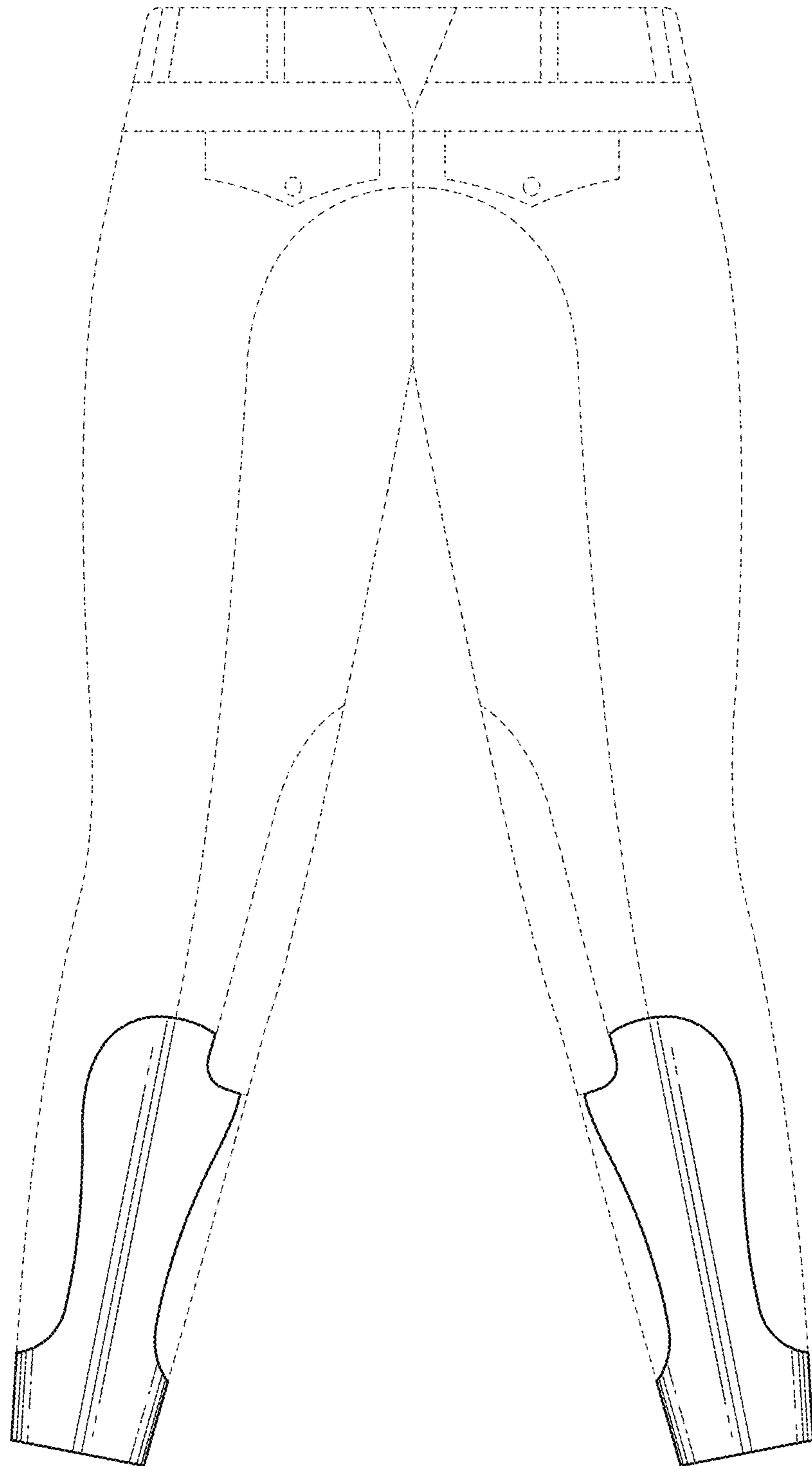

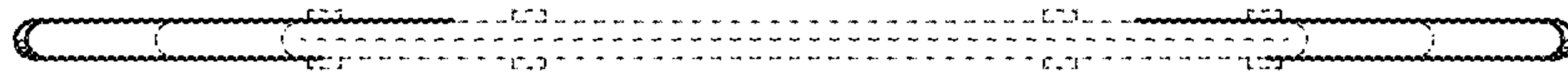

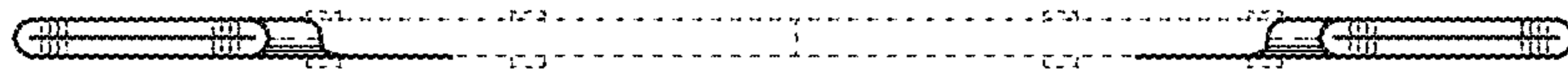

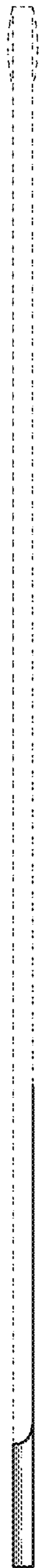

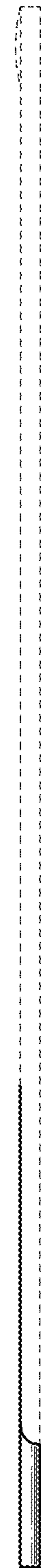

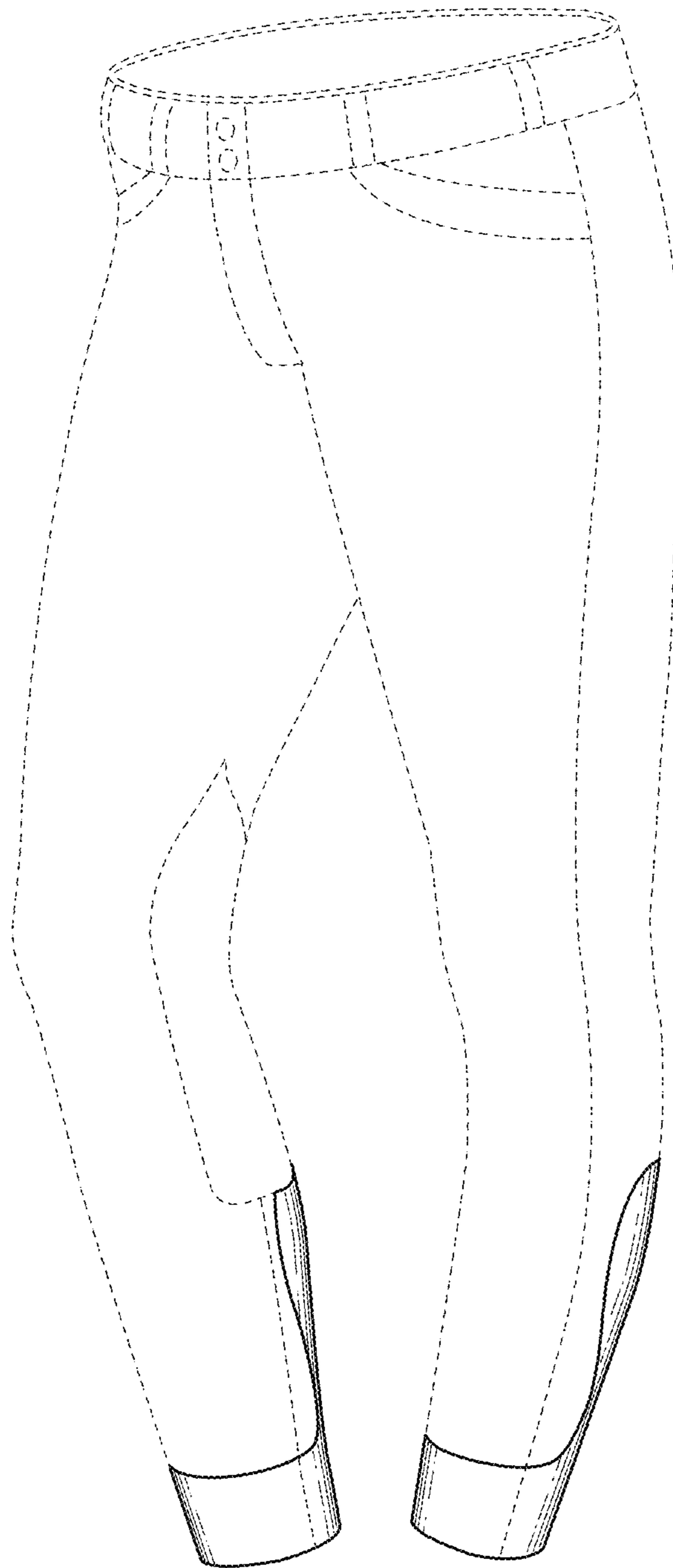
