The ornamental design for a footwear sole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, left perspective view of a footwear sole, according to the embodiment of the design.
FIG. 2 is a top, back, right perspective view of a footwear sole, according to the embodiment of the design.
FIG. 3 is a bottom view of a footwear sole, according to the embodiment of the design.
FIG. 4 is a top view of a footwear sole, according to the embodiment of the design.
FIG. 5 is a right, outer, side view of a footwear sole, according to the embodiment of the design.
FIG. 6 is a left, inner, side view of a footwear sole, according to the embodiment of the design.
FIG. 7 is a front view of a footwear sole, according to the embodiment of the design; and,
FIG. 8 is a rear view of a footwear sole, according to the embodiment of the design.

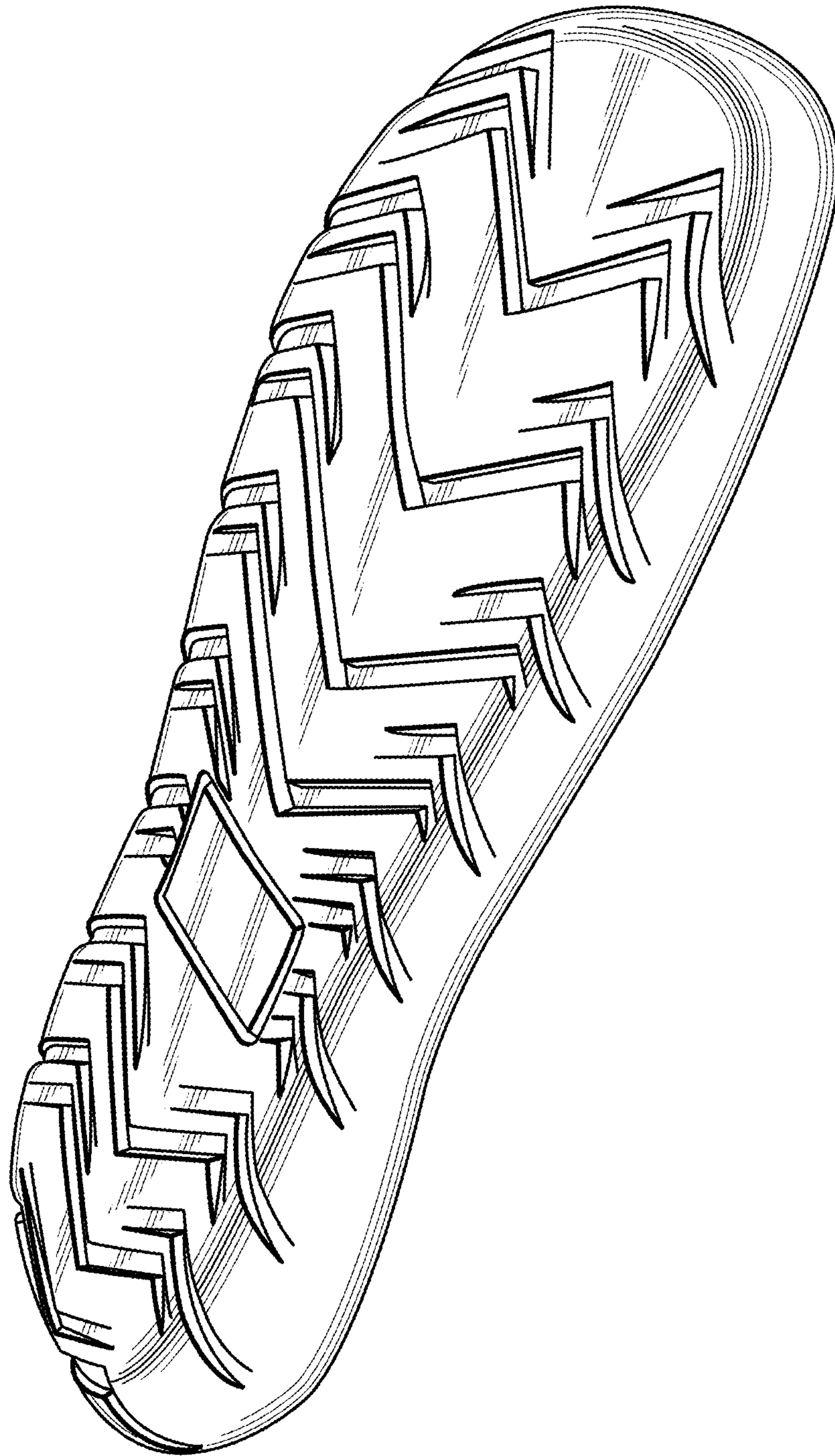

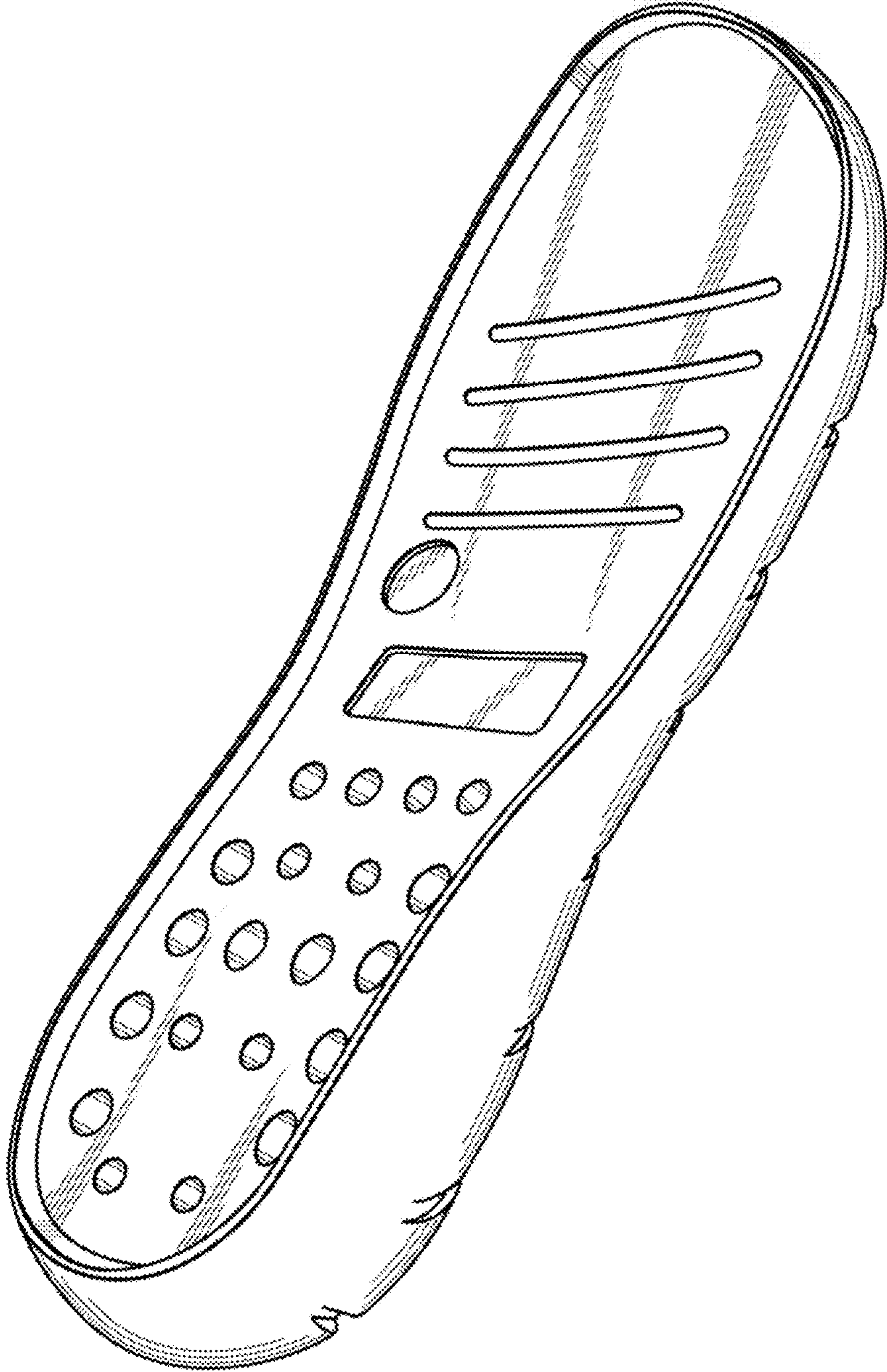

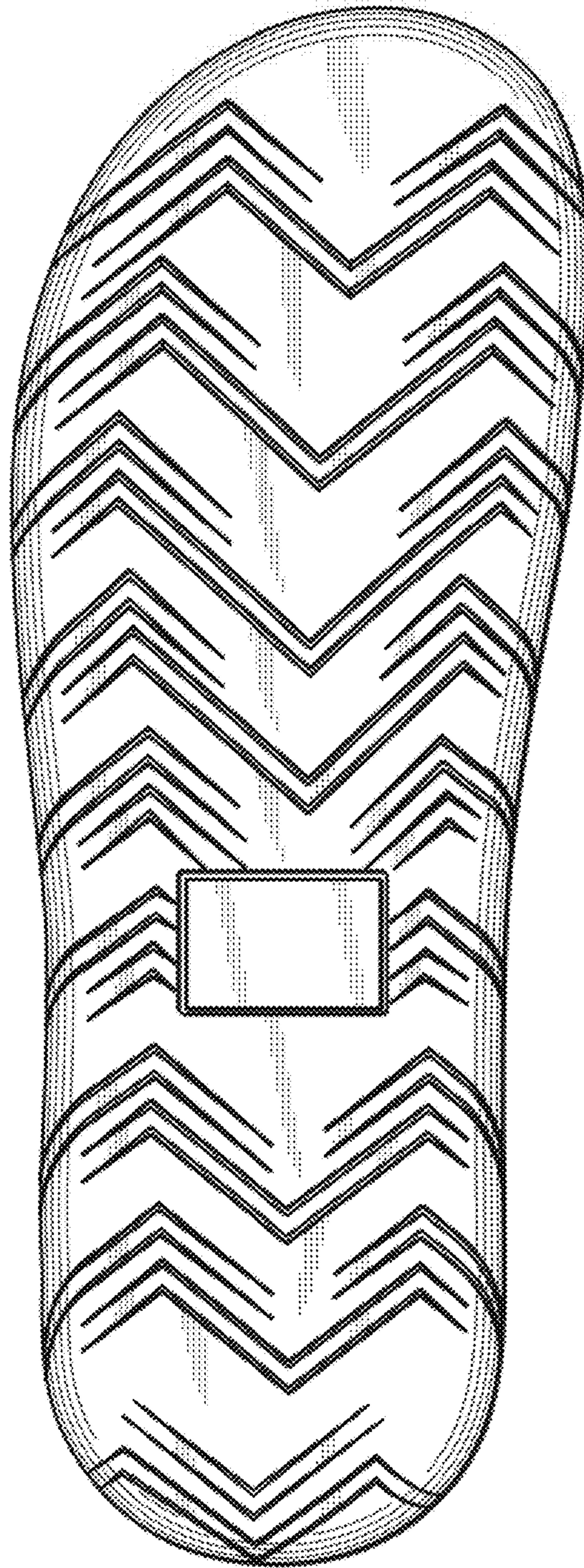

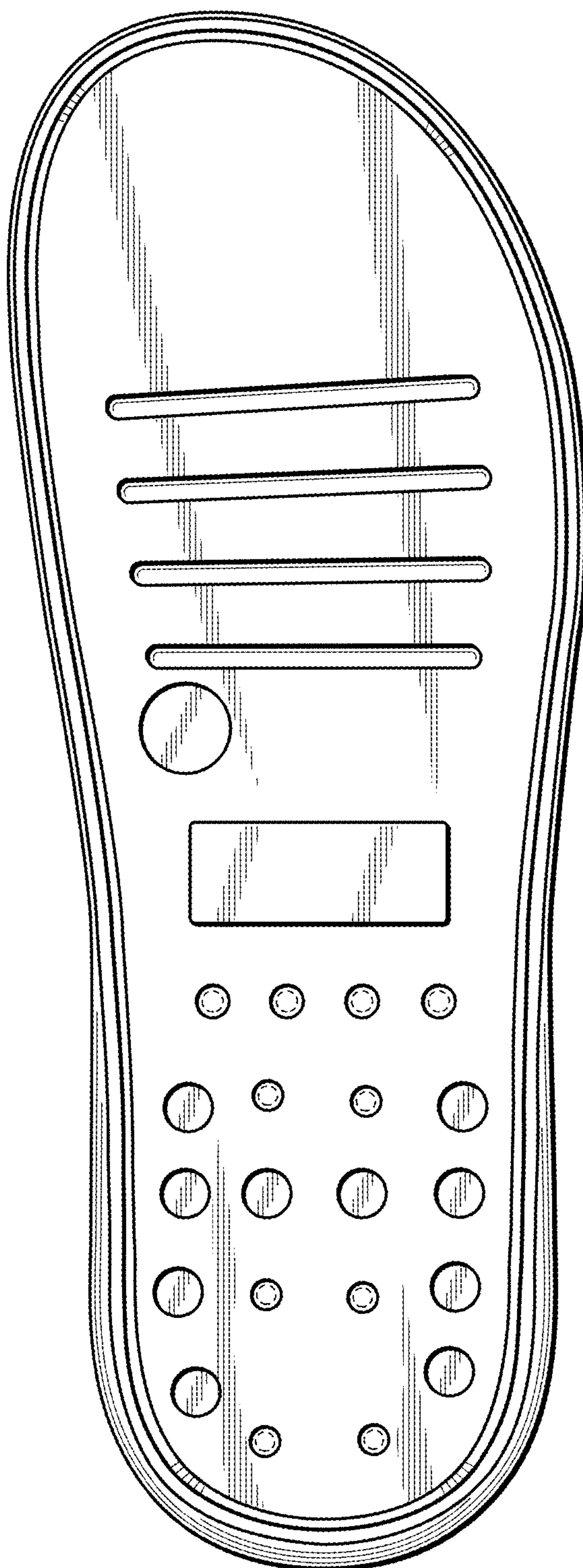

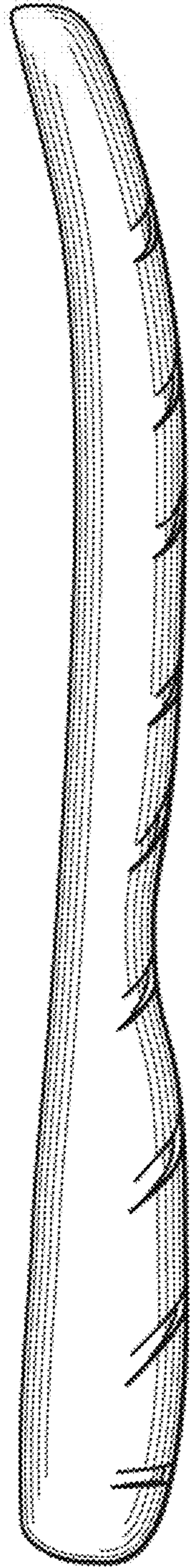

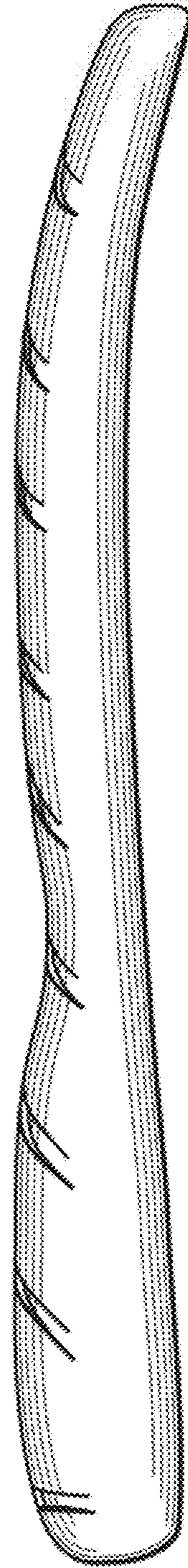

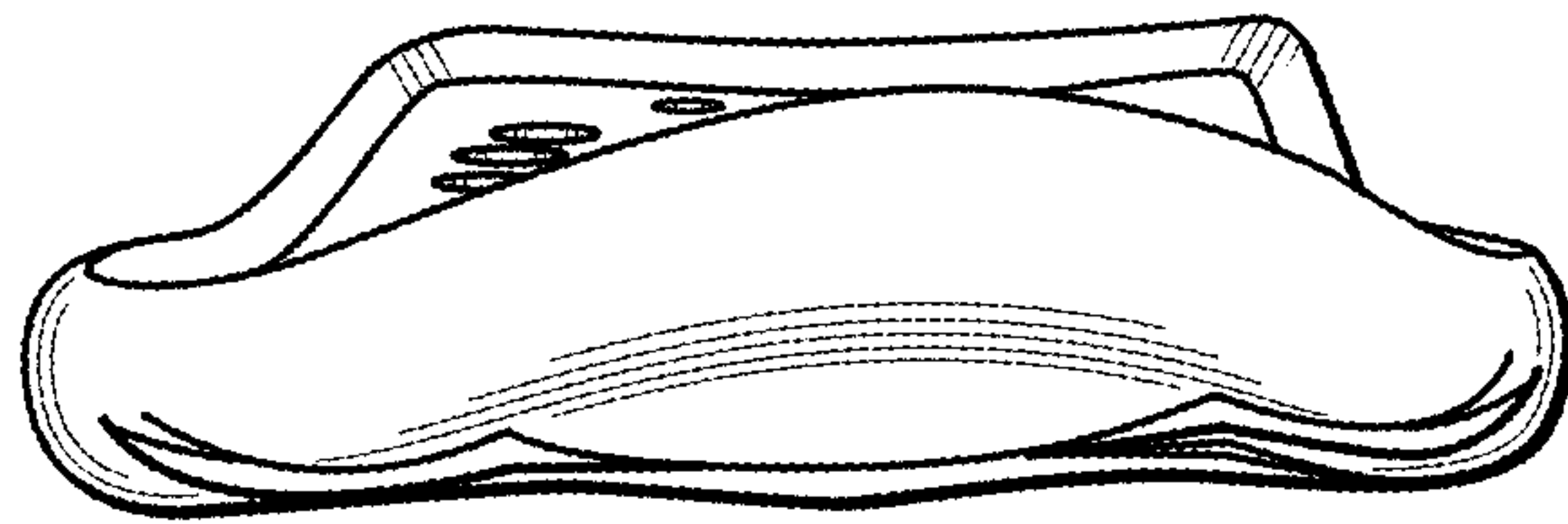

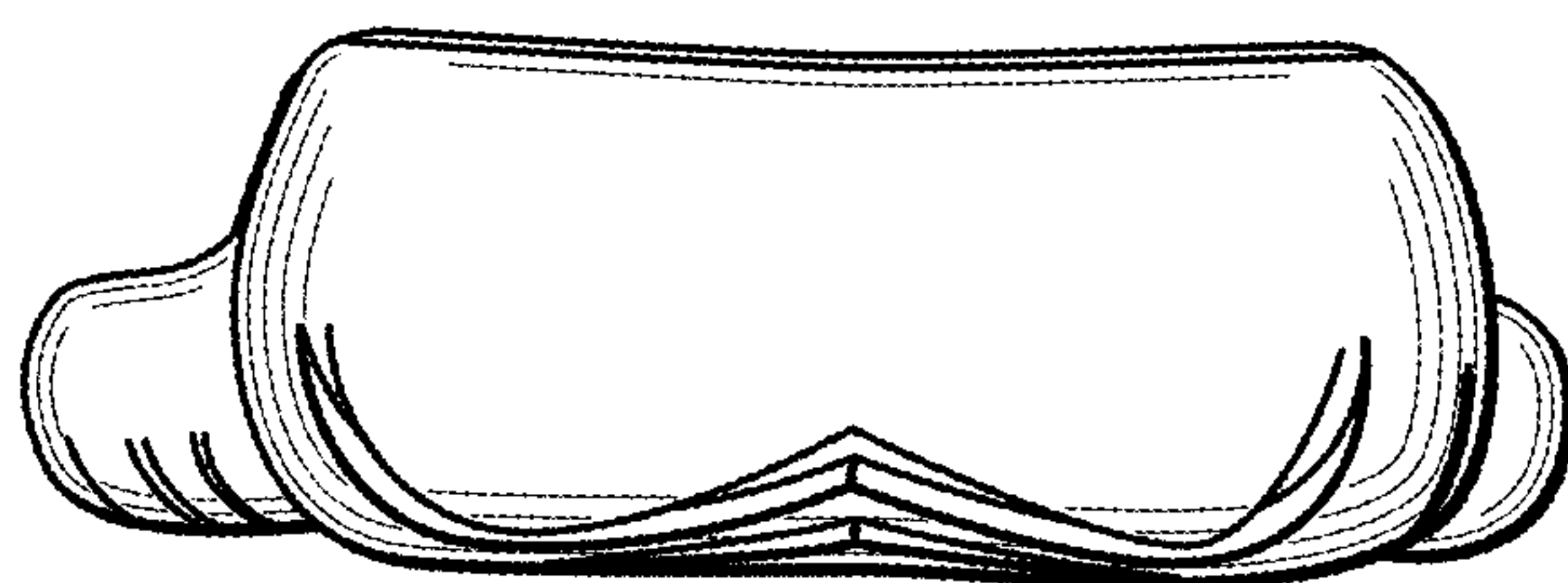
