(57) **CLAIM**

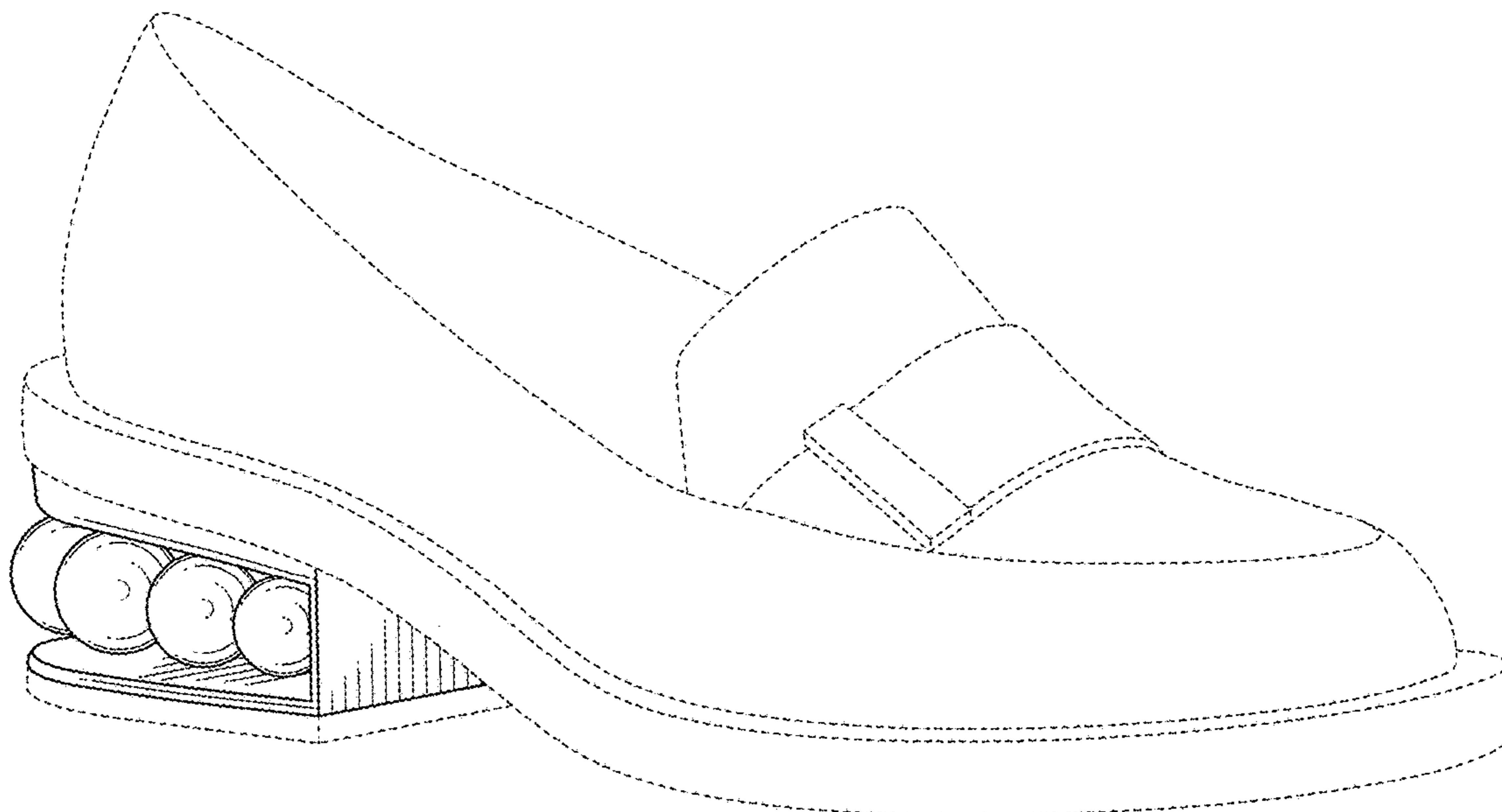
The ornamental design for a pearl heel, as shown and described.

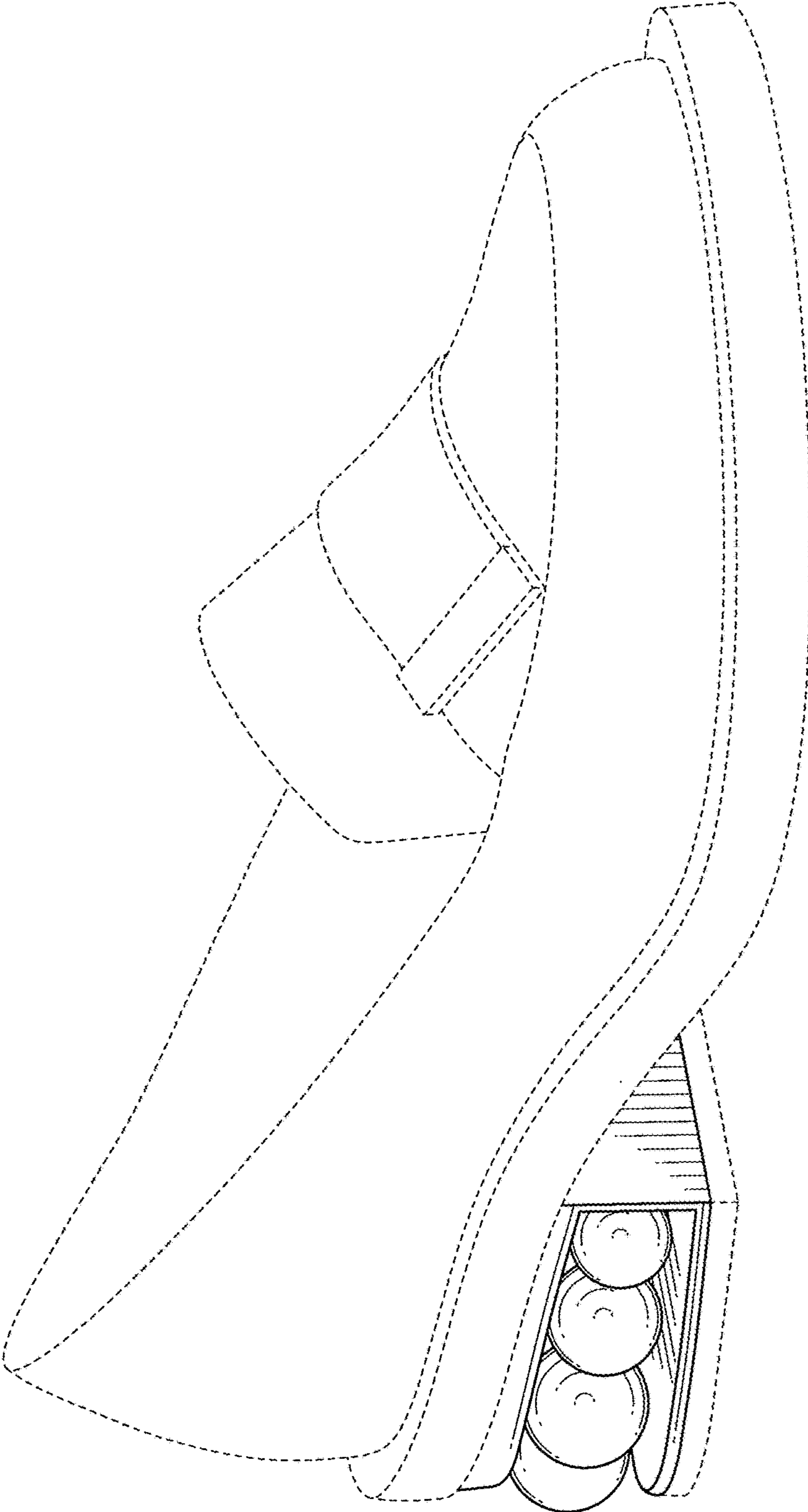

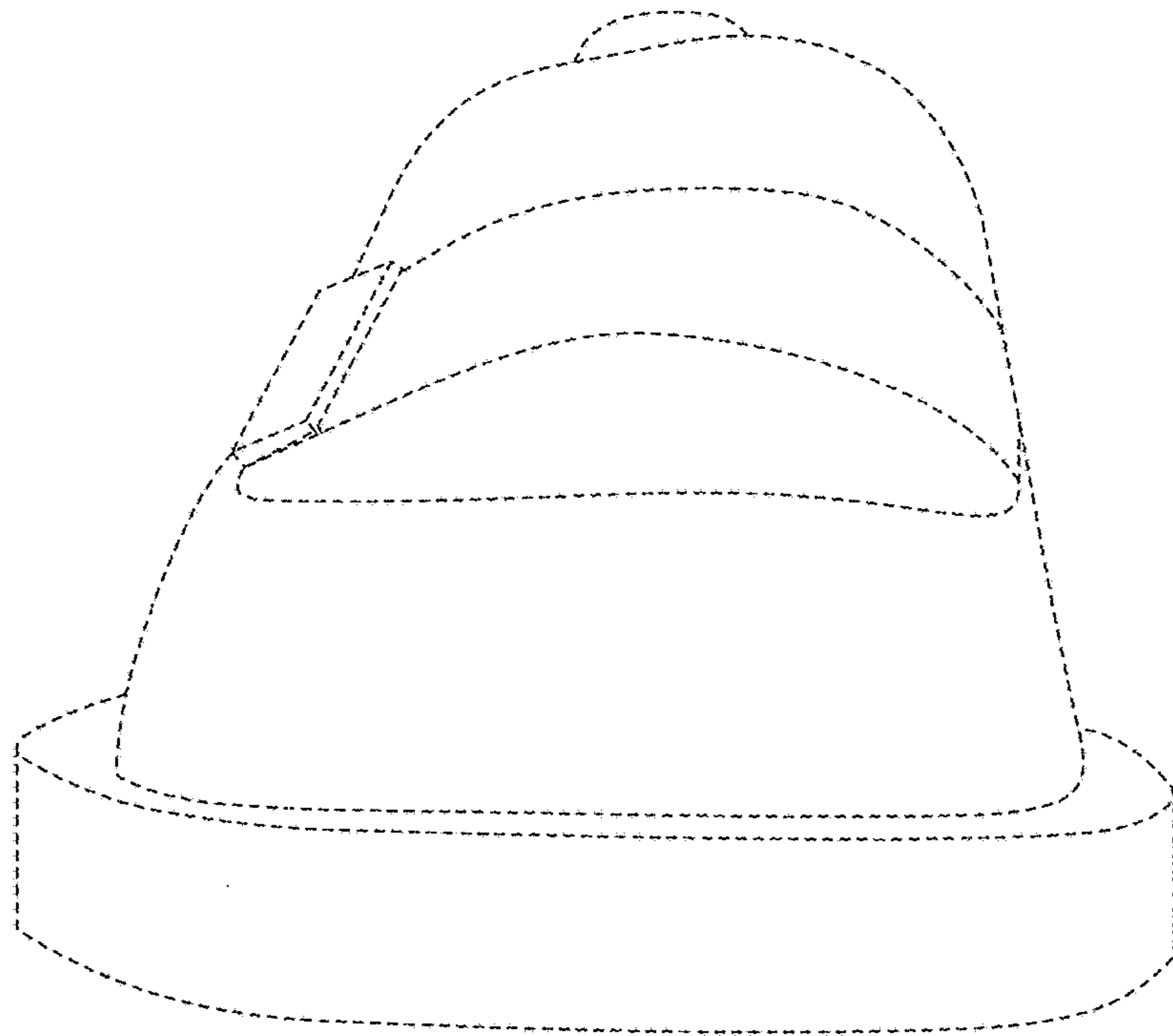

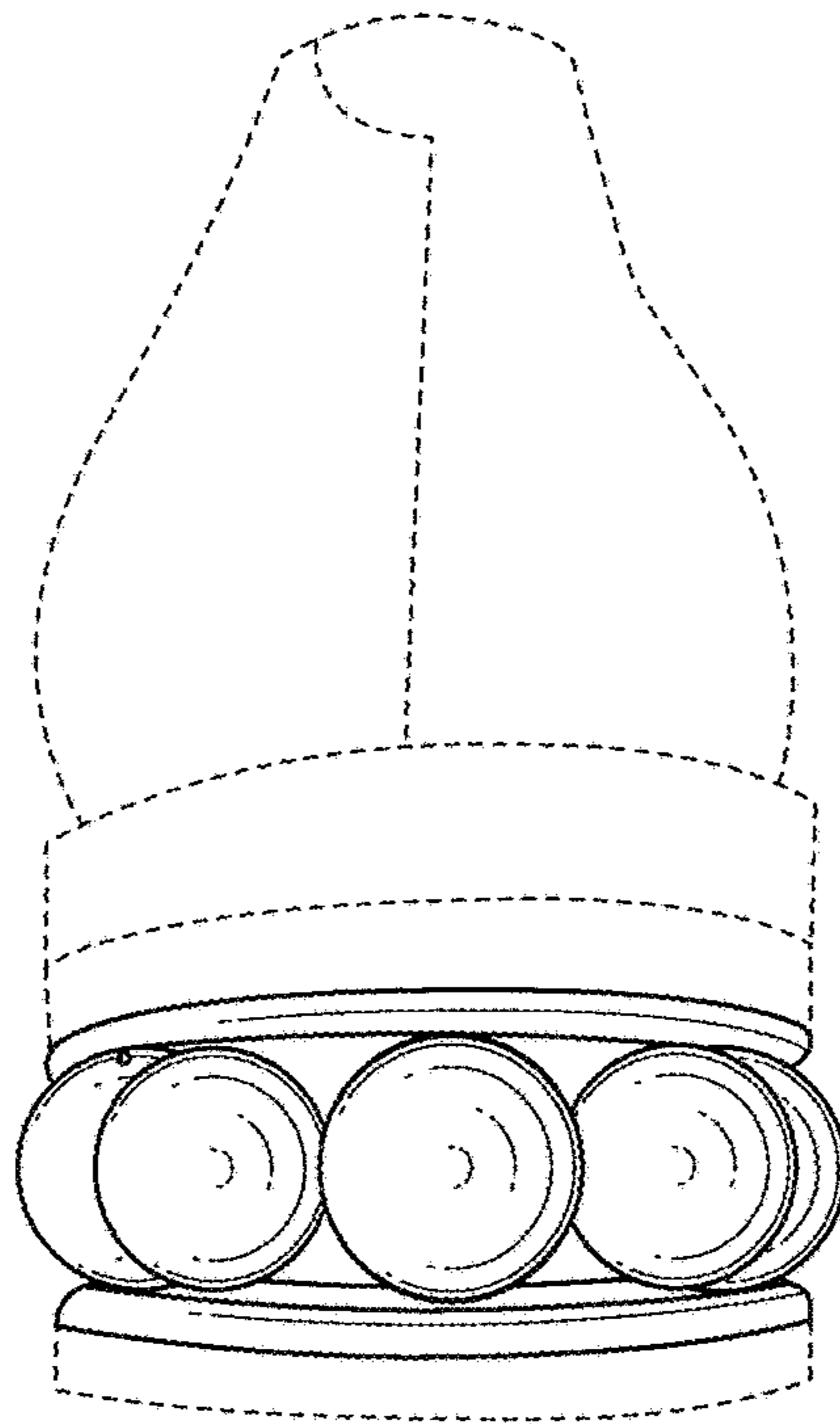

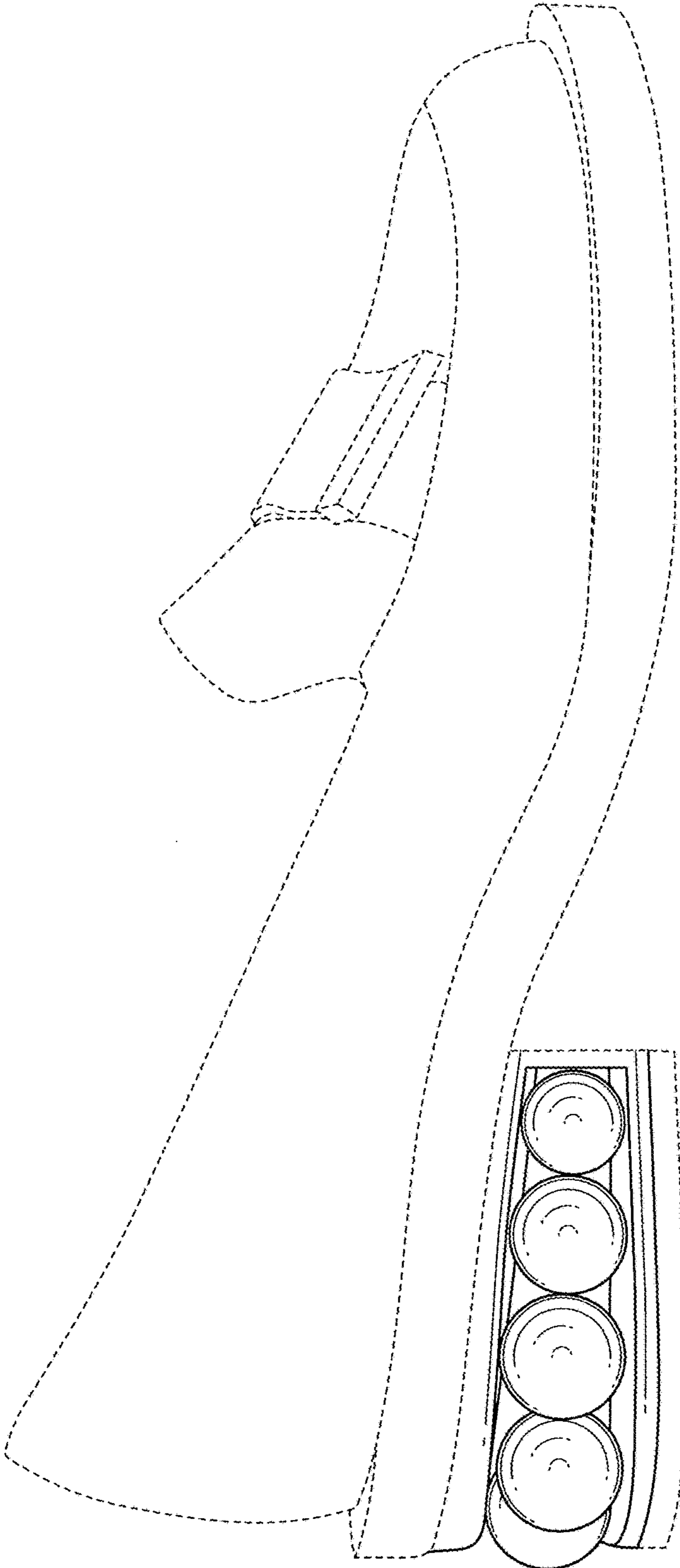

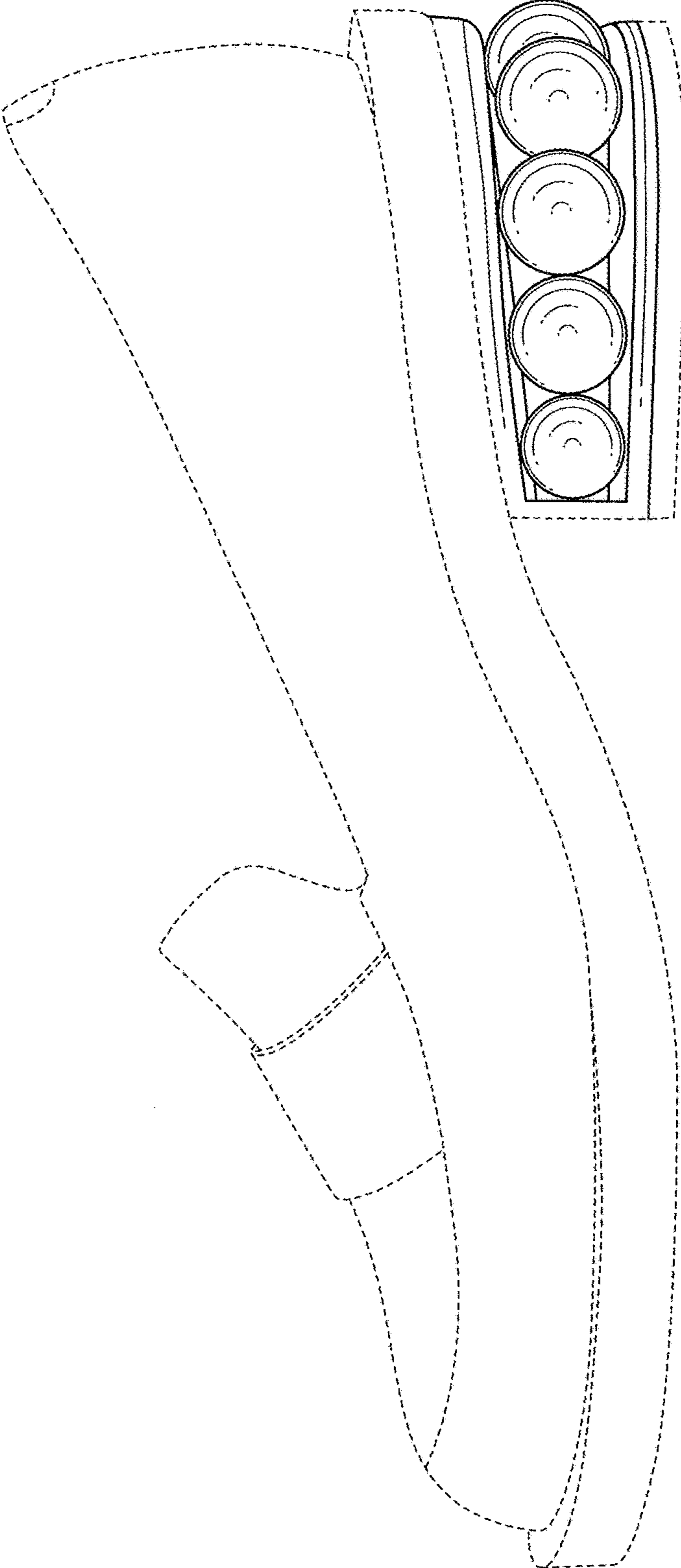

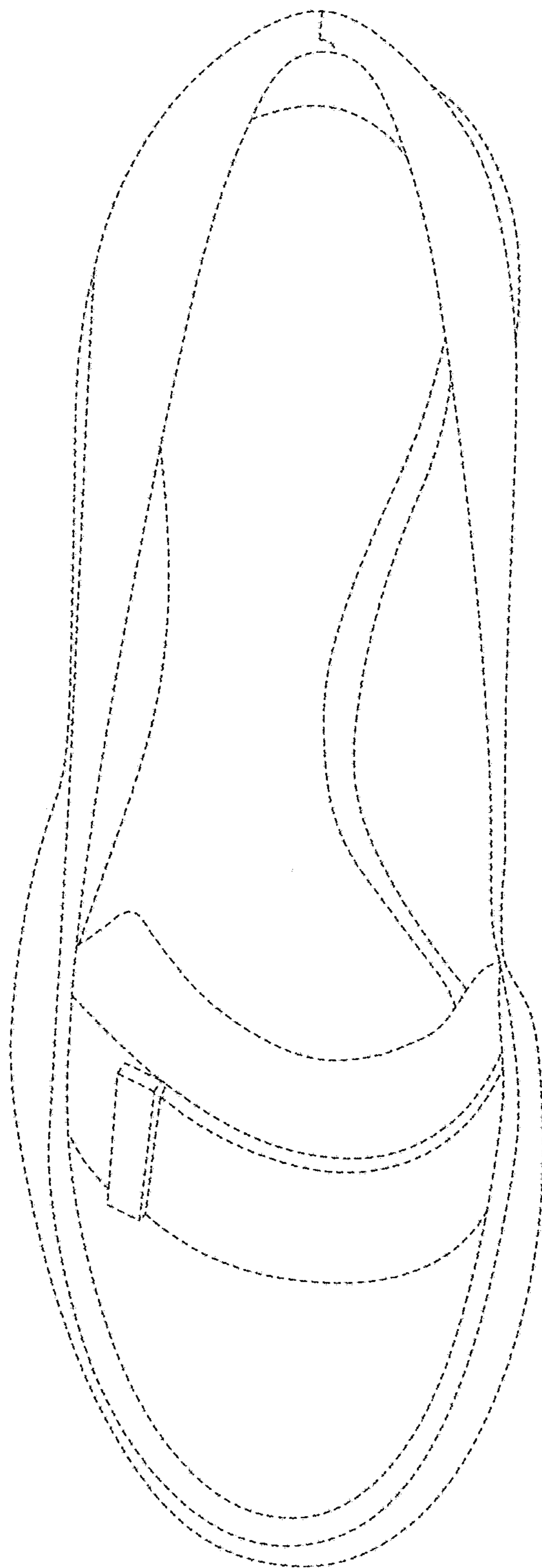

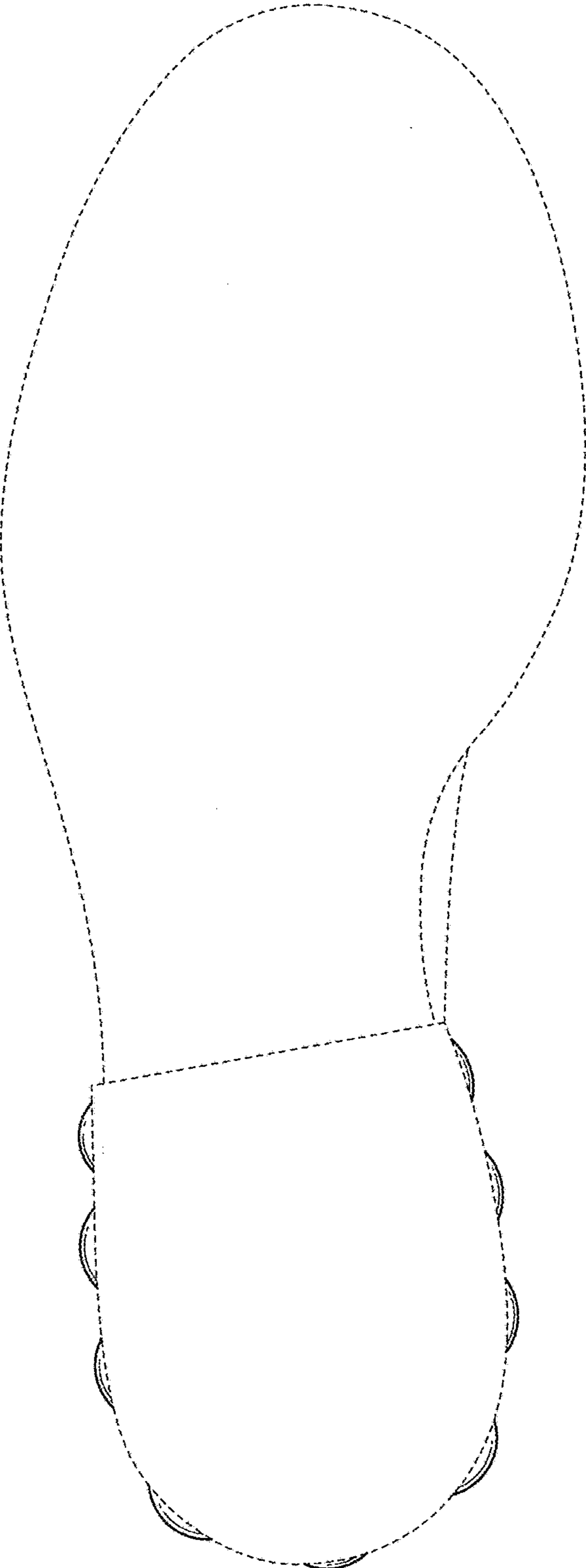
