(57) **CLAIM**

The ornamental design for a portable cooler, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of the portable cooler of the present invention with its lid closed;

FIG. 2 is a bottom perspective view of the portable cooler of FIG. 1;

FIG. 3 is a front elevational view of the portable cooler of FIG. 1;

FIG. 4 is rear elevational view of the portable cooler of FIG. 1;

FIG. 5 is a left side elevational view of the portable cooler of FIG. 1;

FIG. 6 is a right side elevational view of the portable cooler of FIG. 1;

FIG. 7 is a top plan view of the portable cooler of FIG. 1;

FIG. 8 is a bottom plan view of the portable cooler of FIG. 1;

FIG. 9 is a top perspective view of the portable cooler of FIG. 1 with its lid opened;

FIG. 10 is a top perspective view of the portable cooler of FIG. 1 with its inner container shown being removed from or inserted into its outer sleeve;

FIG. 16 is a right side elevational view of the portable cooler of FIG. 11;

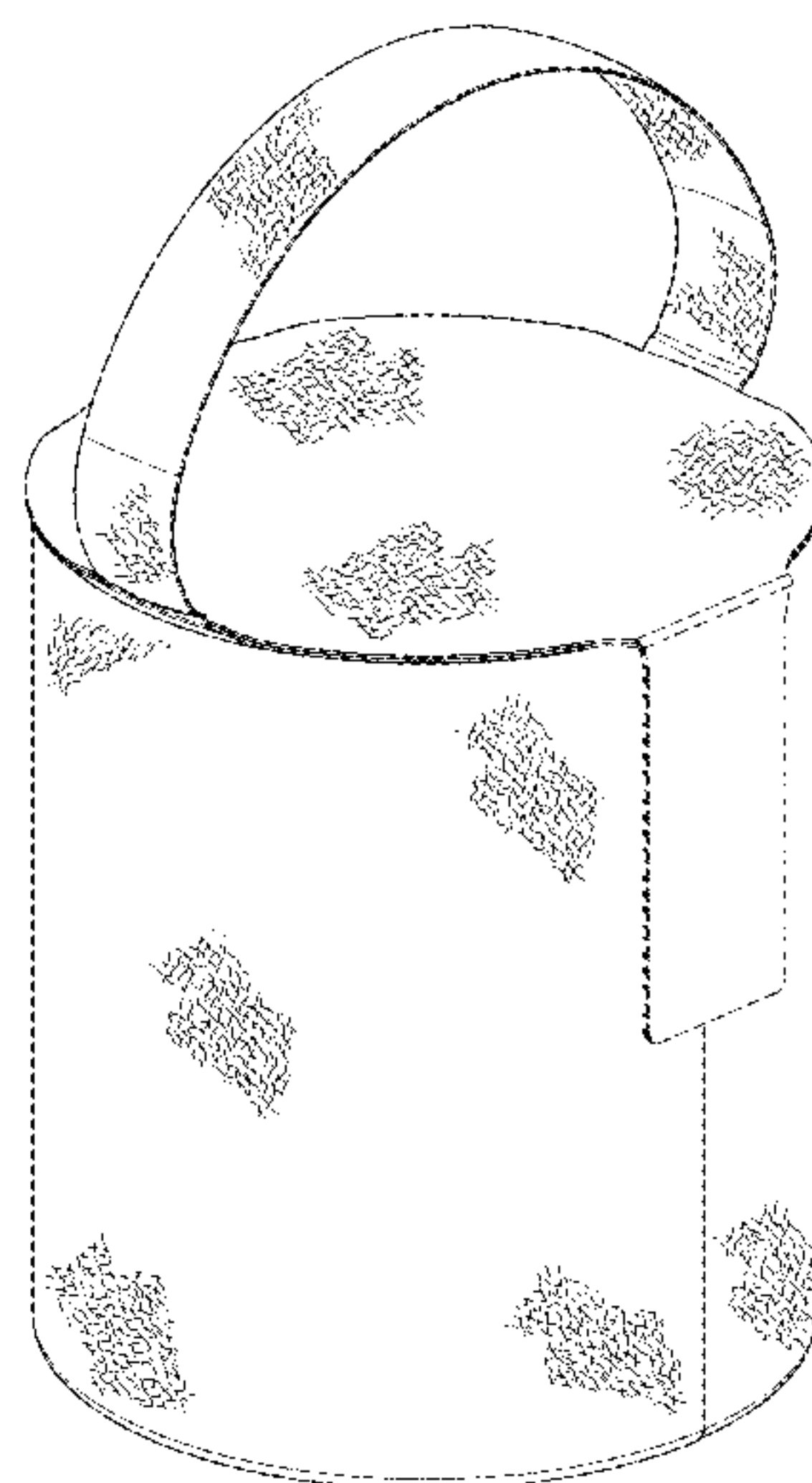
FIG. 17 is a top plan view of the portable cooler of FIG. 11;

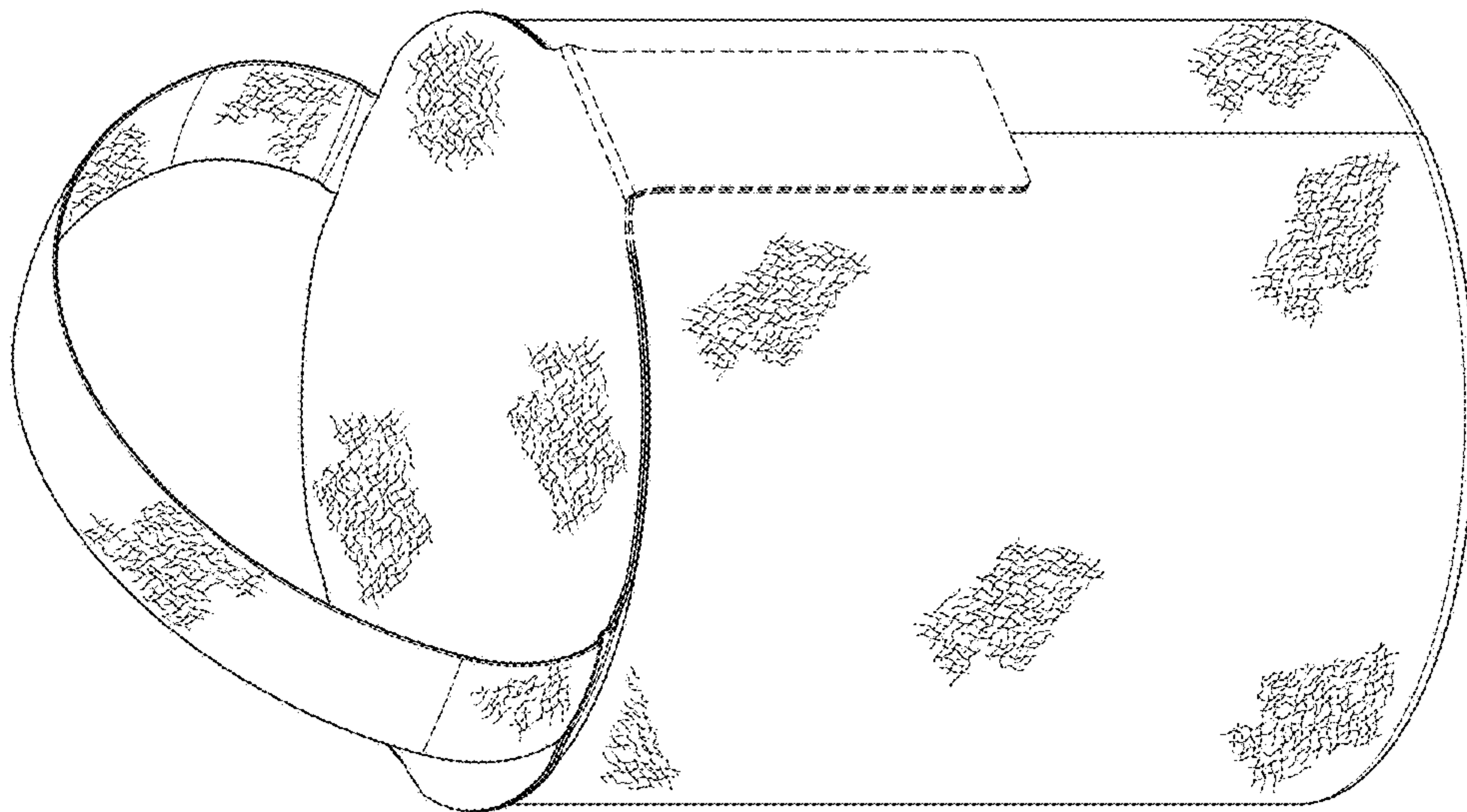

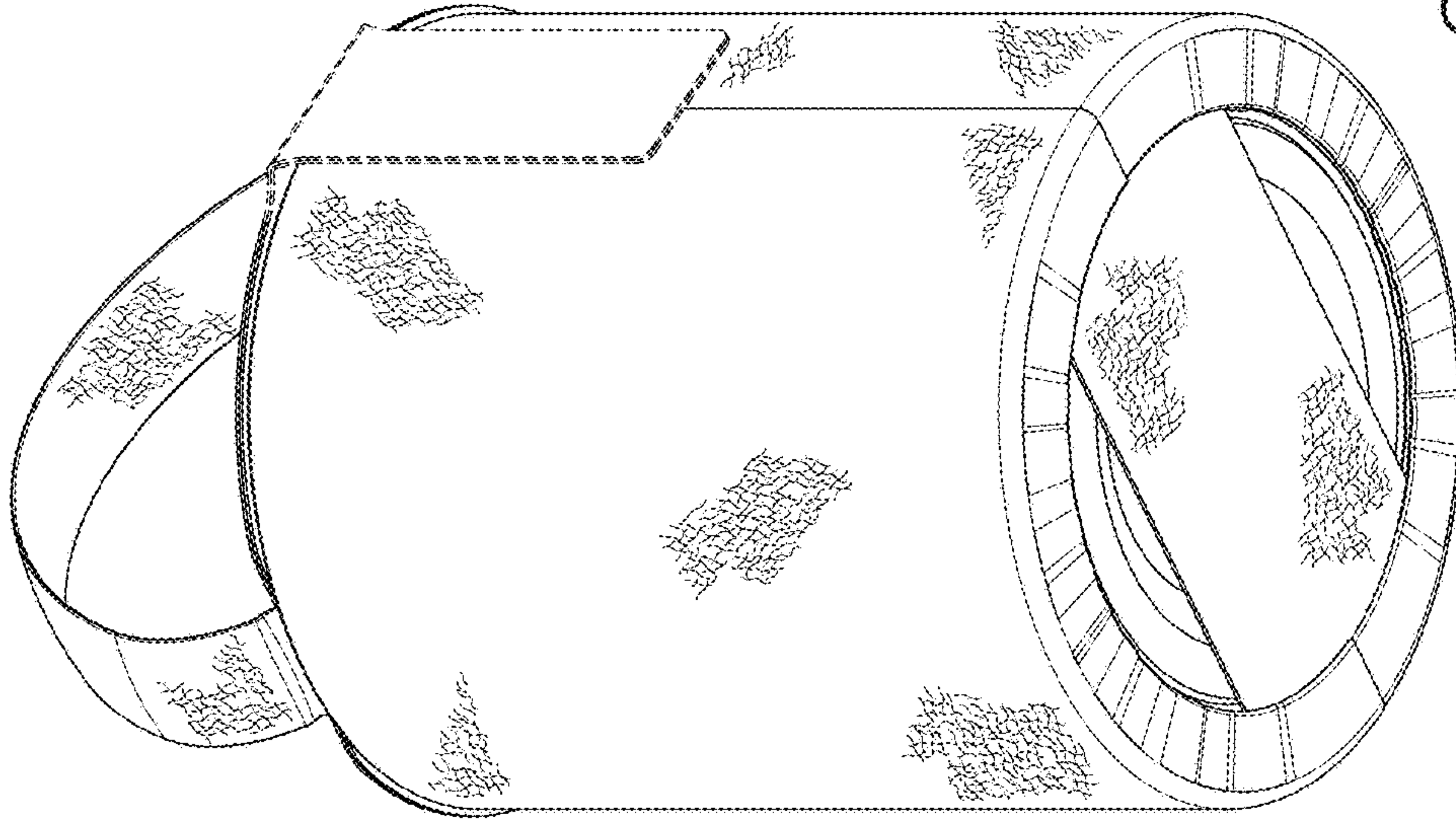

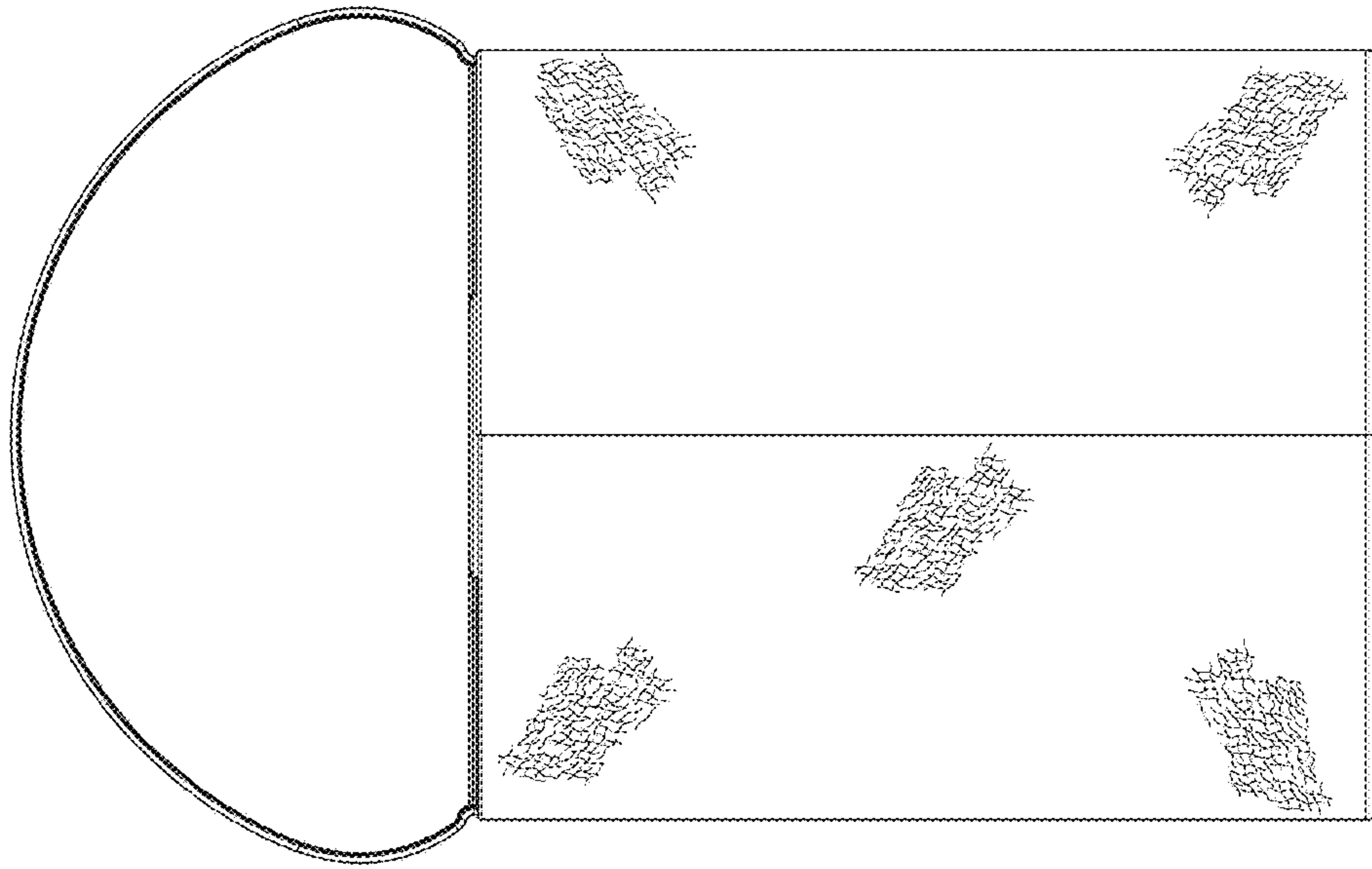

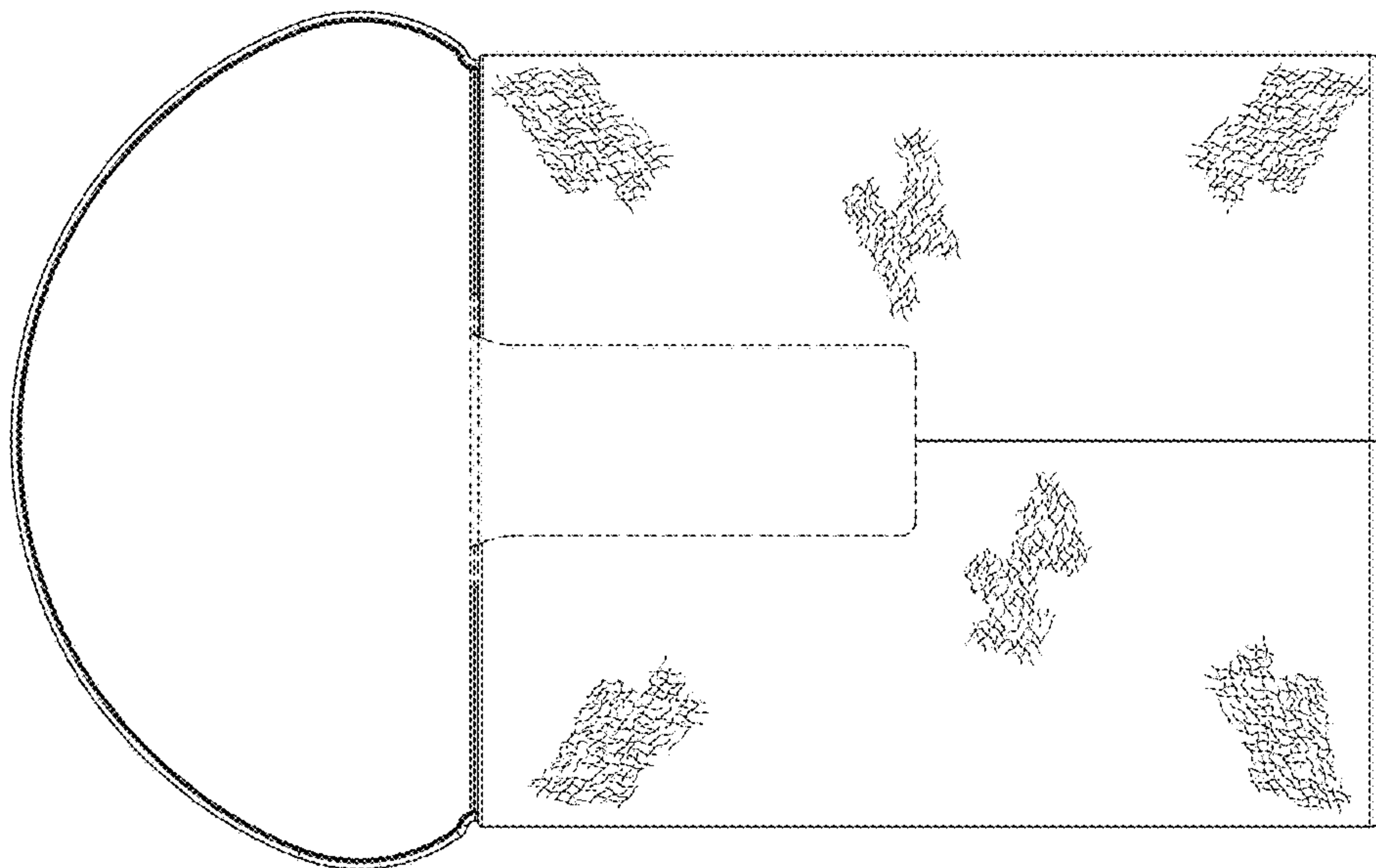

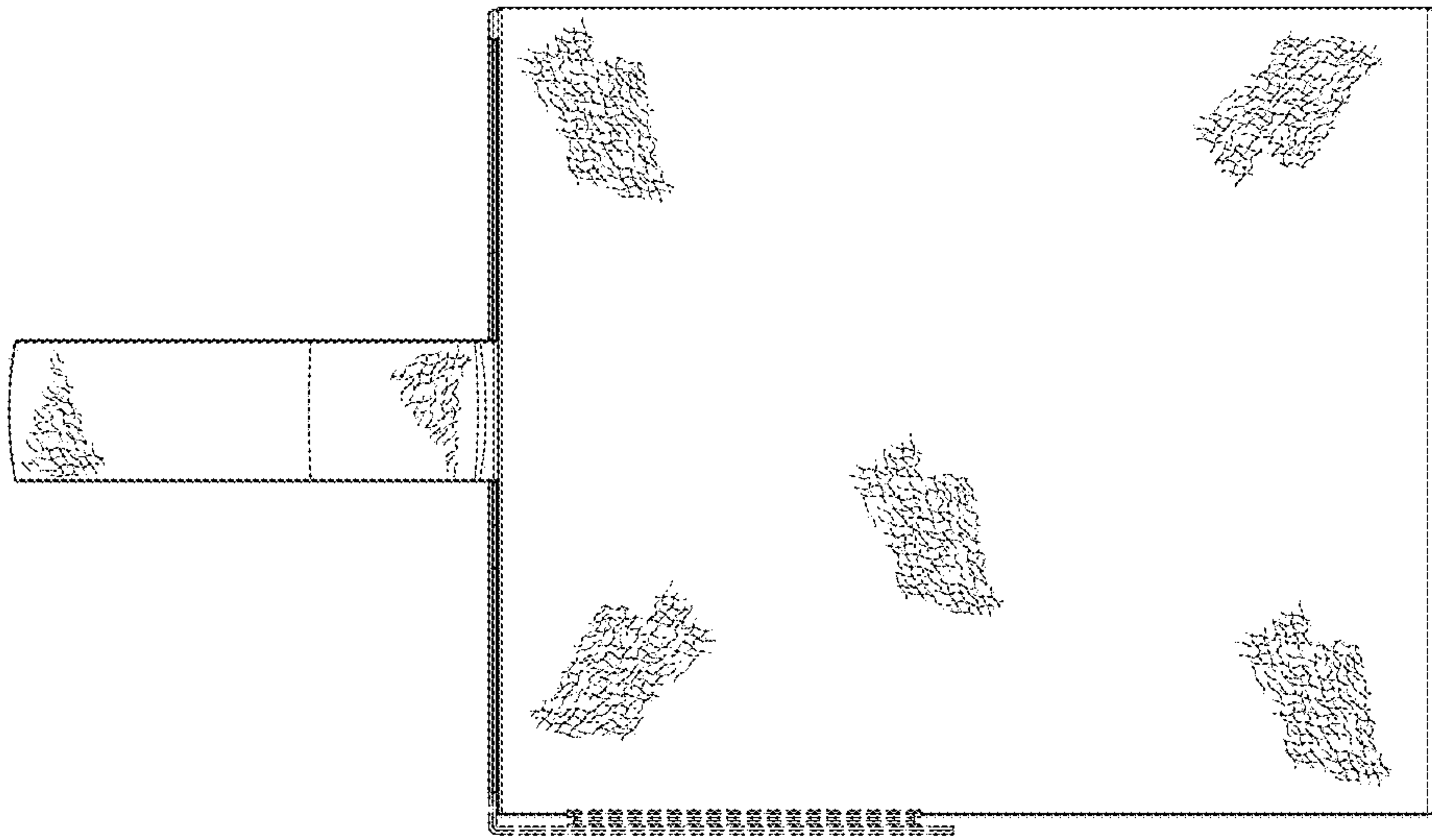

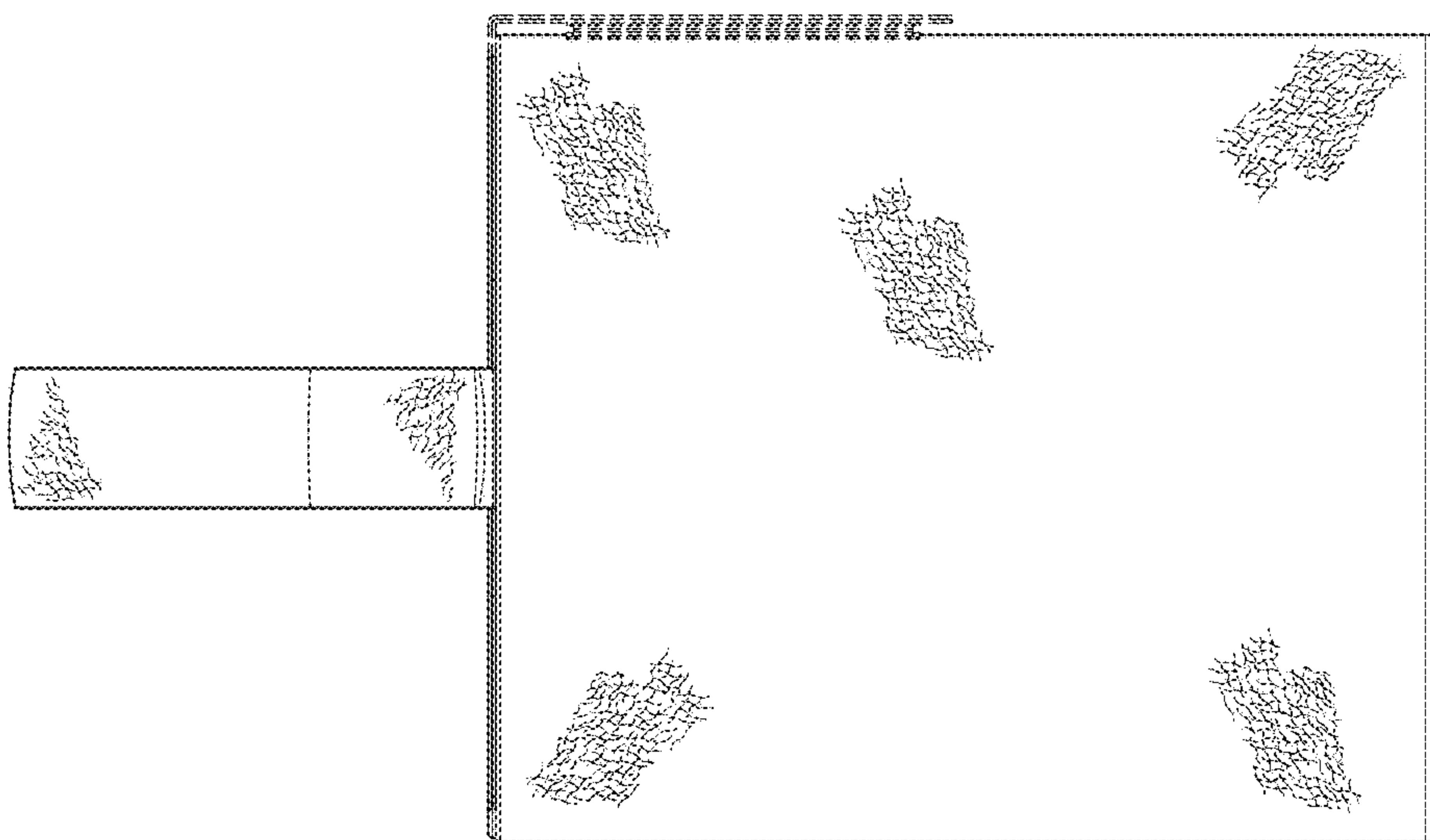

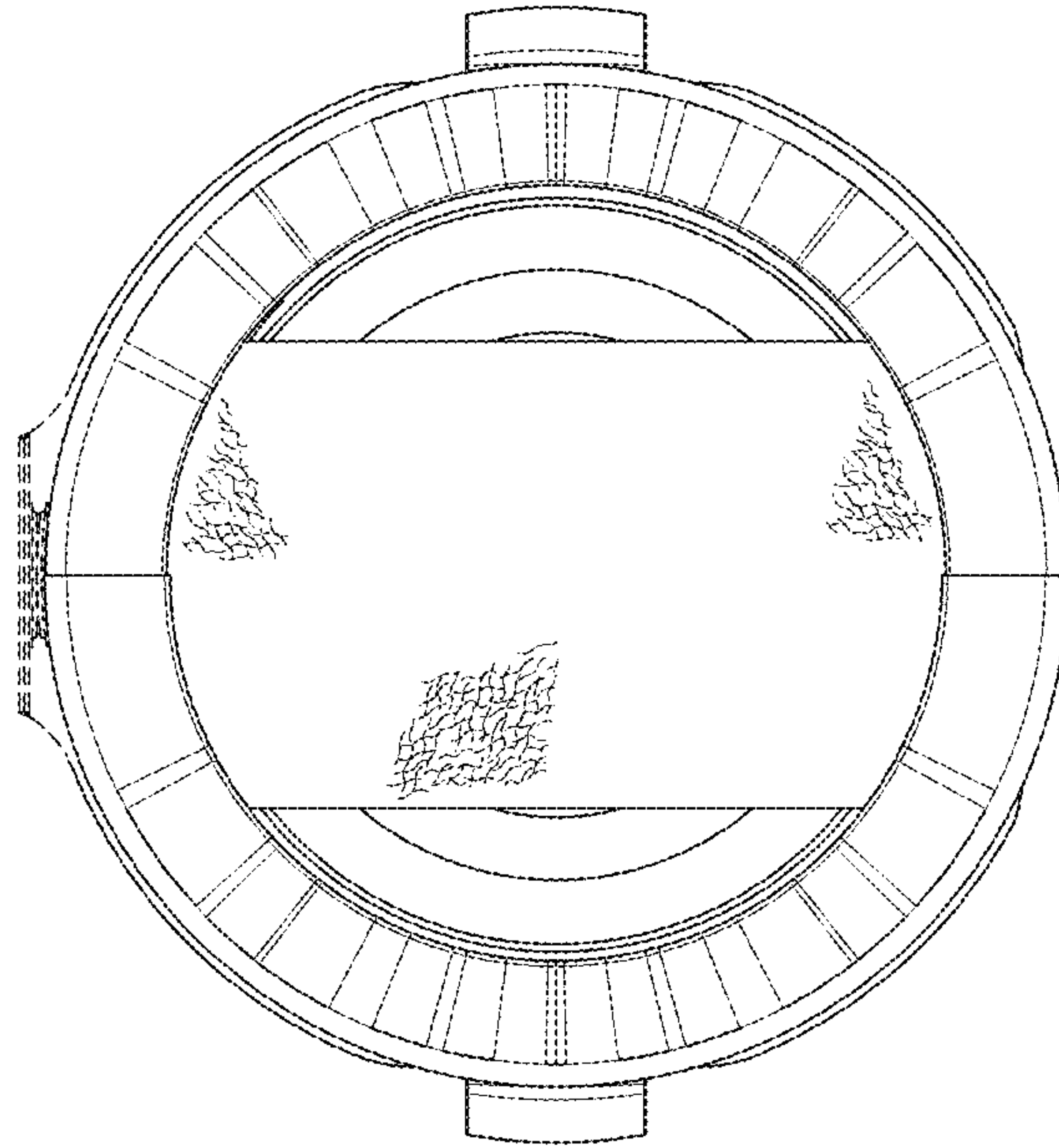

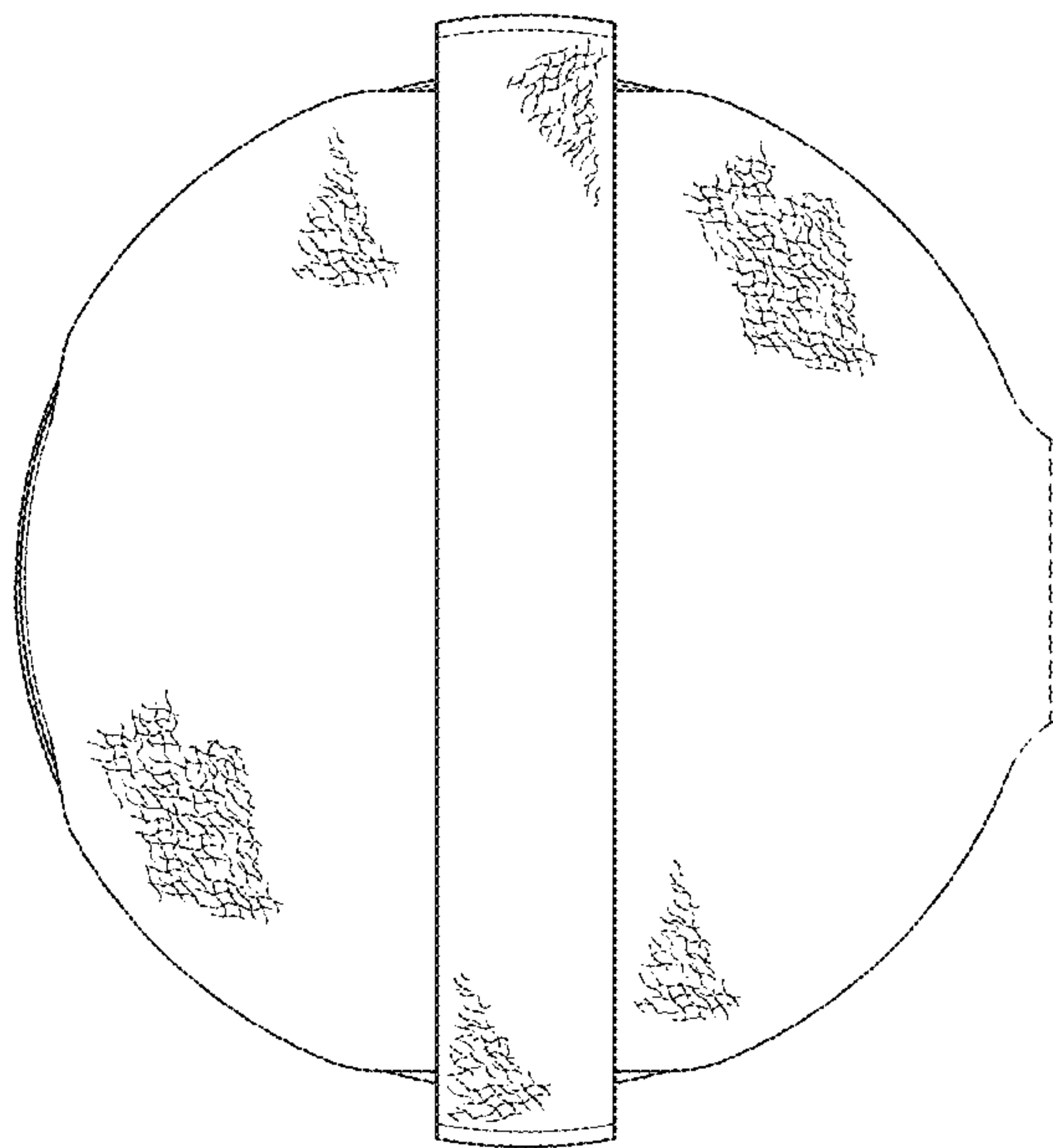

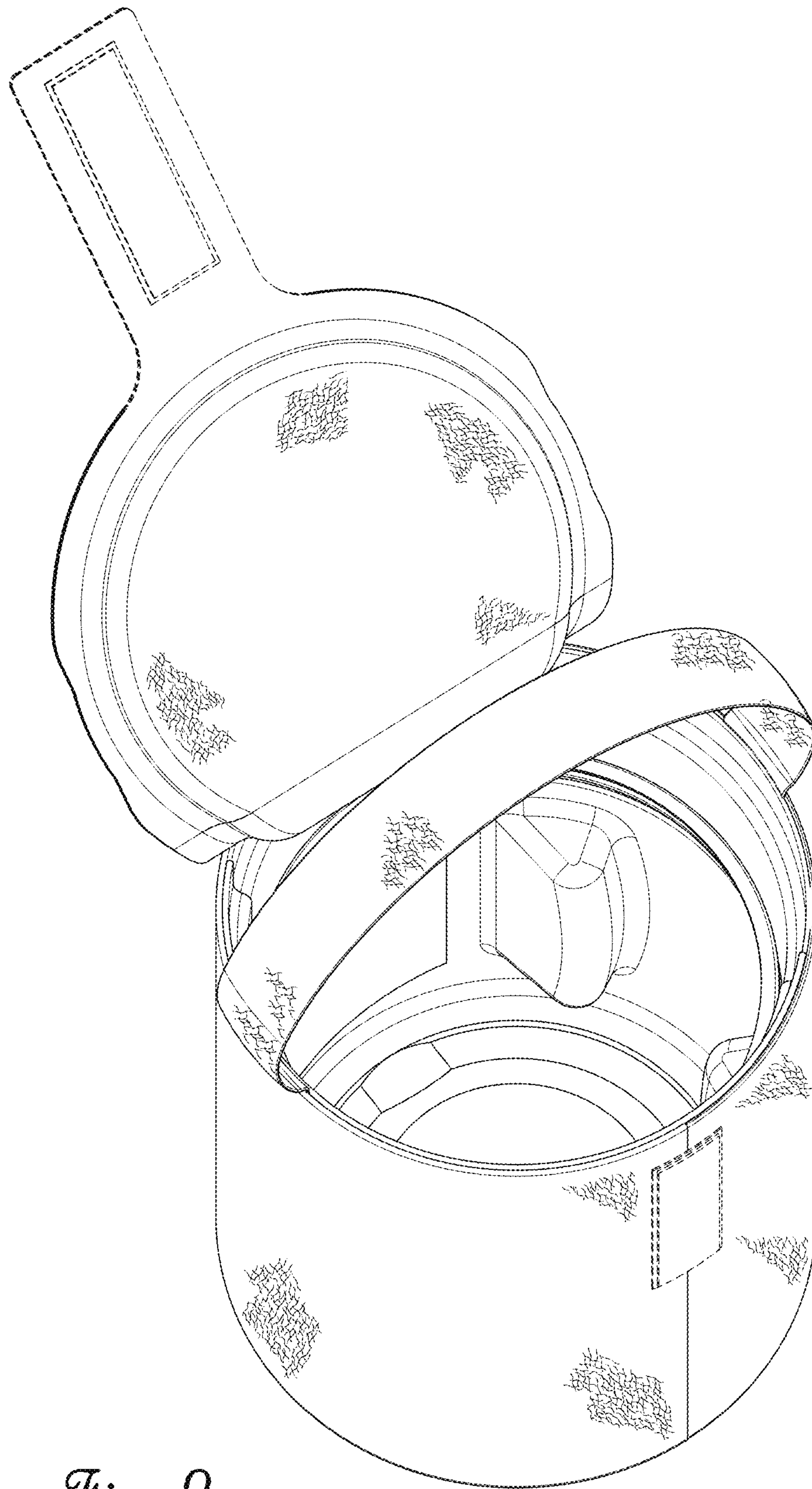

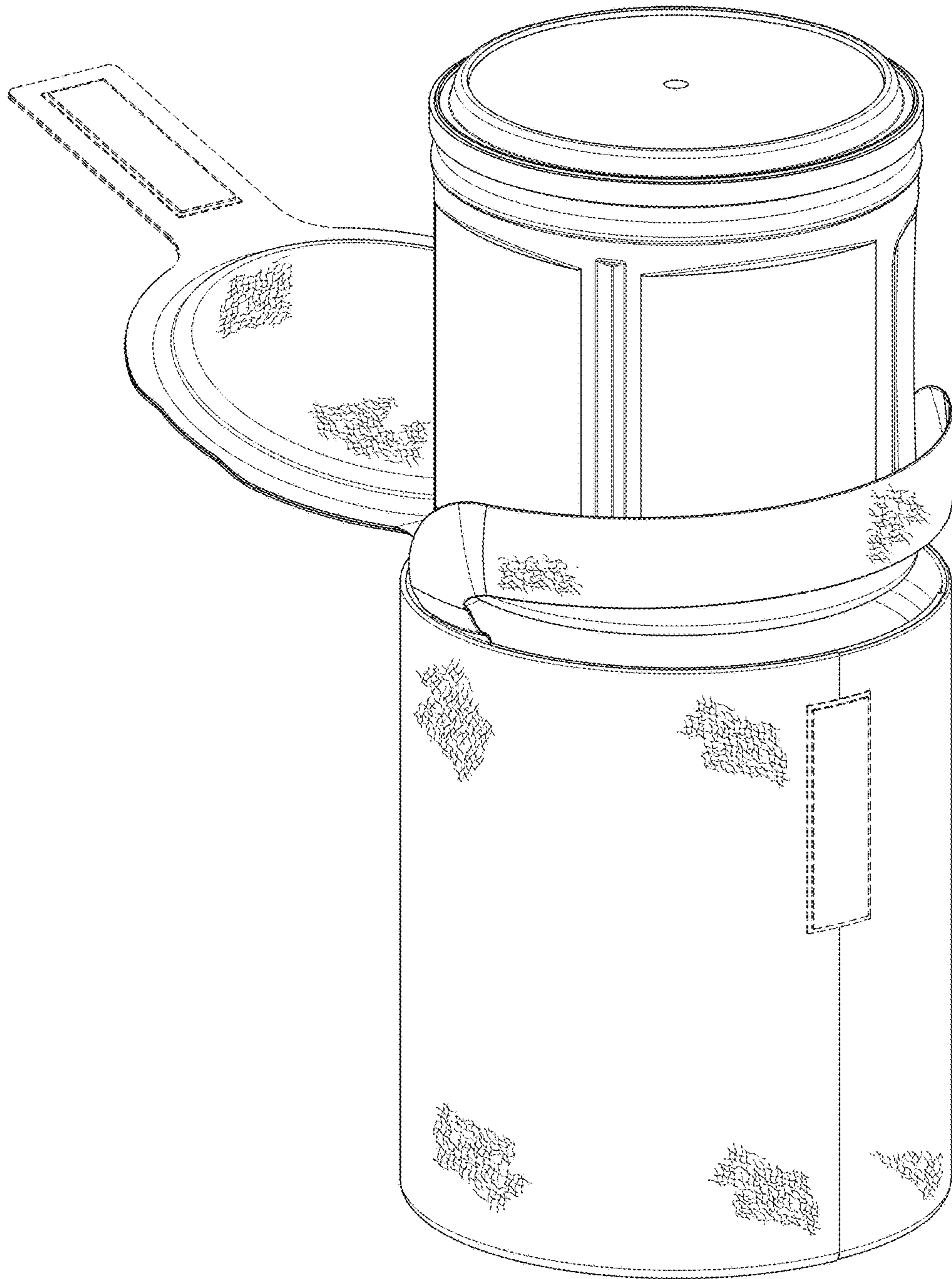

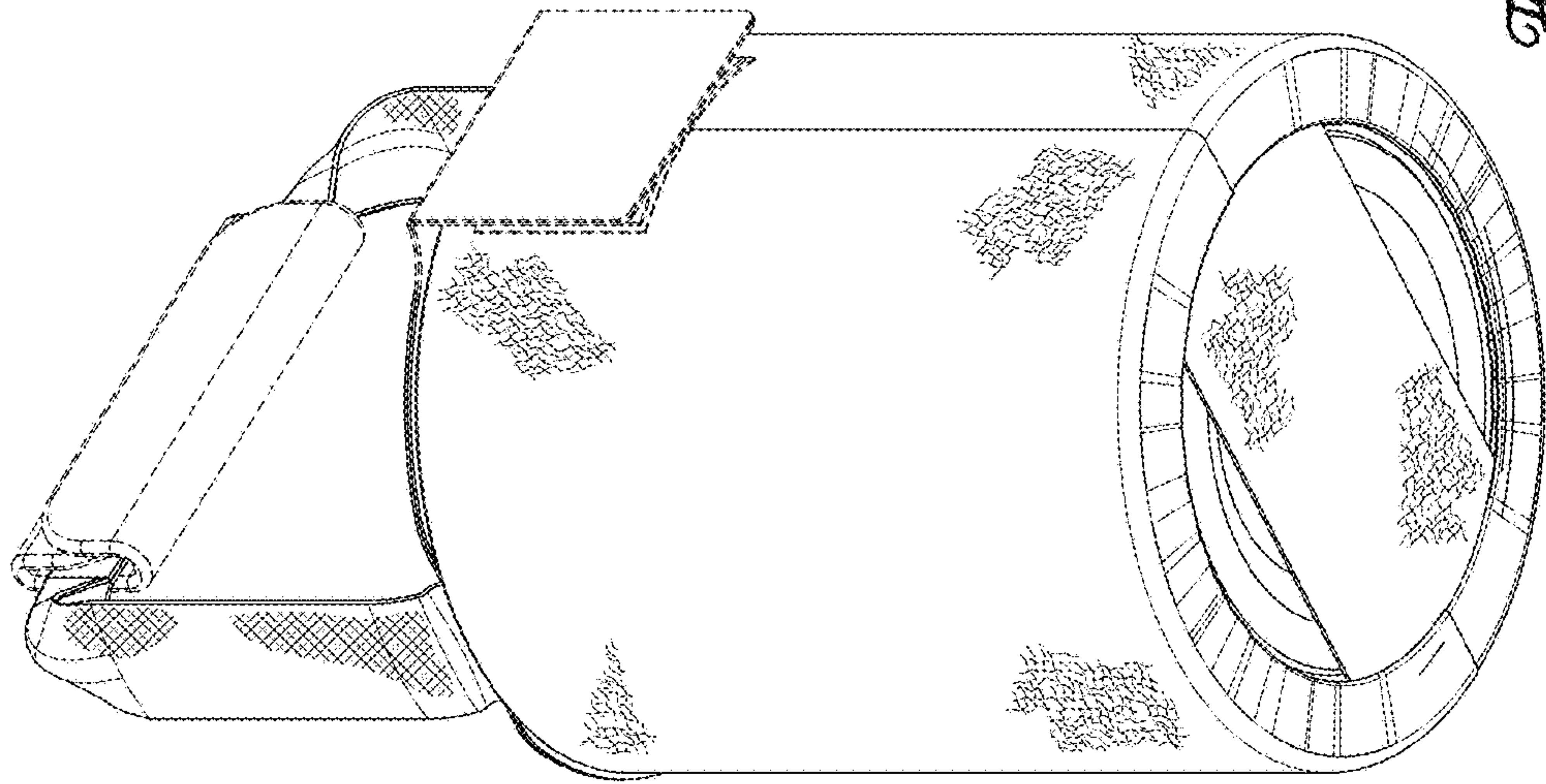

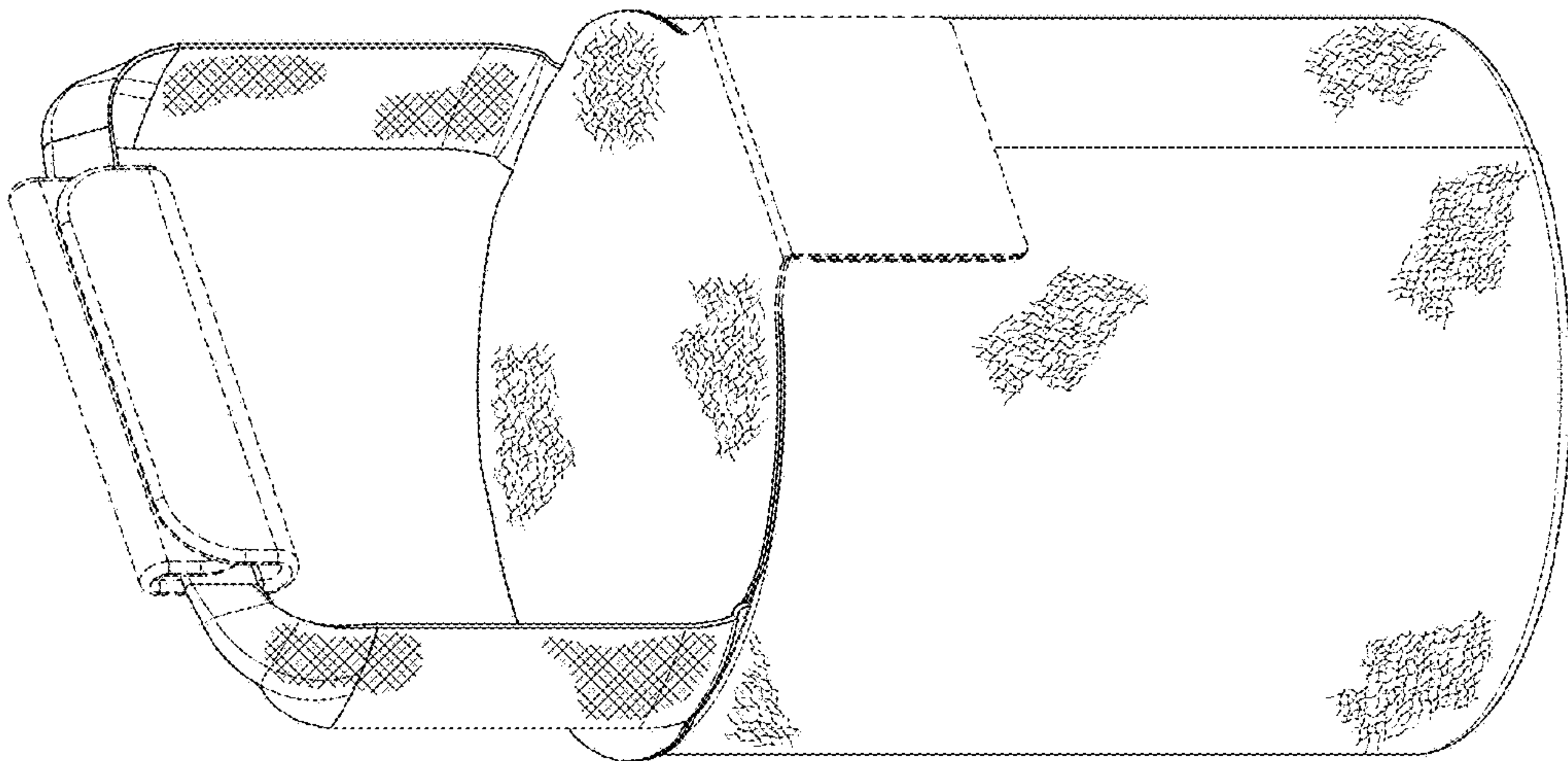

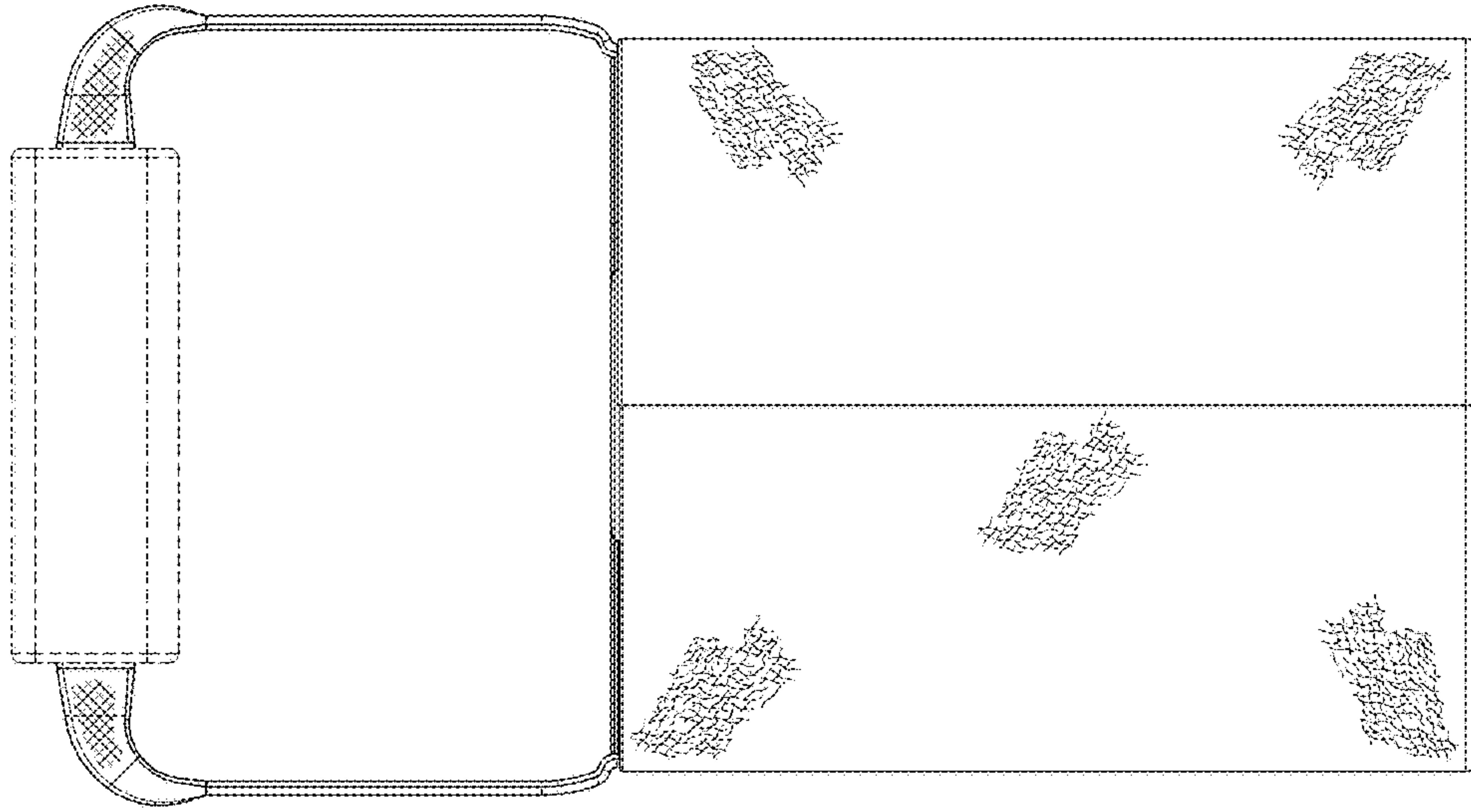

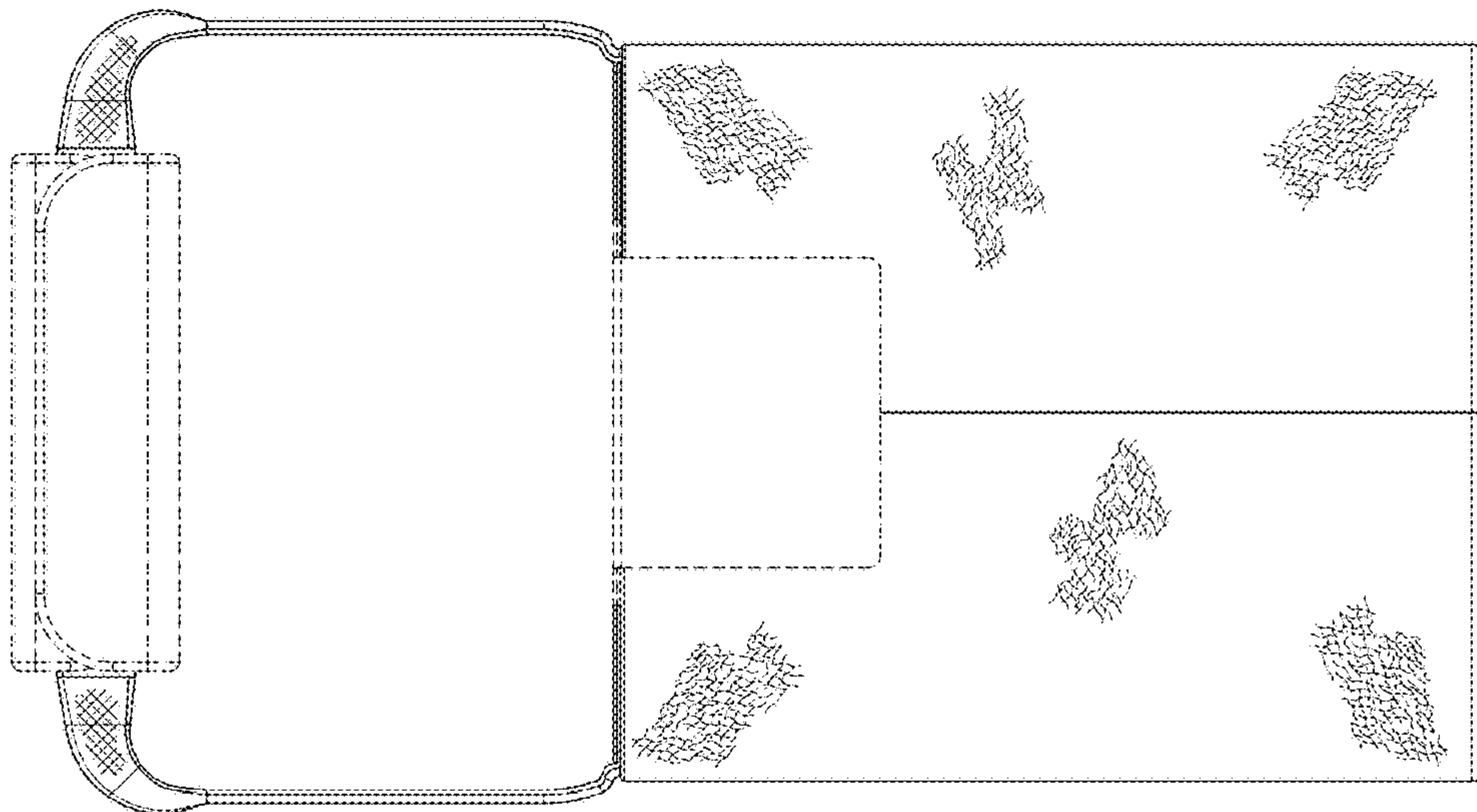

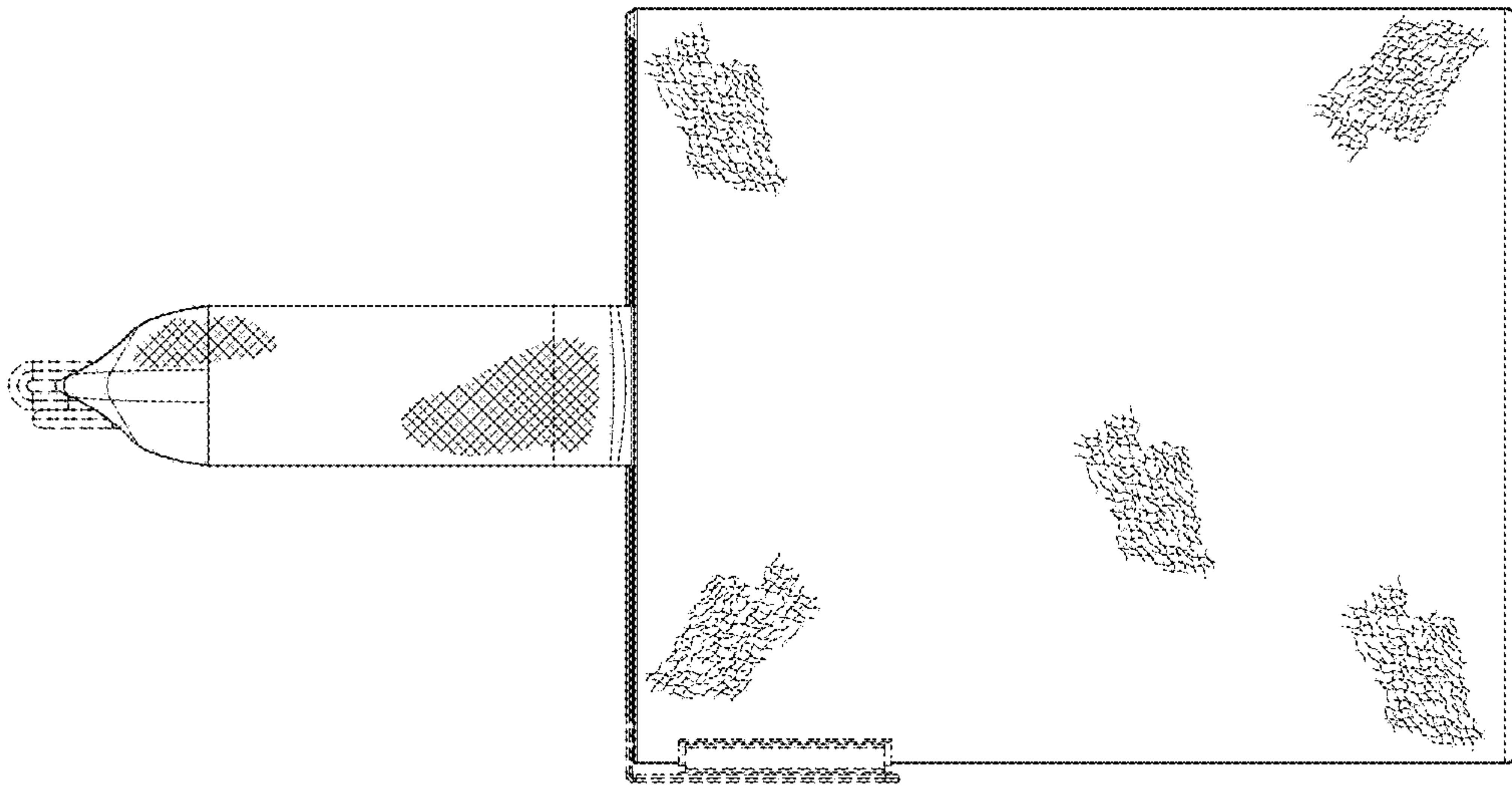

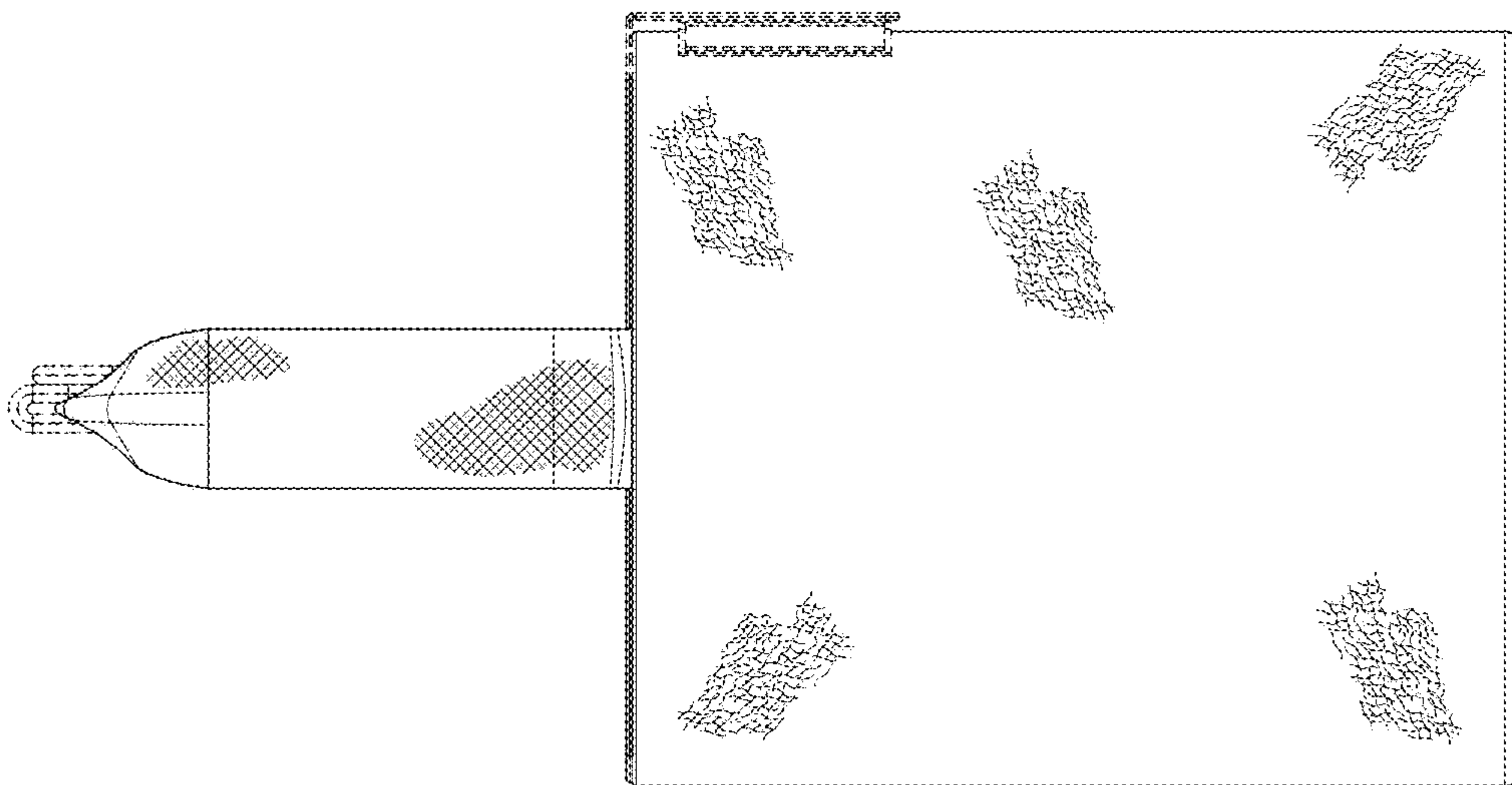

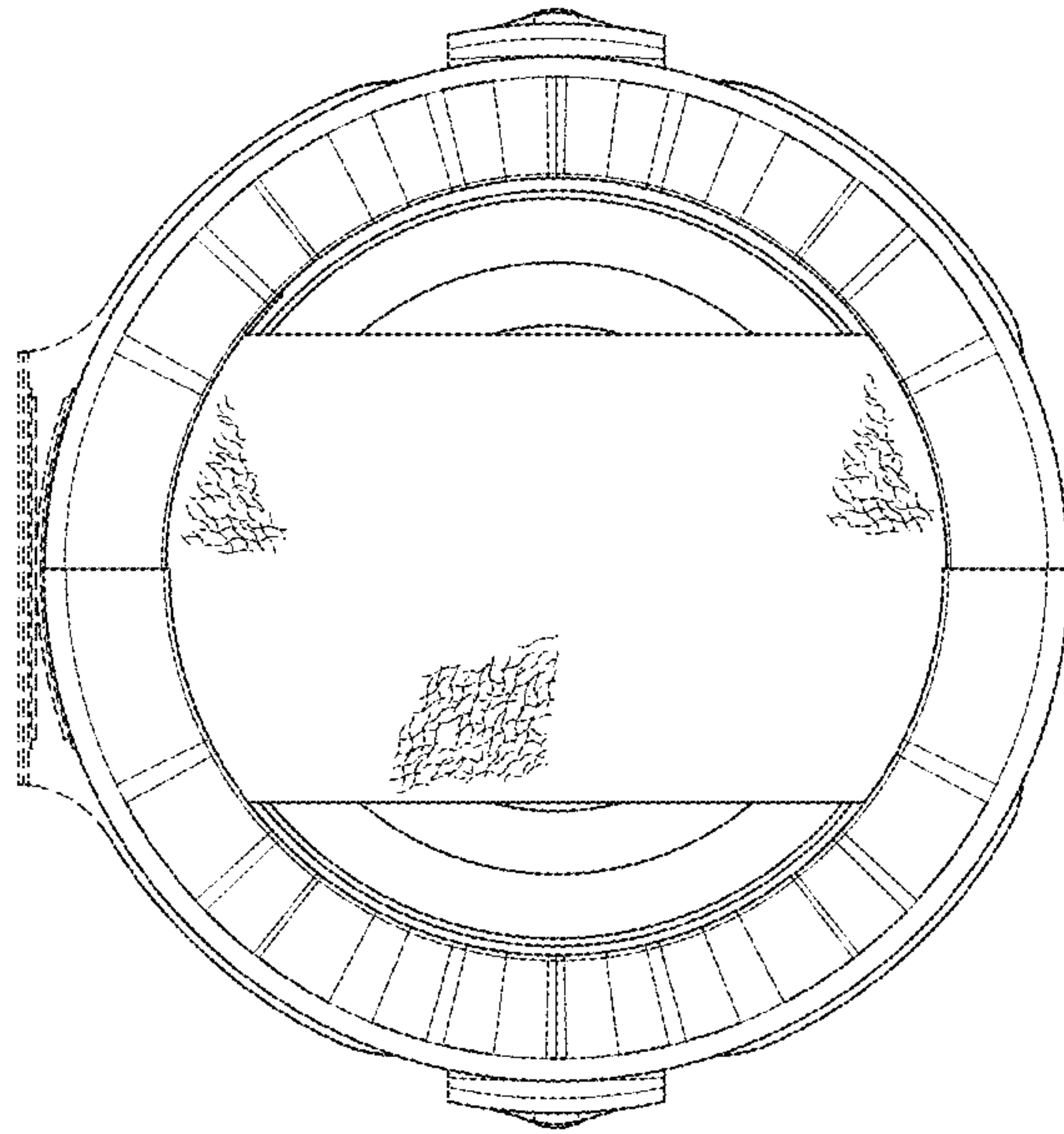

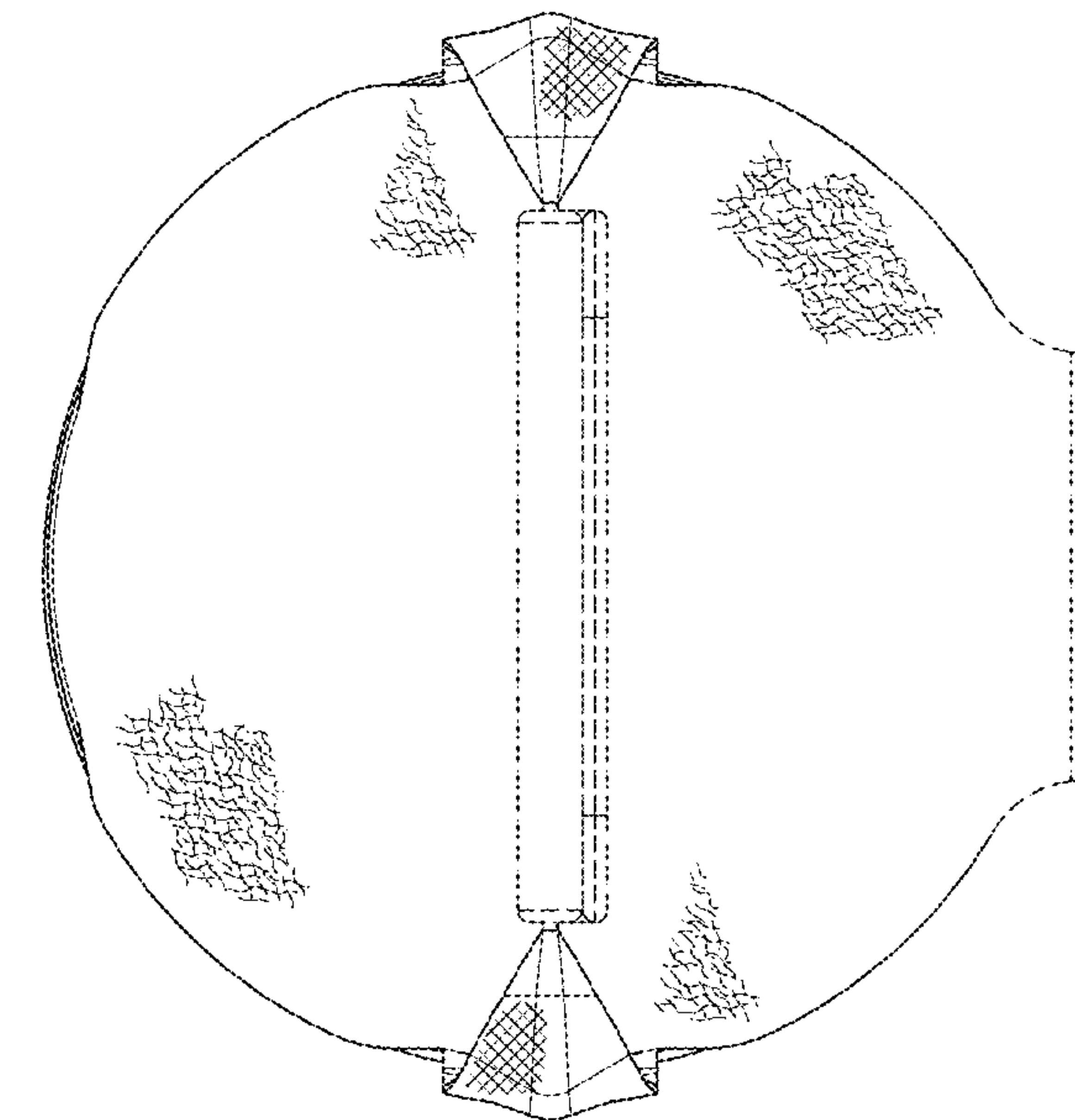

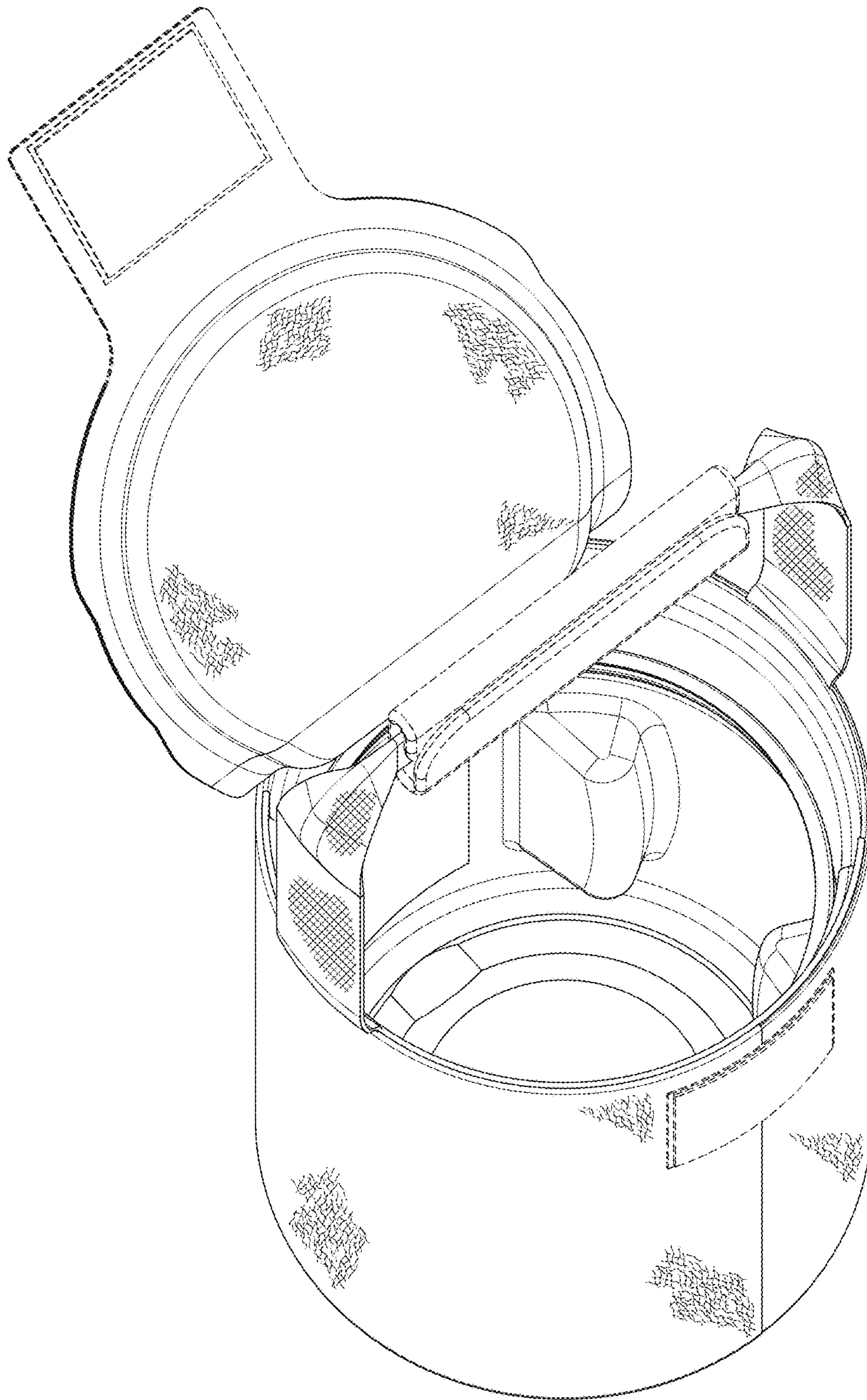

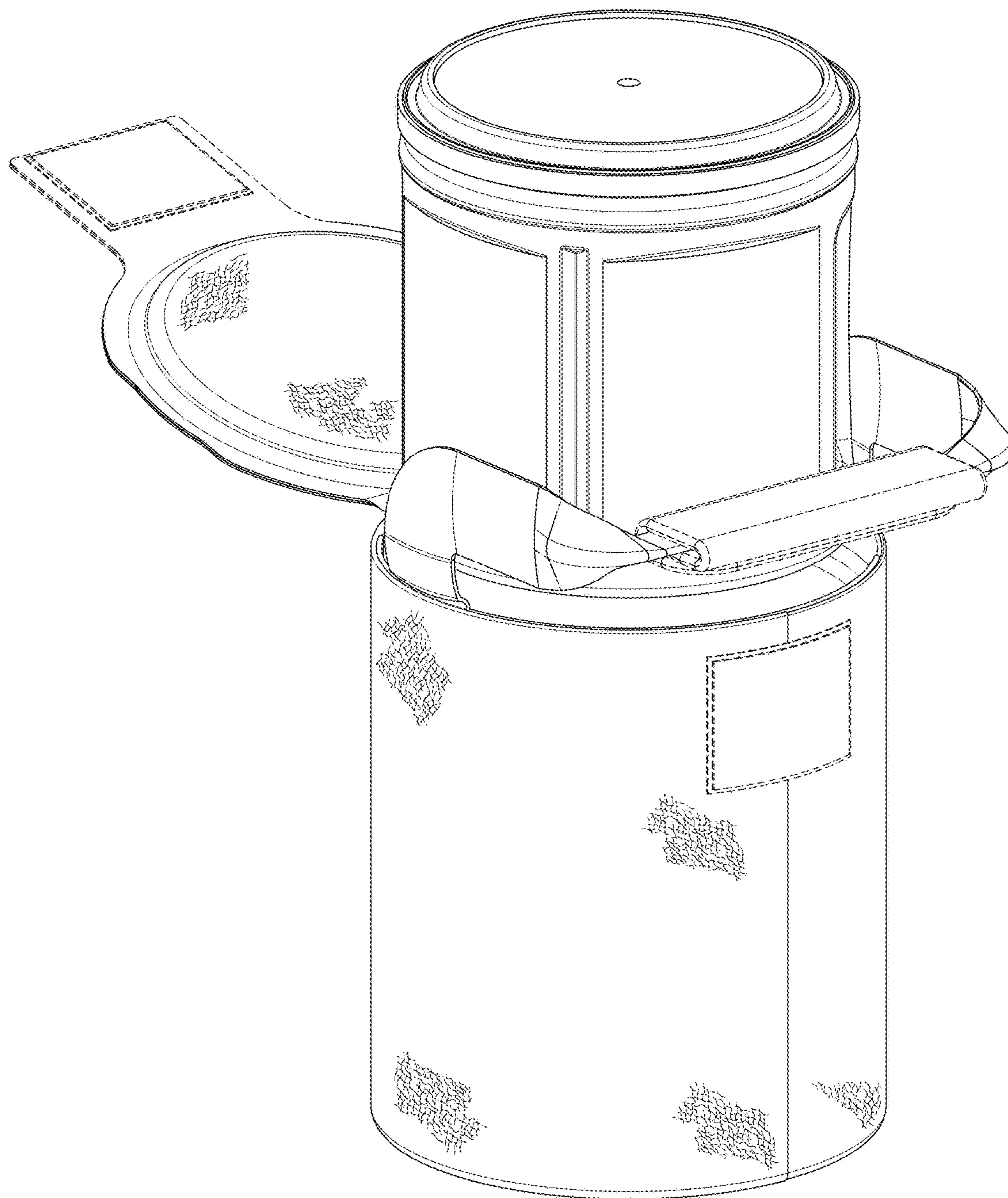
