(57) **CLAIM**

The ornamental design for a double-edged offset blade, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a double-edged offset blade according to the present invention.

FIG. 2 is a side elevation view of the double-edged offset blade illustrated in FIG. 1.

FIG. 3 is another side elevation view of the double-edged offset blade illustrated in FIG. 1.

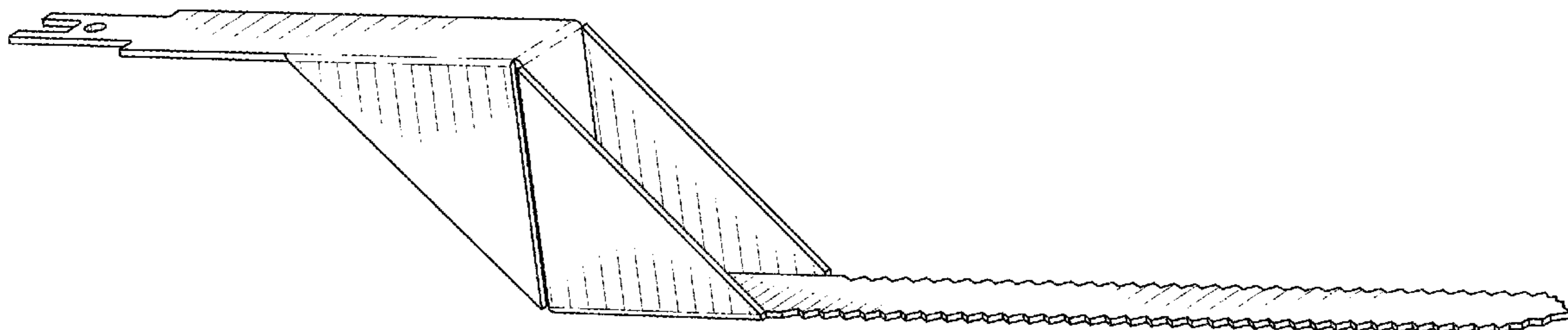
FIG. 4 is a front elevation view of the double-edged offset blade illustrated in FIG. 1.

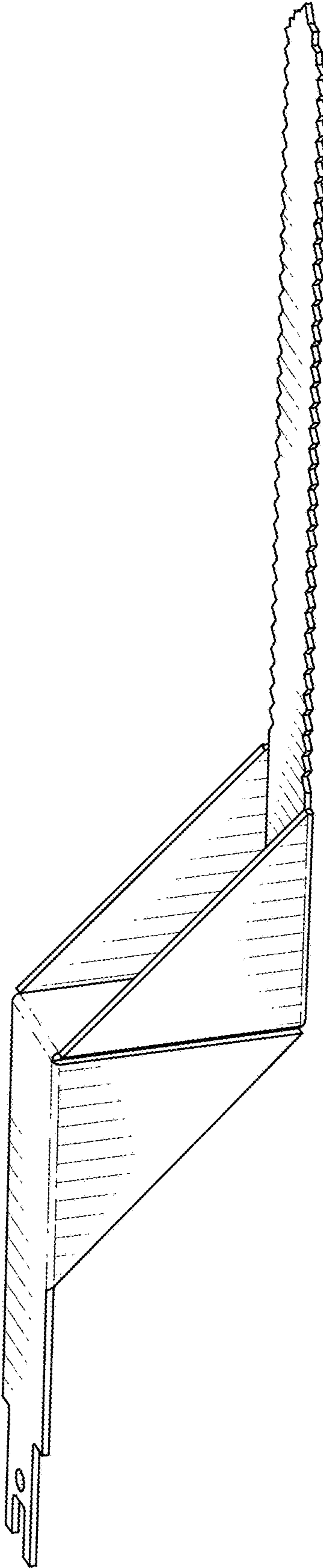

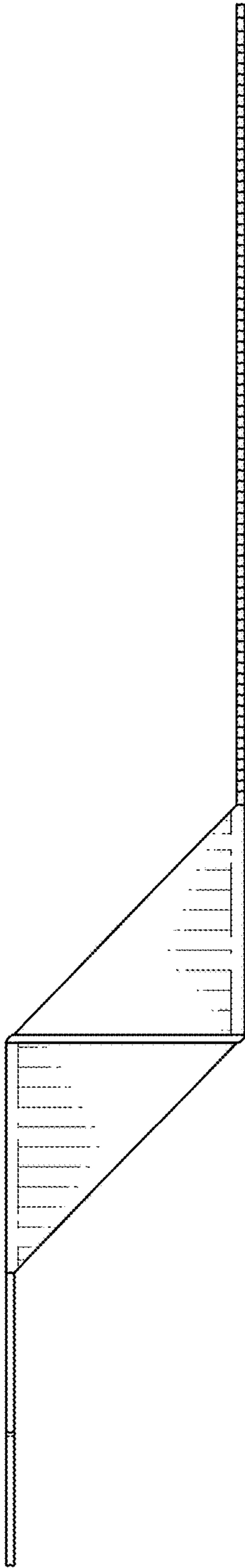

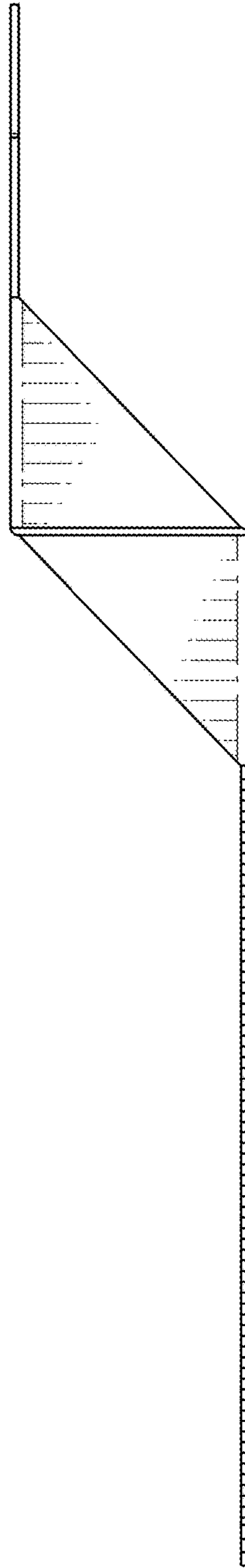

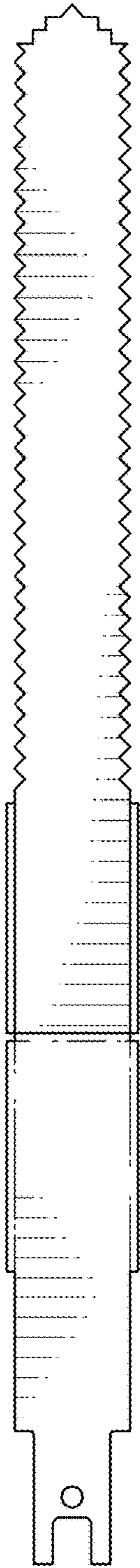

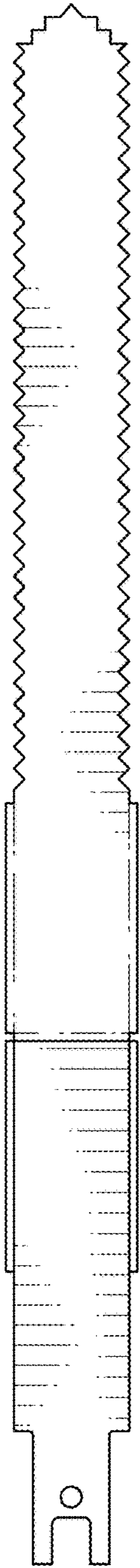

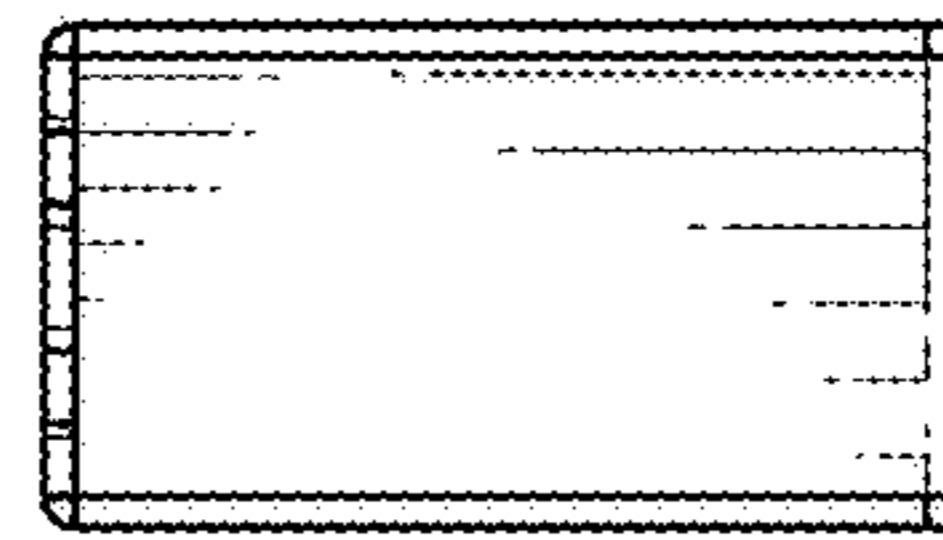

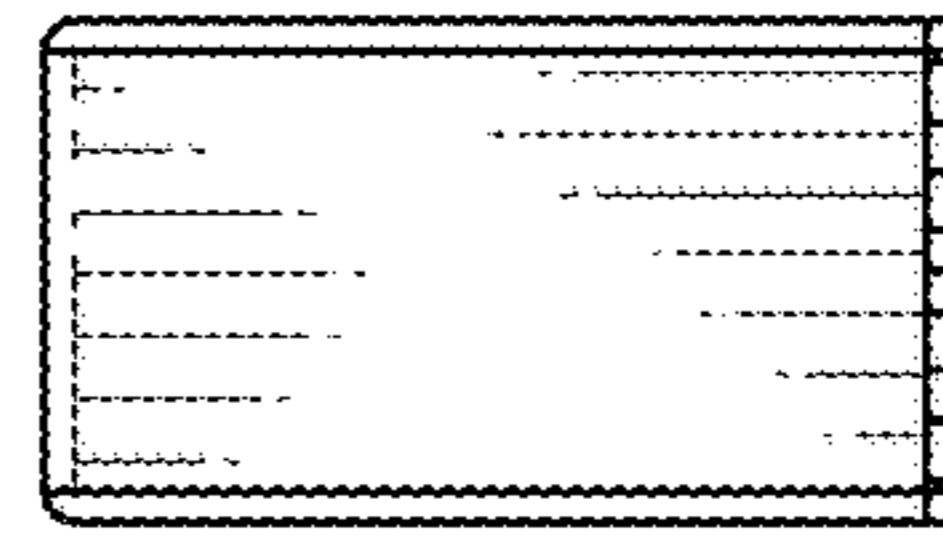
