DESCRIPTION

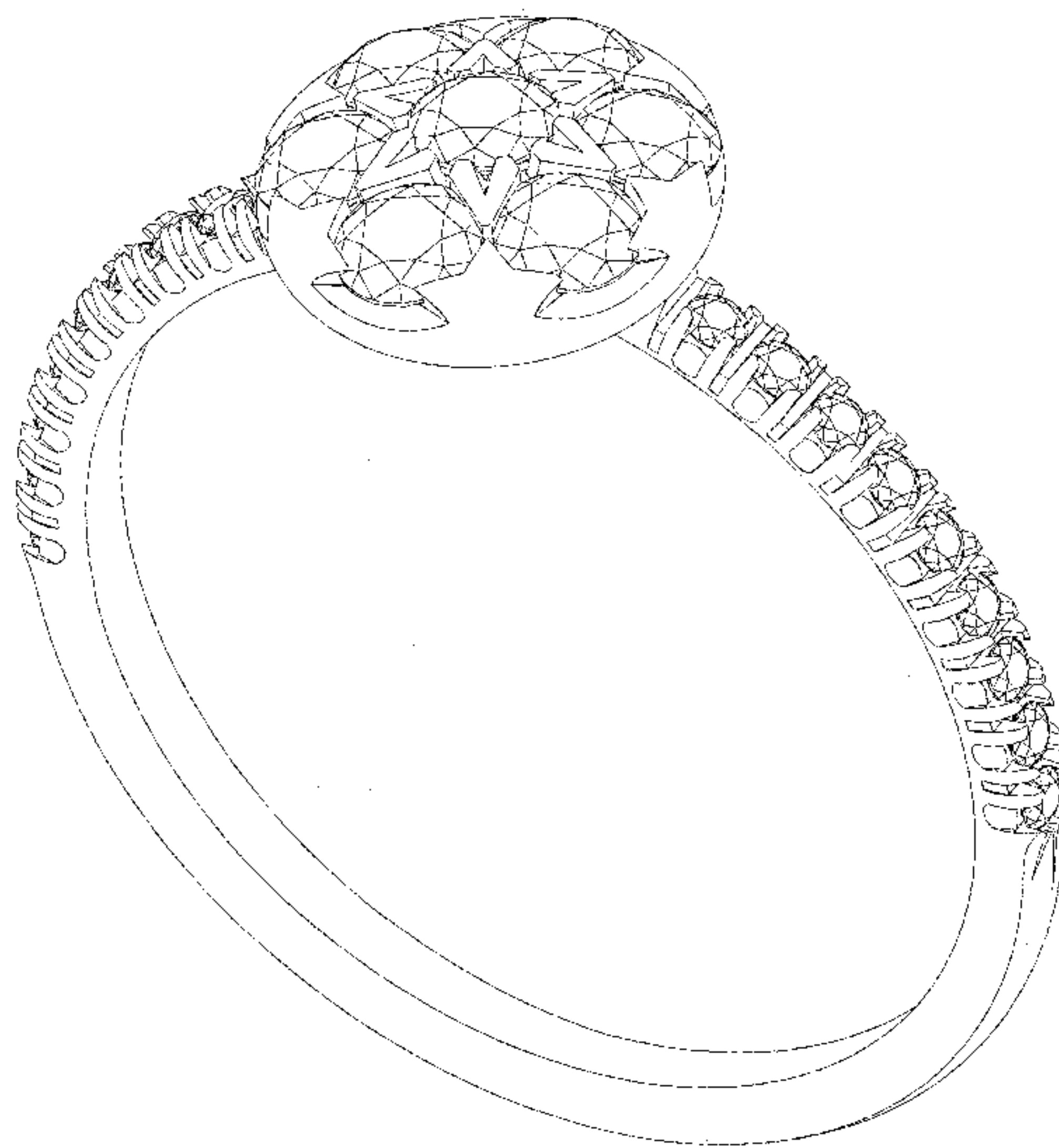
FIG. 1 is a front elevational view of a ring showing my new design;

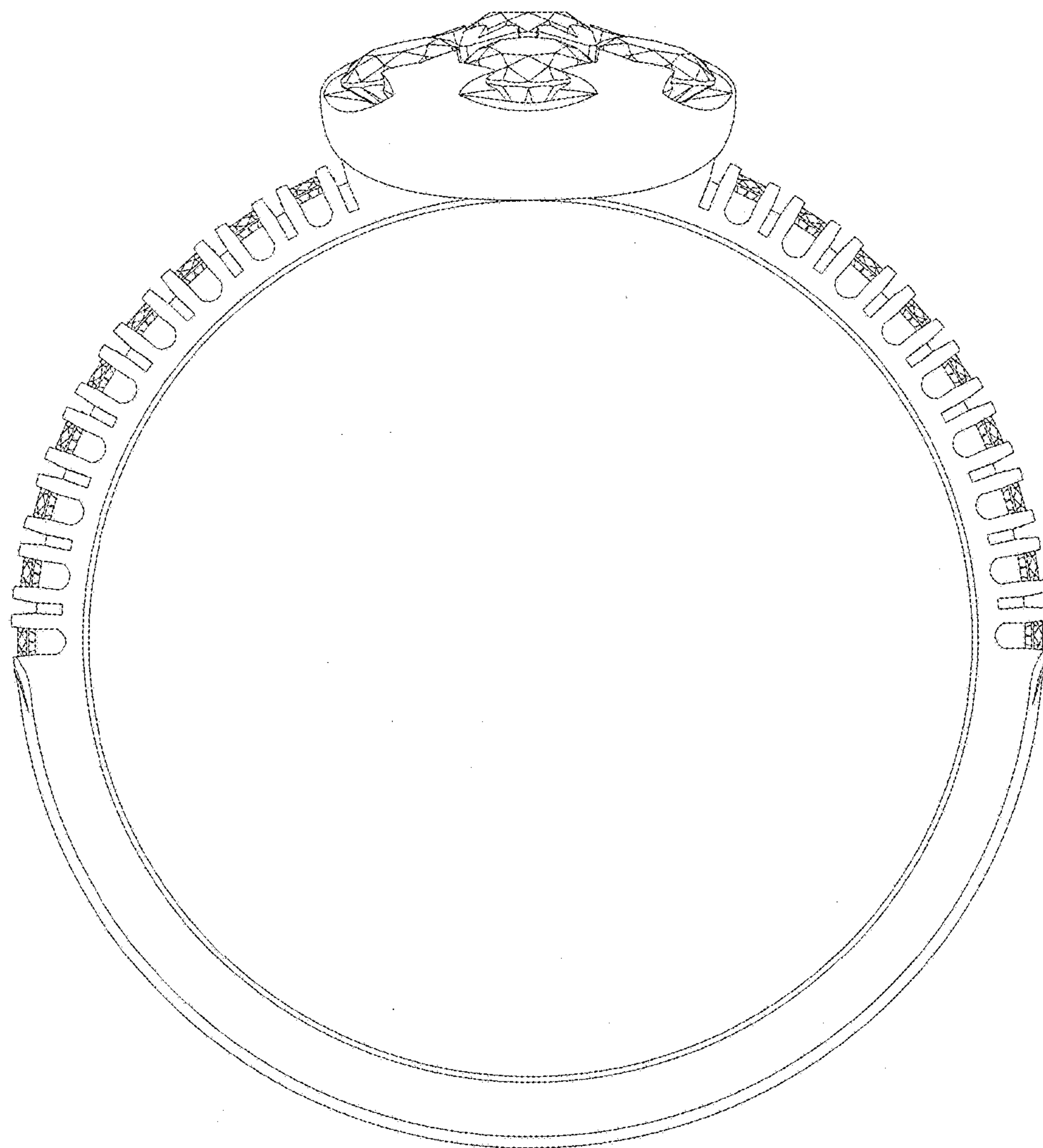

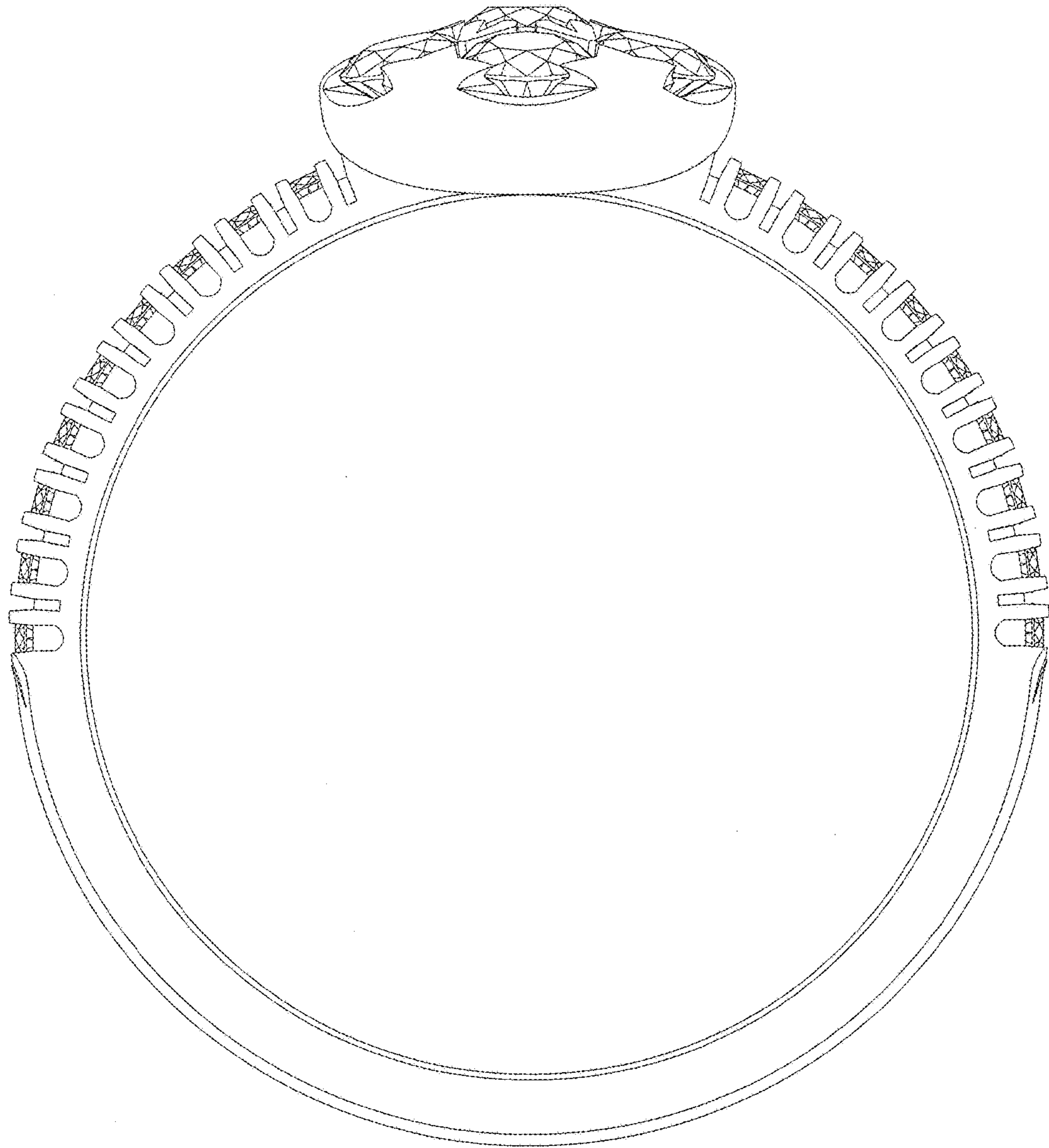

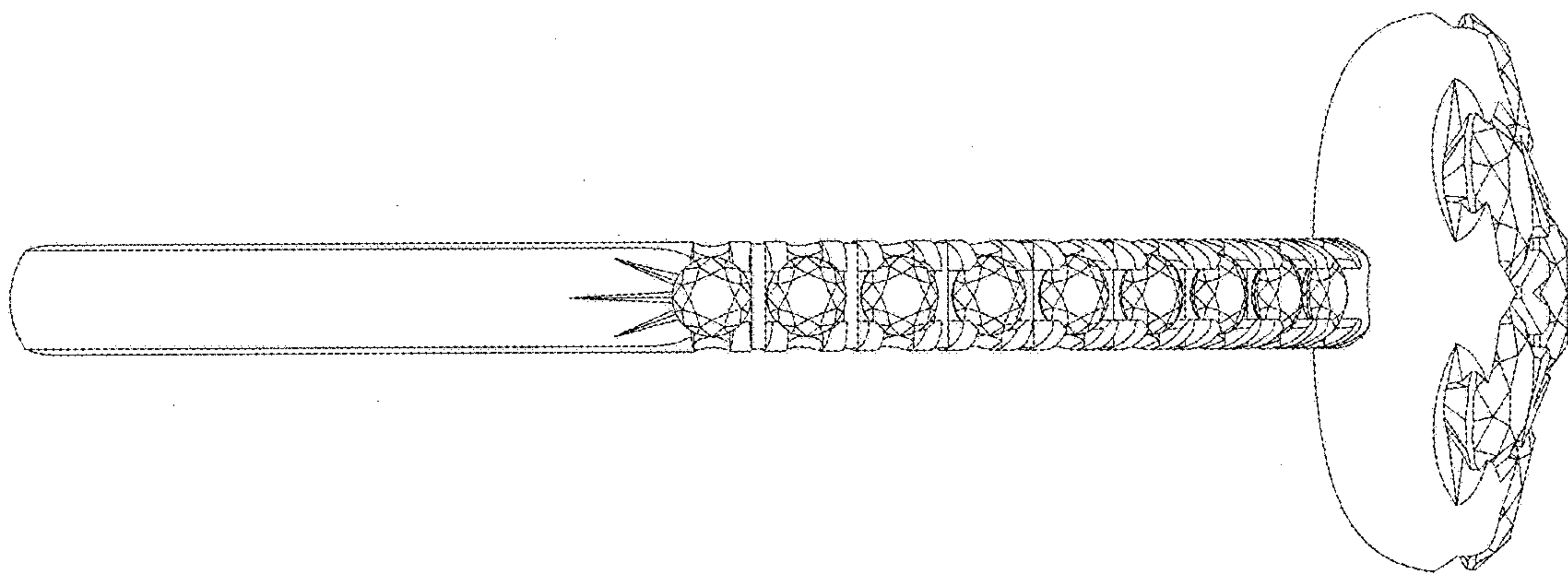

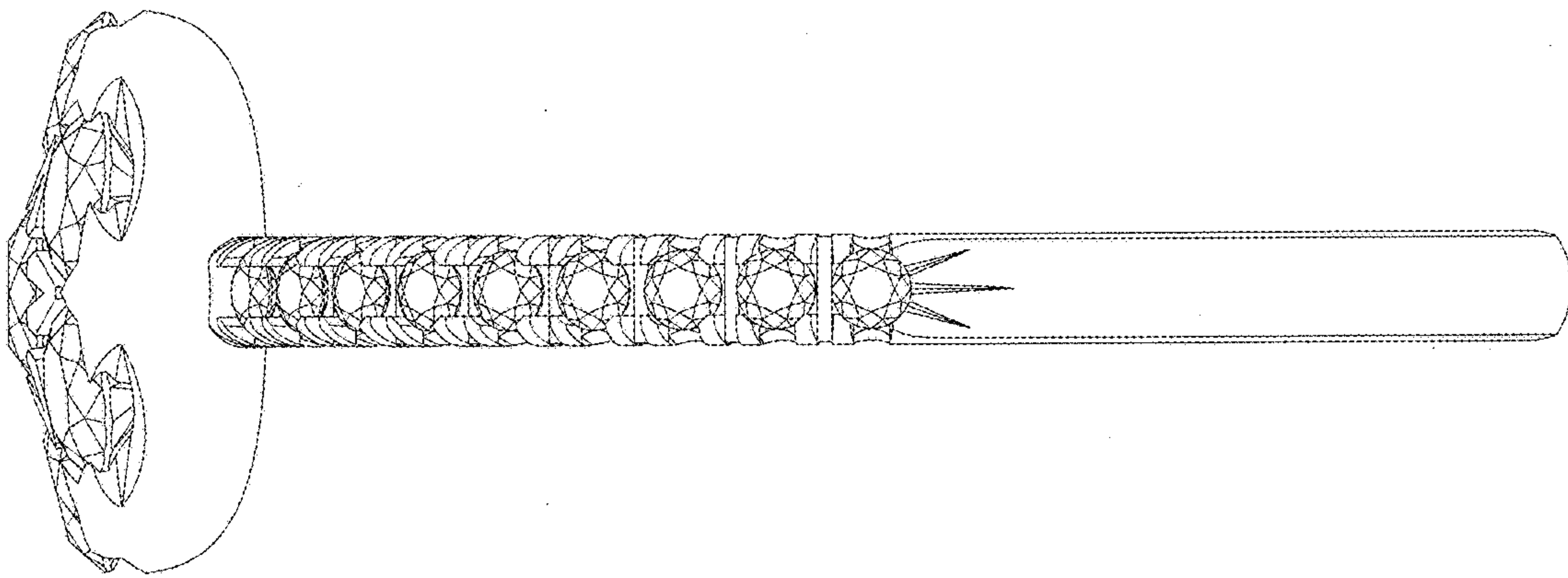

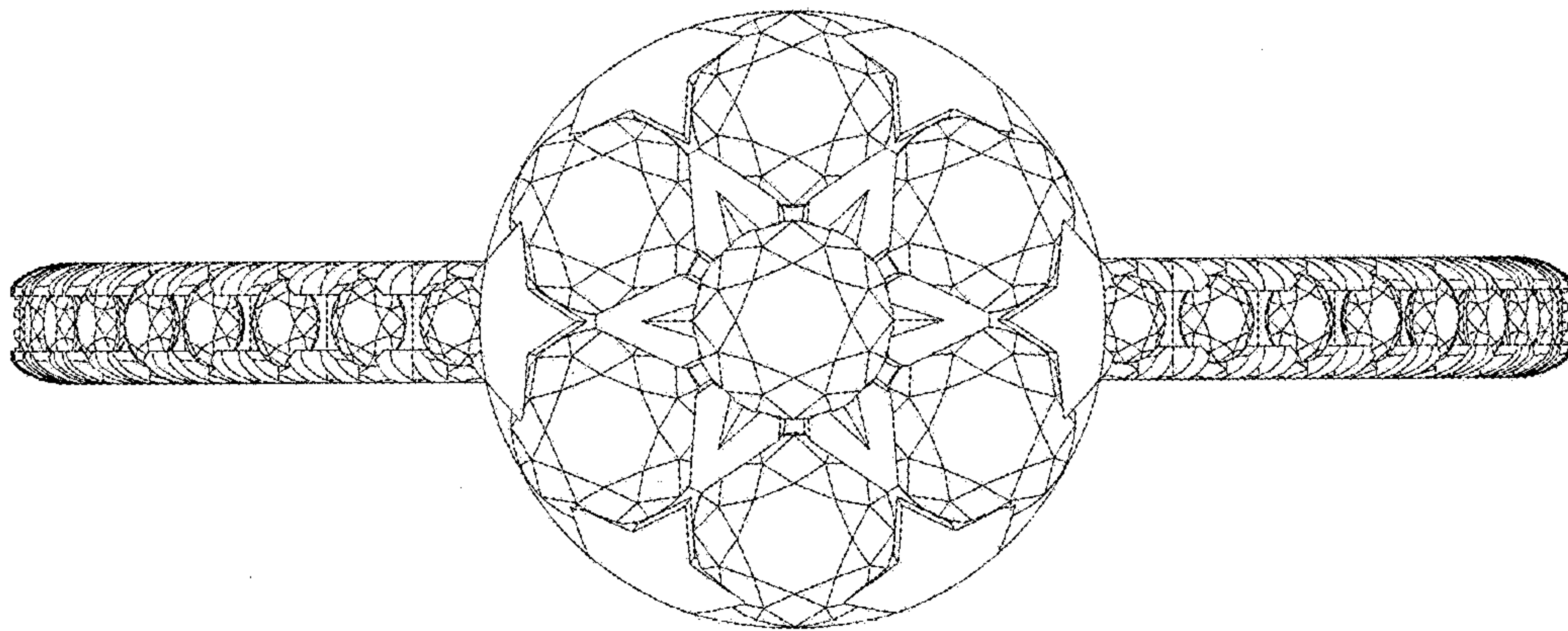

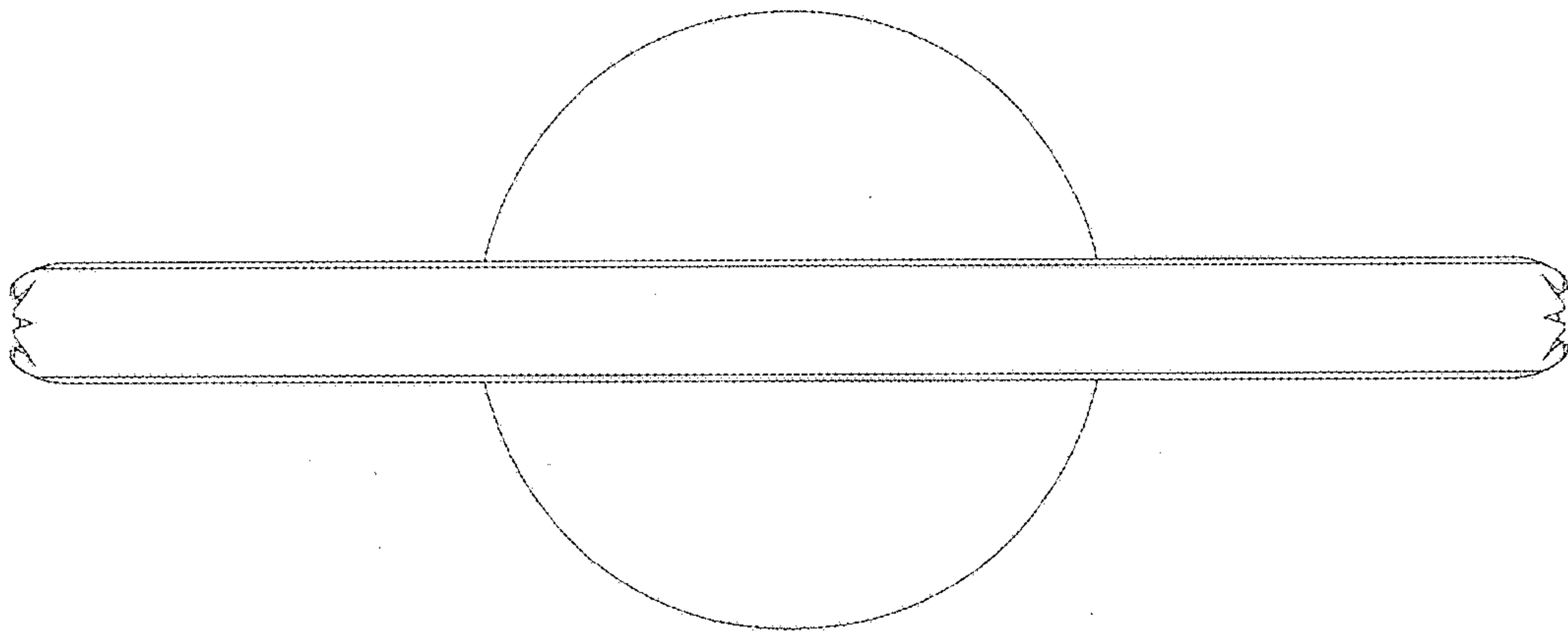

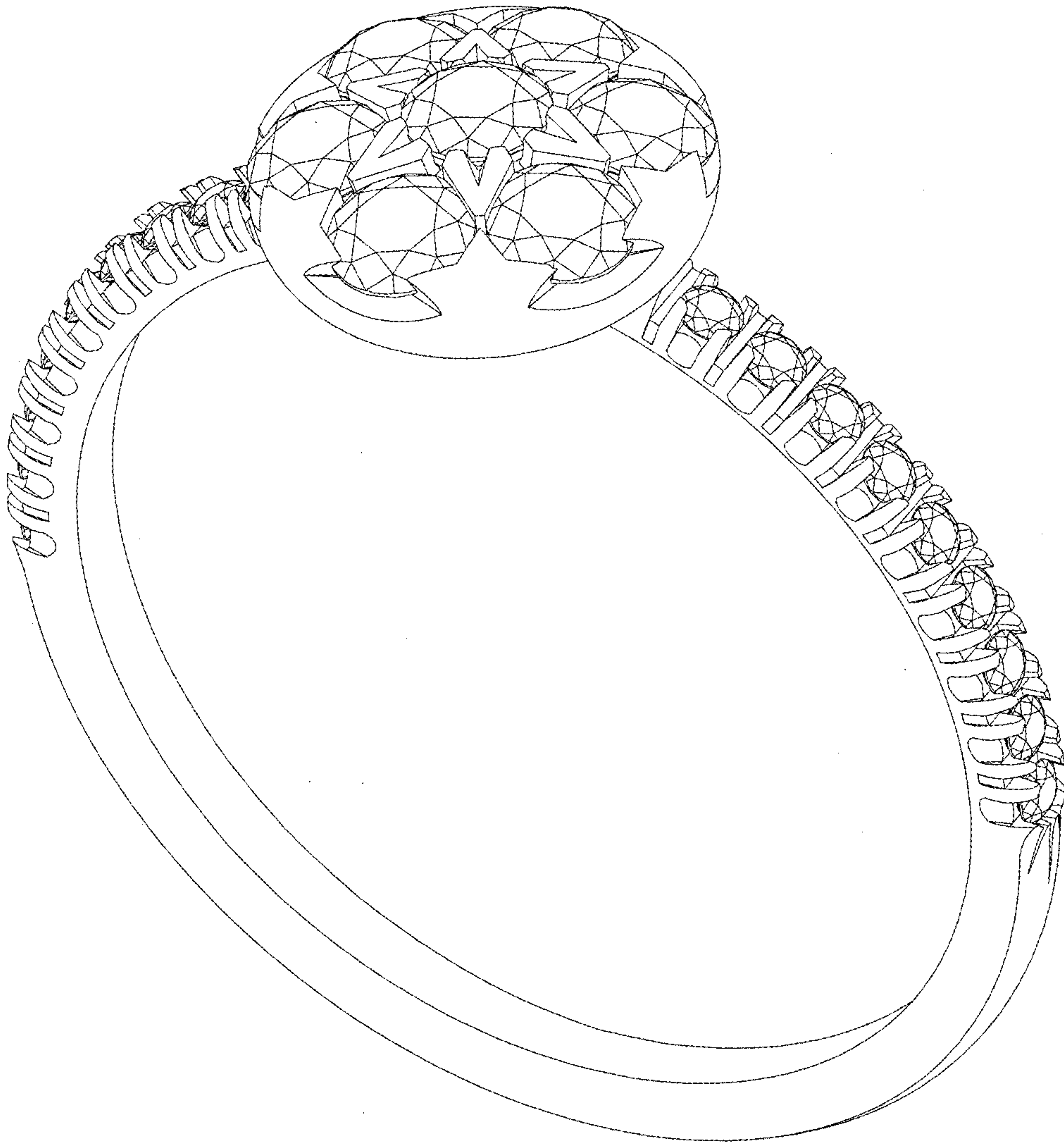
