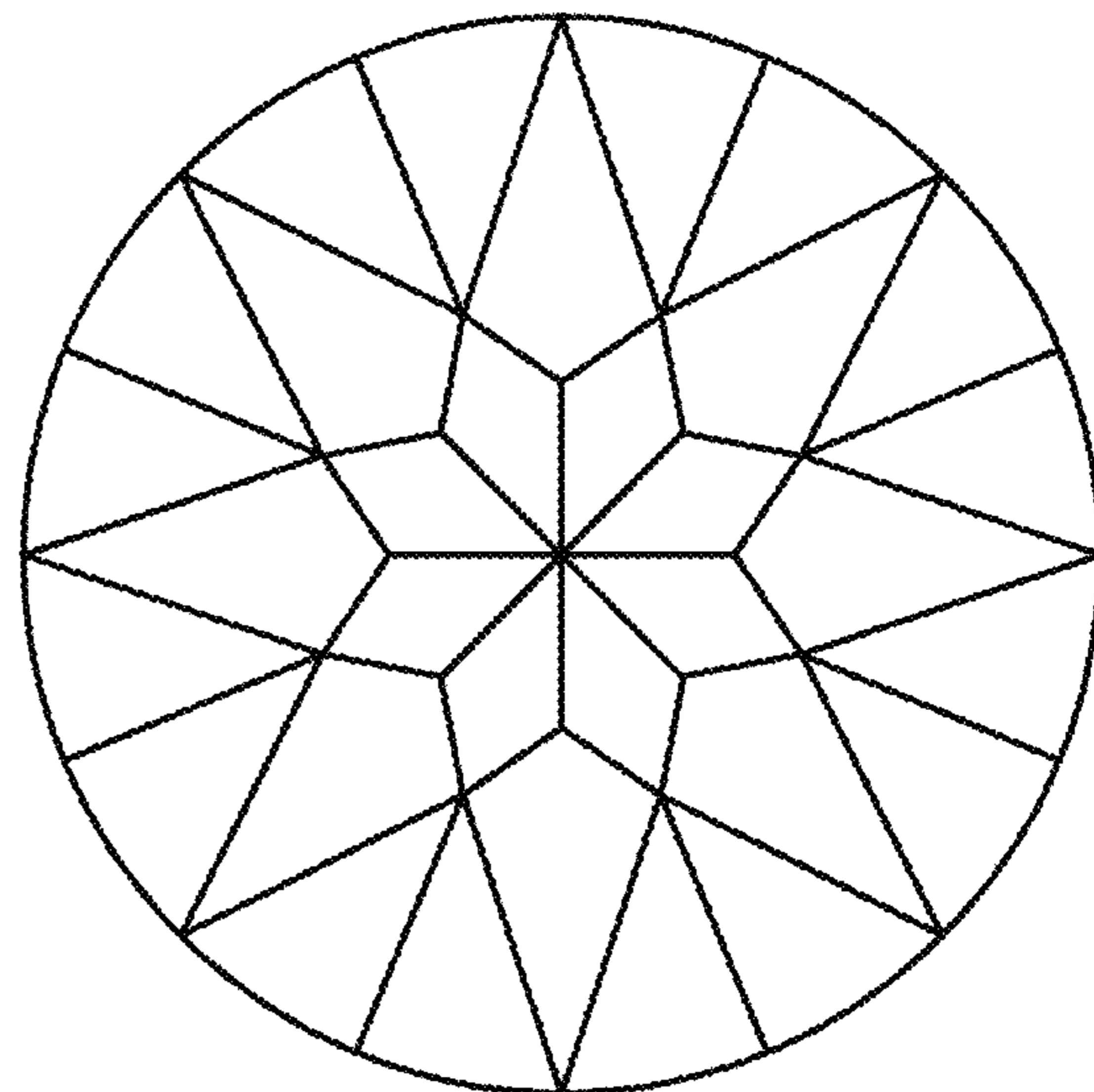
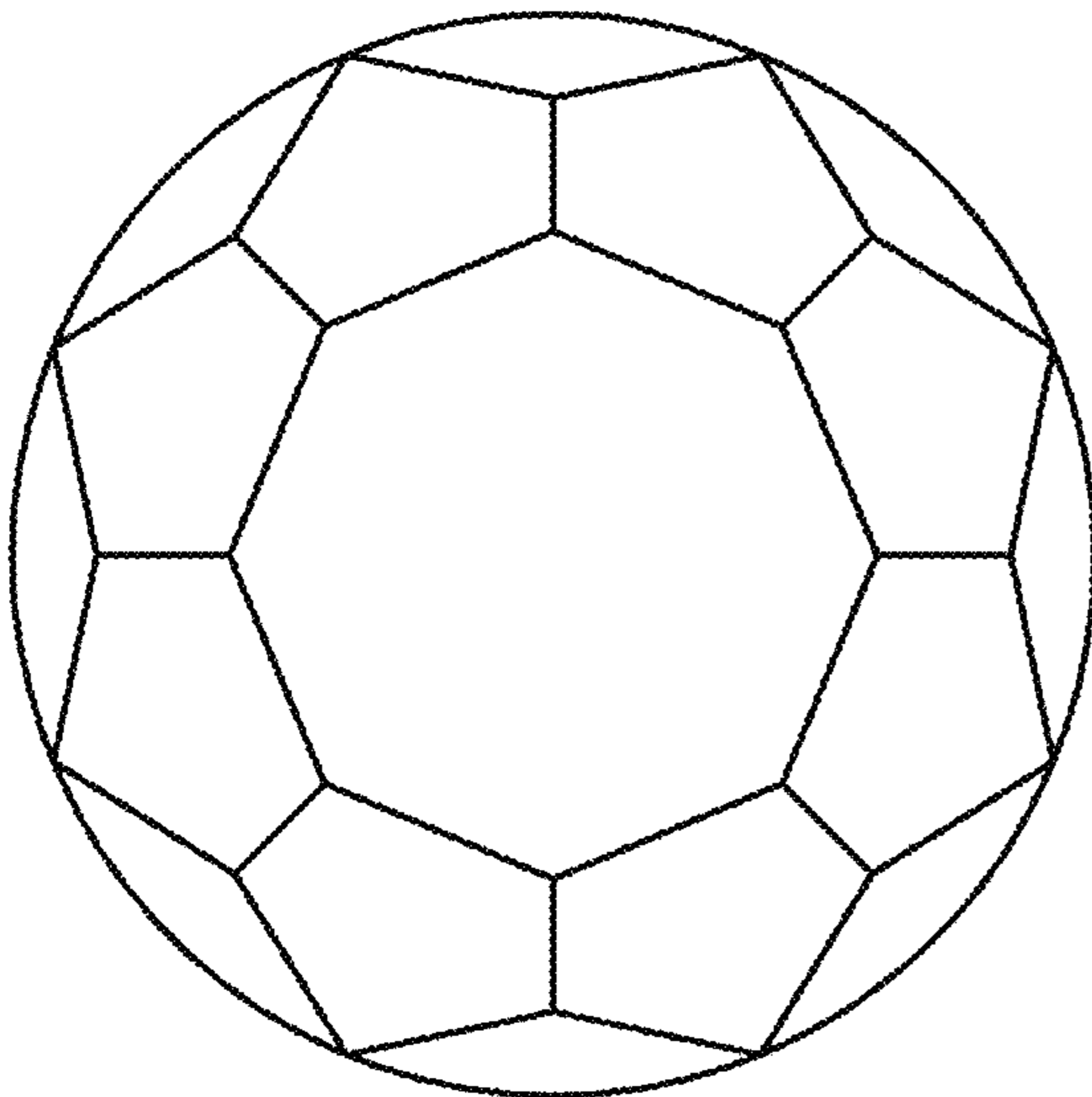
(57) **CLAIM**

The ornamental design for a diamond, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a diamond showing the new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is an opposite side elevation view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines shown in the drawings illustrate portions of the design for a diamond that form no part of the claimed design.

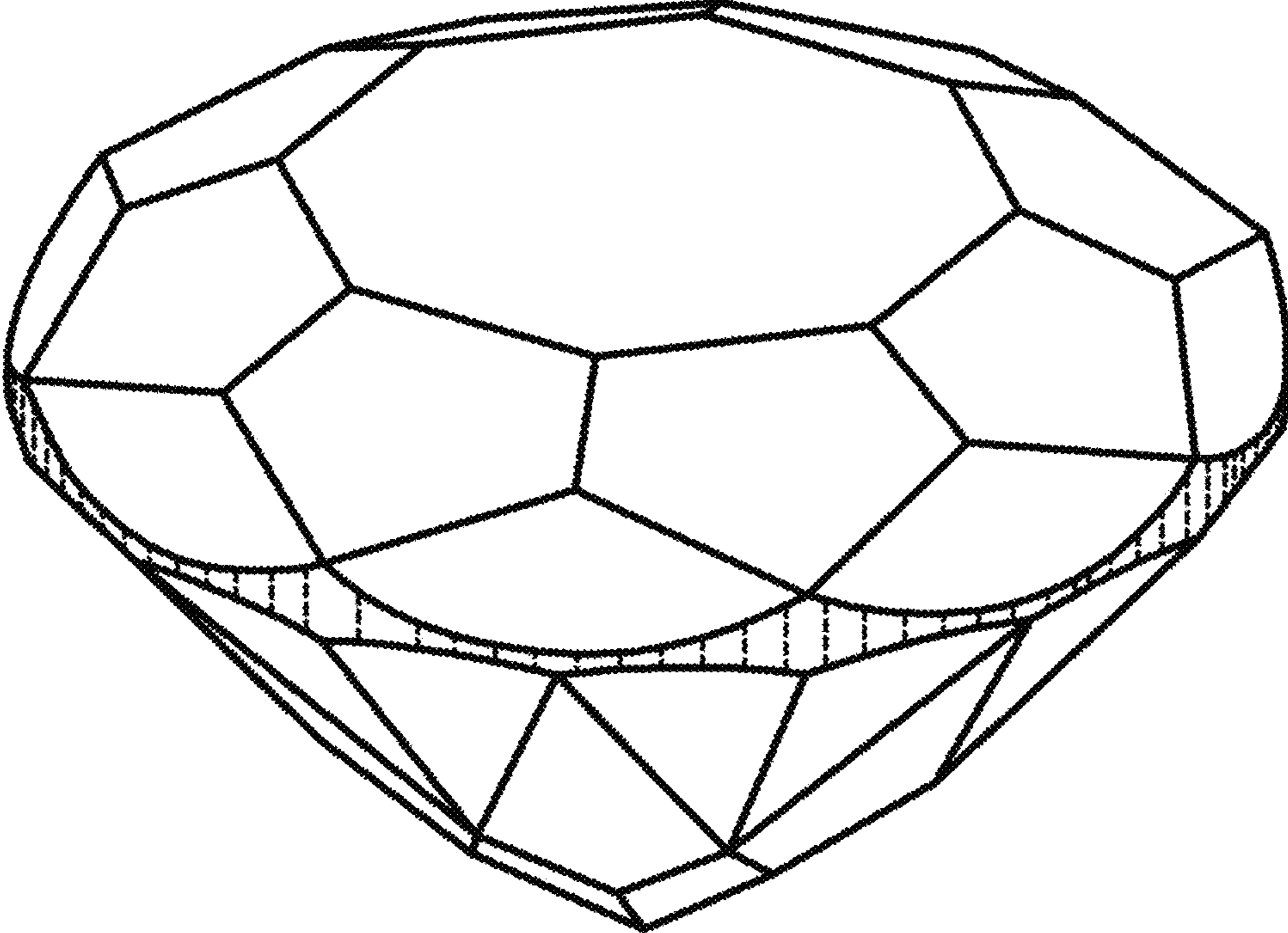

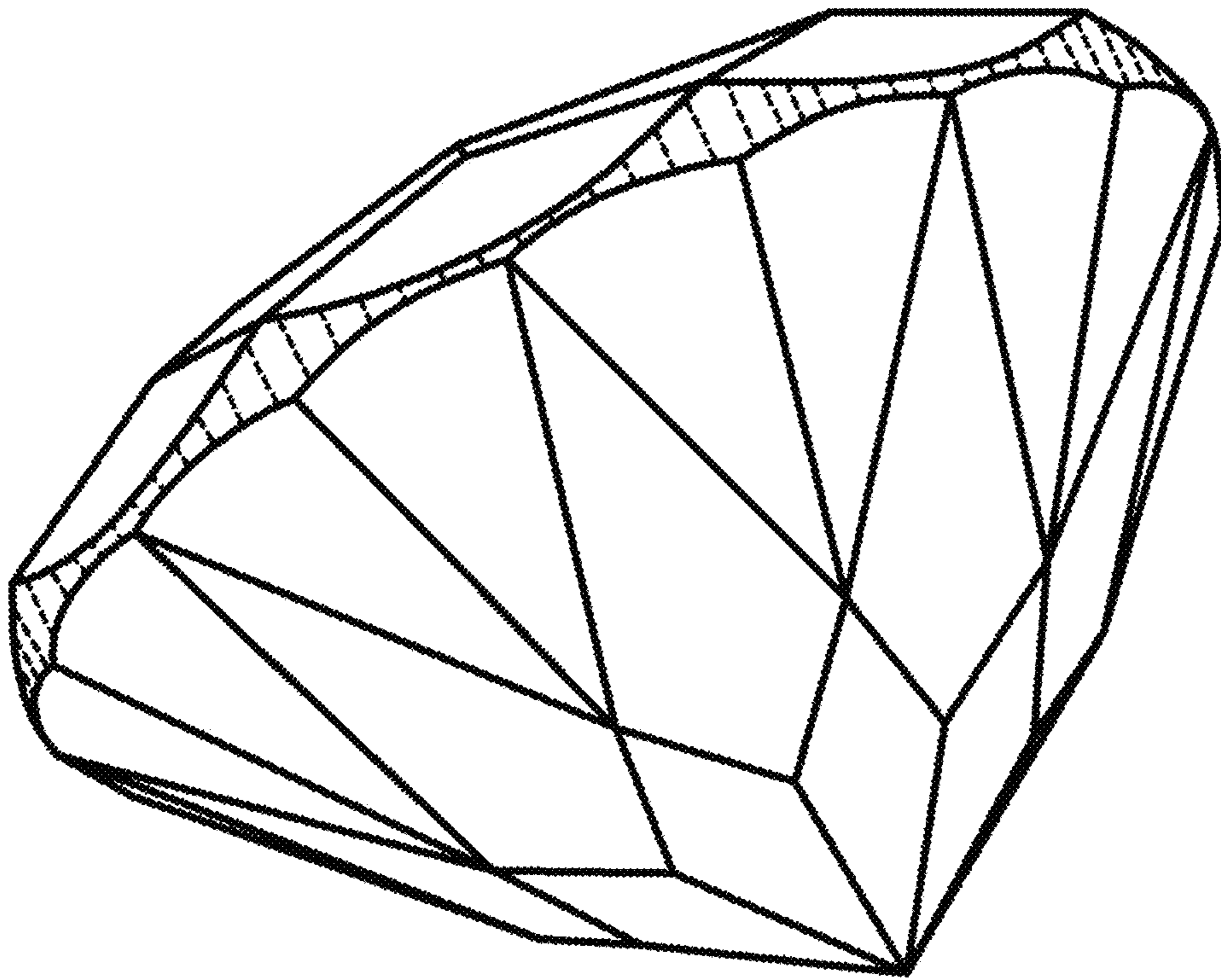

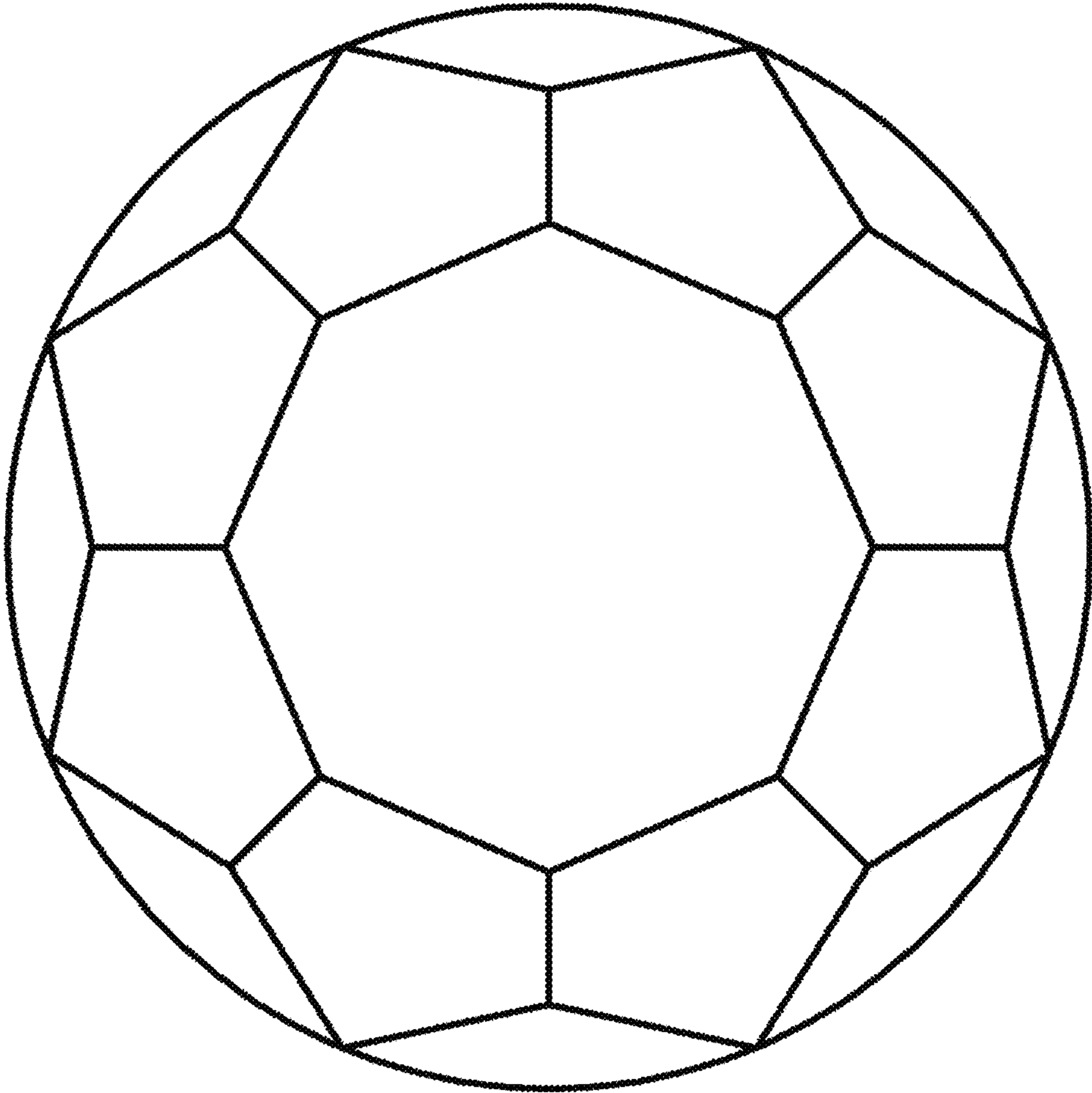

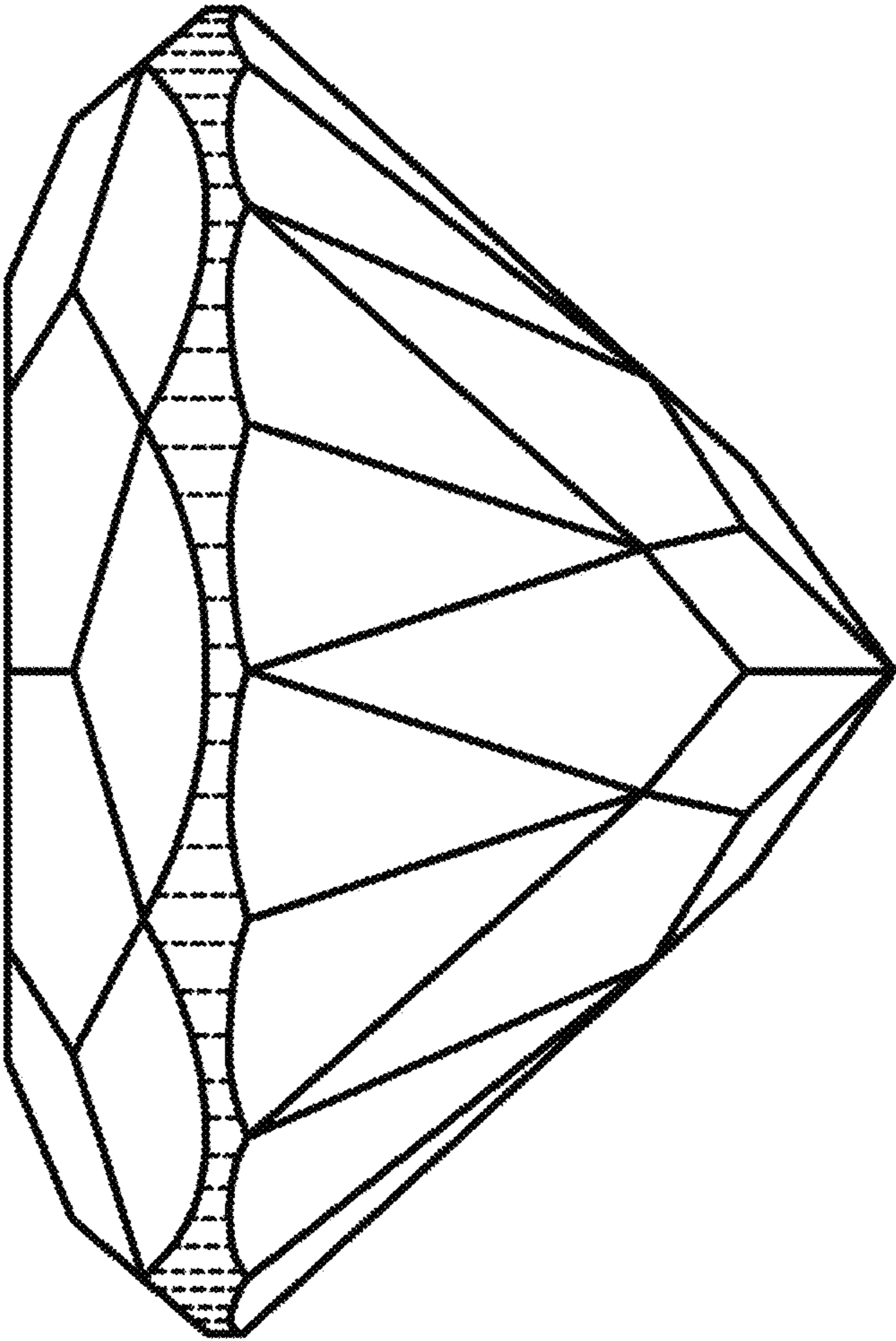

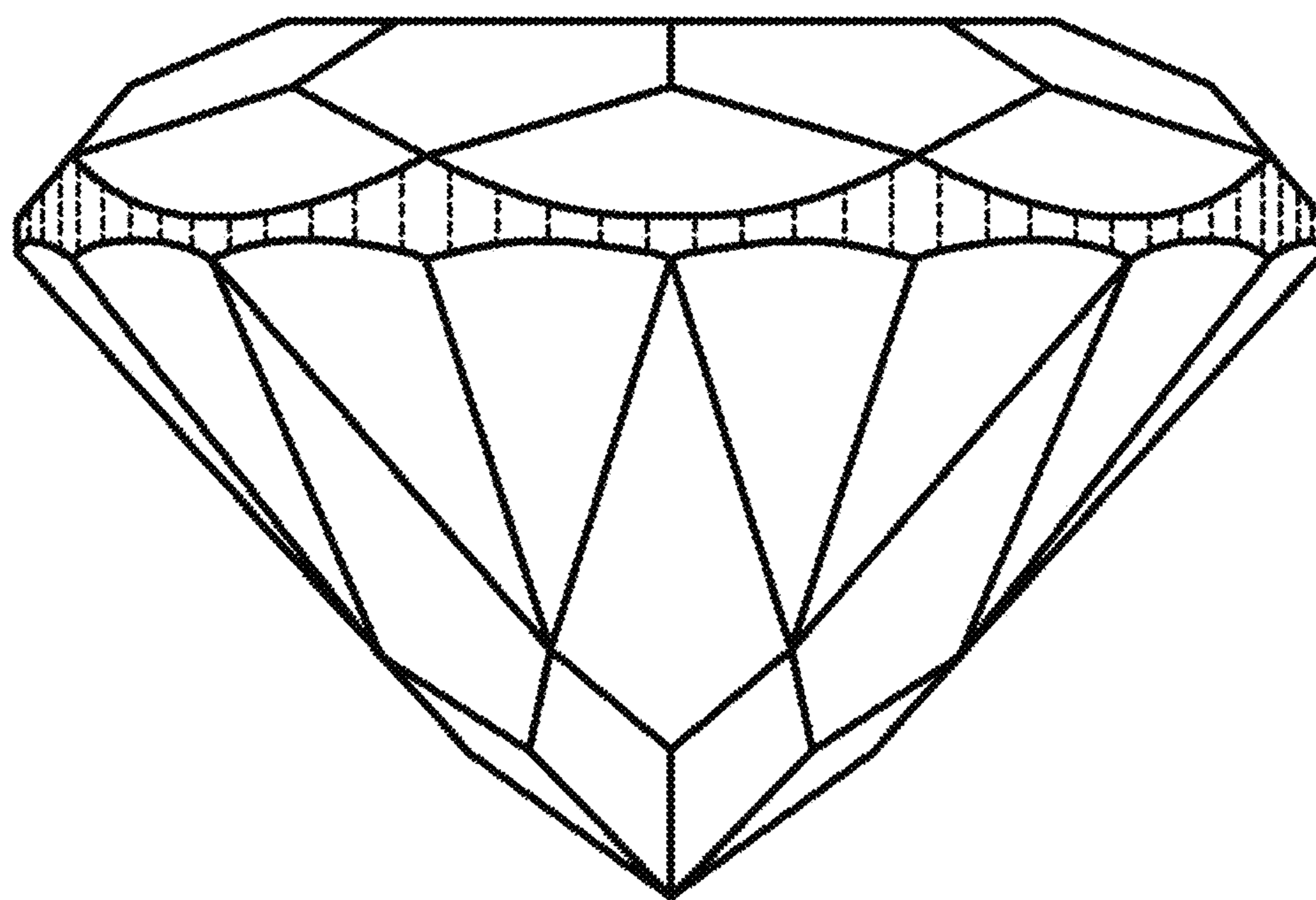

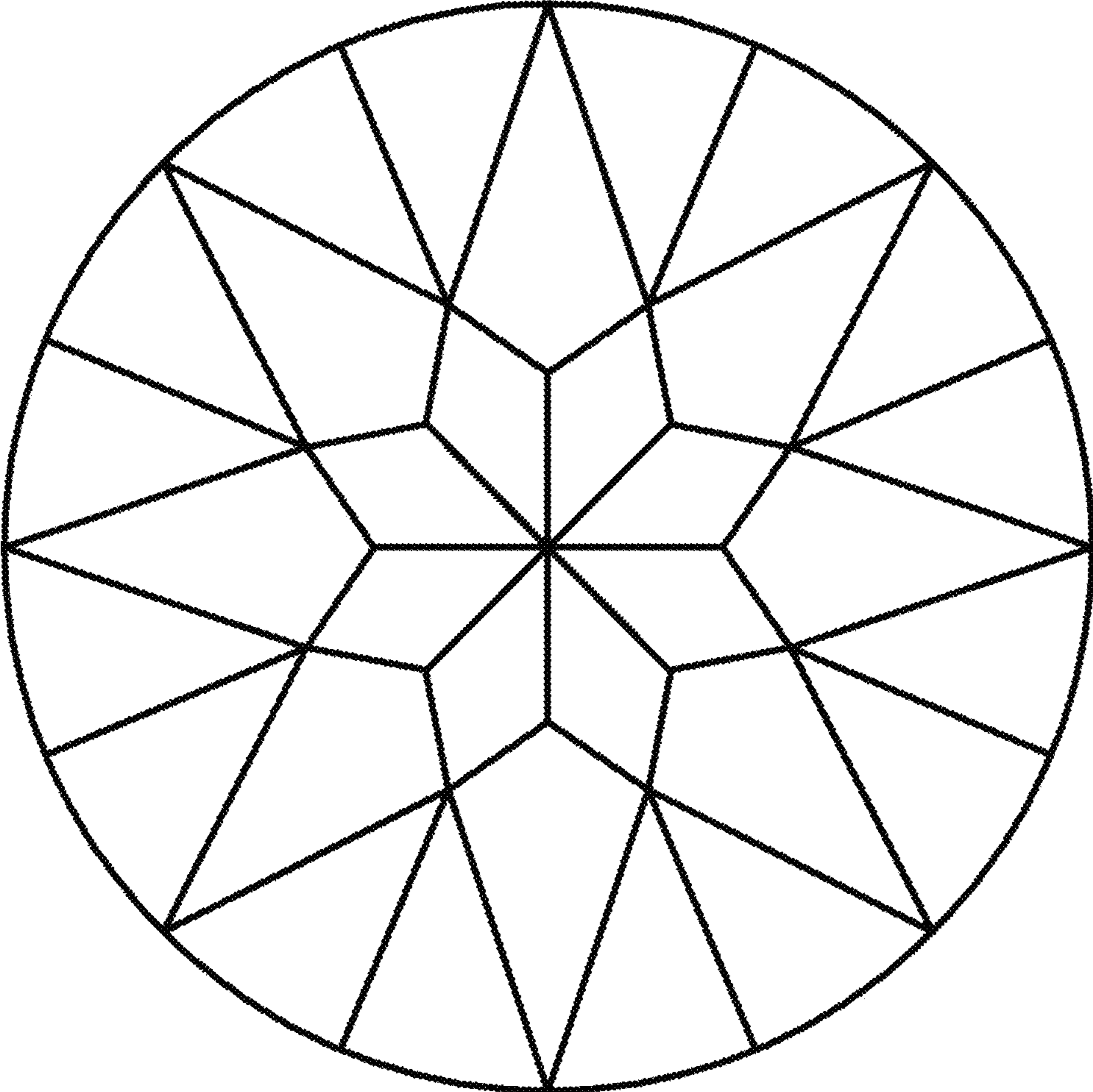
