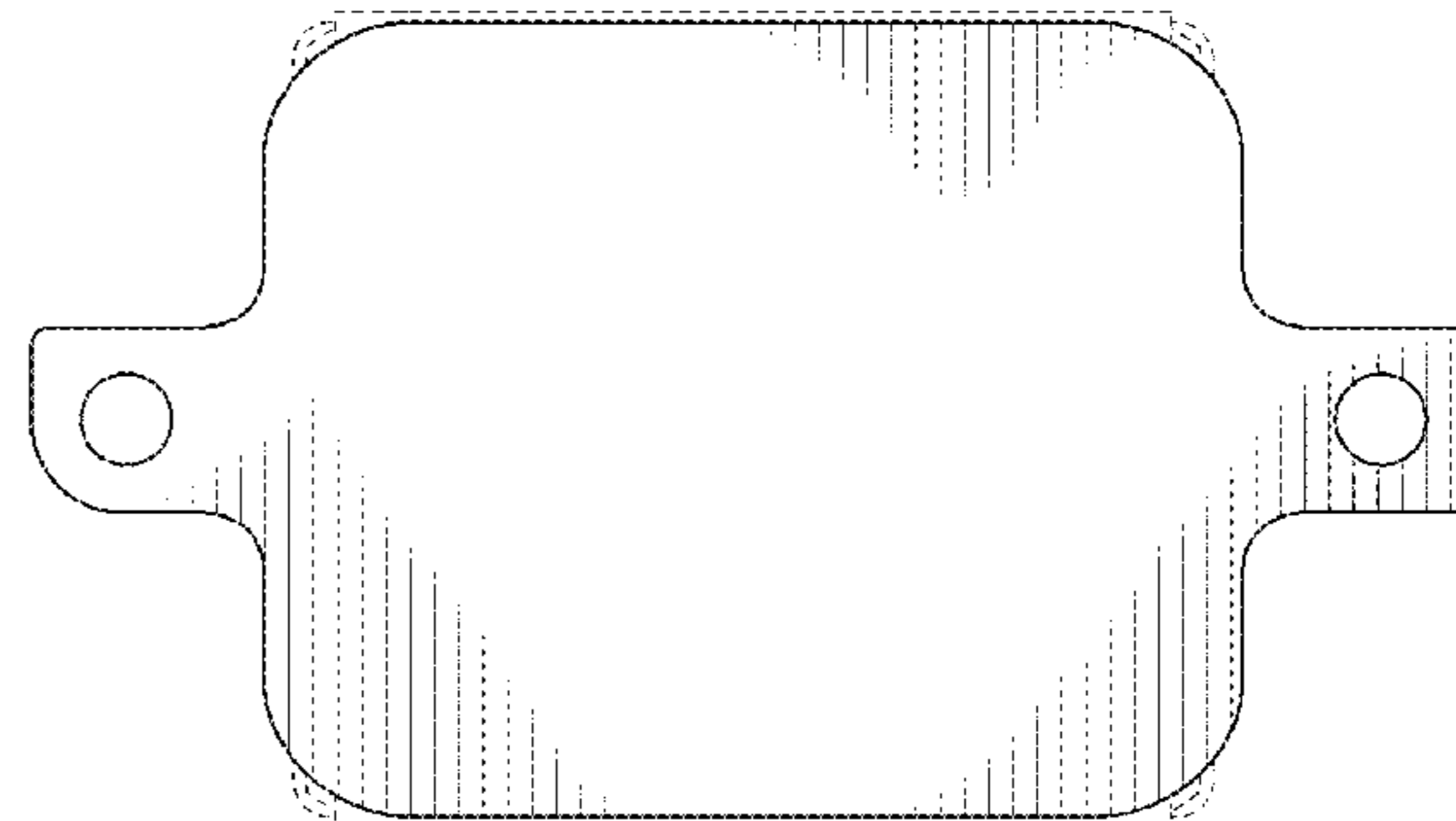
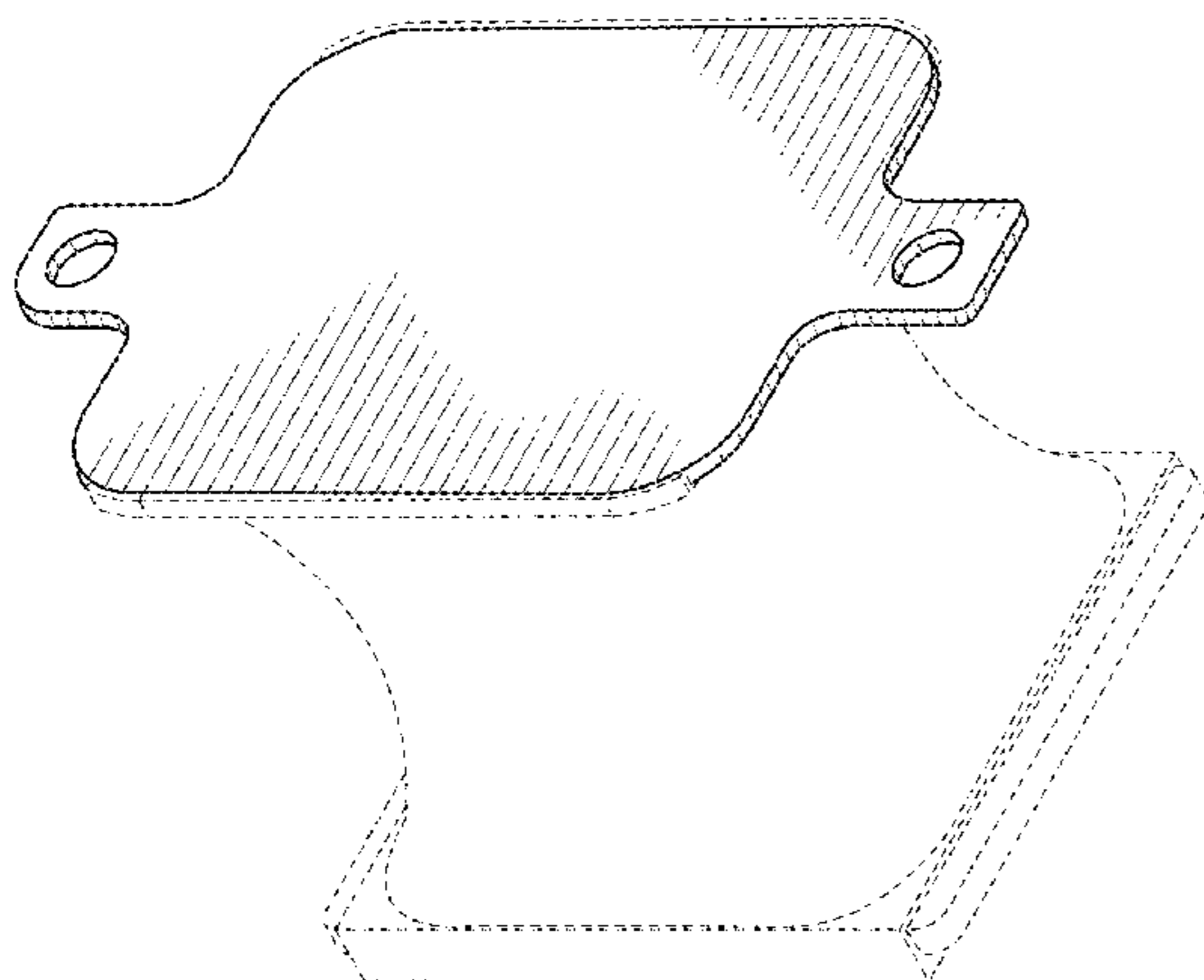
The ornamental design for a load cushion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top and left side view of a load cushion, having the inventive design;
FIG. 2 is a bottom view thereof;

FIG. 5 is a right side view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.

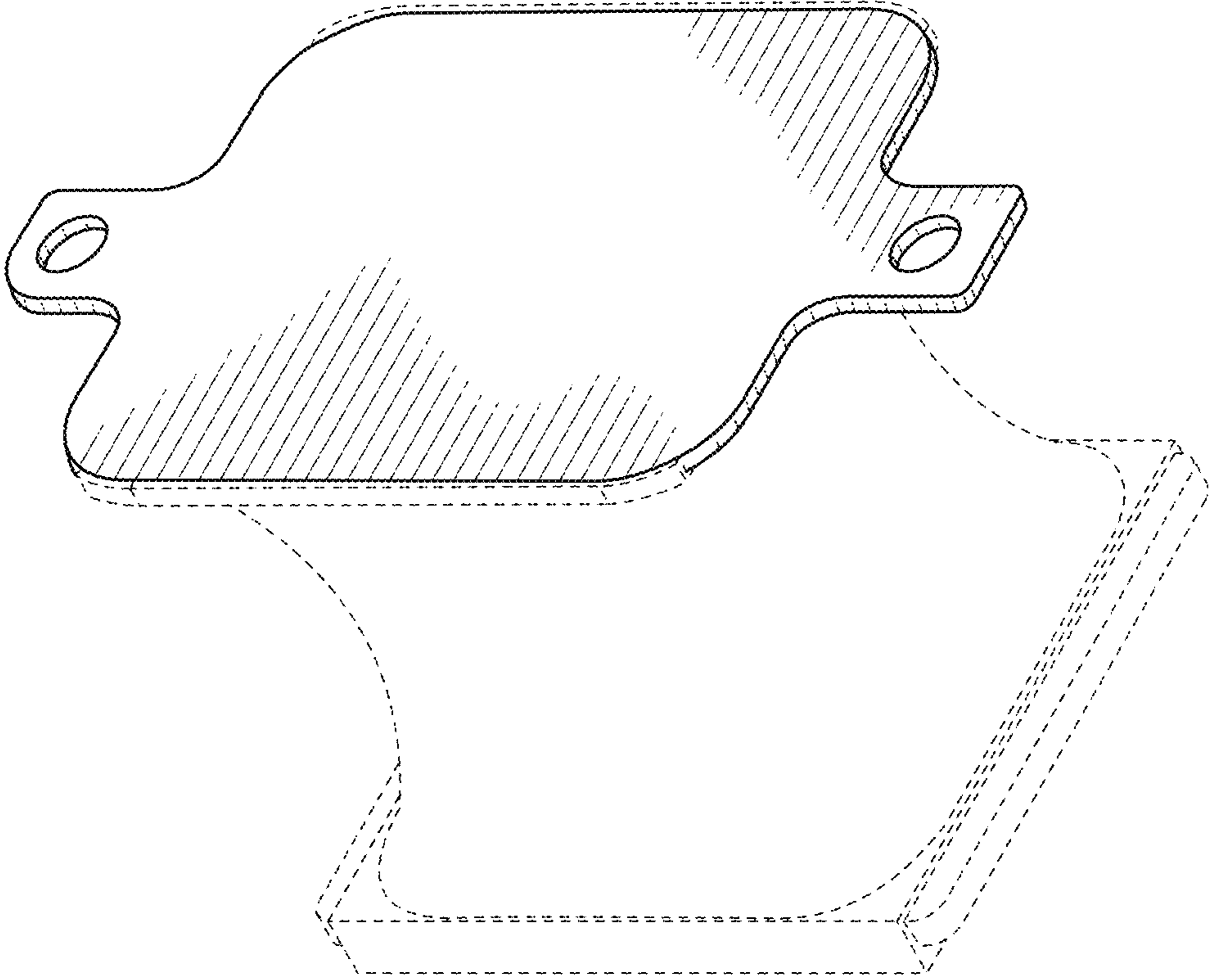

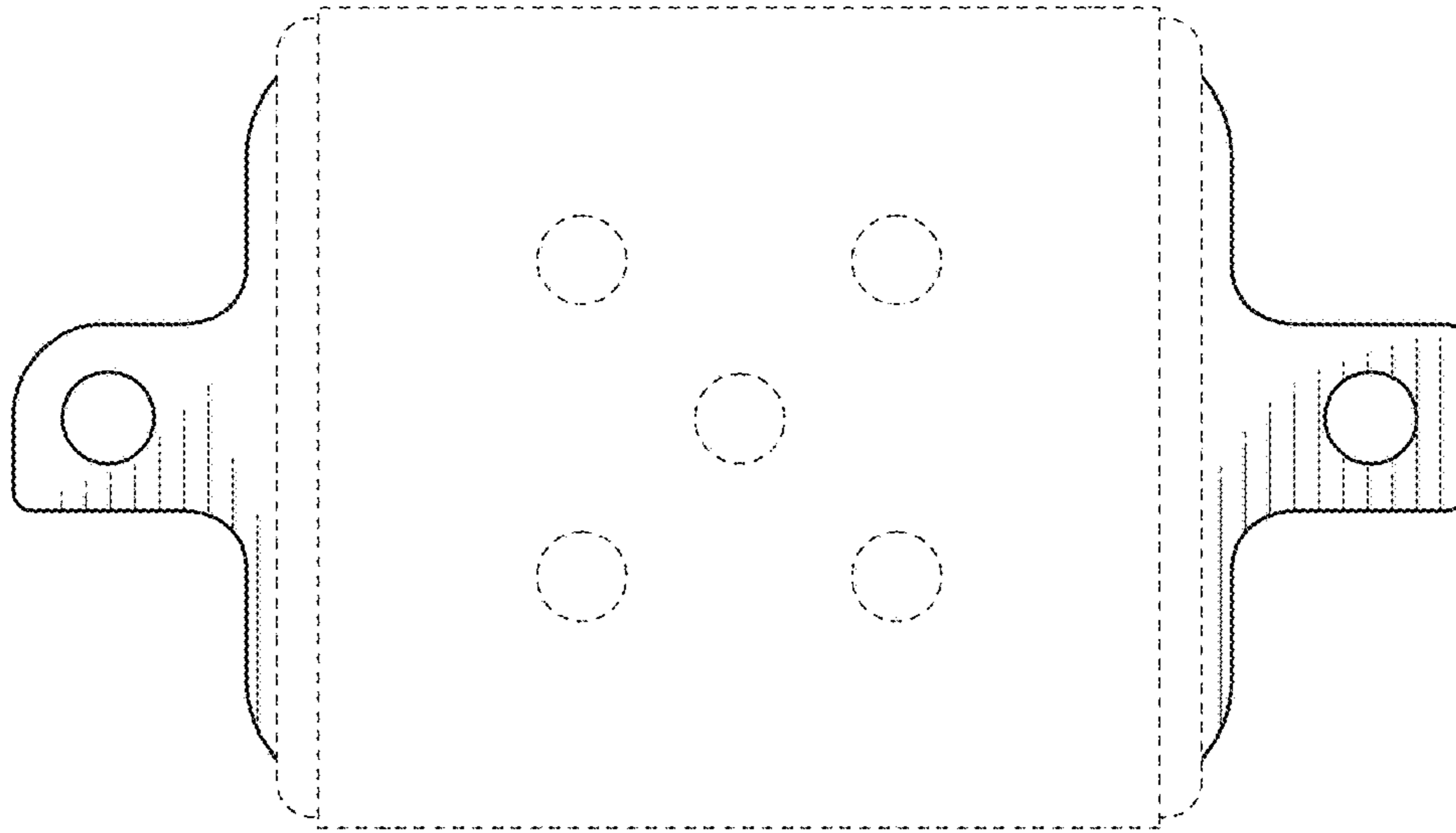

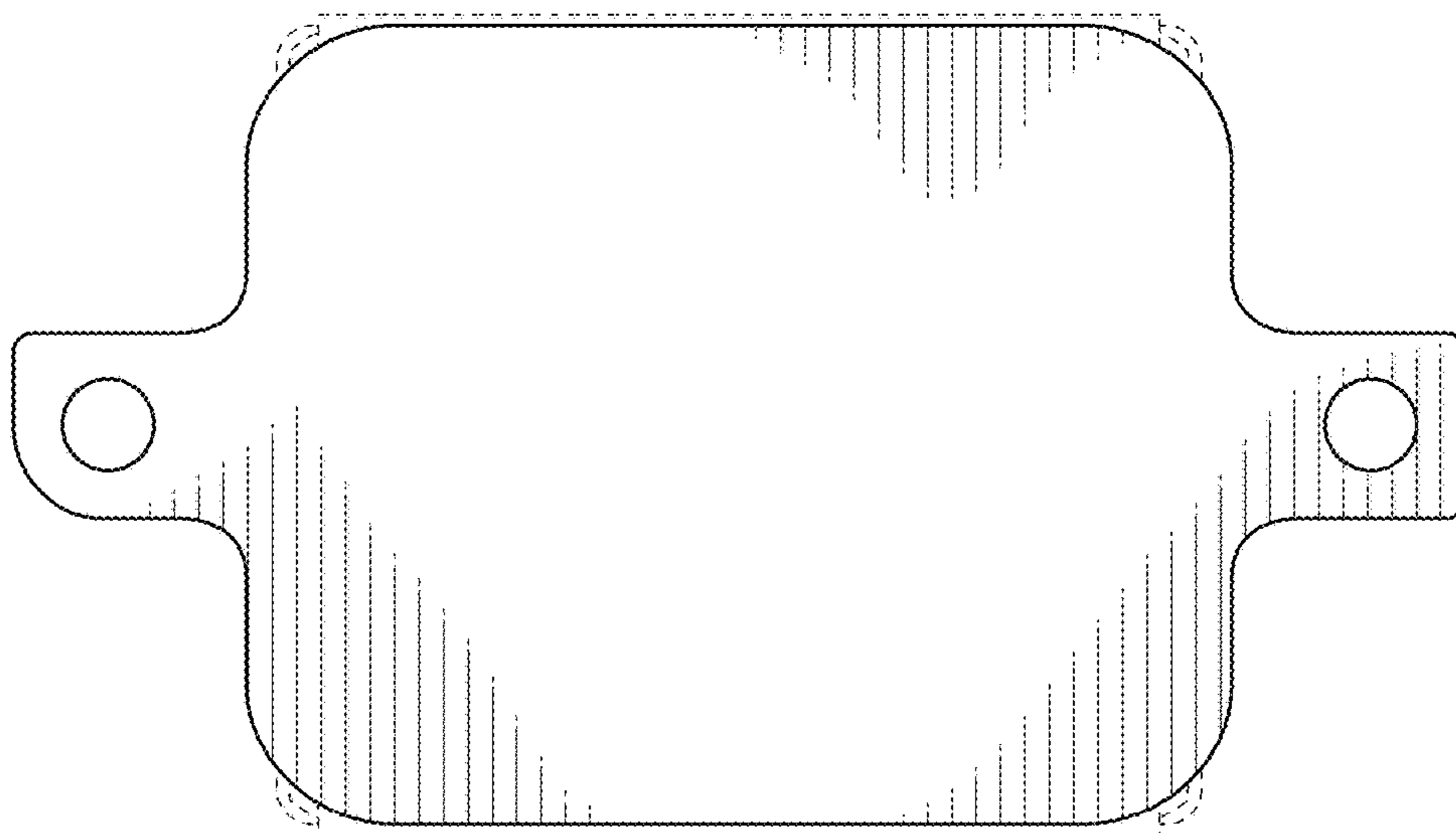

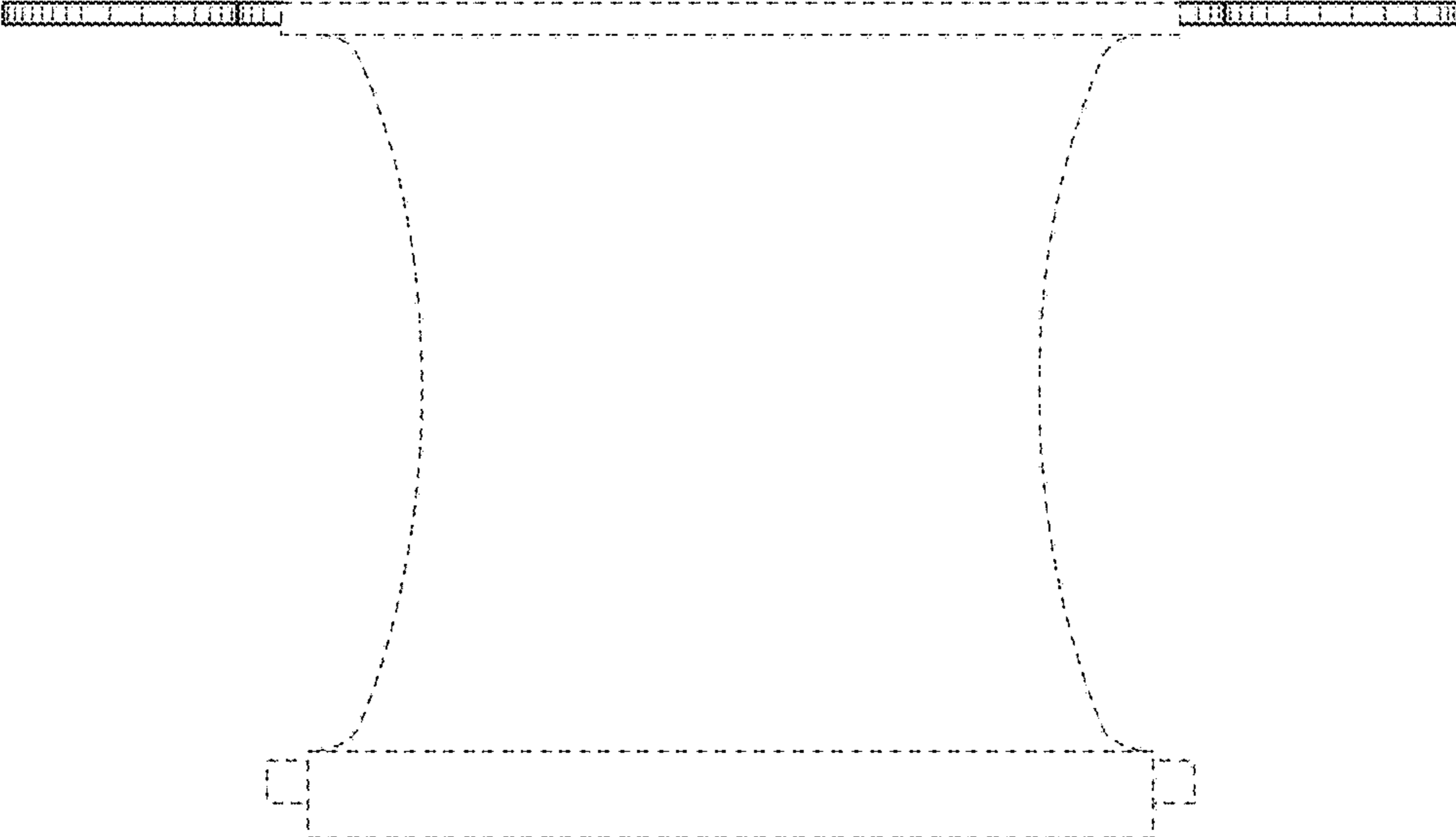

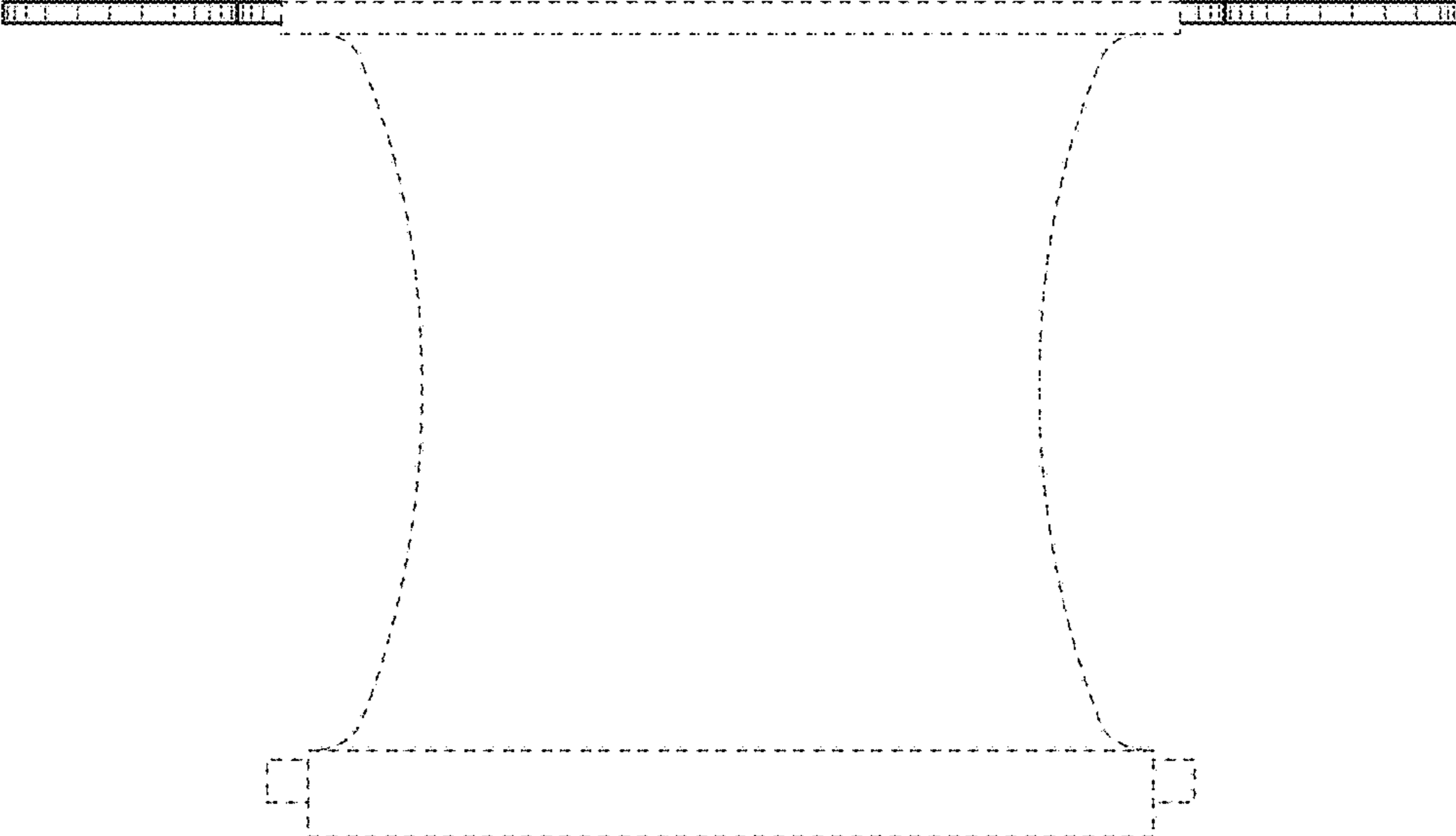

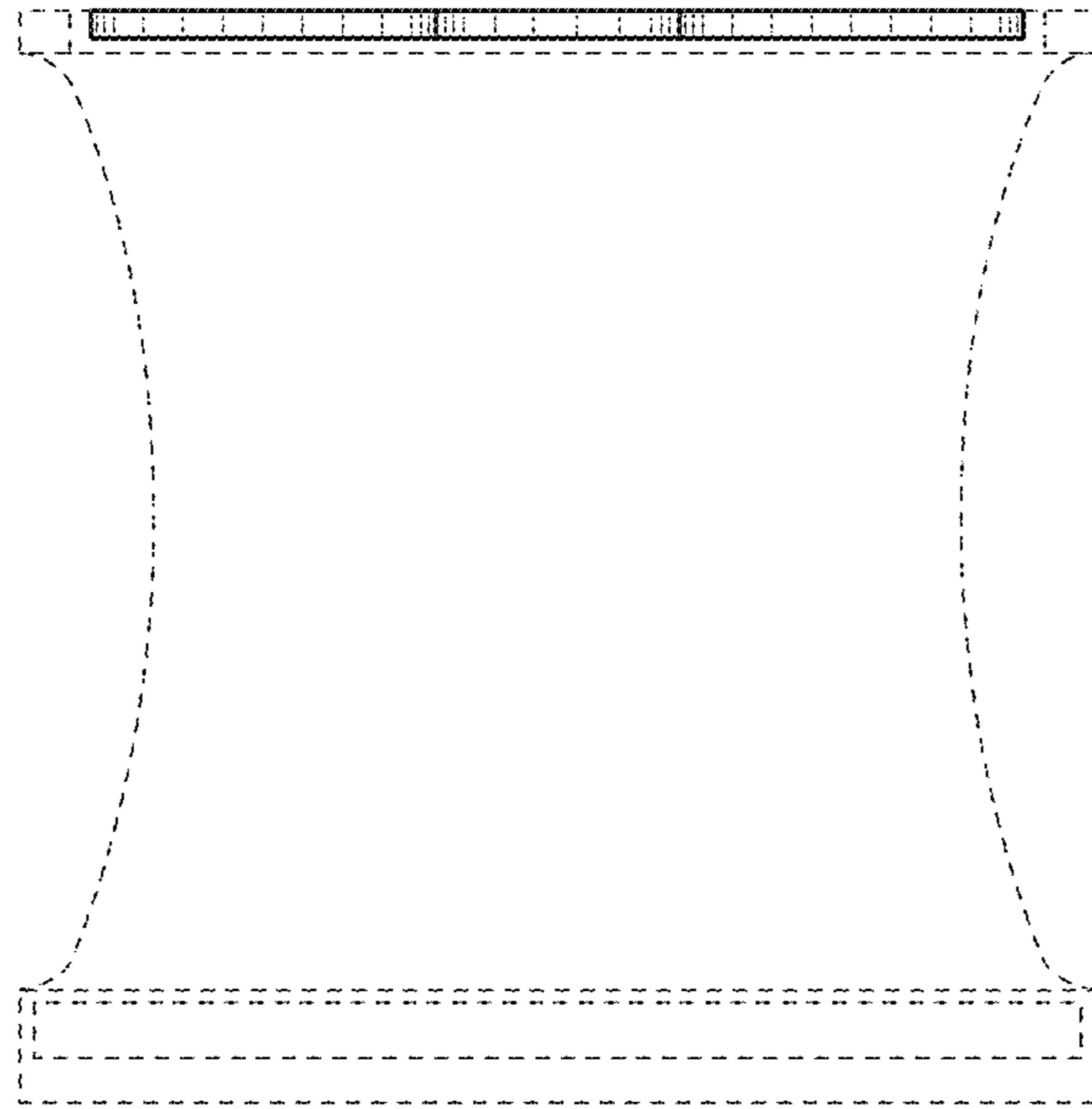

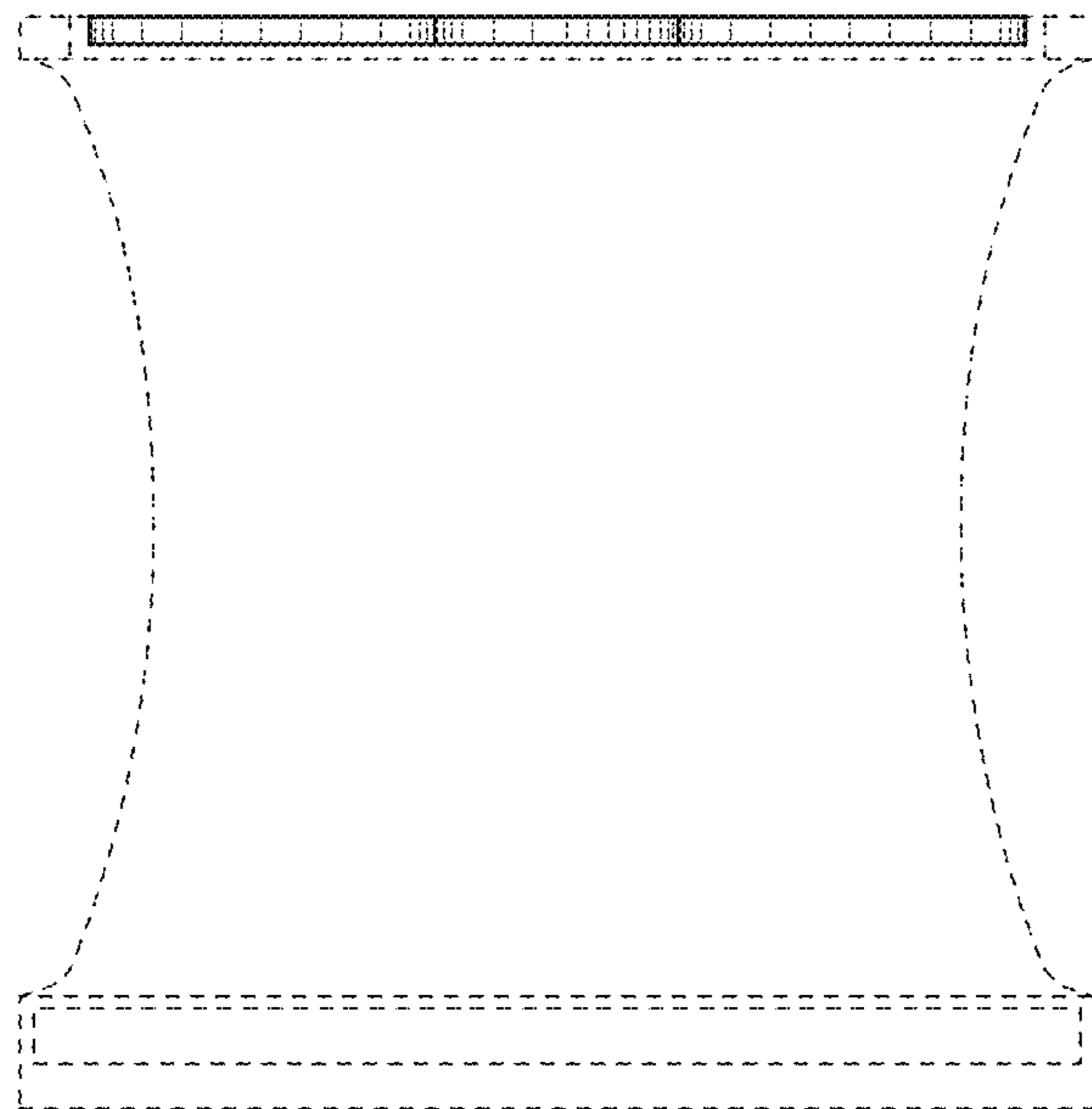
