FIG. 5 is a left elevation view of the headset of FIG. 1.

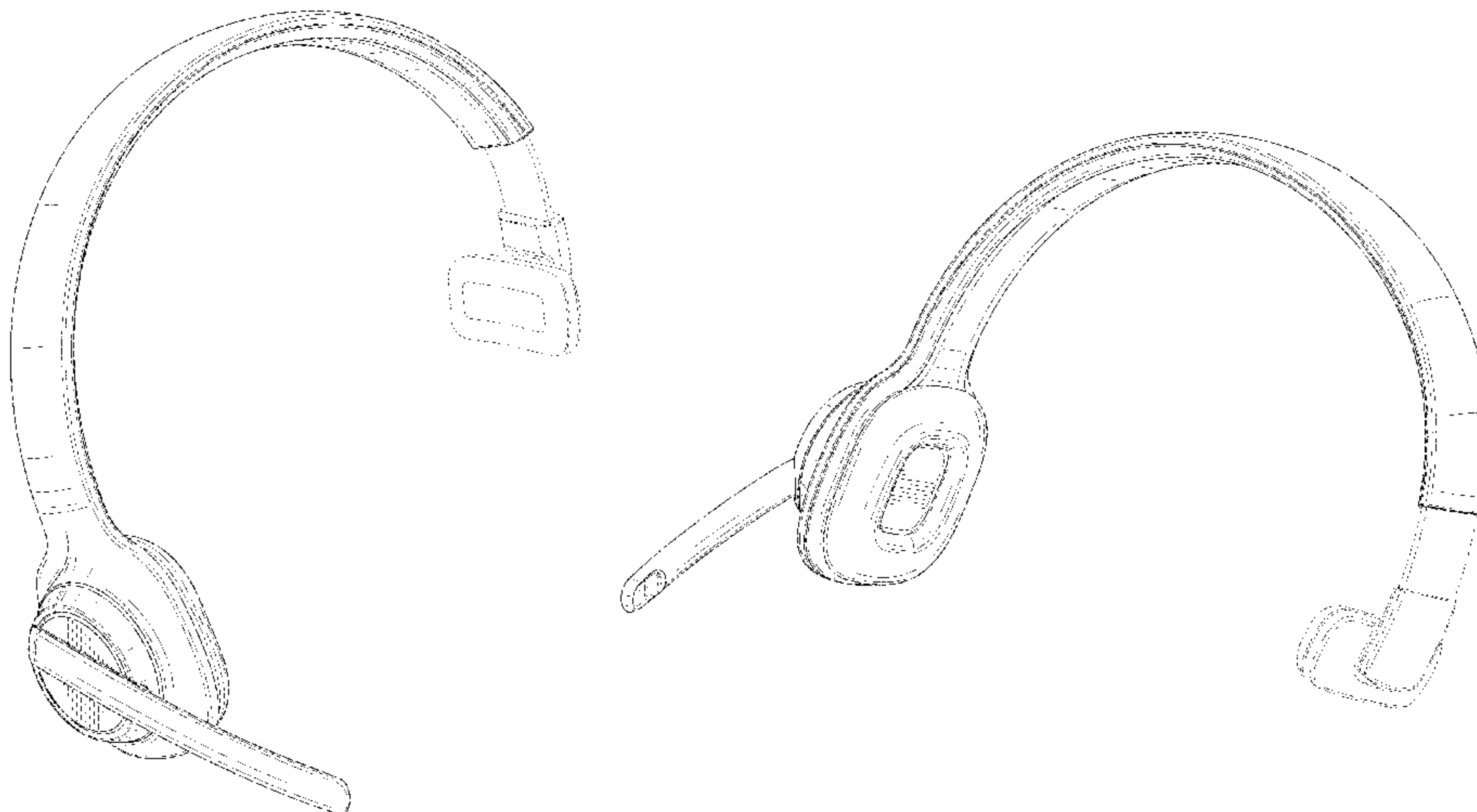
FIG. 6 is a right elevation view of the headset of FIG. 1.

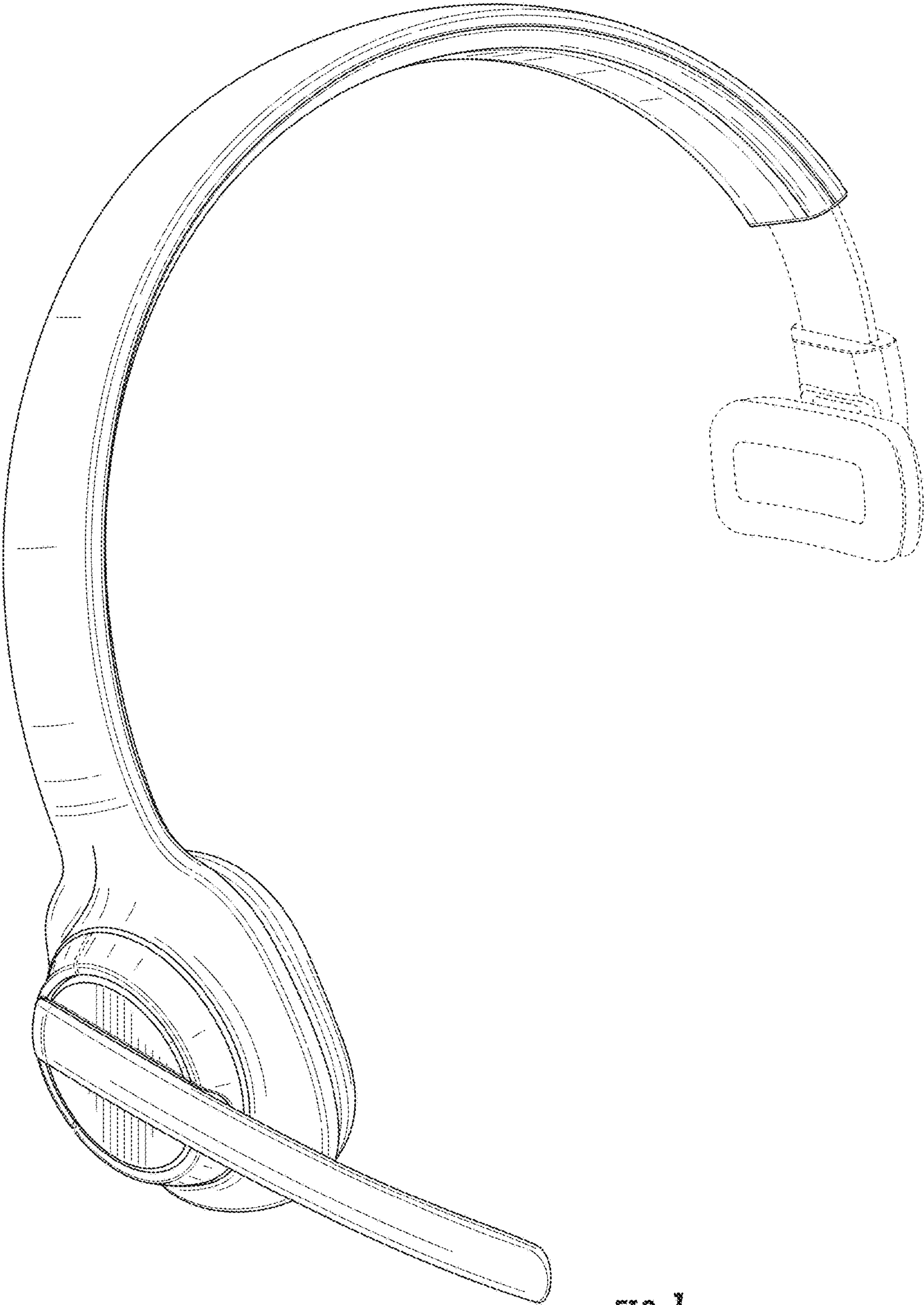

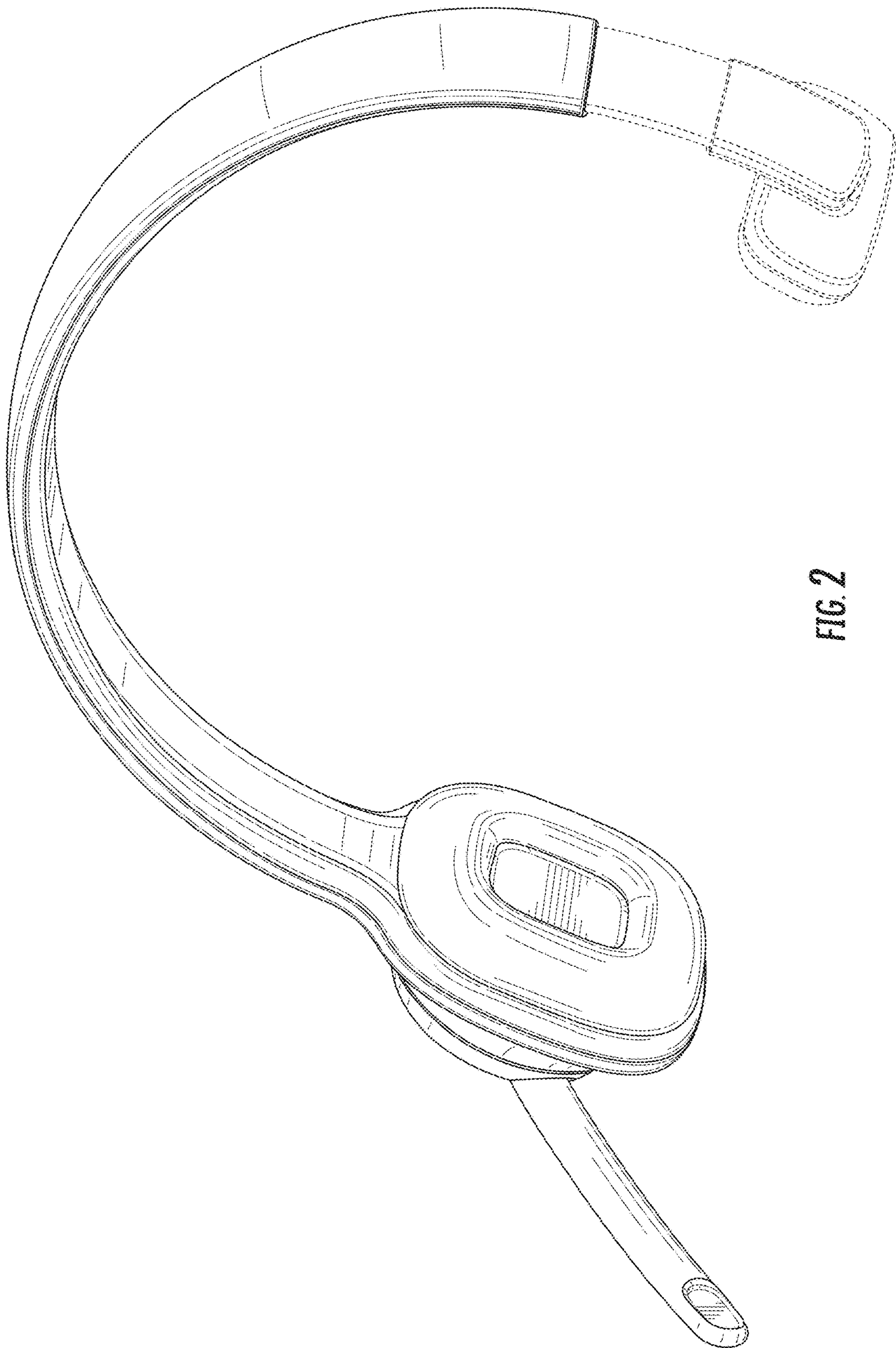

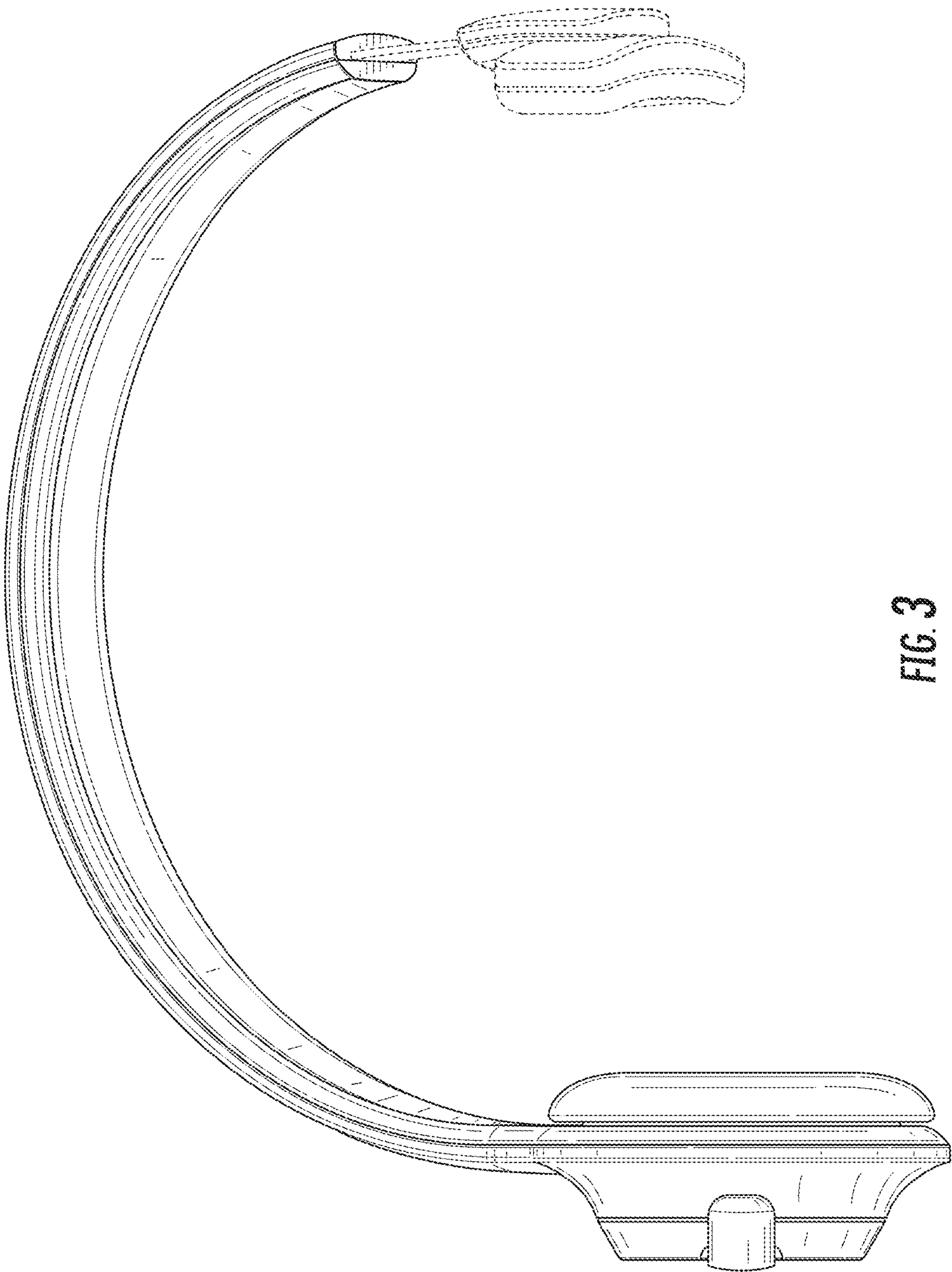

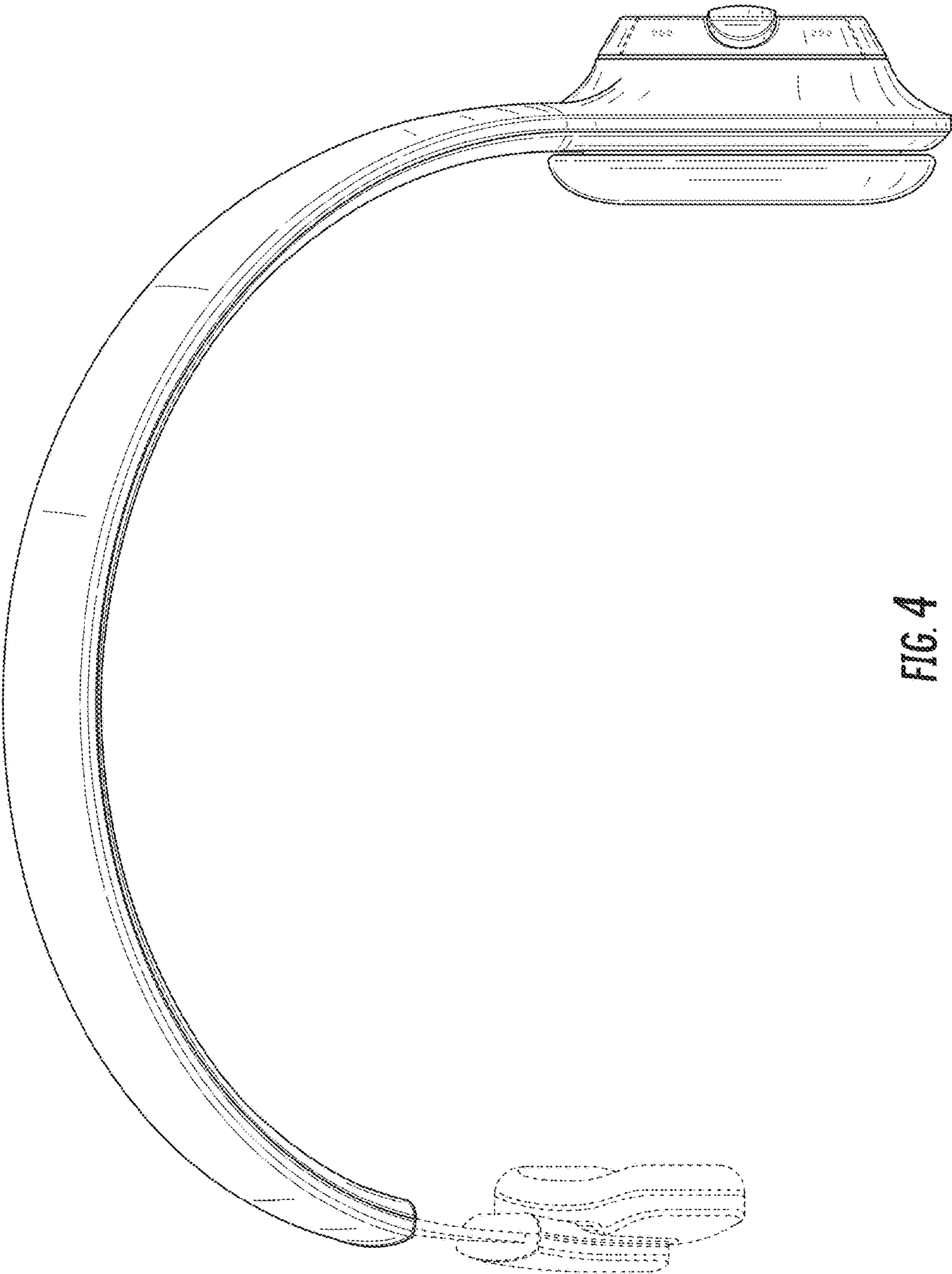

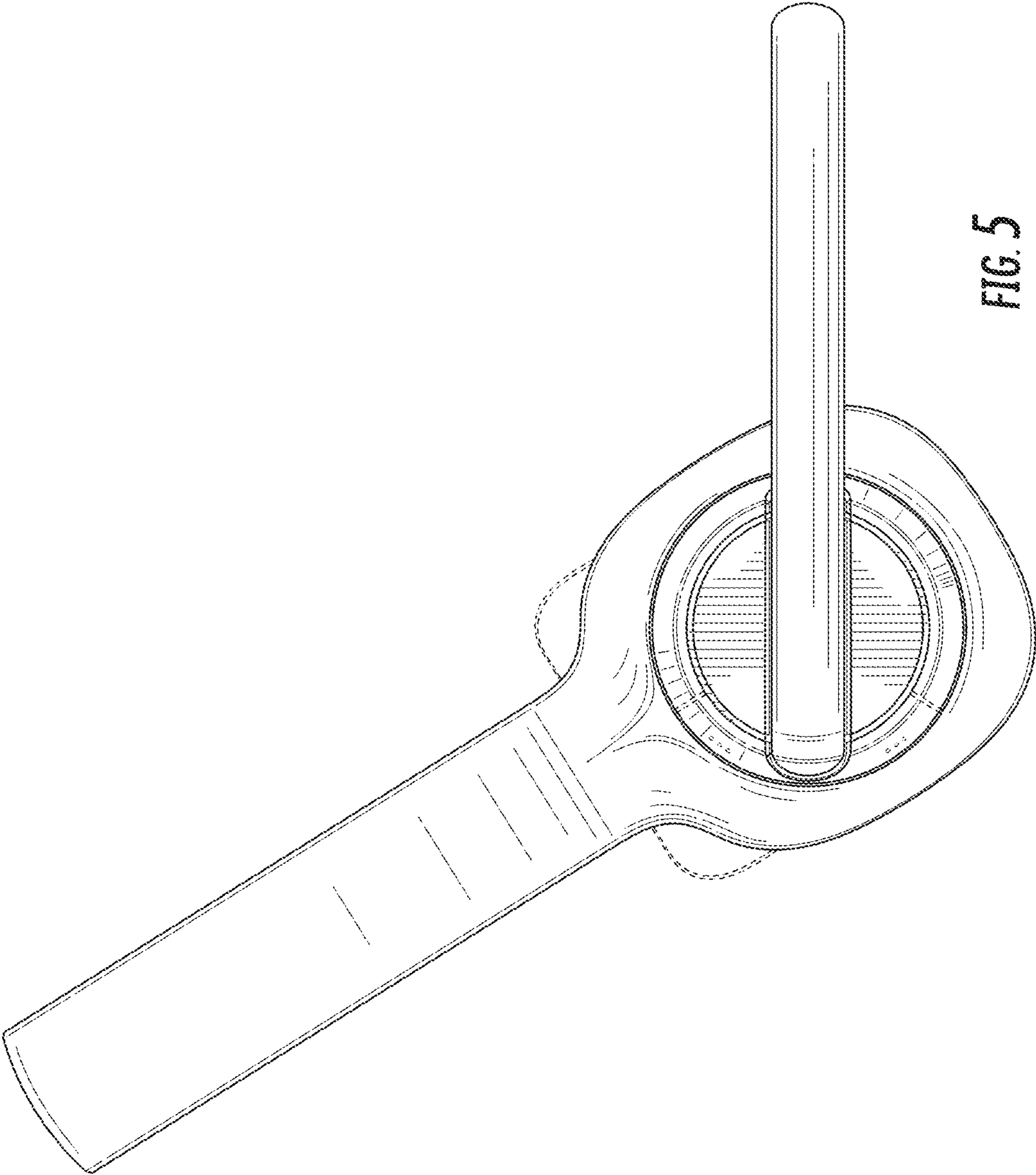

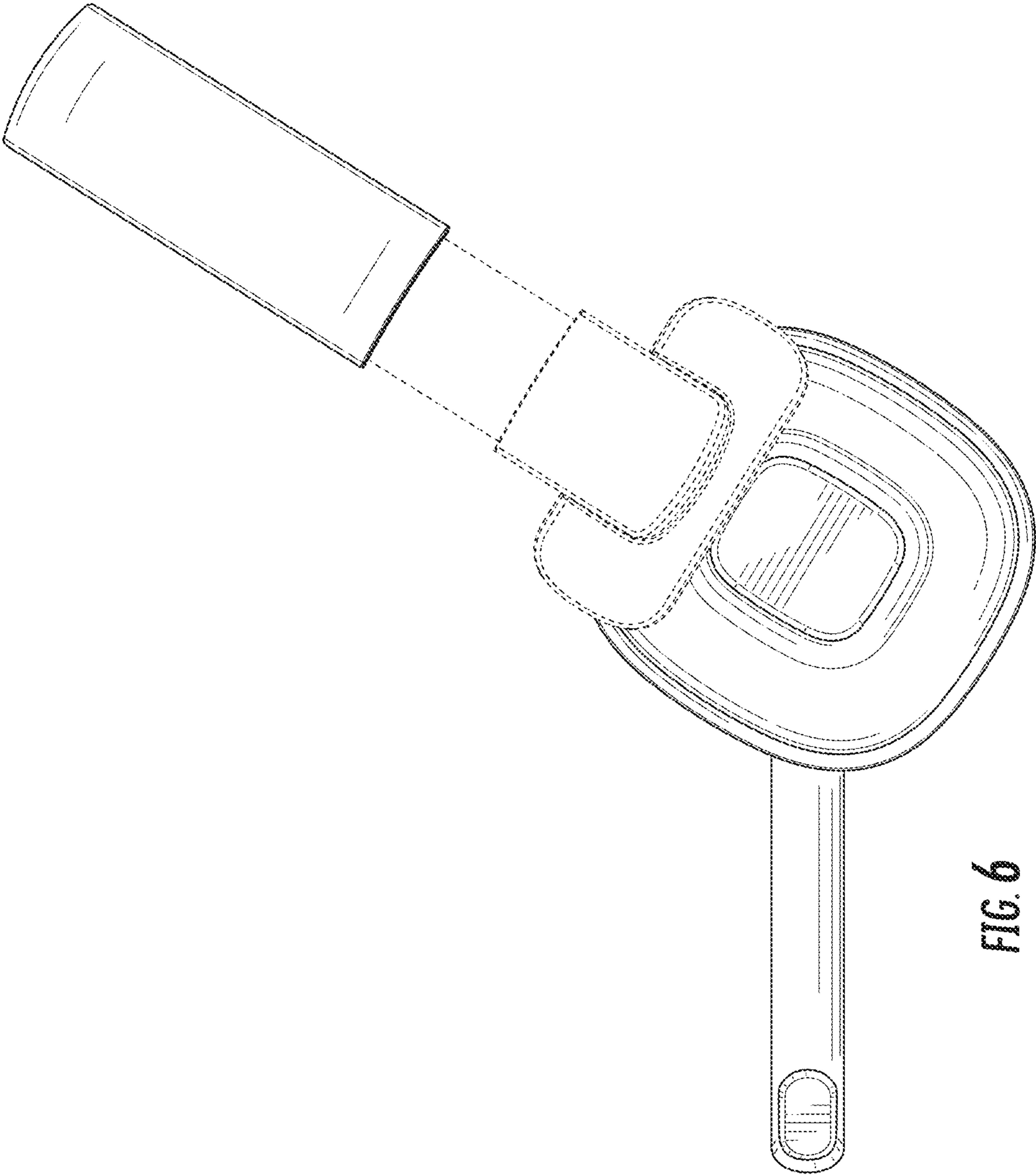

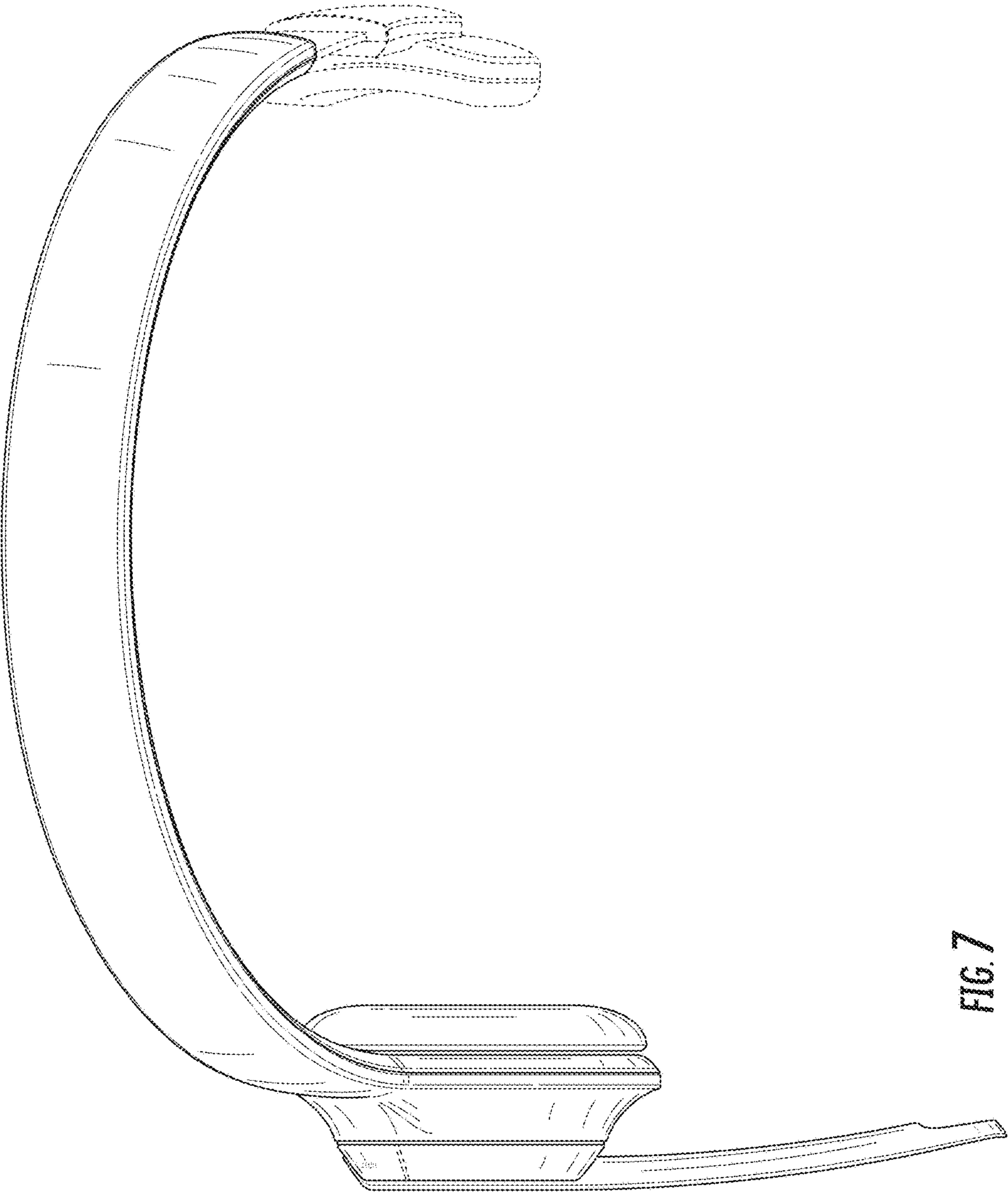

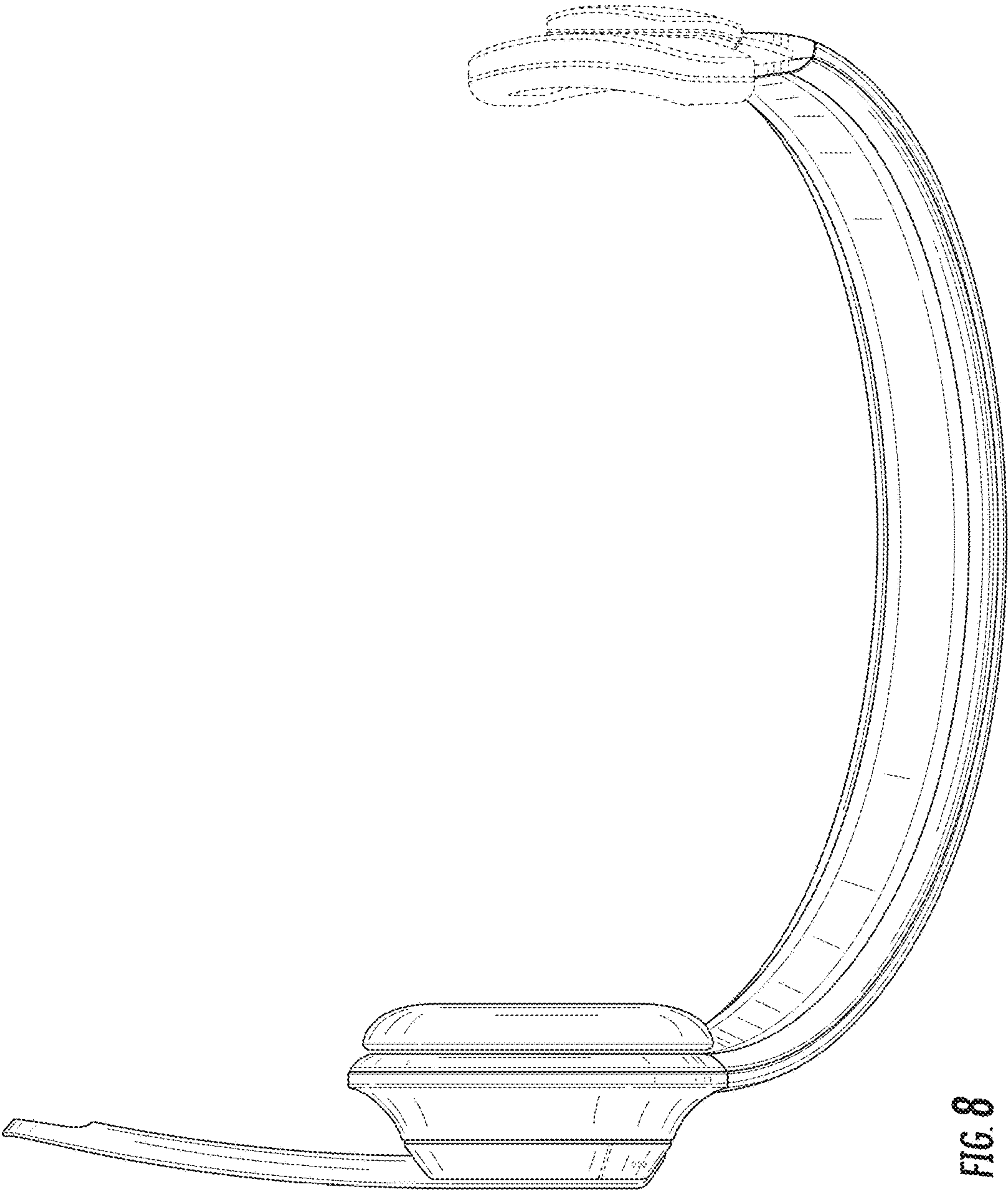
