(57) **CLAIM**

The ornamental design for a display screen with graphical user interface for enabling color selection, as shown and described.

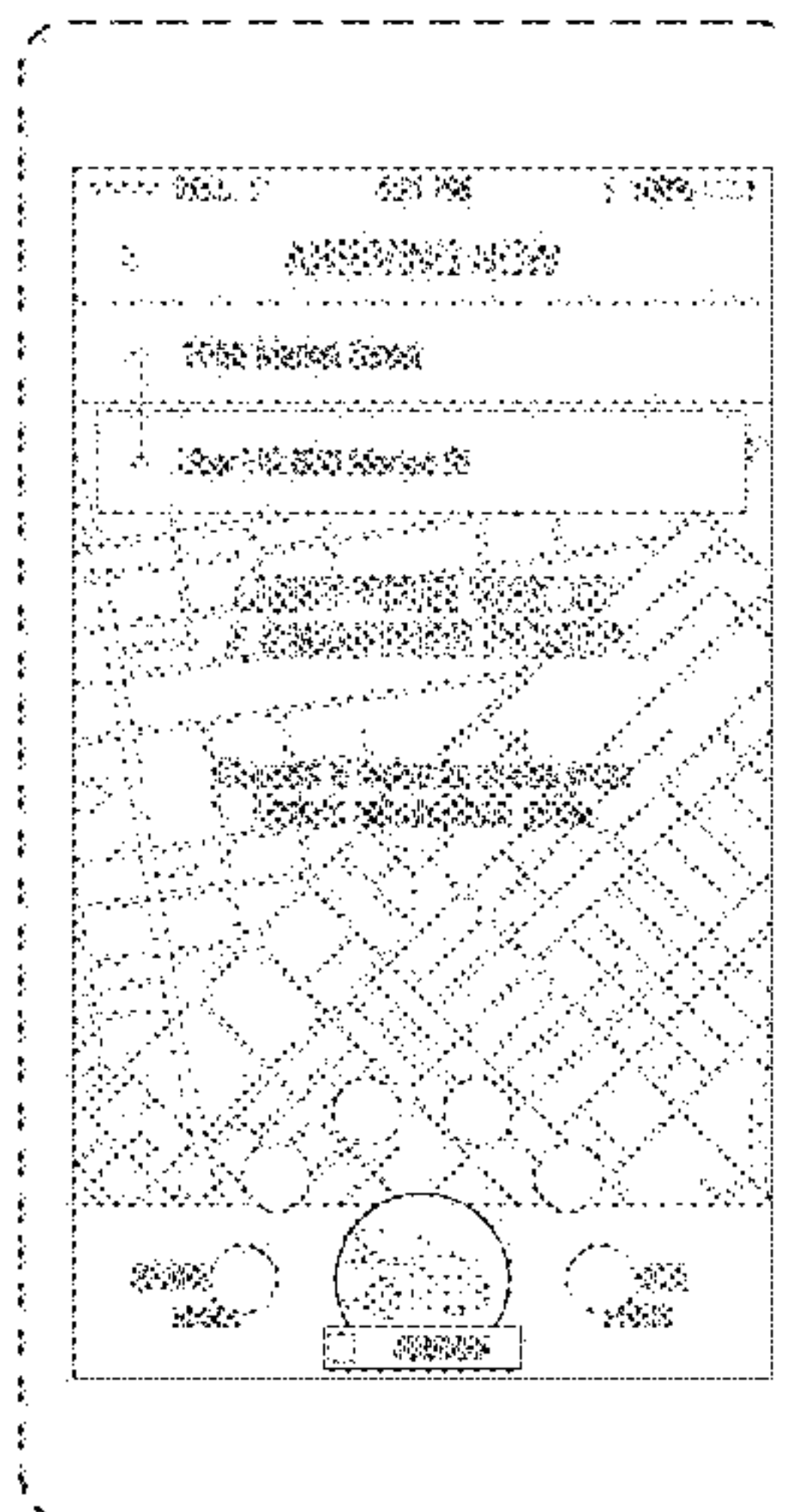
DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface for enabling color selection, showing a first embodiment; and,

FIG. 2 is a front view of a display screen with graphical user interface for enabling color selection, showing a second embodiment.

The shaded portions shown in FIG. 1, other than fill patterns shown within the smaller circular shapes, form part of the claimed design. The fill patterns within the circular shapes in FIG. 1 form no part of the claimed design. The outer broken line showing of a display screen and all other broken lines showing portions of the graphical user interface are included for the purpose of illustrating portions of the article and form no part of the claim.

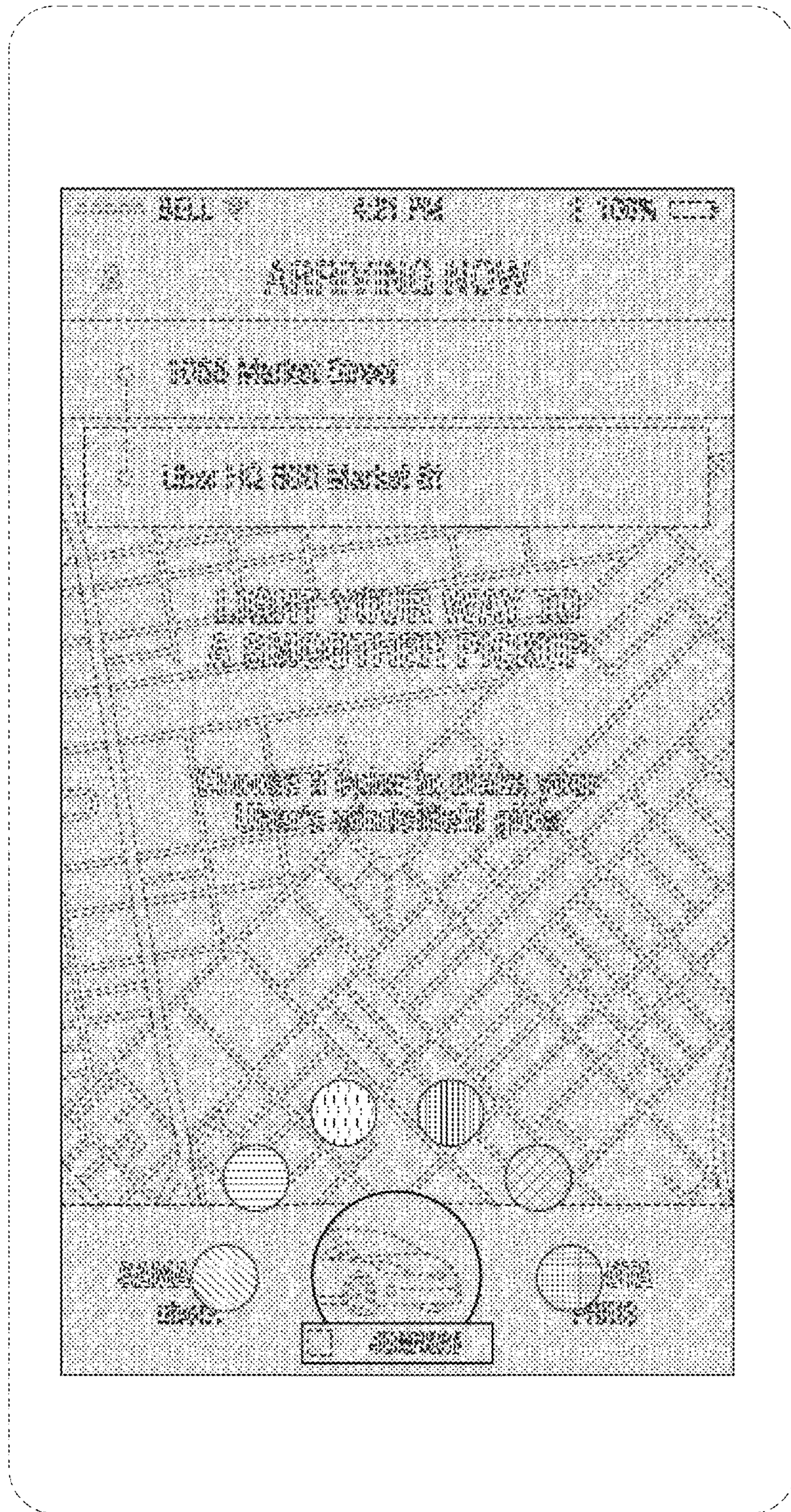

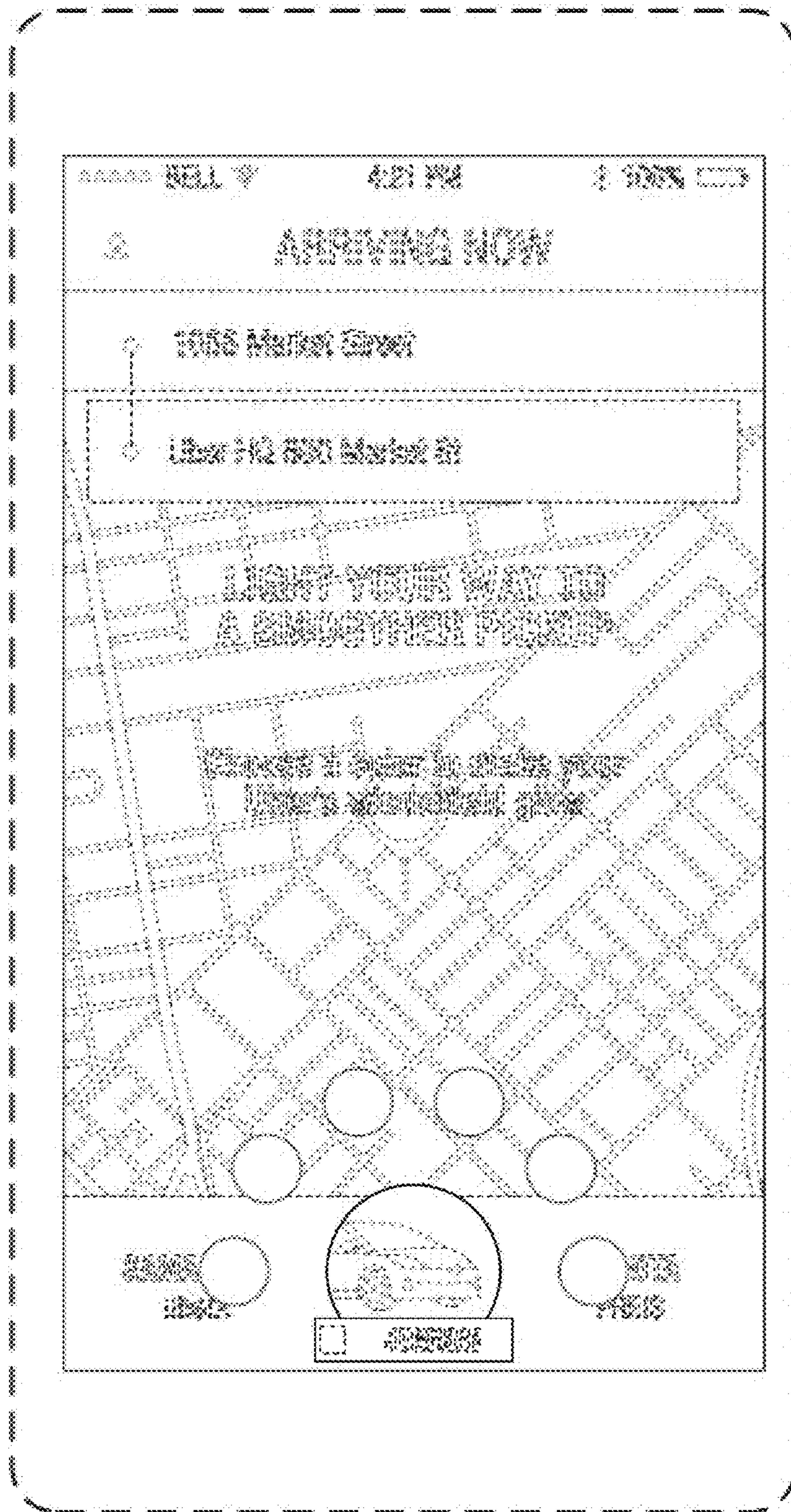
