The ornamental design for a zipper pull, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a zipper pull showing my new design;

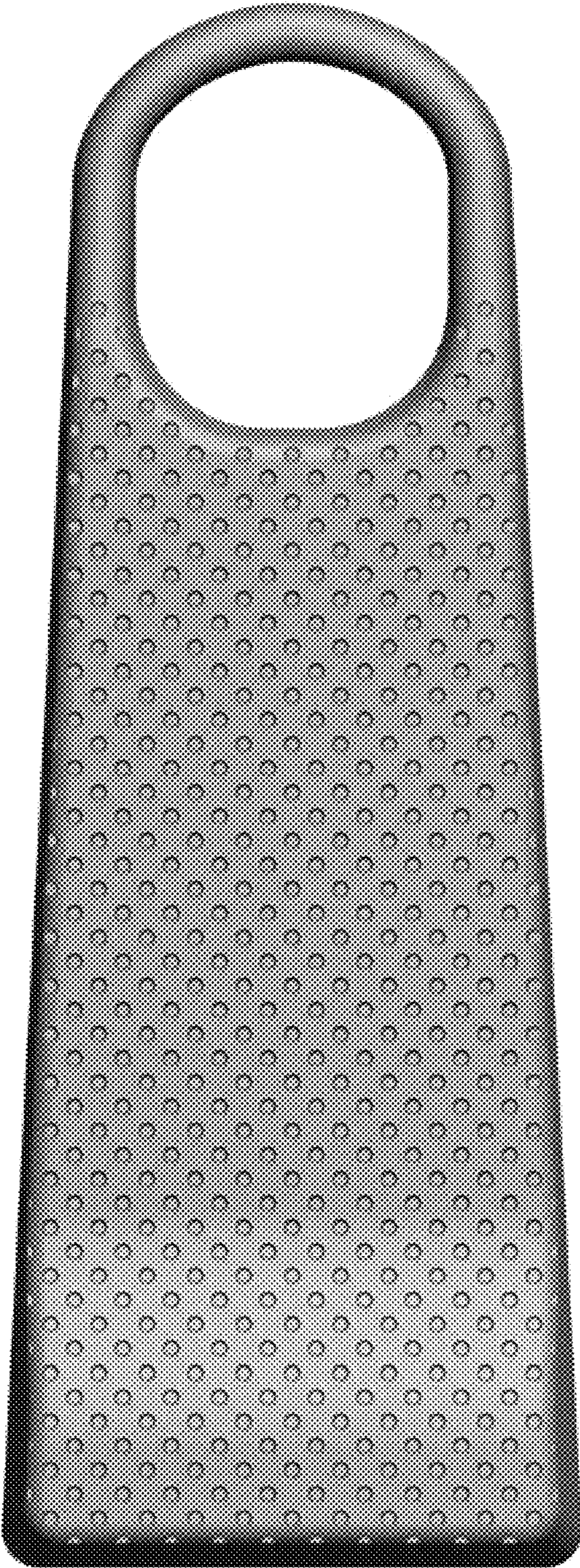

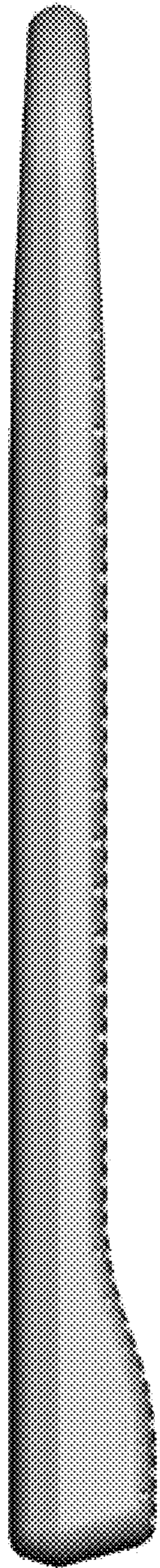

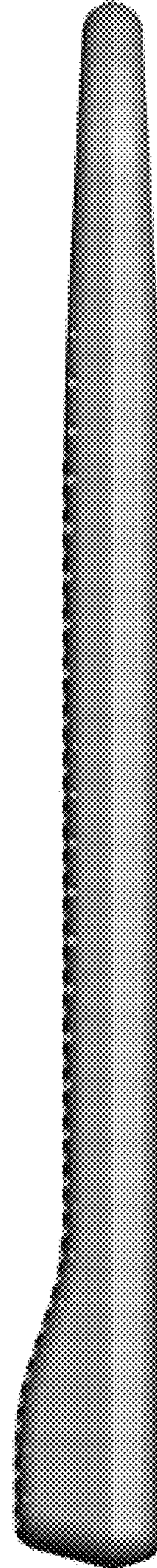

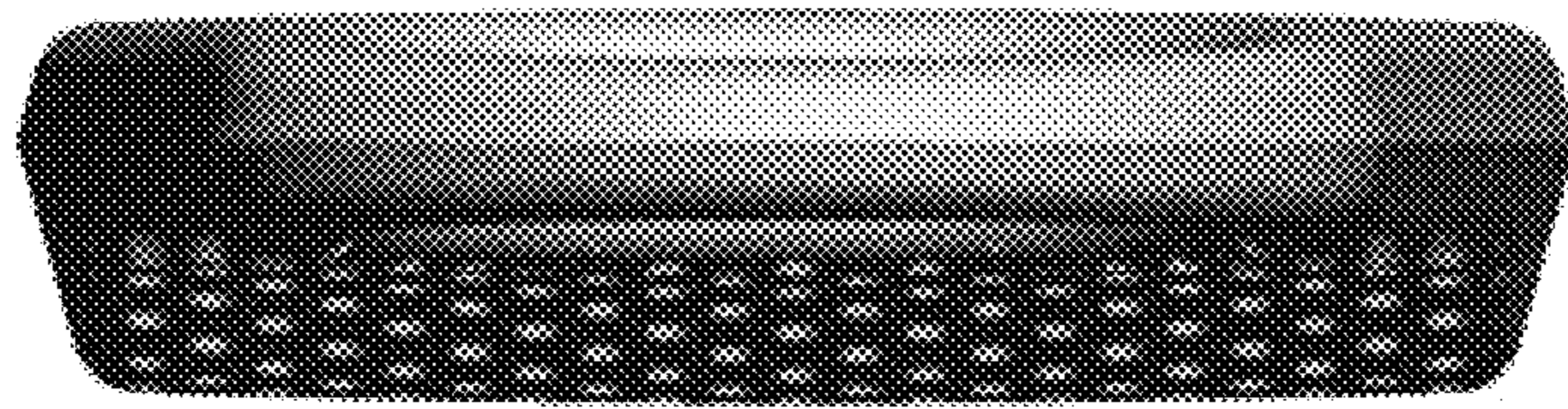

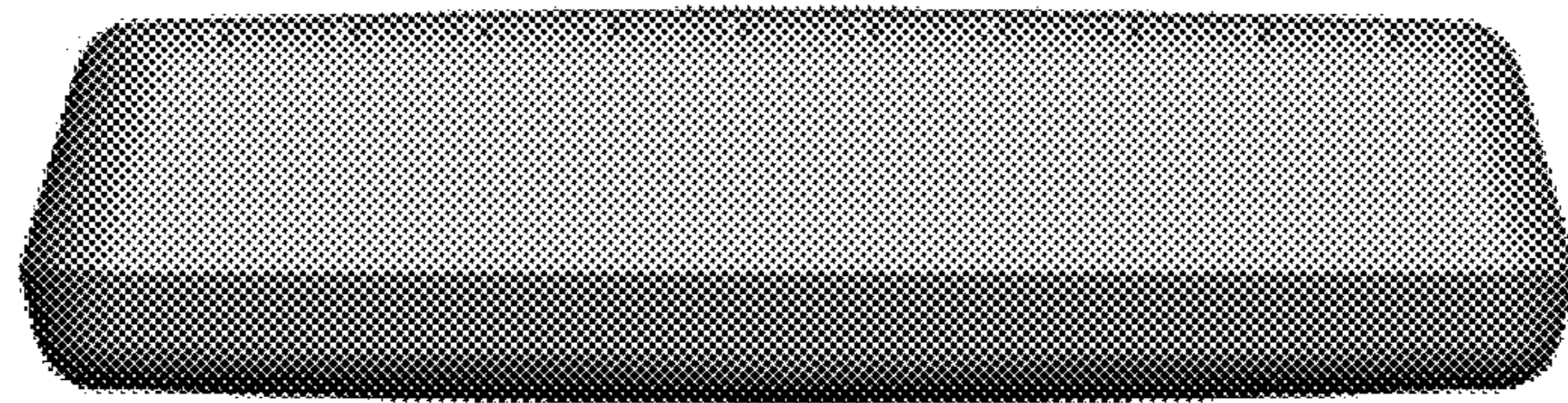

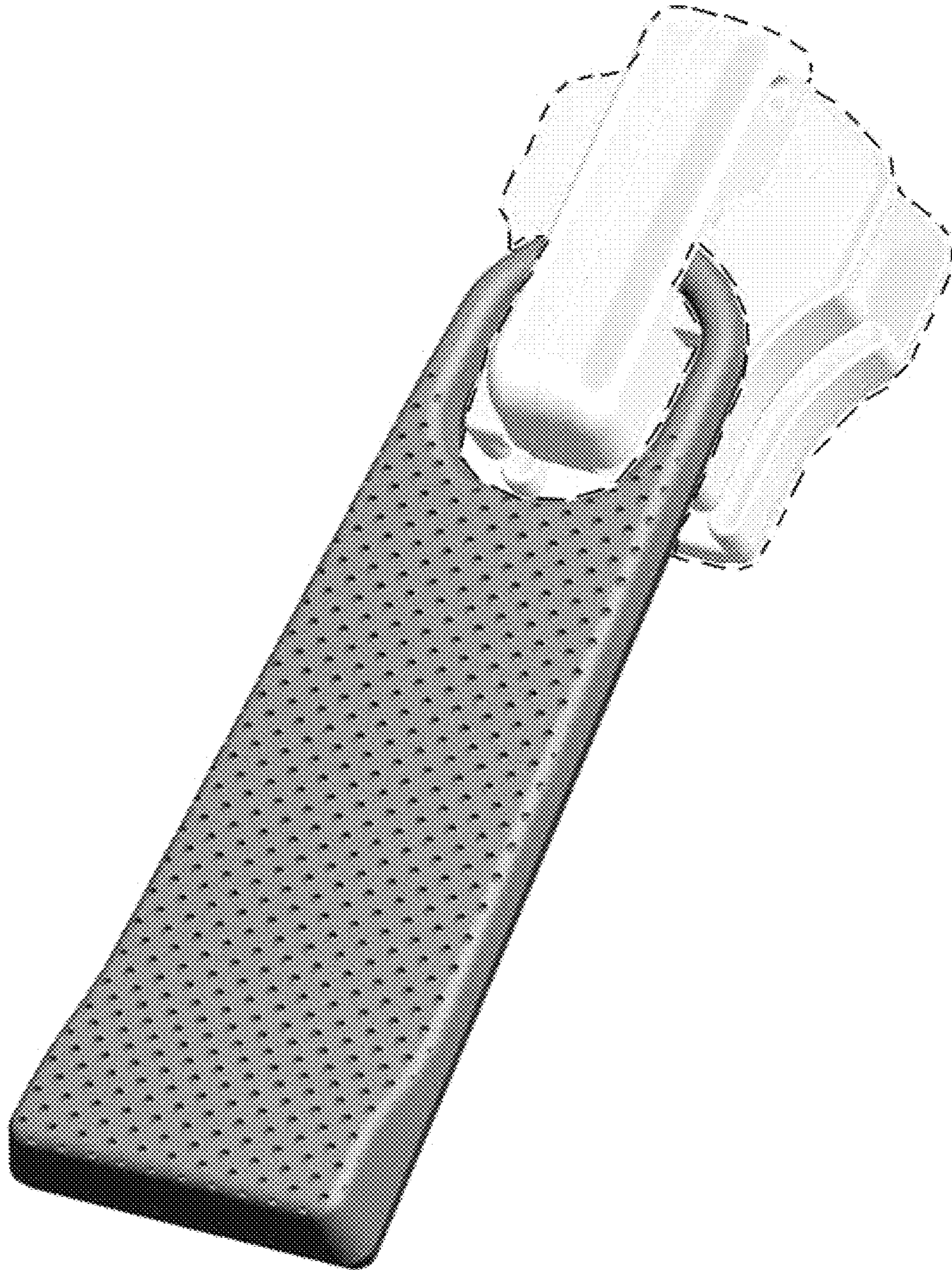
