(57) **CLAIM**

We claim the ornamental design for a mobile two-door food cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile two-door food cabinet showing our new design;

FIG. 5 is a top plan view thereof;

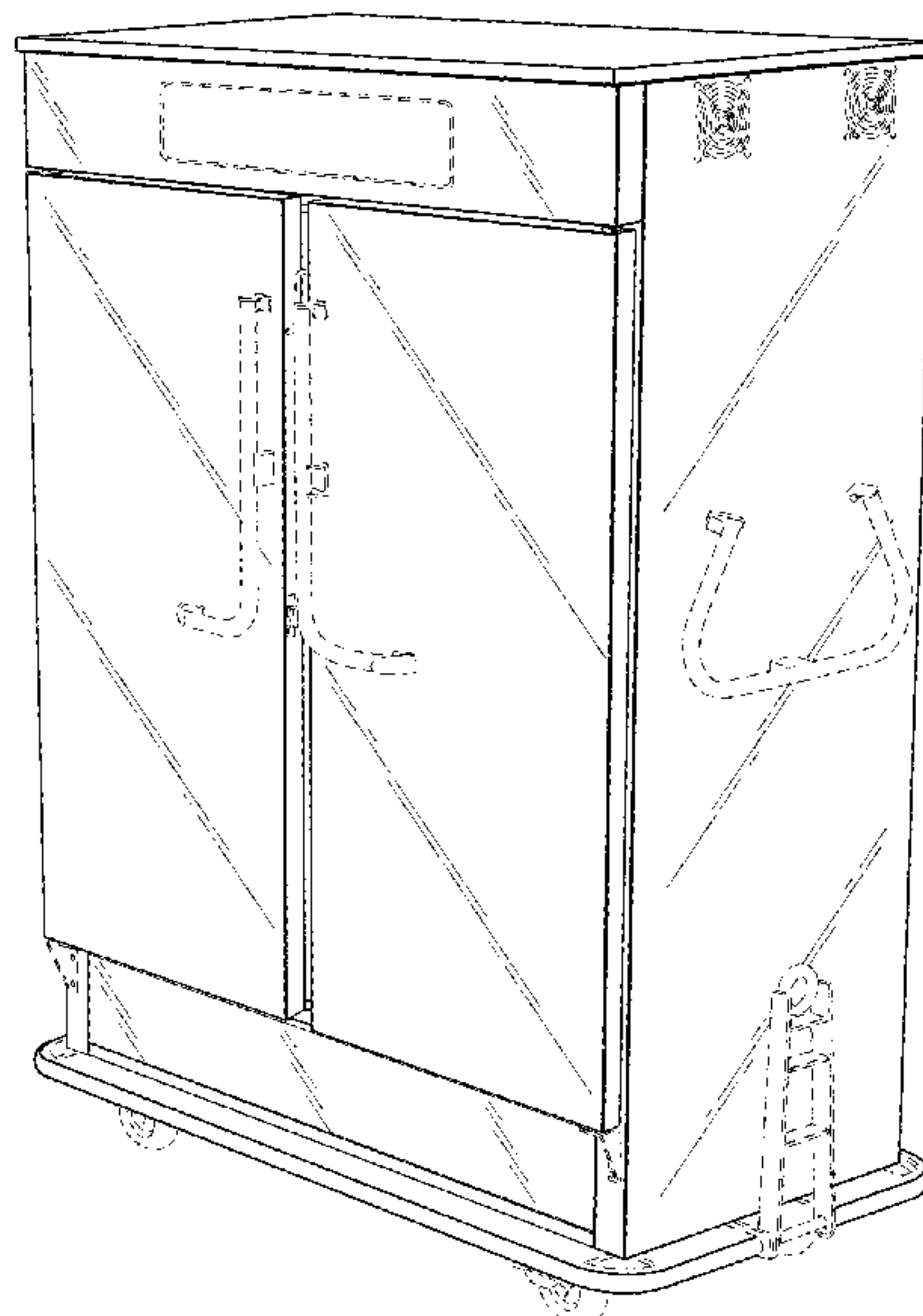
FIG. 6 is a rear elevation view thereof;

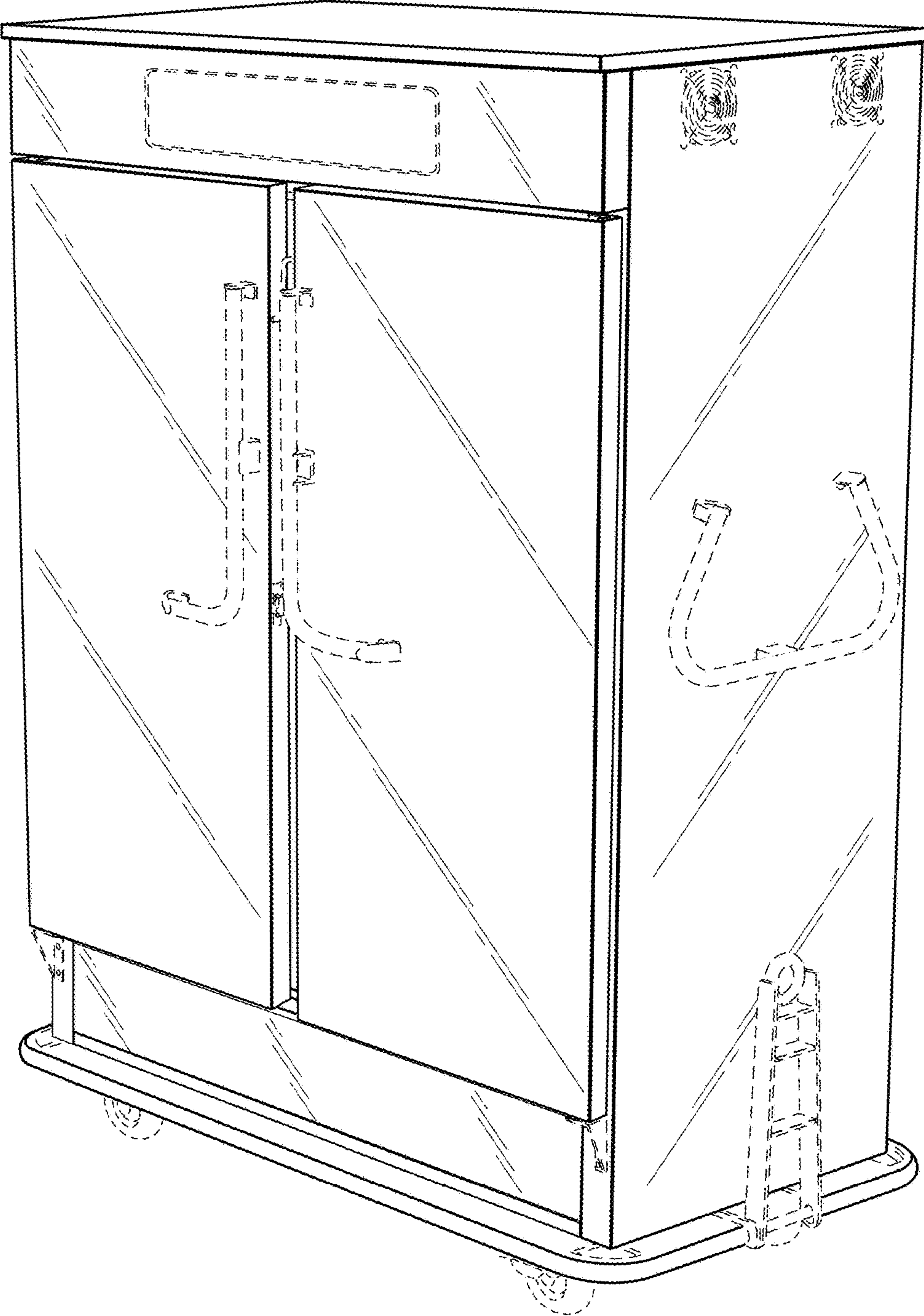

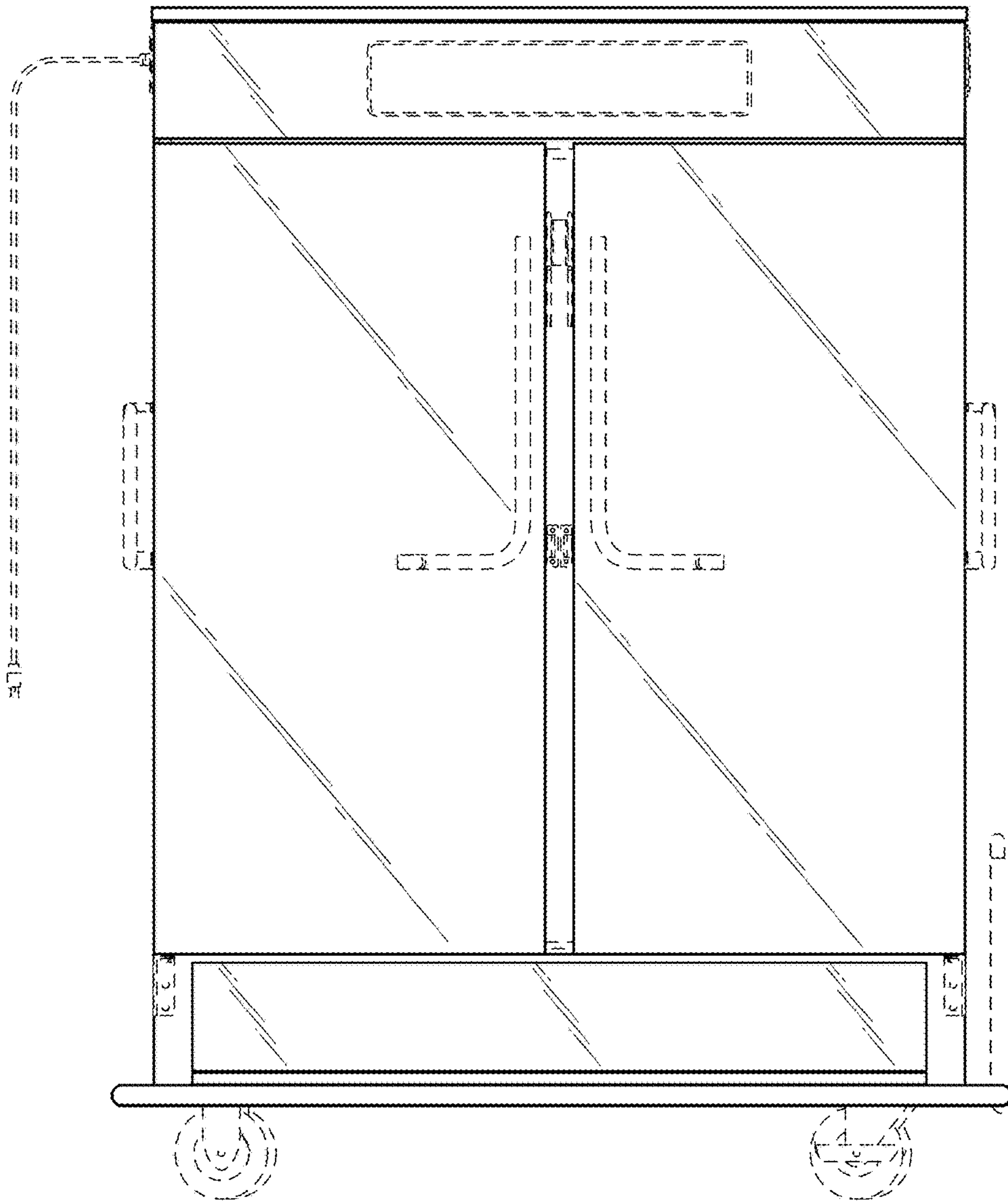

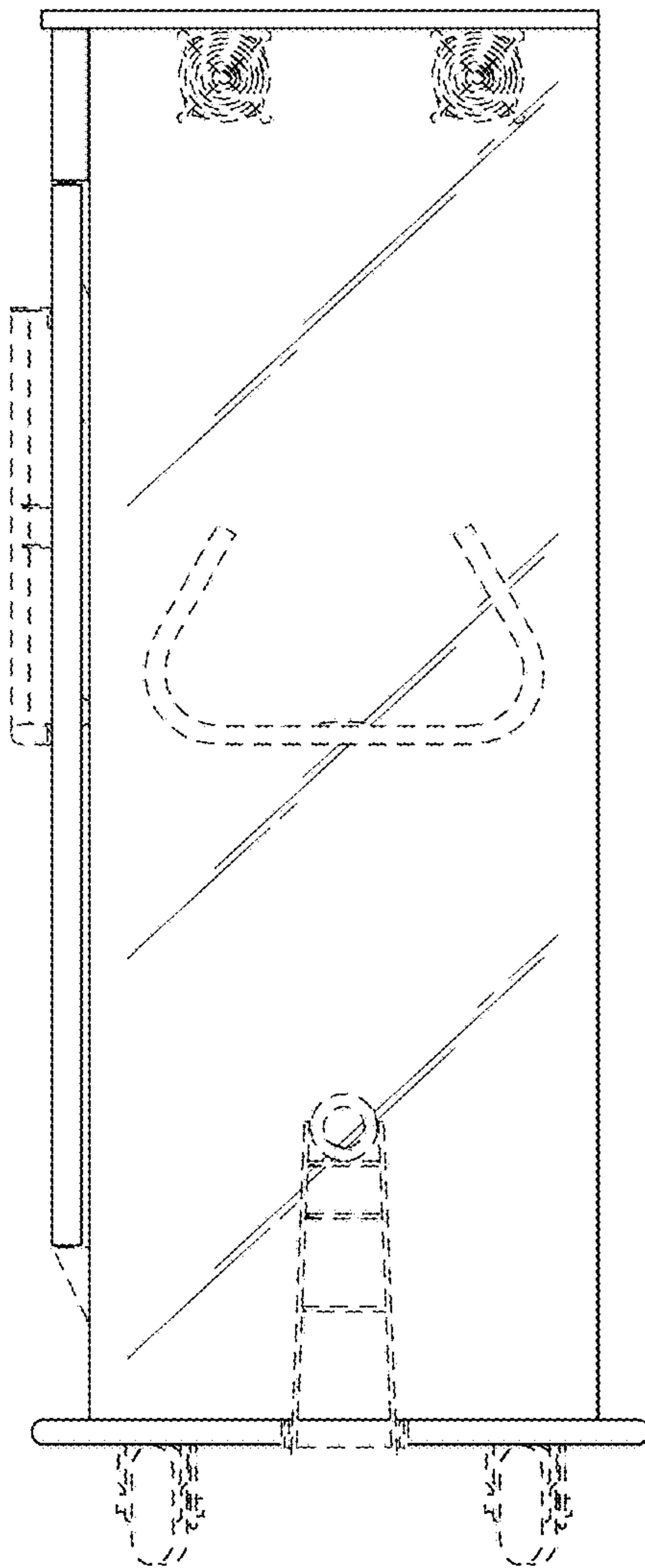

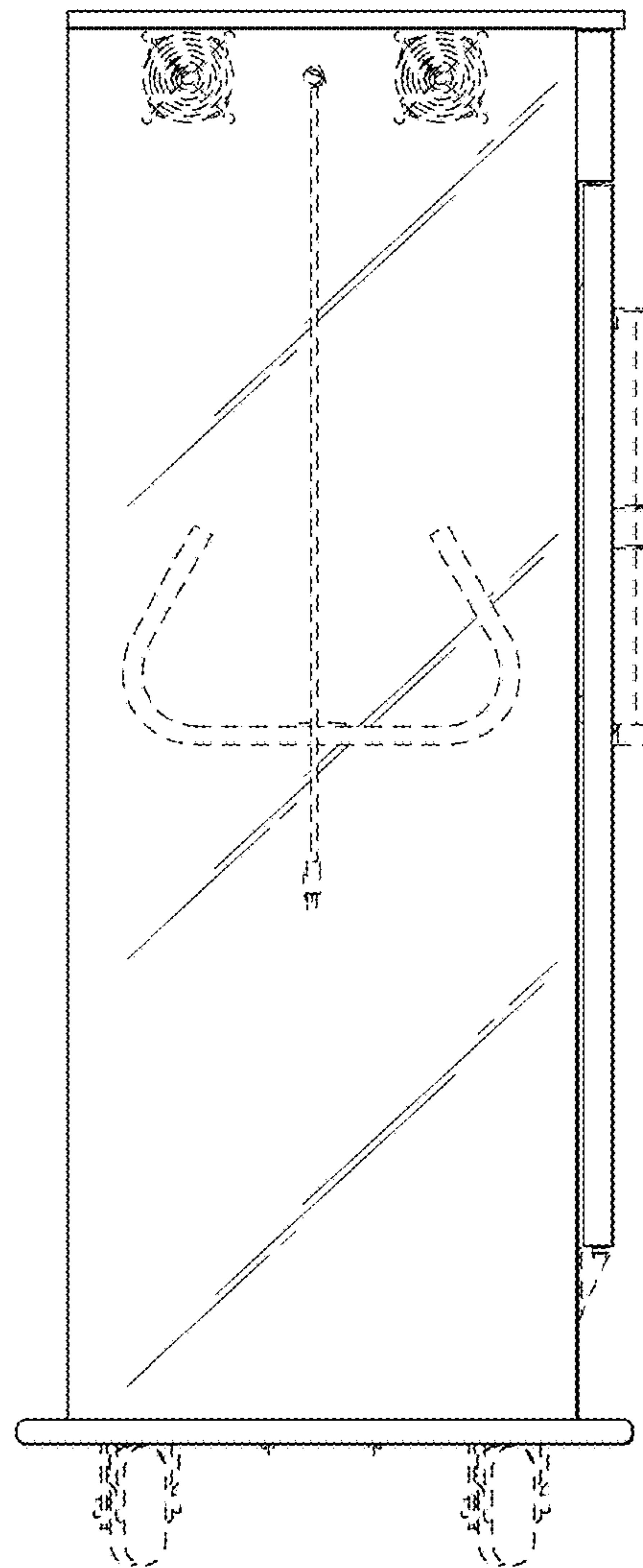

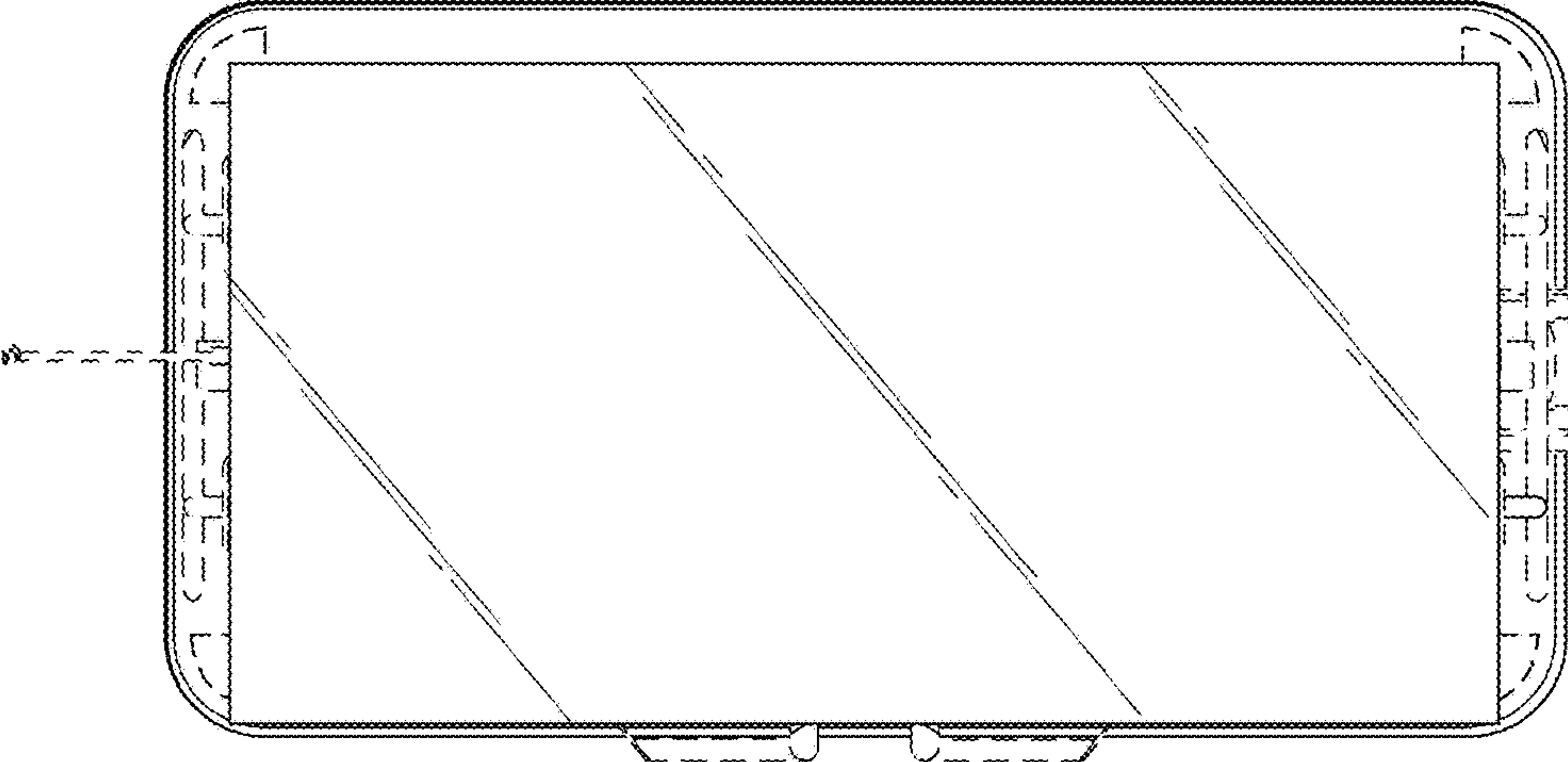

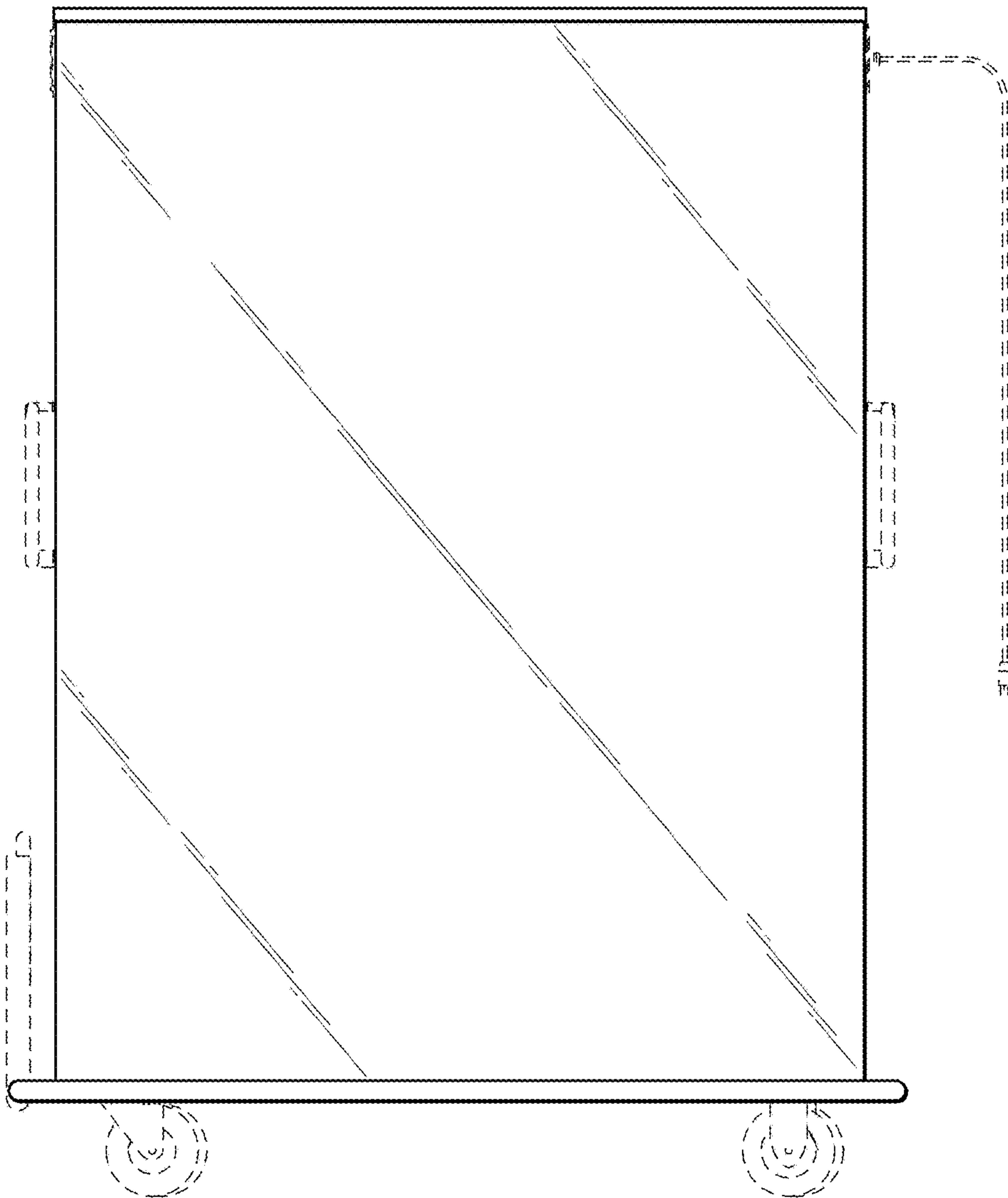

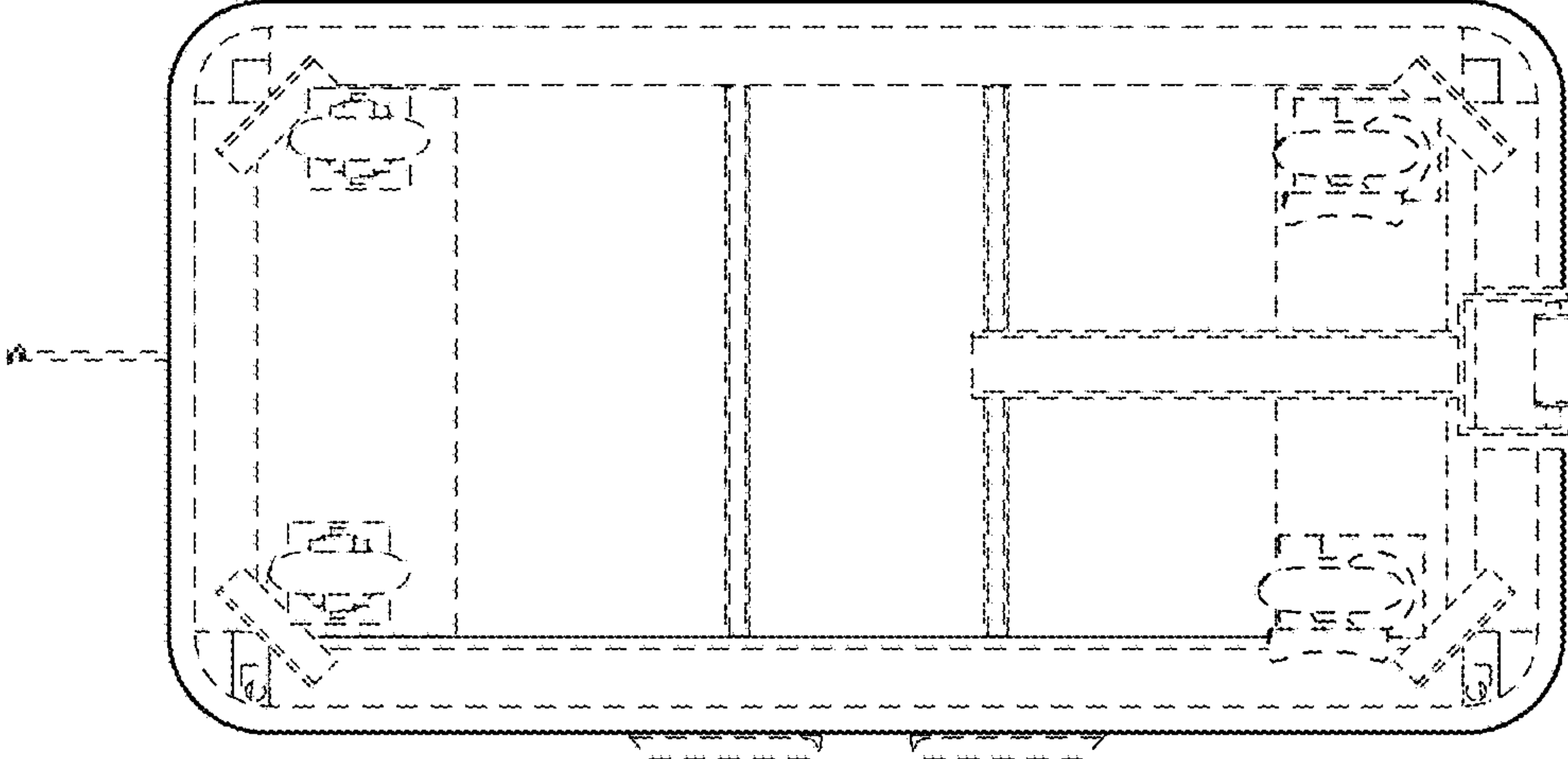
