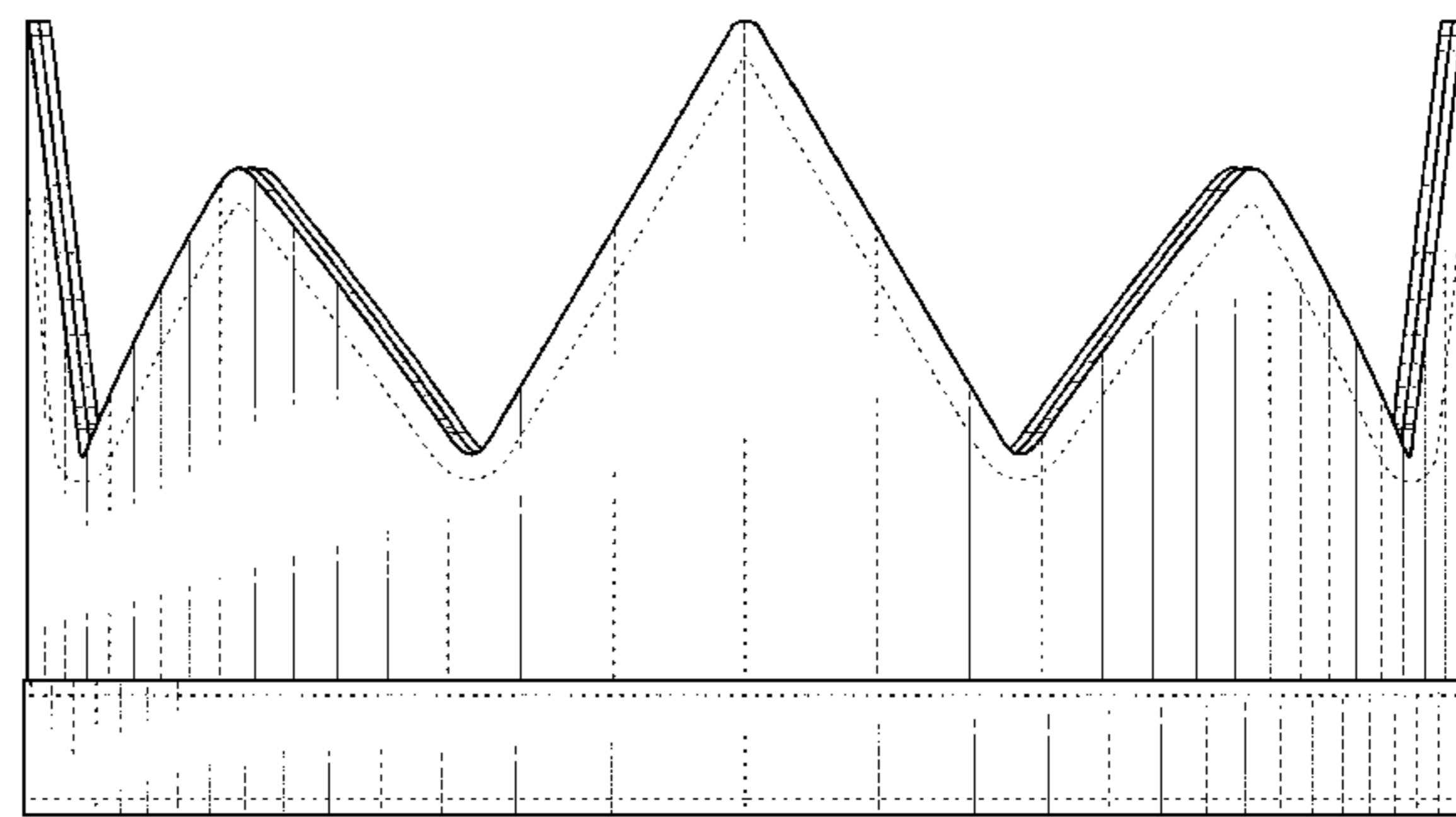
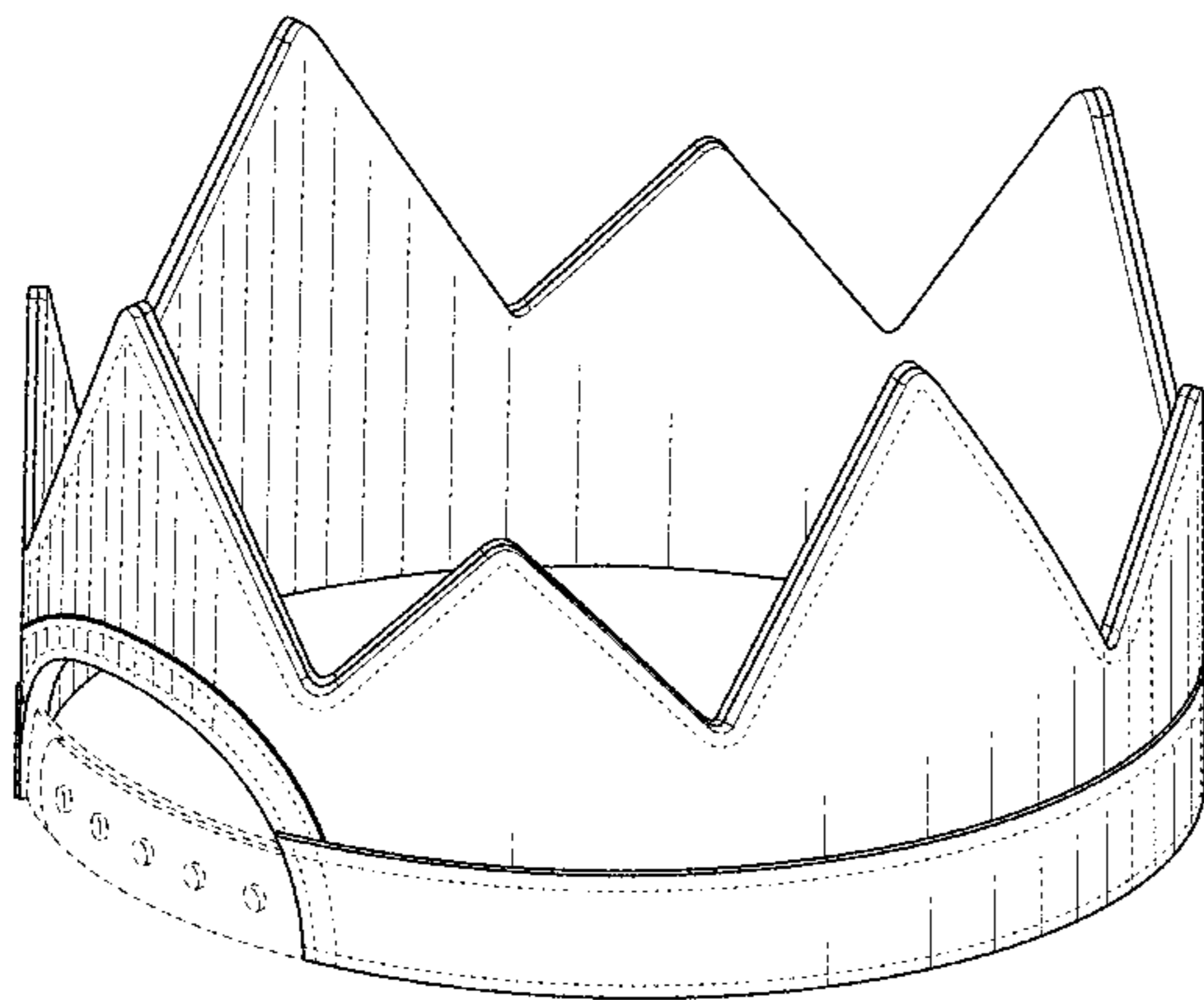
The ornamental design for a crown hat, as shown and described.

**DESCRIPTION**

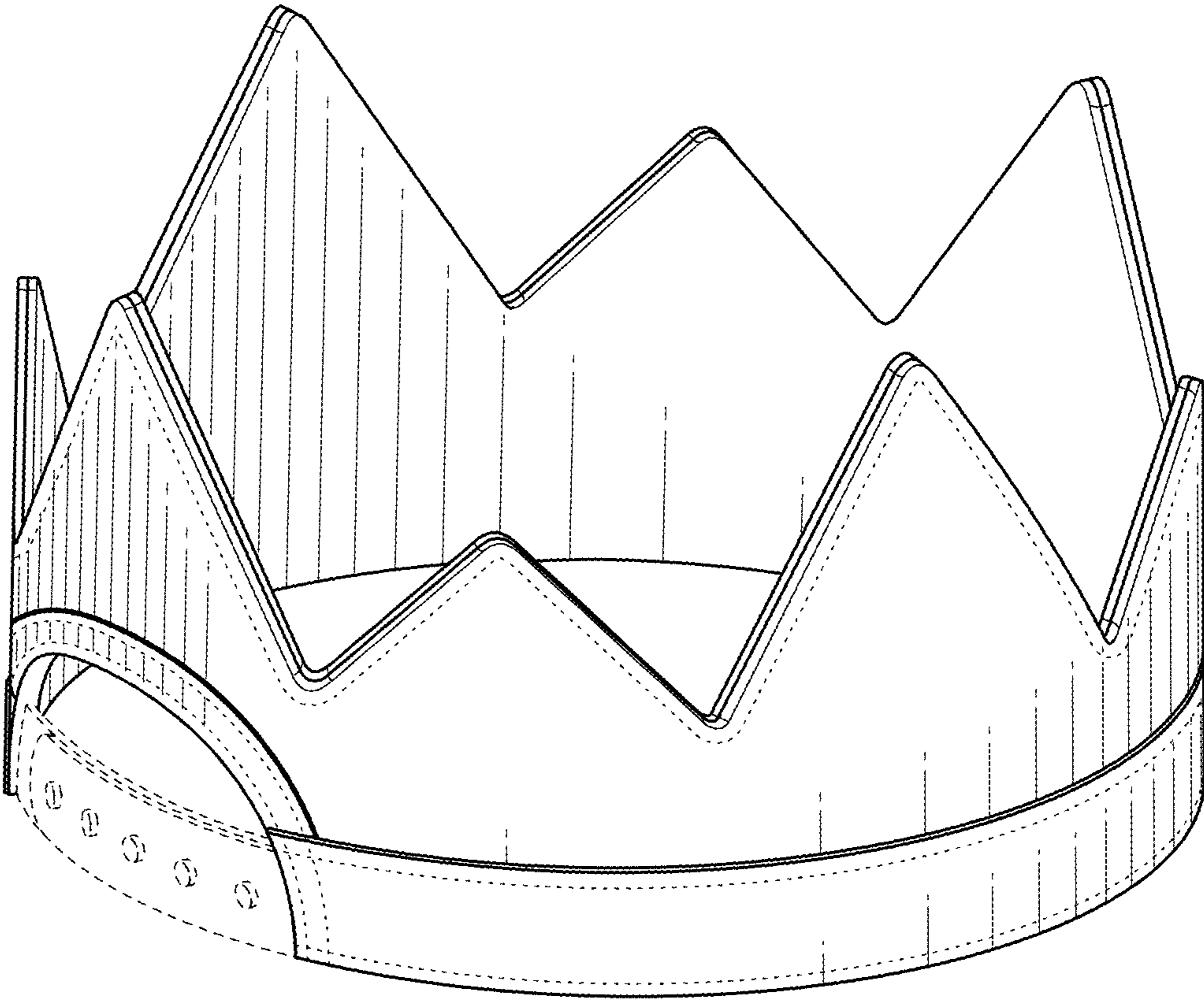

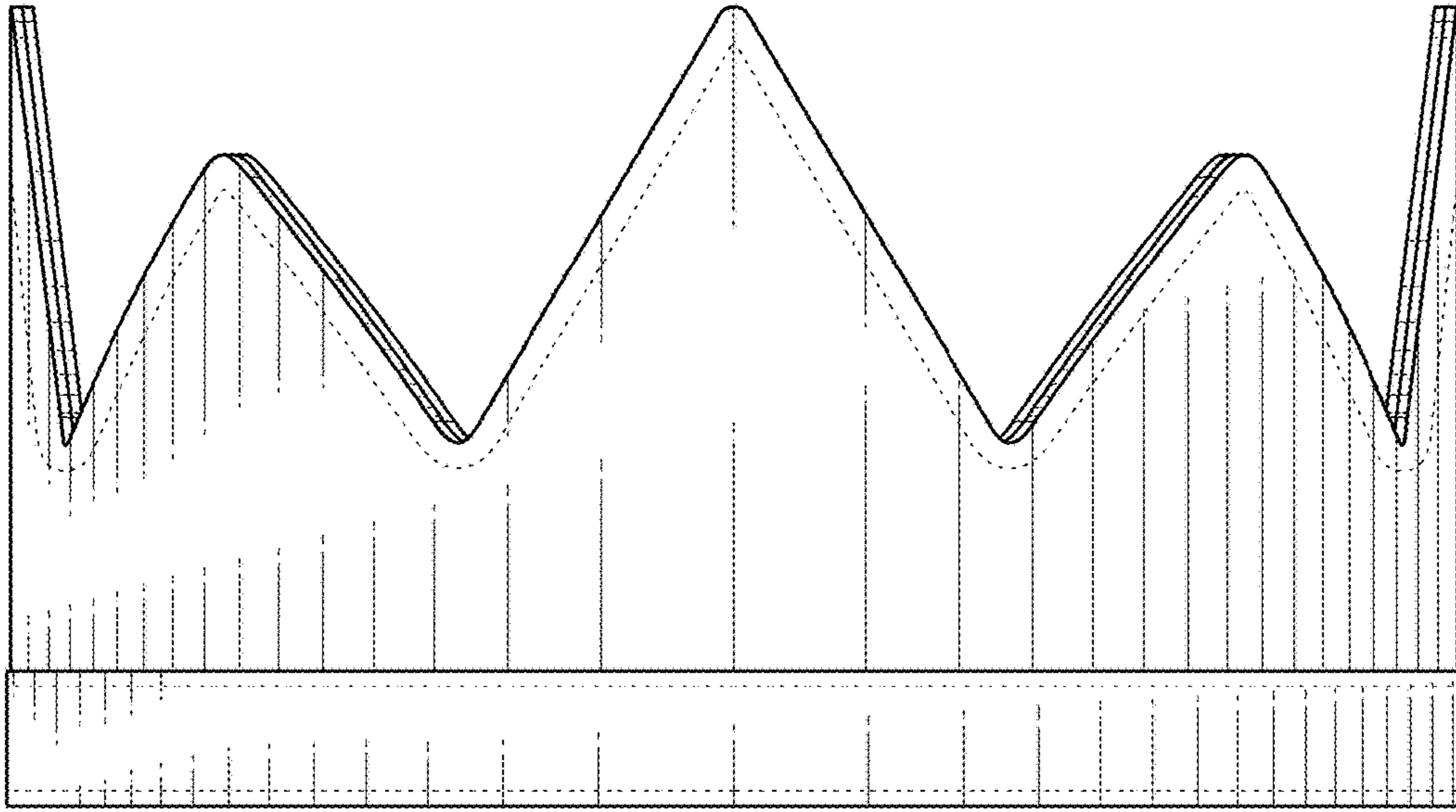

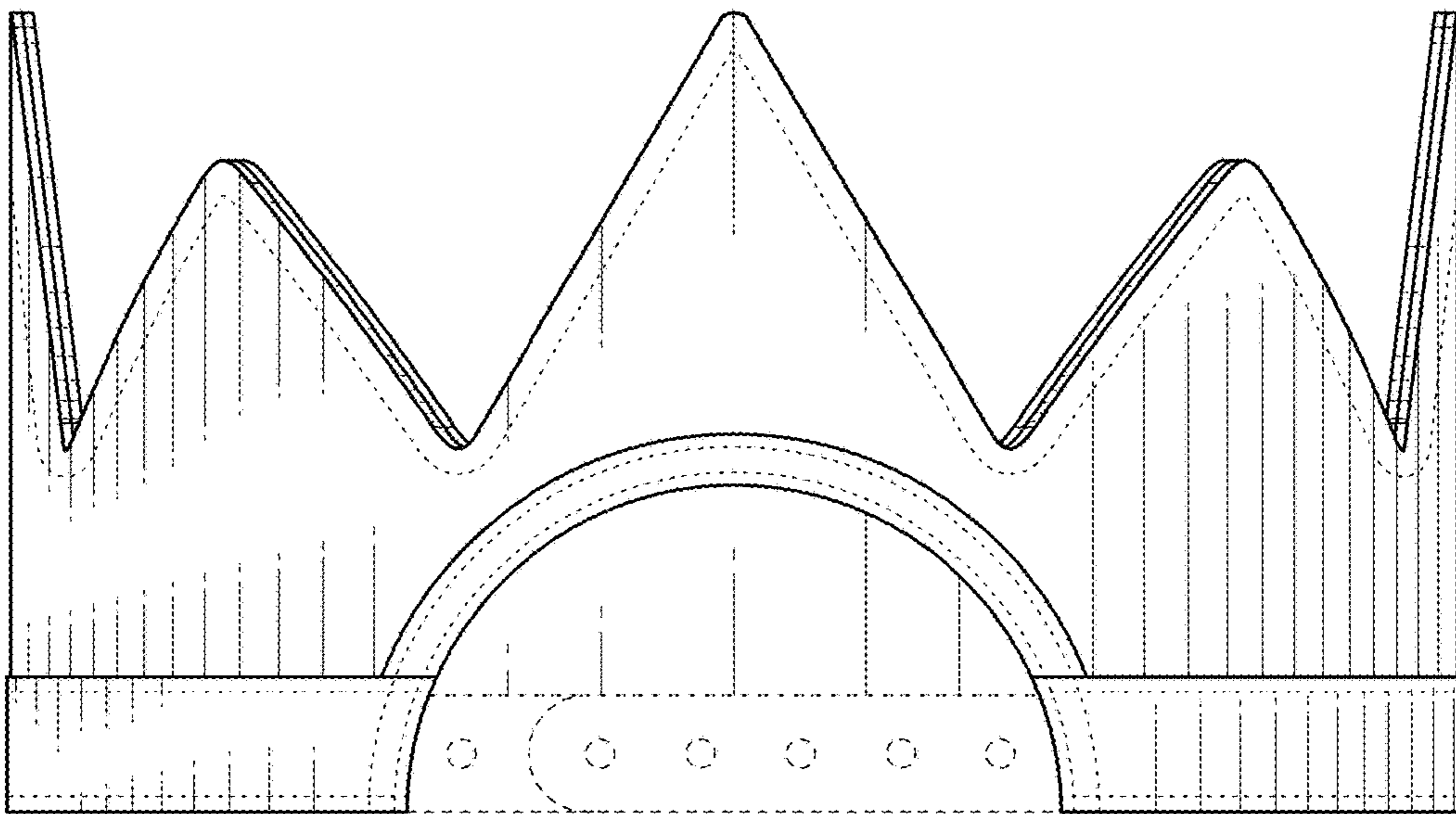

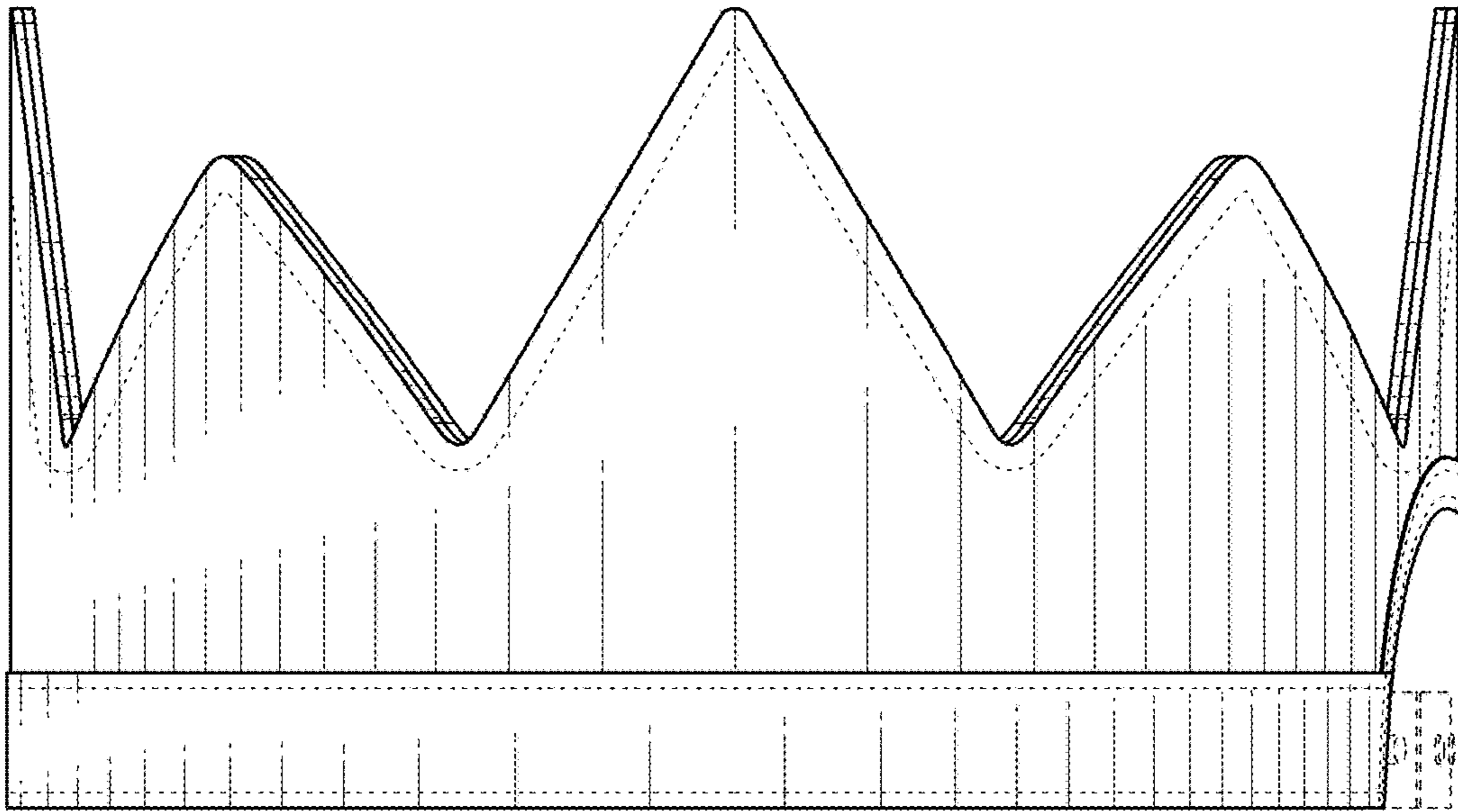

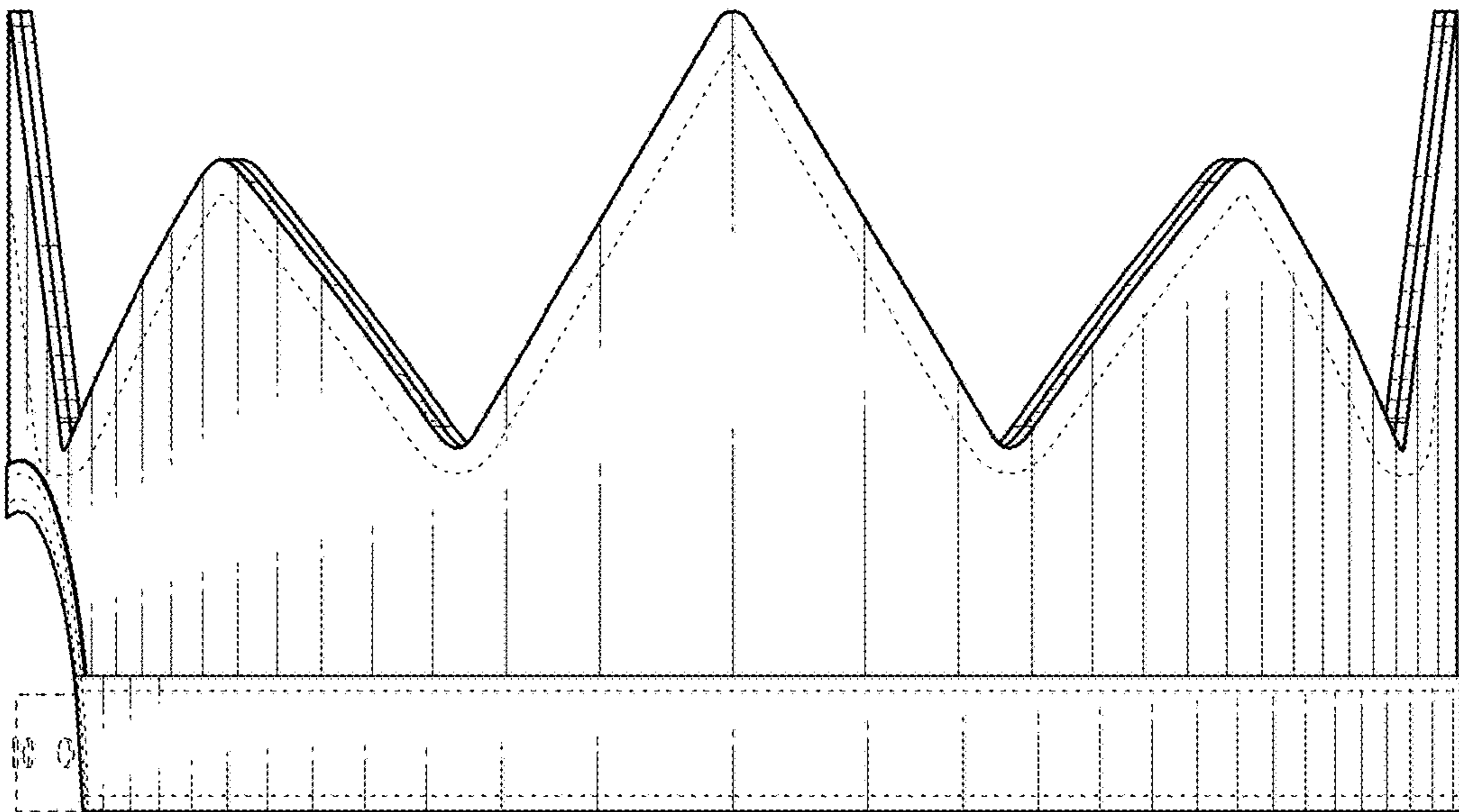

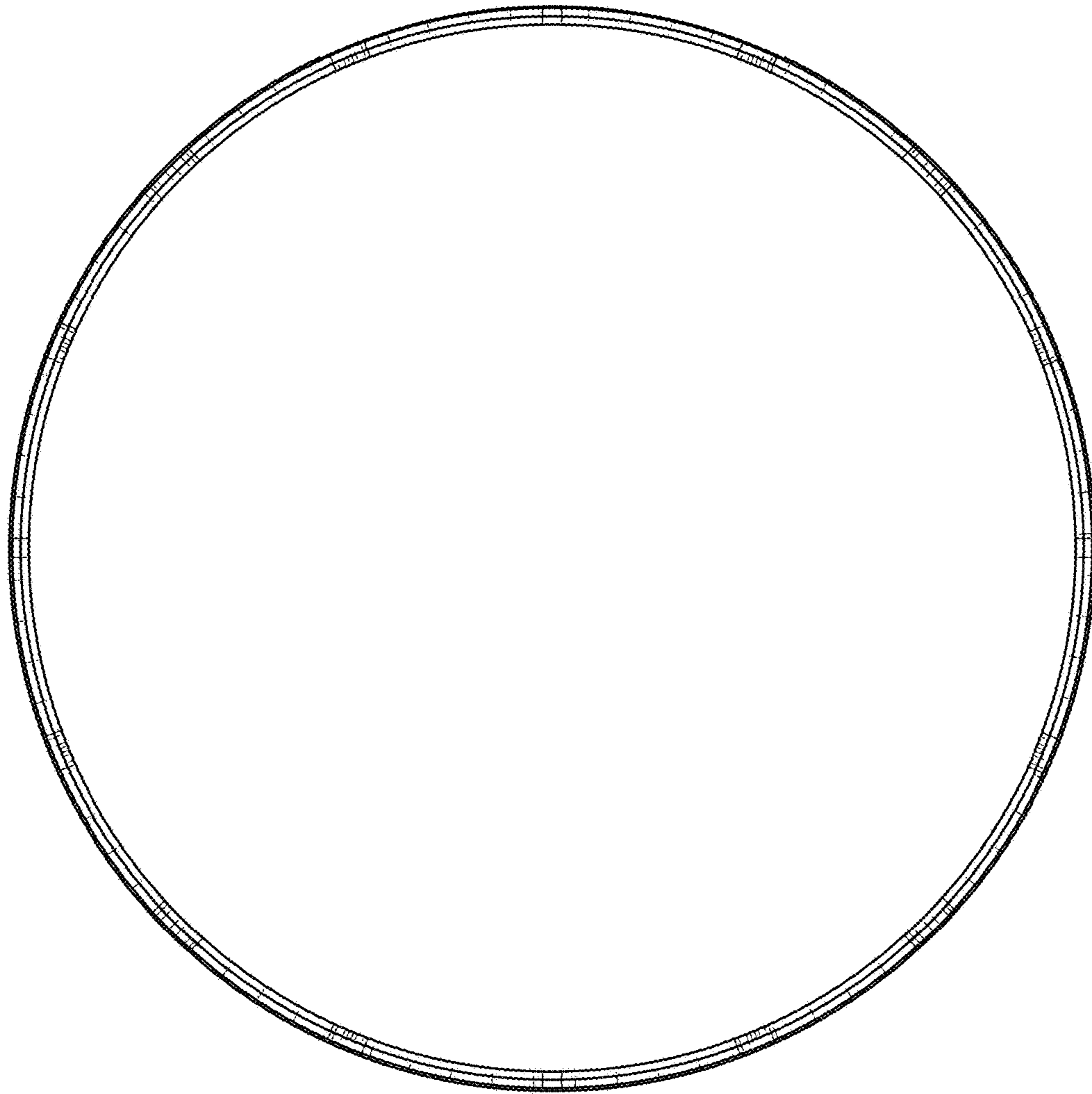

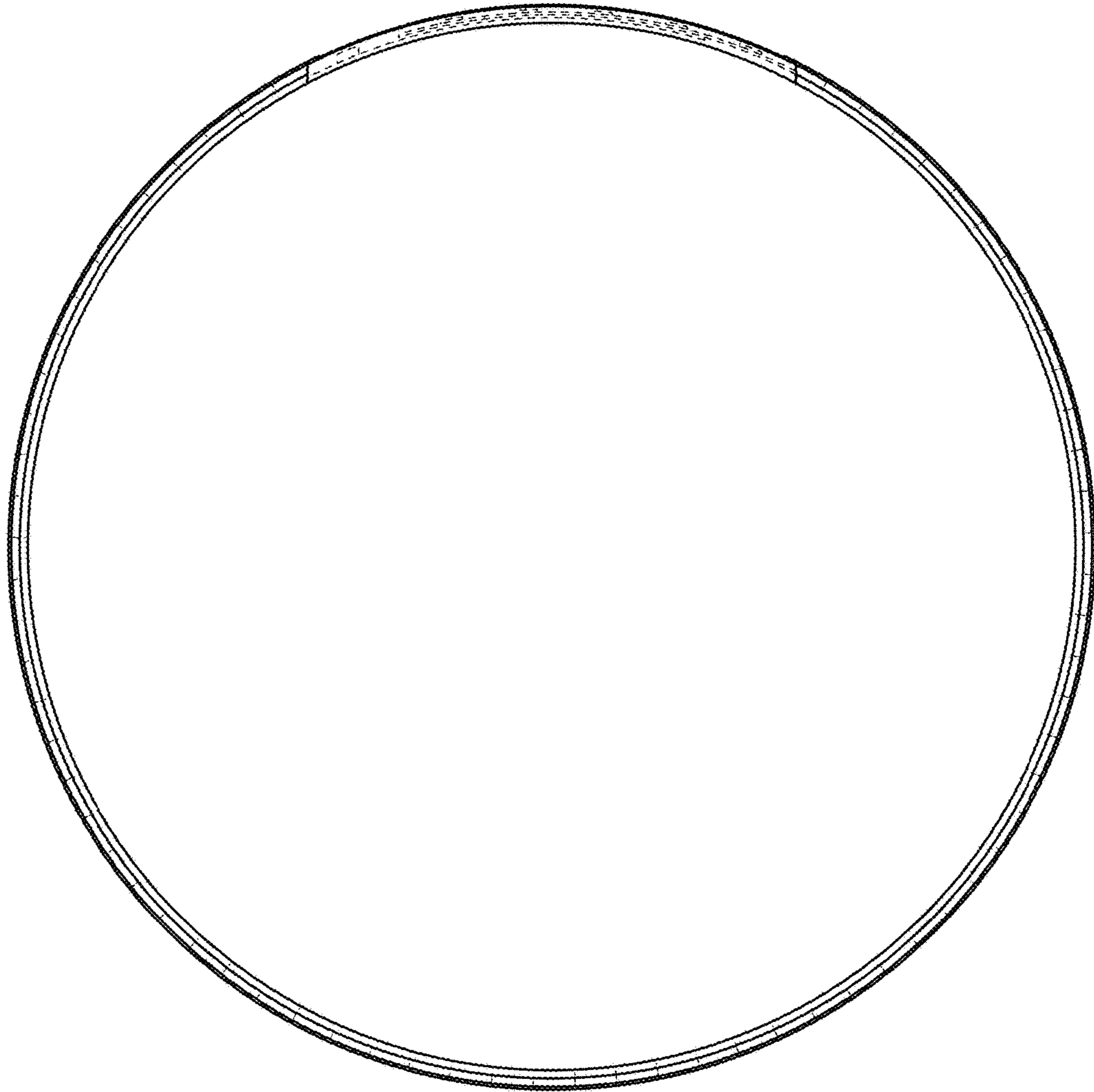
