DESCRIPTION

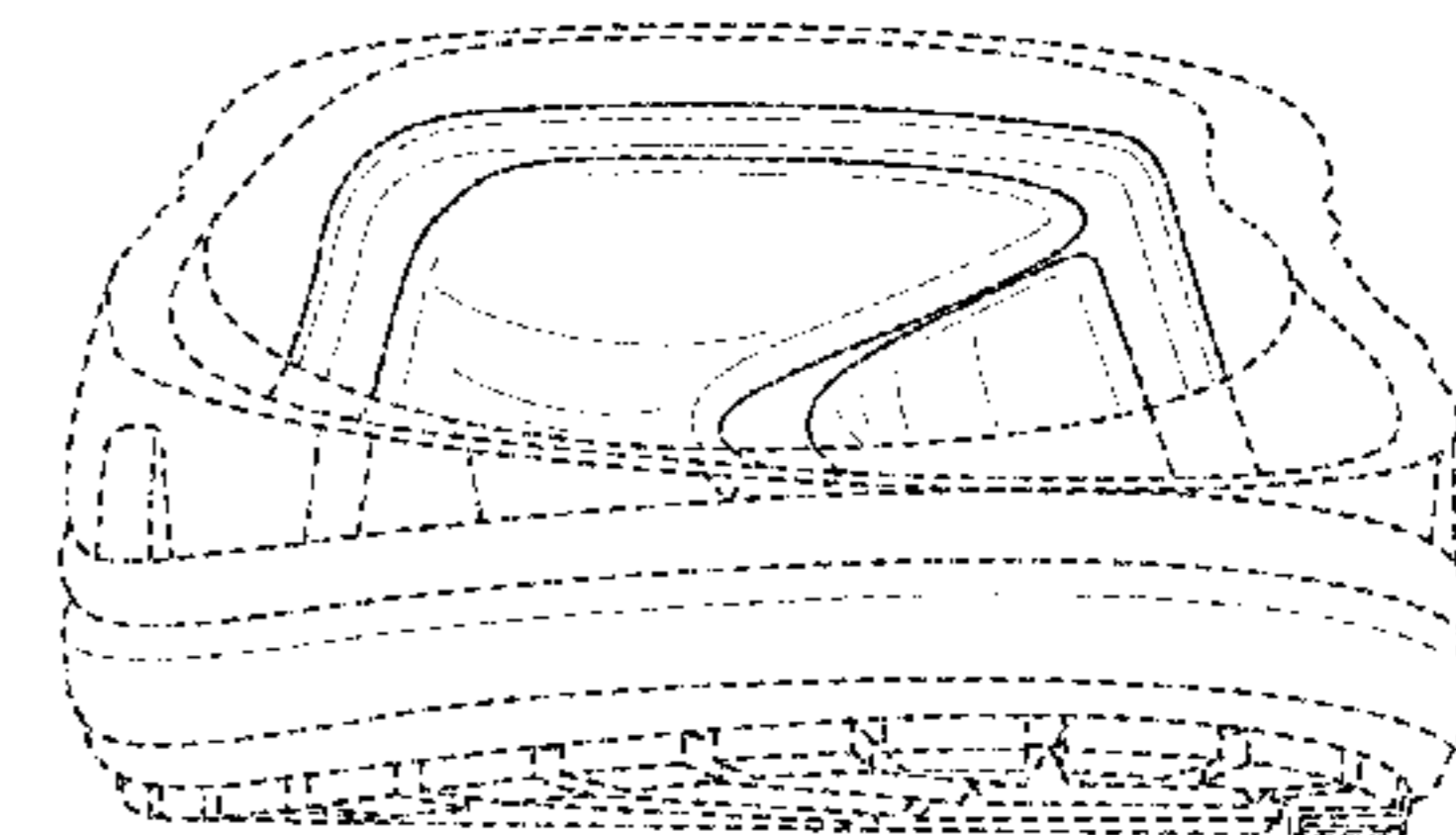
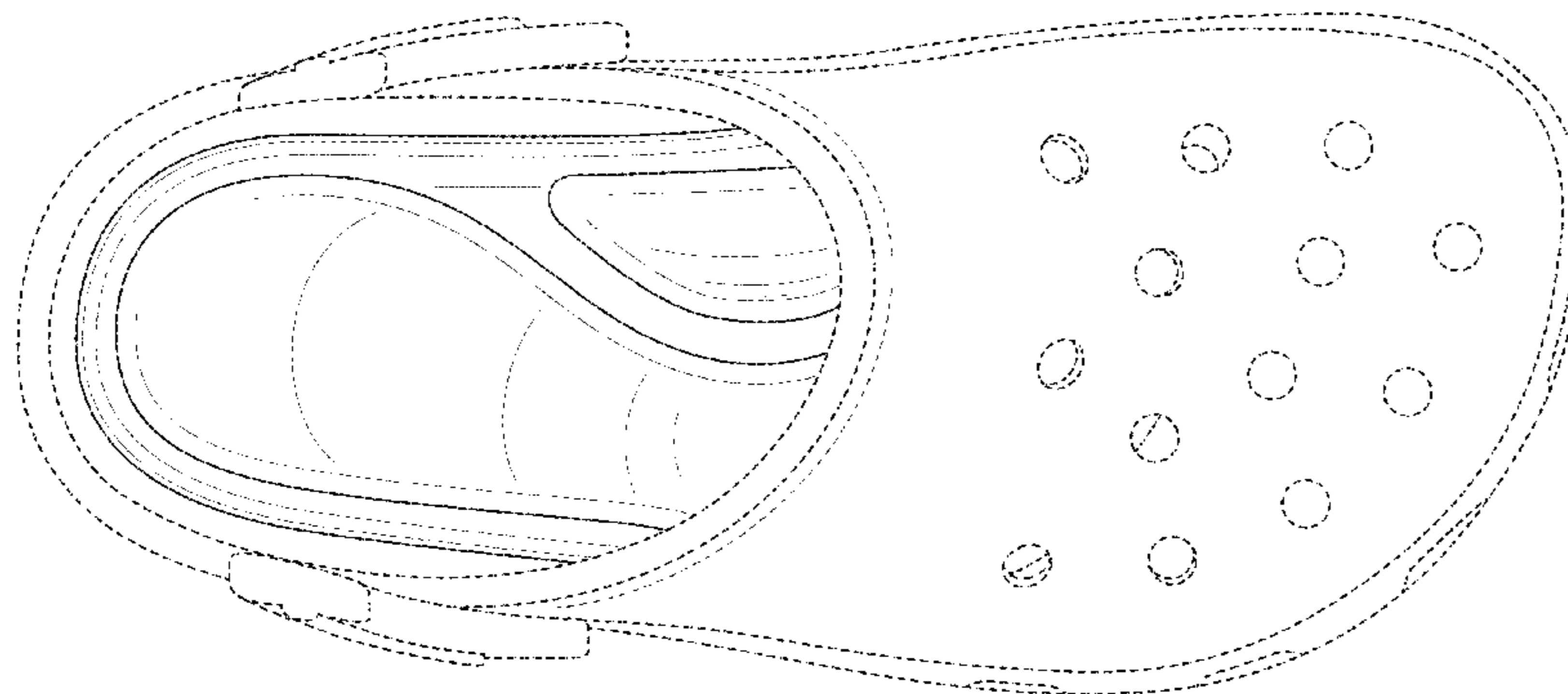
FIG. 1 is a top plan view of footbed, showing my new

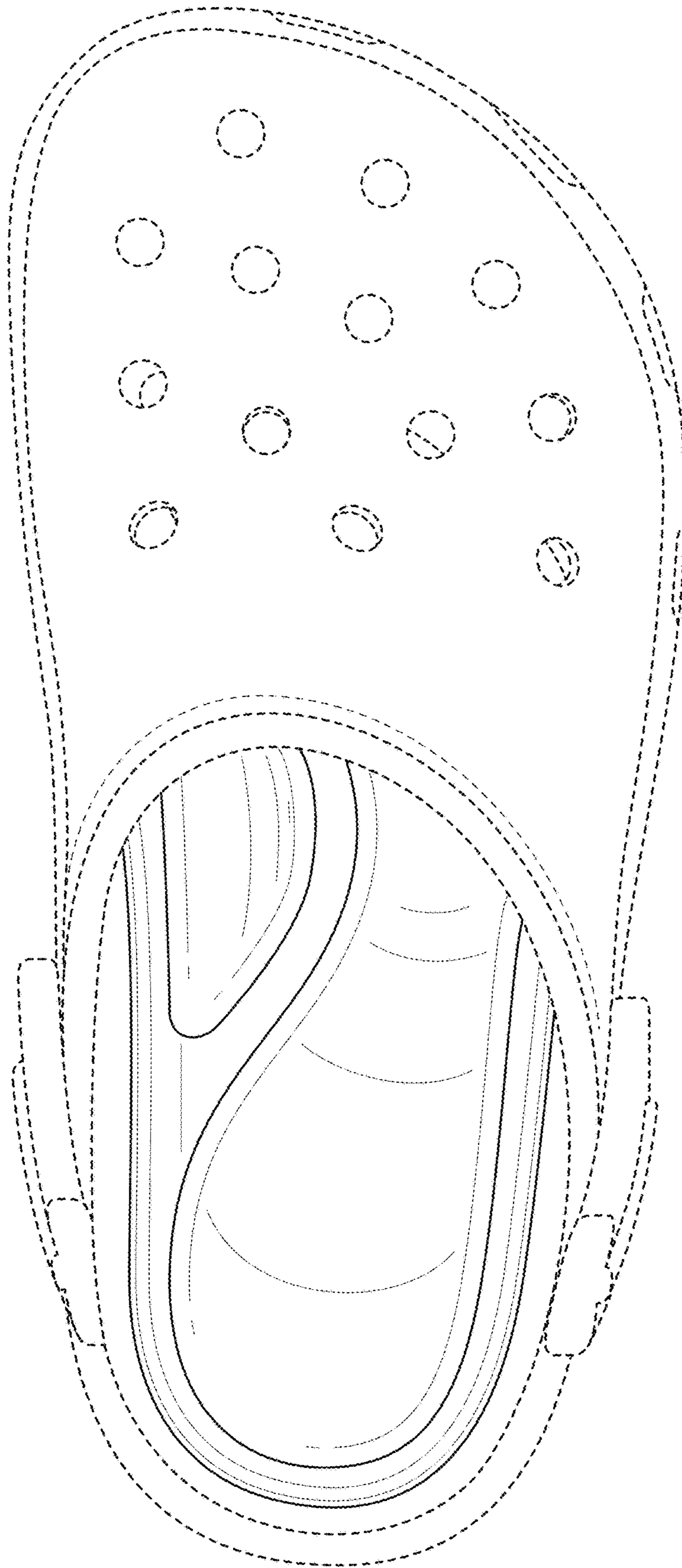

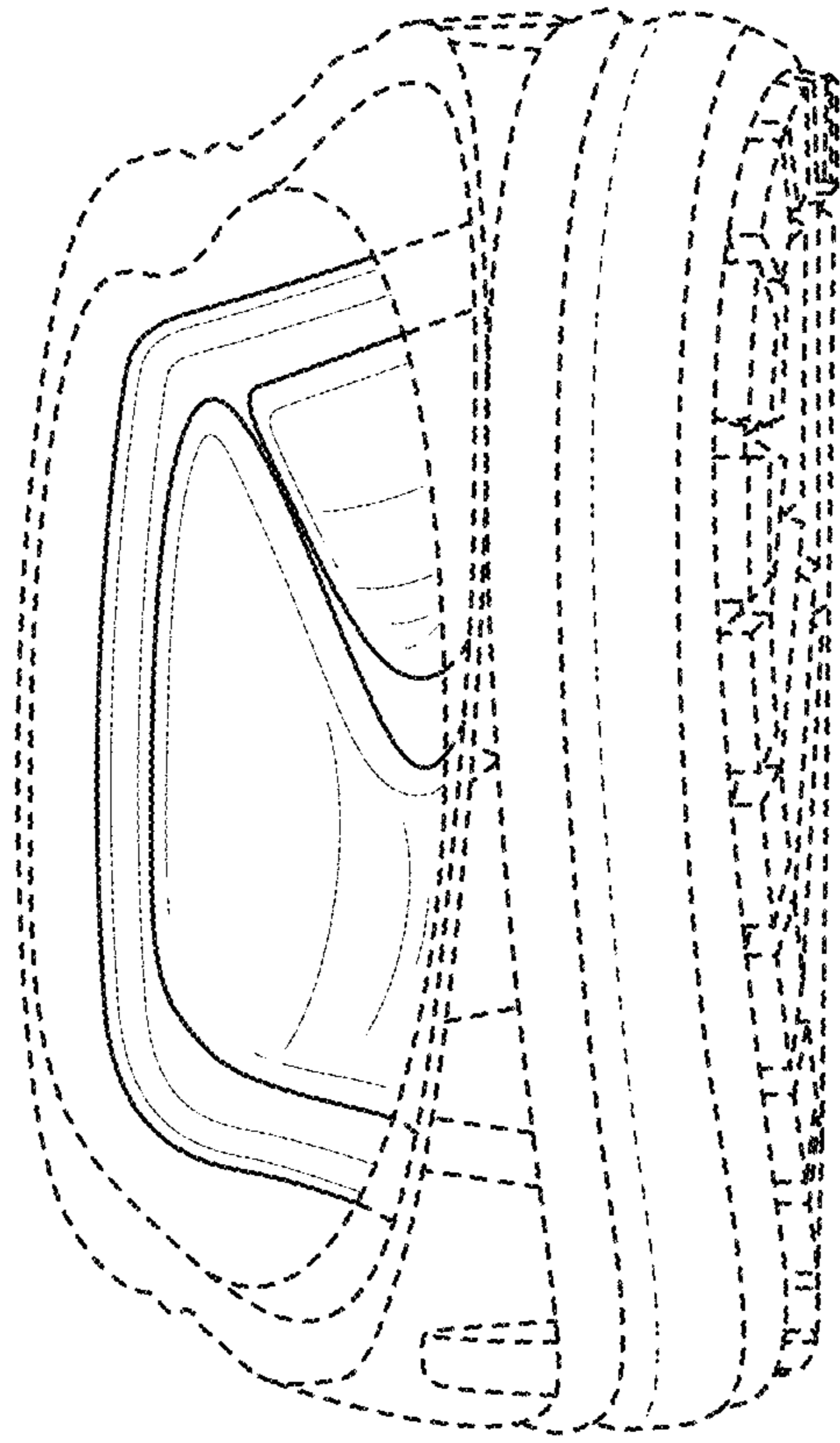

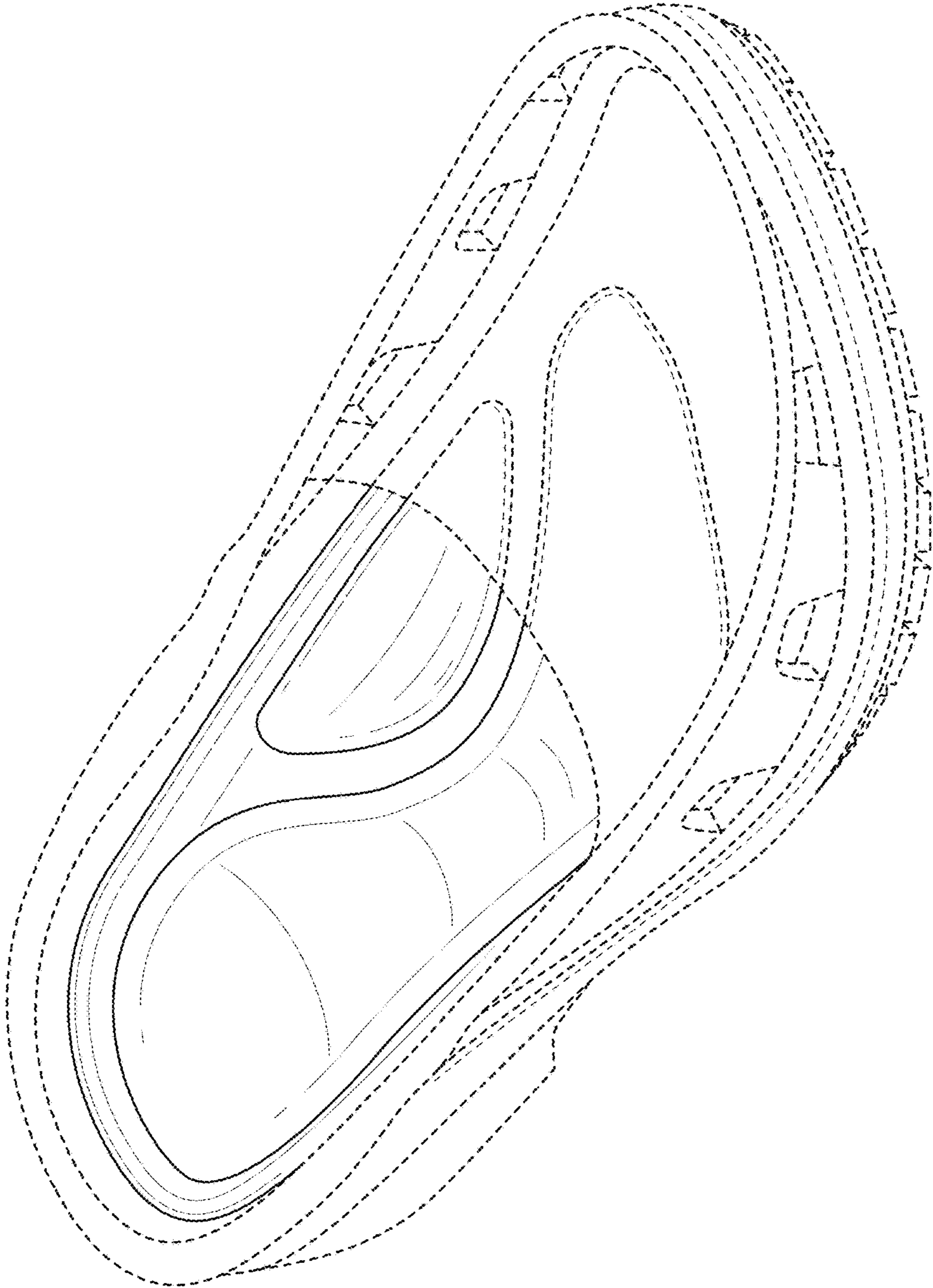

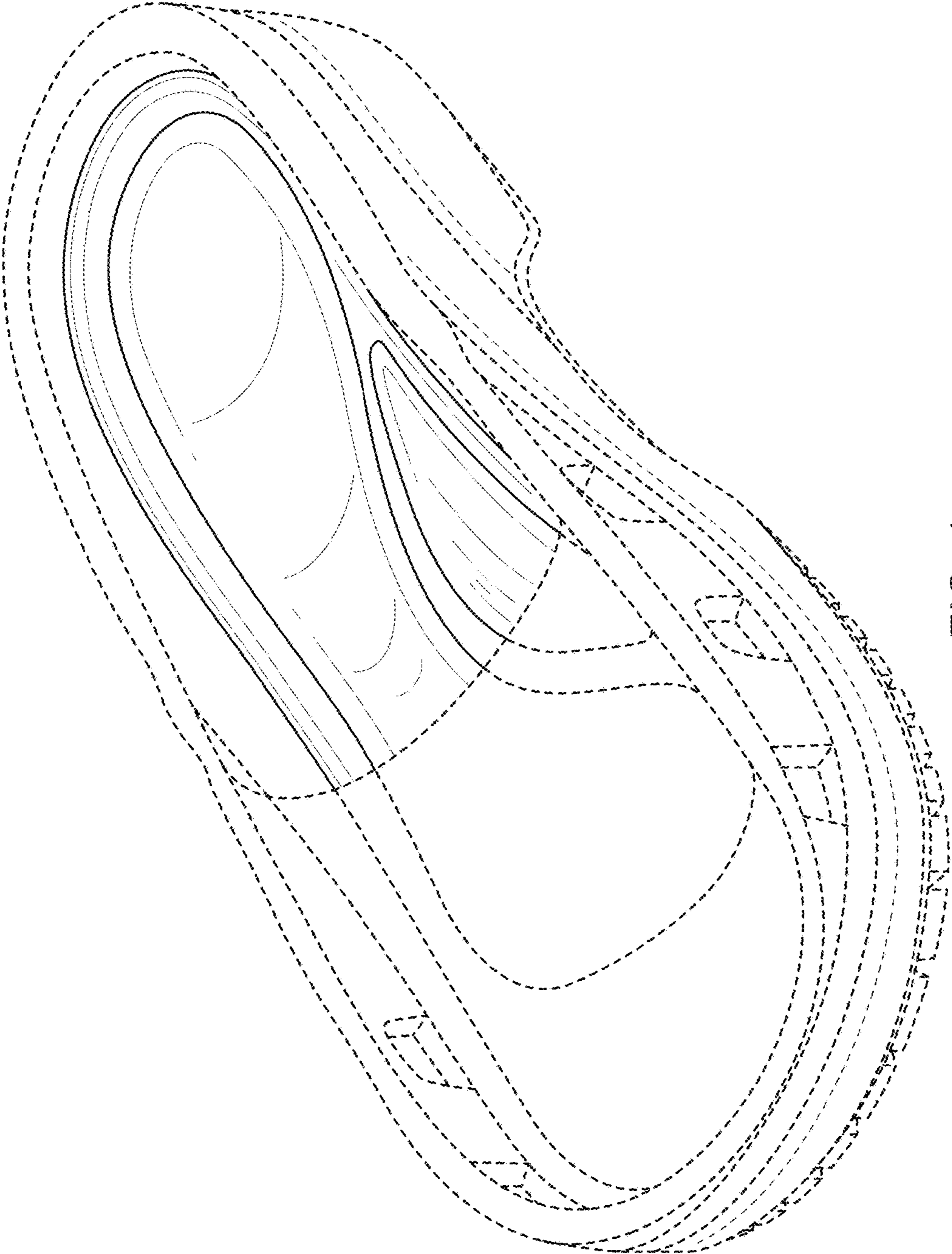
