DESCRIPTION

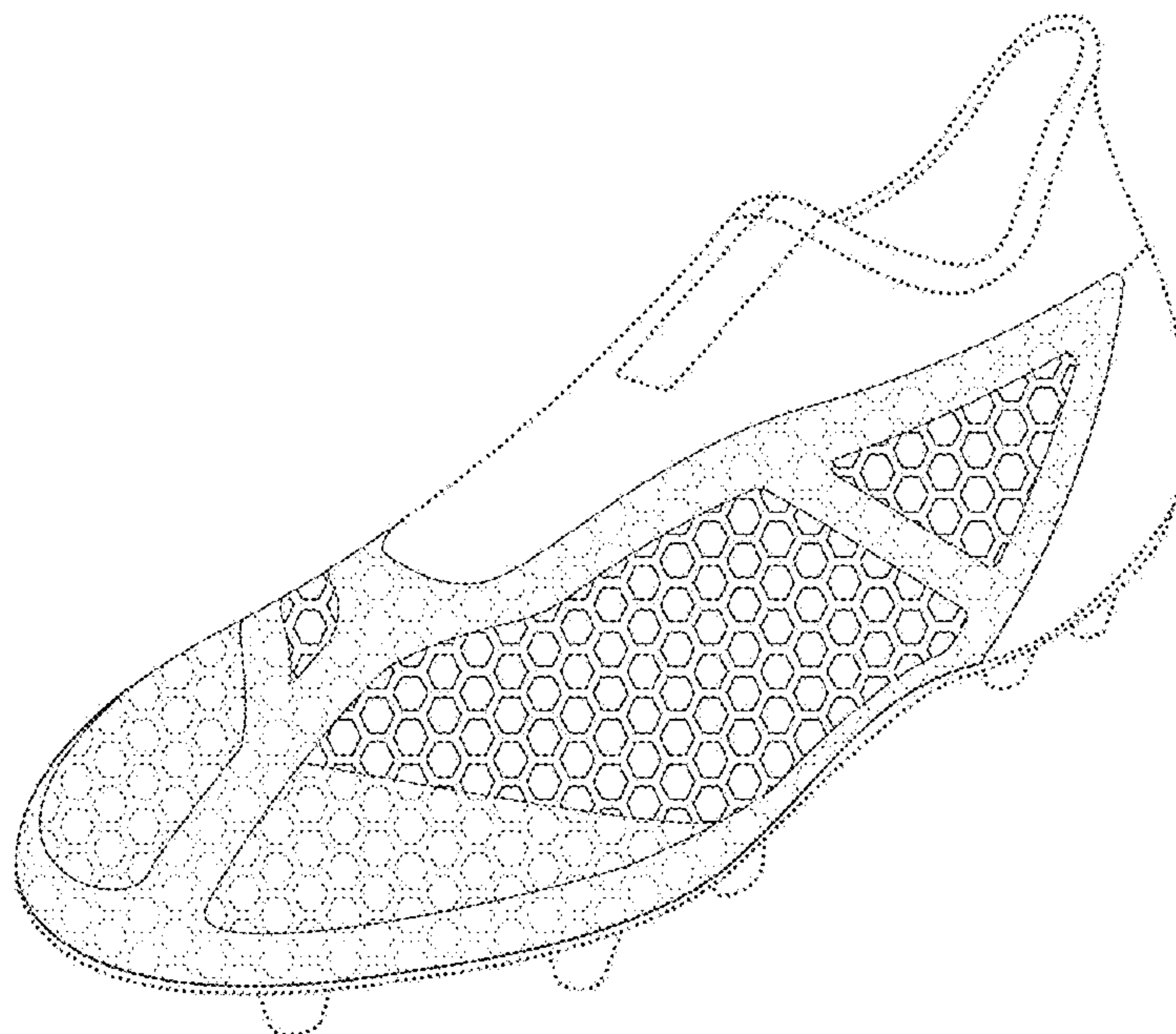
FIG. 1 is a top right front perspective view of the shoe upper showing my new design;

 Any broken lines in the drawings indicate portions which form no part of the claimed design.

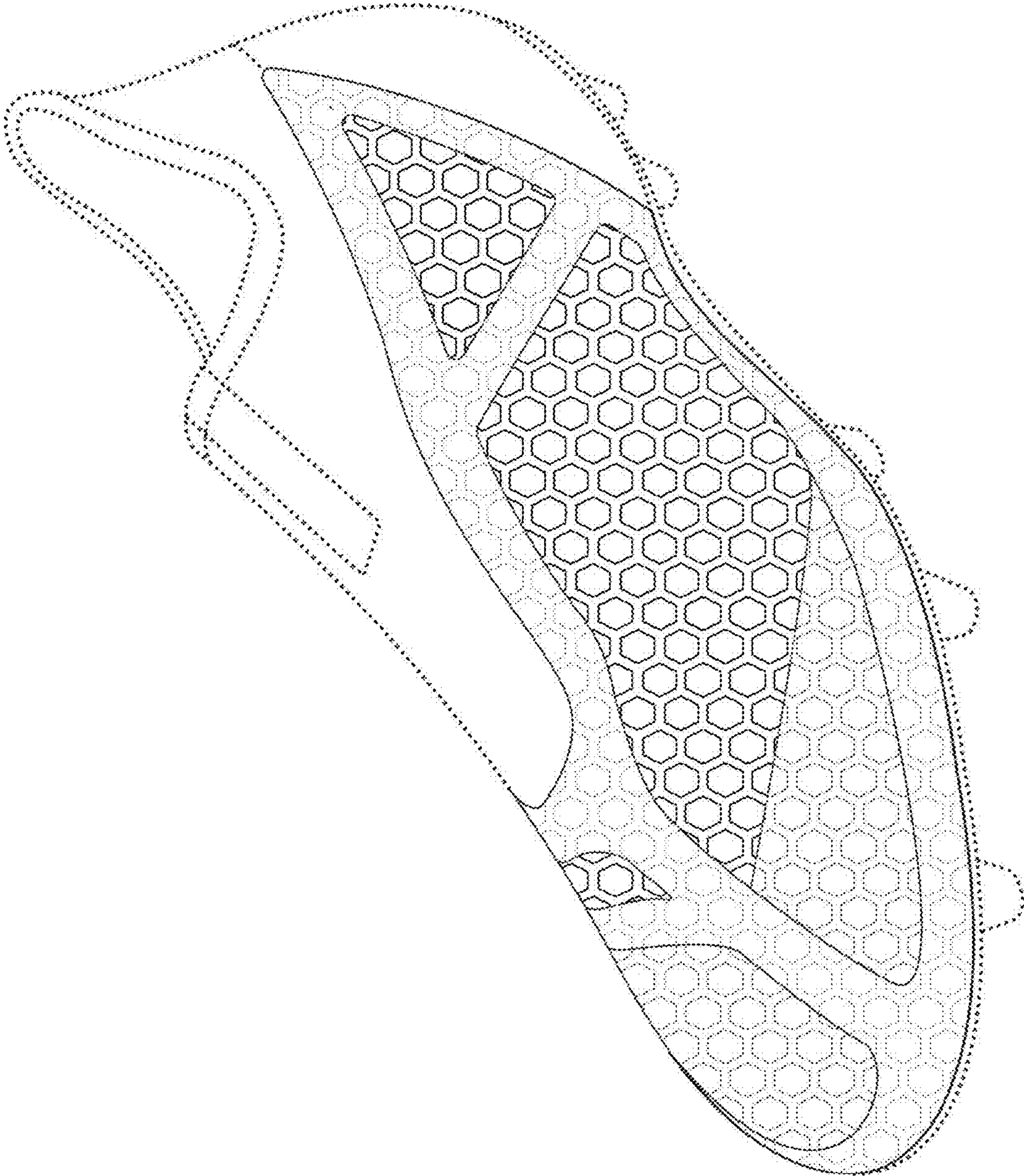

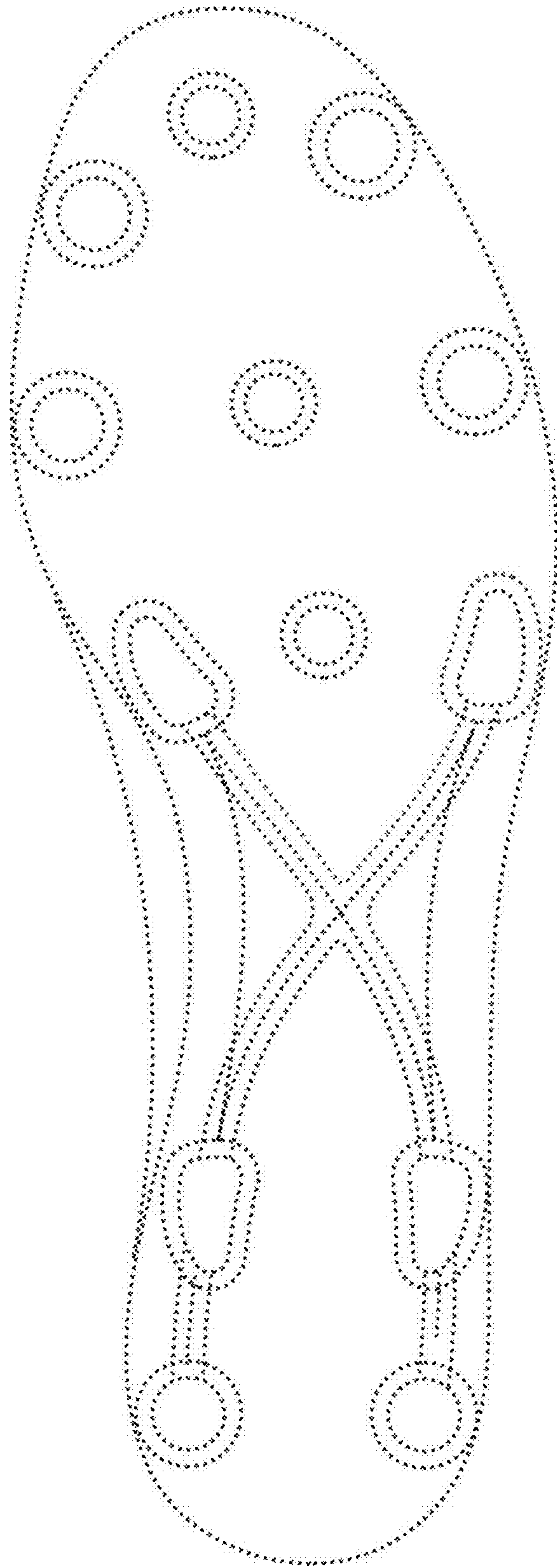

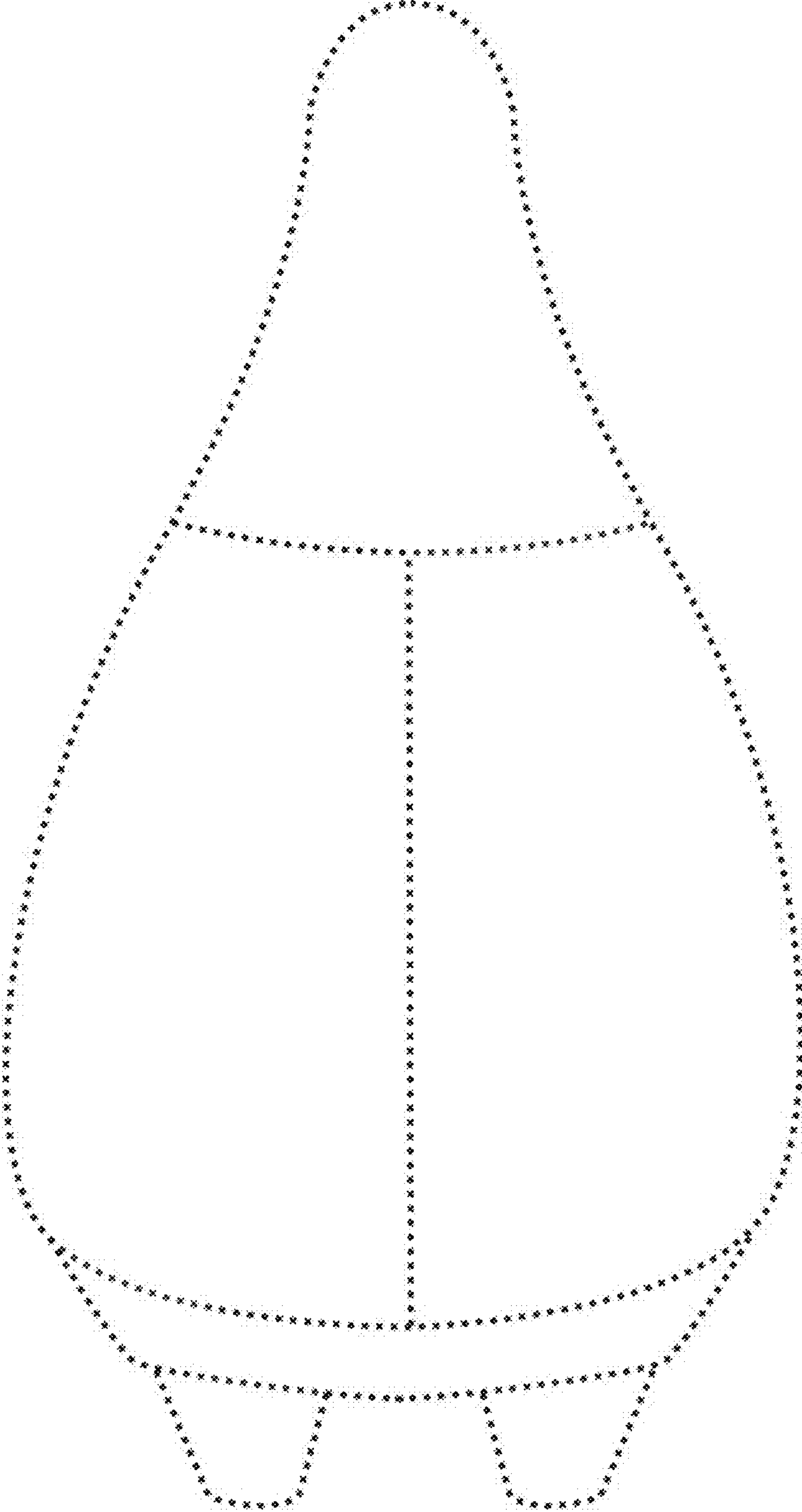

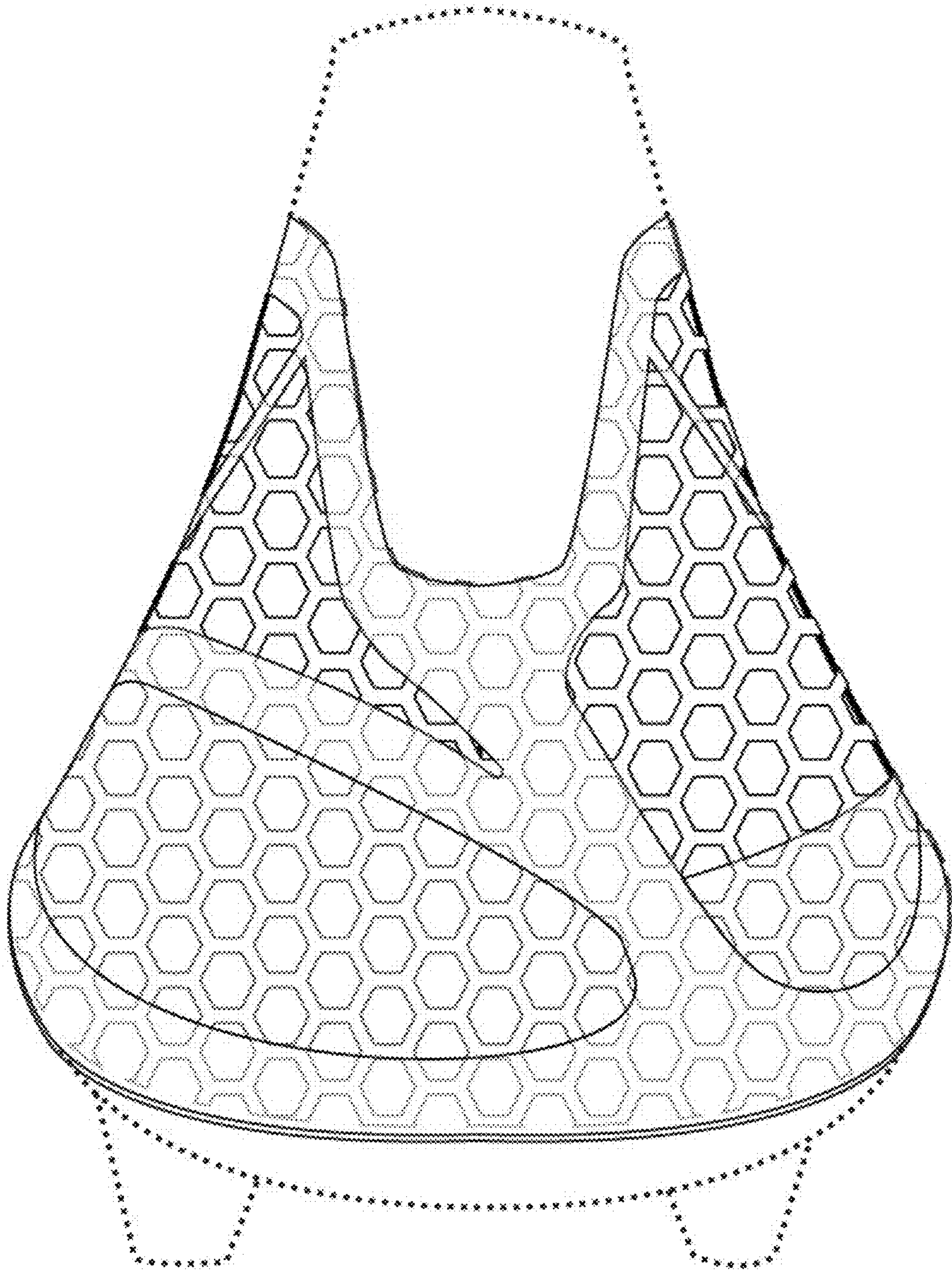

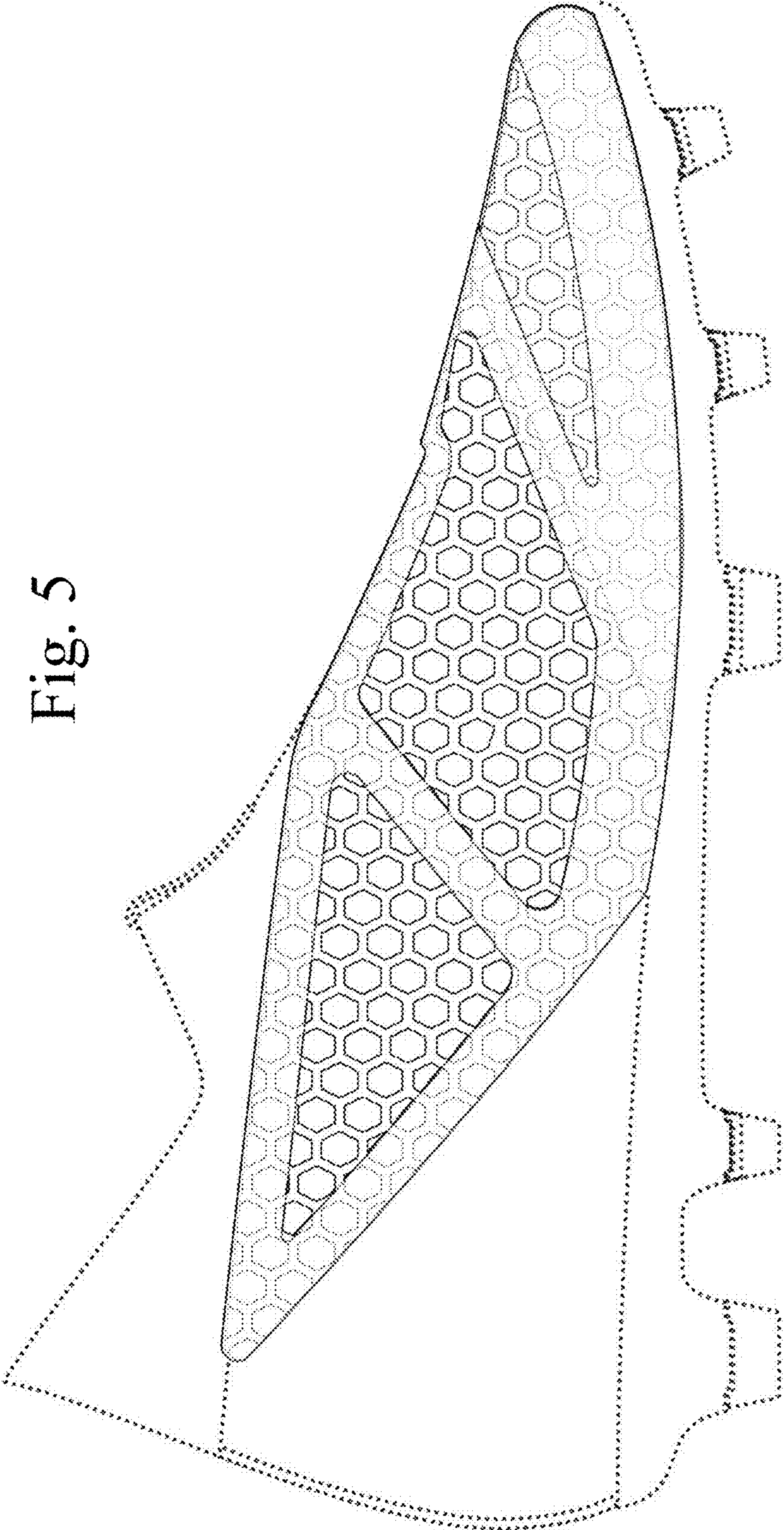
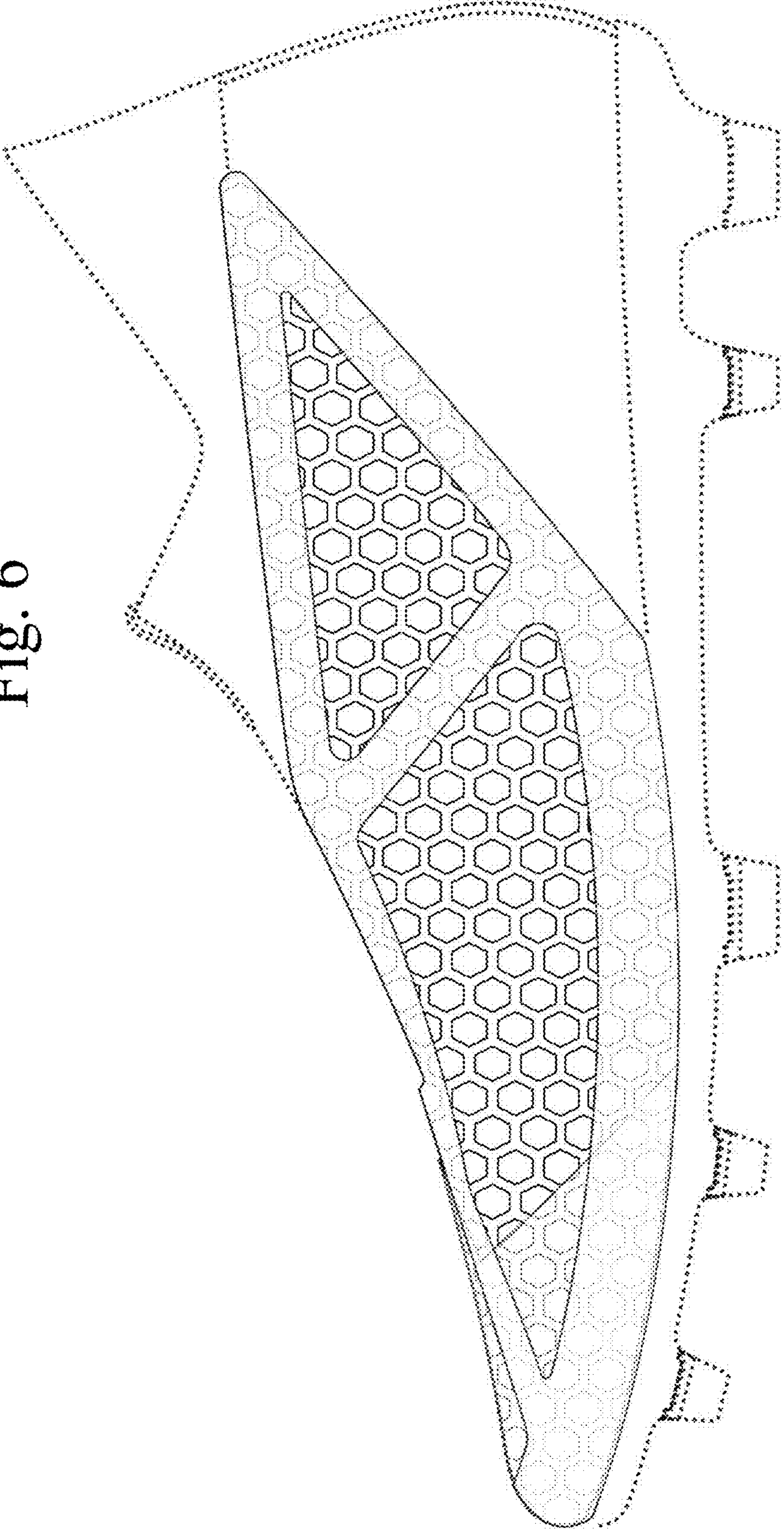

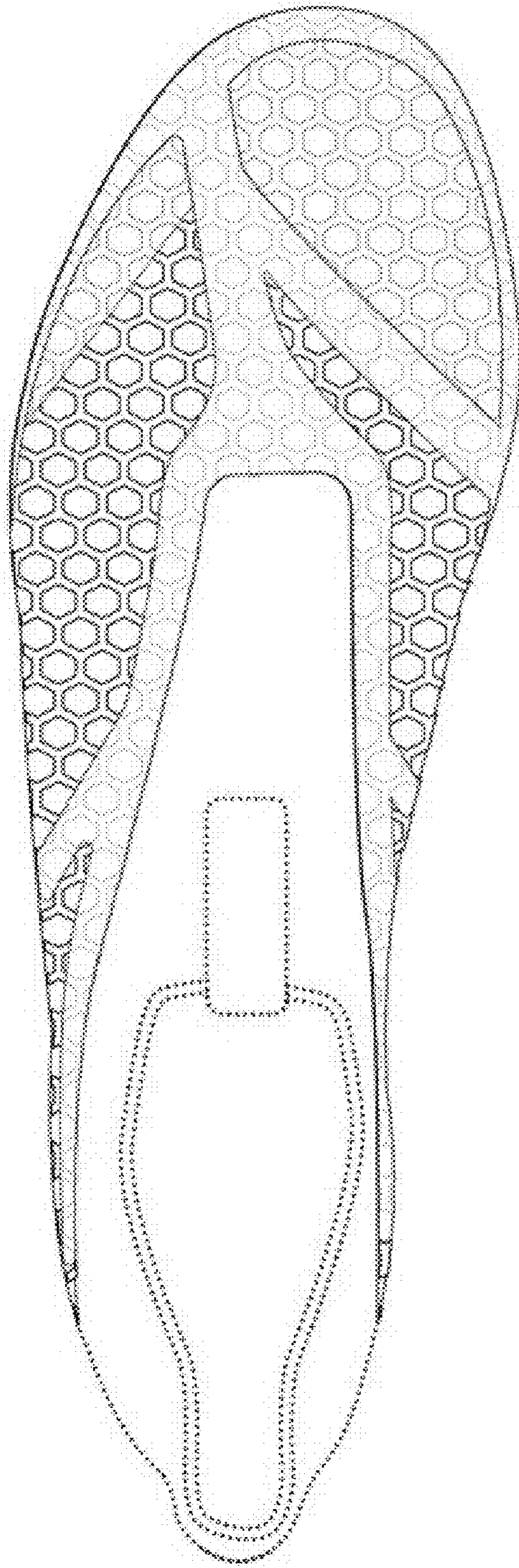
