(57) **CLAIM**

The ornamental design for a hanging chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hanging chair showing a first embodiment of the new design.

FIG. 2 is a front view of the hanging chair of FIG. 1.

FIG. 3 is a rear view of the hanging chair of FIG. 1.

FIG. 4 is a right side view of the hanging chair of FIG. 1.

FIG. 5 is a left side view of the hanging chair of FIG. 1.

FIG. 6 is a top view of the hanging chair of FIG. 1.

FIG. 7 is a bottom view of the hanging chair of FIG. 1.

FIG. 8 is a perspective view of a hanging chair showing a second embodiment of the new design.

FIG. 9 is a front view of the hanging chair of FIG. 8.

FIG. 10 is a rear view of the hanging chair of FIG. 8.

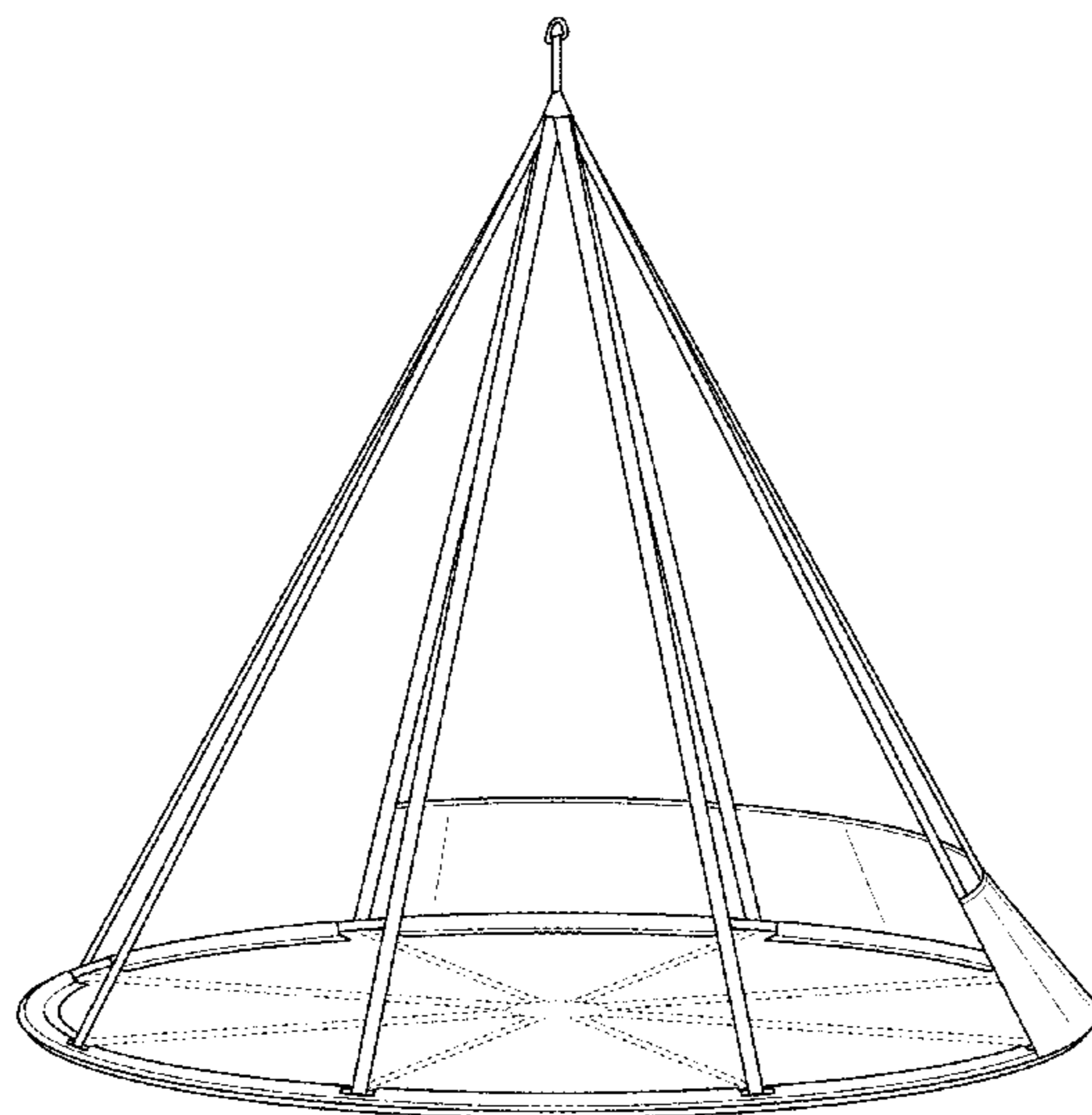
FIG. 11 is a right side view of the hanging chair of FIG. 8.

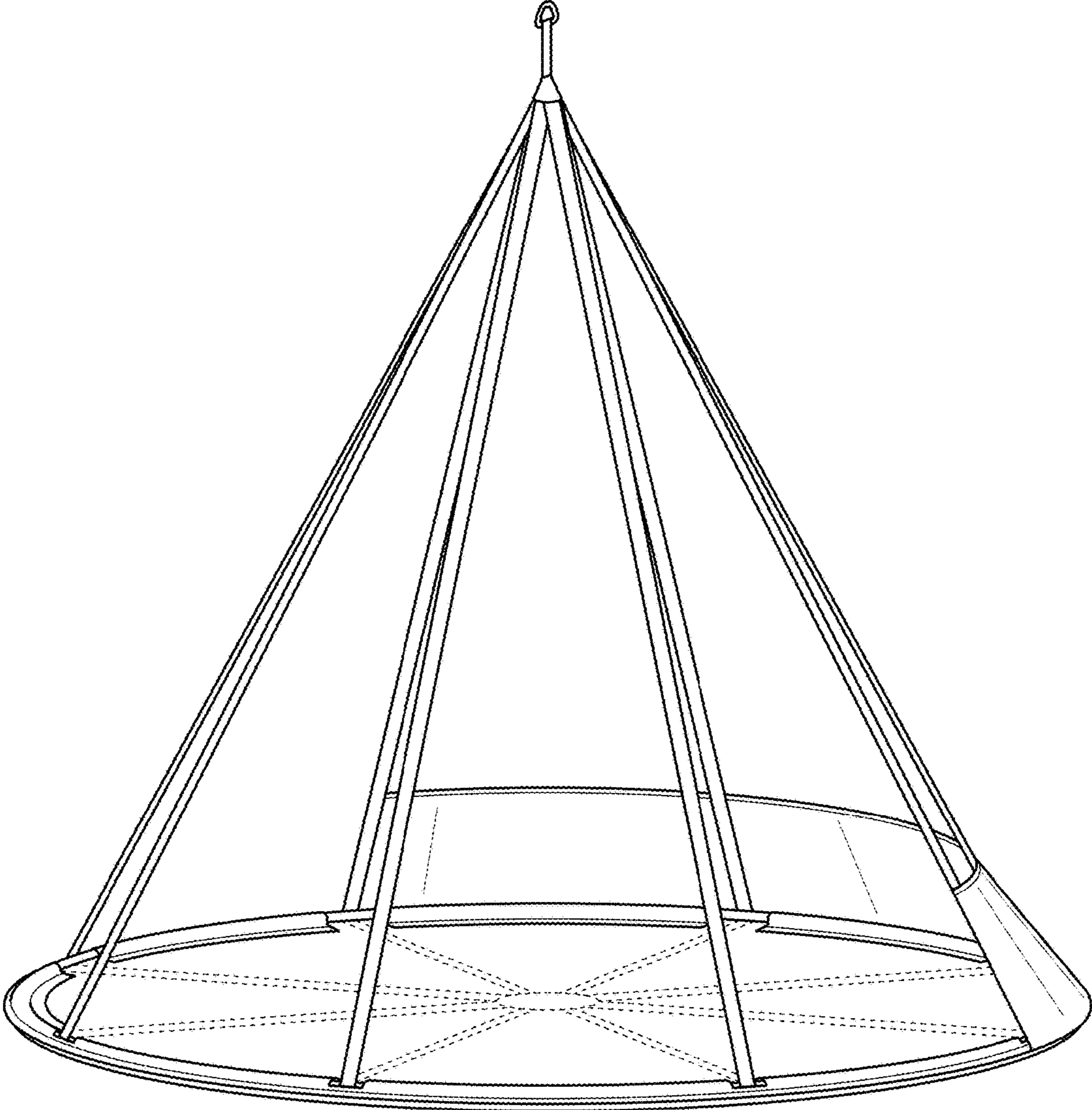

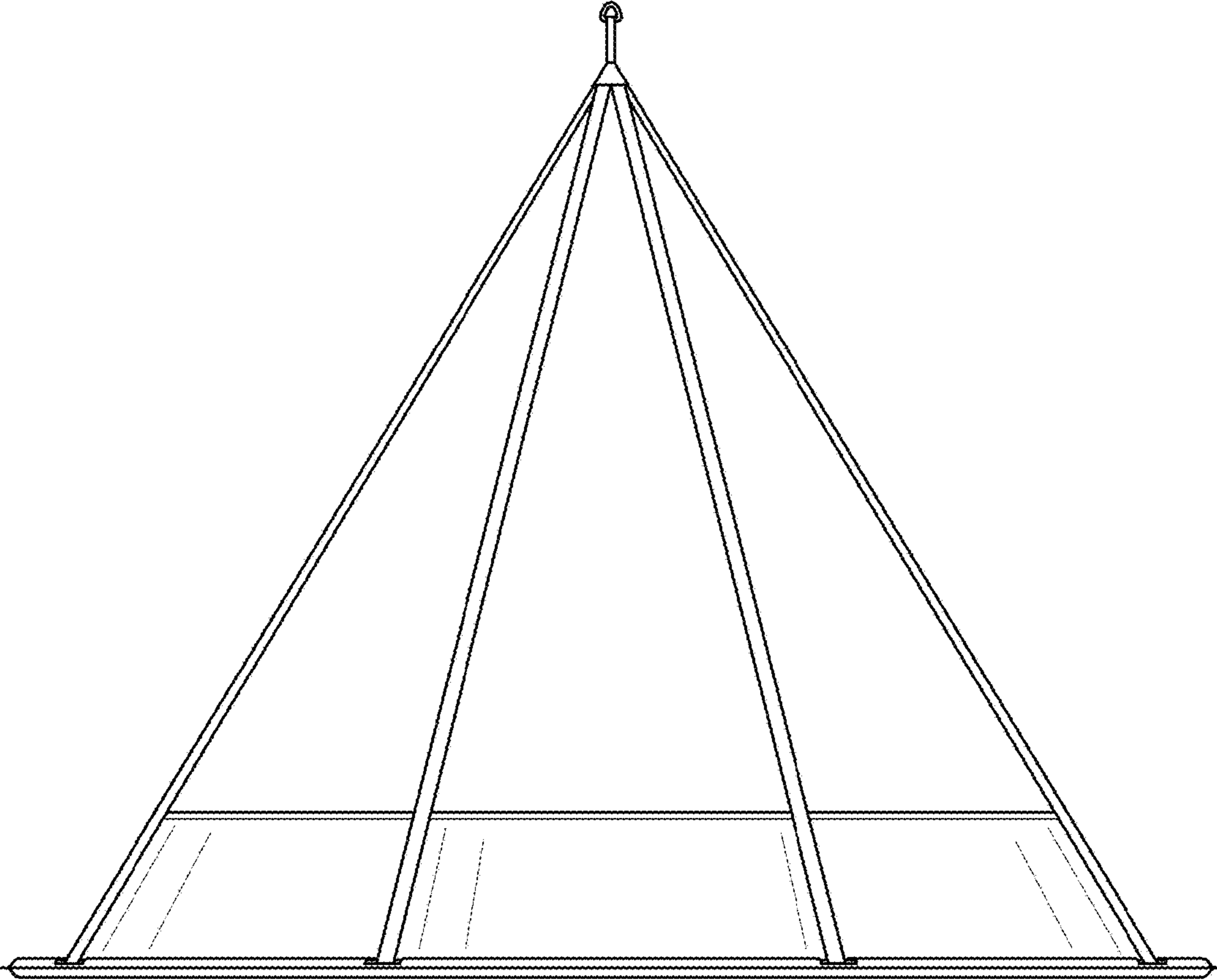

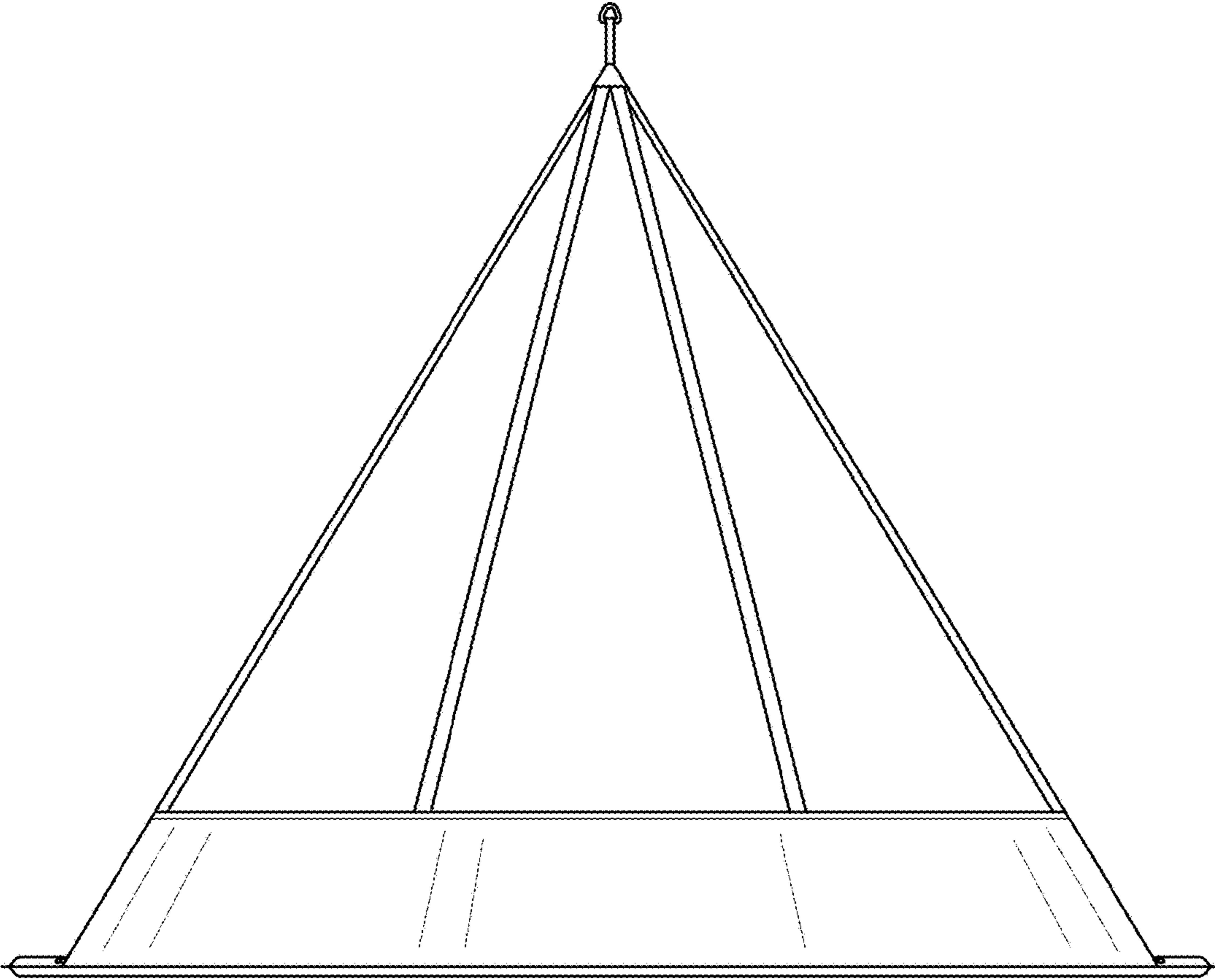

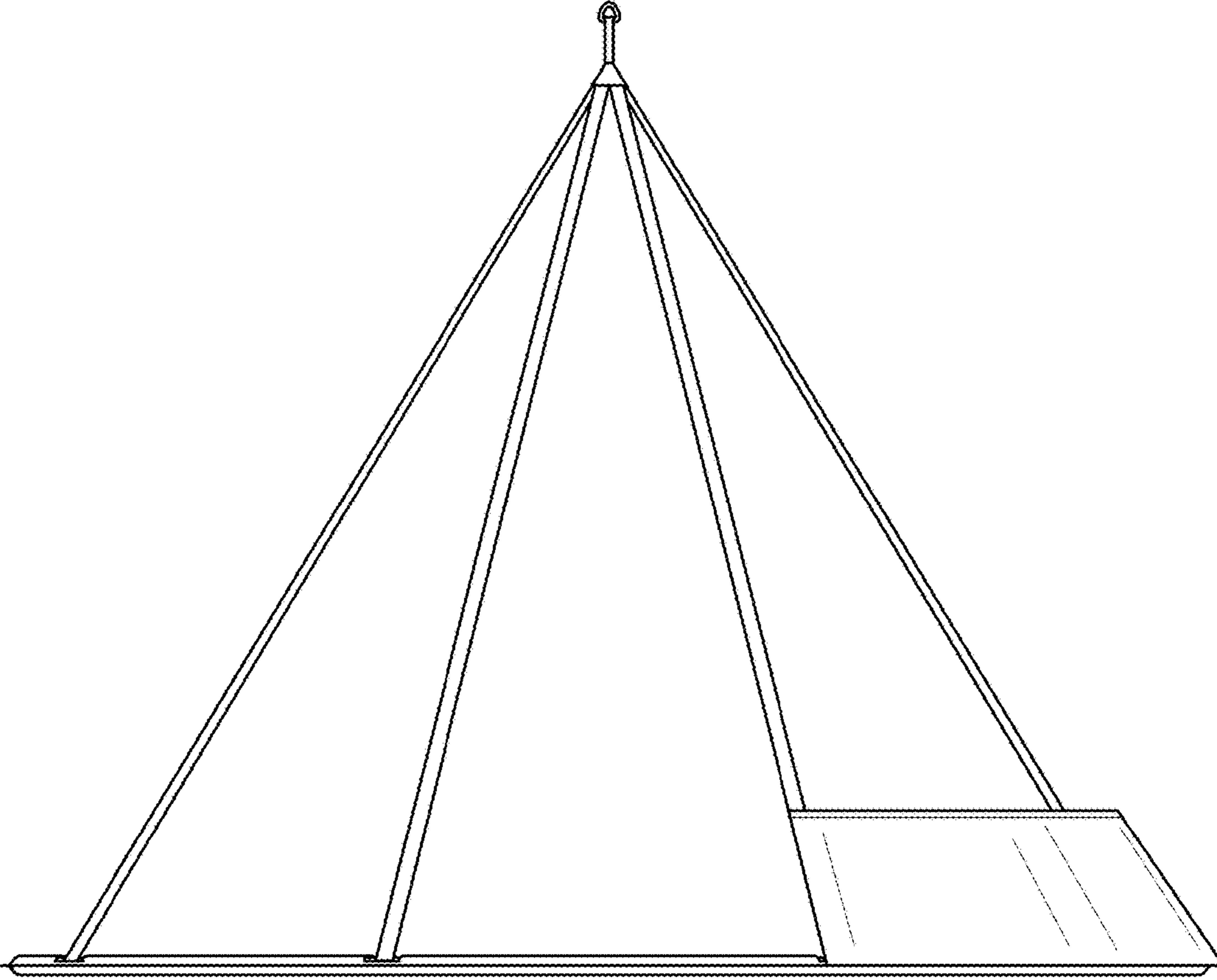

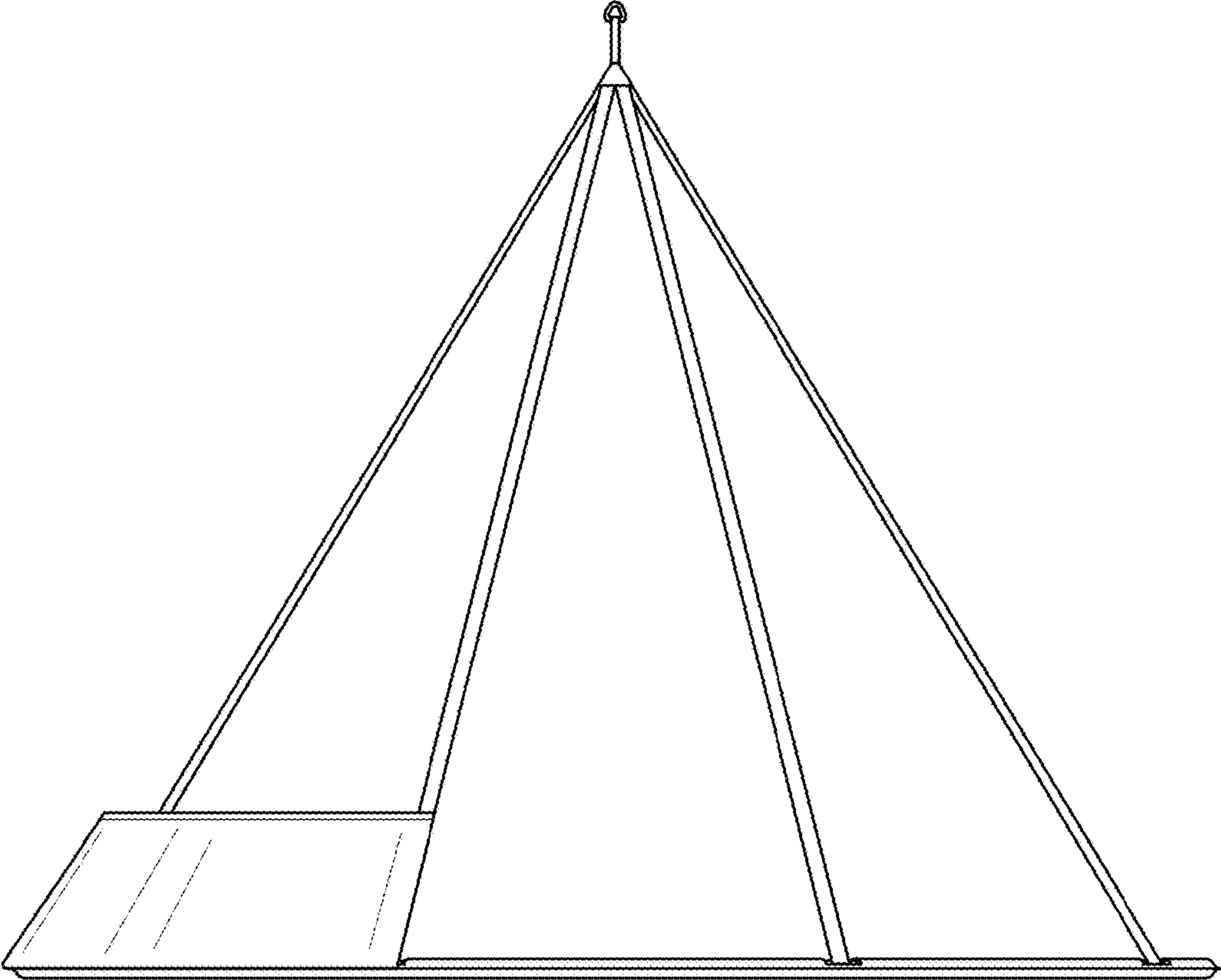

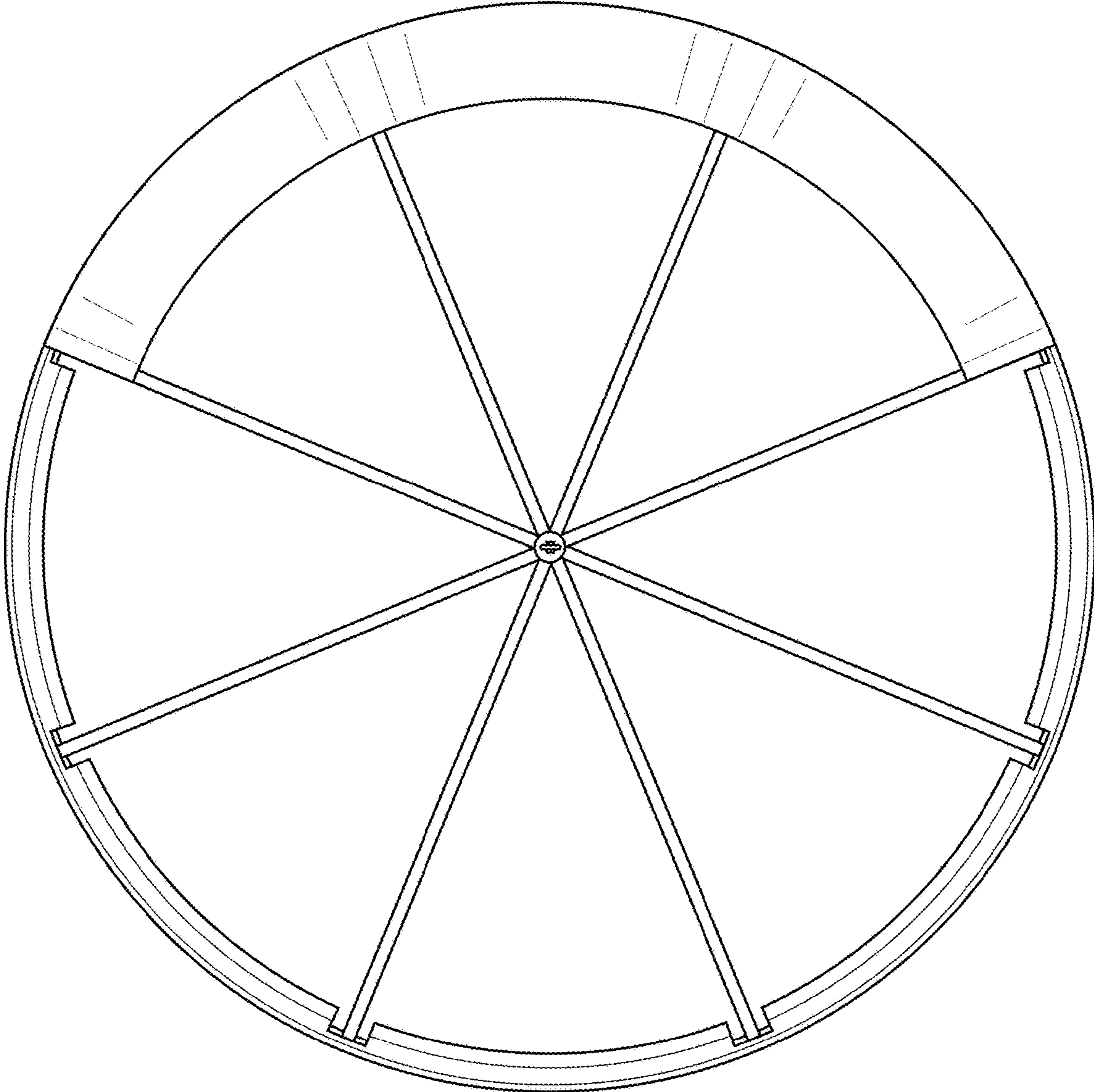

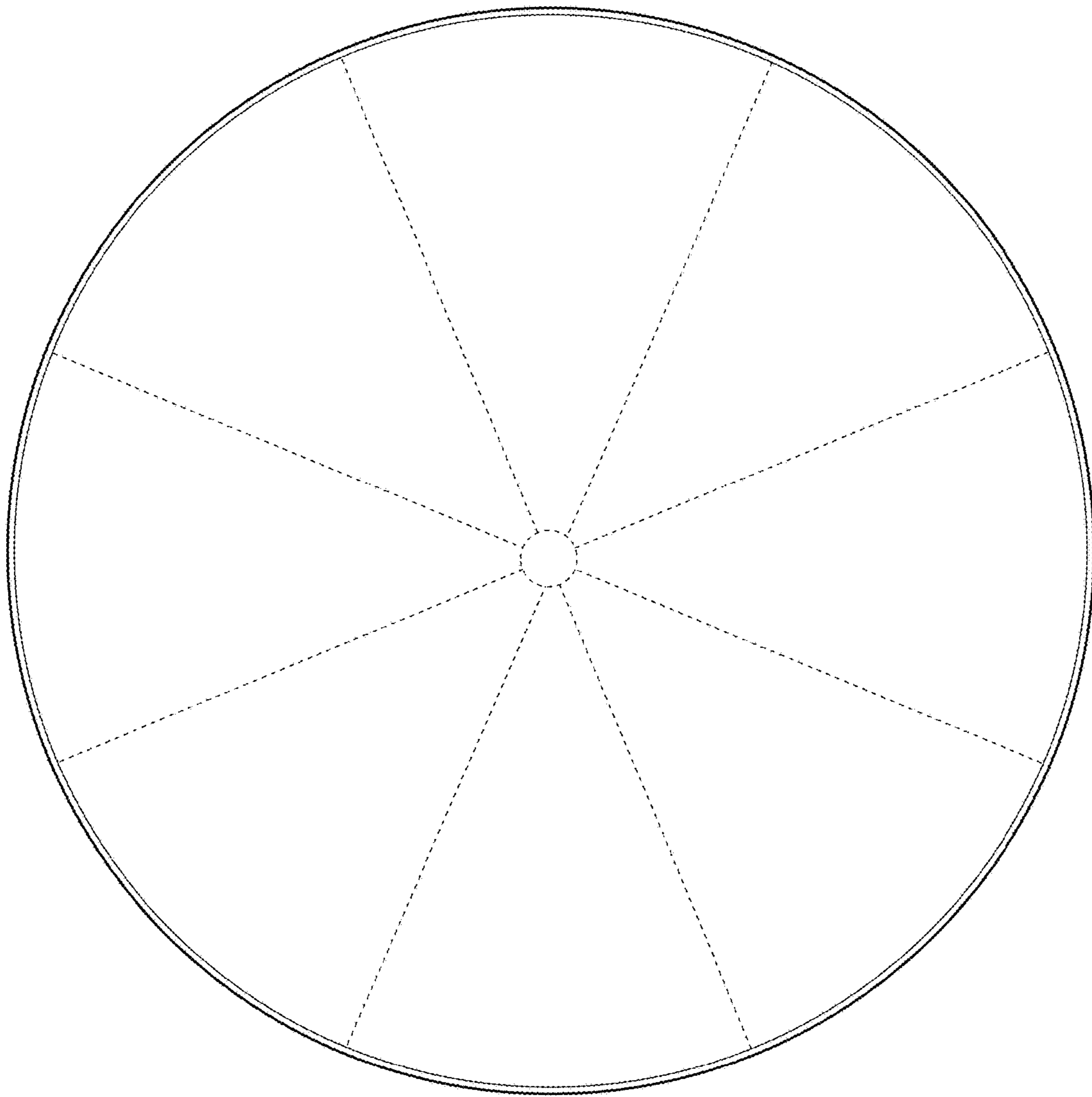

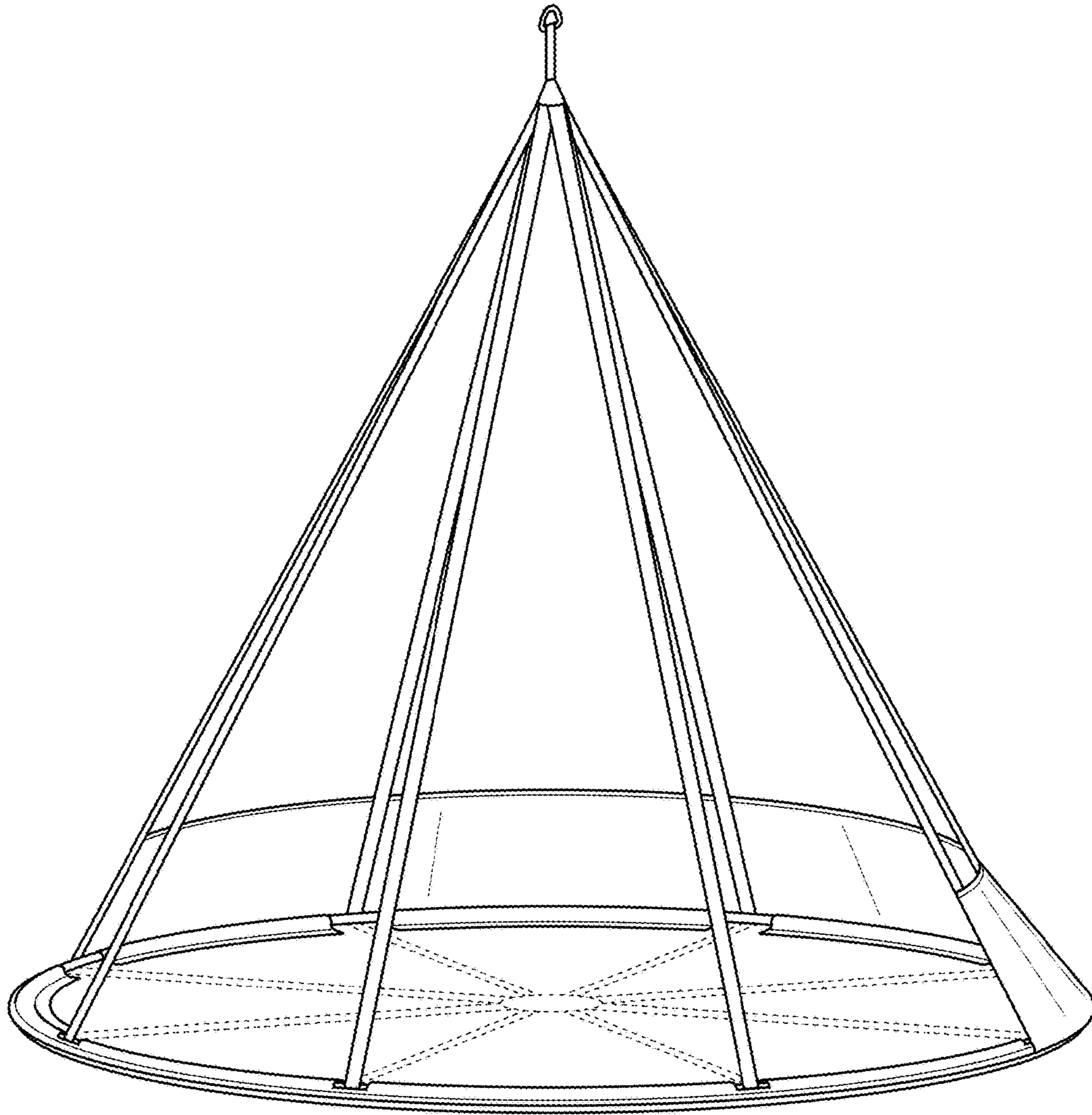

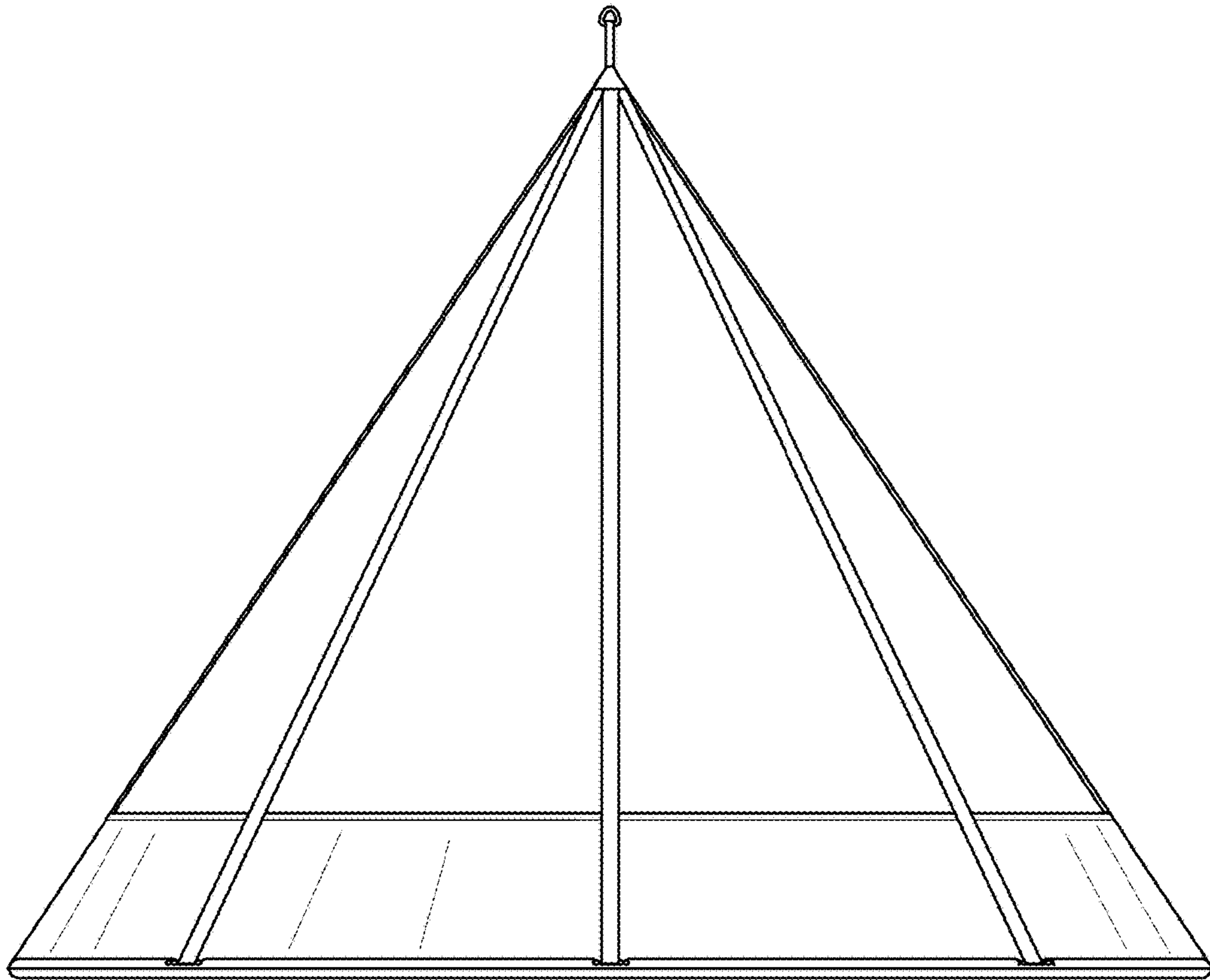

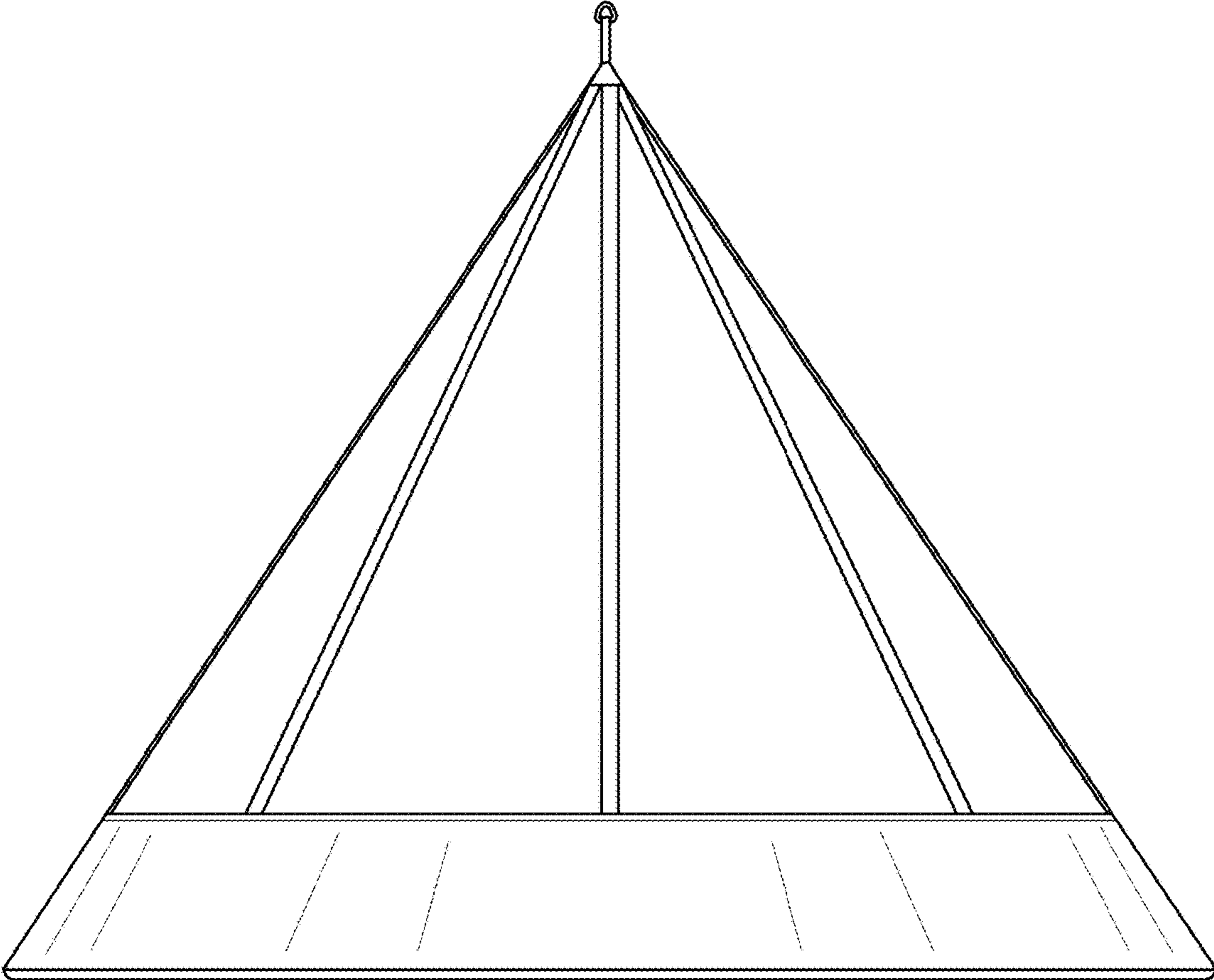

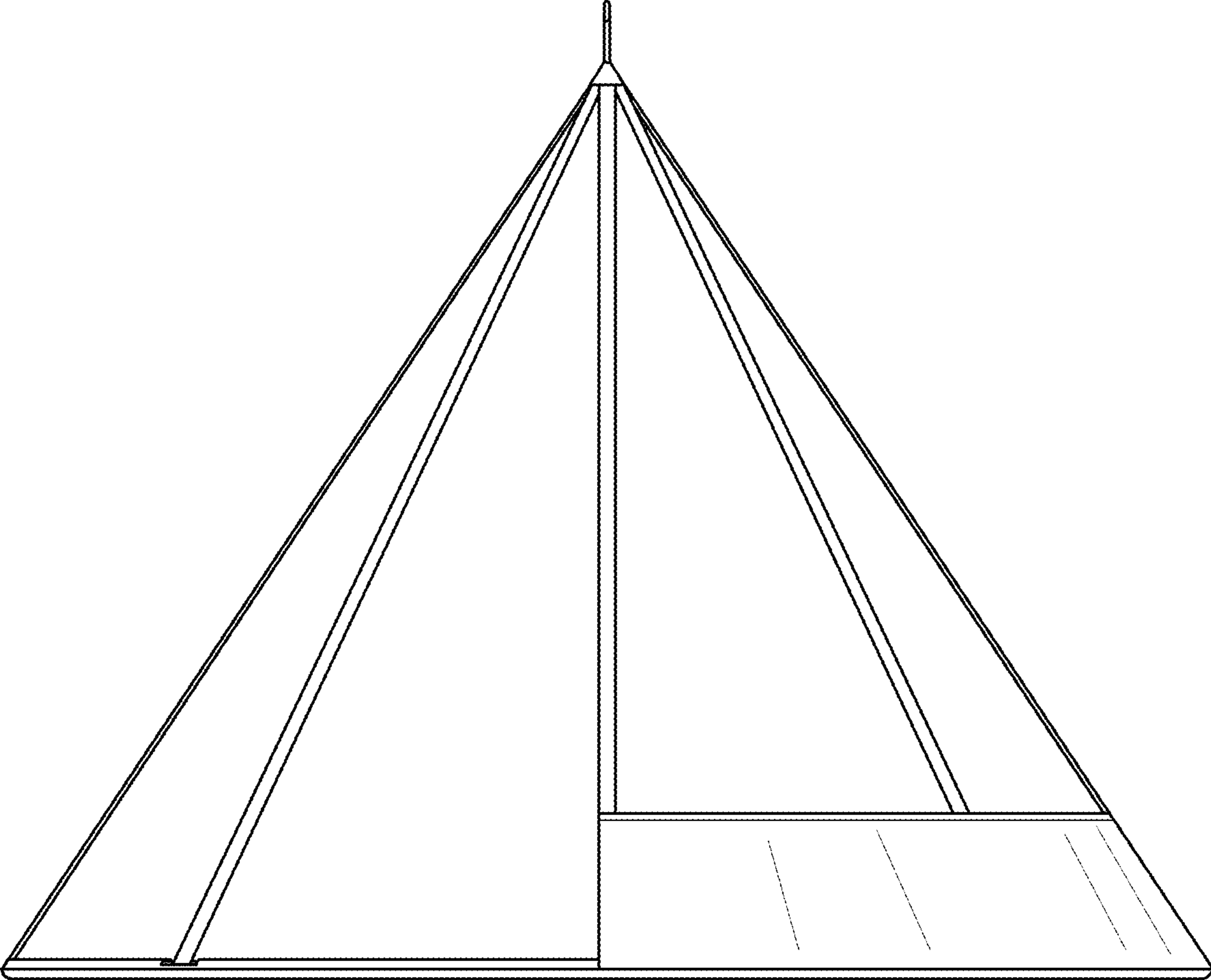

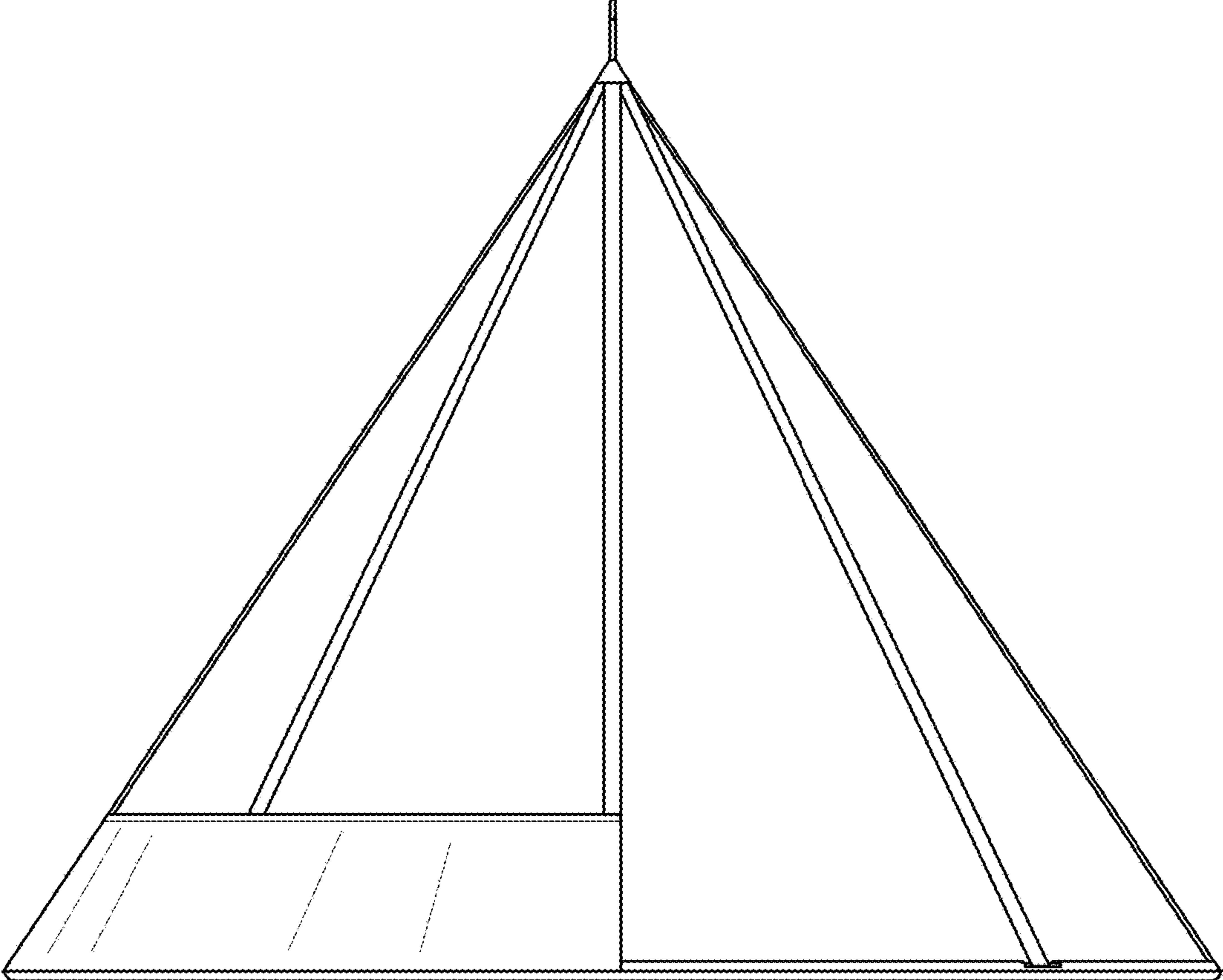

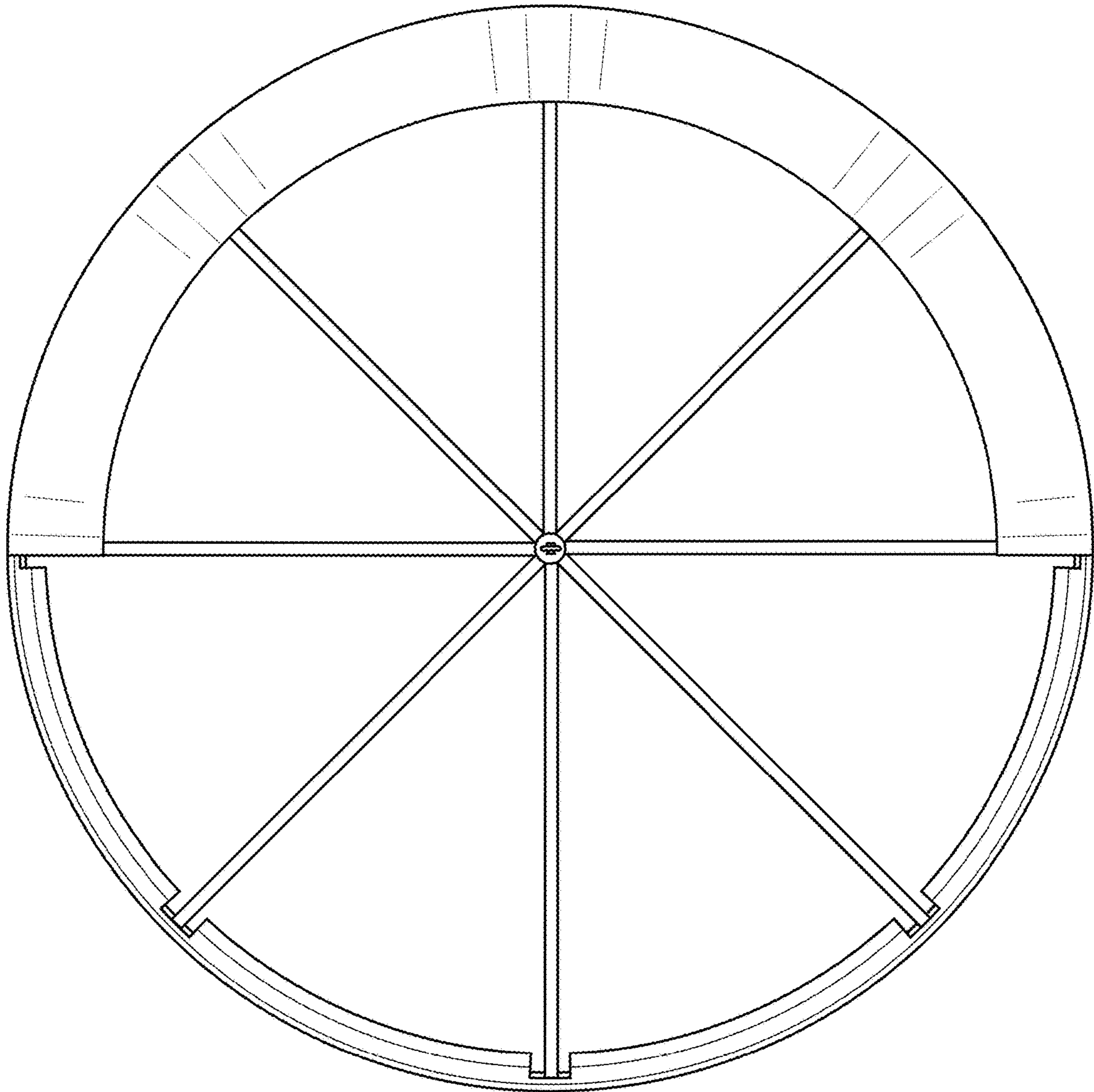

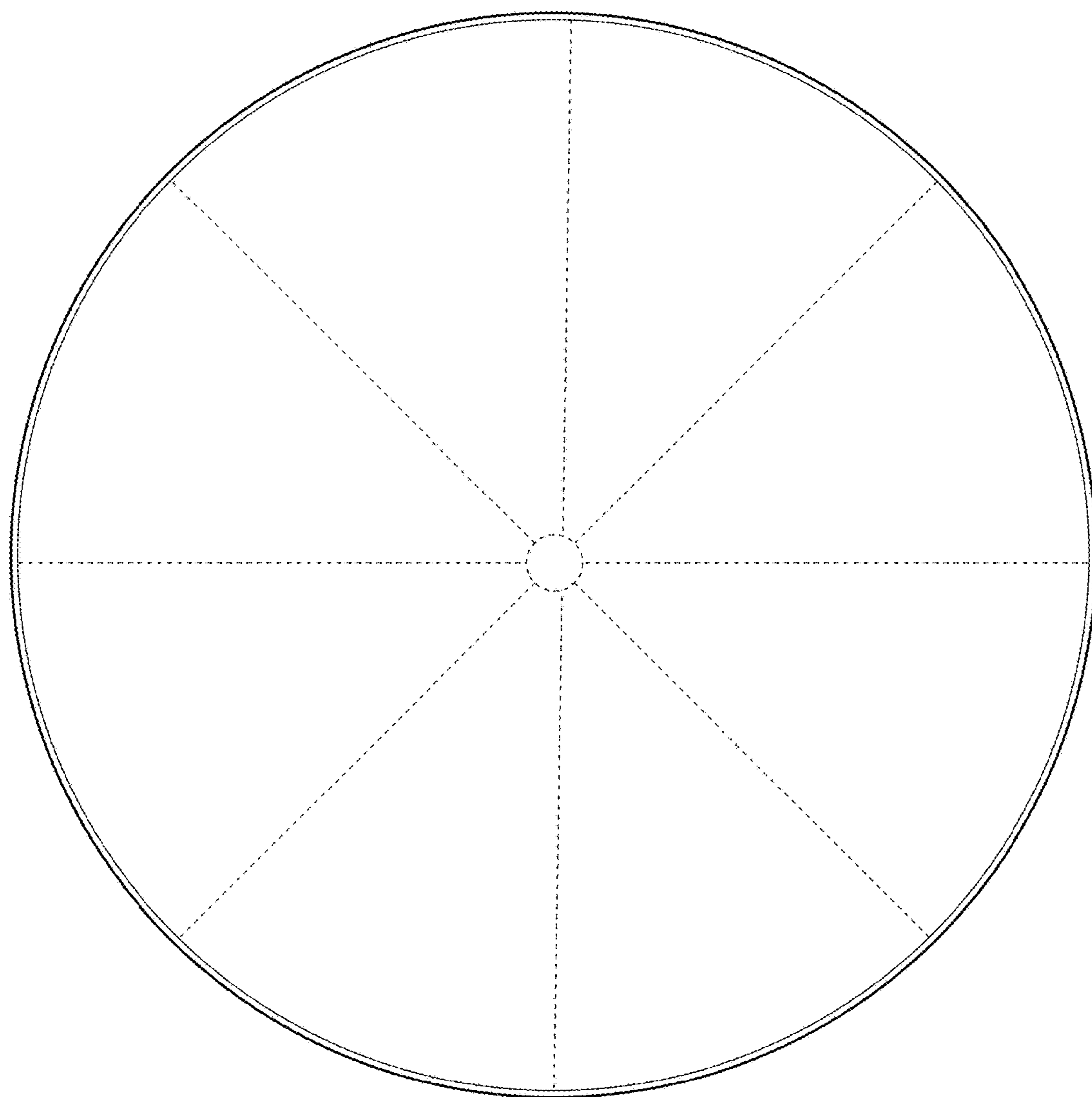
