The ornamental design for a pillow case, as shown and described.

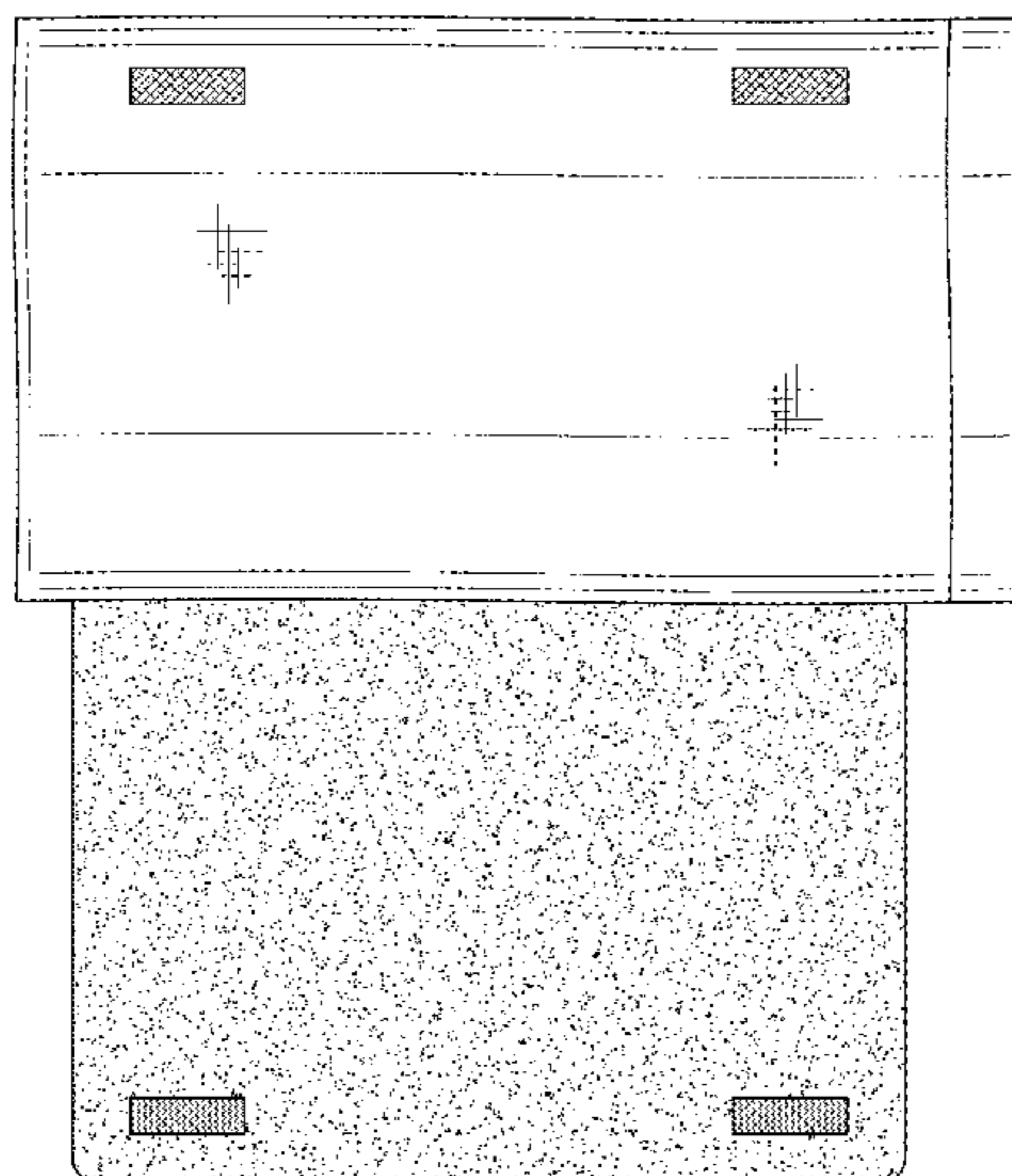
DESCRIPTION

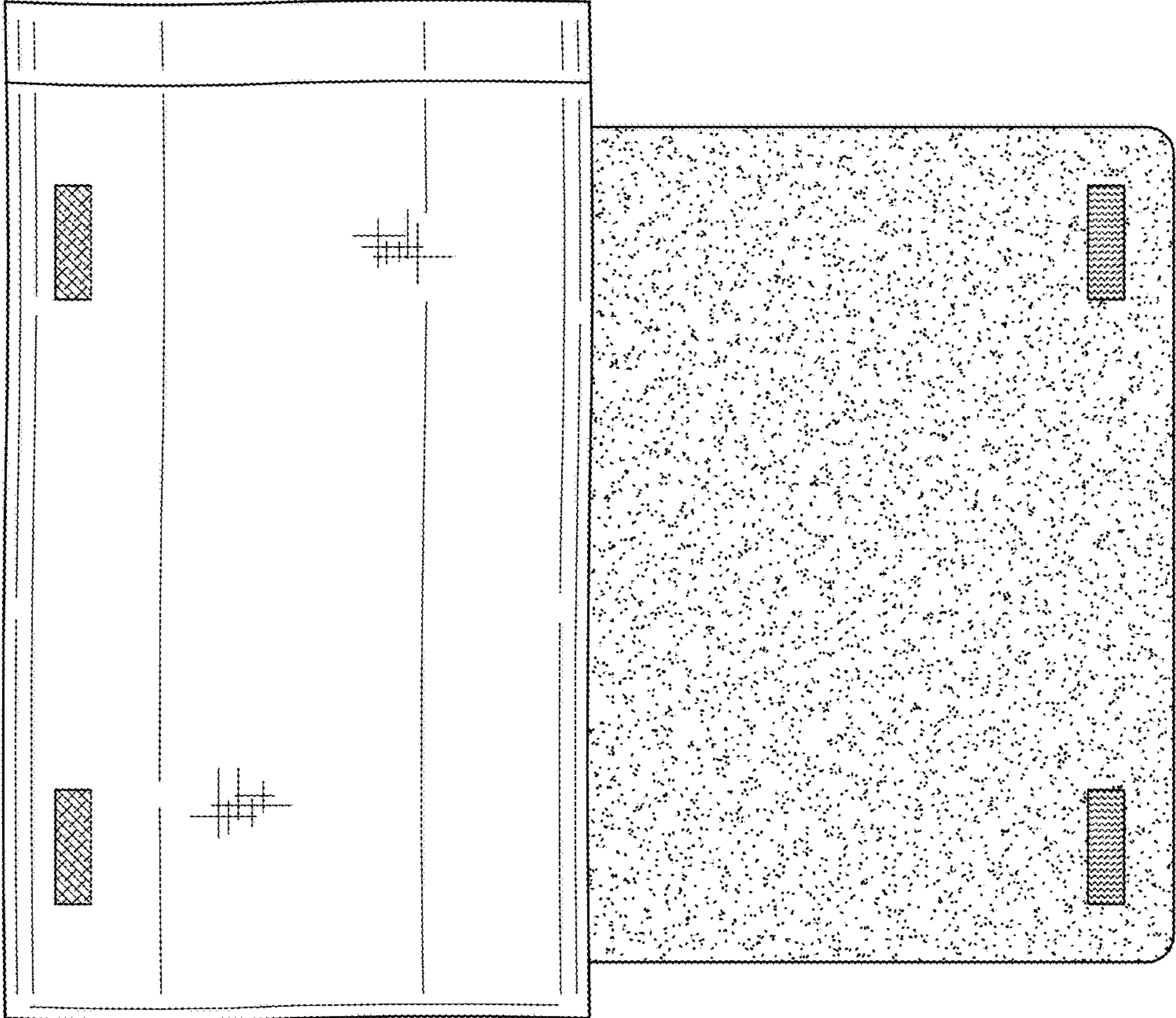

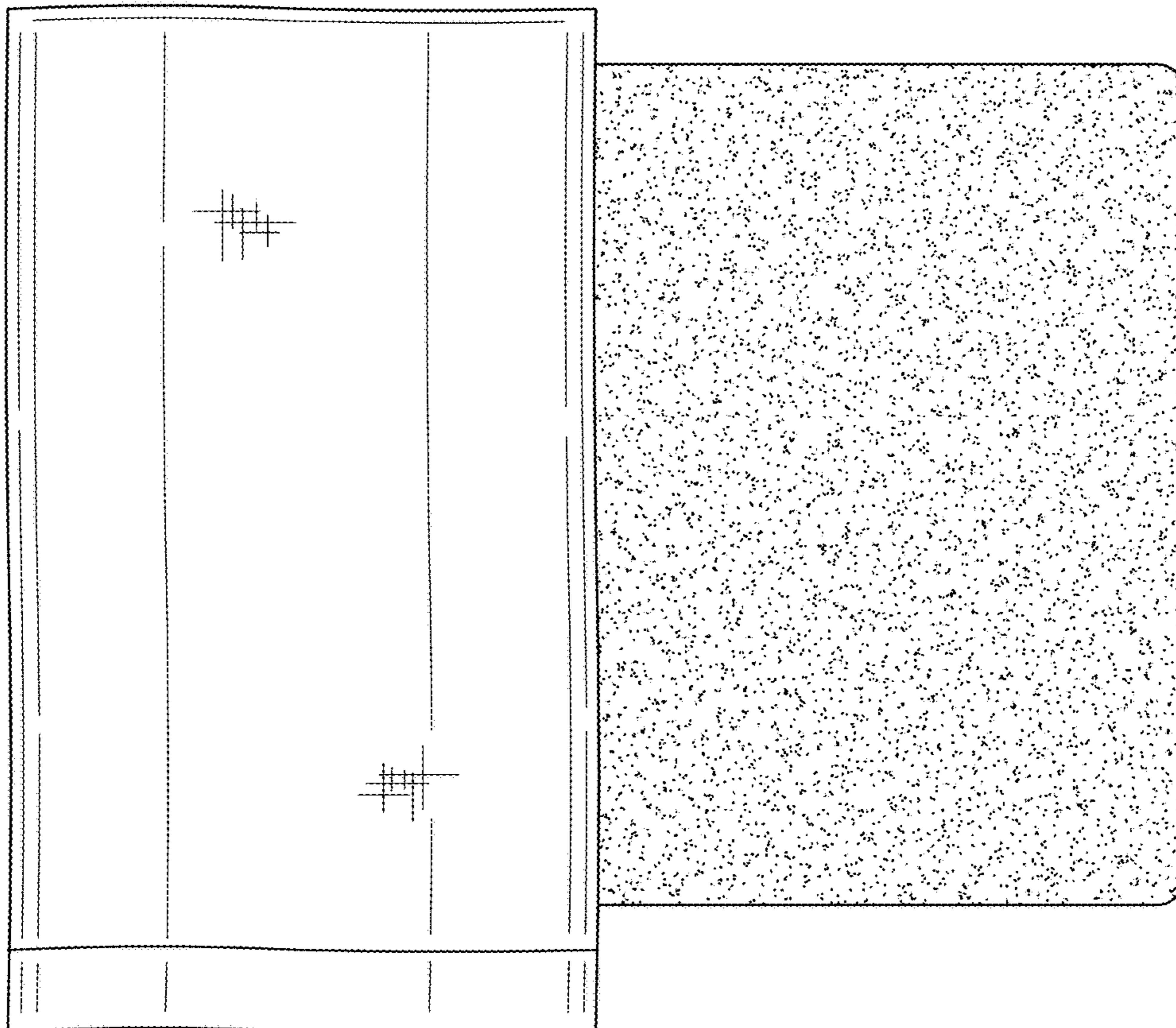

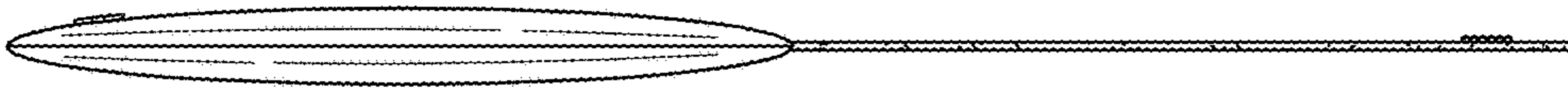

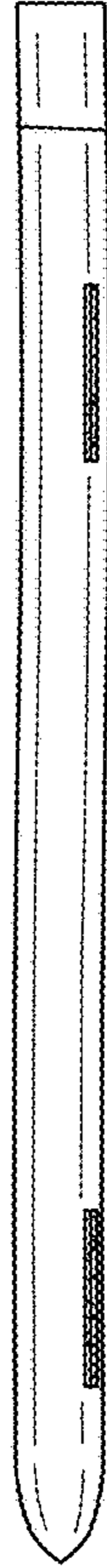
