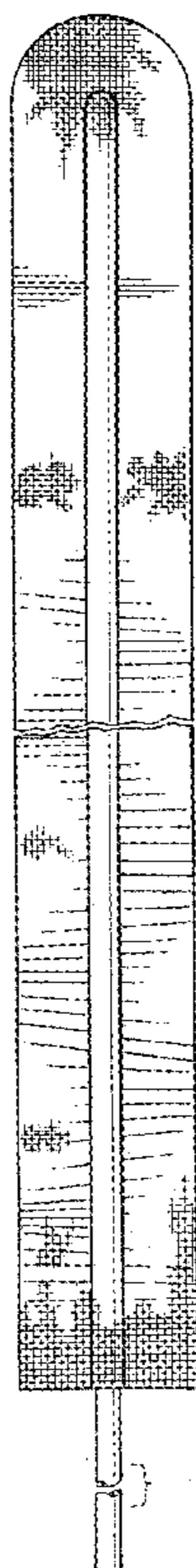
The ornamental design for a support for displaying items, as shown and described.

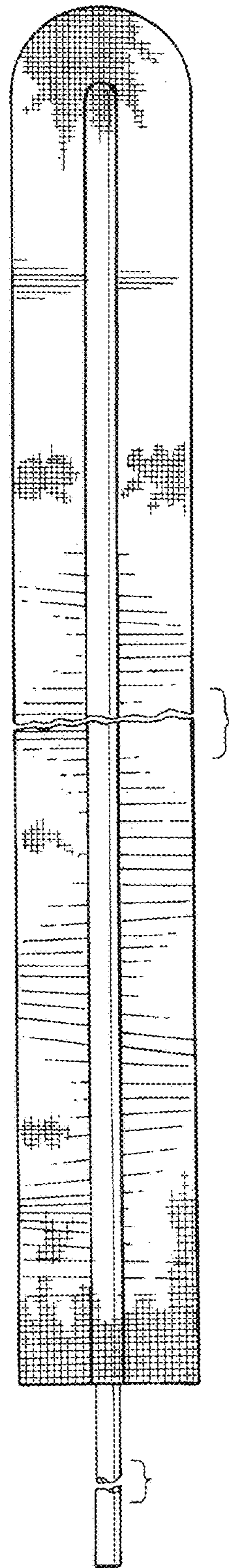
**DESCRIPTION**

FIG. 1 is a front elevation view of a support for displaying items showing our new design;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a left side elevation view thereof;  
 FIG. 4 is a right side elevation view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a top, front left side perspective view thereof; and,  
 FIG. 8 is an environmental view thereof.

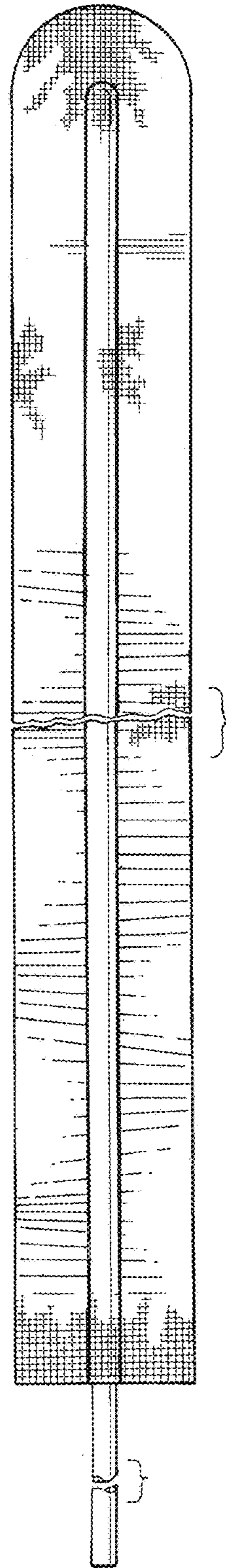

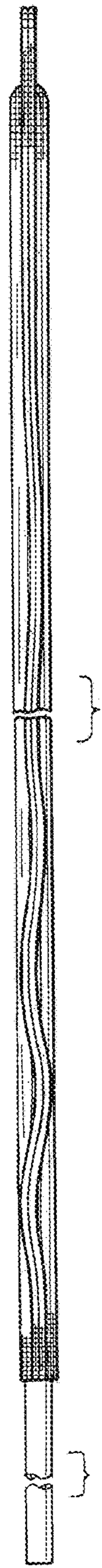

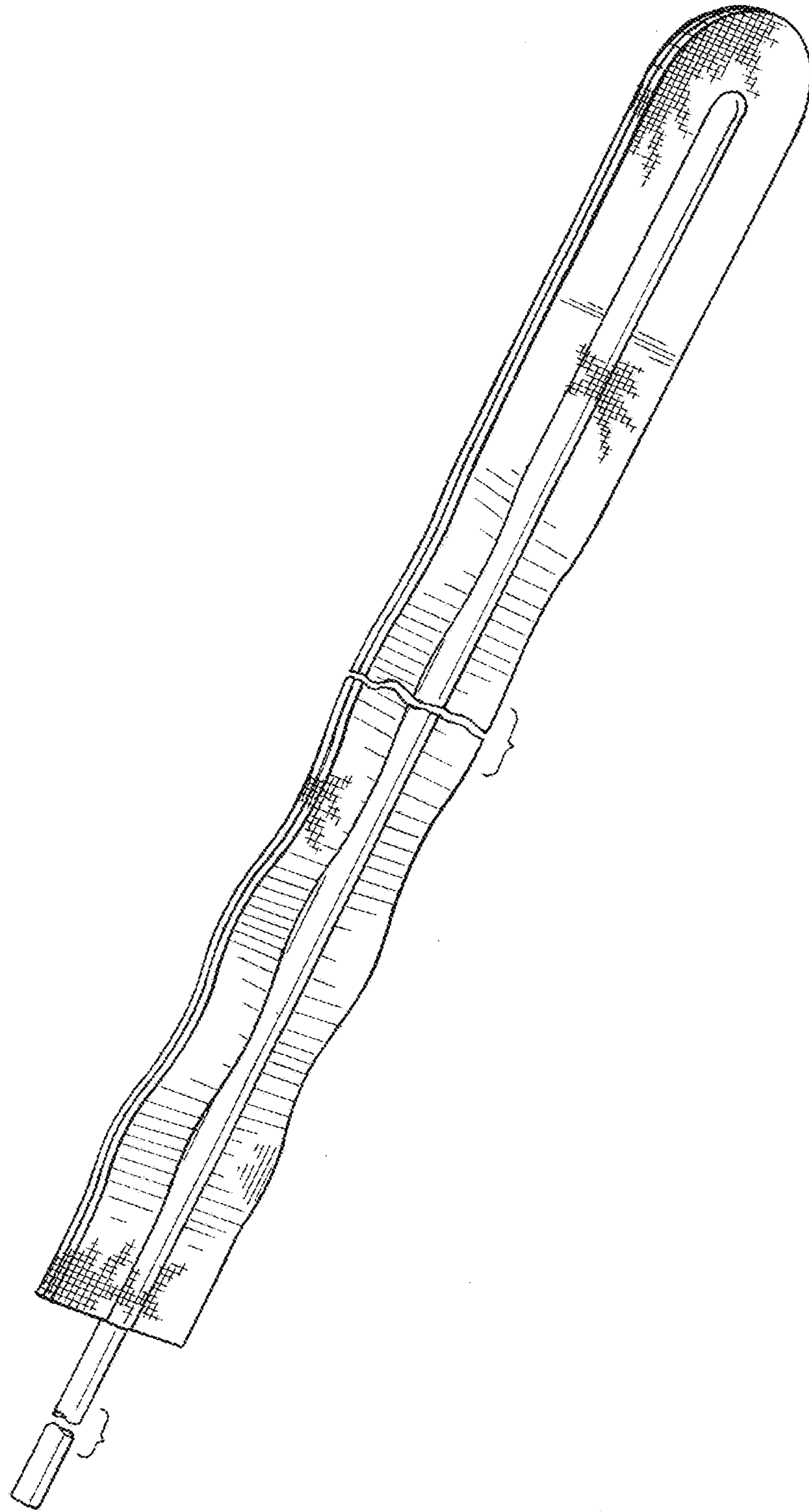

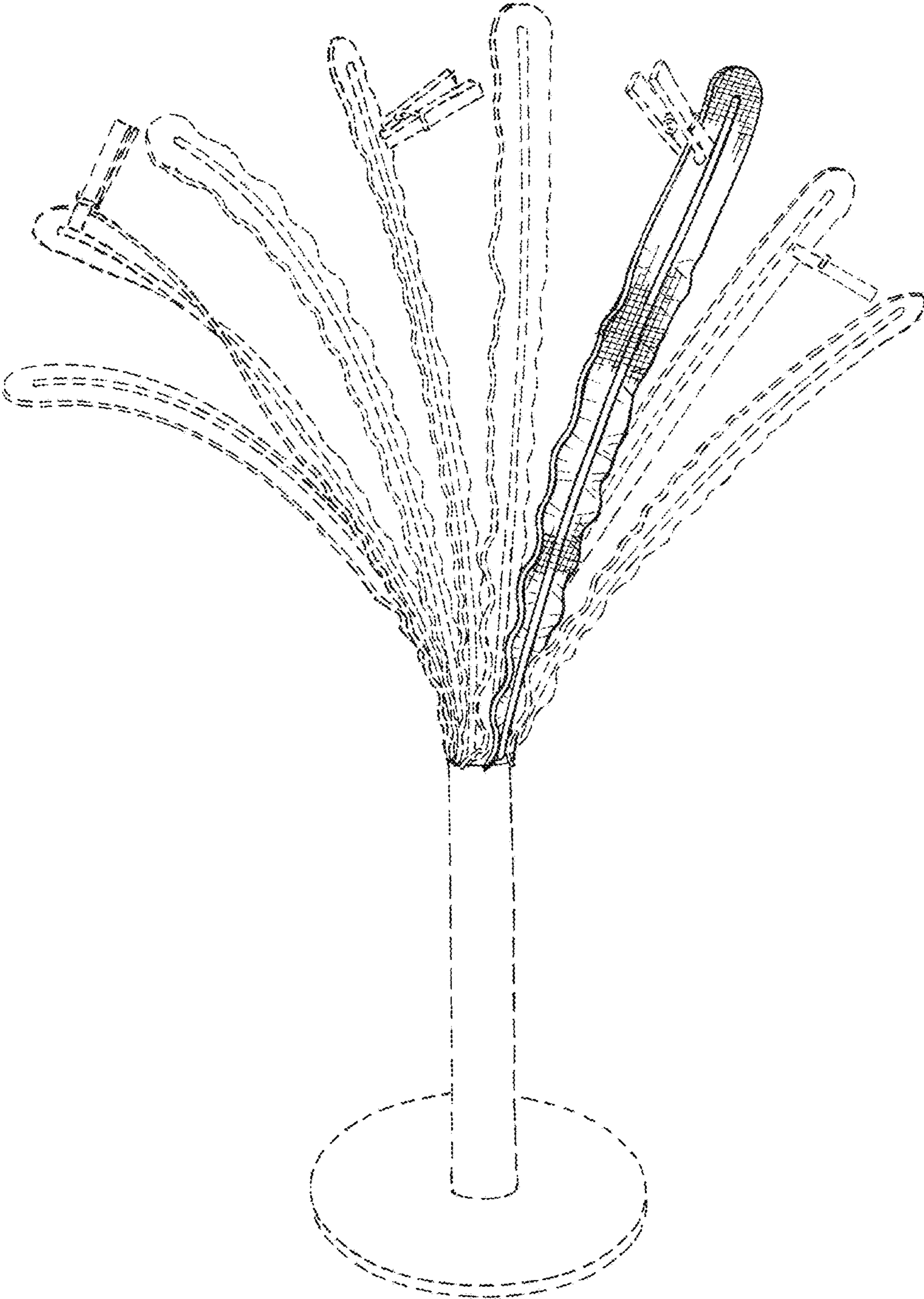
