The ornamental design for a plate, as shown and described.

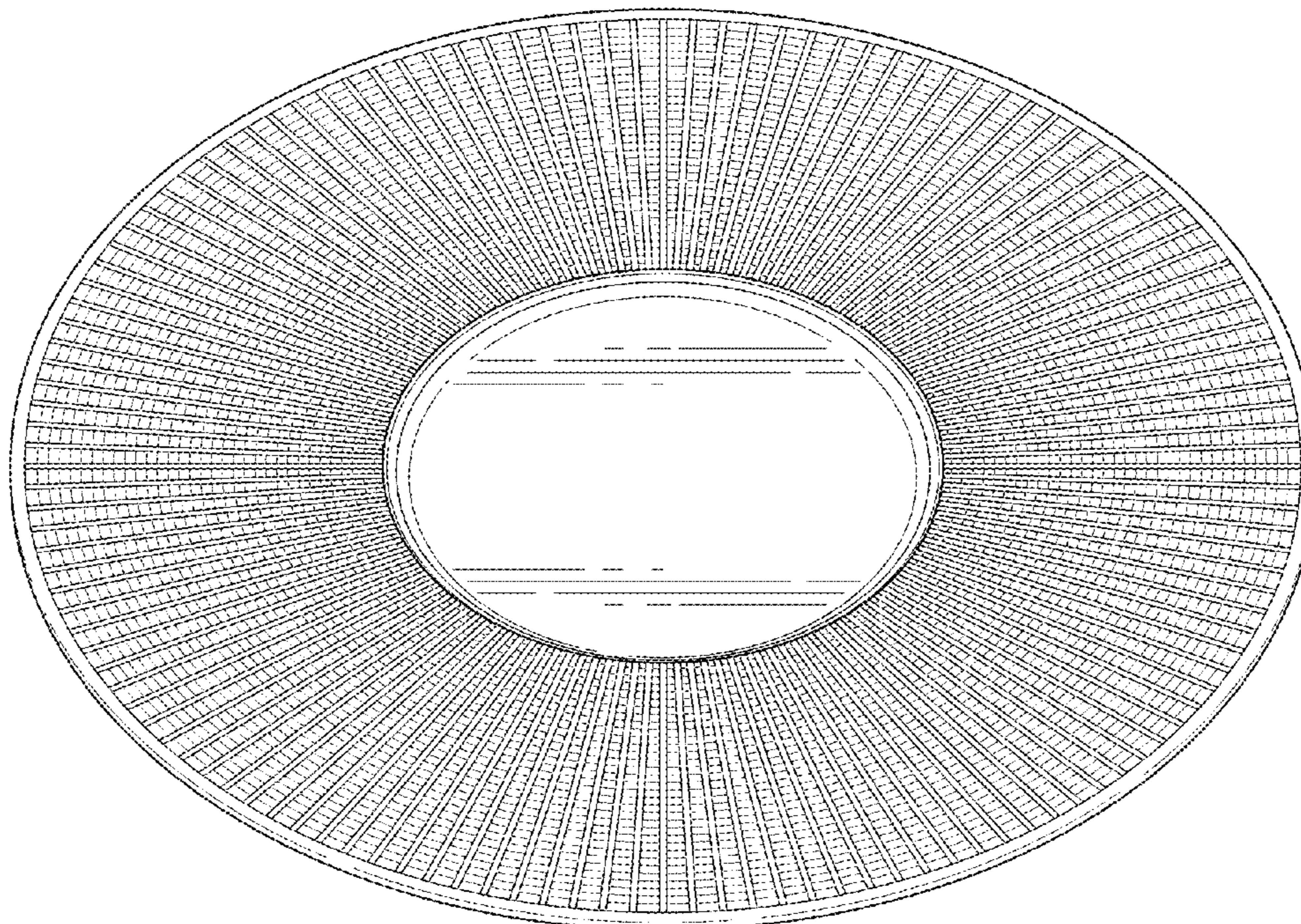
DESCRIPTION

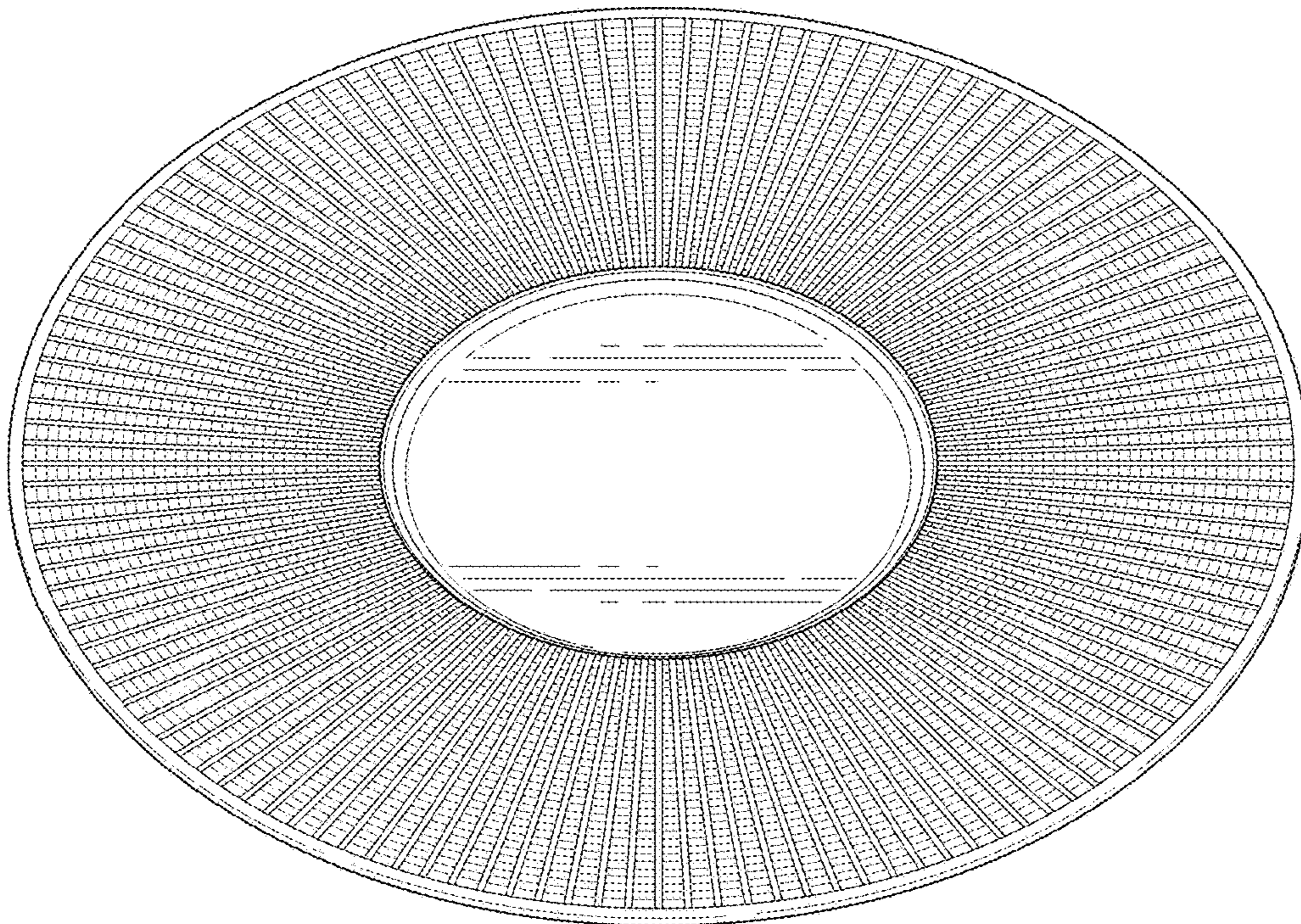

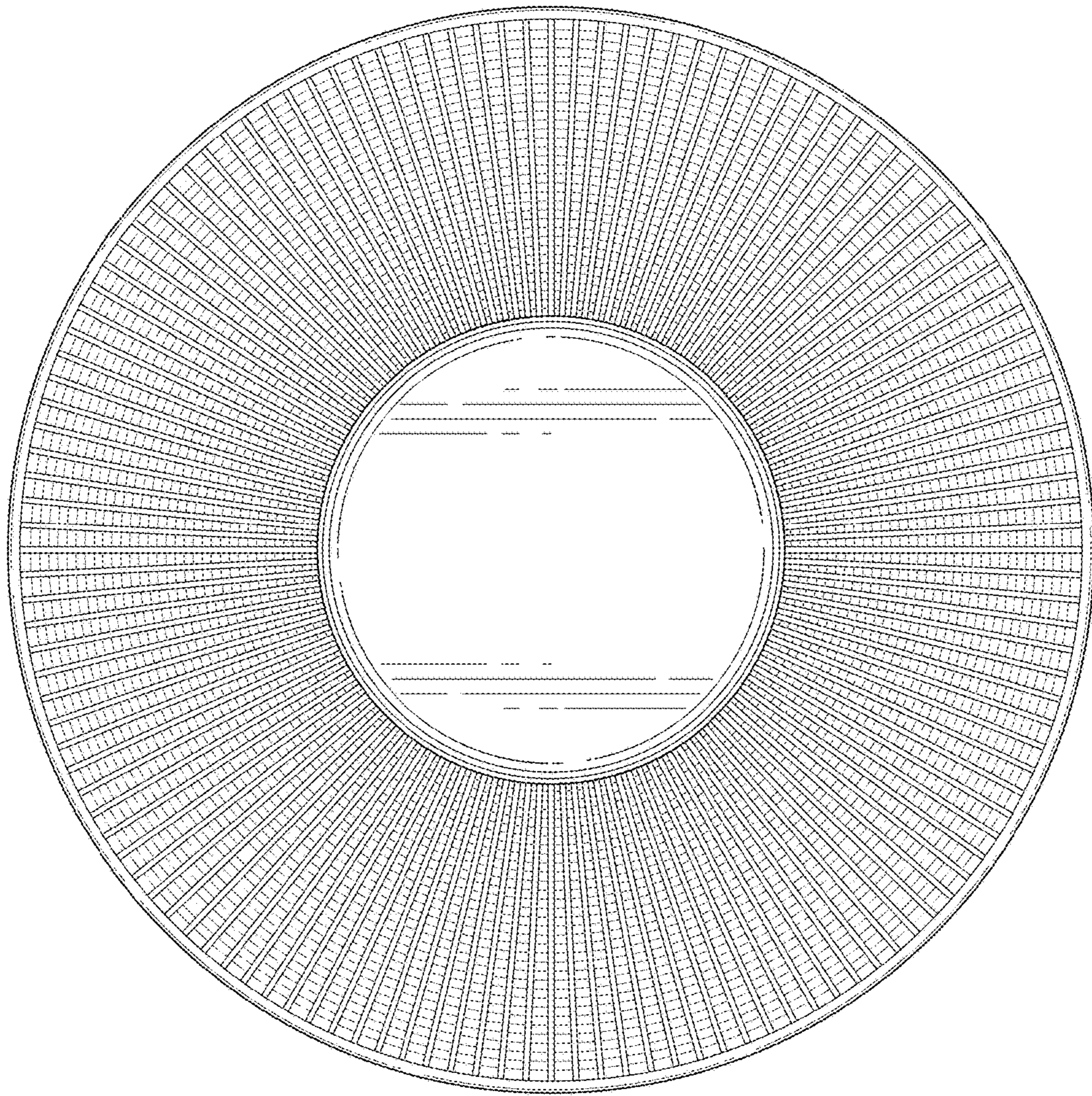

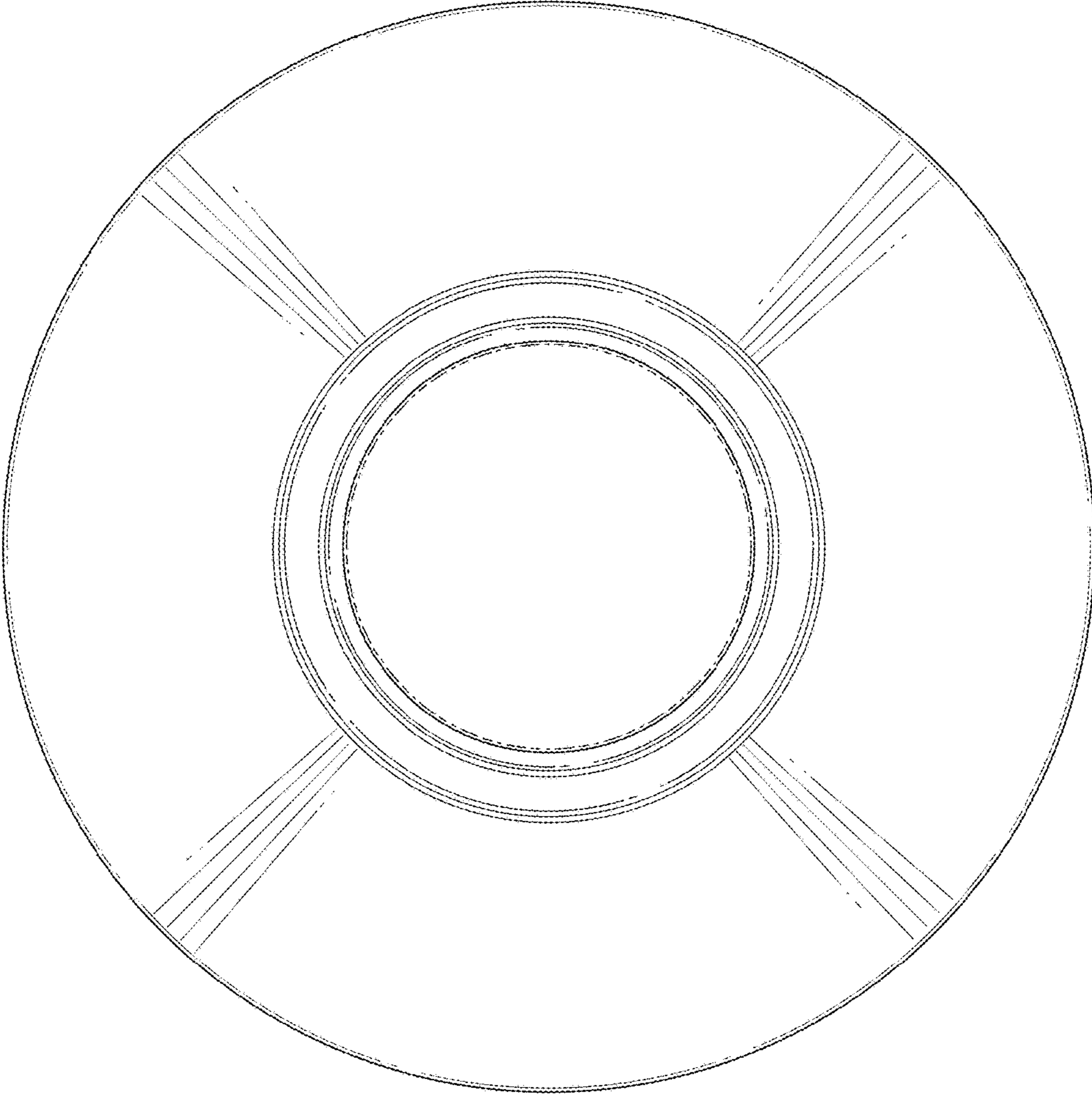

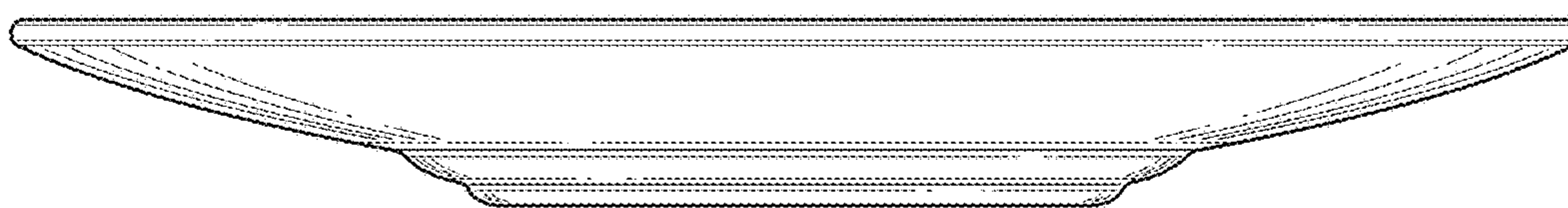

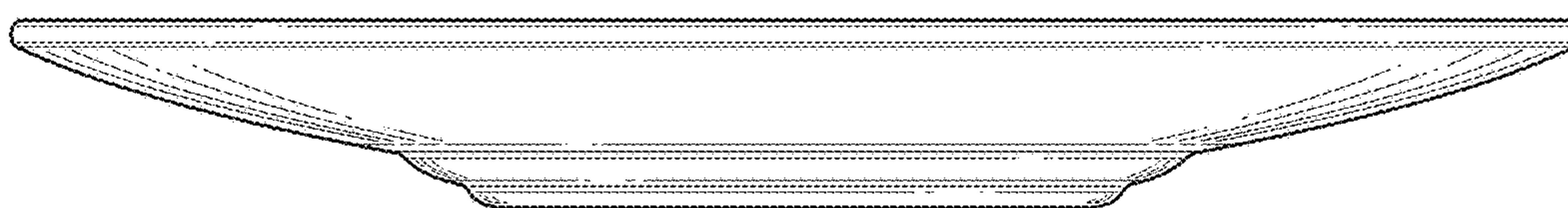
