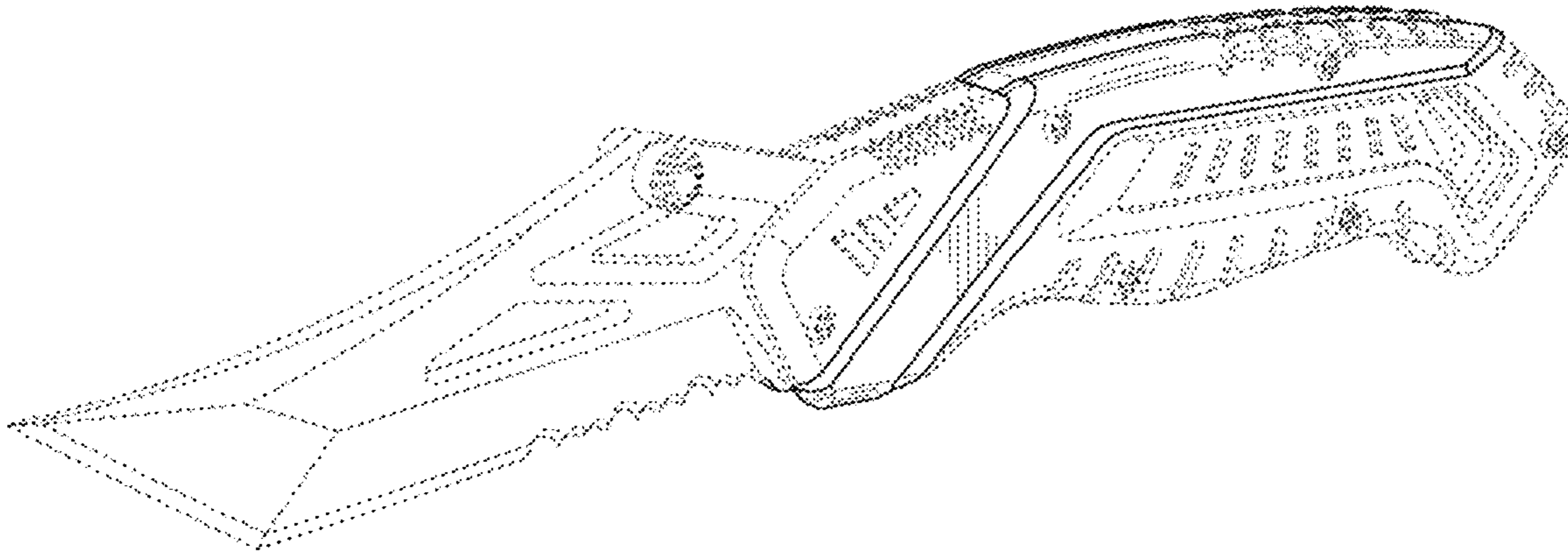
The broken lines depict portions of the folding knife in which the design is embodied that are not considered part of the claimed design.

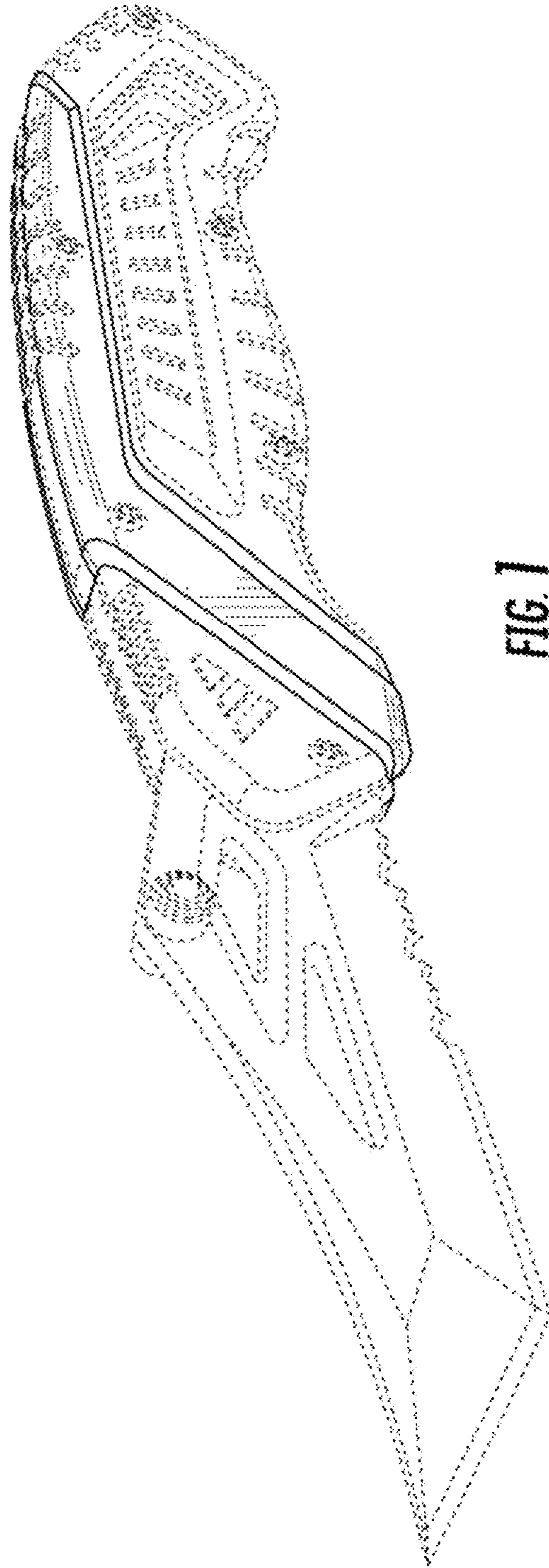

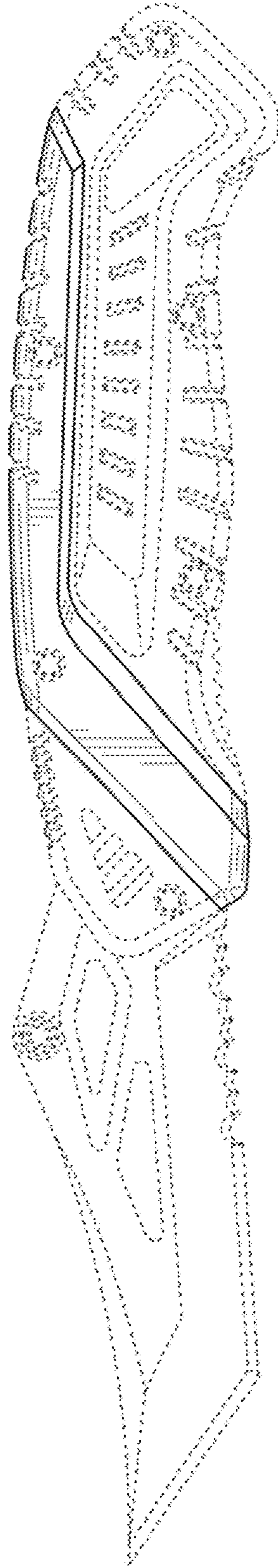

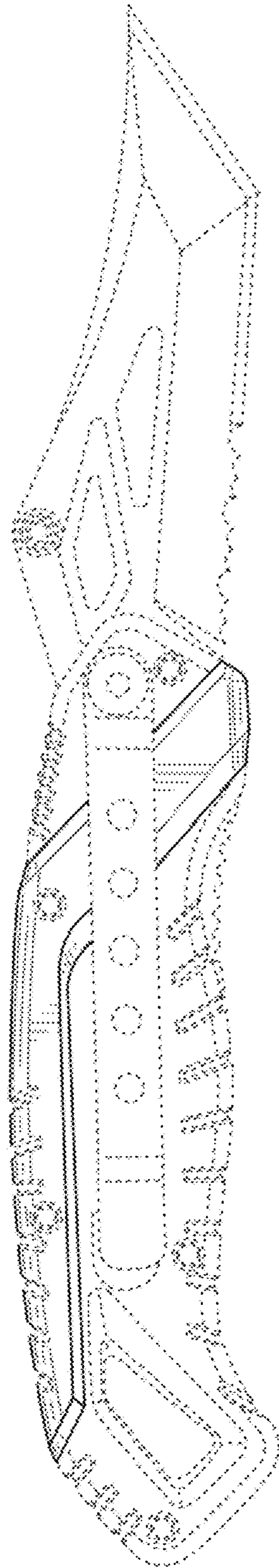

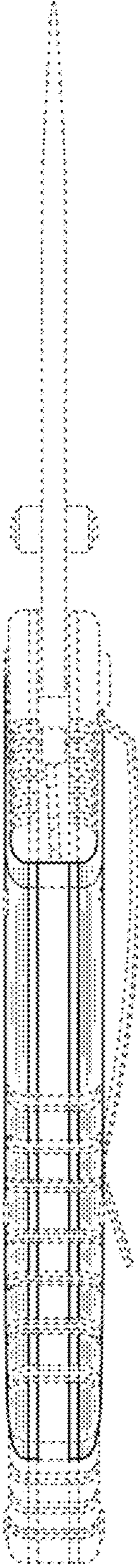

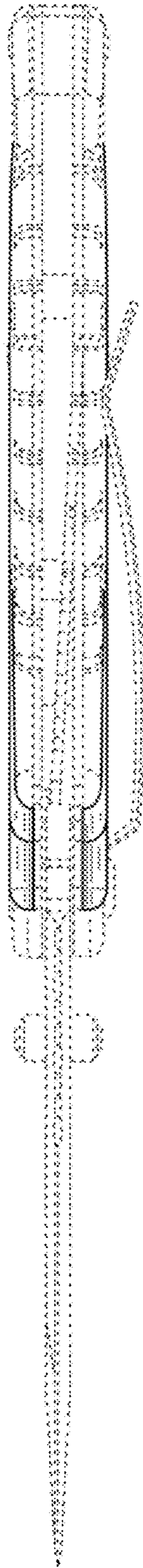

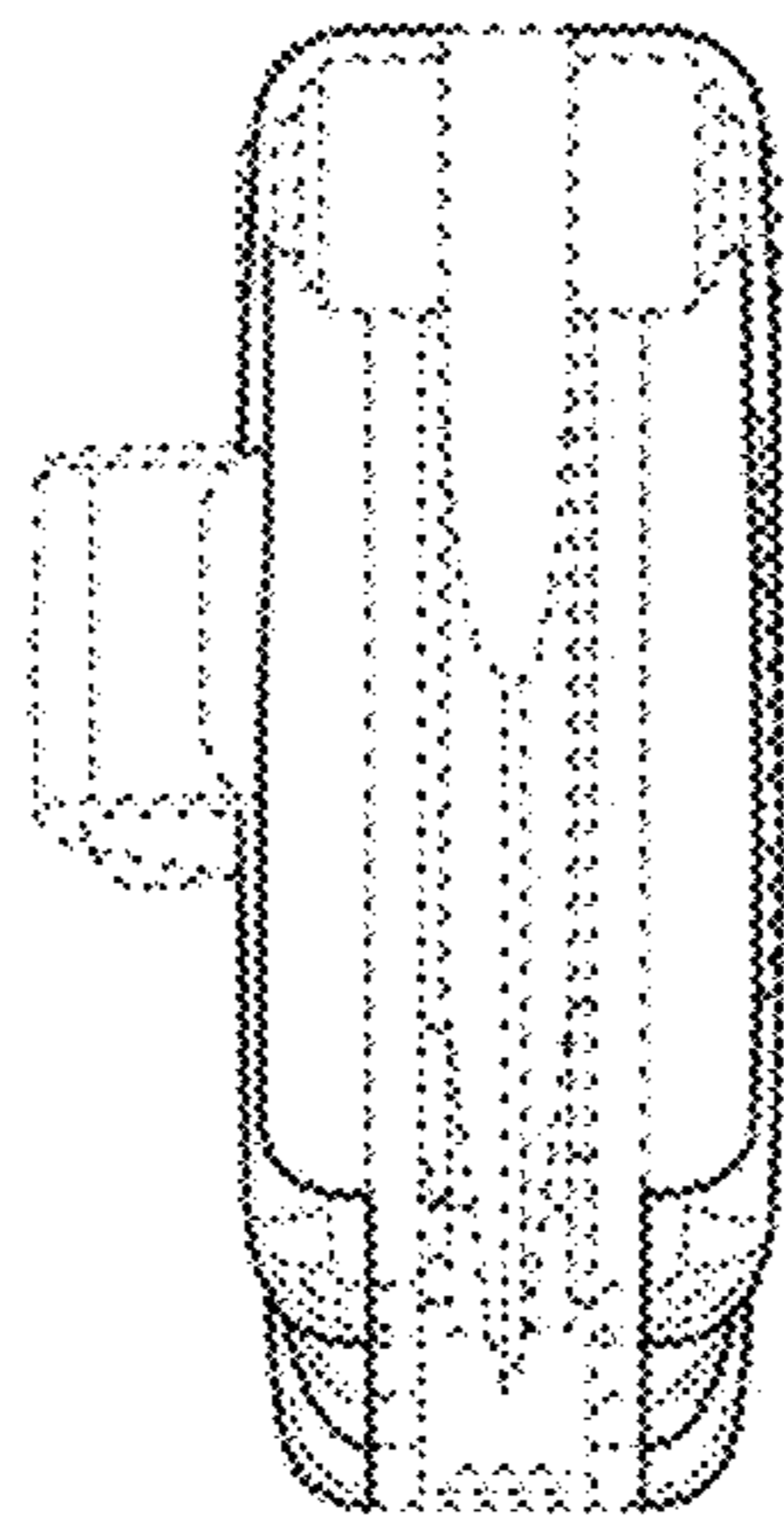
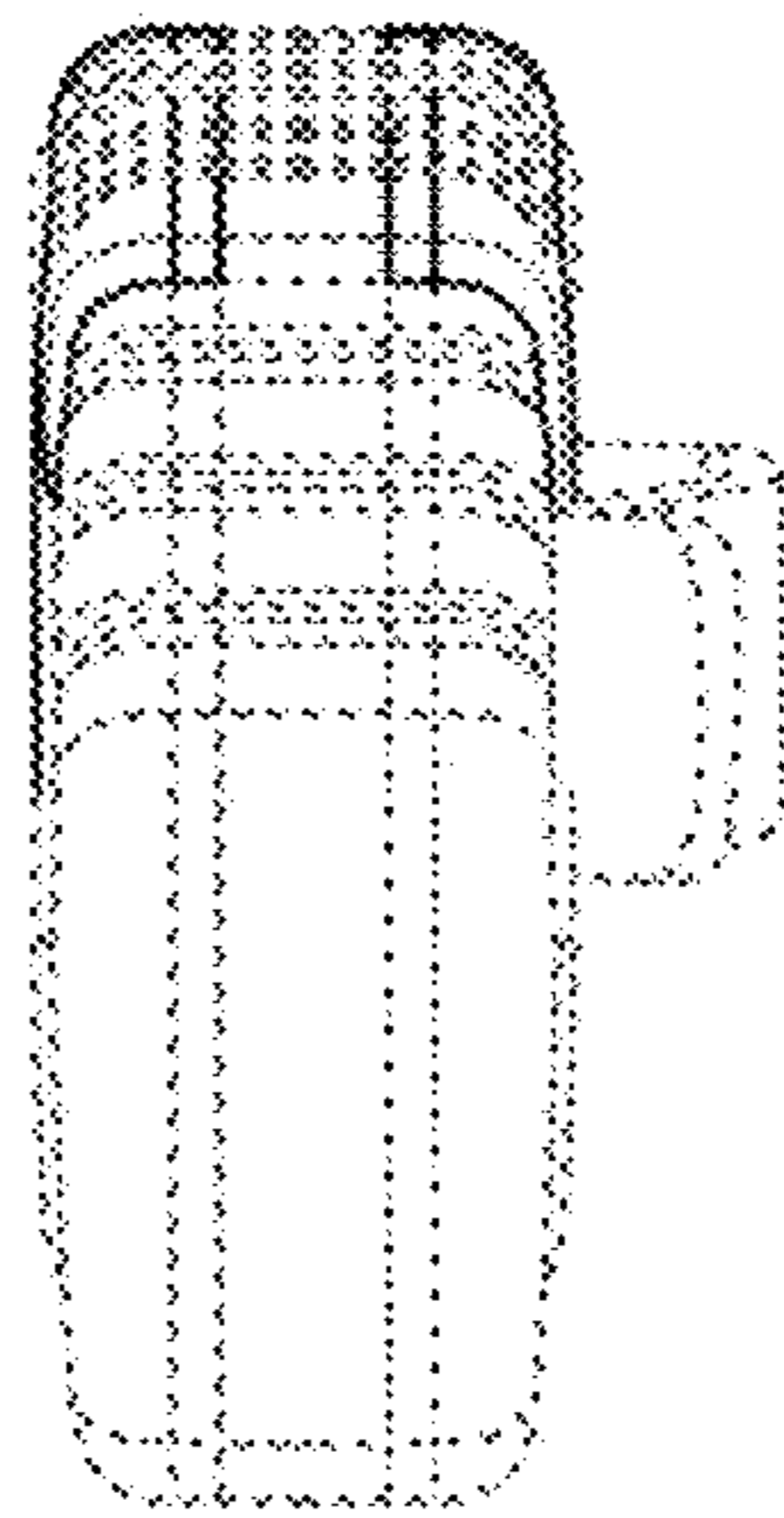

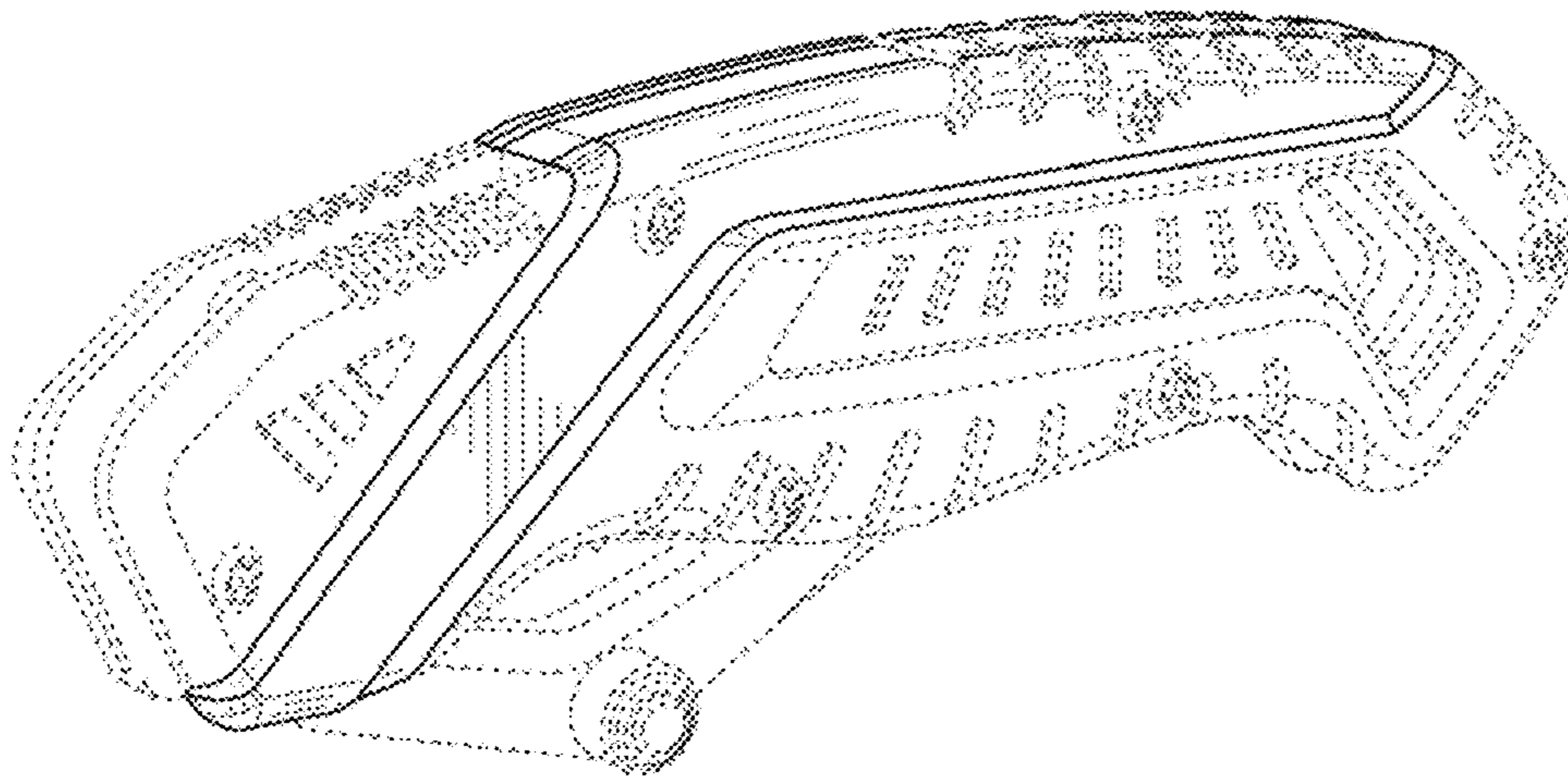
