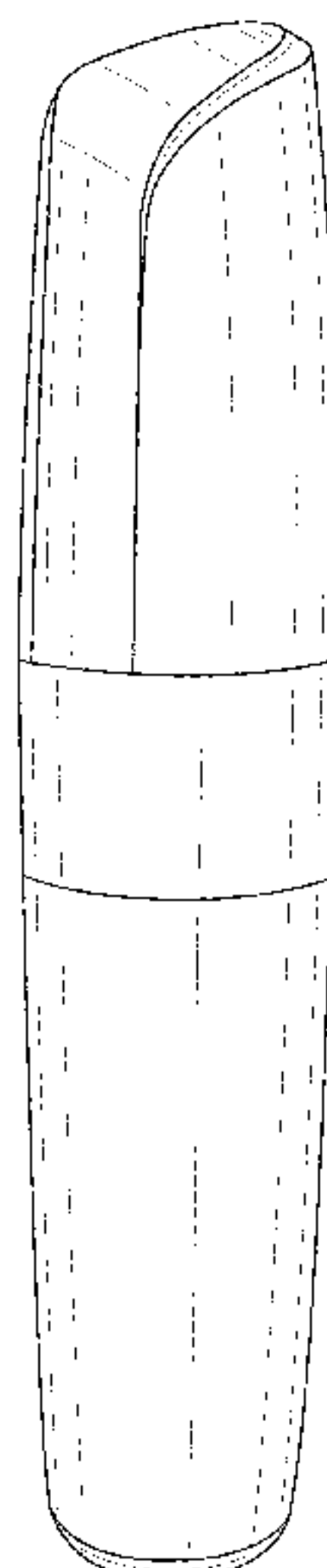
(57) **CLAIM**

We claim the ornamental design for a flask, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right perspective view of a flask, showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a back elevational view thereof;
FIG. 6 is a right elevational view thereof; and,
FIG. 7 is a left elevational view thereof.
The broken lines in the drawings depict portions of the flask that form no part of the claimed design.

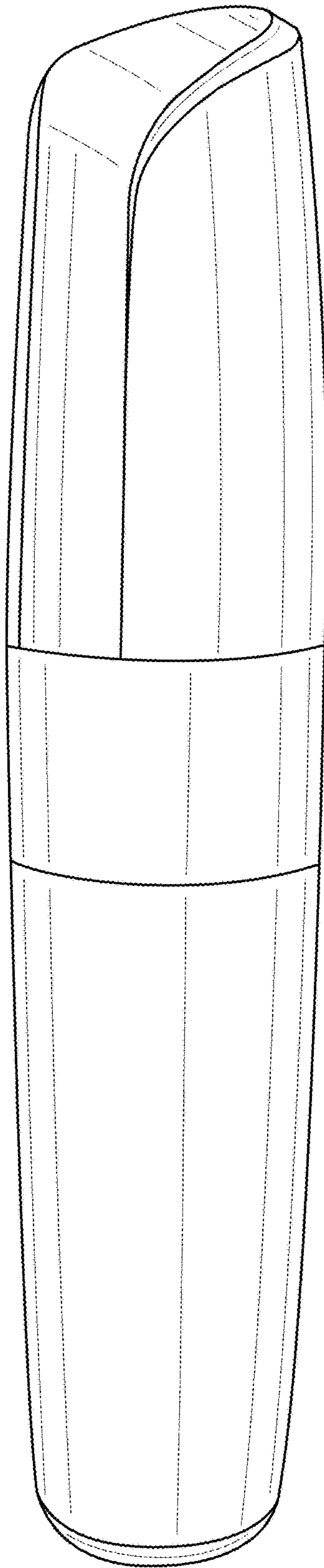

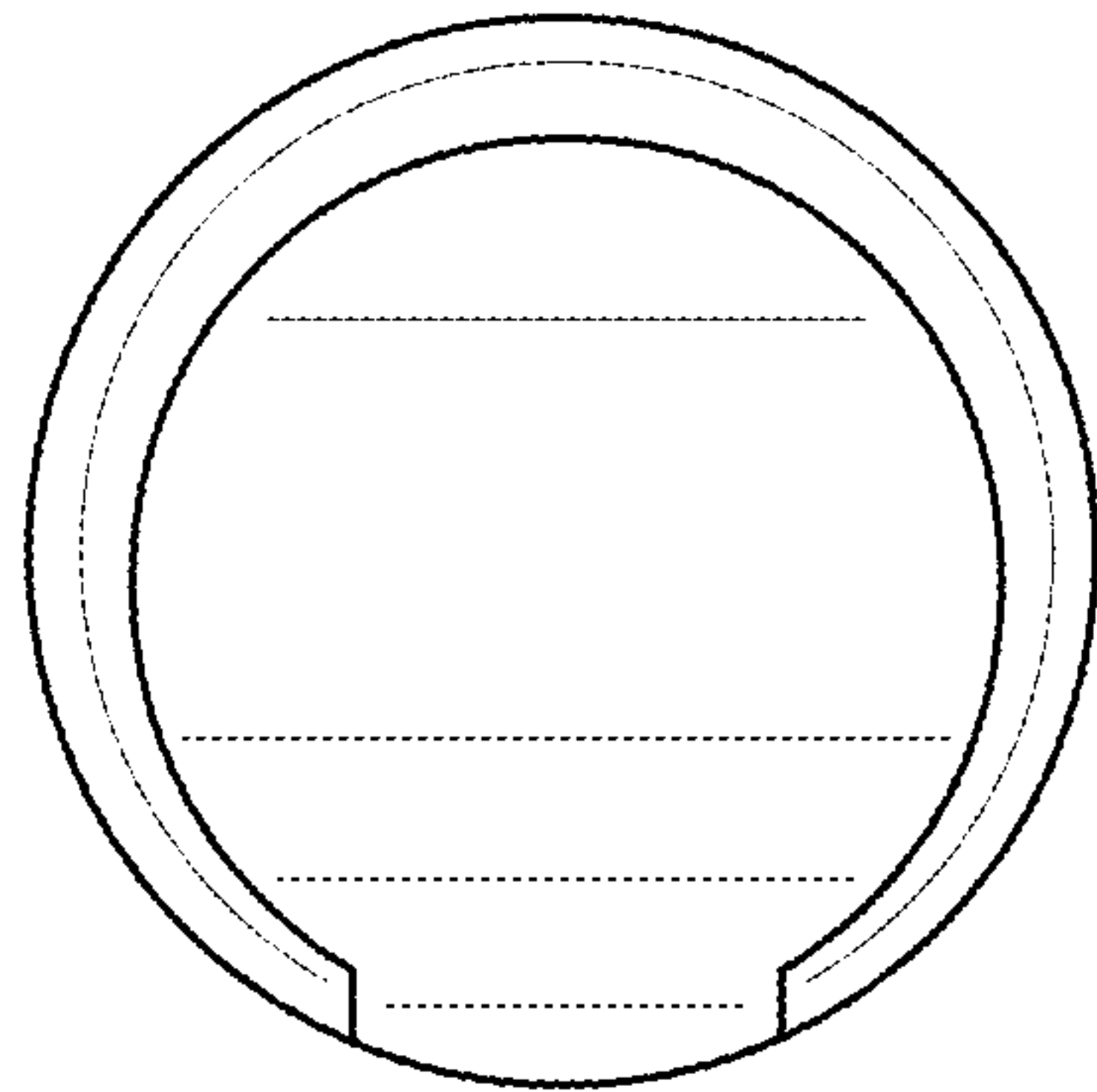

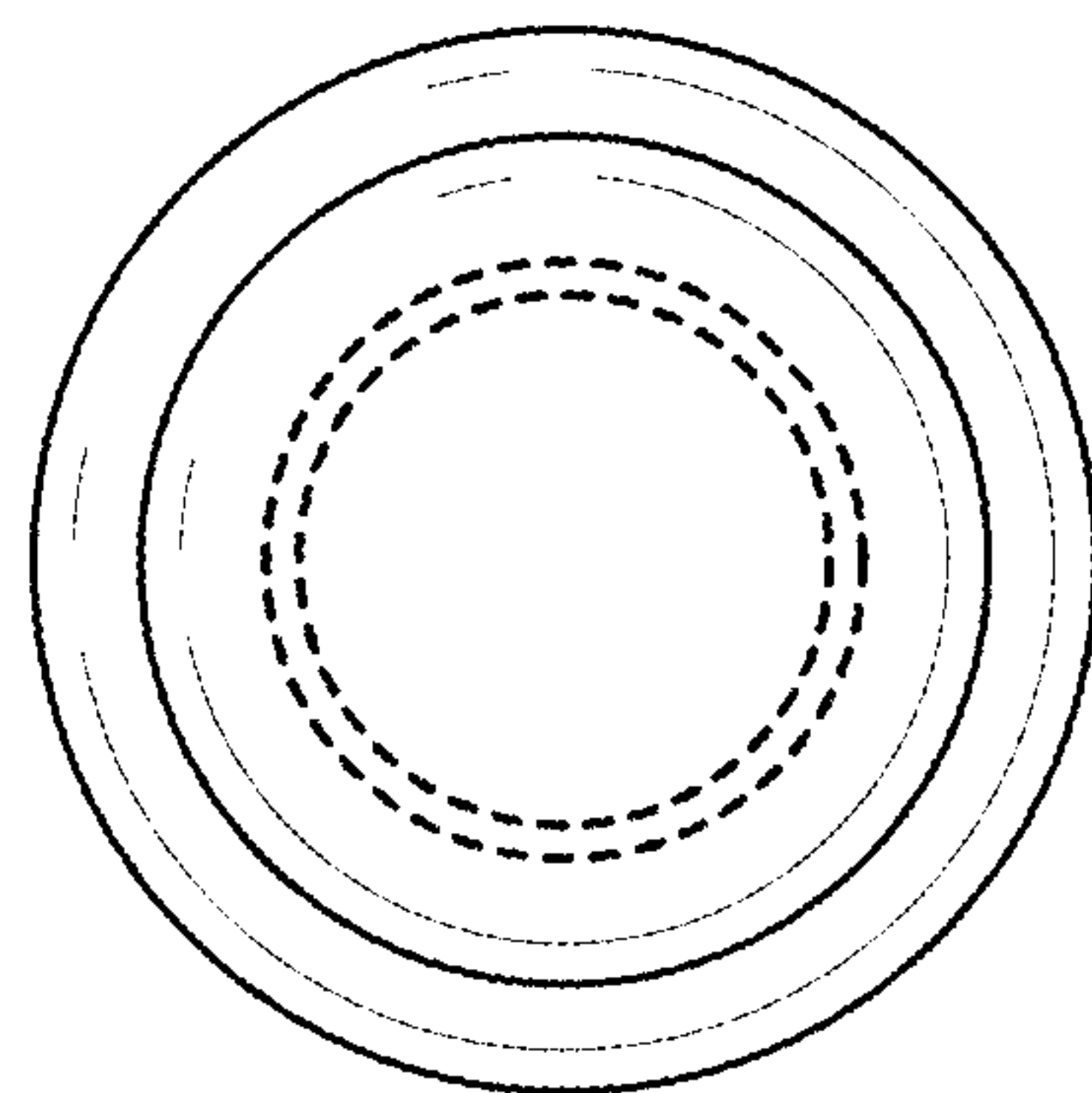

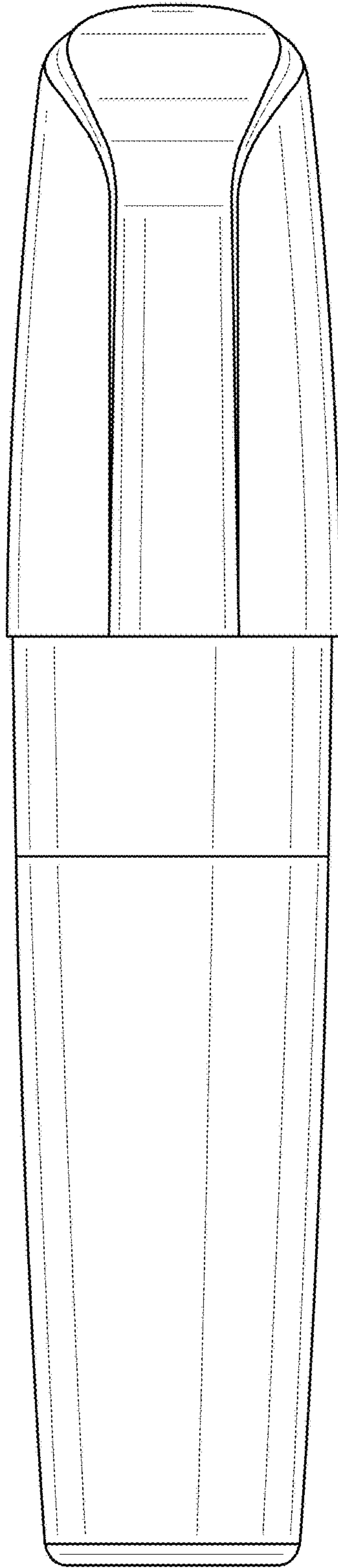

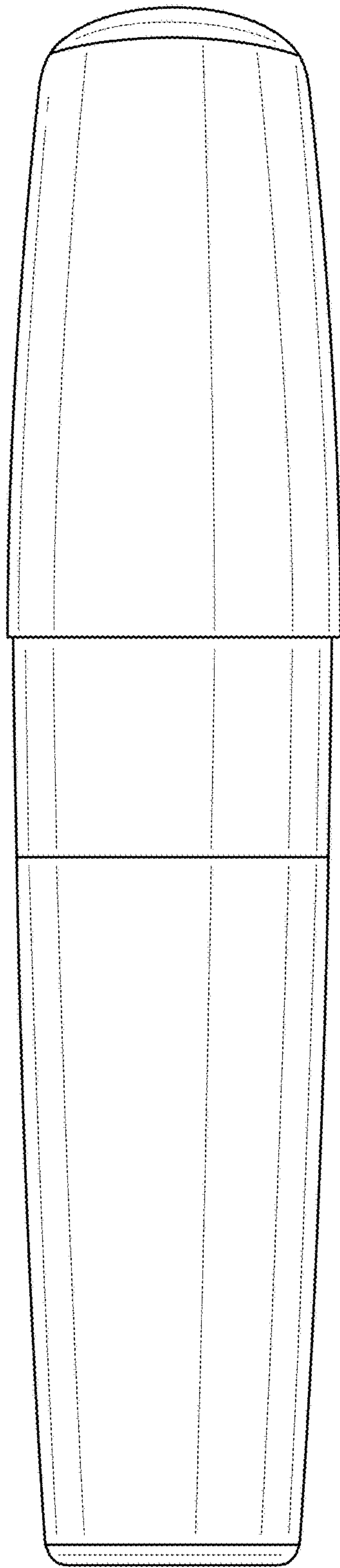

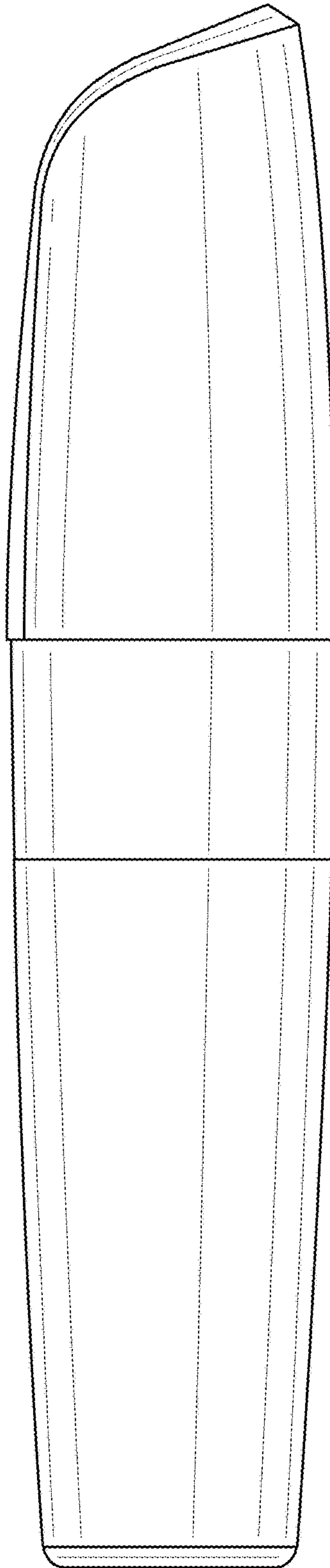

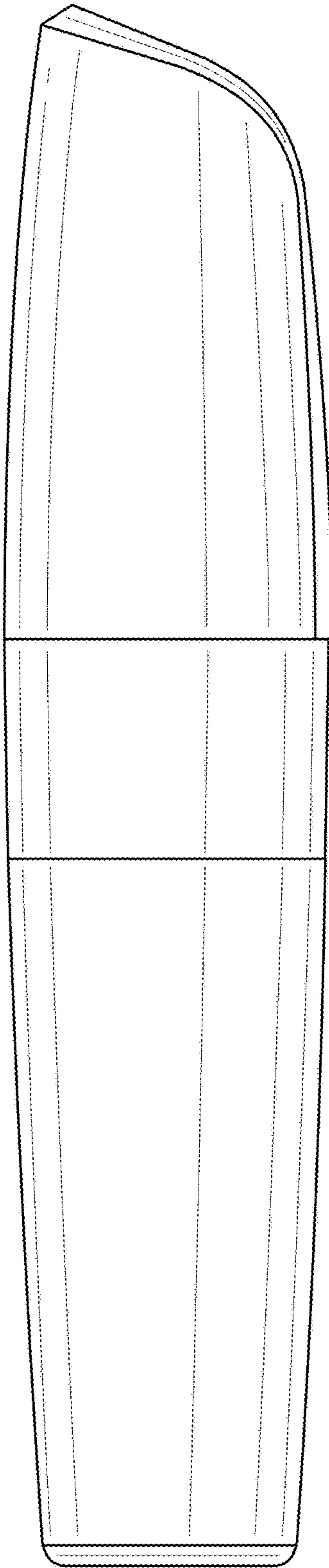
