(57) **CLAIM**

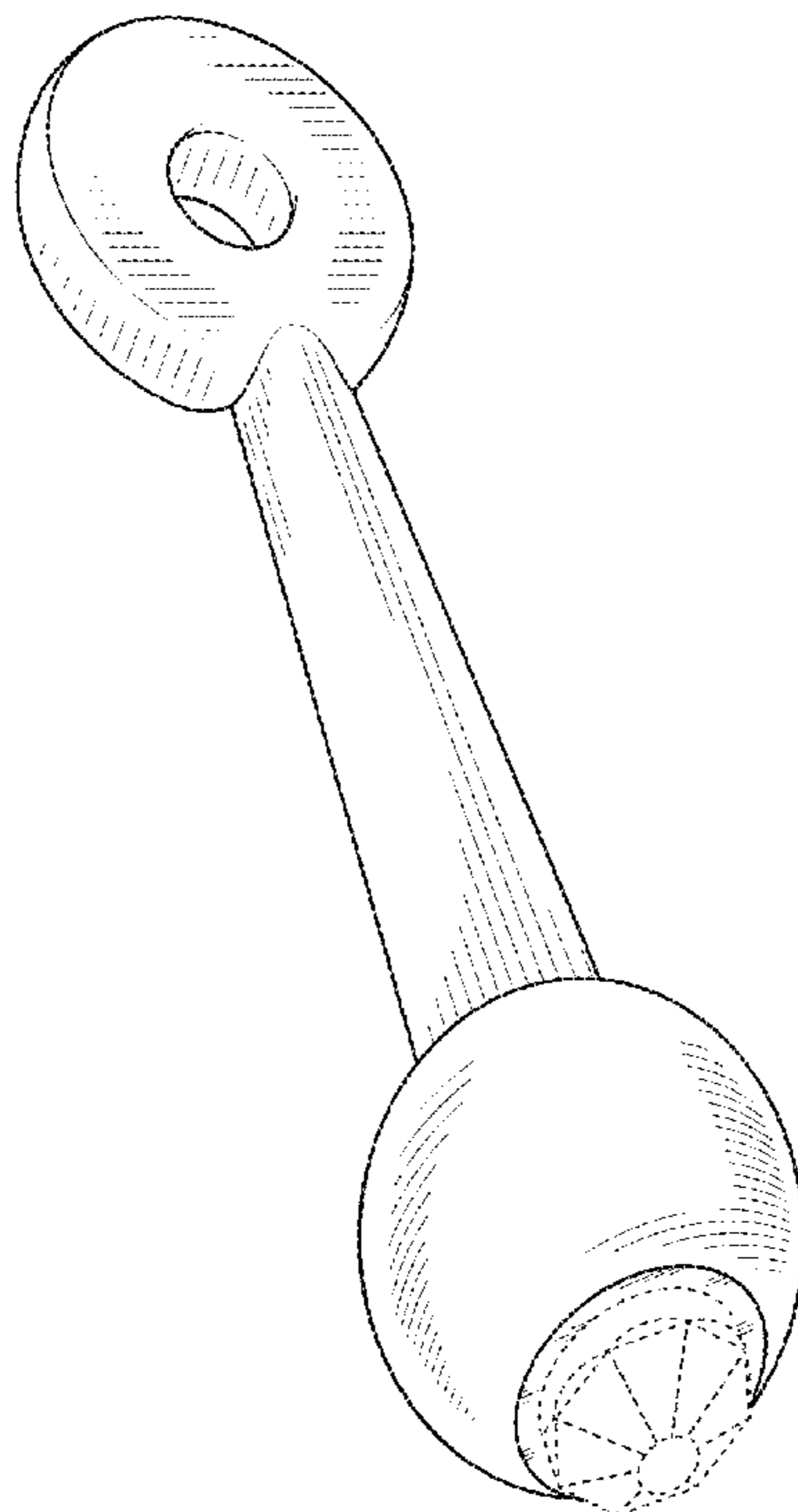
The ornamental design for a clapper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the clapper;
FIG. 2 is a front view of the clapper of FIG. 1;
FIG. 3 is a back view of the clapper of FIG. 1;
FIG. 4 is a left side view of the clapper of FIG. 1;
FIG. 5 is a right side view of the clapper of FIG. 1;
FIG. 6 is a top view of the clapper of FIG. 1;
FIG. 7 is a bottom view of the clapper of FIG. 1; and,
FIG. 8 is a contextual view of the clapper of FIG. 1.
Broken lines depict portions of the environment and the clapper that form no part of the claimed design.
The clapper features a unique appearance over prior art, including a gemstone on the lower portion of the clapper.

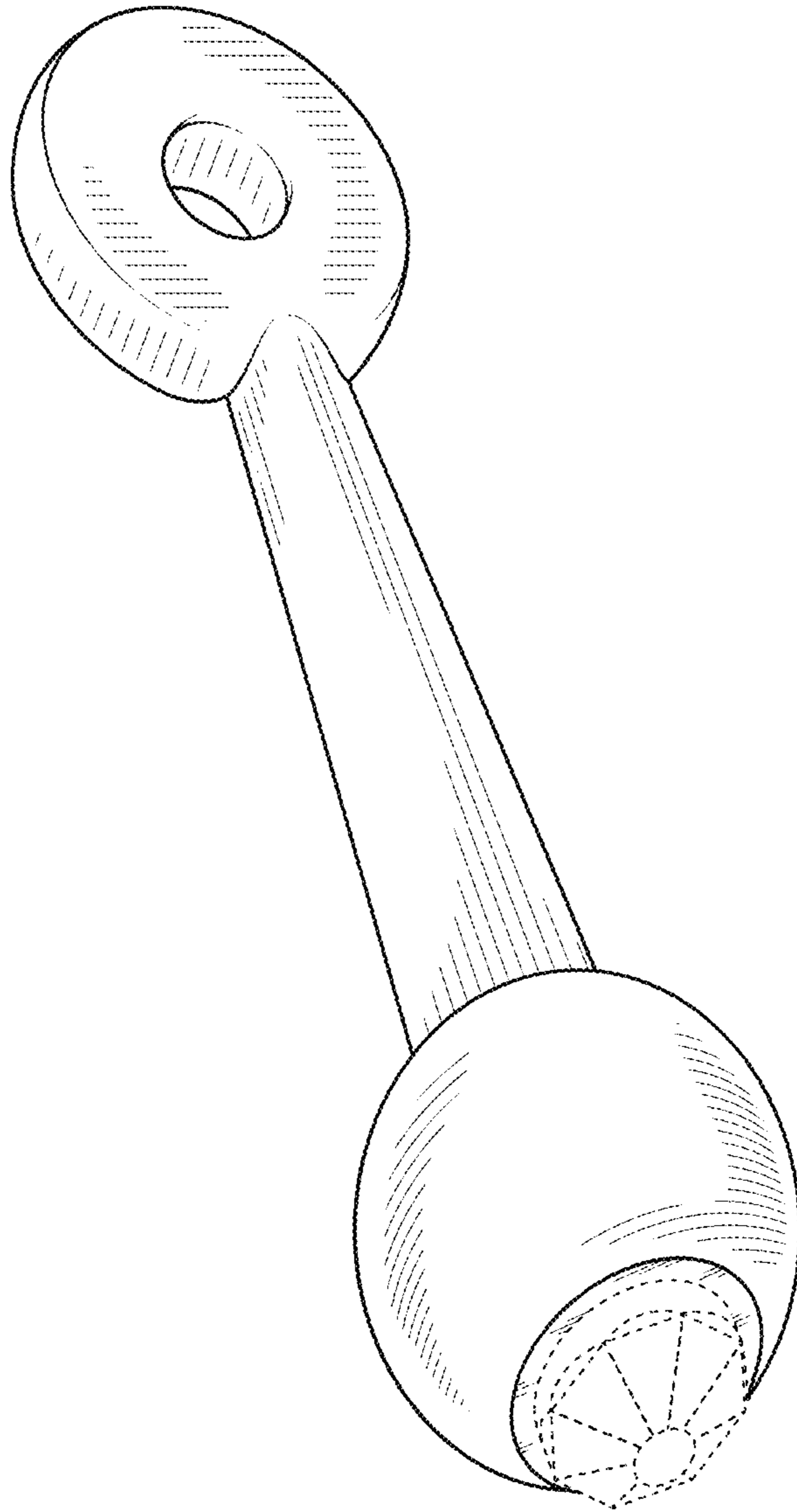

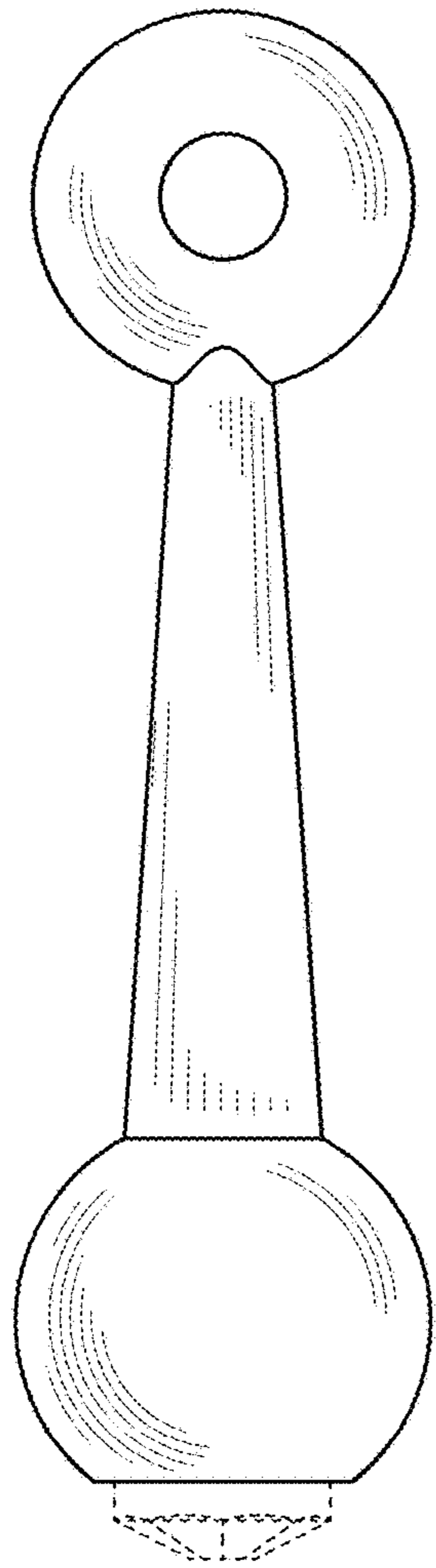

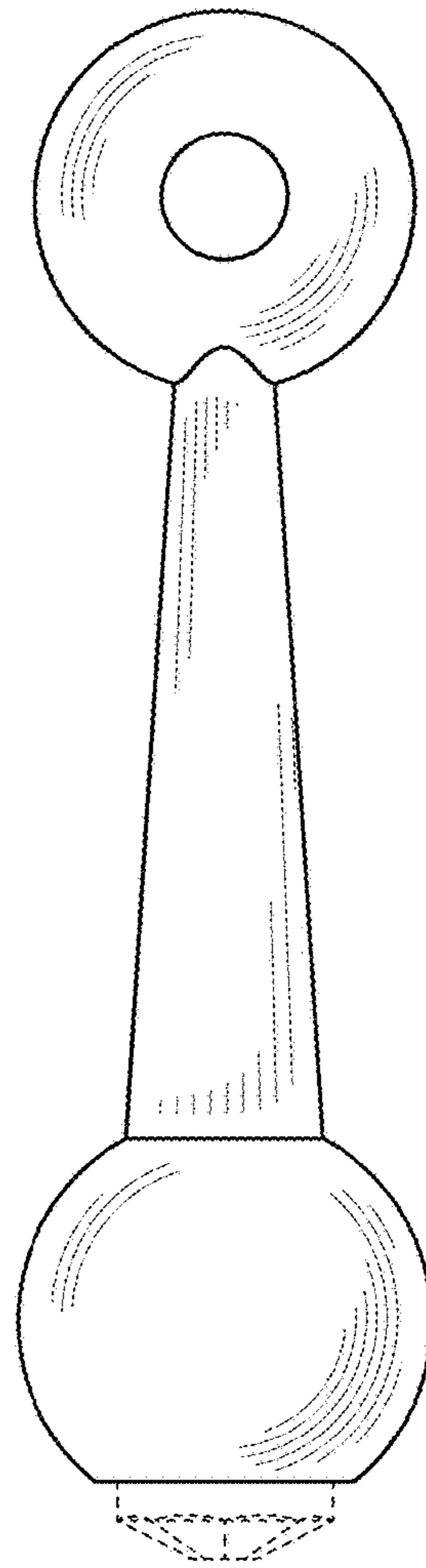

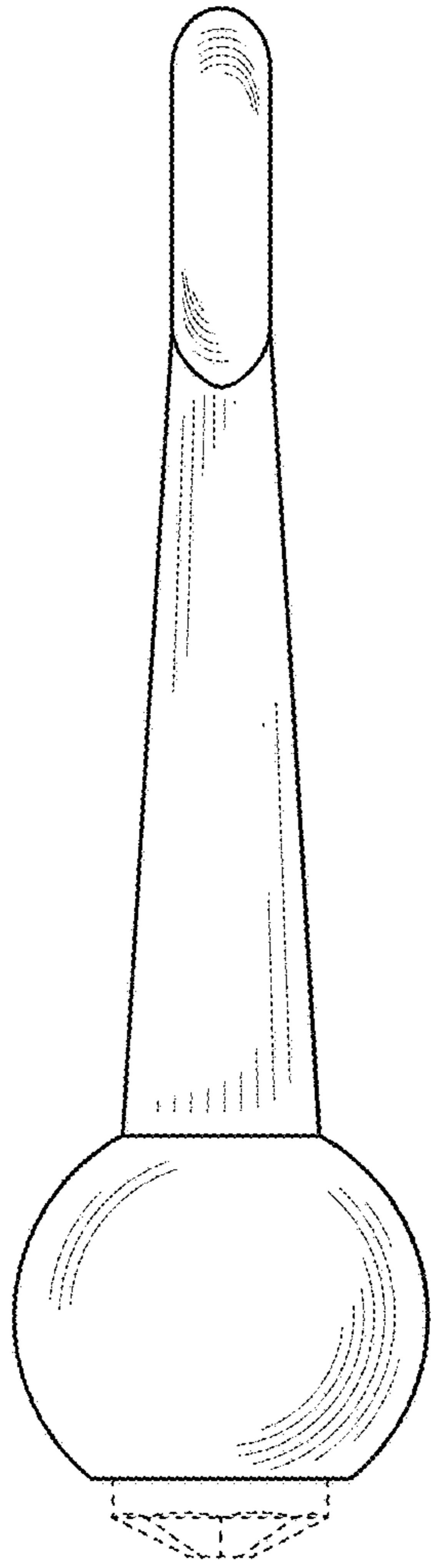

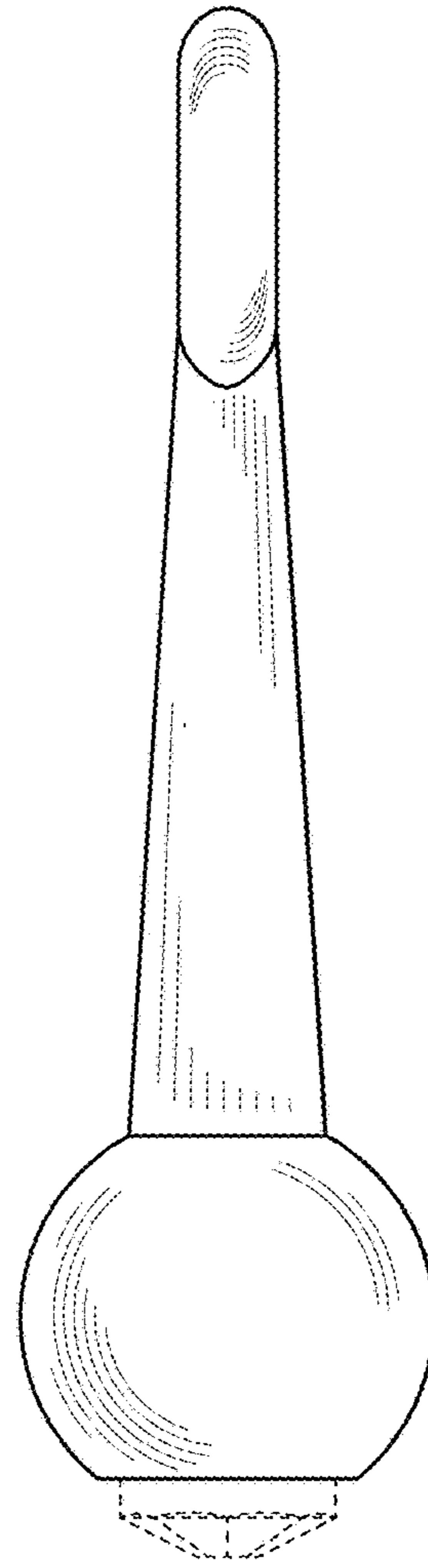

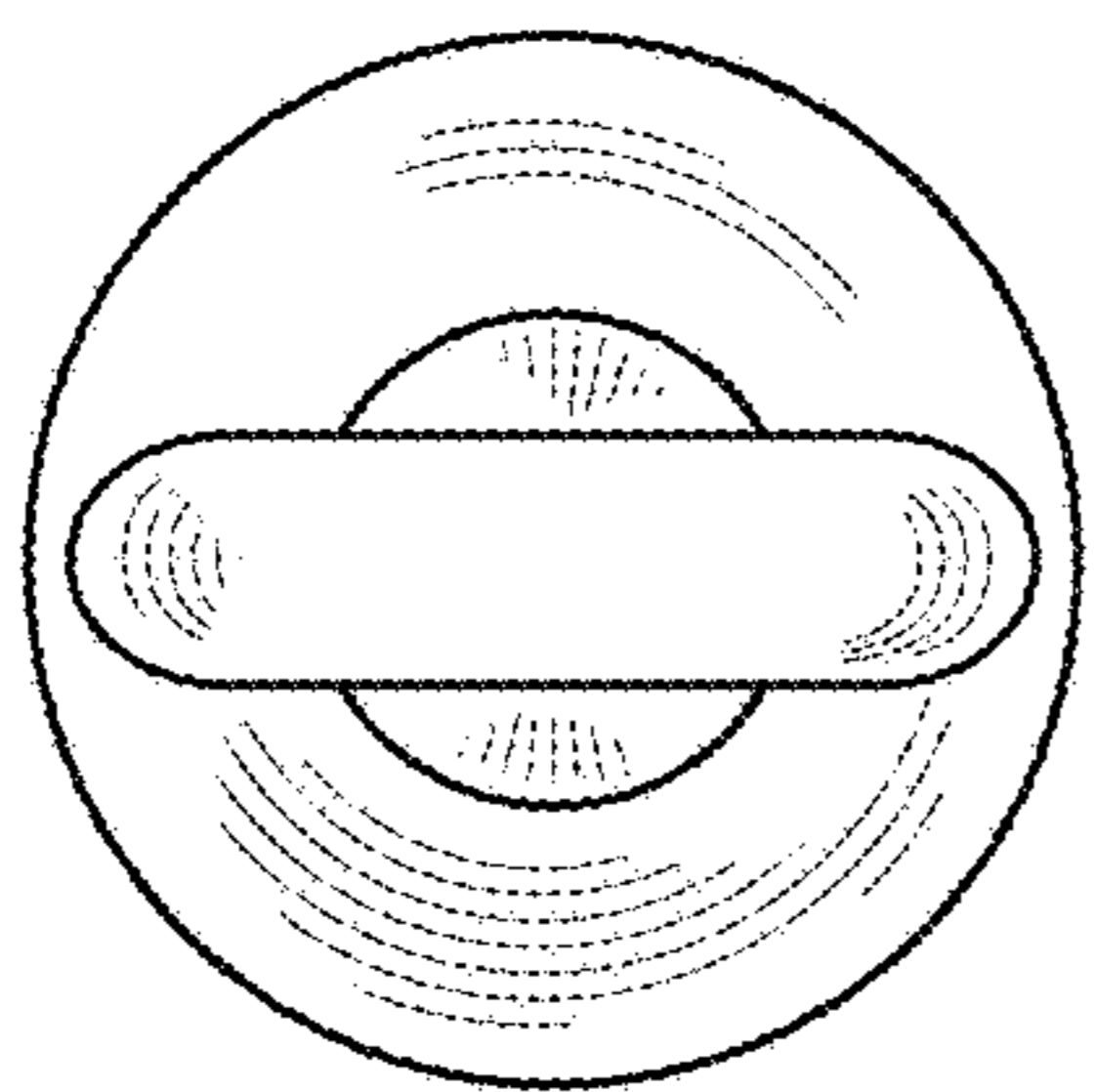

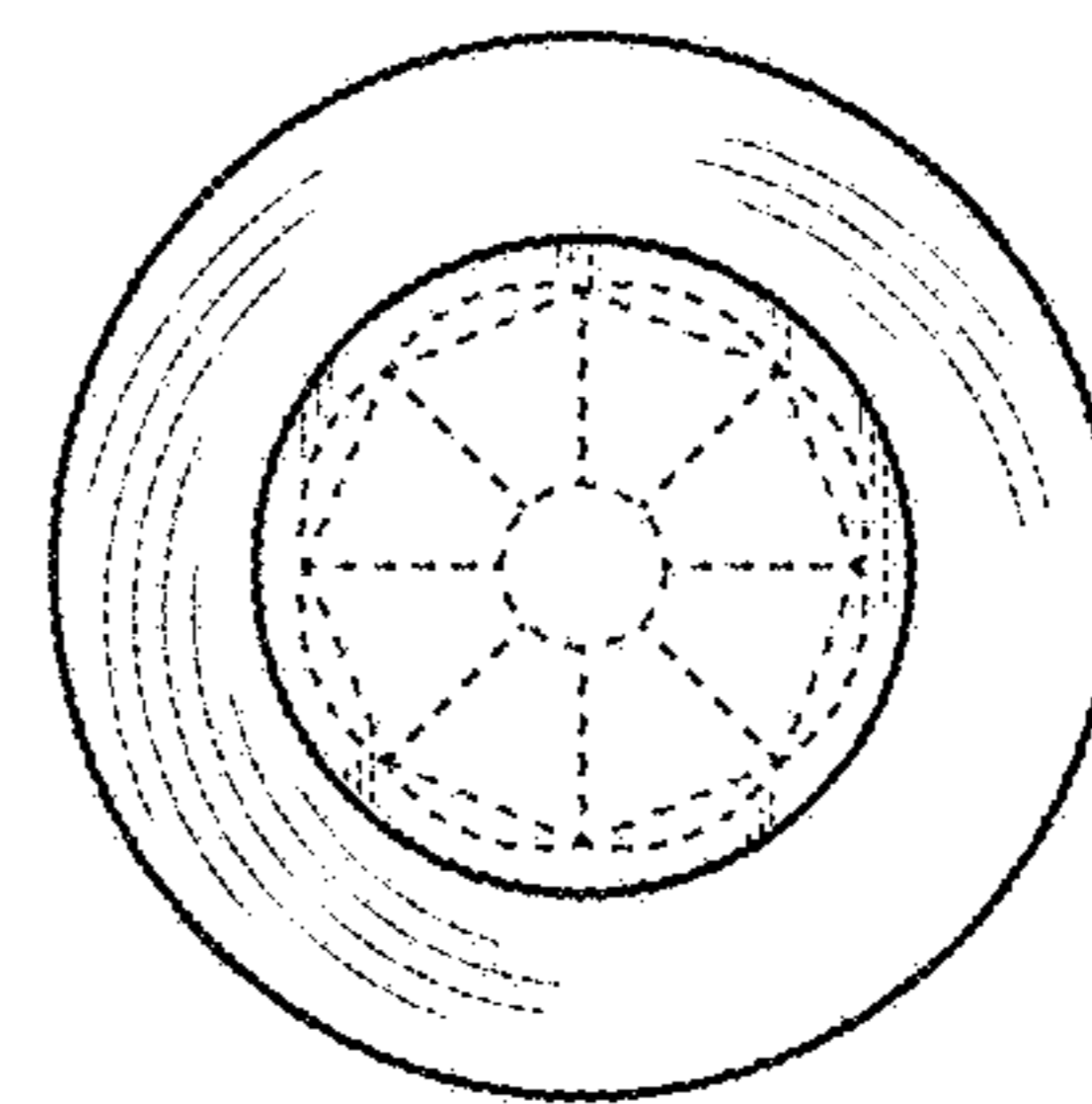

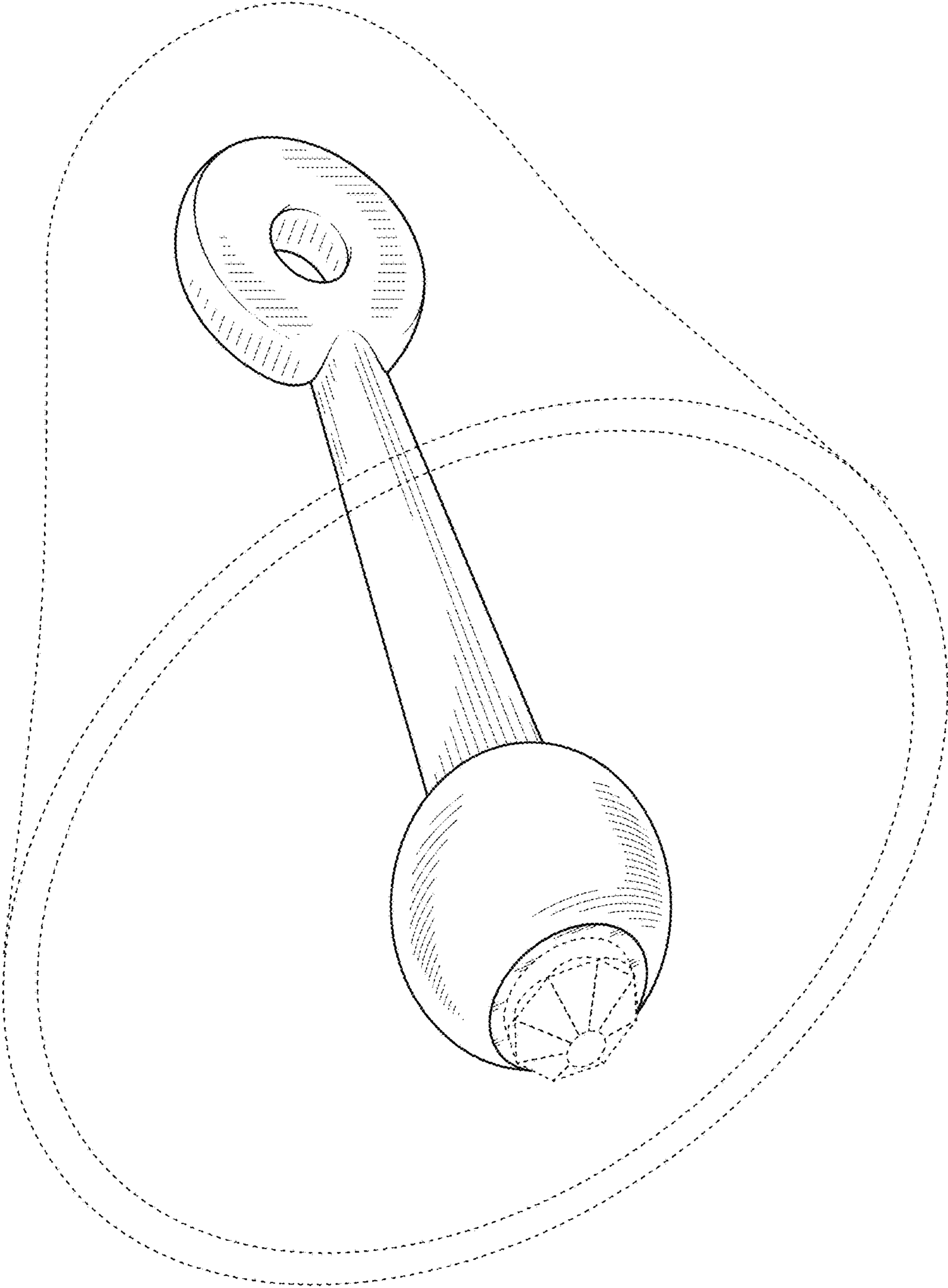
