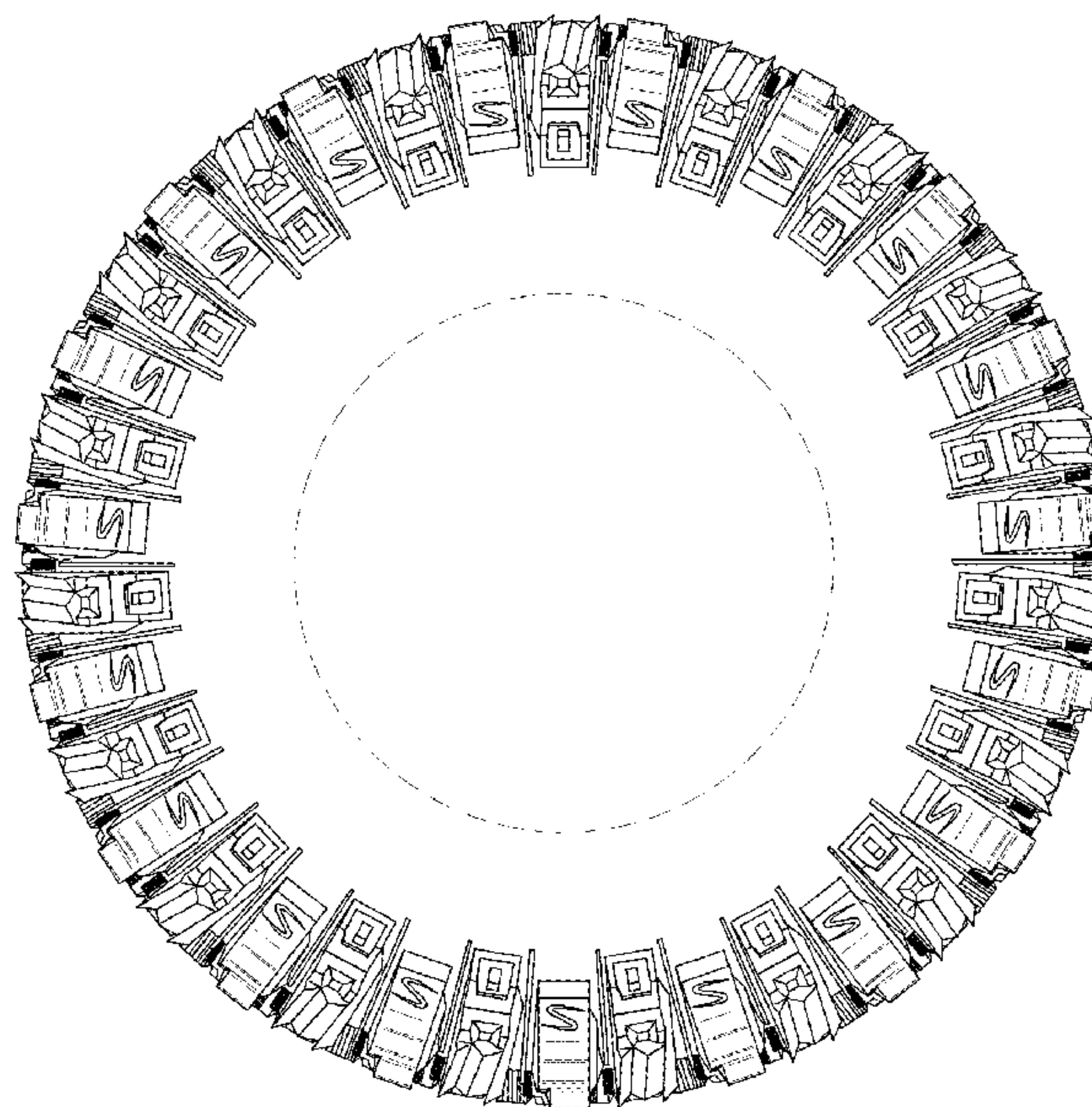
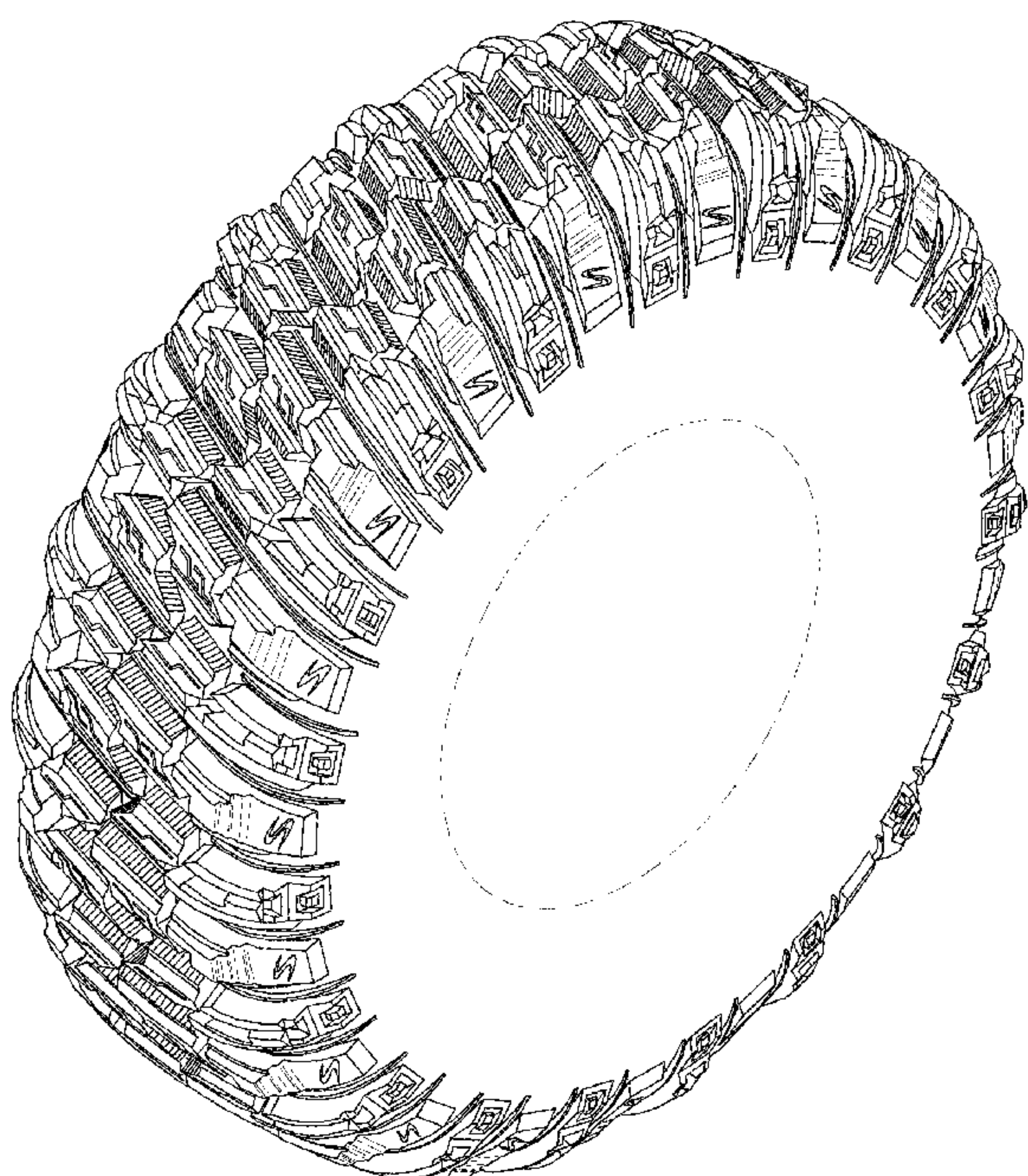
The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front/top view of a tire, showing our new design; FIG. 2 is a perspective view thereof; FIG. 3 is a side view thereof, the opposite side view being identical thereto; FIG. 4 is a perspective view of the sidewall blocks thereof, shown removed from the tire for clarity of disclosure; FIG. 5 is a perspective view of the sidewall blocks thereof, shown removed from the tire for clarity of disclosure; FIG. 6 is a perspective view of the sidewall blocks thereof, shown removed from the tire for clarity of disclosure; FIG. 7 is a perspective view of the center tread blocks thereof, shown removed from the tire for clarity of disclosure; FIG. 8 is a perspective view of the center tread blocks thereof, shown removed from the tire for clarity of disclosure; and, FIG. 9 is a side elevational view of the center tread blocks thereof, shown removed from the tire for clarity of disclosure.

The broken lines in FIGS. 2, 3 and 4 depict the boundary of the claimed design and form no part thereof.

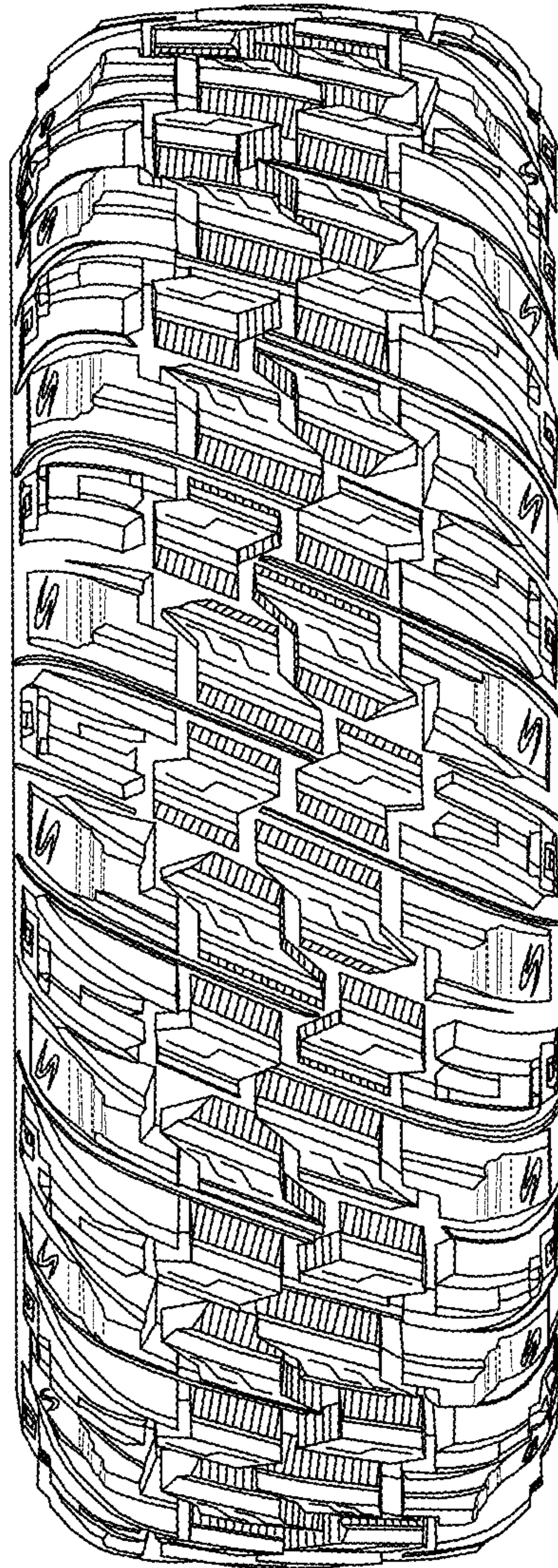

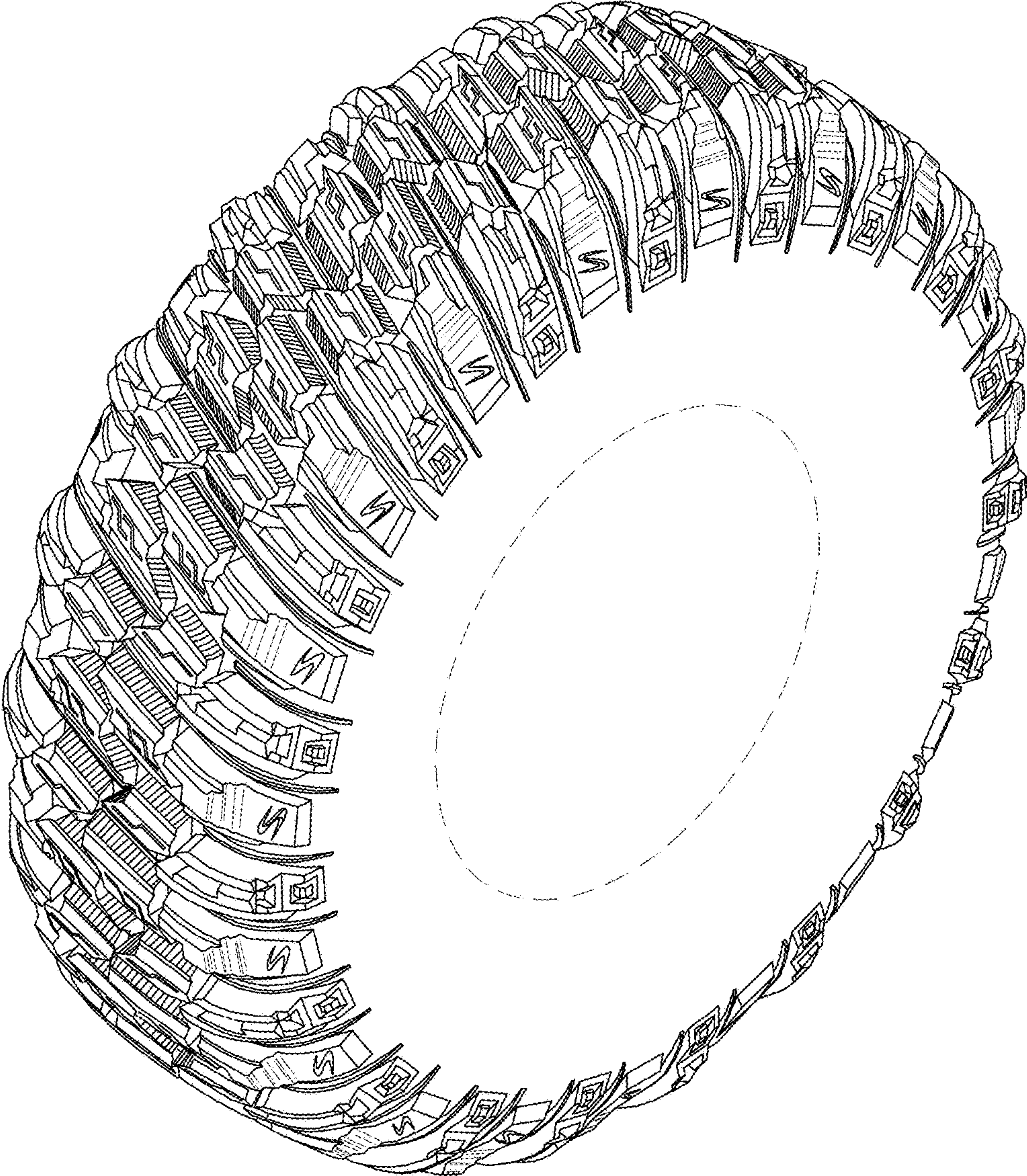

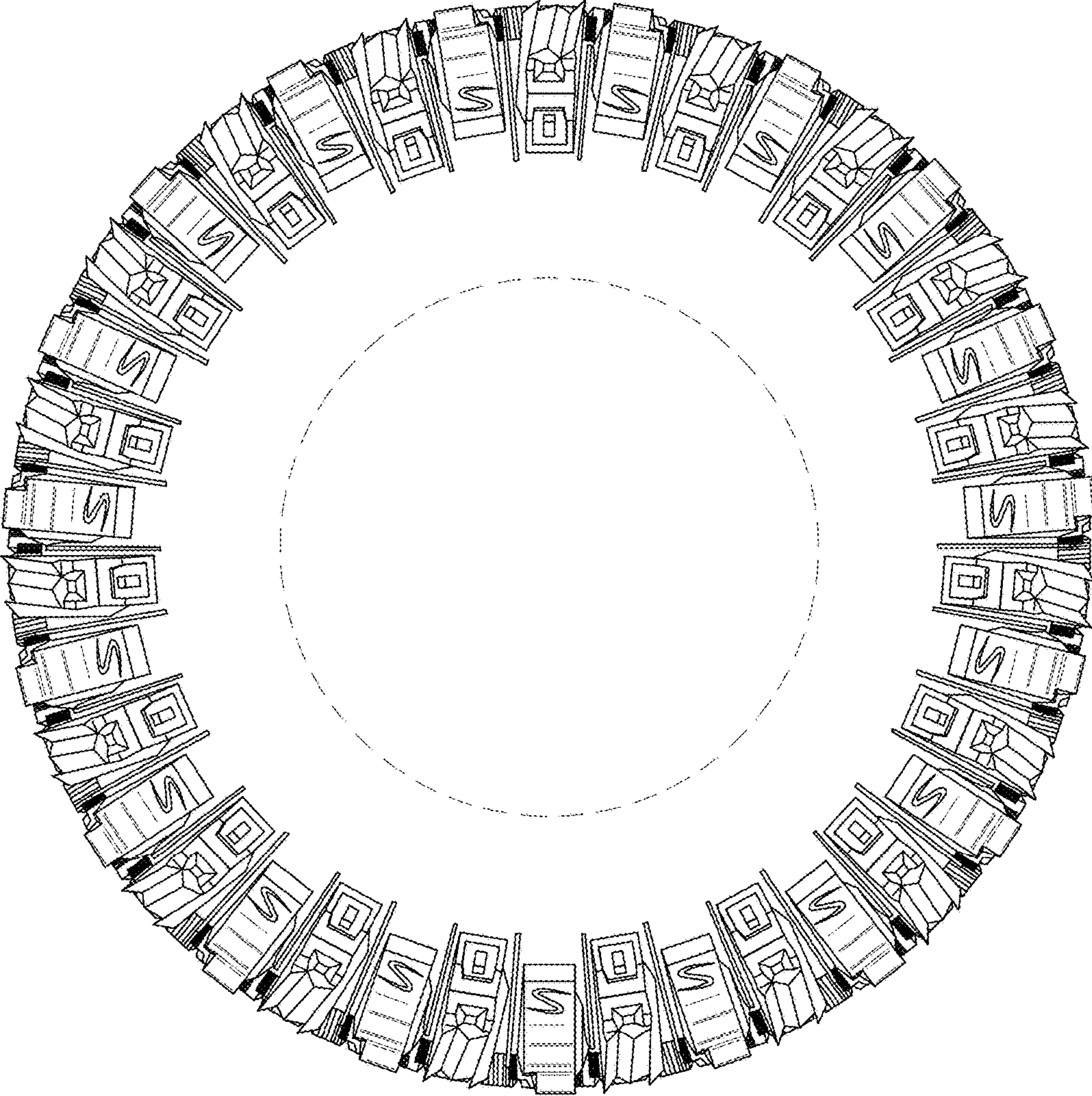

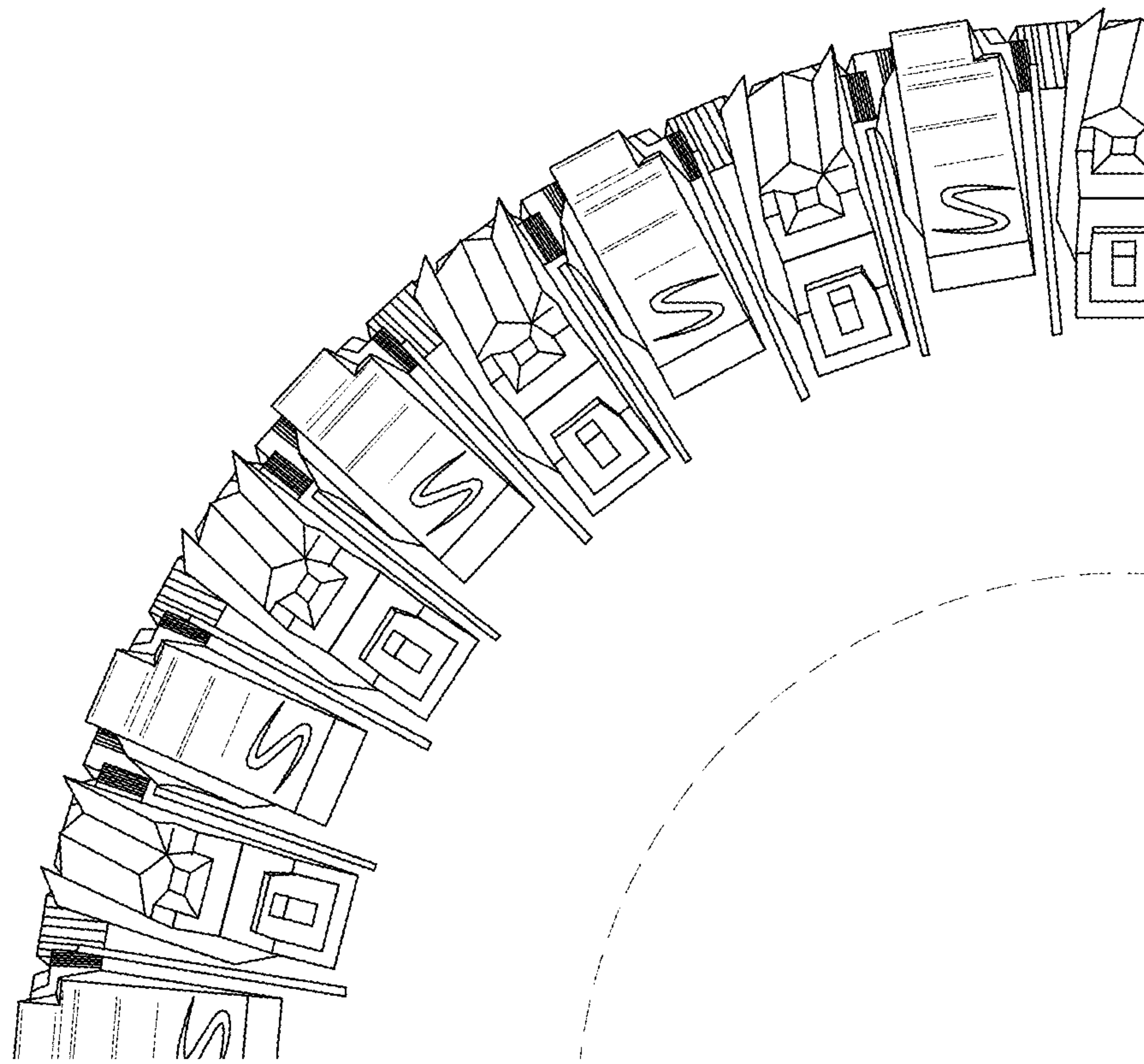
