(57) **CLAIM**

The ornamental design for a protective housing for a transformer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a protective housing for a transformer showing our new design; FIG. 2 is a back elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a side elevational view of the right side thereof; FIG. 6 is a side elevational view of the left side thereof; and, FIG. 7 is a top, front, and right side perspective view thereof. 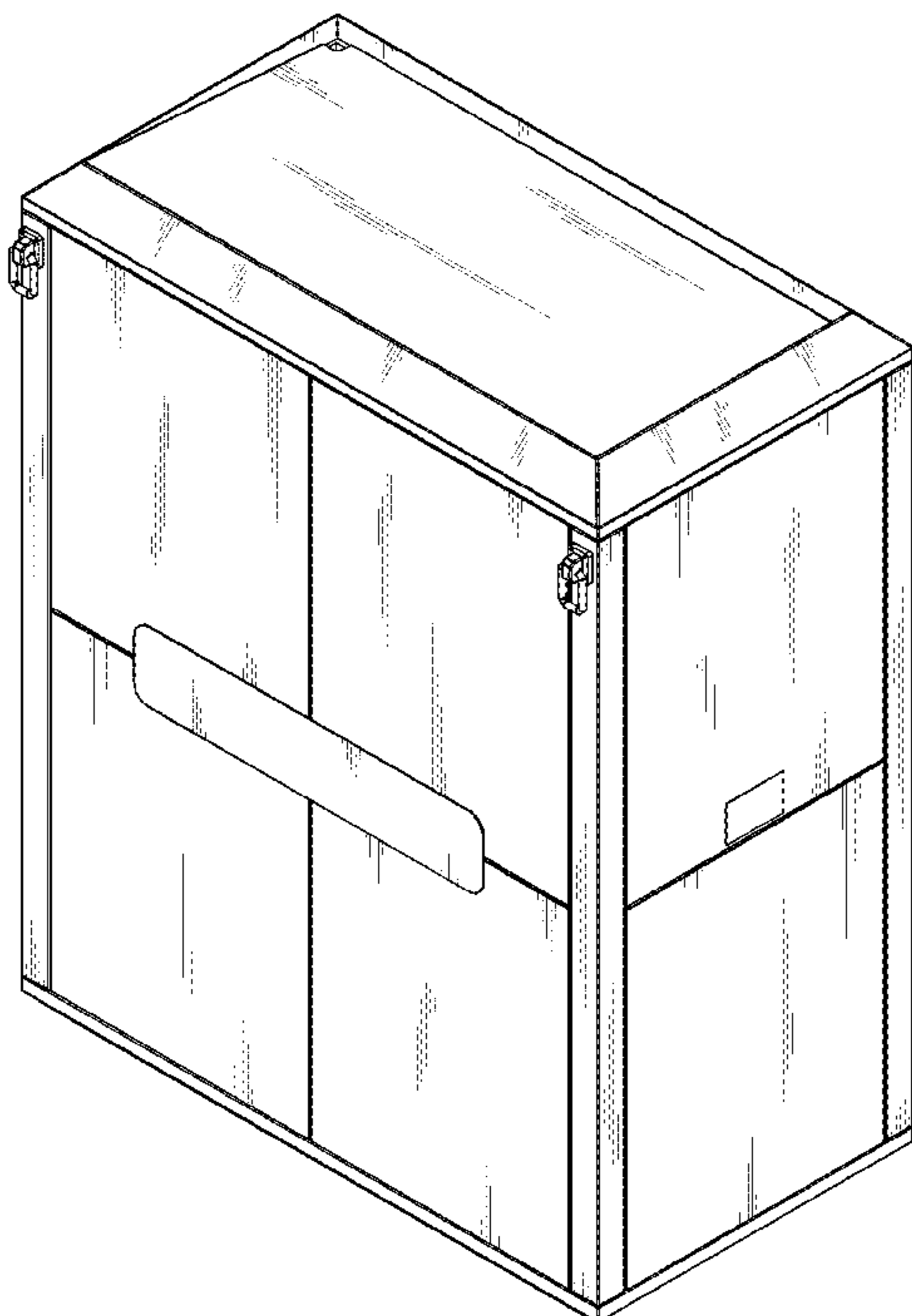

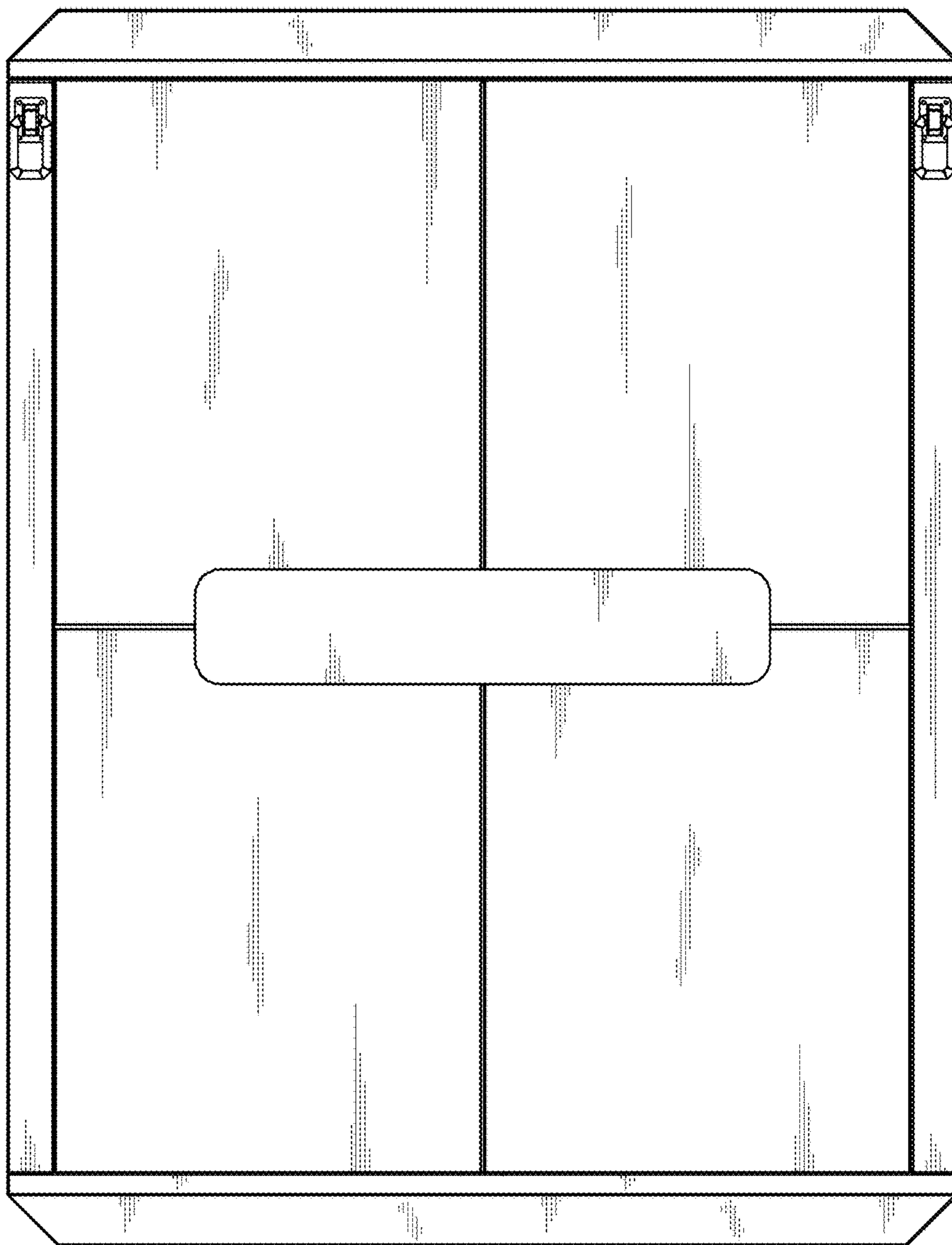

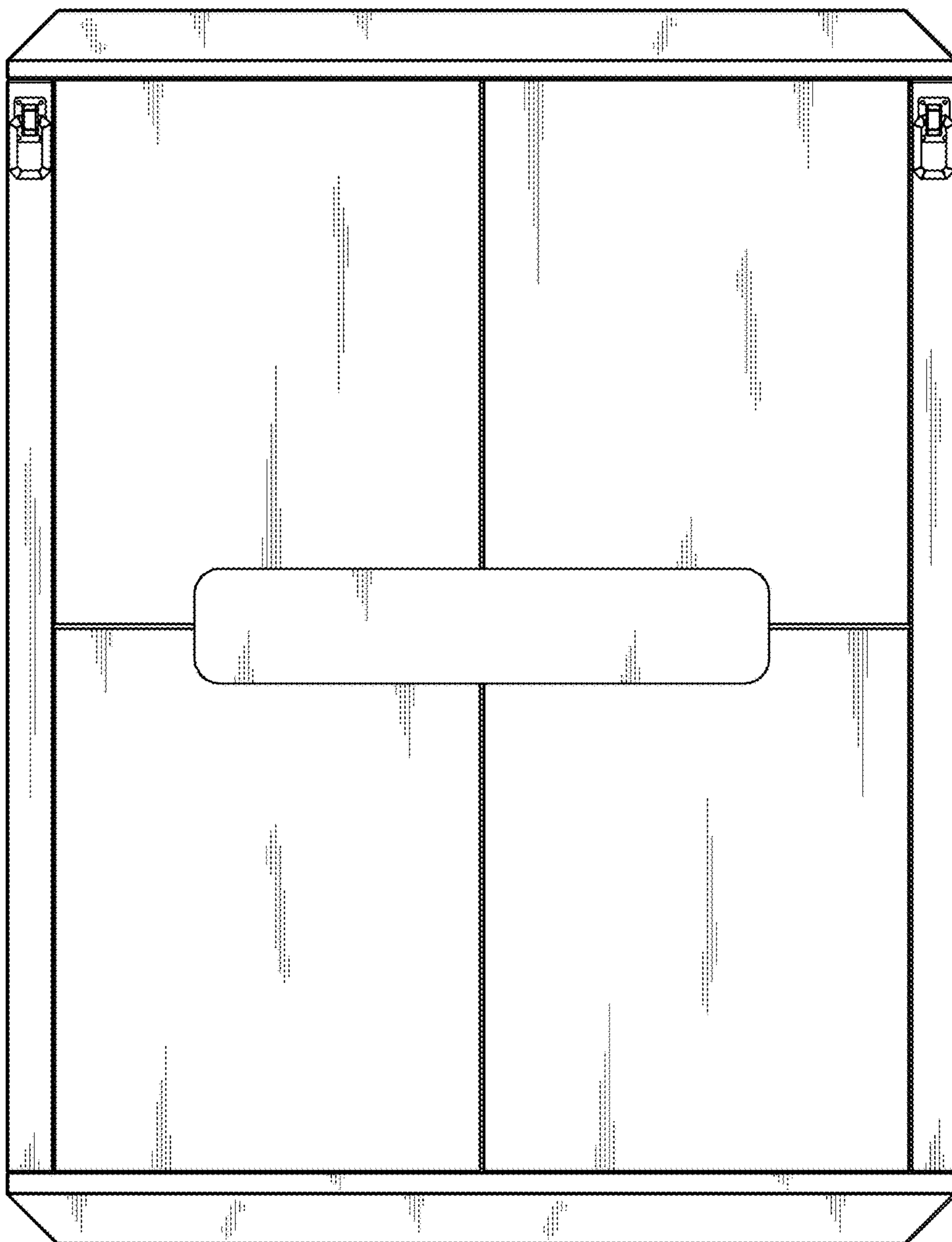

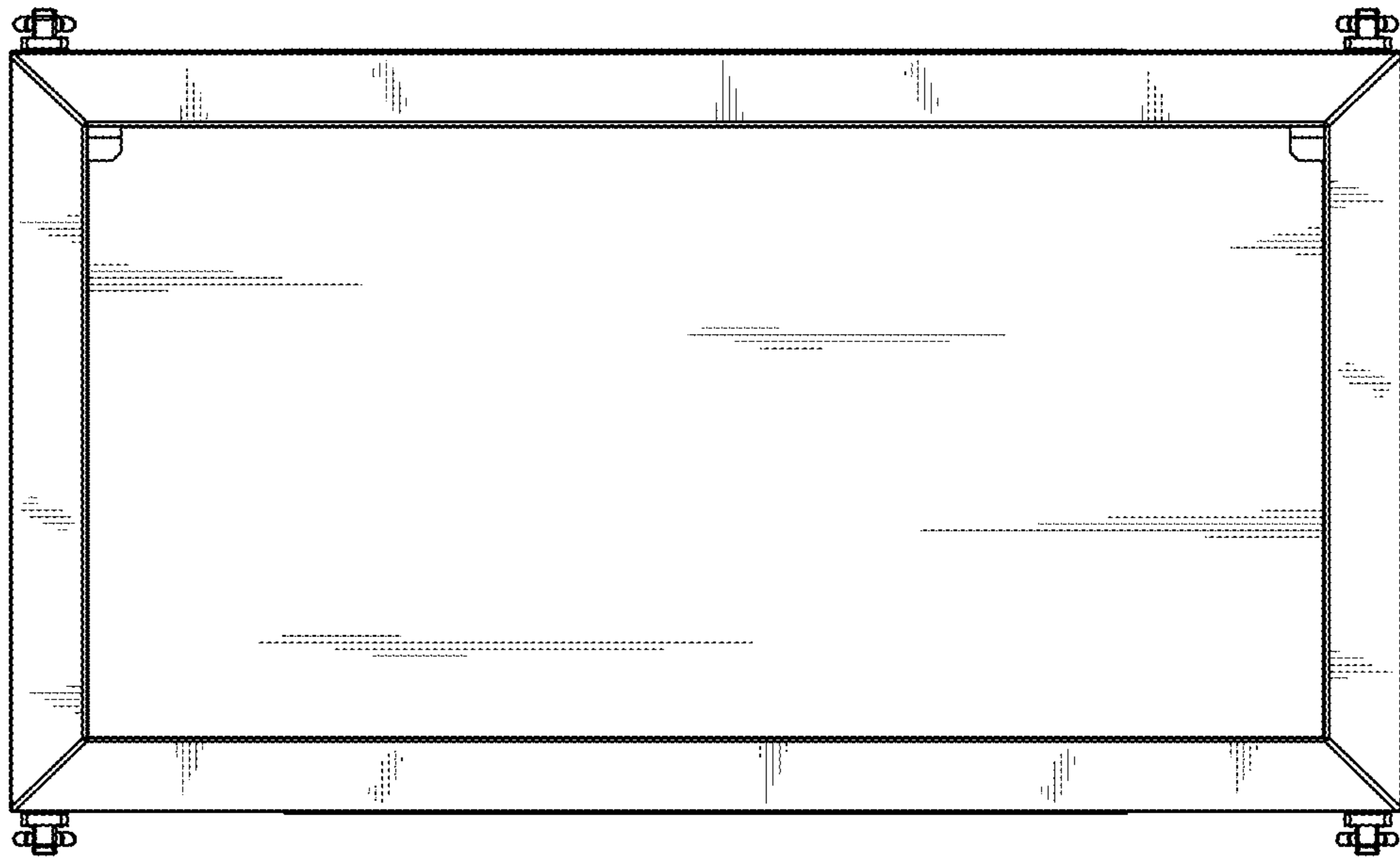

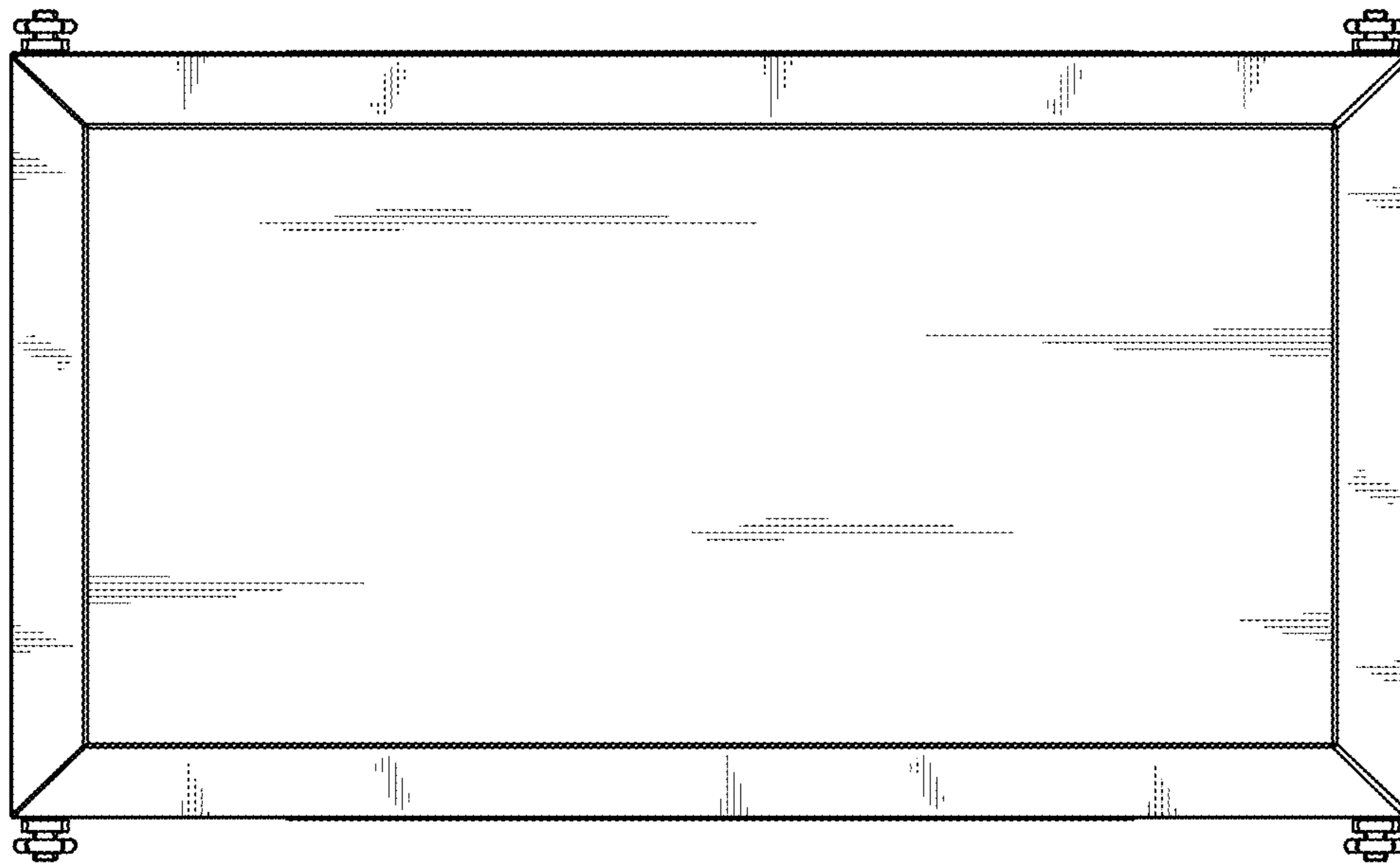

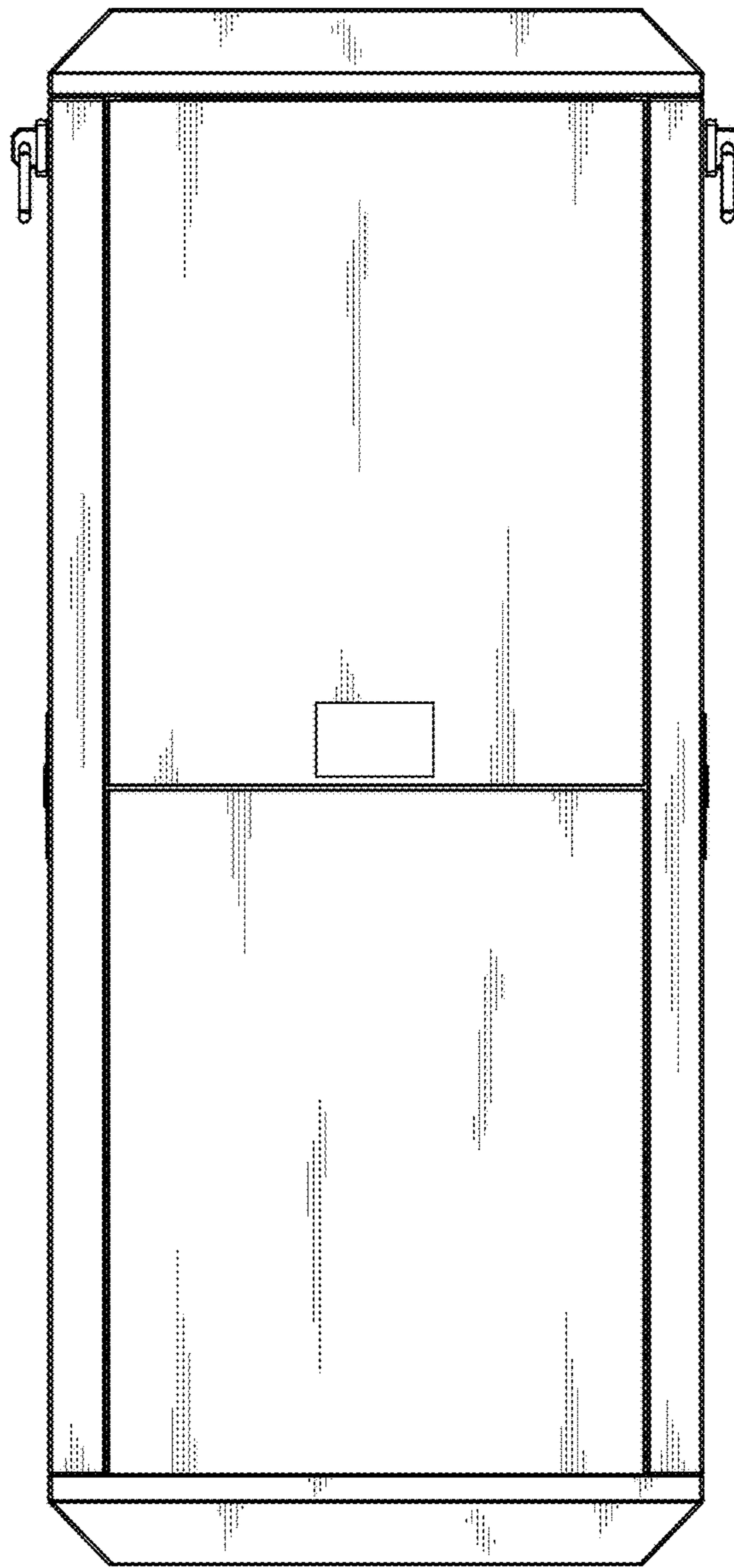

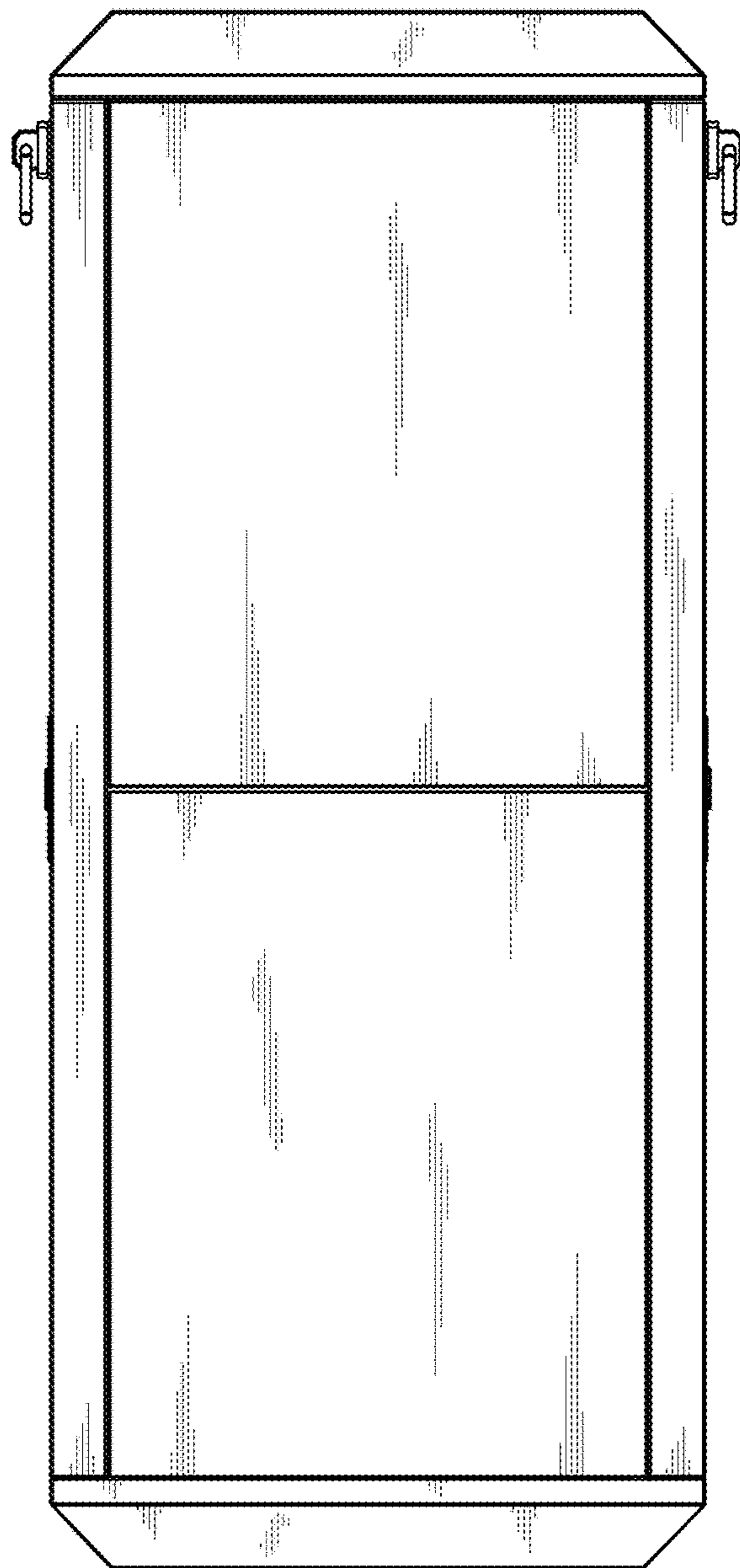
