FIG. 1 is a front perspective view of a pair of coupling features on a circuit board, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevation view thereof, the rear elevation view thereof being identical; and,

FIG. 5 is a front perspective view thereof in an unclaimed environment of use.

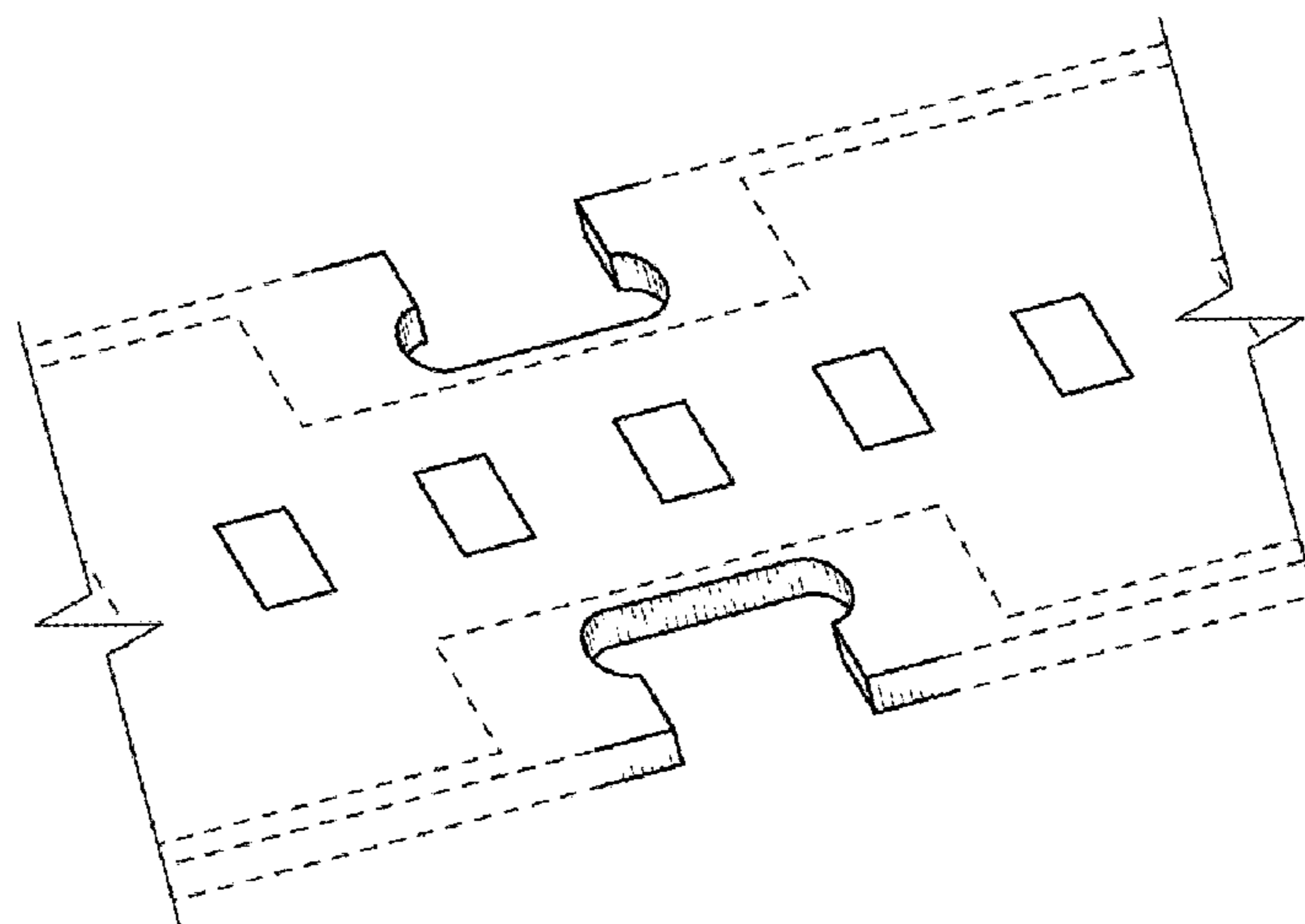

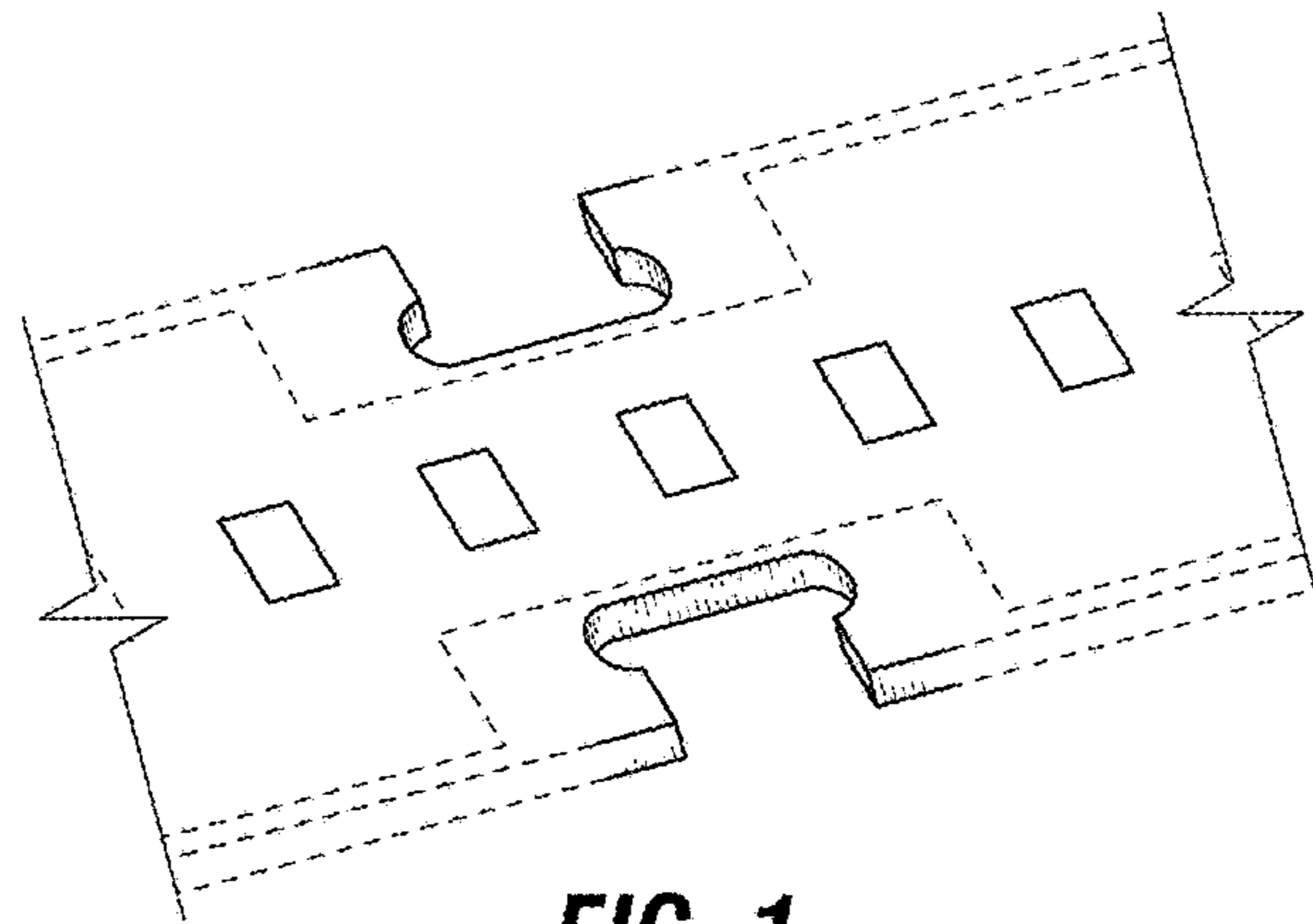

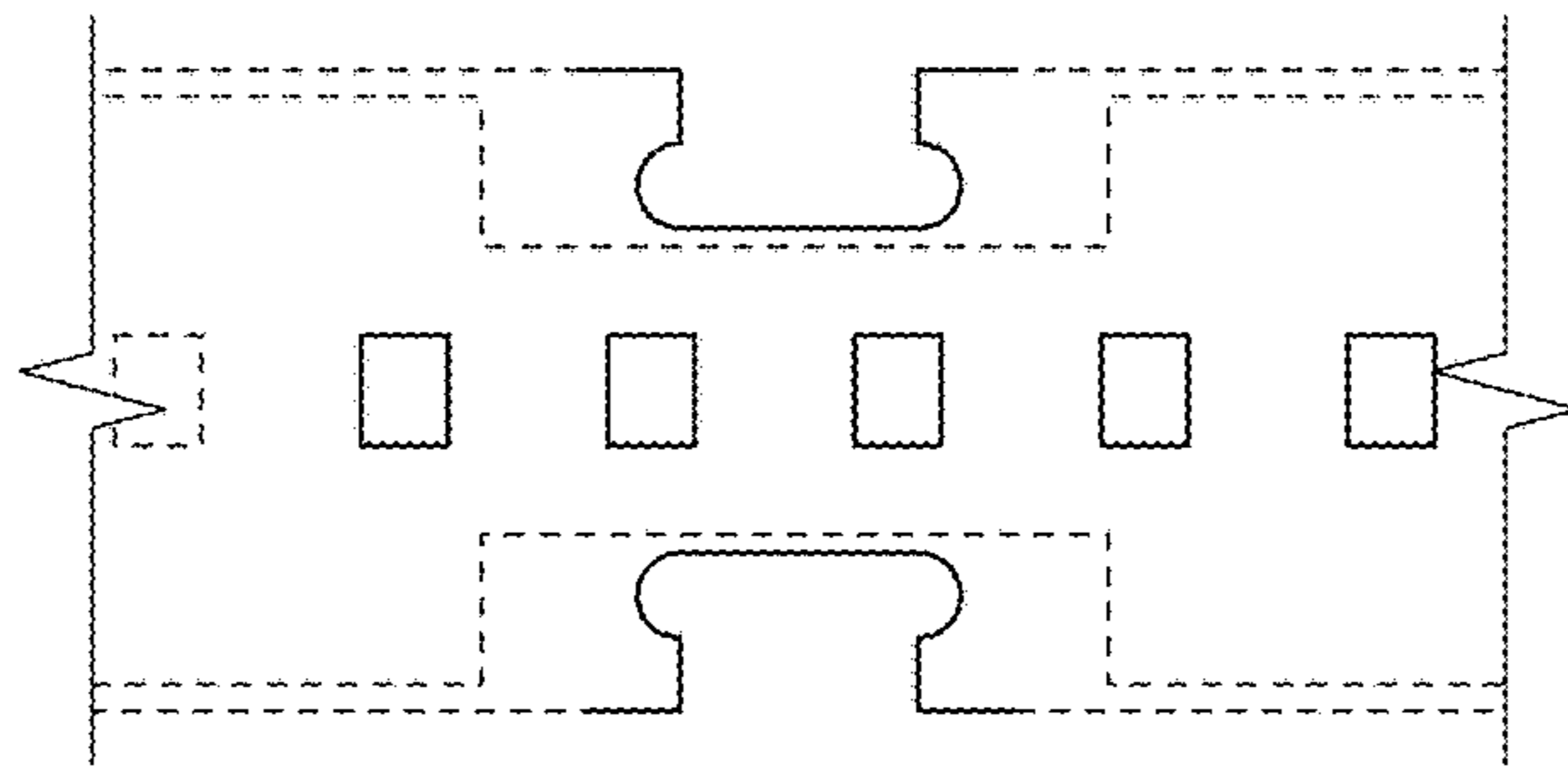

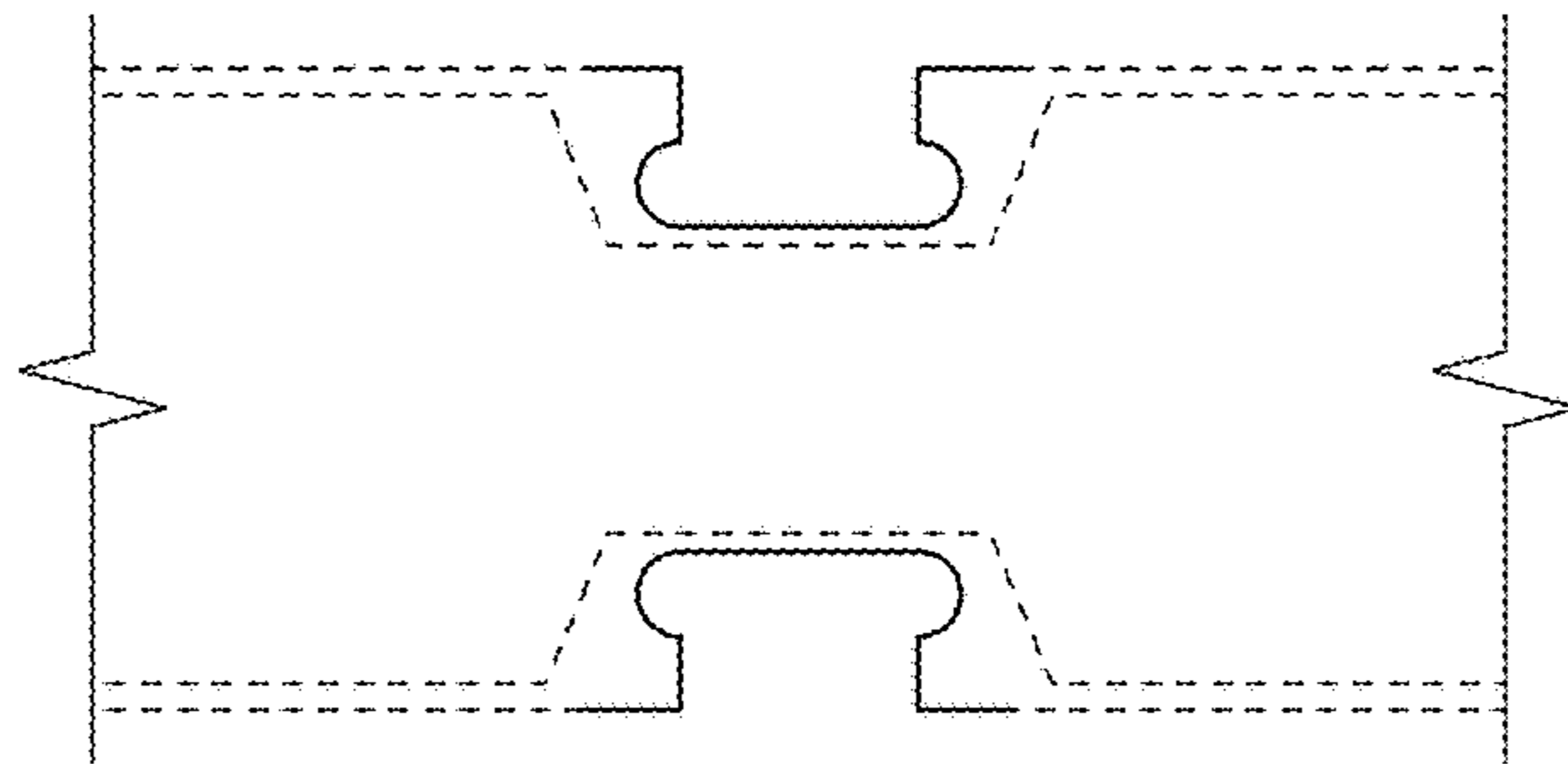

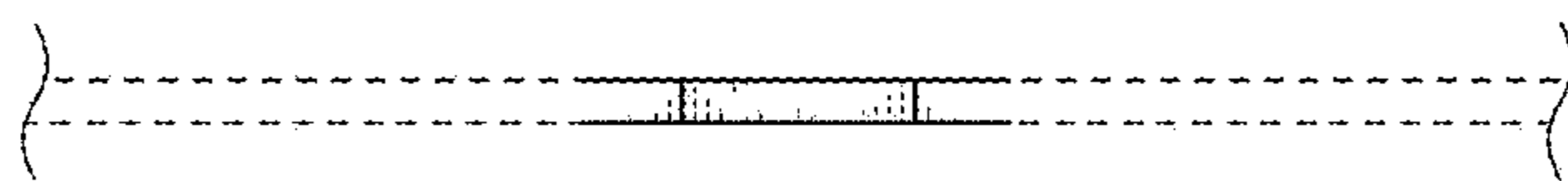

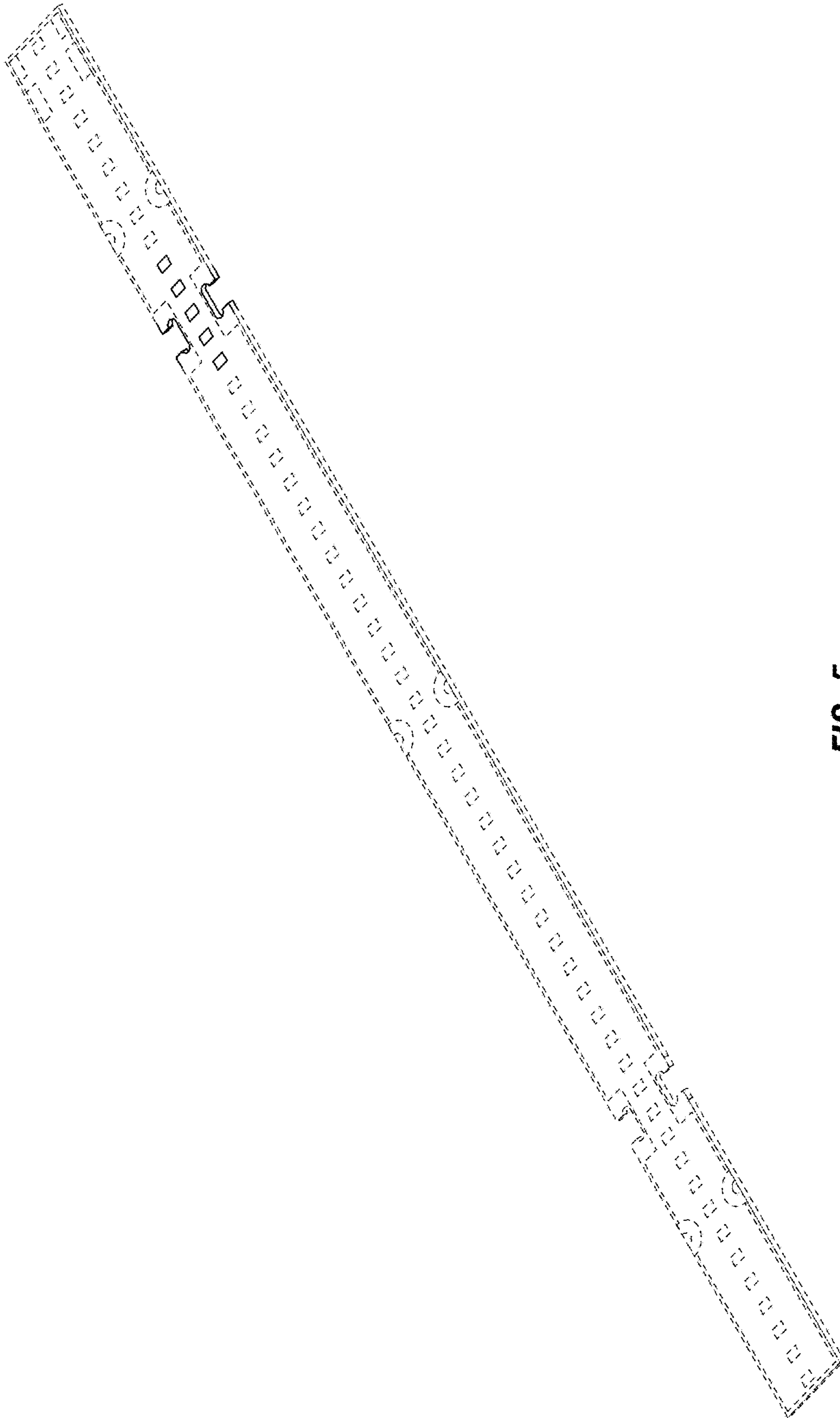
