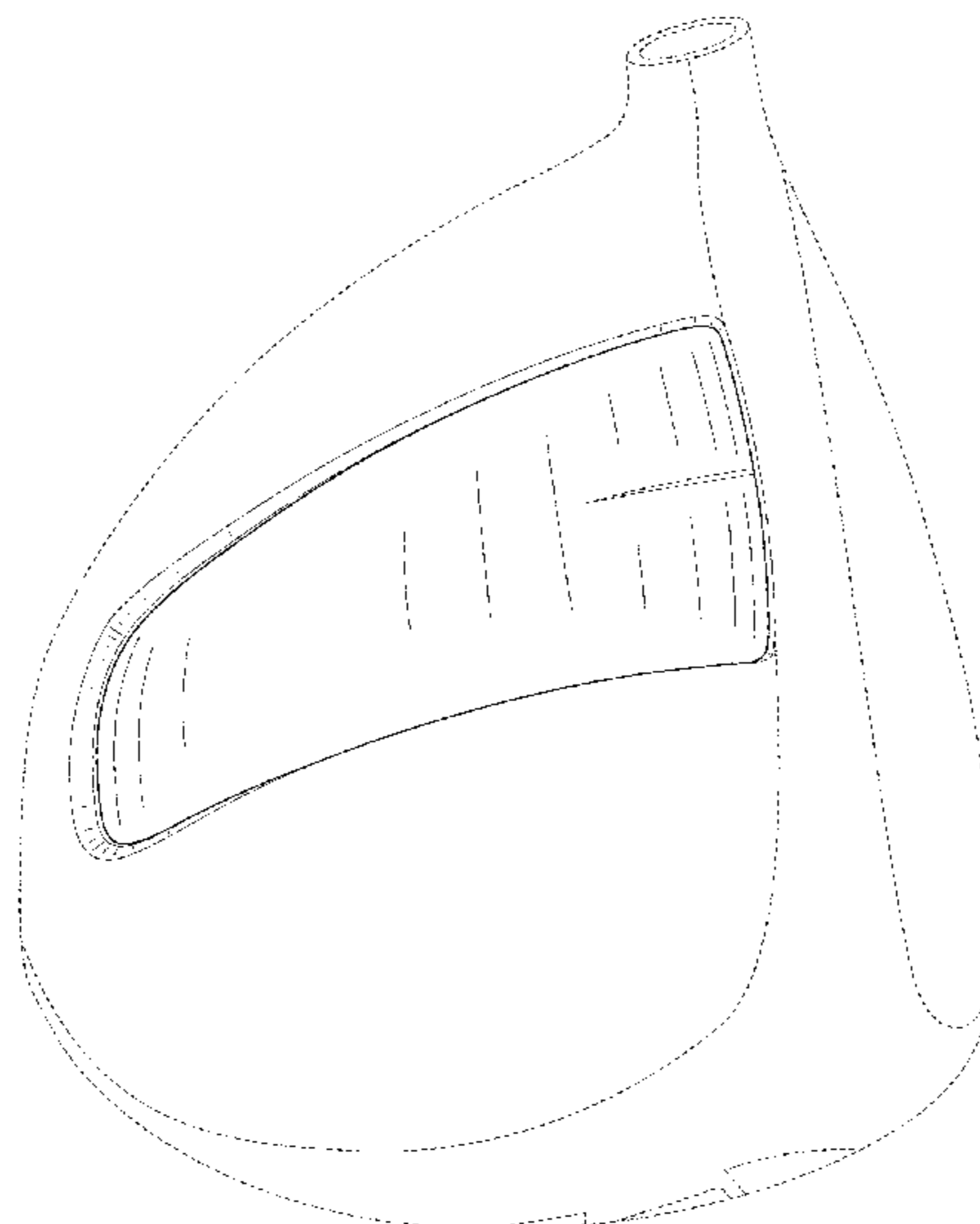
(57) **CLAIM**

I claim the ornamental design for a crown of a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side perspective view of a crown of a golf club head of the present design;  
FIG. 2 is a top view of the crown of a golf club head of FIG. 1;  
FIG. 3 is a front view of the crown of a golf club head of FIG. 1;  
FIG. 4 is a rear view of the crown of a golf club head of FIG. 1;  
FIG. 5 is a toe end view of the crown of a golf club head of FIG. 1; and,  
FIG. 6 is a heel end view of the crown of a golf club head of FIG. 1.  
The ornamental design that is claimed is shown in solid lines in the drawings. The broken (dashed) lines shown in FIGS. 1 through 7 are included only for the purpose of illustrating environmental elements, and form no part of the claimed design.

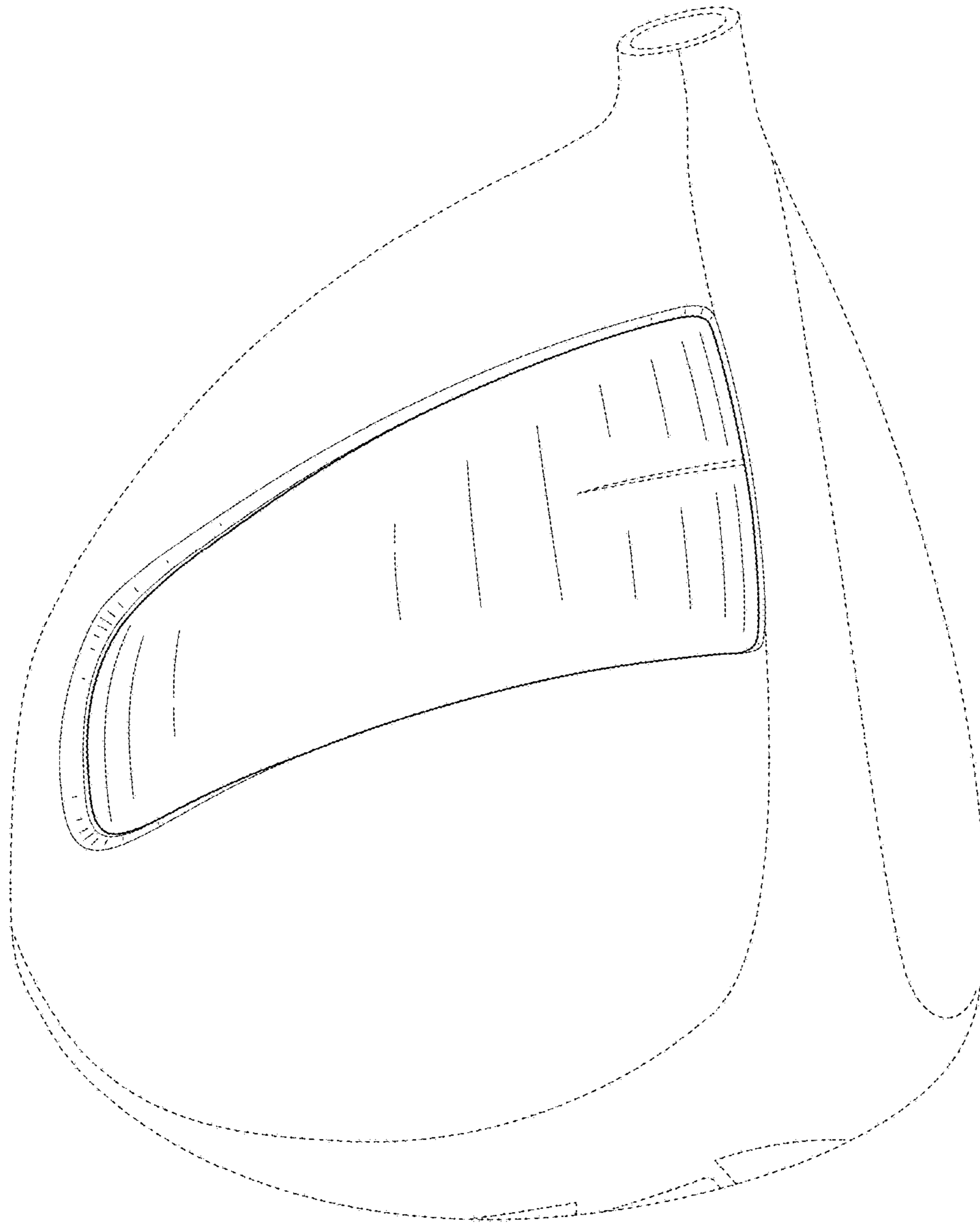

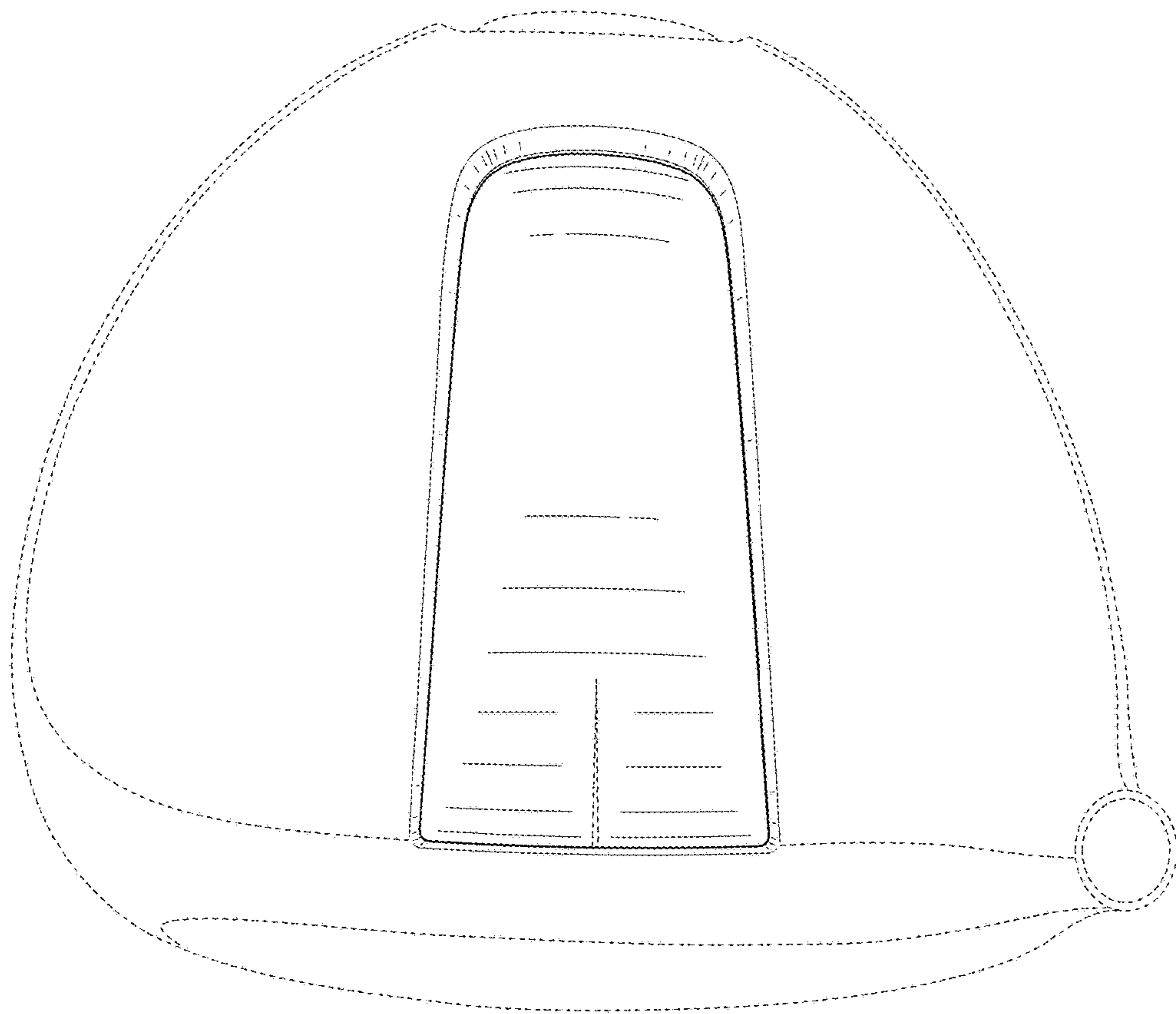

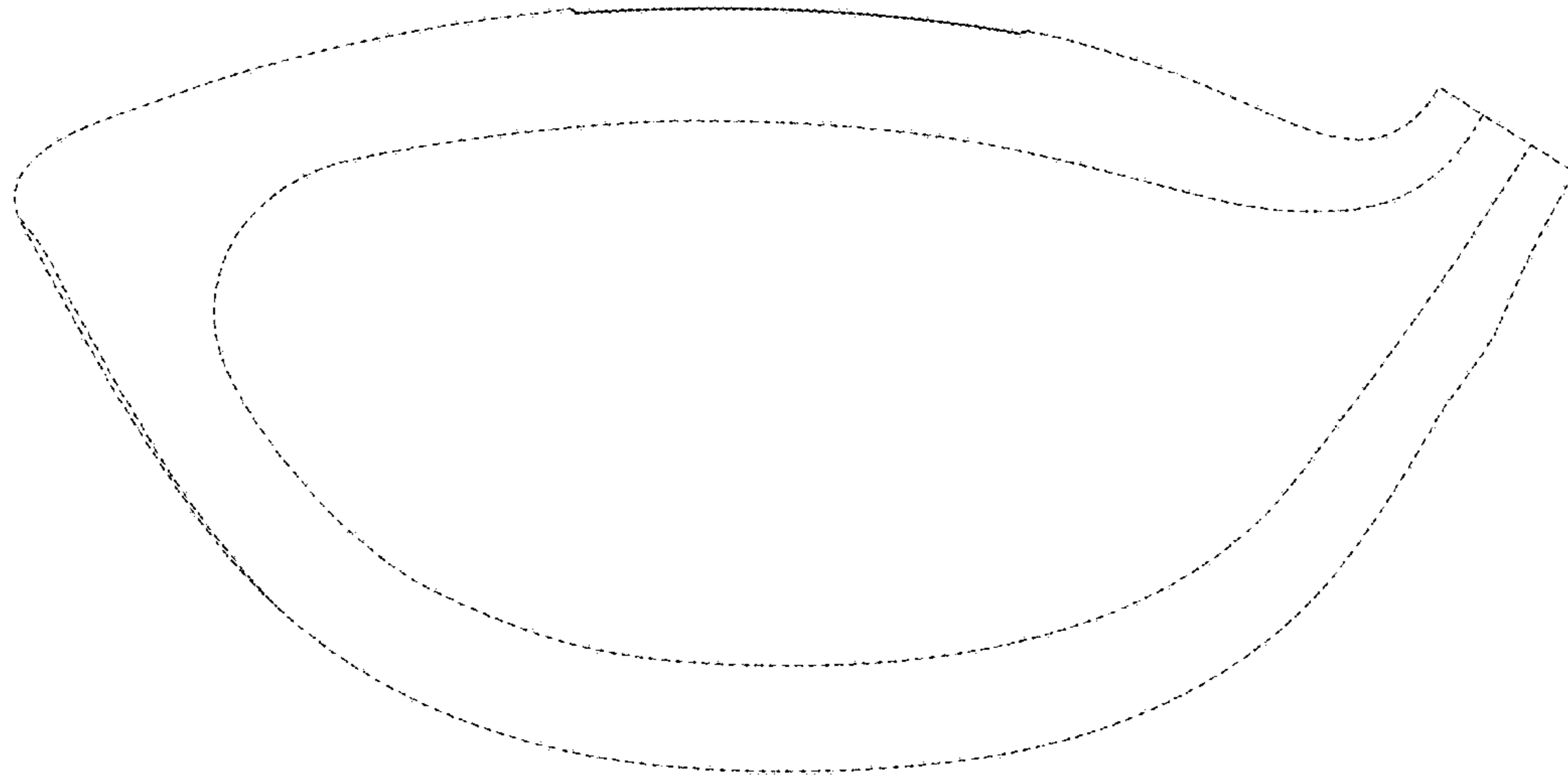

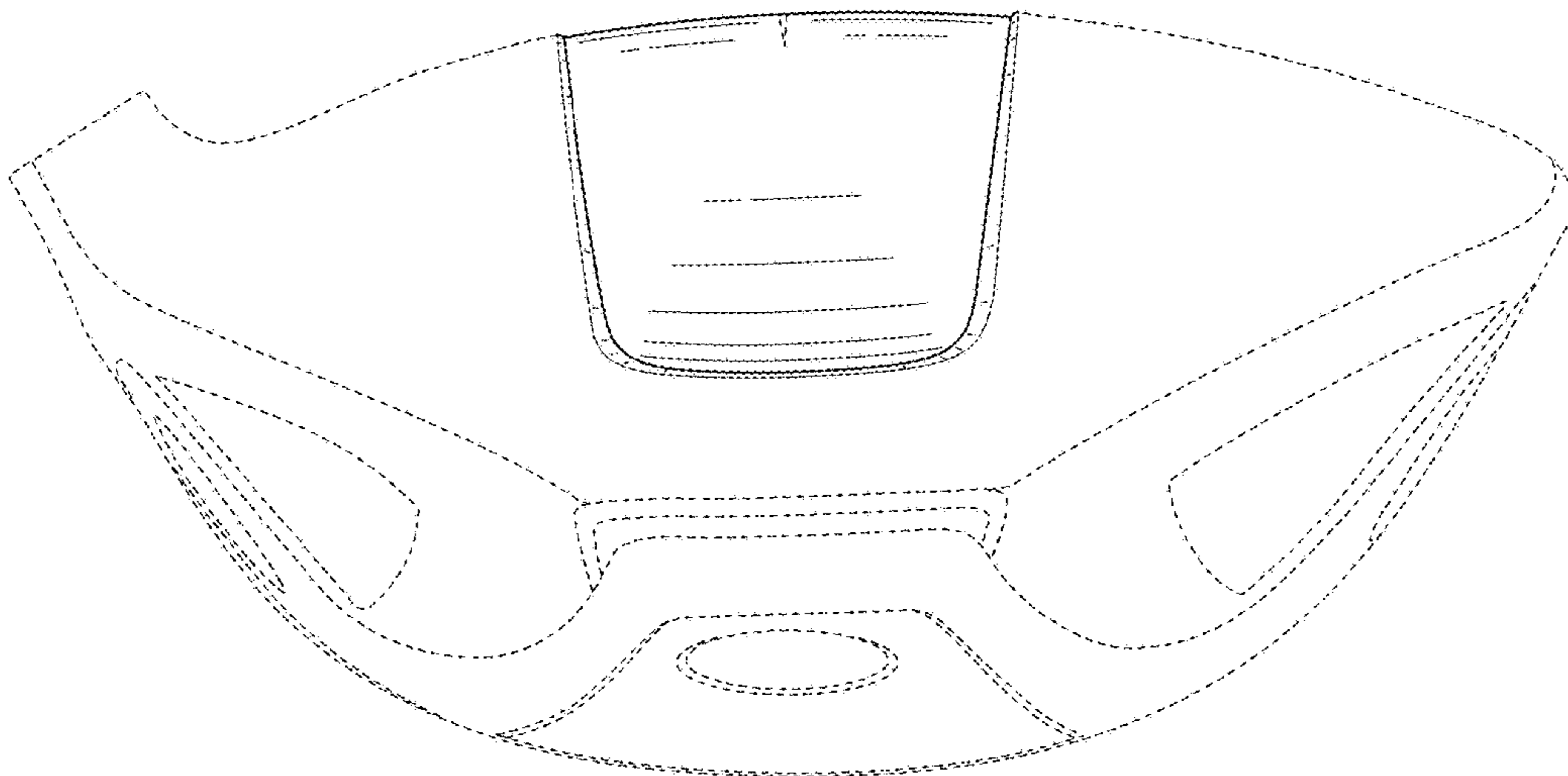

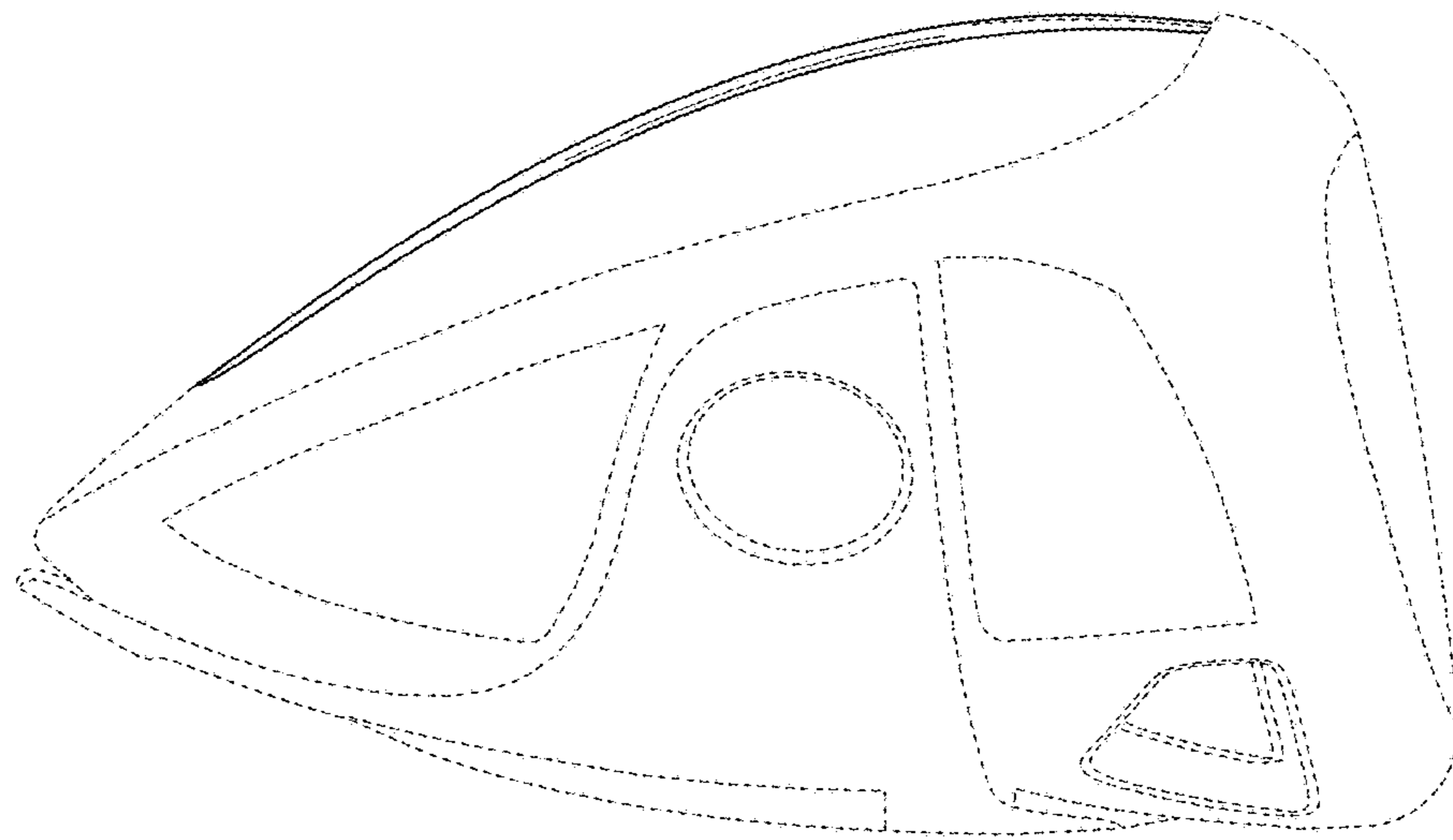

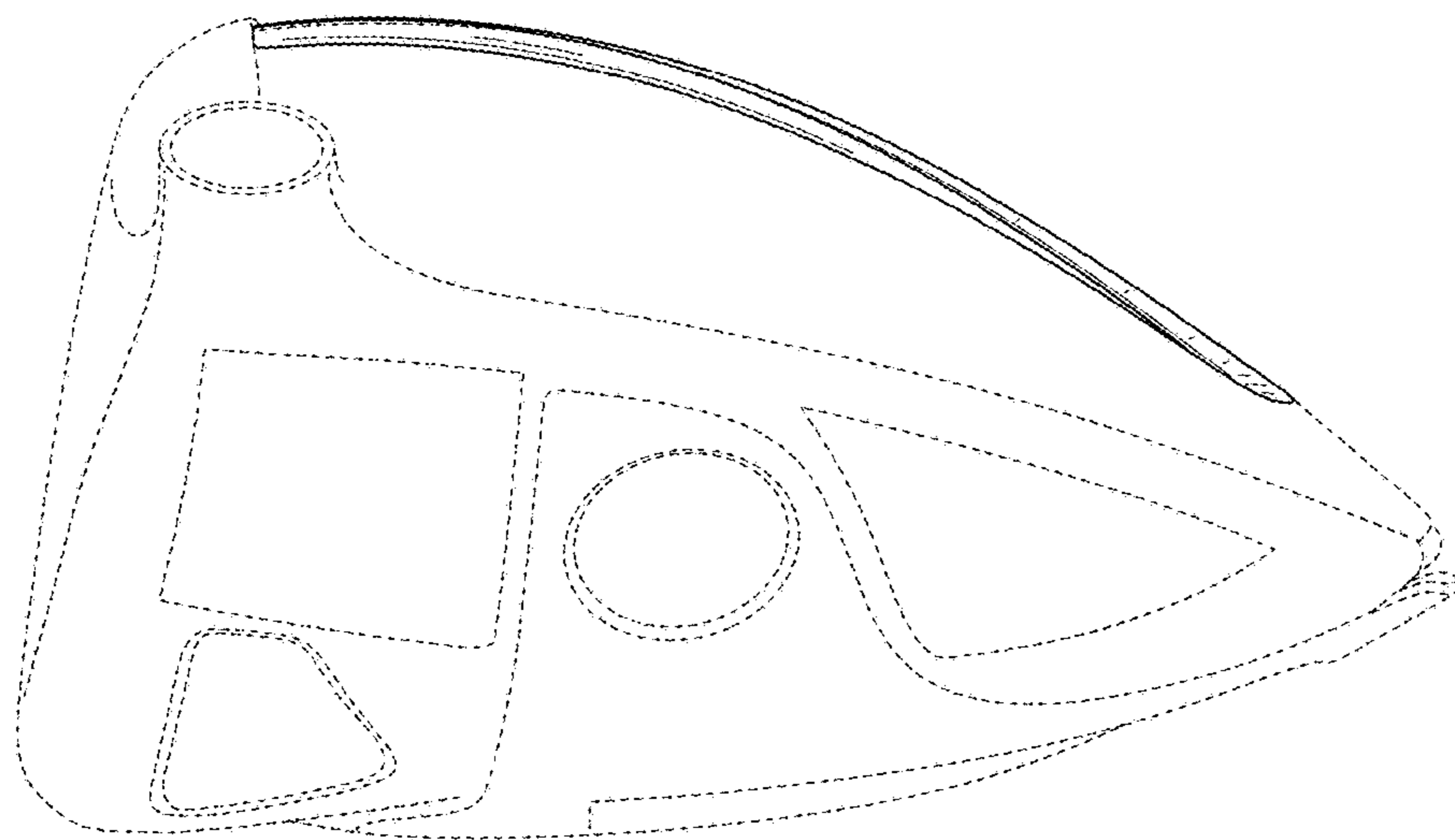
