design.

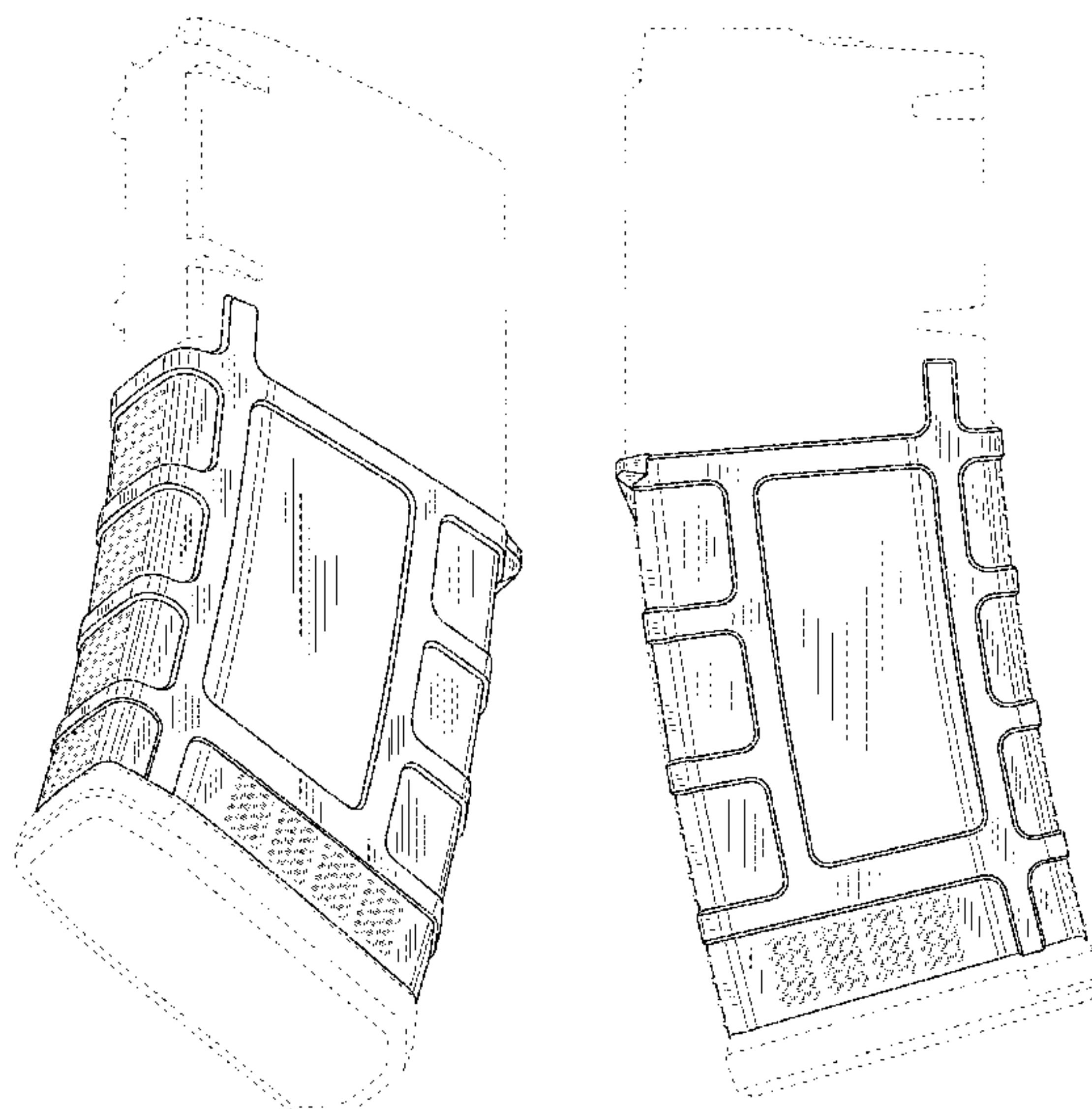

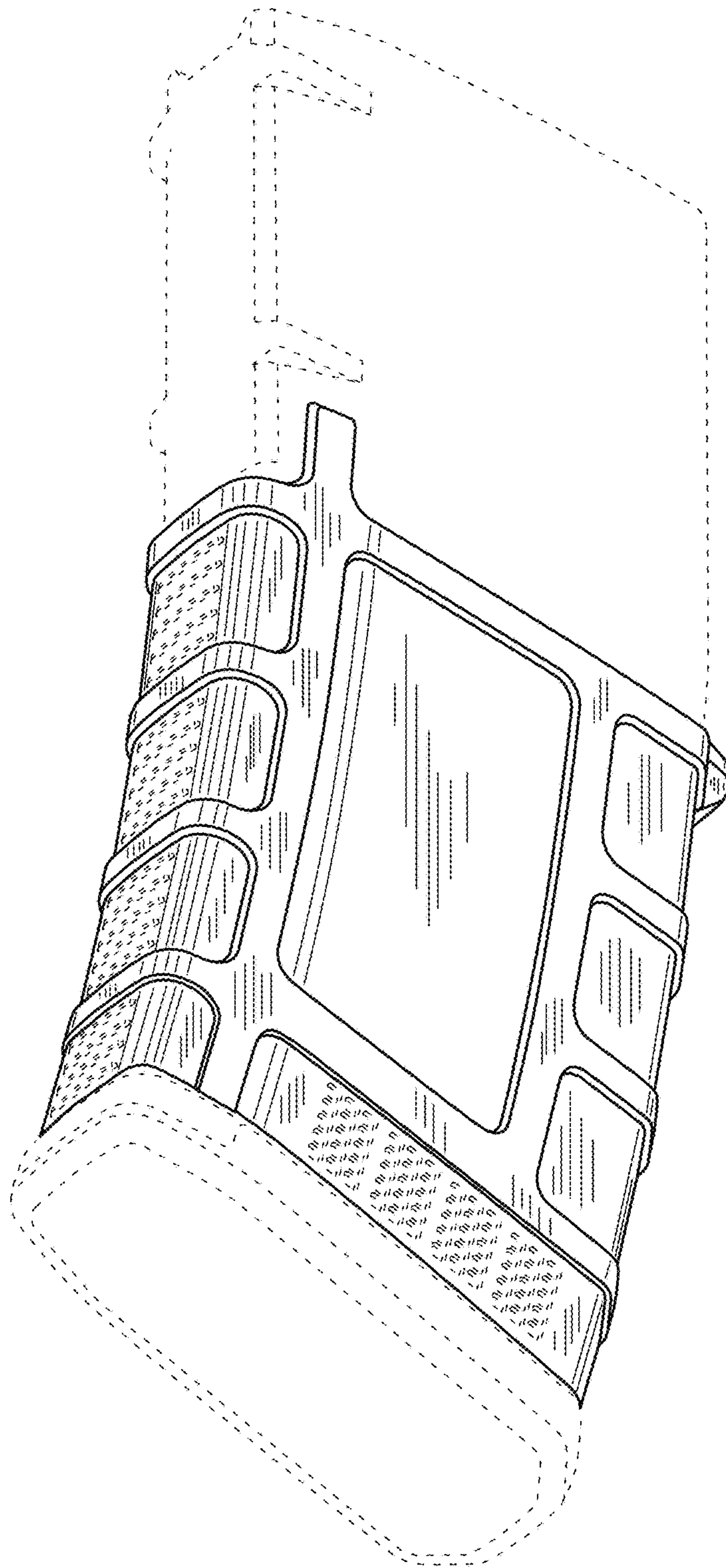

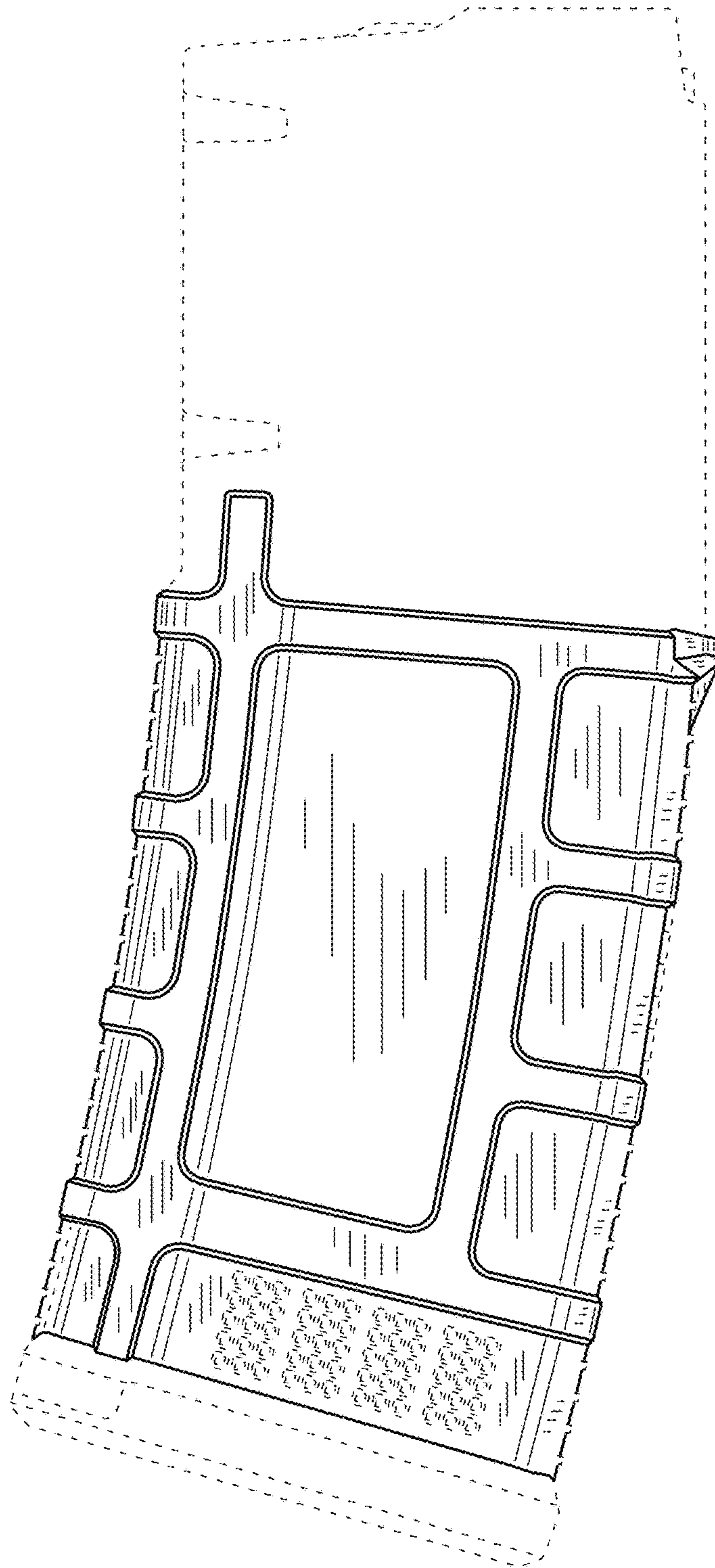

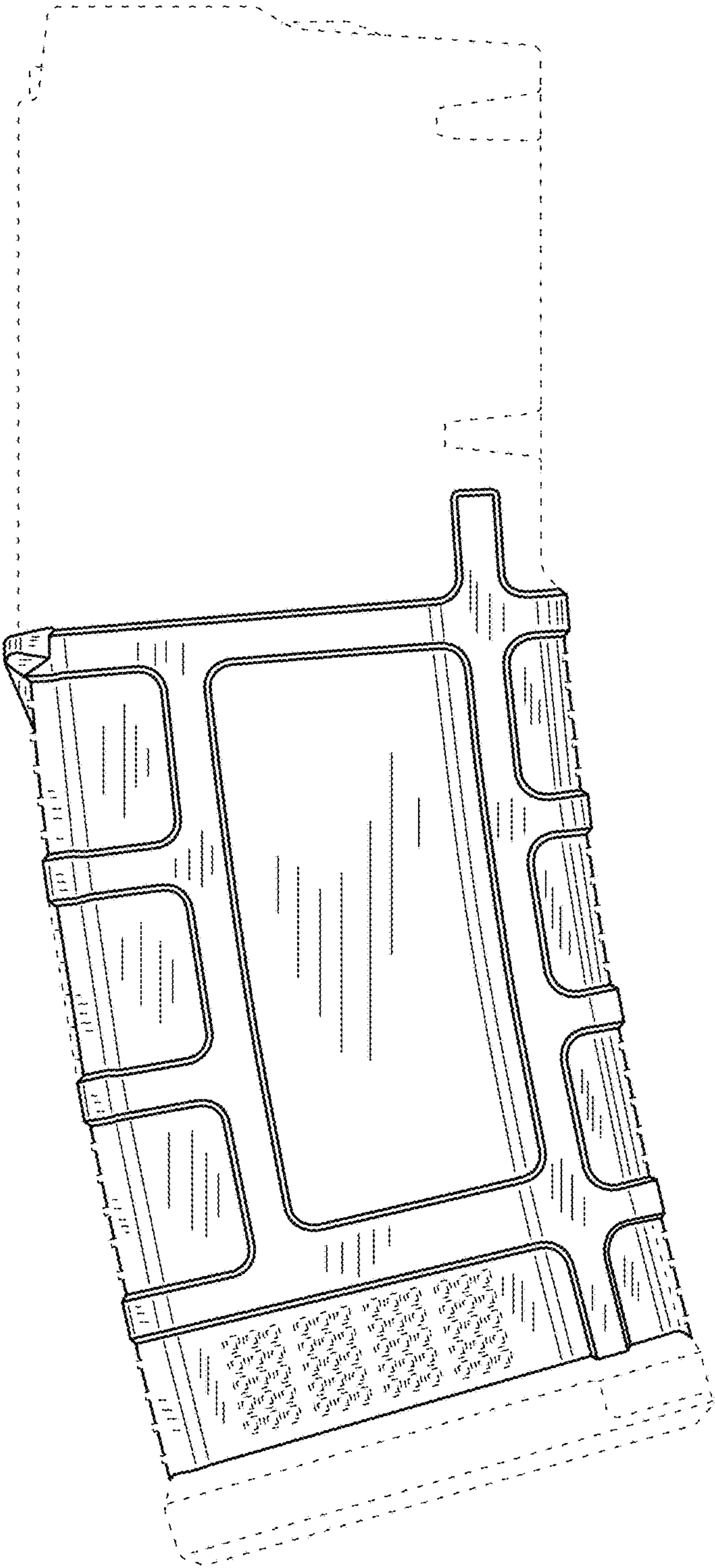

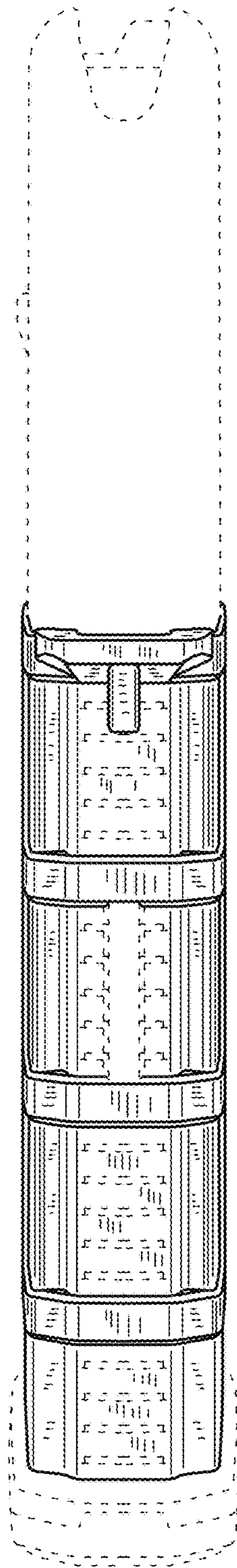

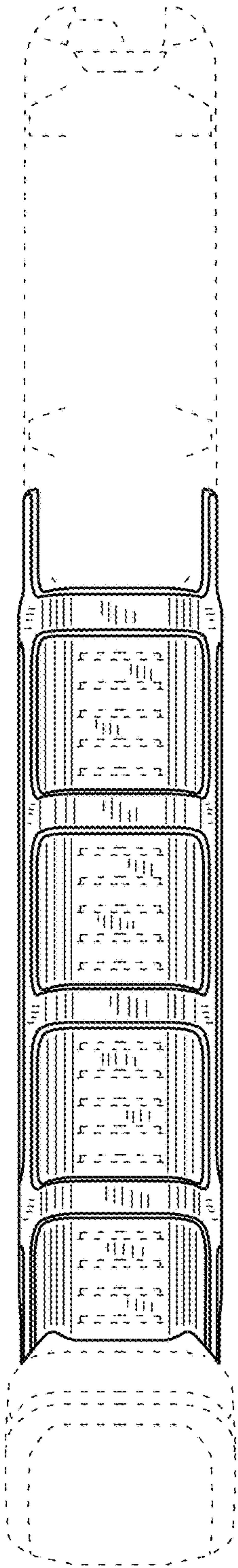

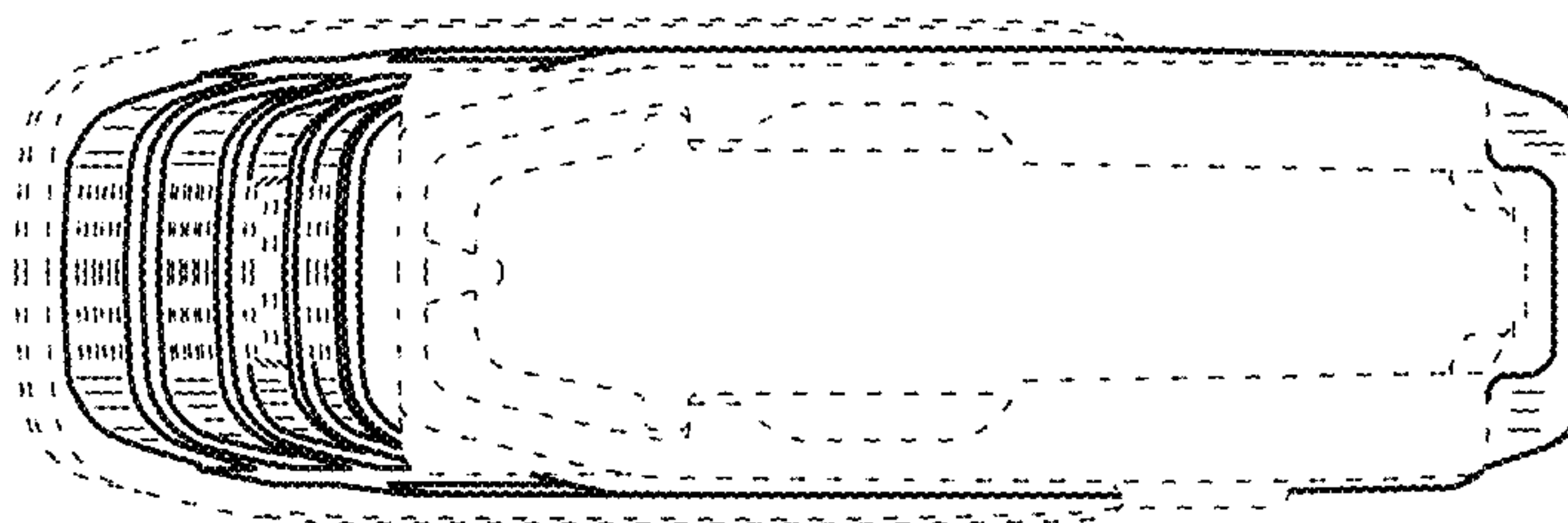

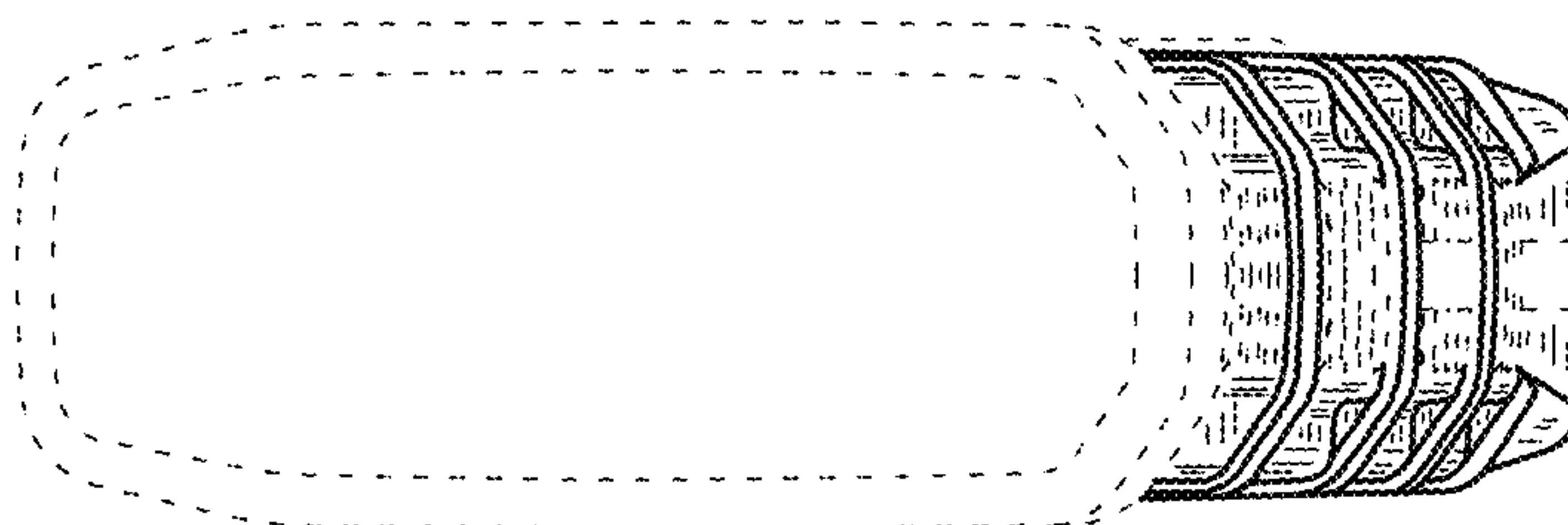
