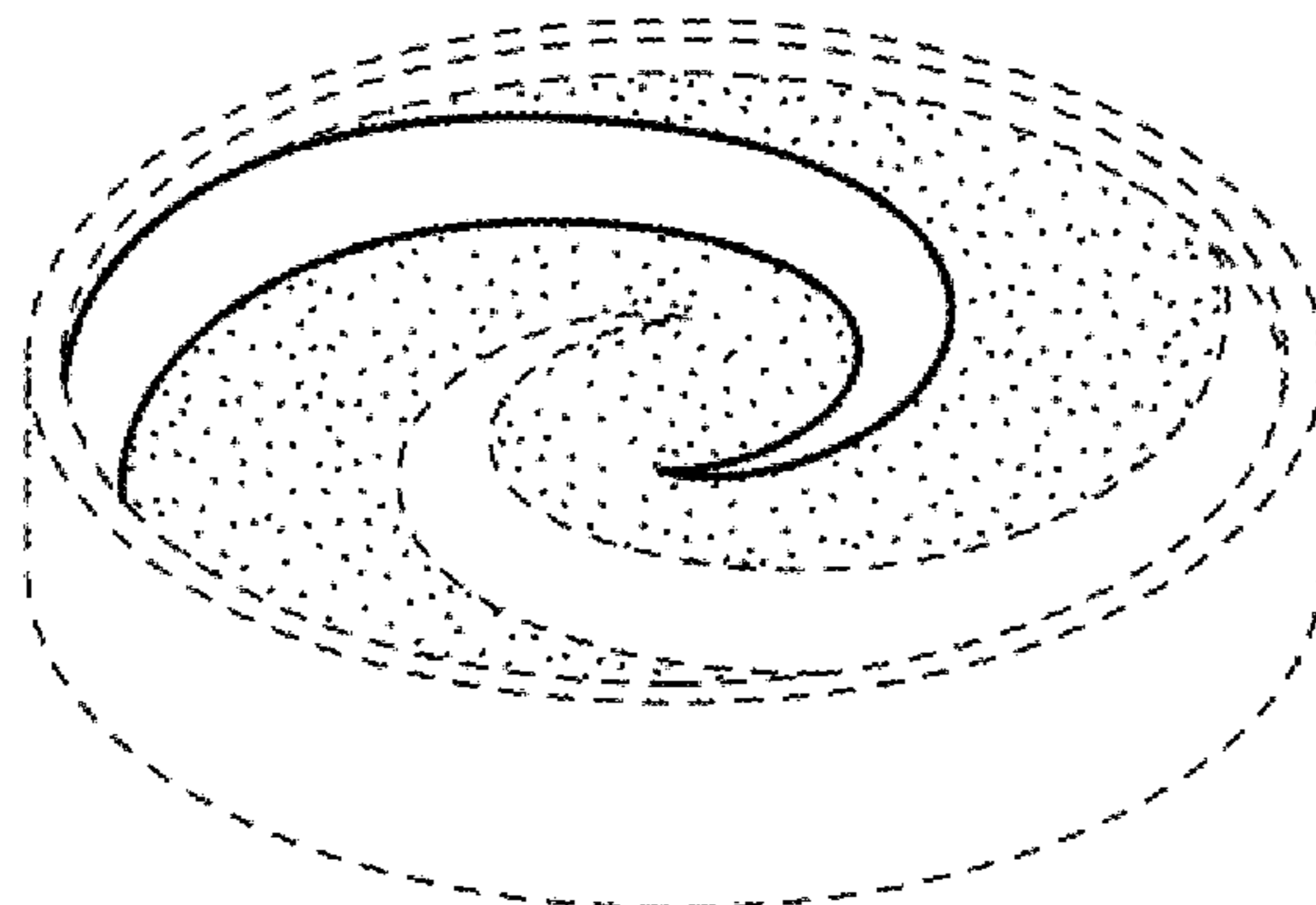
FIG. 1 is a perspective view of a cosmetic product, embodying our new design;

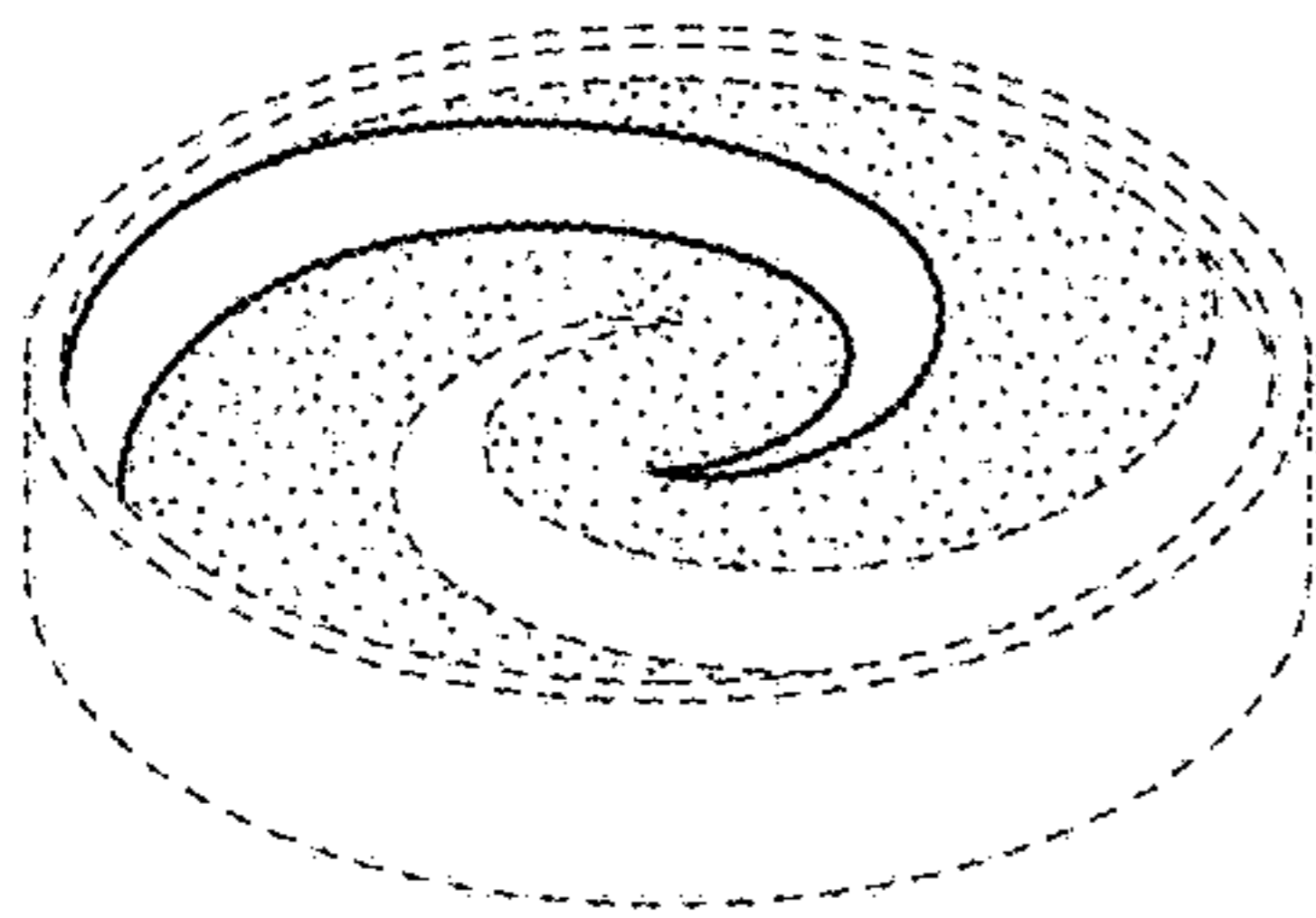

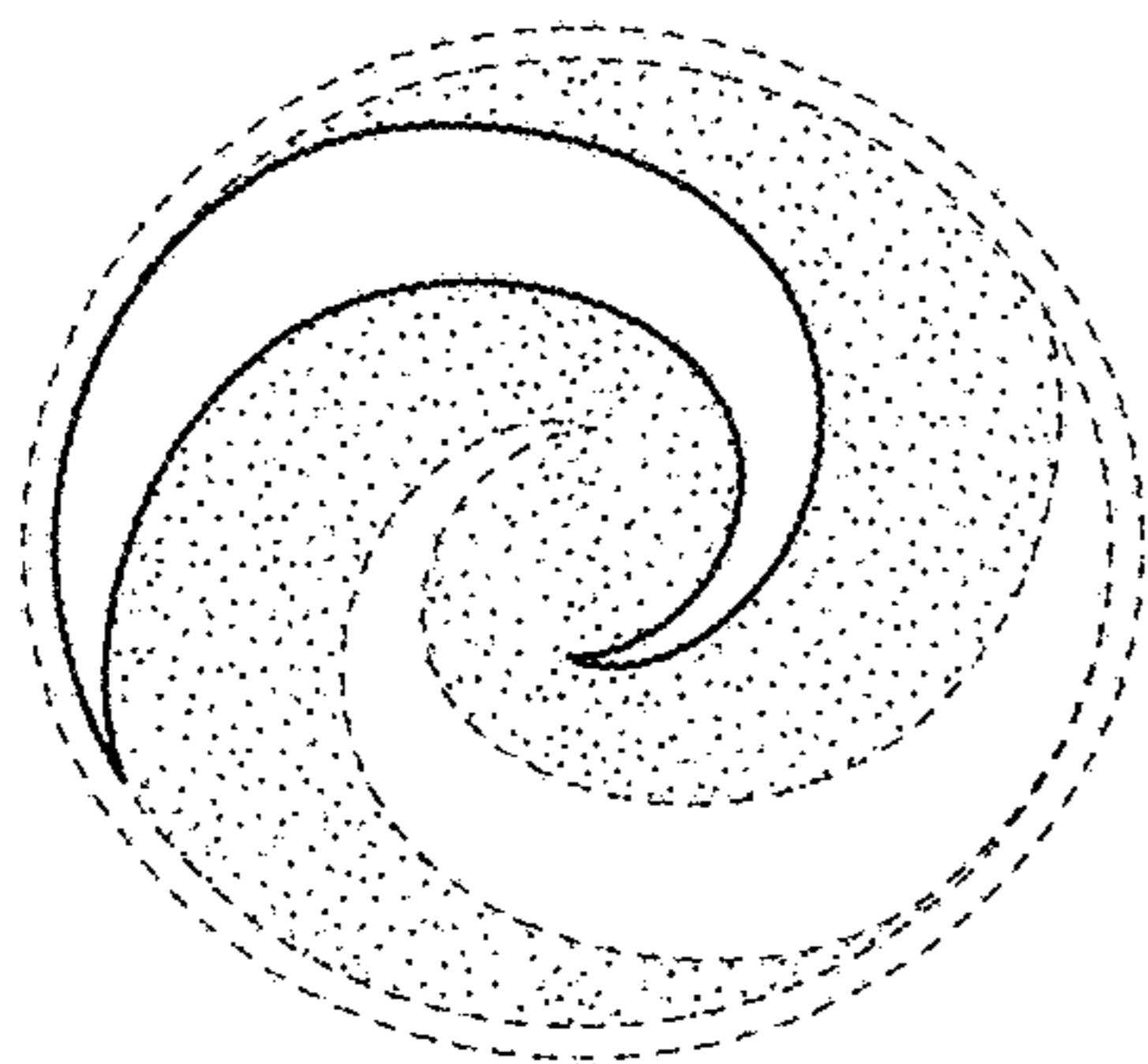

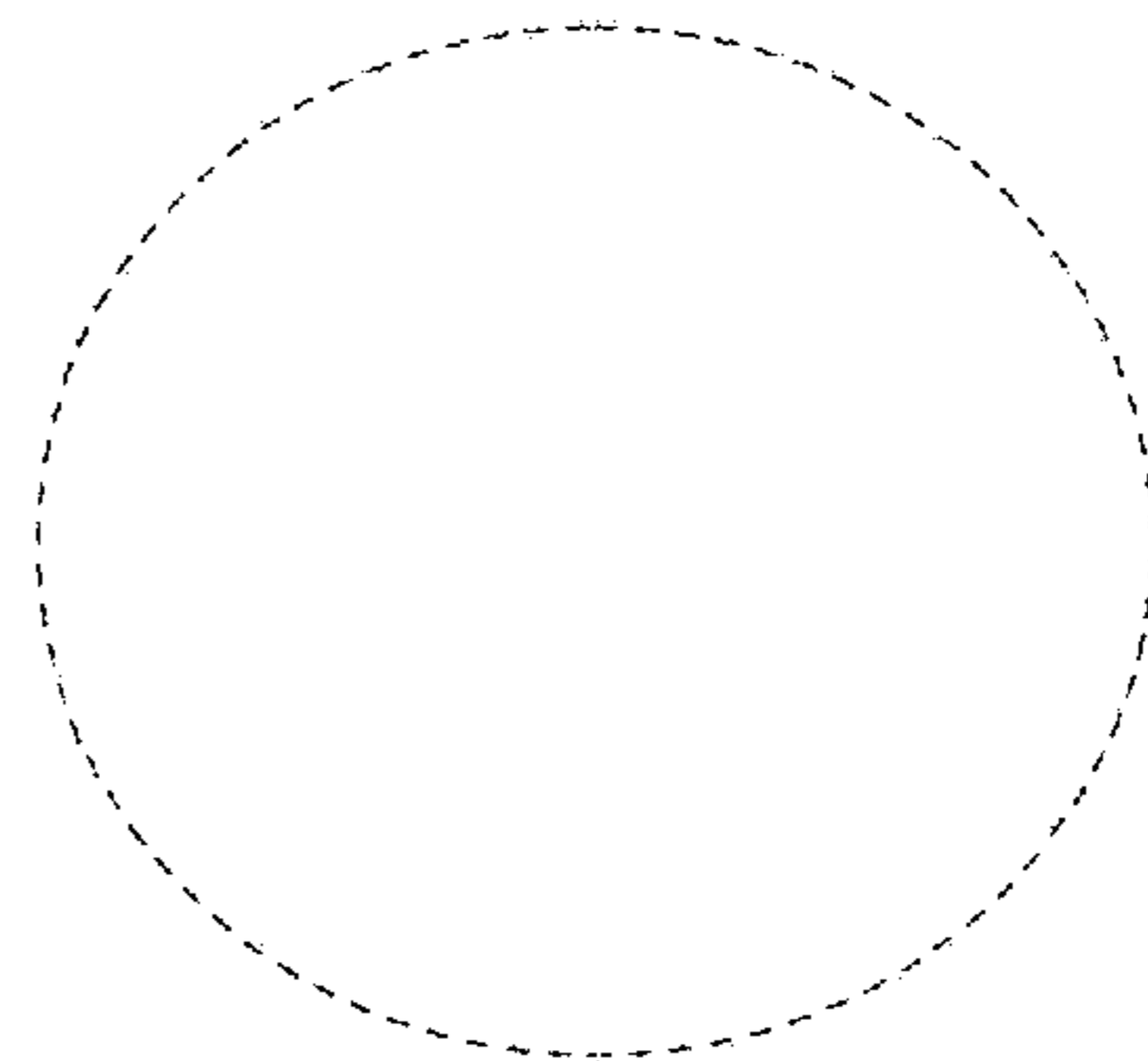

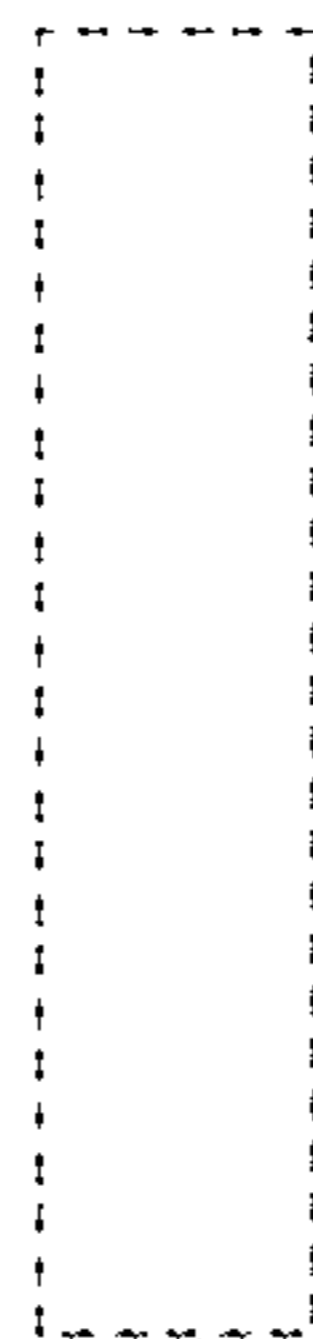
