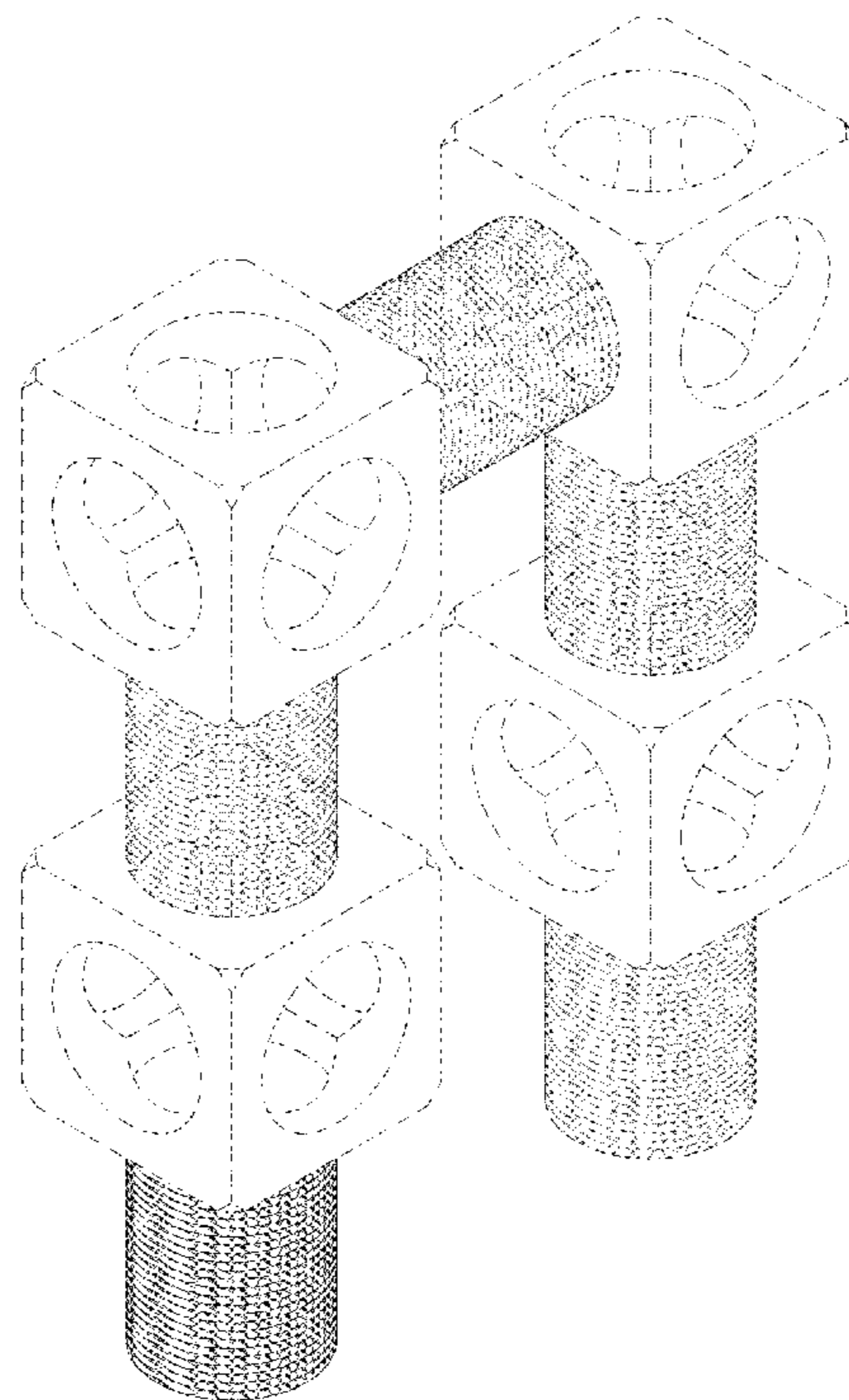
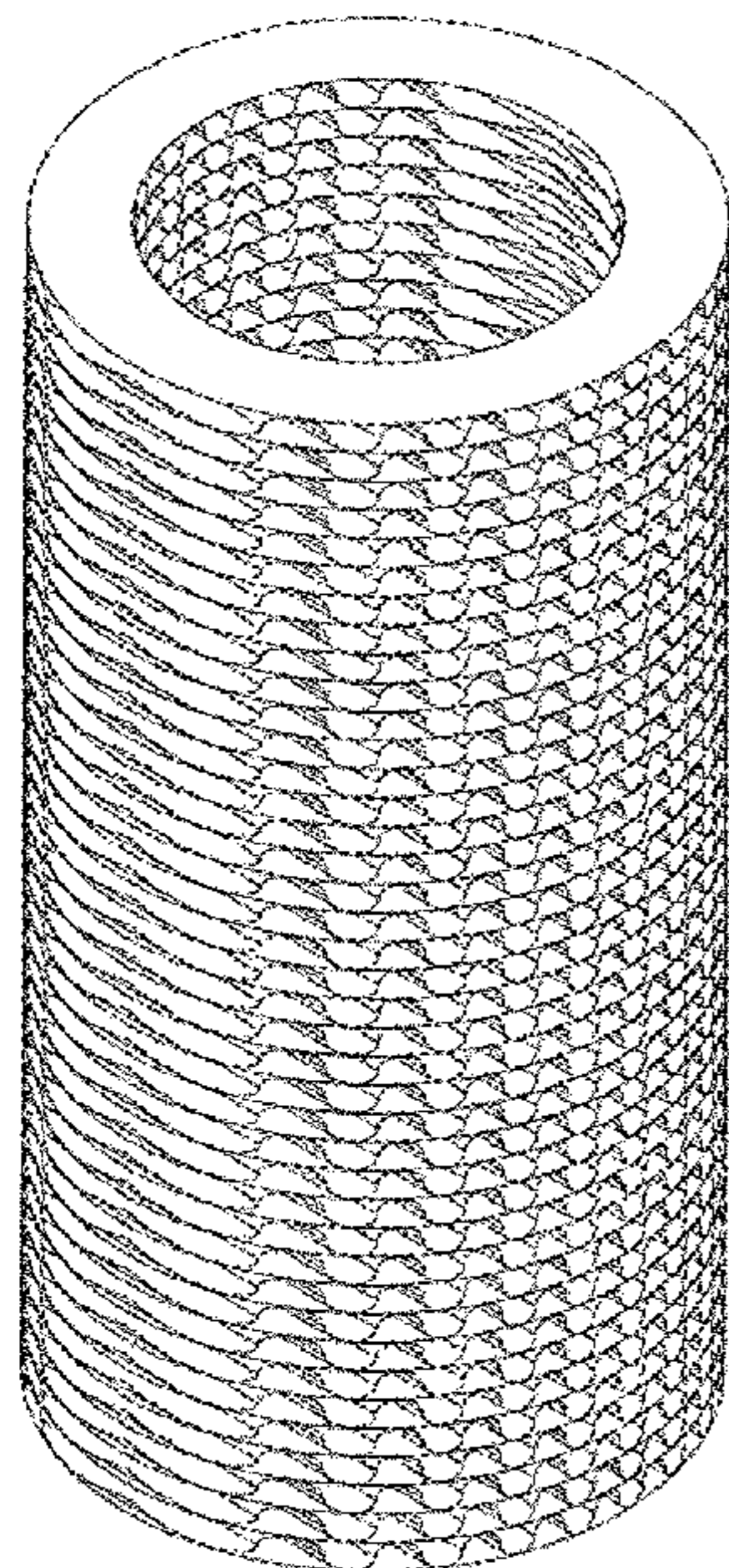
The ornamental design for a scratching post for cats, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a scratching post for cats showing my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is bottom plan view thereof;
FIG. 8 is a perspective view showing the scratching post for cats in use; and,
FIG. 9 is another perspective view showing the scratching post for cats in use.

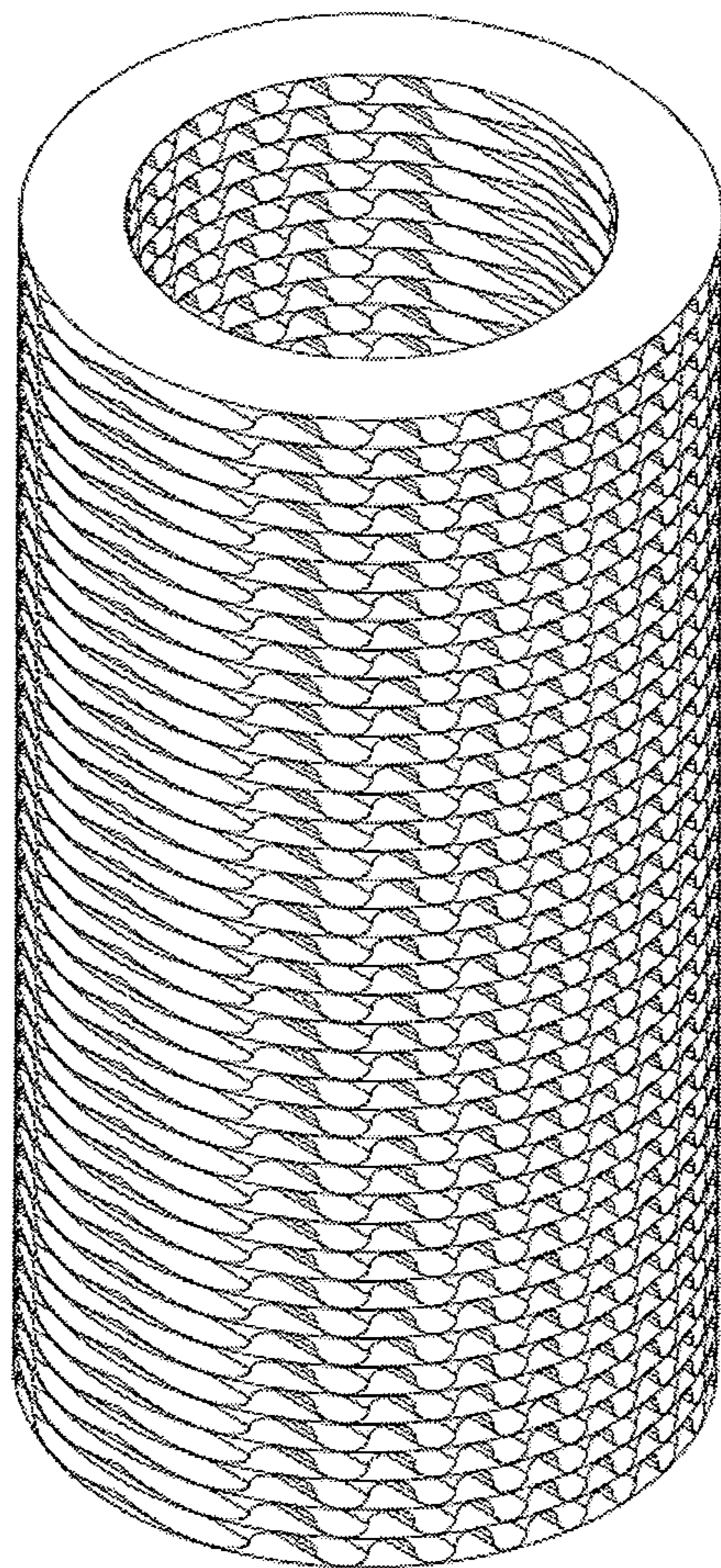

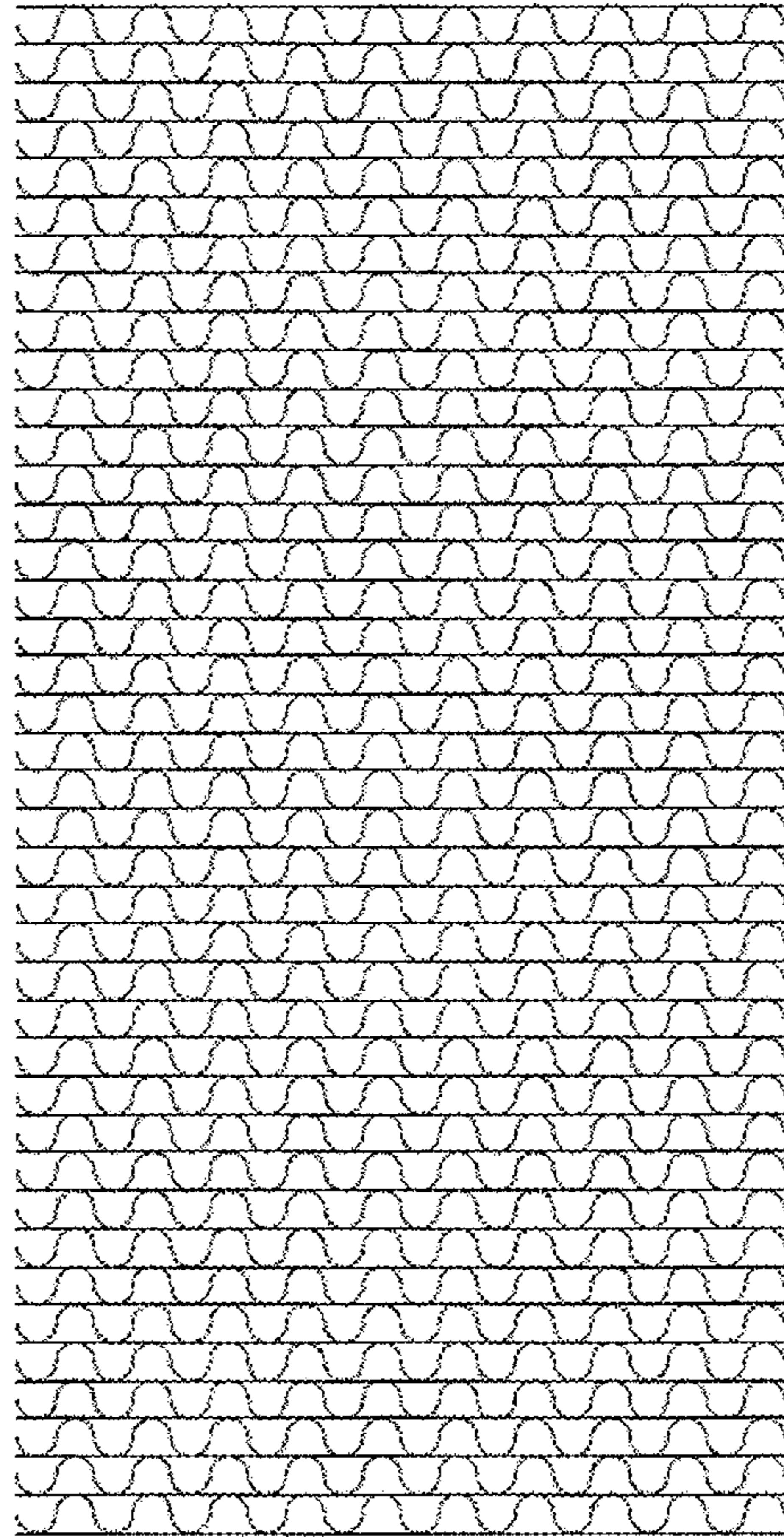

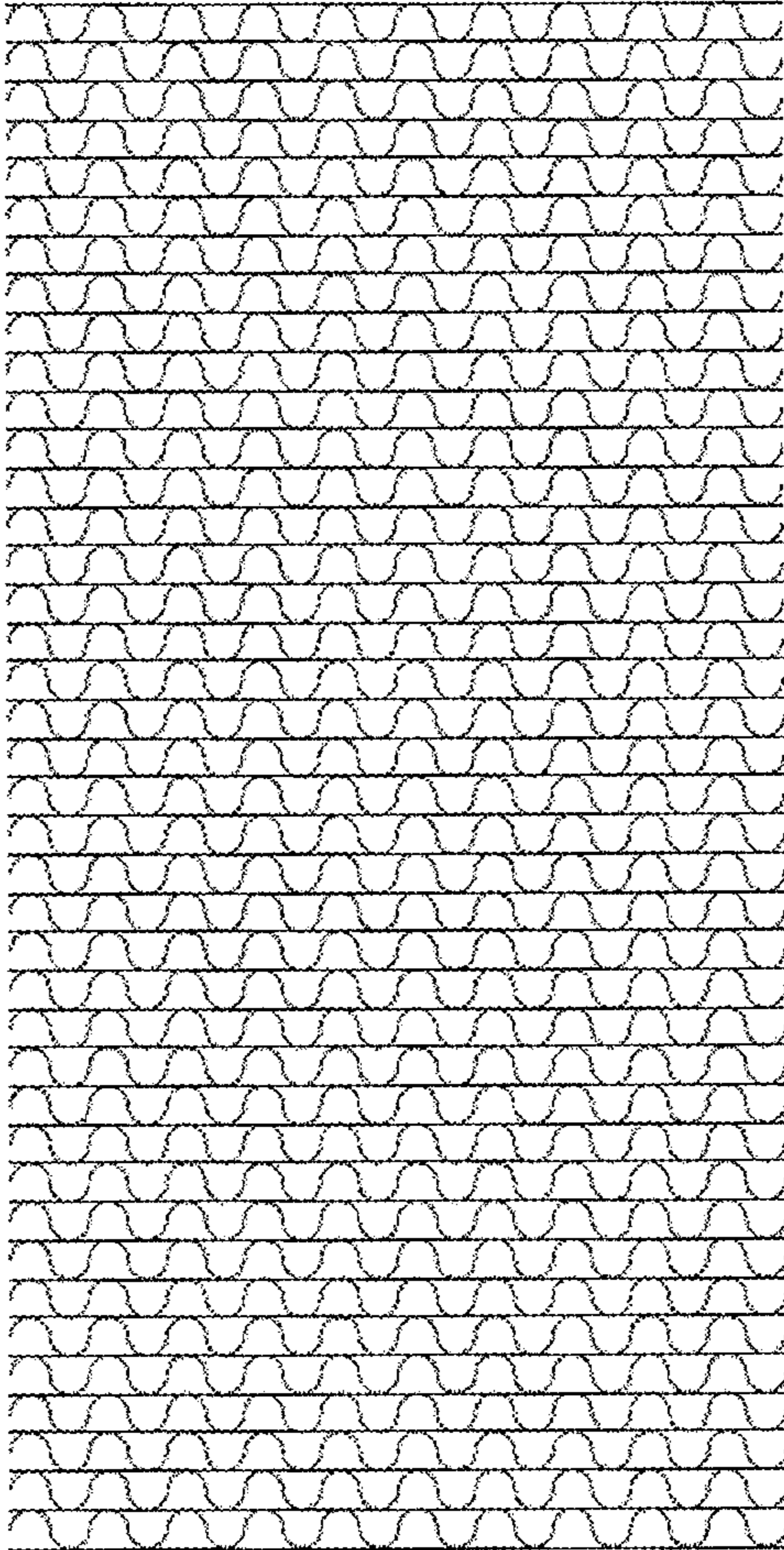

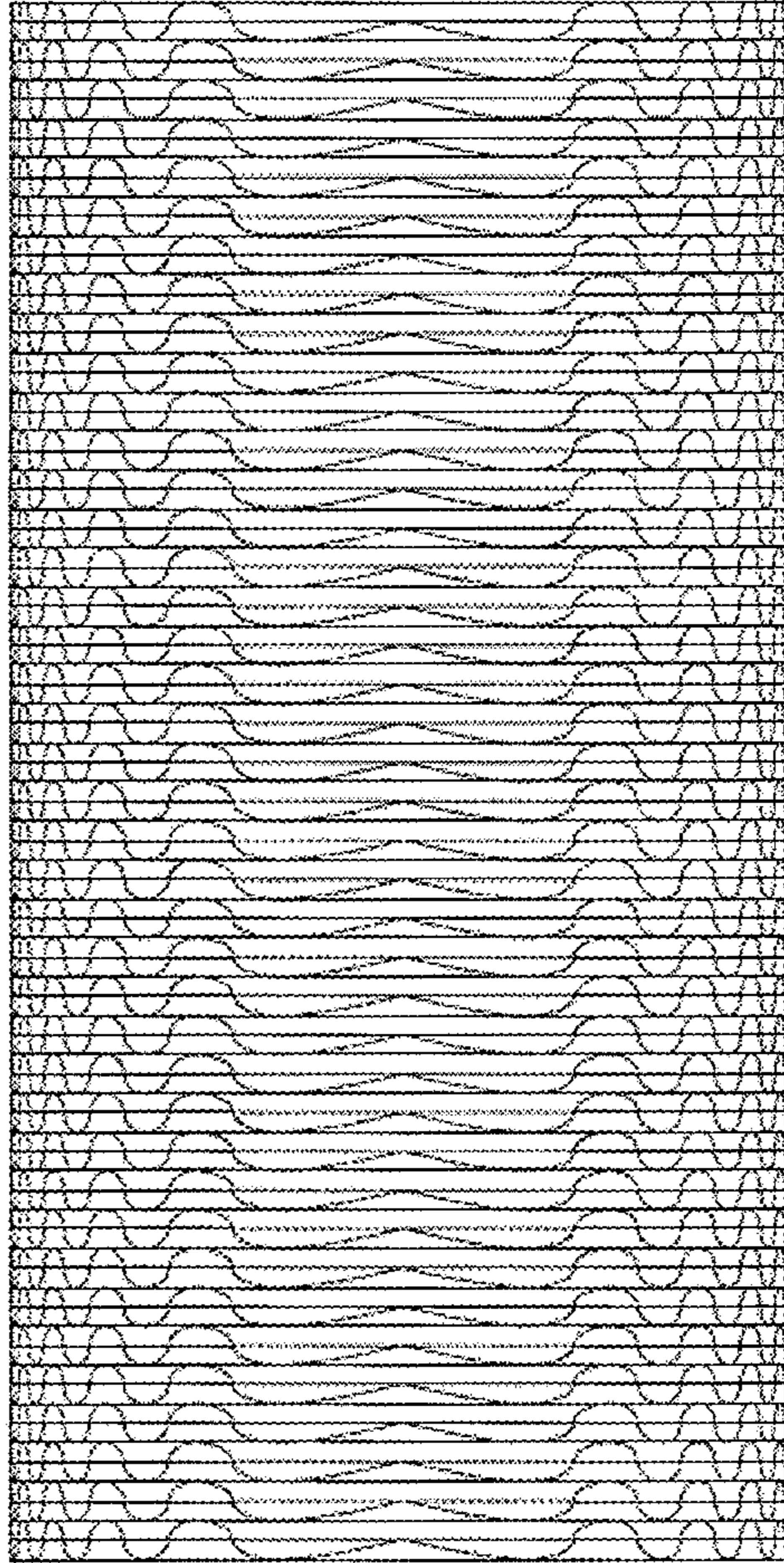

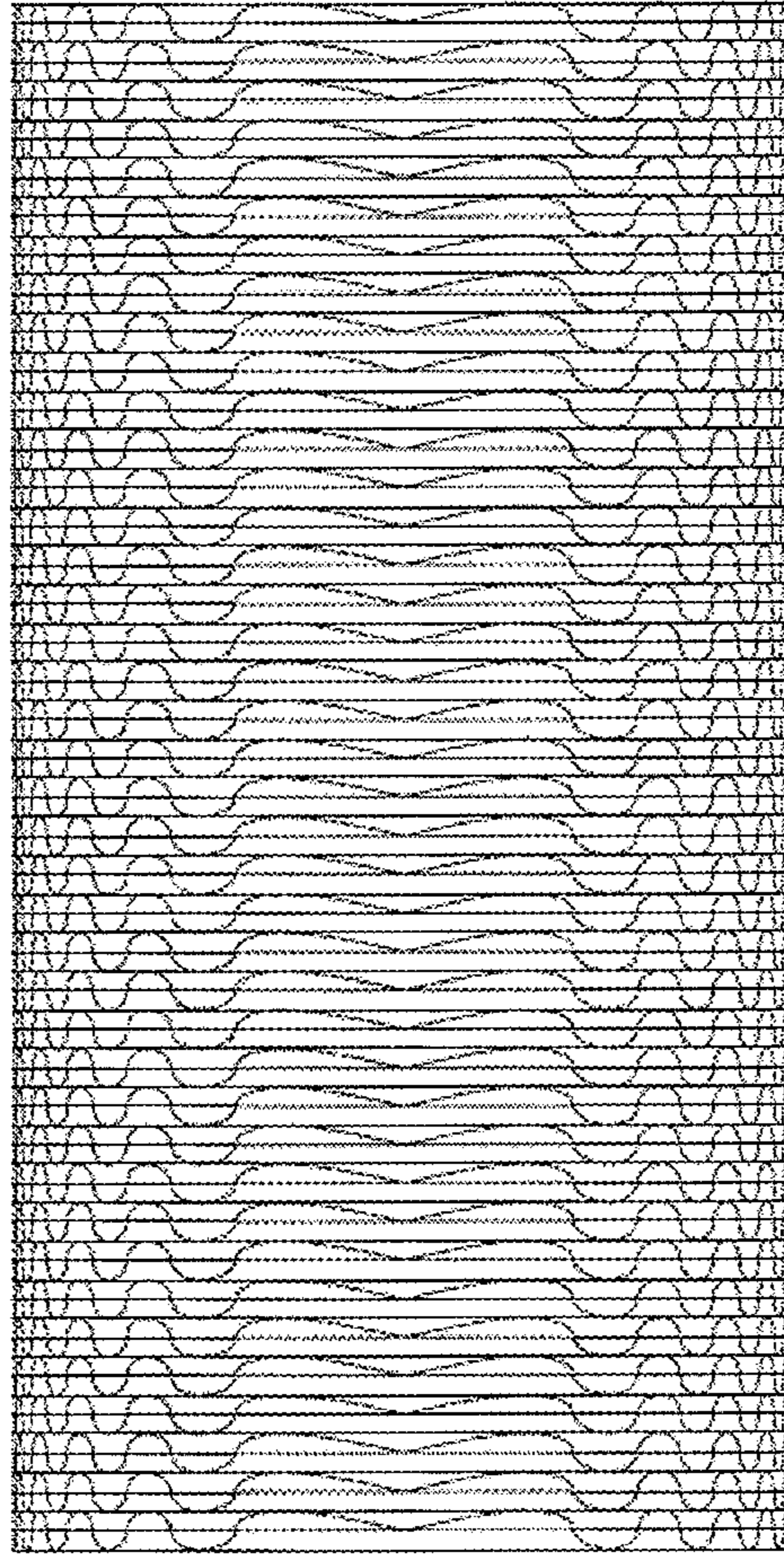

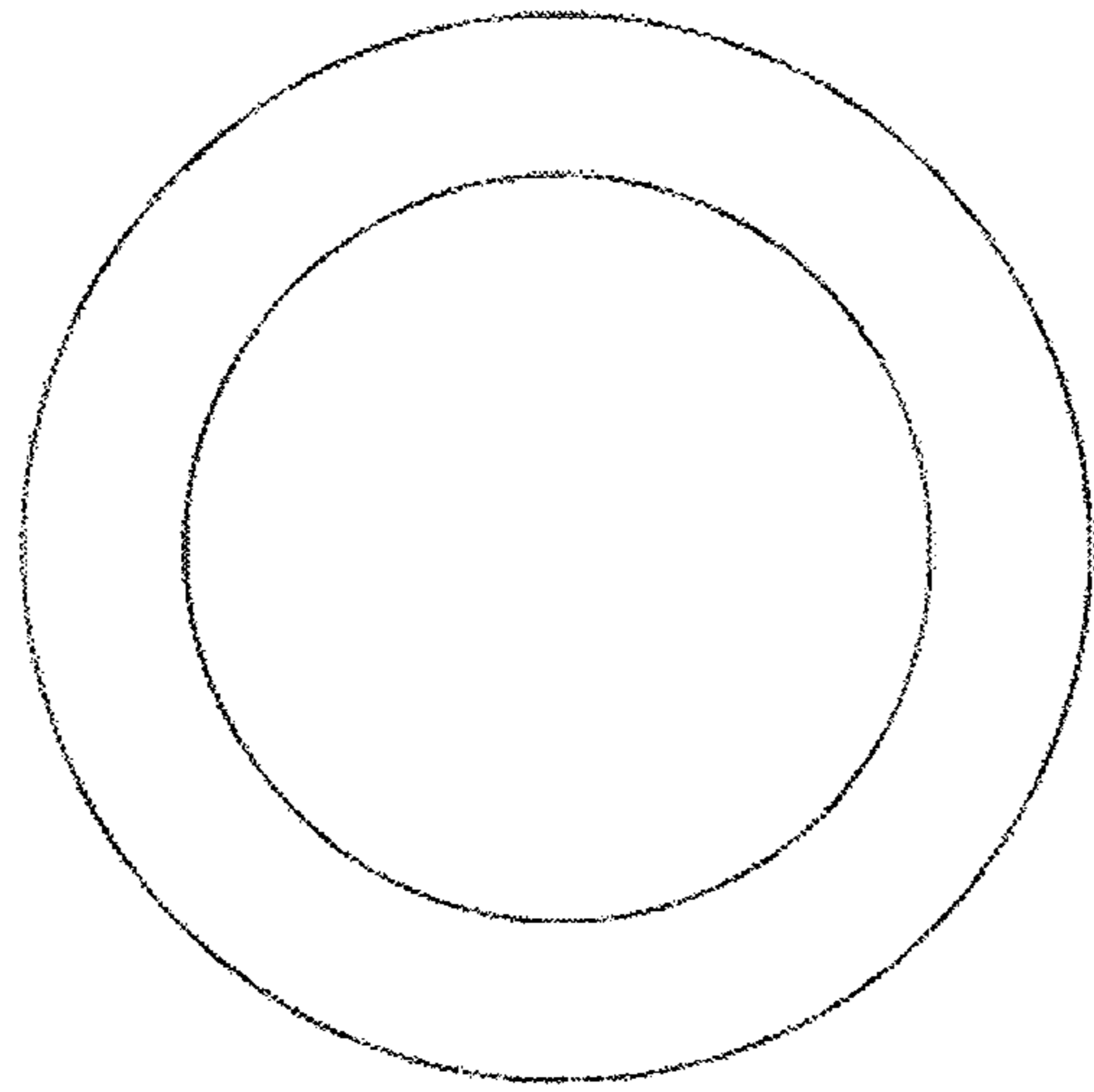

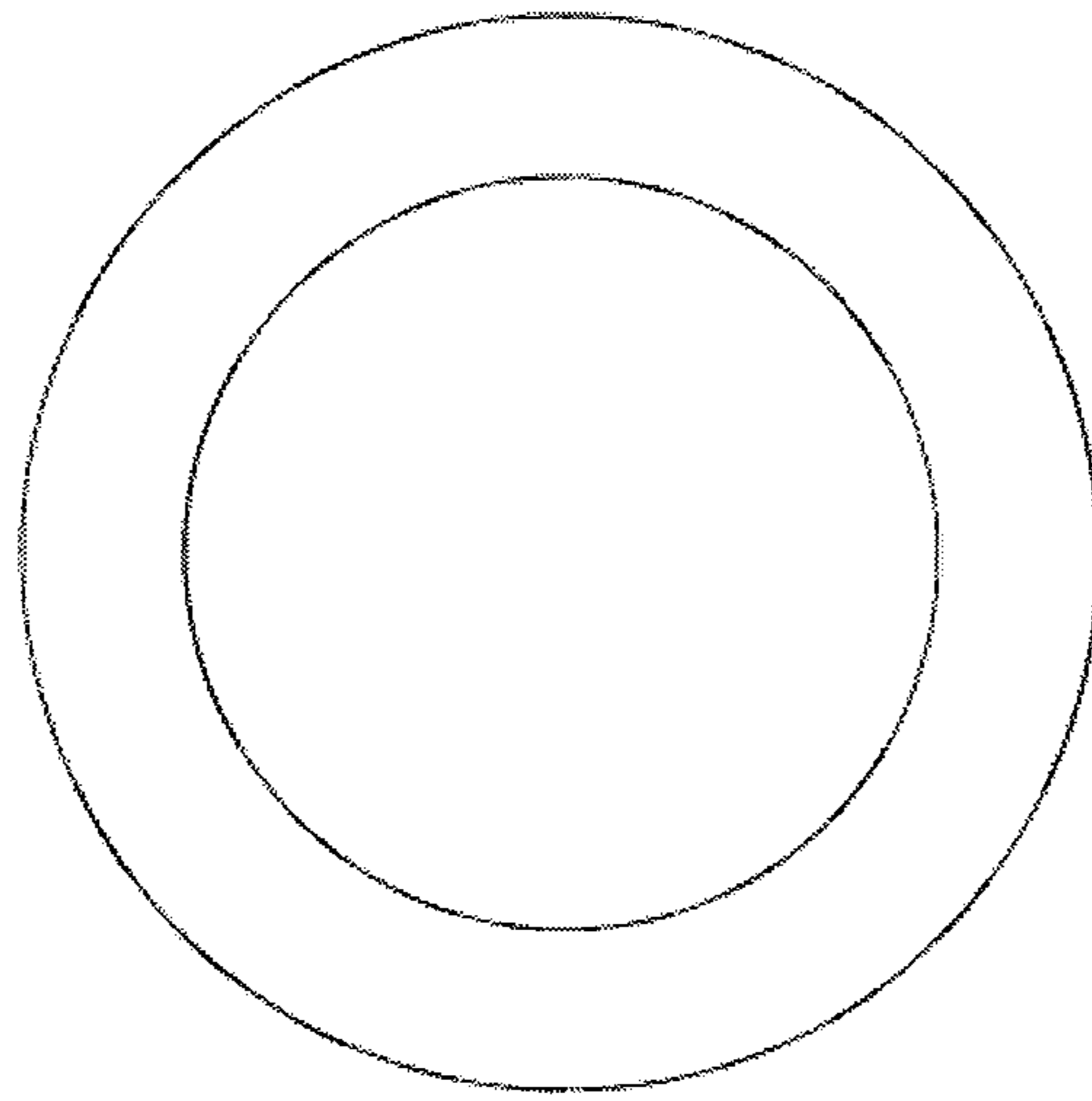

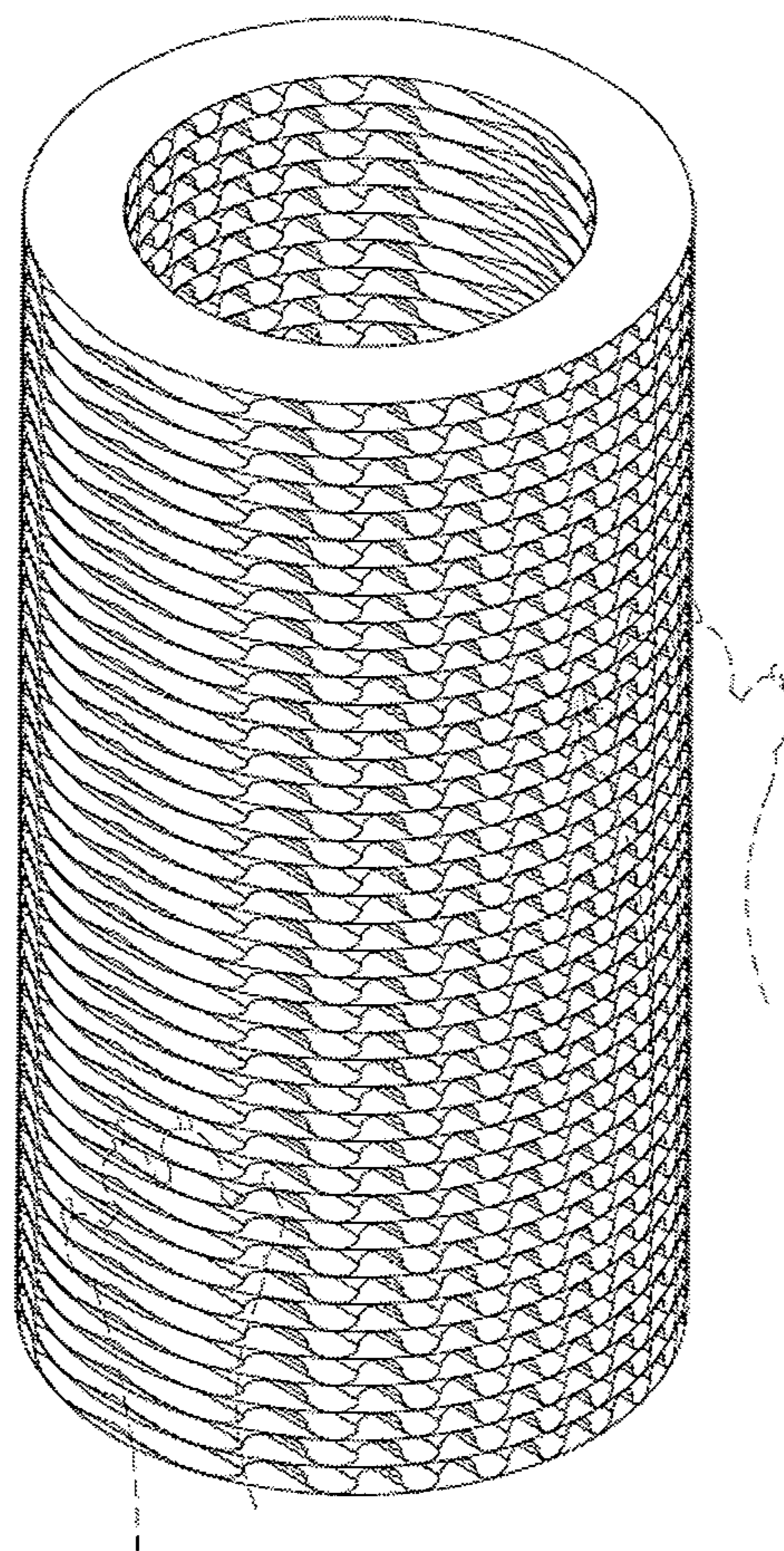

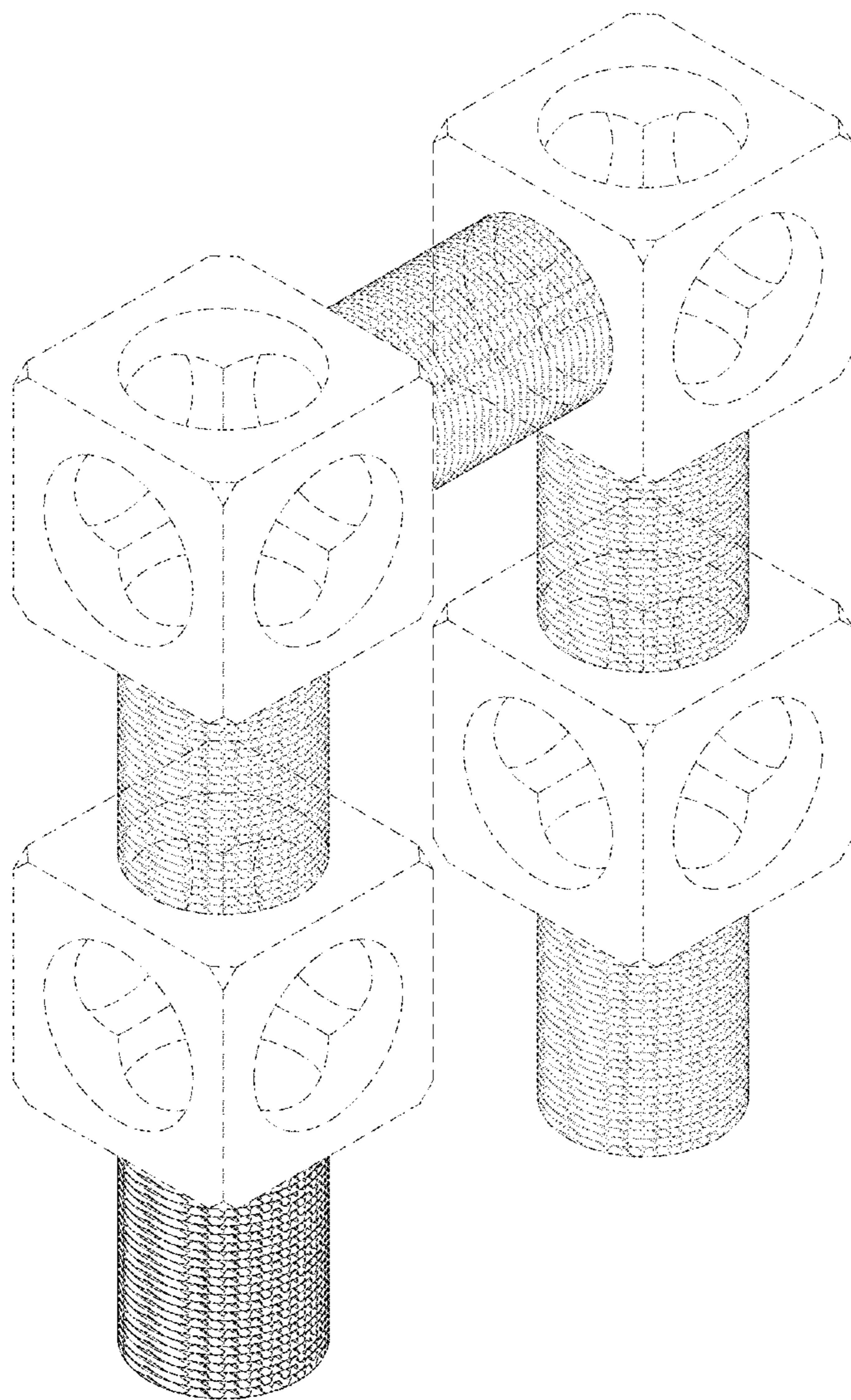
