The ornamental design for a cluster box mail delivery unit, as shown and described.

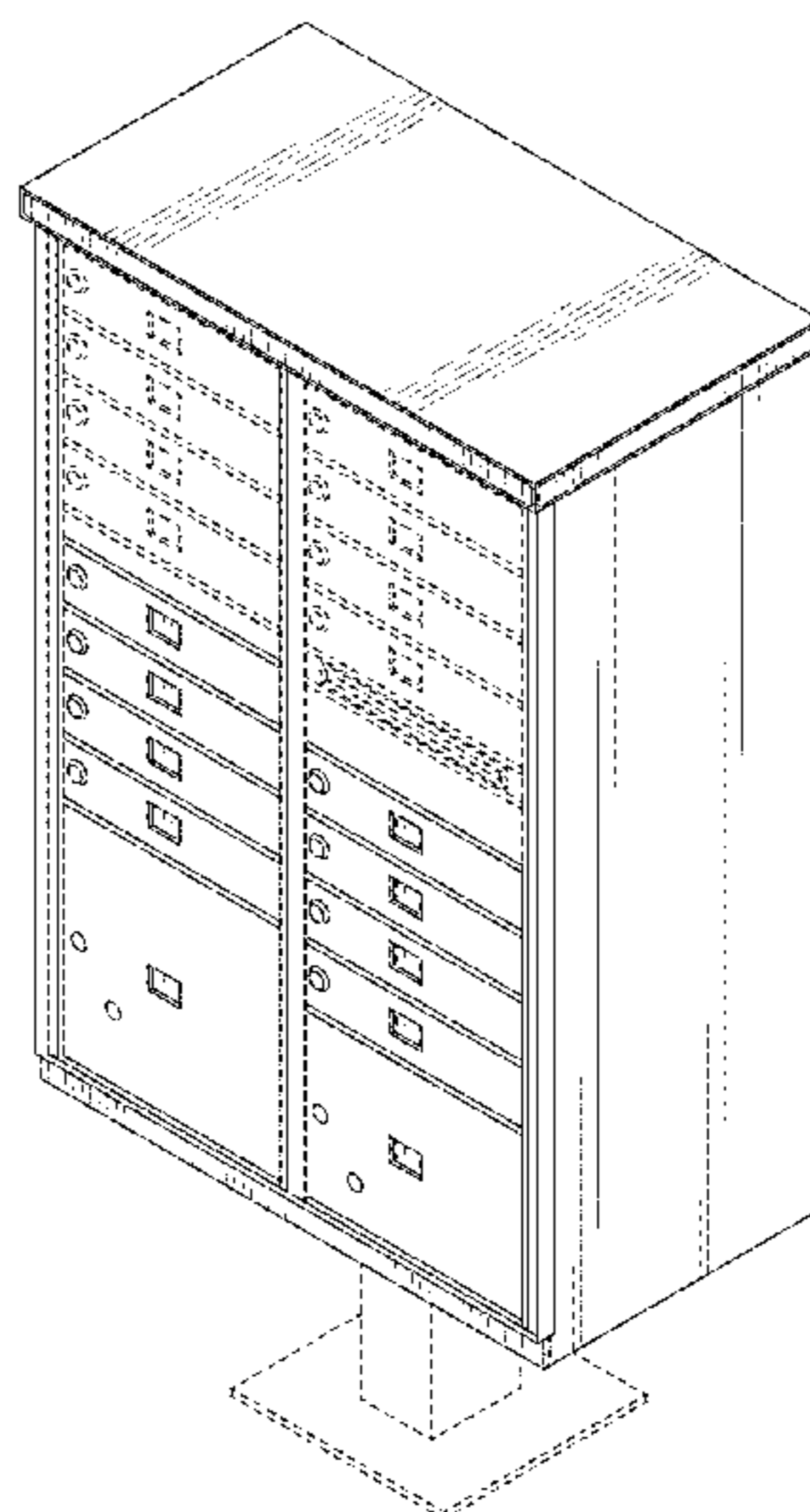
**DESCRIPTION**

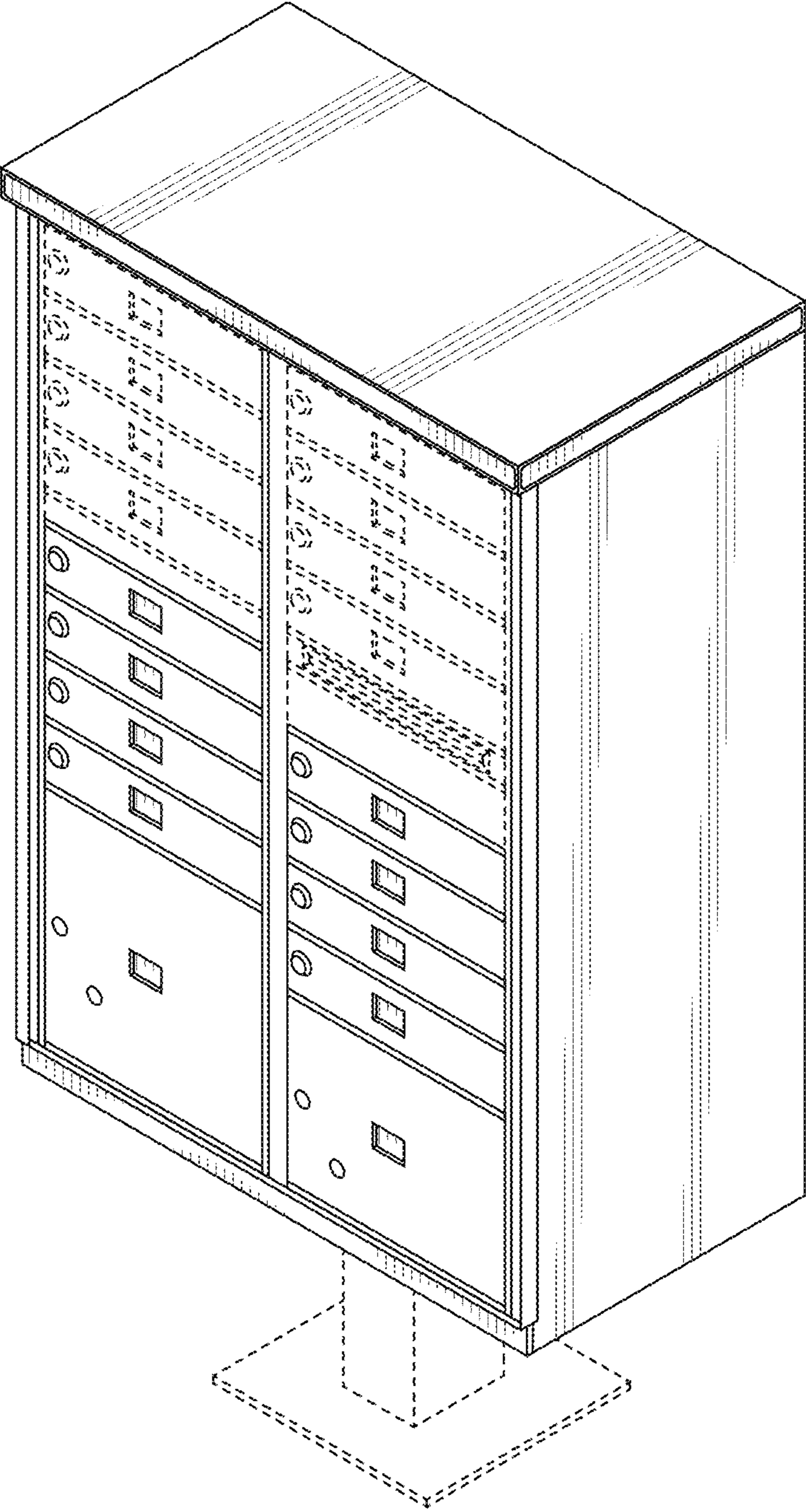

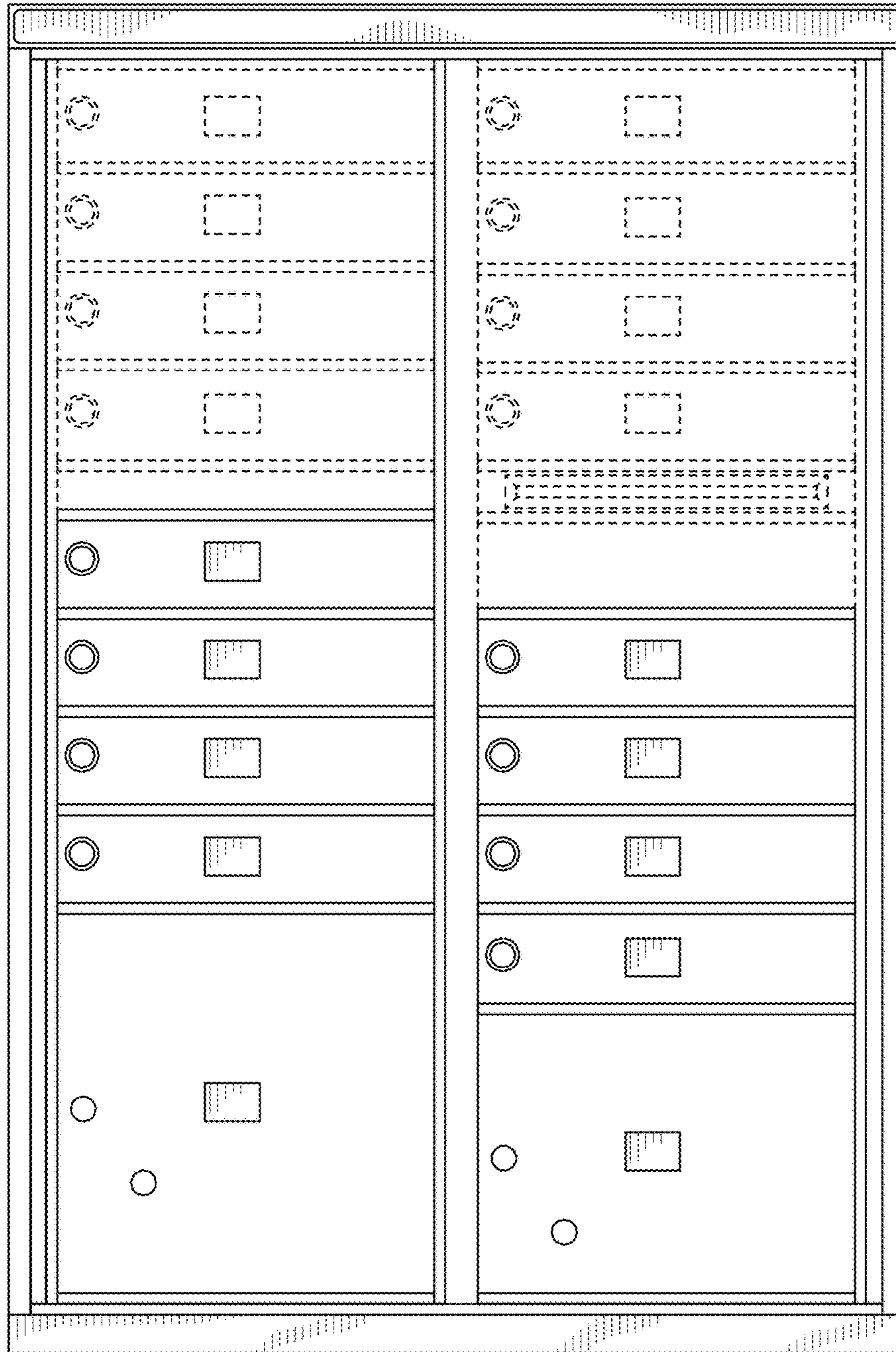

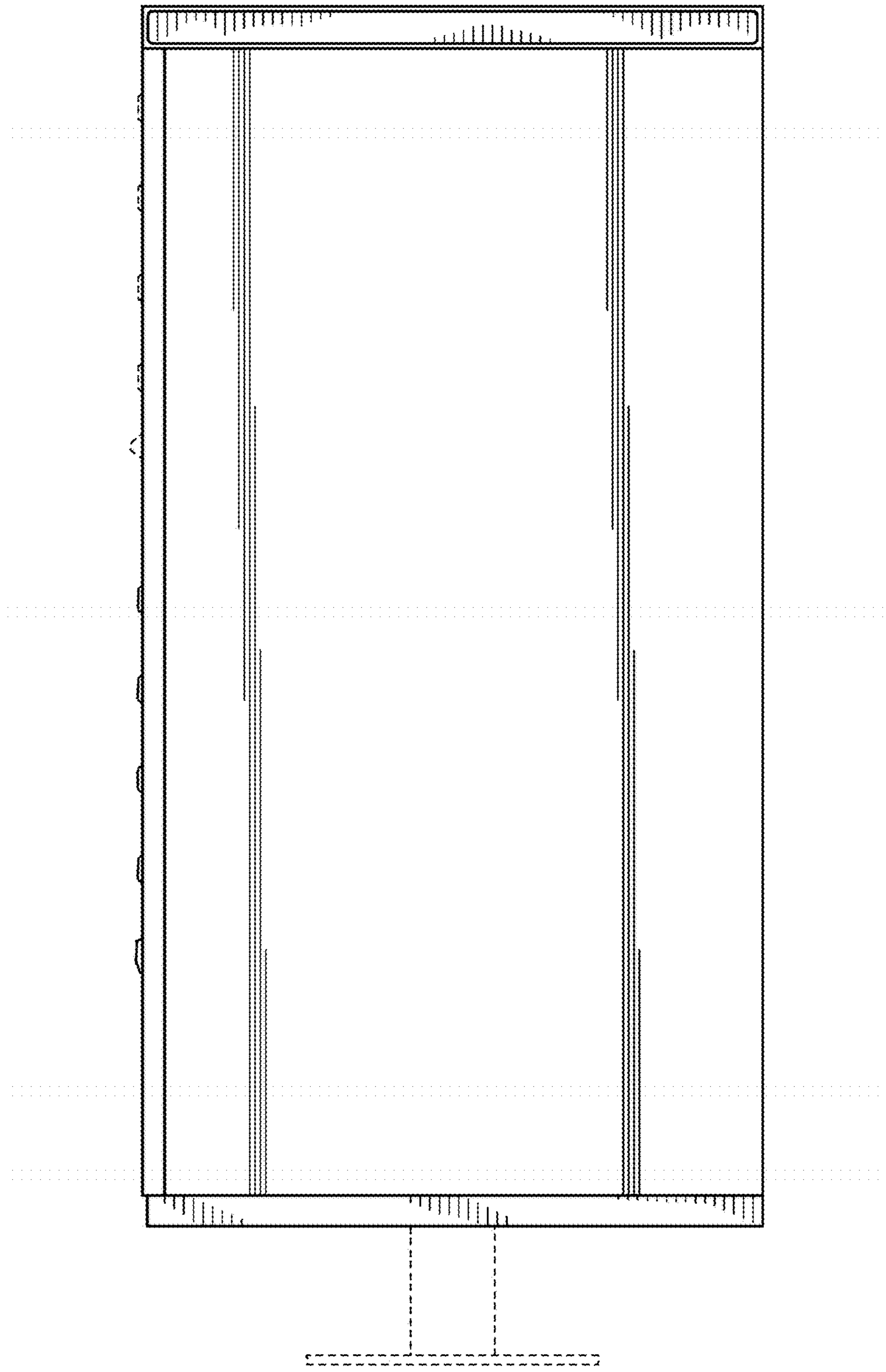

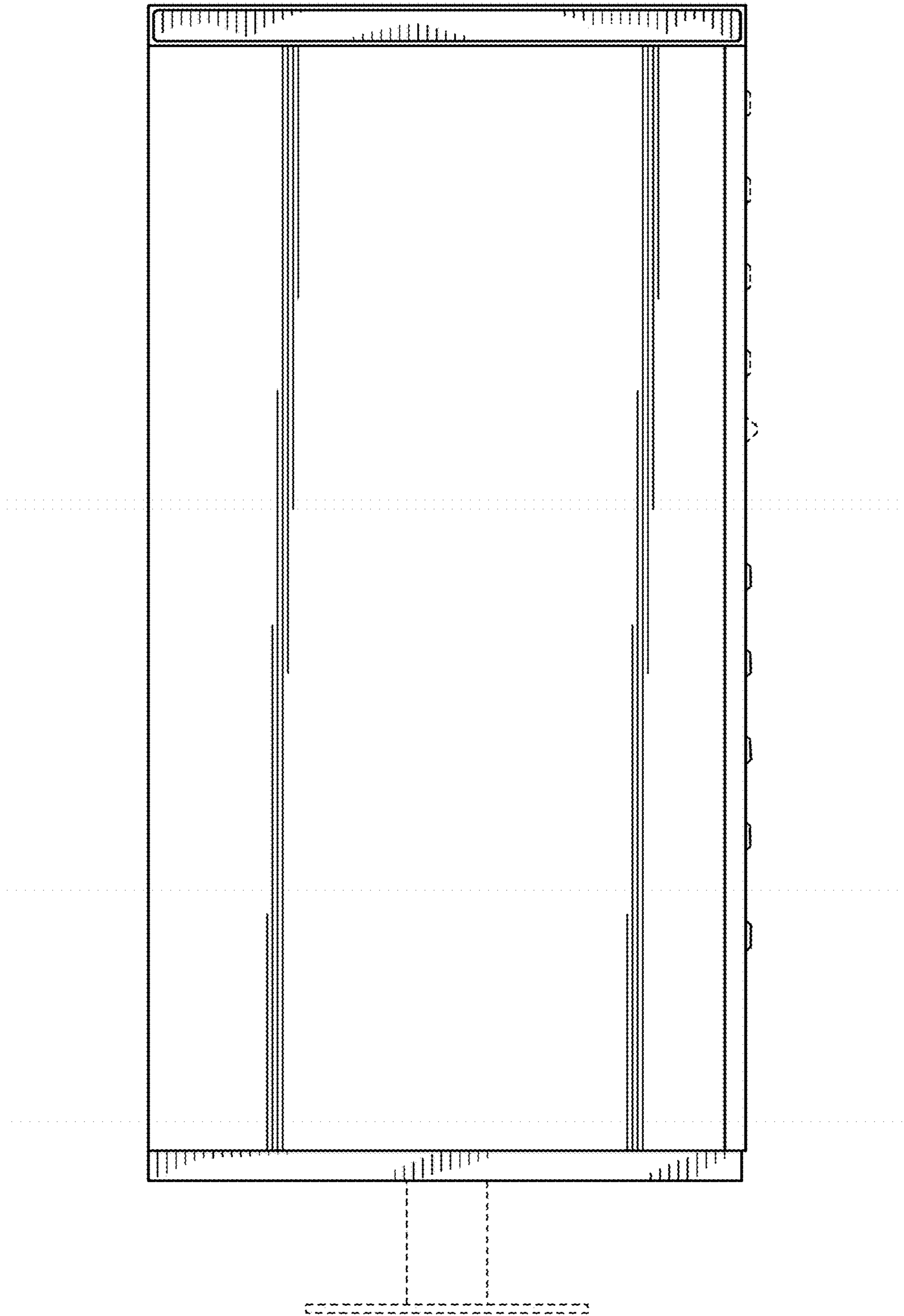
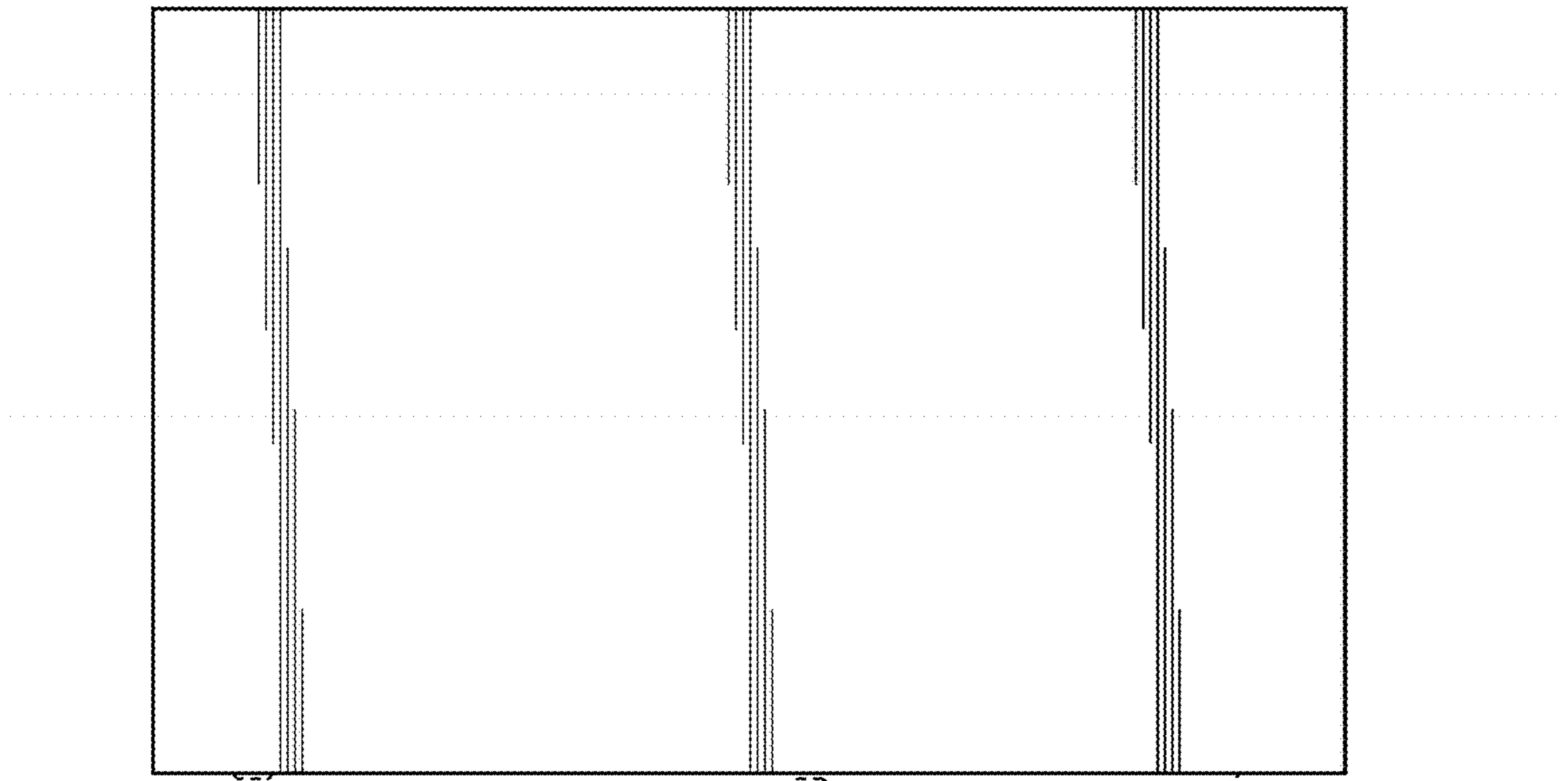
