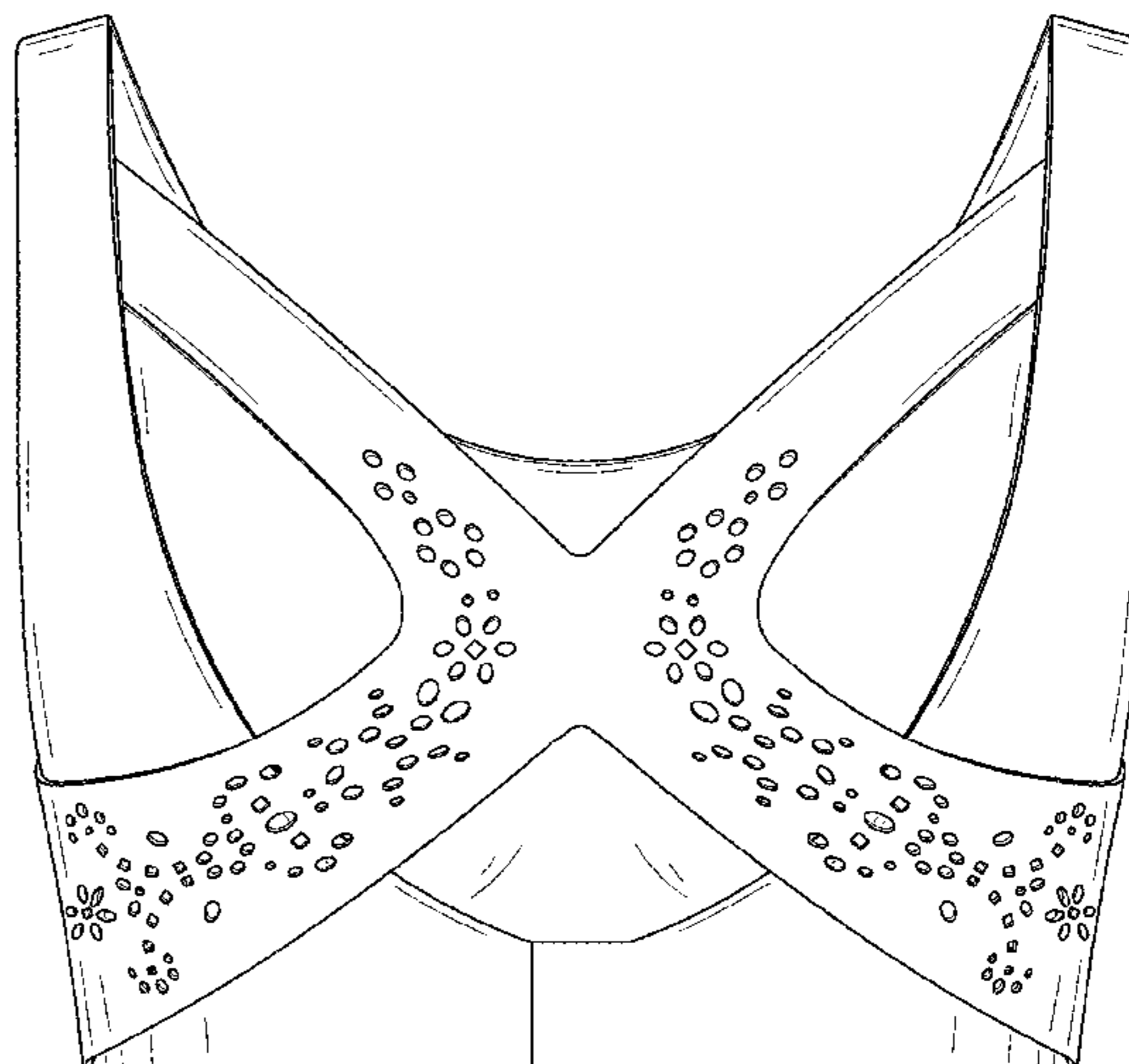
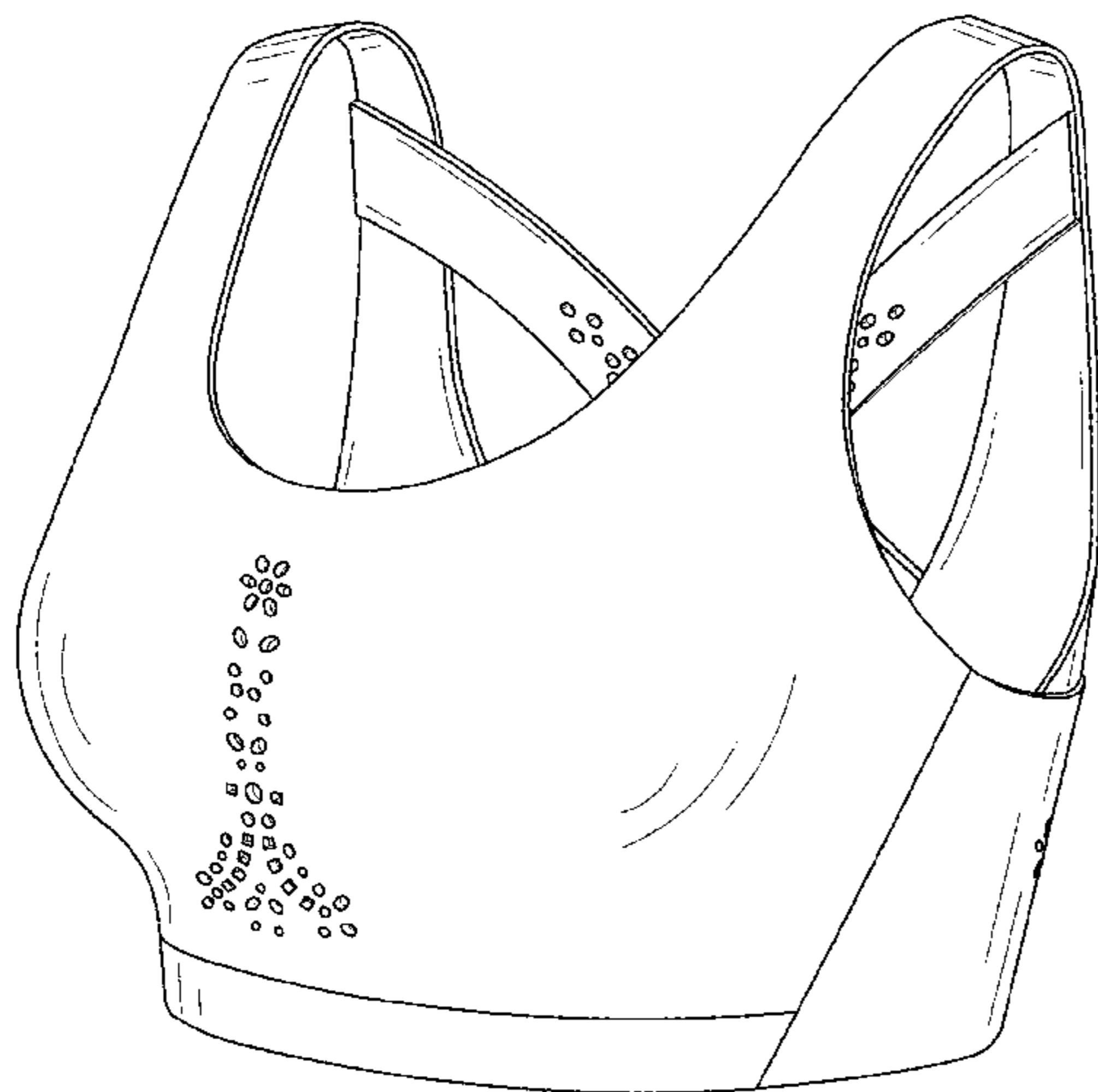
(57) **CLAIM**

The ornamental design for a brassiere, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a brassiere according to our new and ornamental design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a rear elevation view thereof, showing a closure portion of the first embodiment of the brassiere in an alternative position; FIG. 8 is a front perspective view of a second embodiment of a brassiere according to our new and ornamental design; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a rear elevation view thereof, showing a closure portion of the second embodiment of the brassiere in an alternative position.

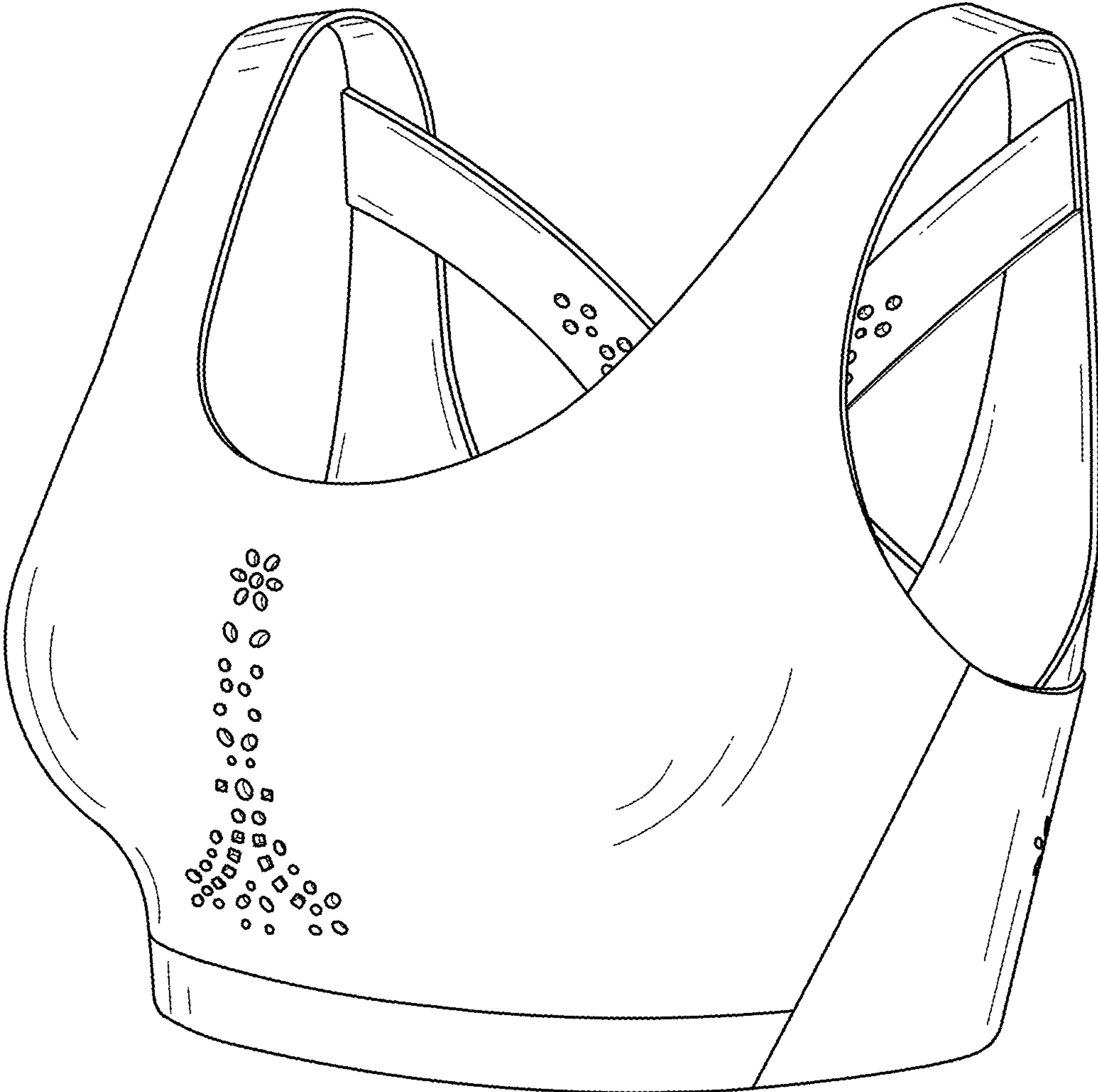

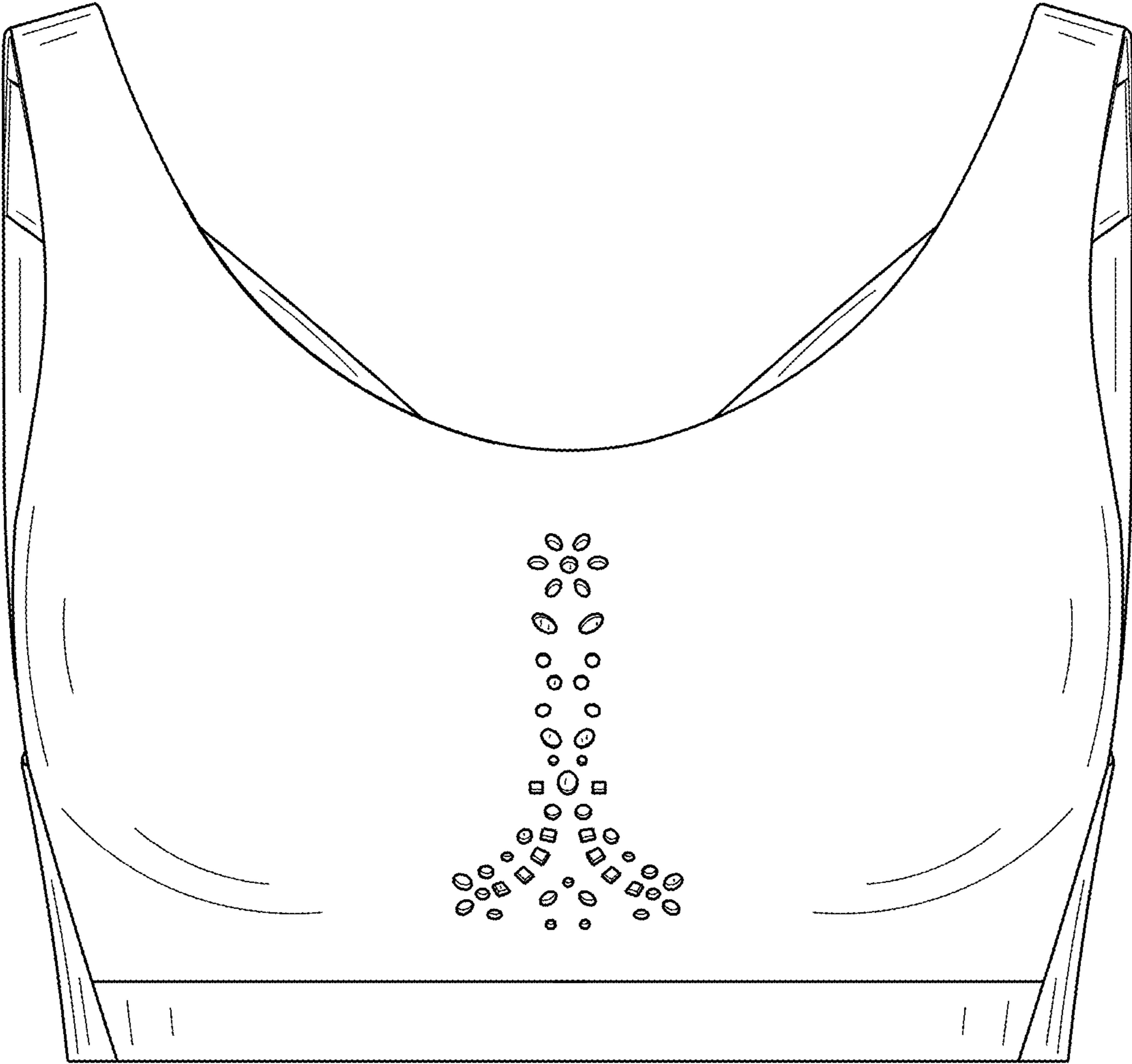

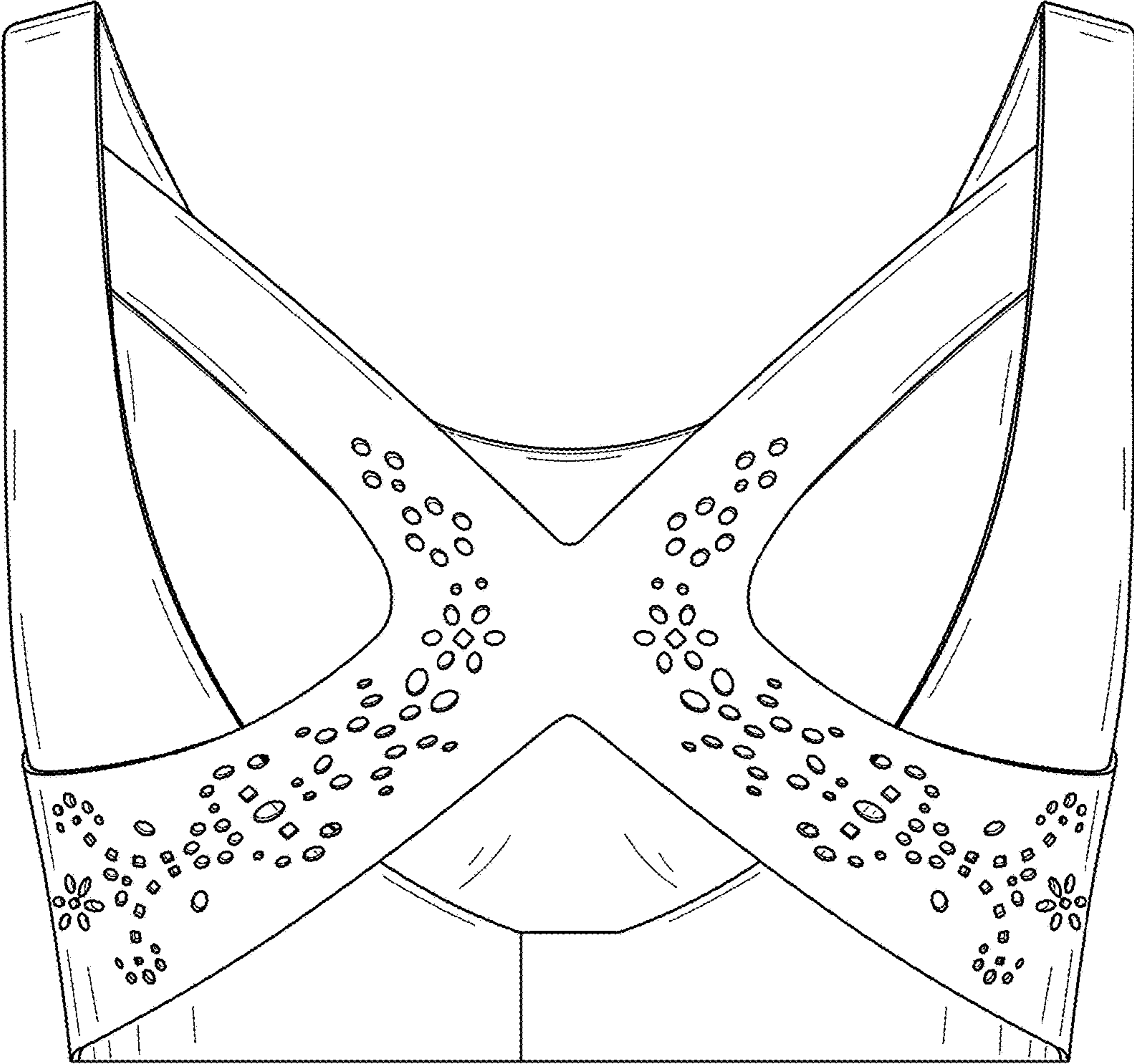

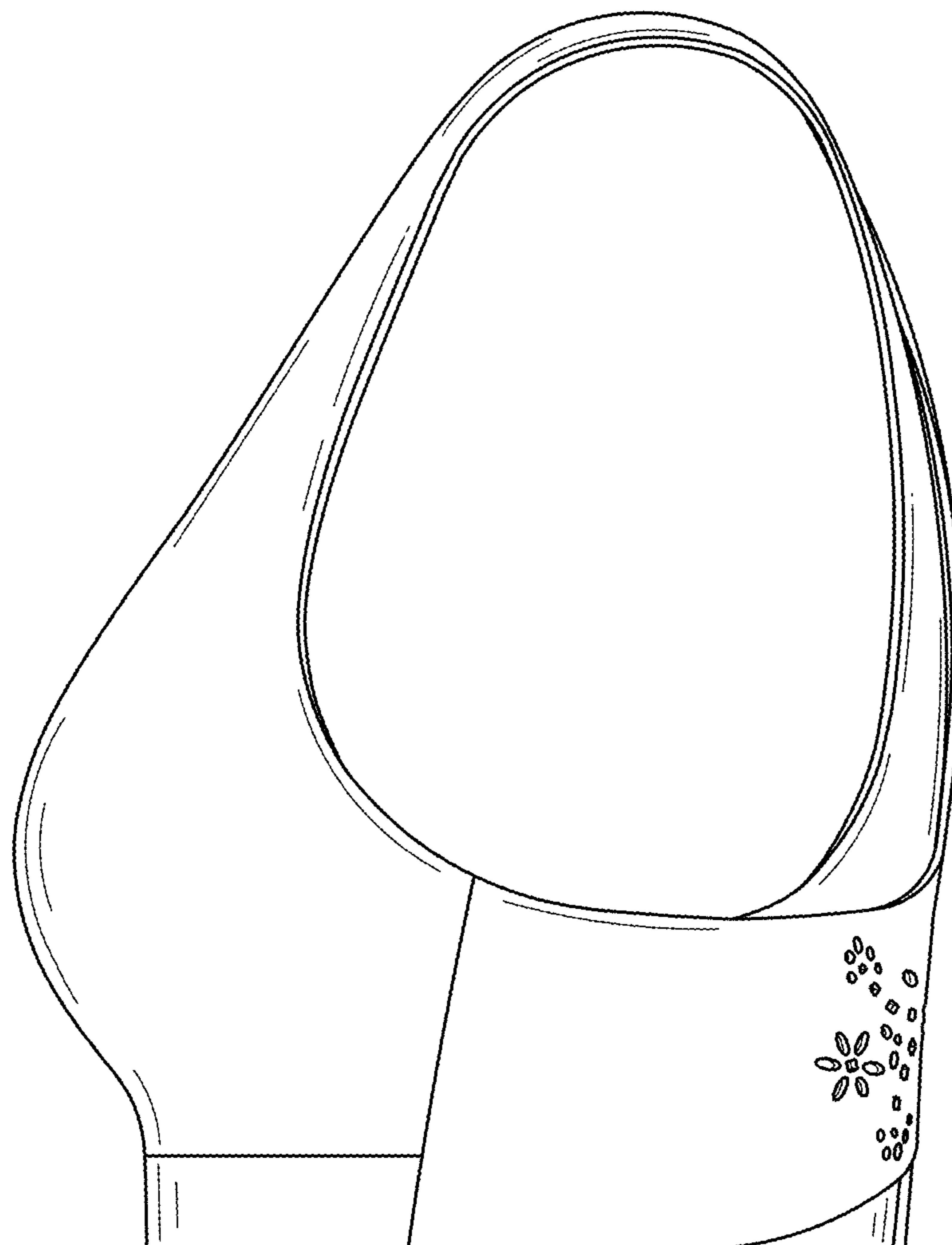

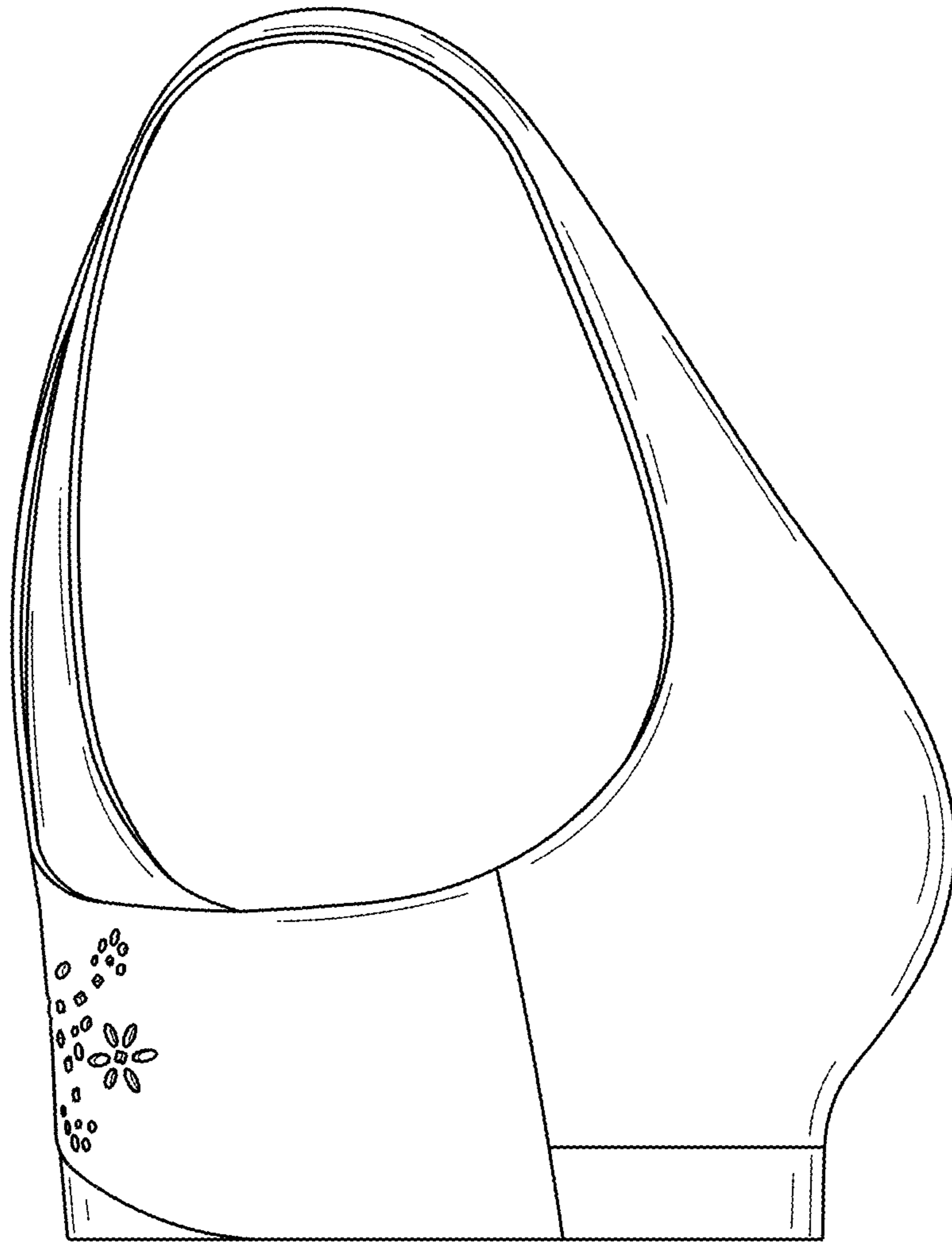

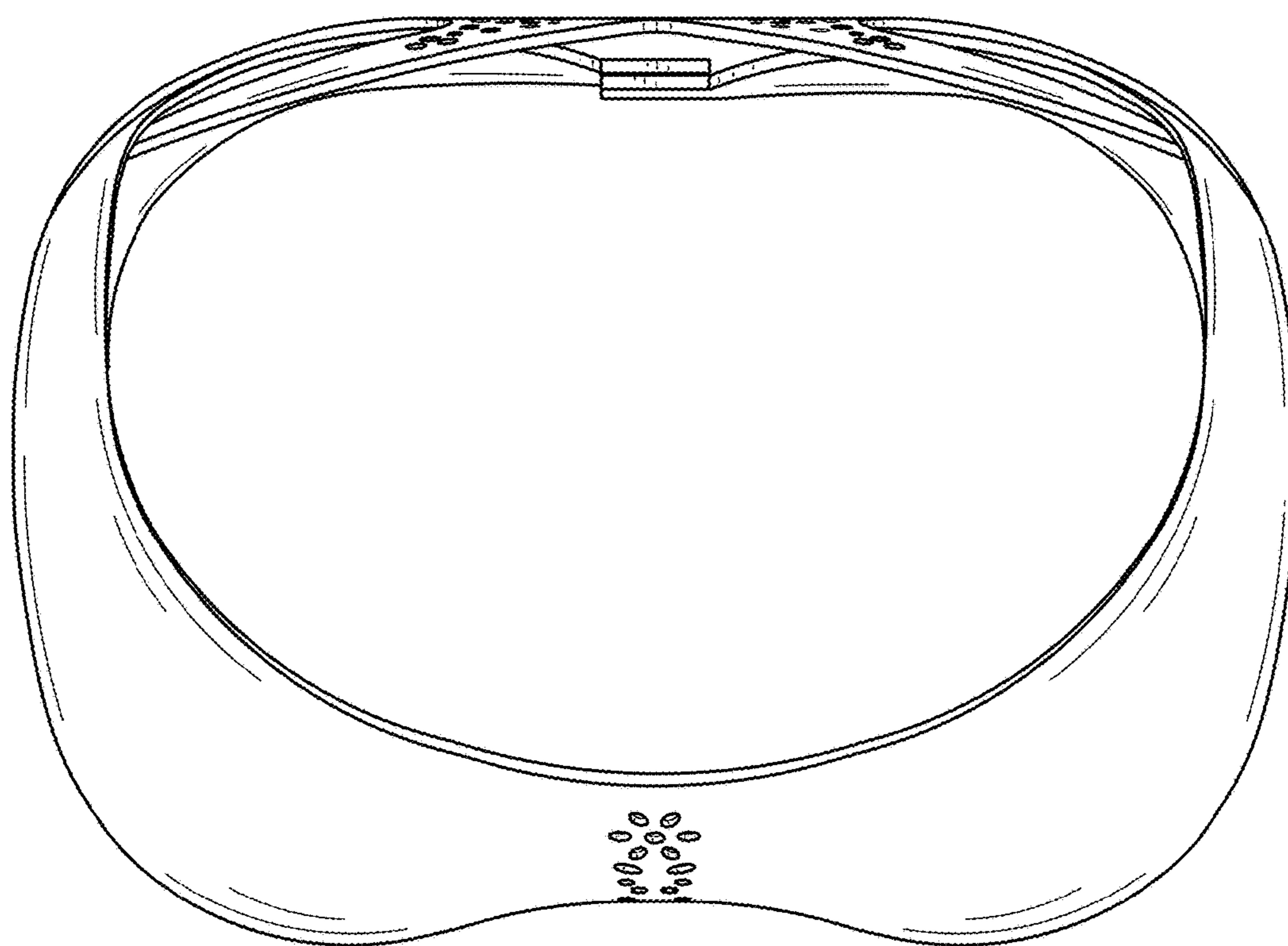

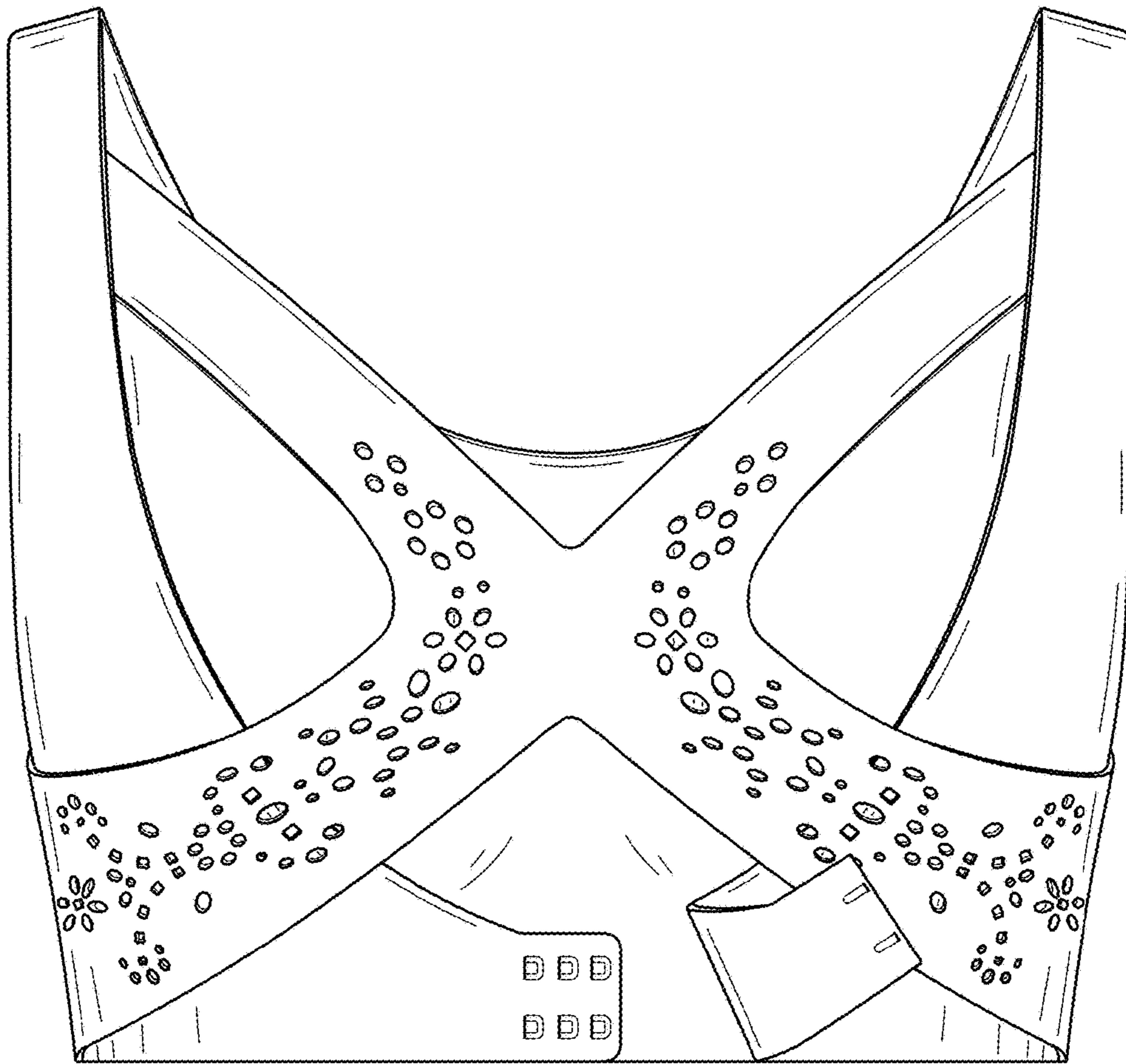

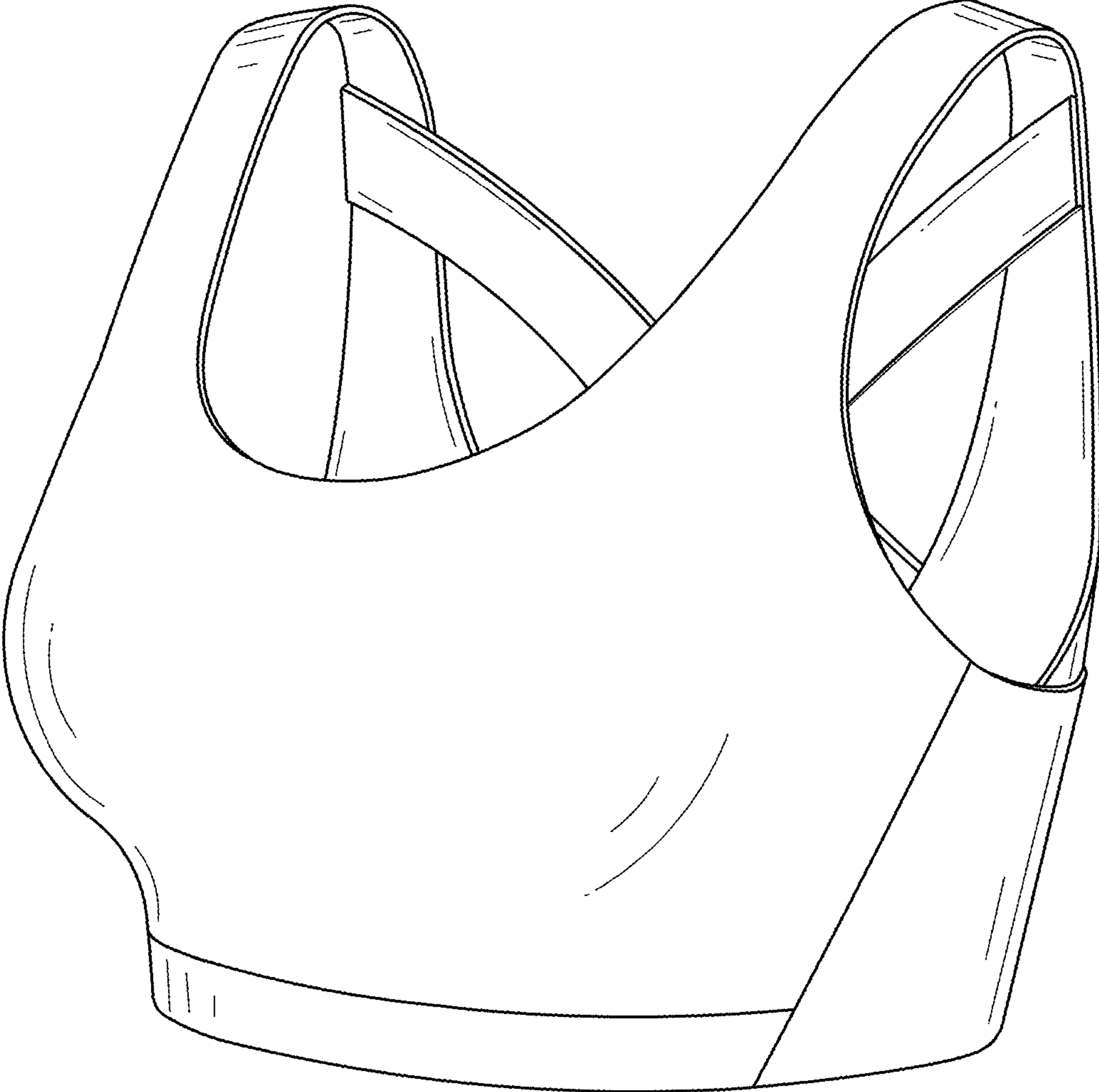

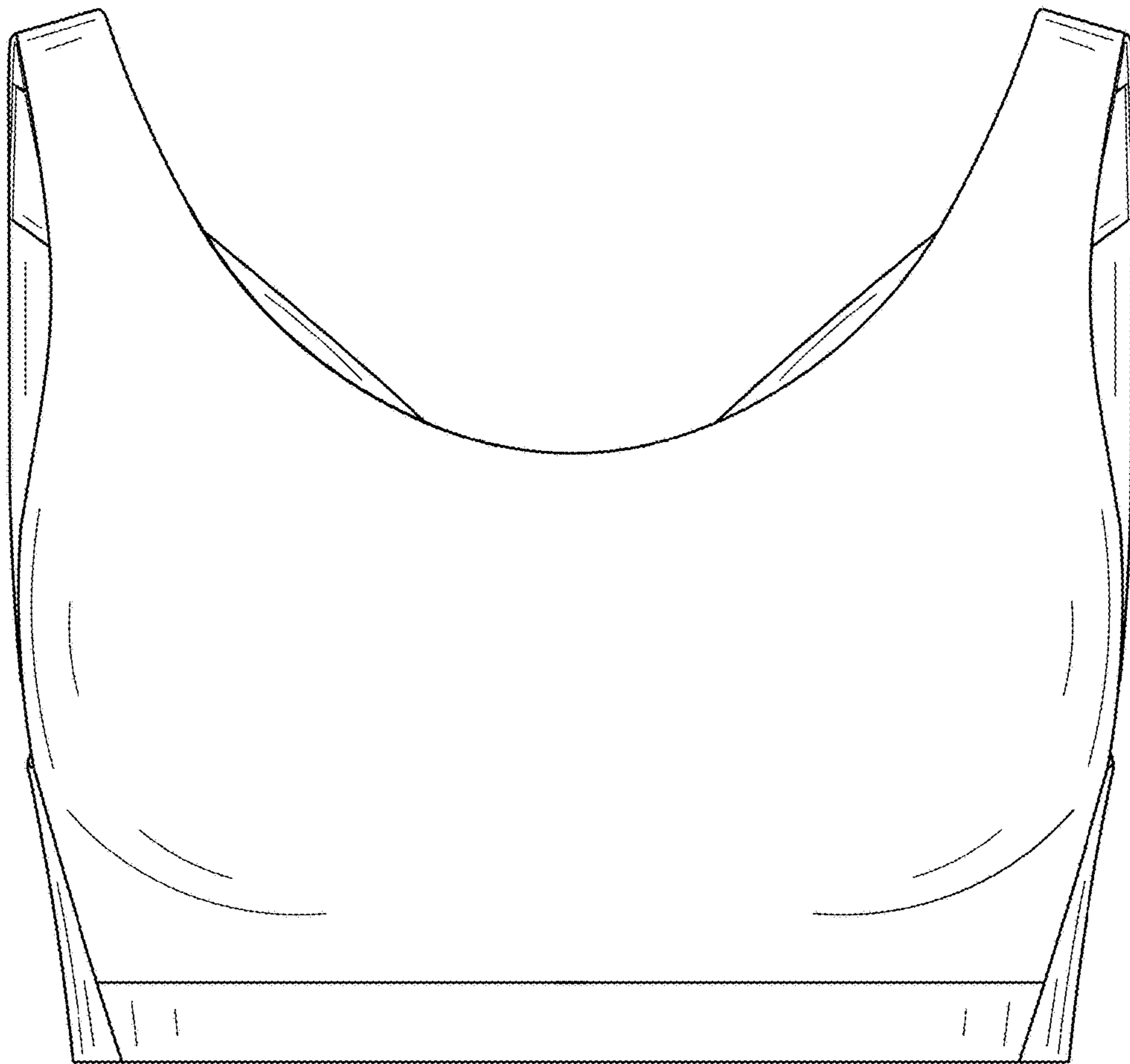

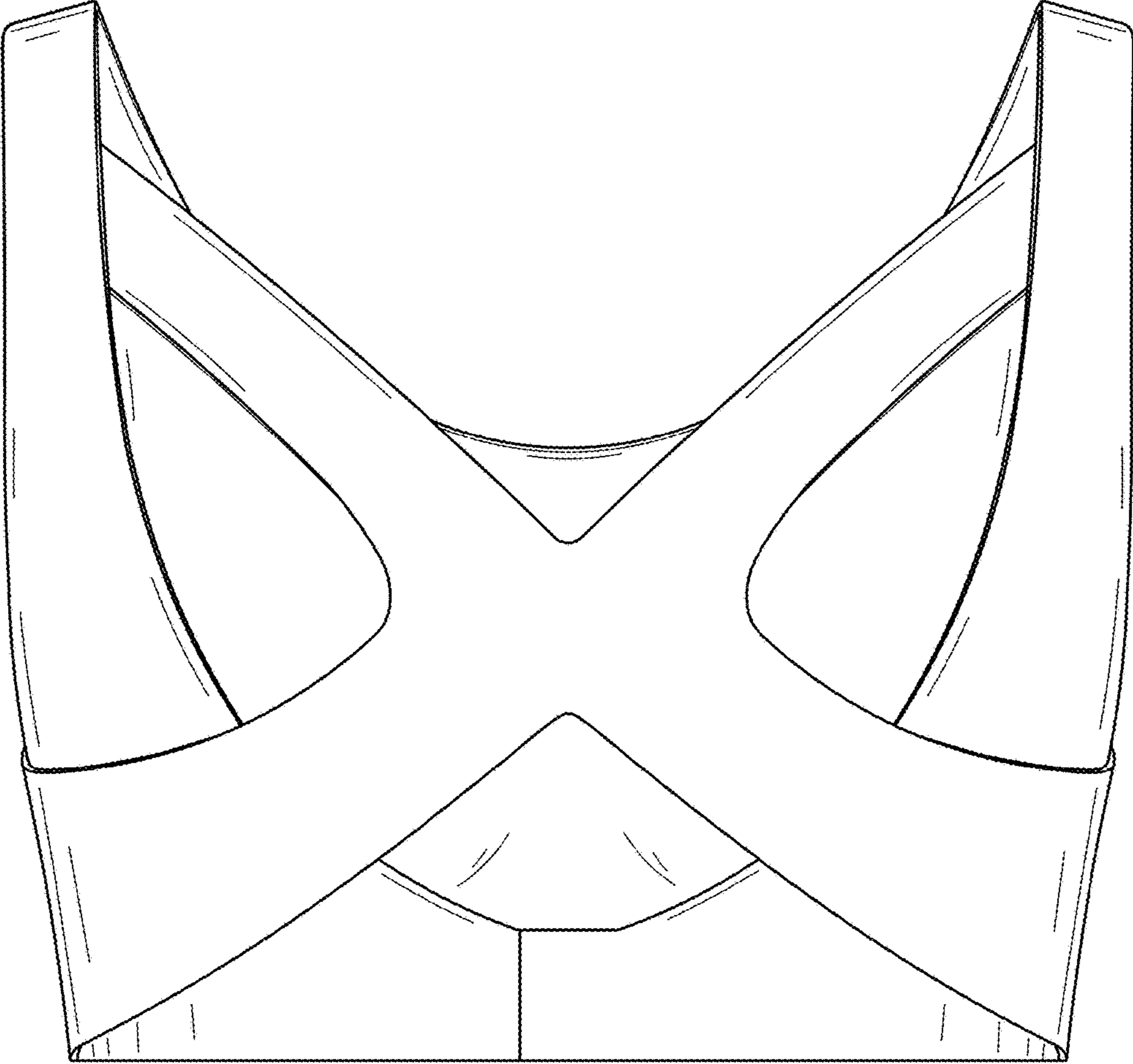

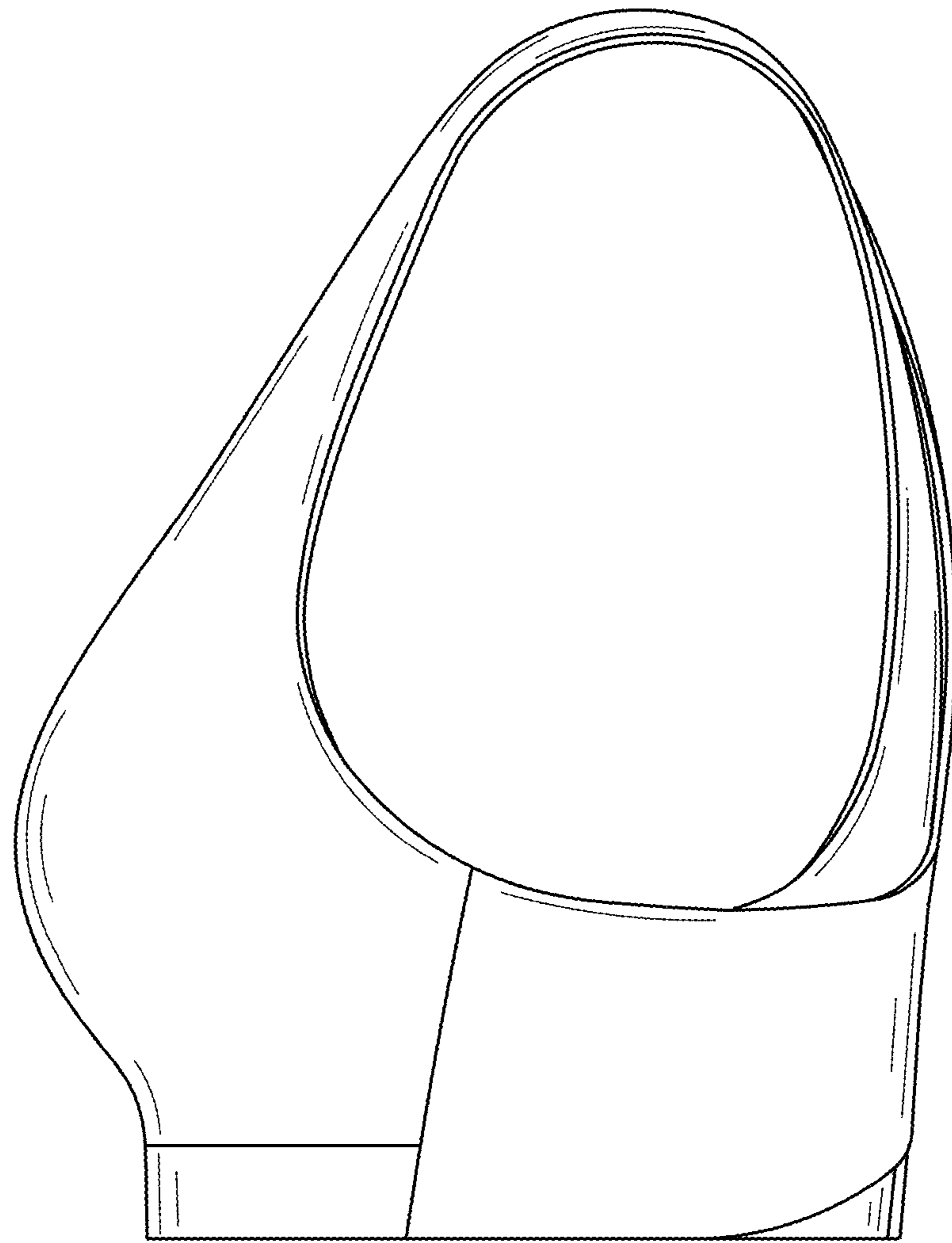

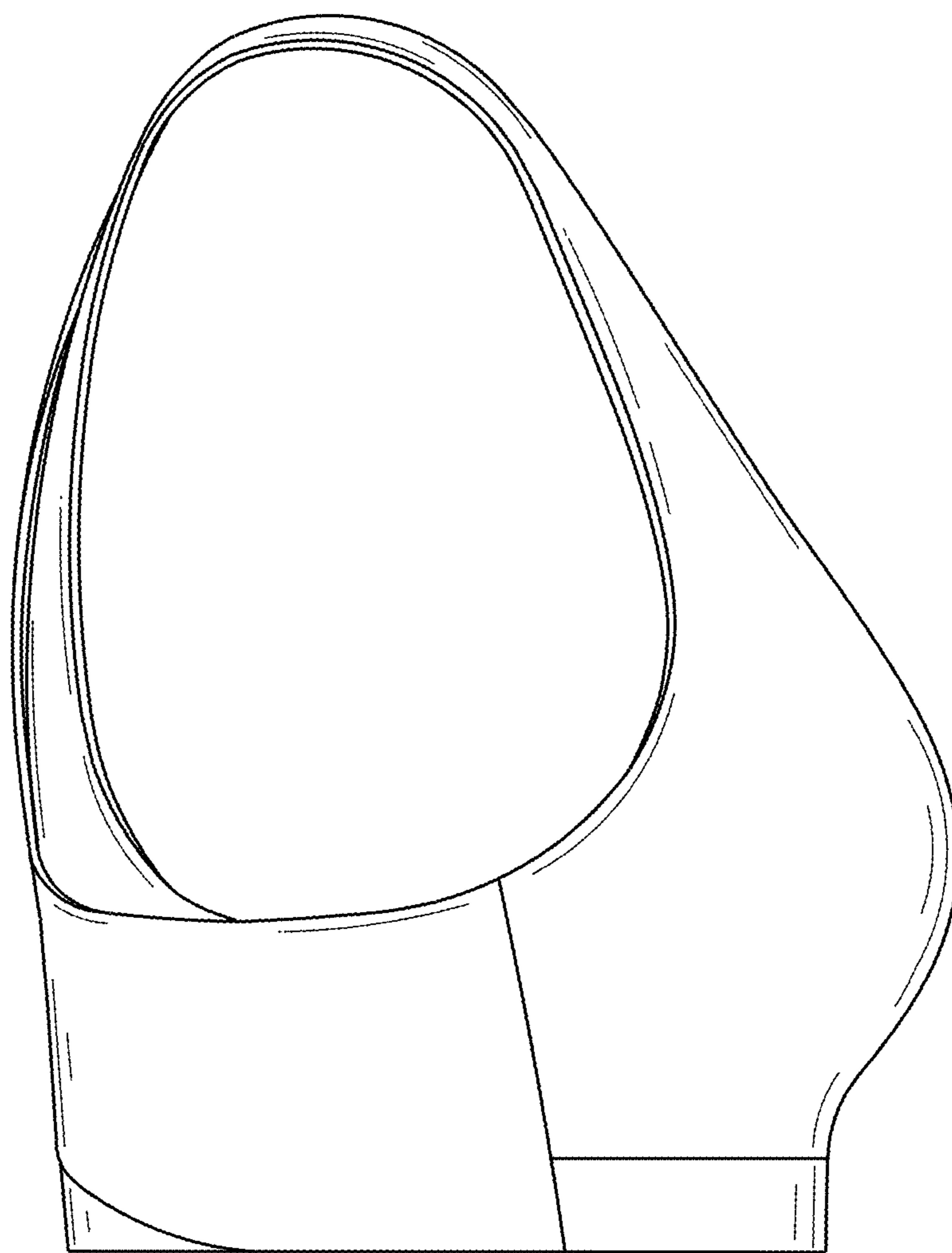

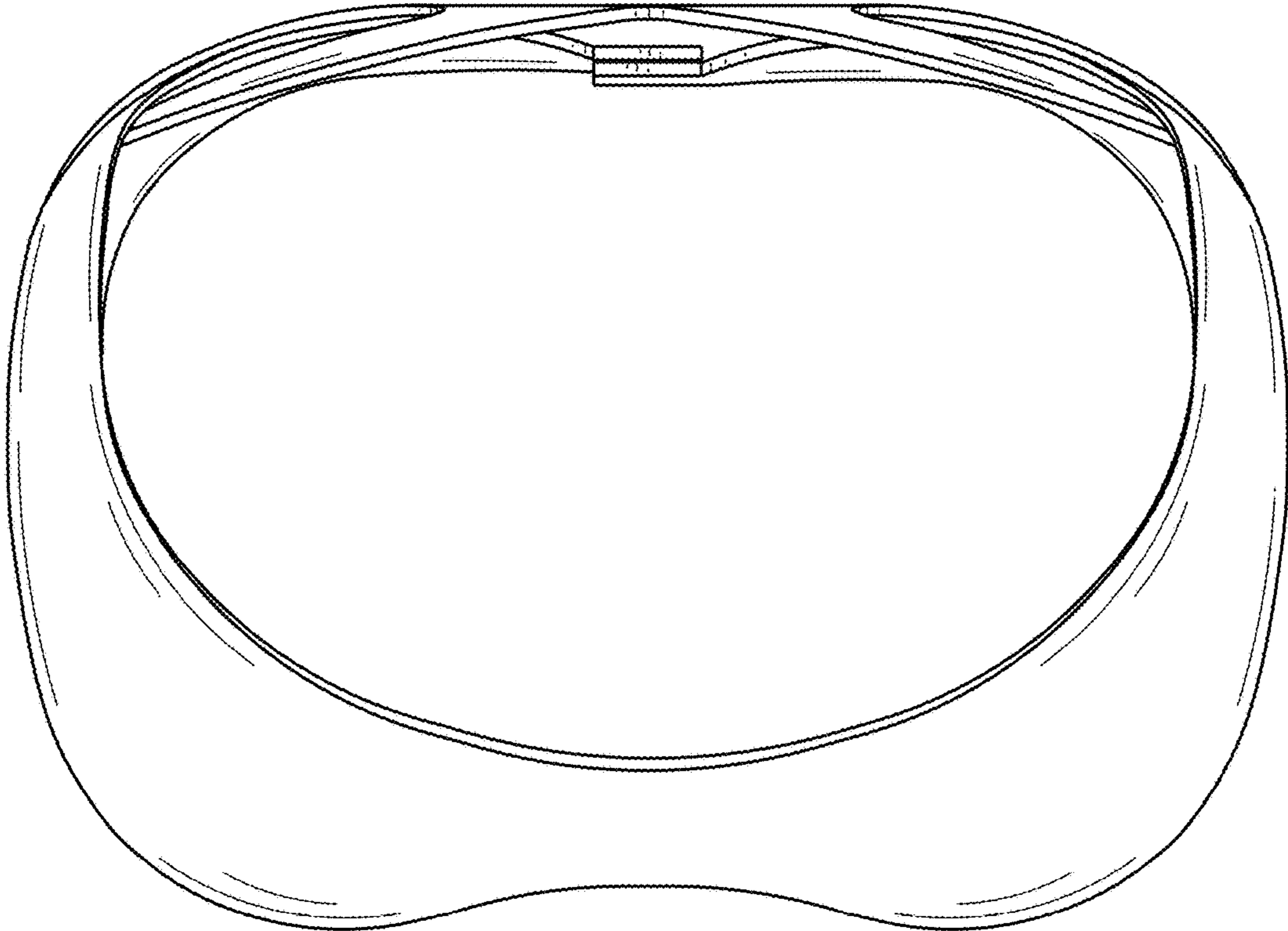

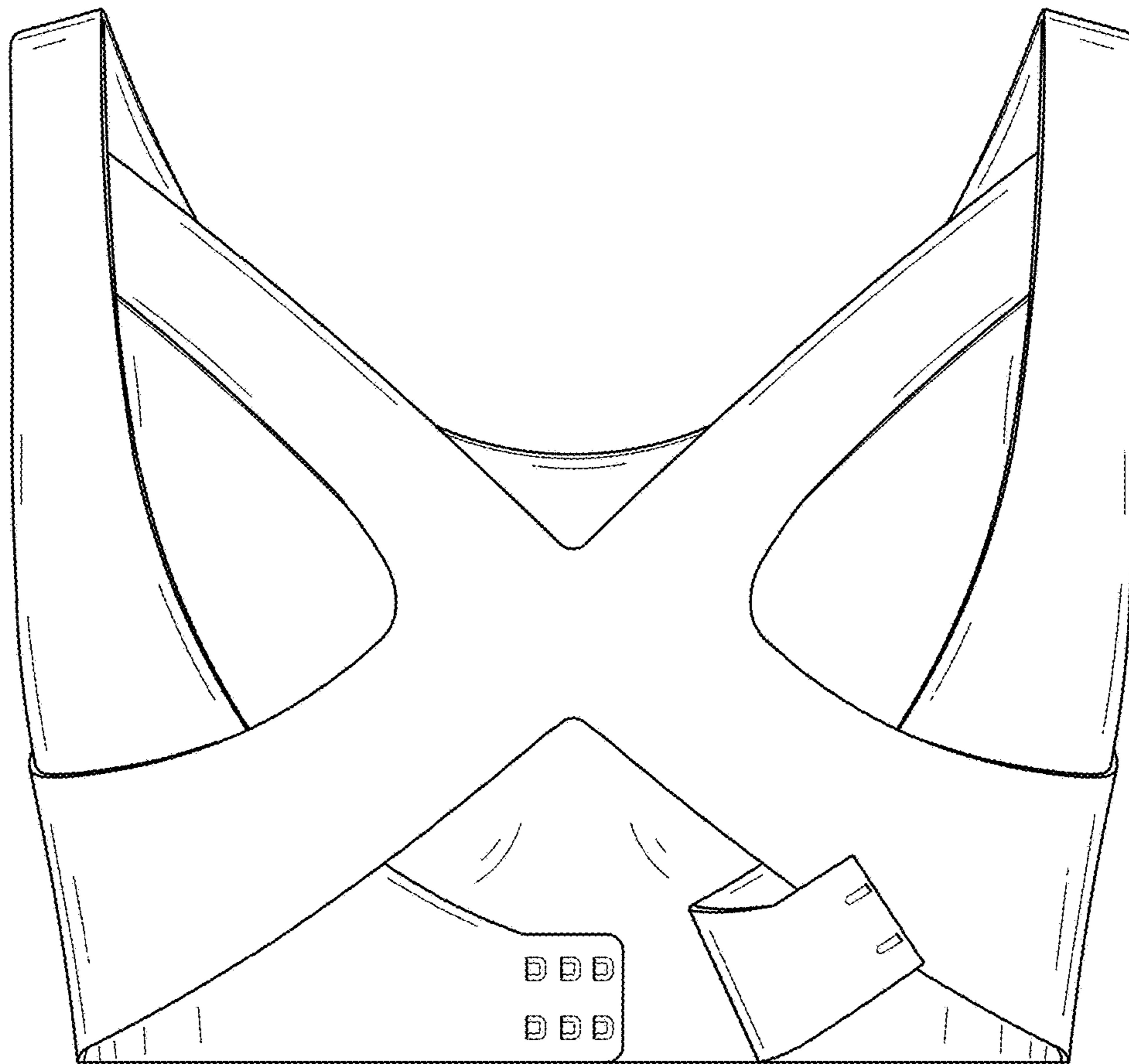
