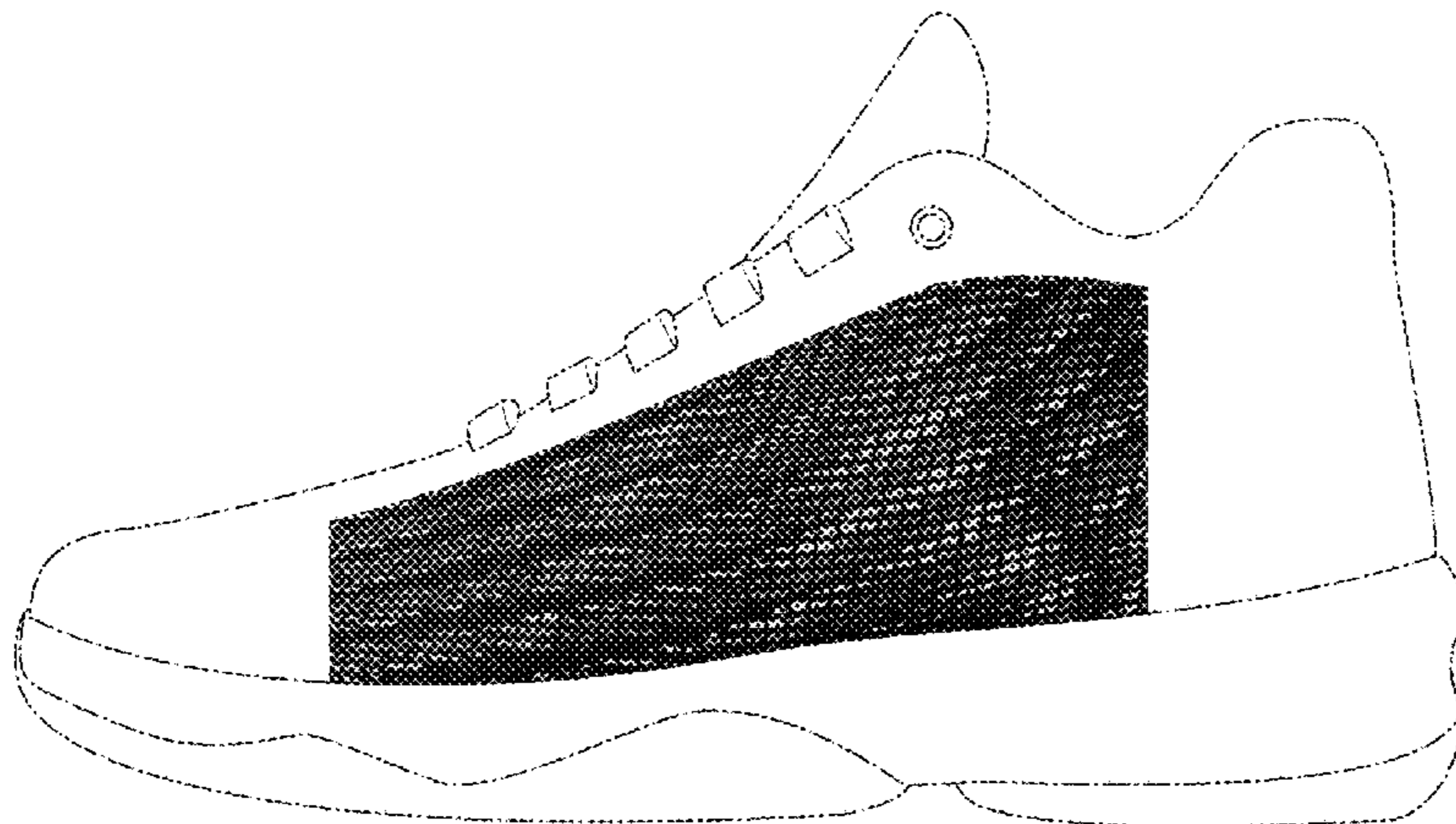
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof; and,
FIG. 4 is an enlarged view of FIG. 2 with environment removed for clarity.
The photographic area shows the claim. The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe are for enviromental purposes only and form no part of the claimed design.

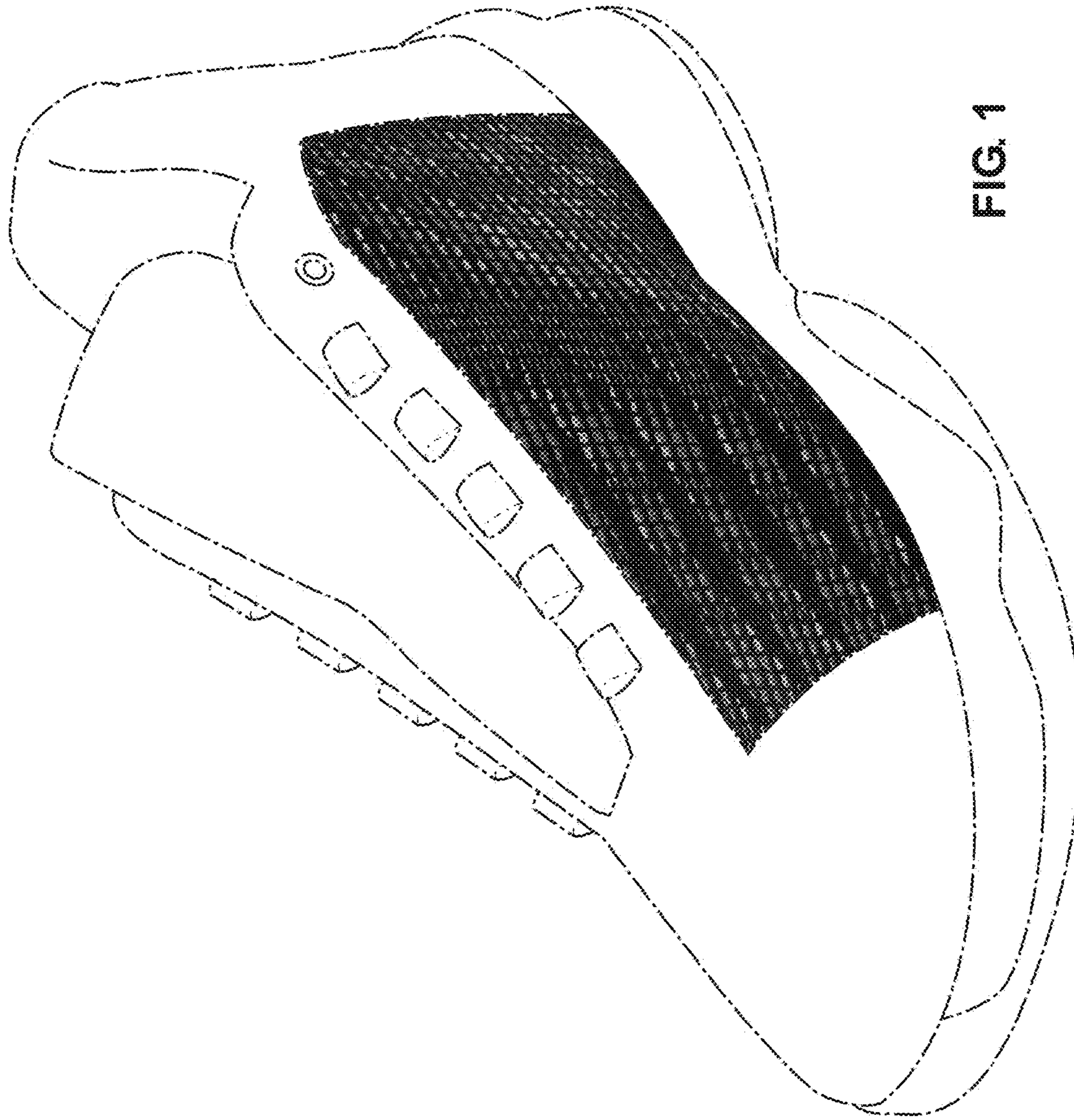

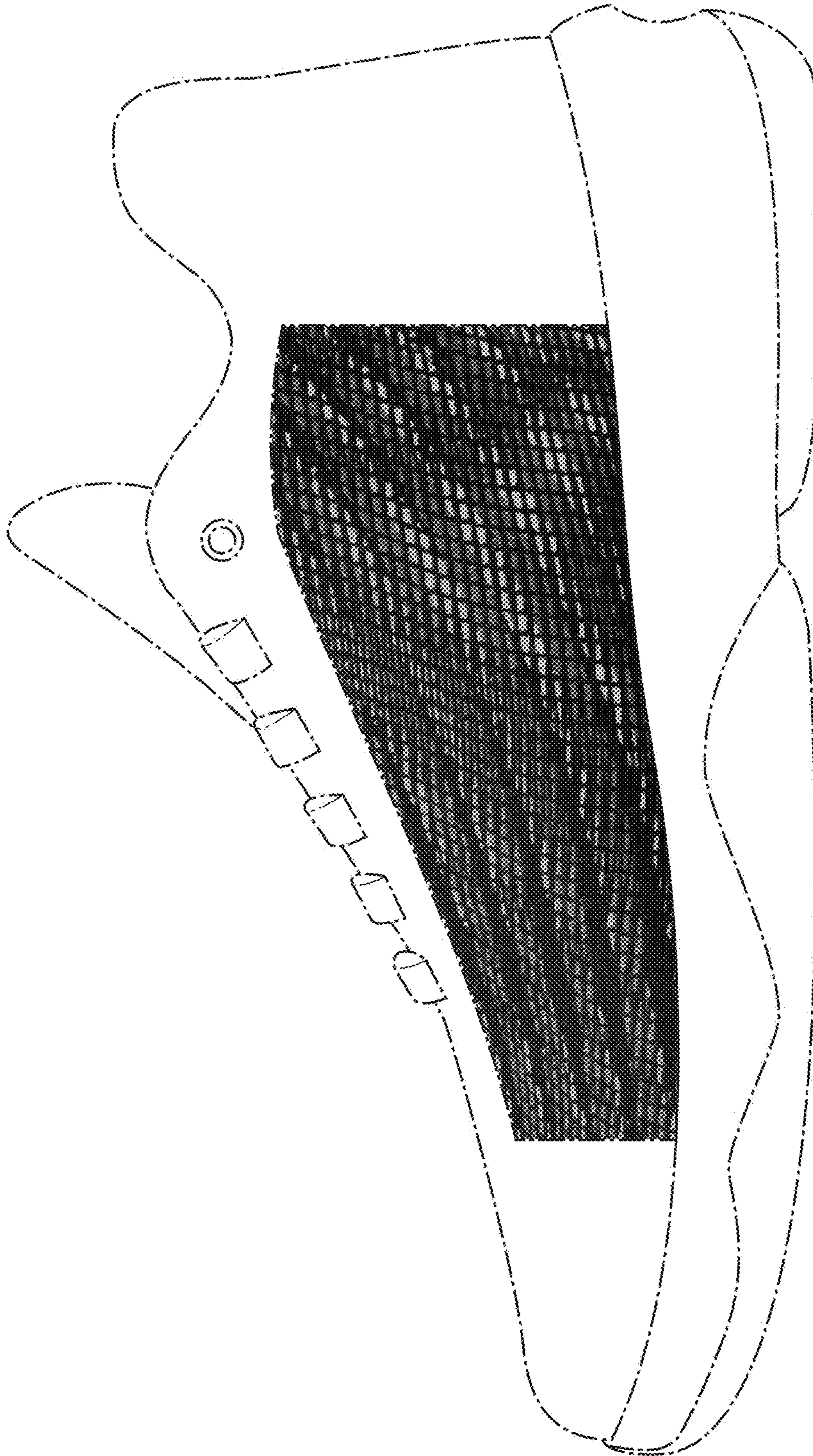

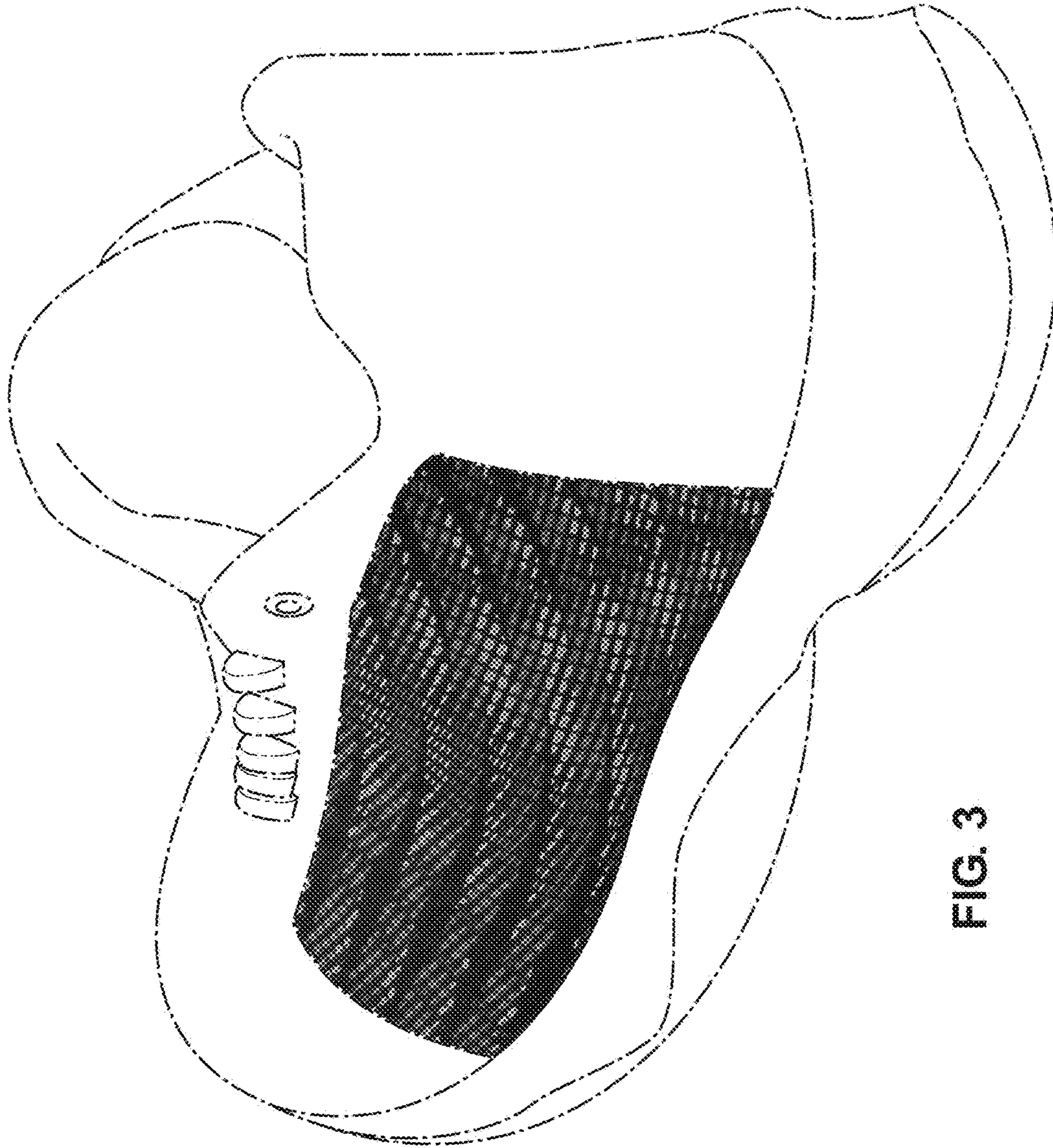

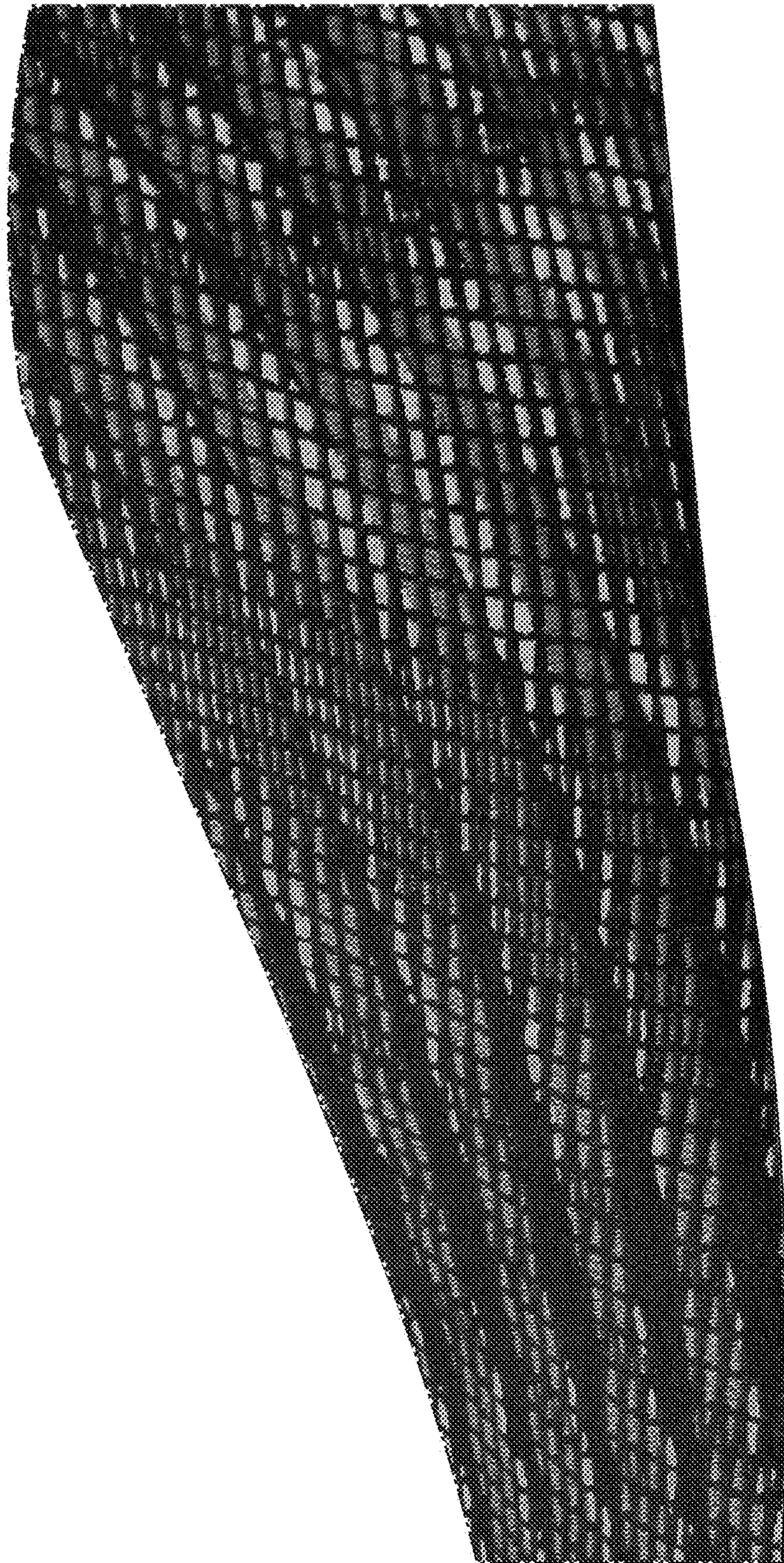
