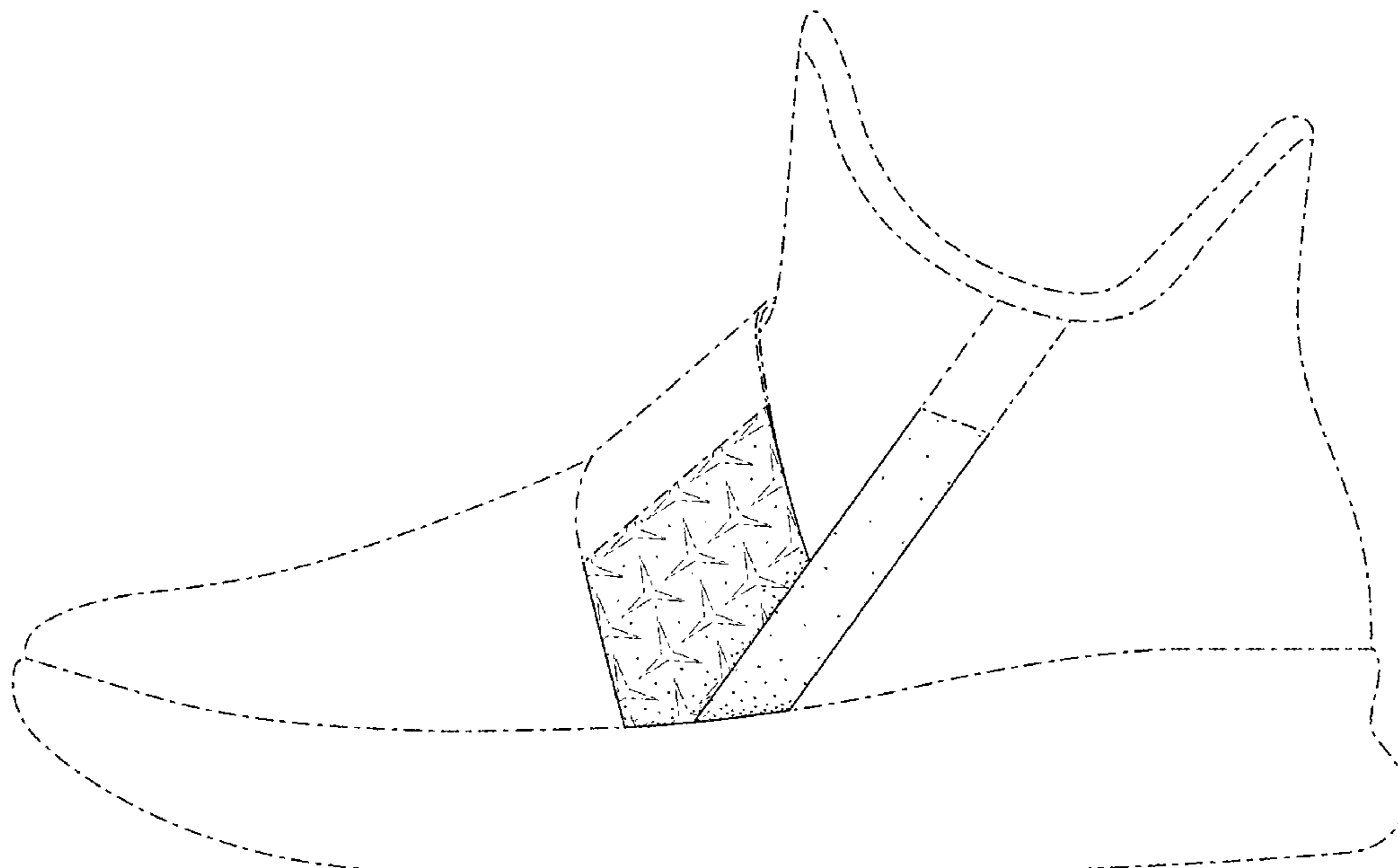

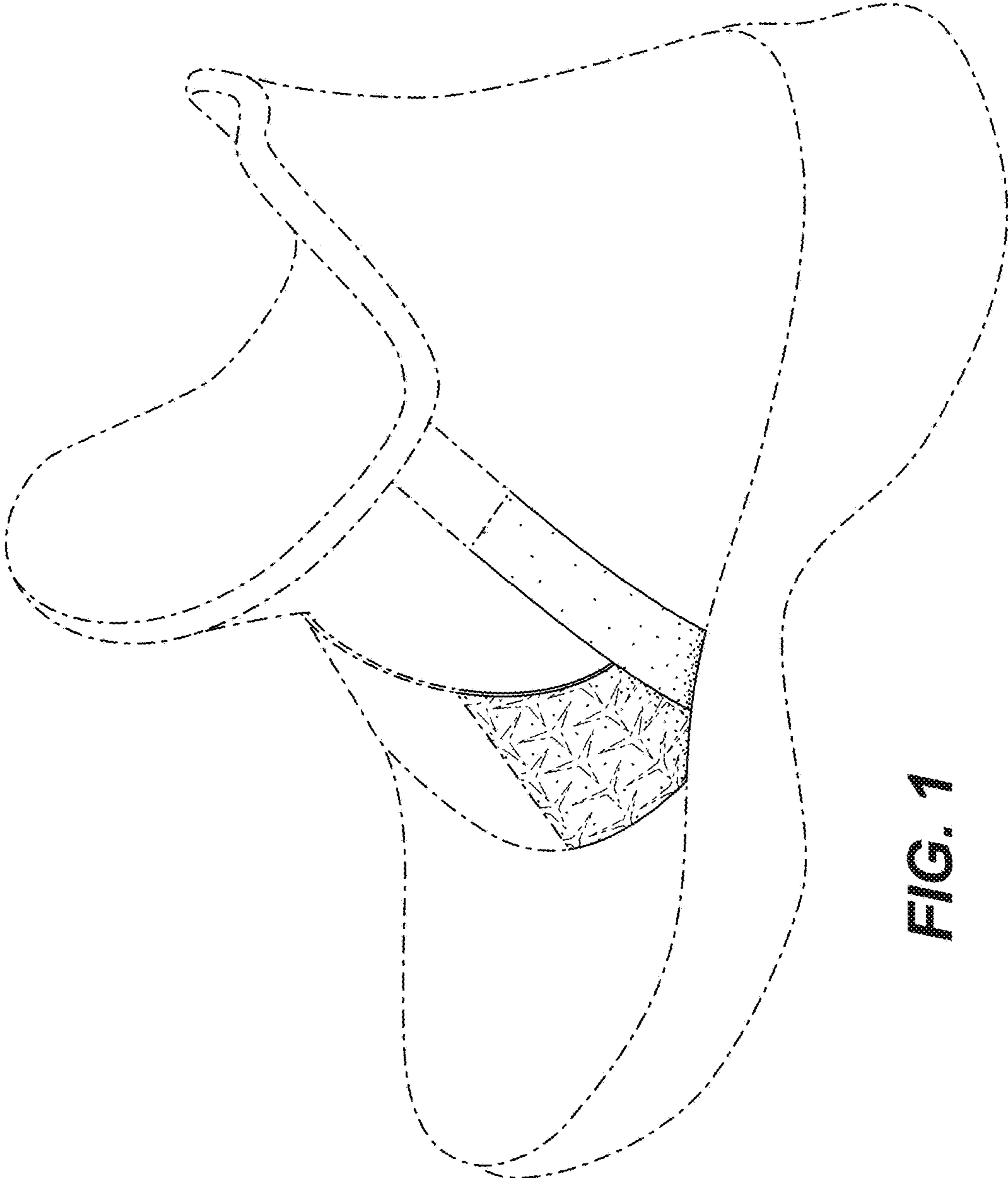
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

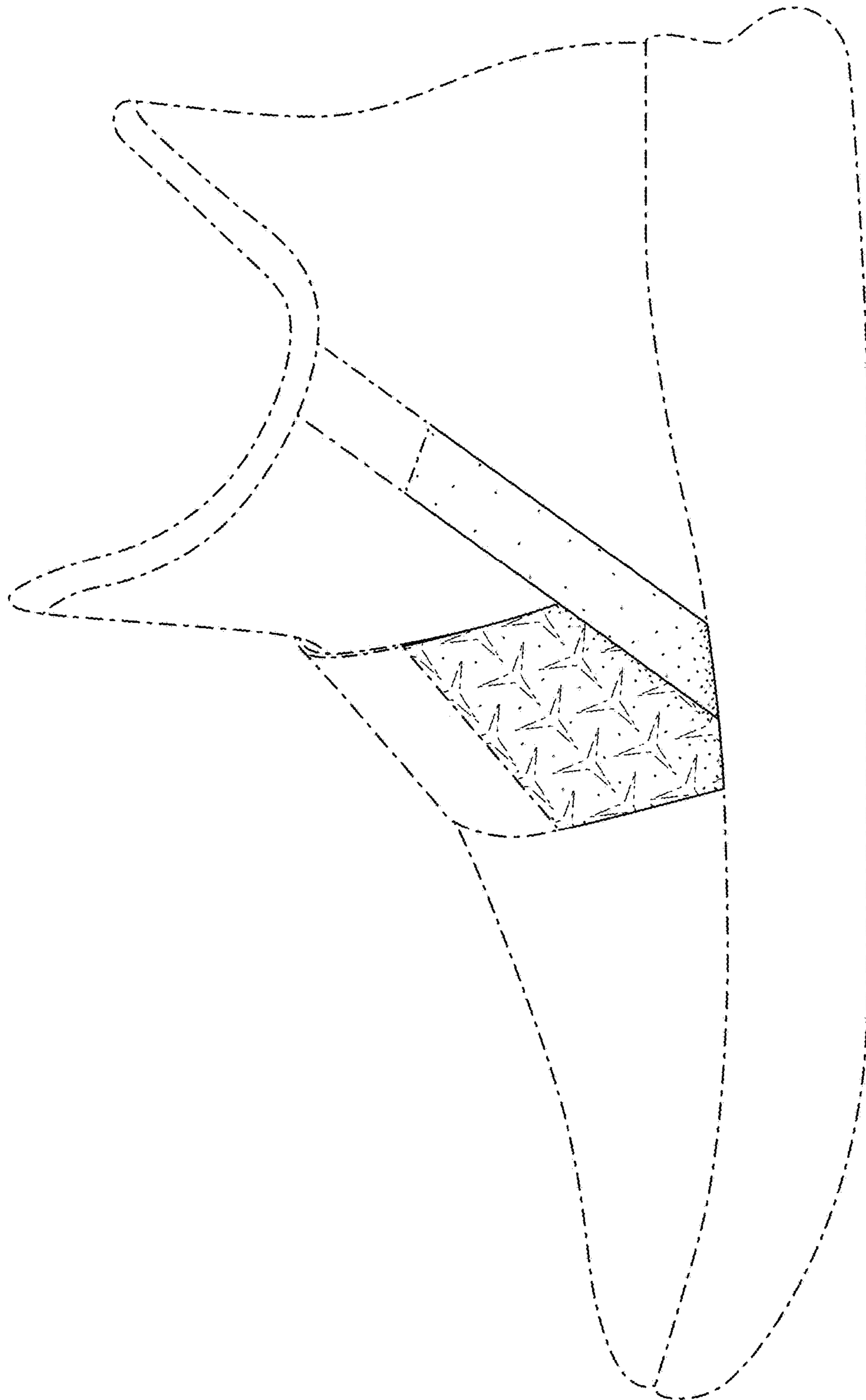
FIG. 1 is a rear perspective view of a shoe upper showing my new design;

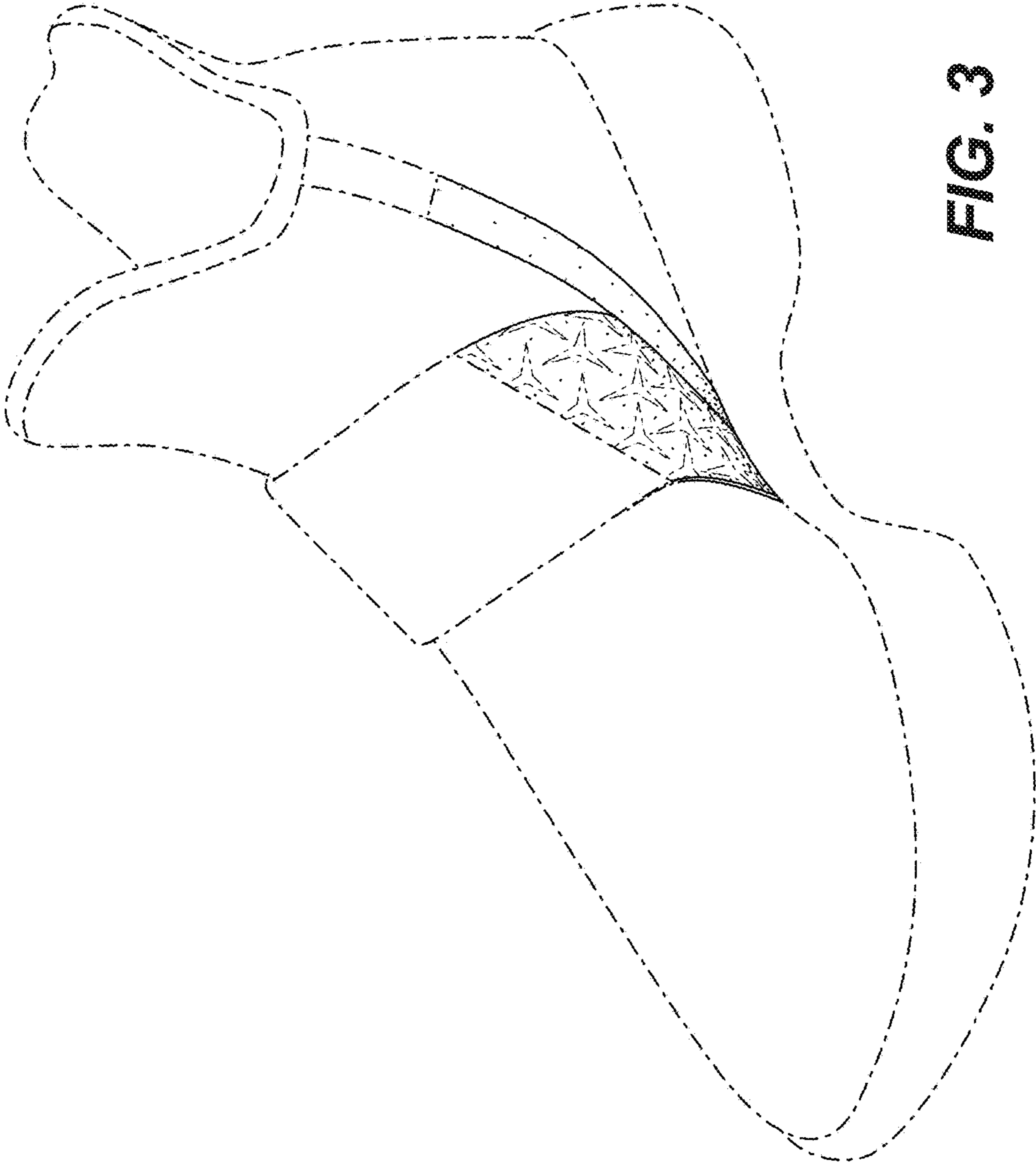
