DESCRIPTION

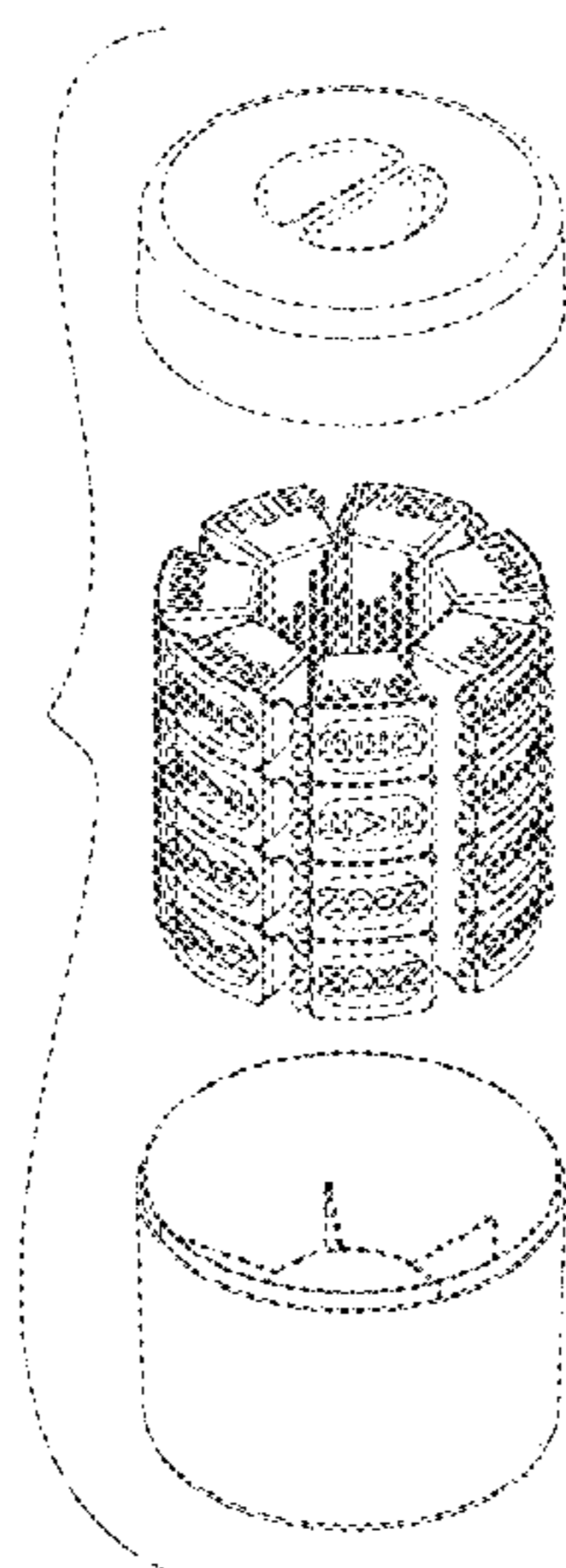
FIG. 1 is a perspective view of a weekly pill organizer shown in a closed state;
FIG. 2 is an exploded view of the weekly pill organizer, showing the 7 internal pill holders;
FIG. 3 is a perspective view of one of the pill holders, shown separately for ease of disclosure; and,
FIG. 4 is another perspective view of one of the pill holders, shown with one of the compartments opened for ease of disclosure.
The broken lines depict portions of the article that form no part of the claimed design.

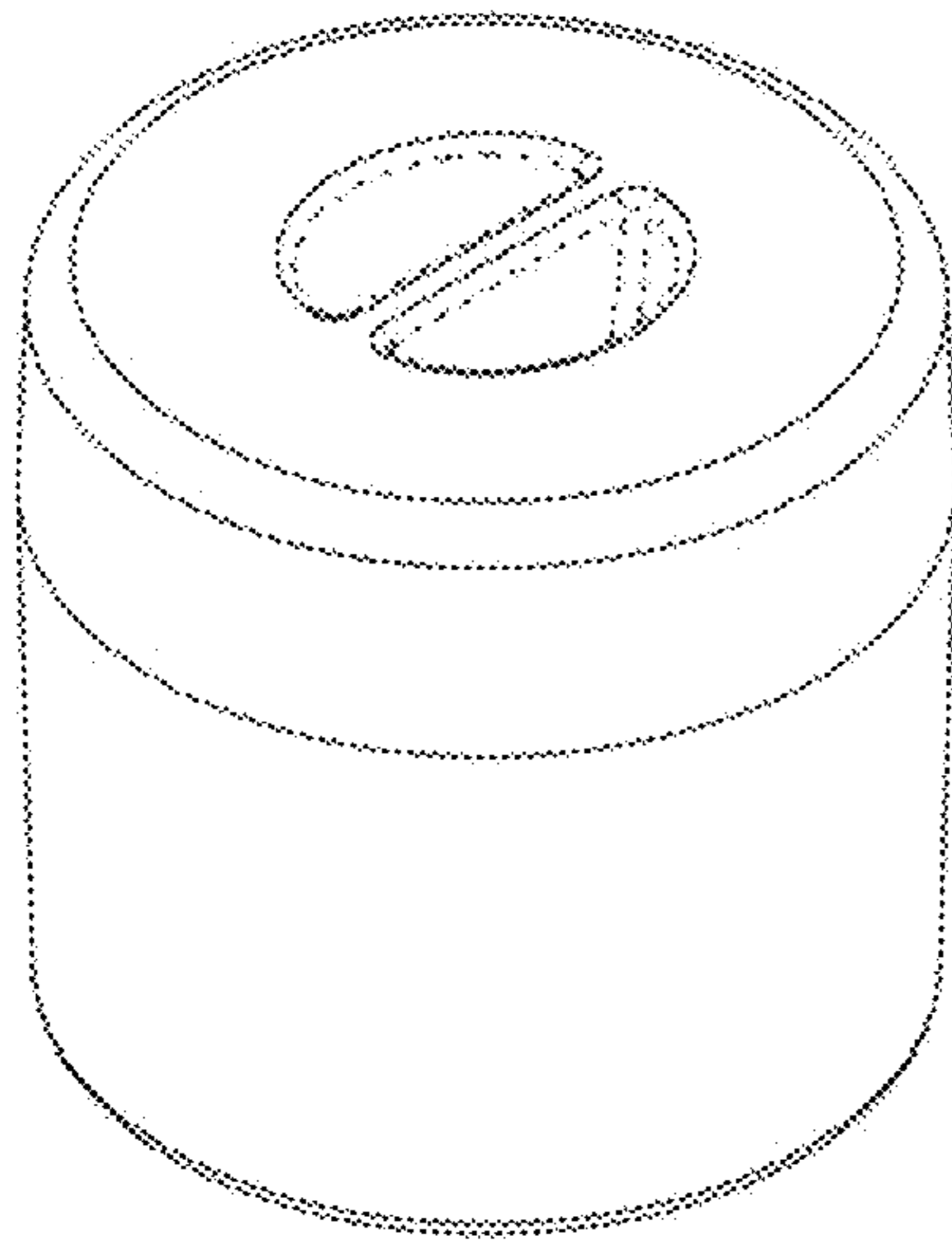

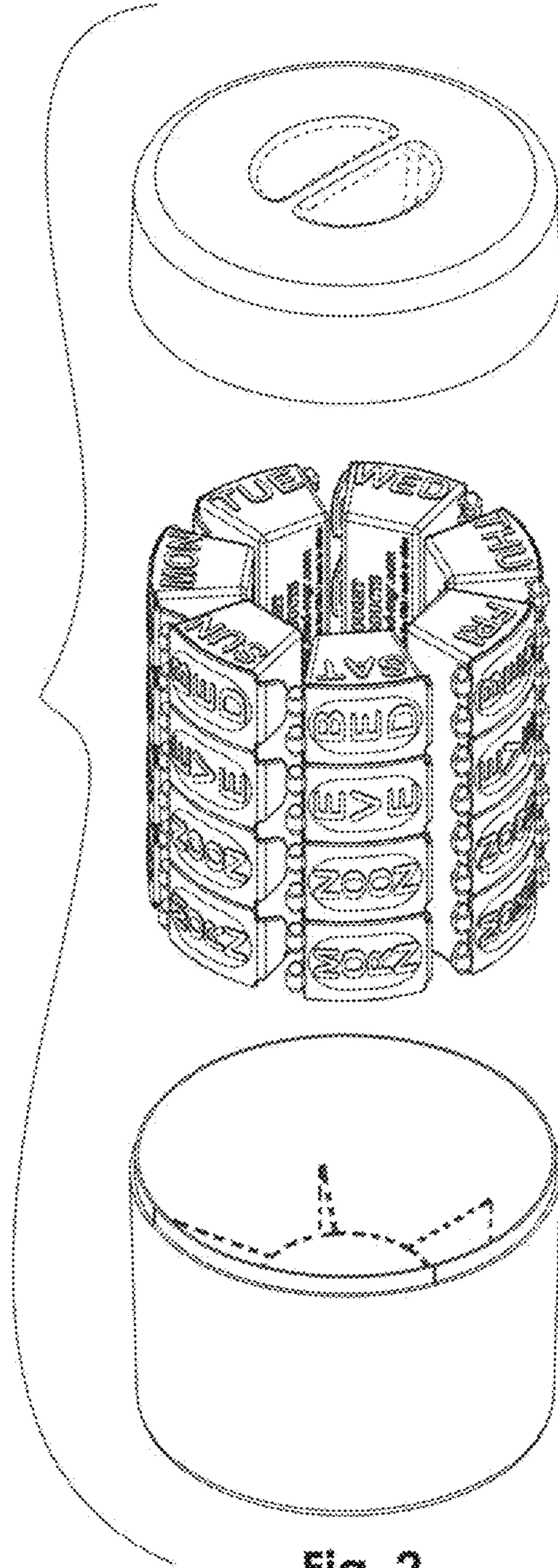

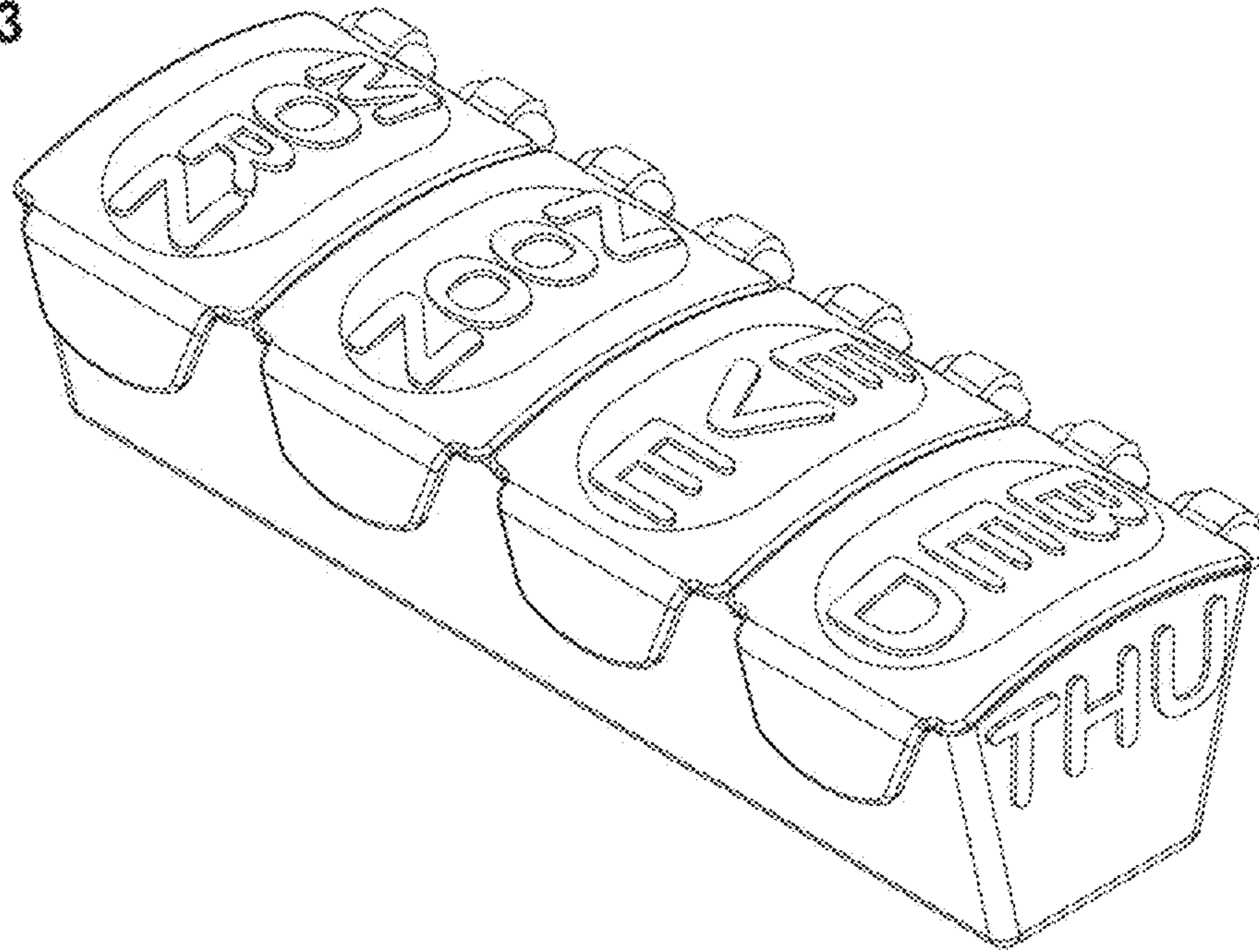
