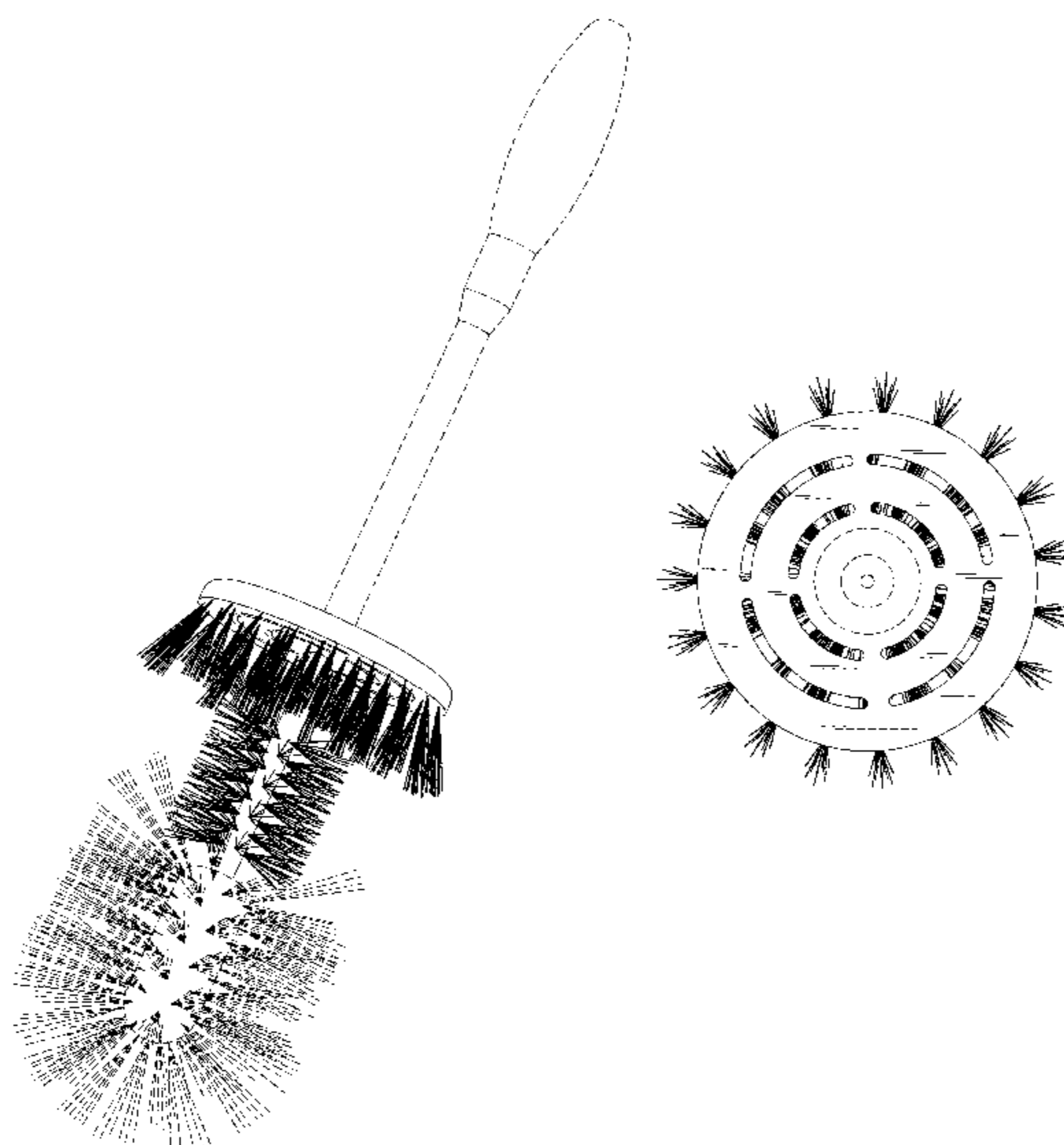
(57) **CLAIM**

The ornamental design for a toilet bowl brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the toilet bowl brush showing our new design;  
 FIG. 2 is a front view thereof, the back view, right side view, and left side view being a mirror image.  
 FIG. 3 is a top view thereof; and,  
 FIG. 4 is a bottom view thereof.  
 The broken lines shown are included for the purpose of illustrating portions of the toilet bowl brush that form no part of the claim.

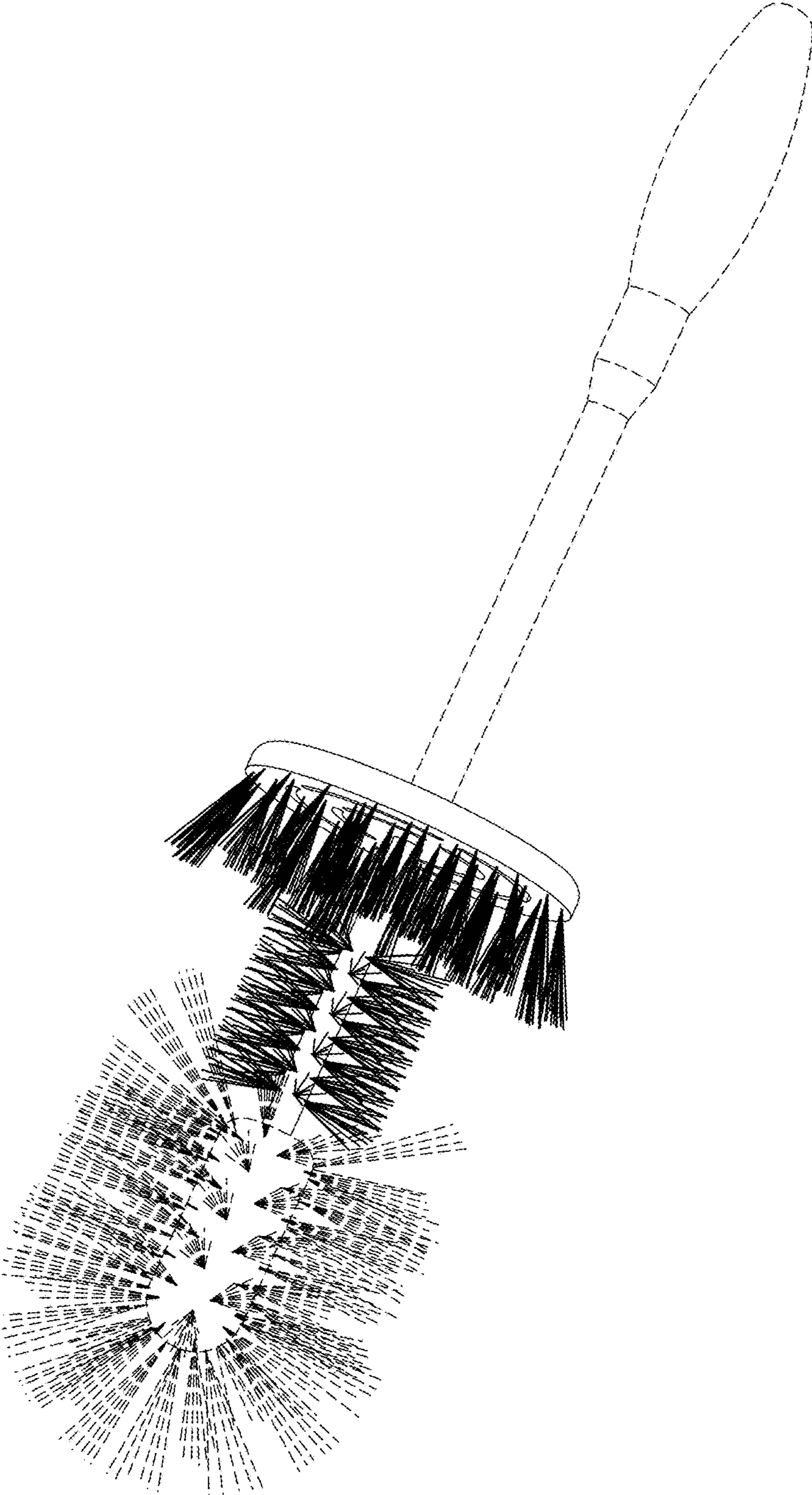

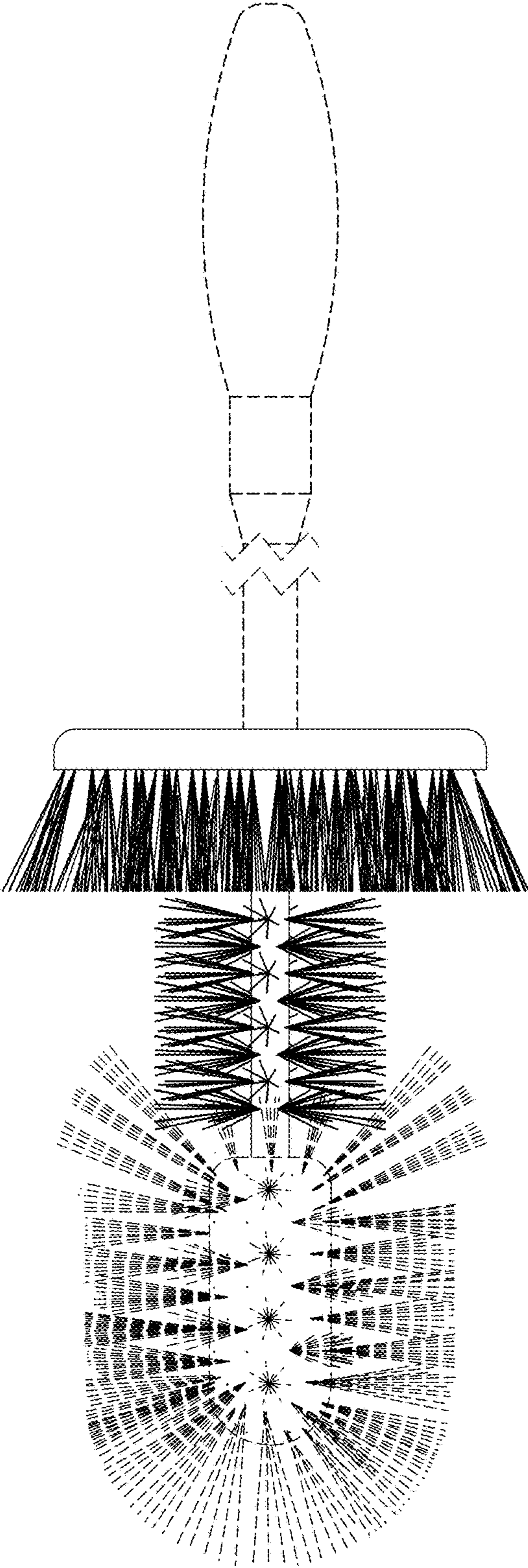

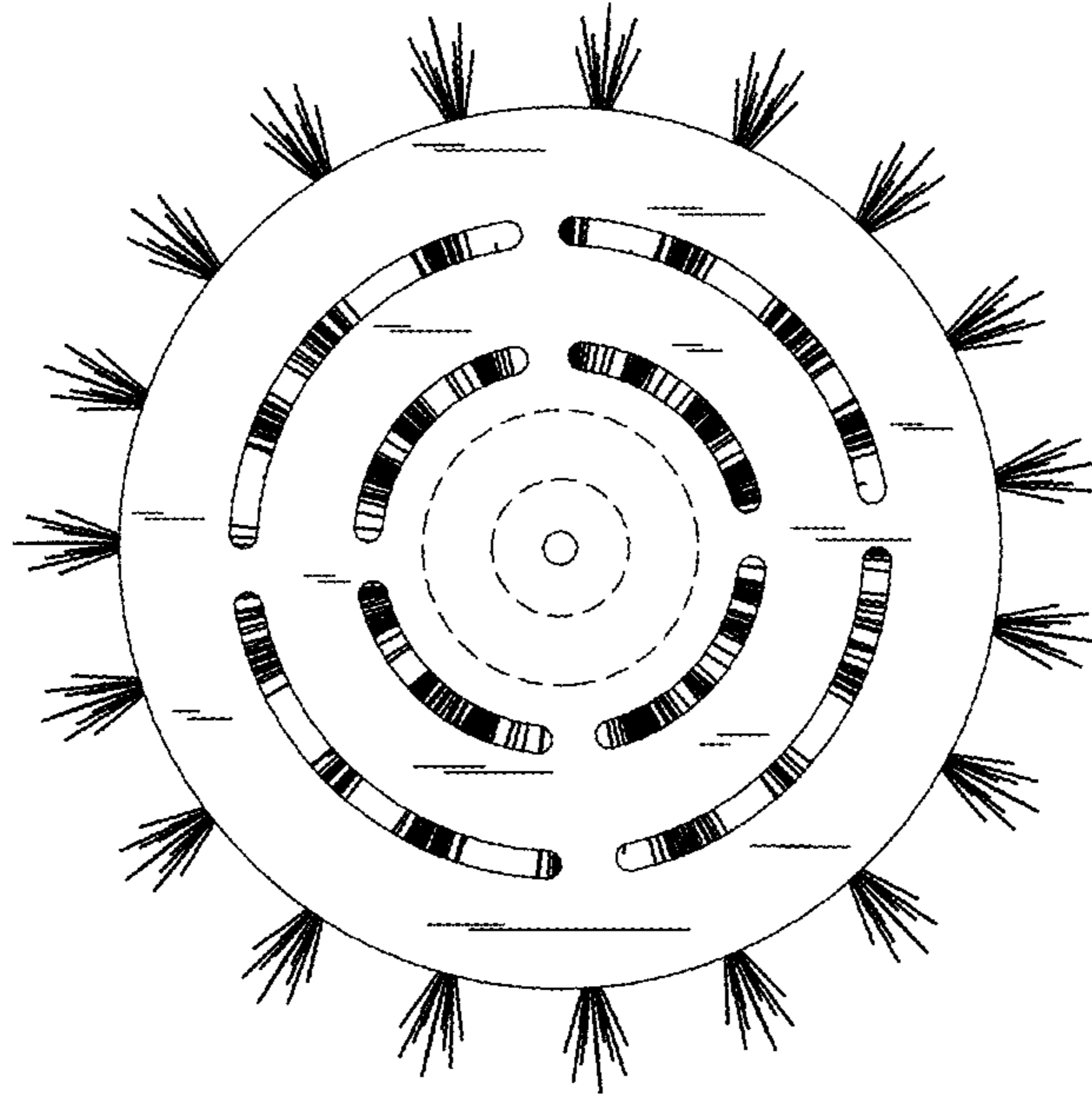

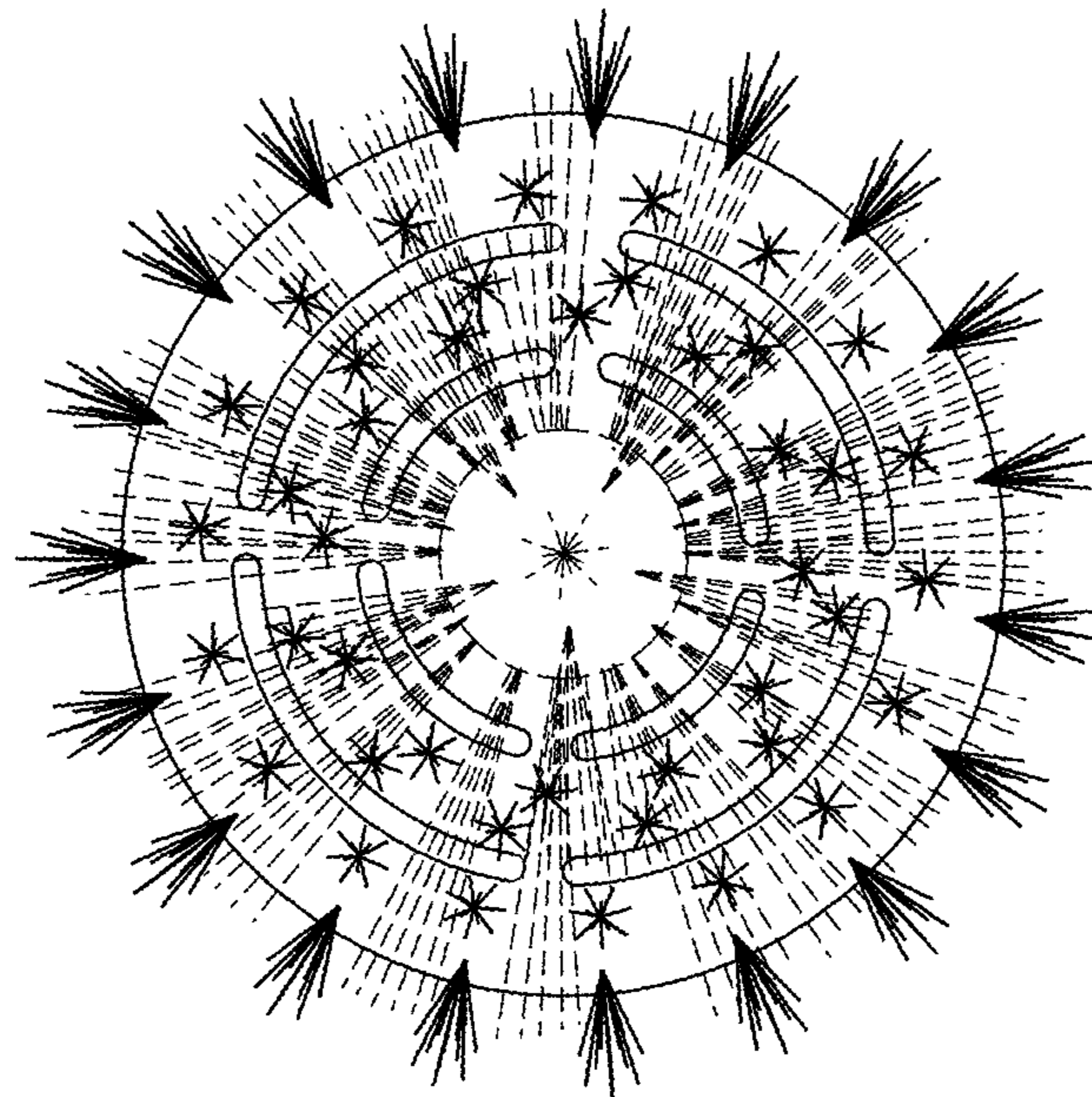
