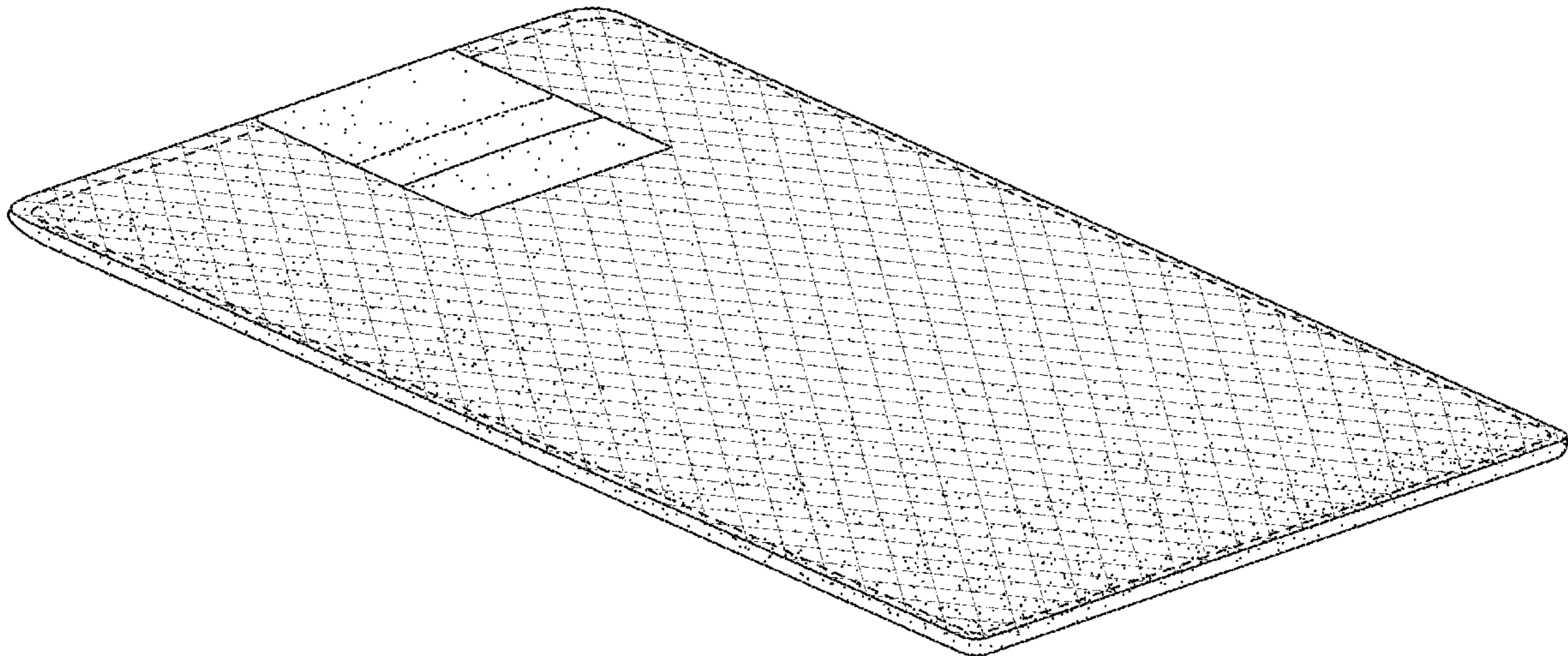
(57) **CLAIM**

The ornamental design for a folding blanket with pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new and ornamental design for a folding blanket with pouch;
FIG. 2 is a top plan thereof;
FIG. 3 is a bottom plan thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a front view of the folding blanket folded into the pouch; and,
FIG. 9 is a rear view of the folding blanket folded into the pouch.
The broken lines represent stitching.

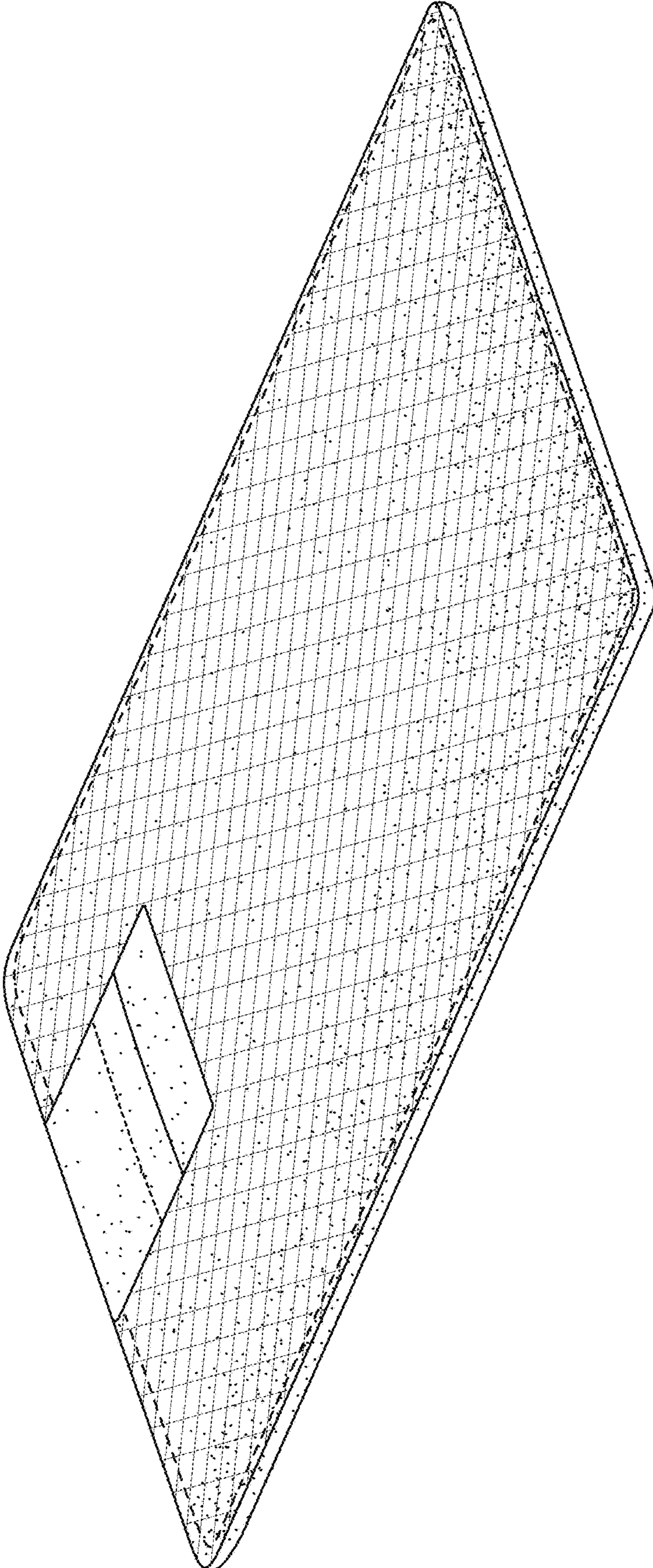

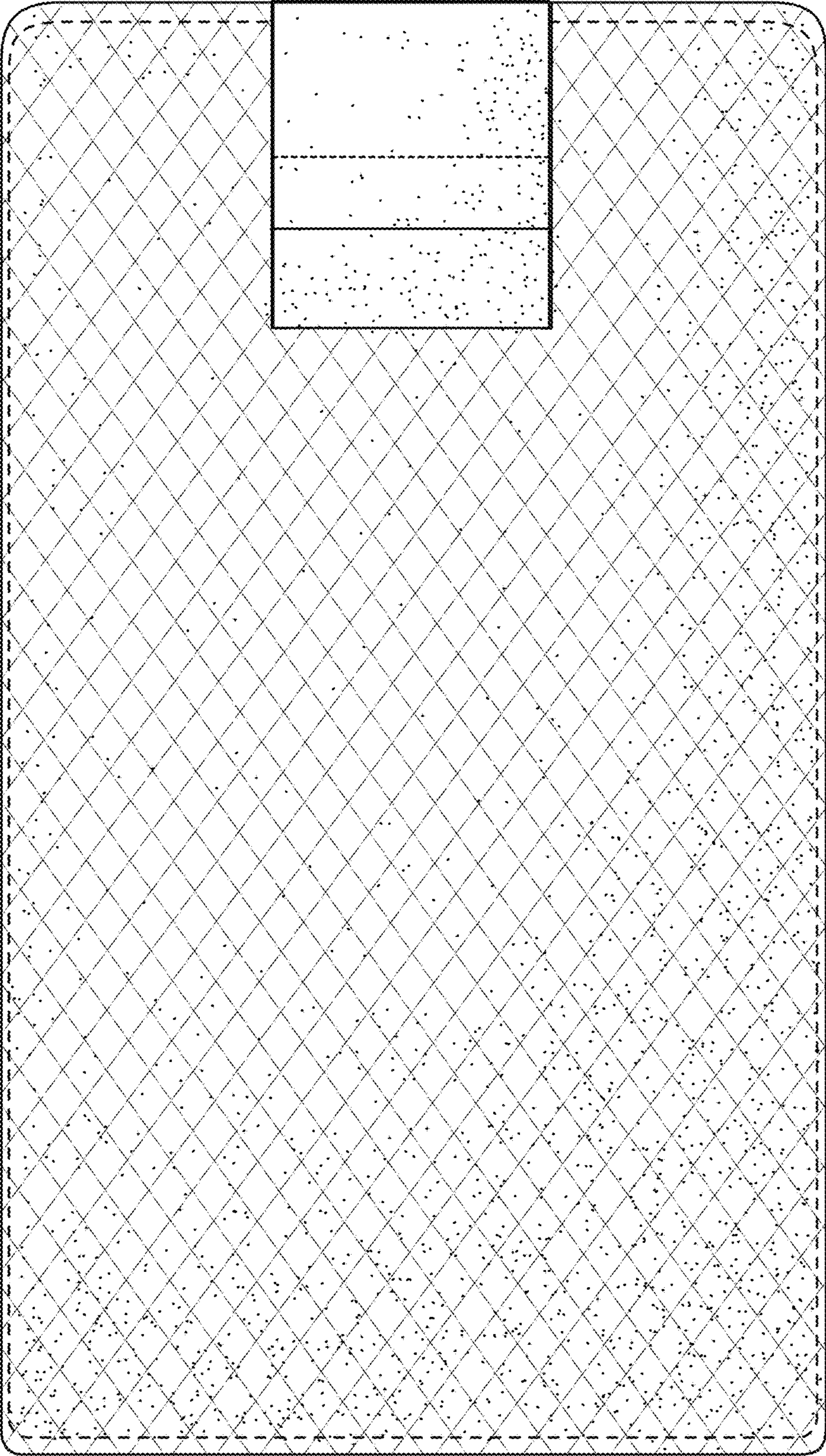

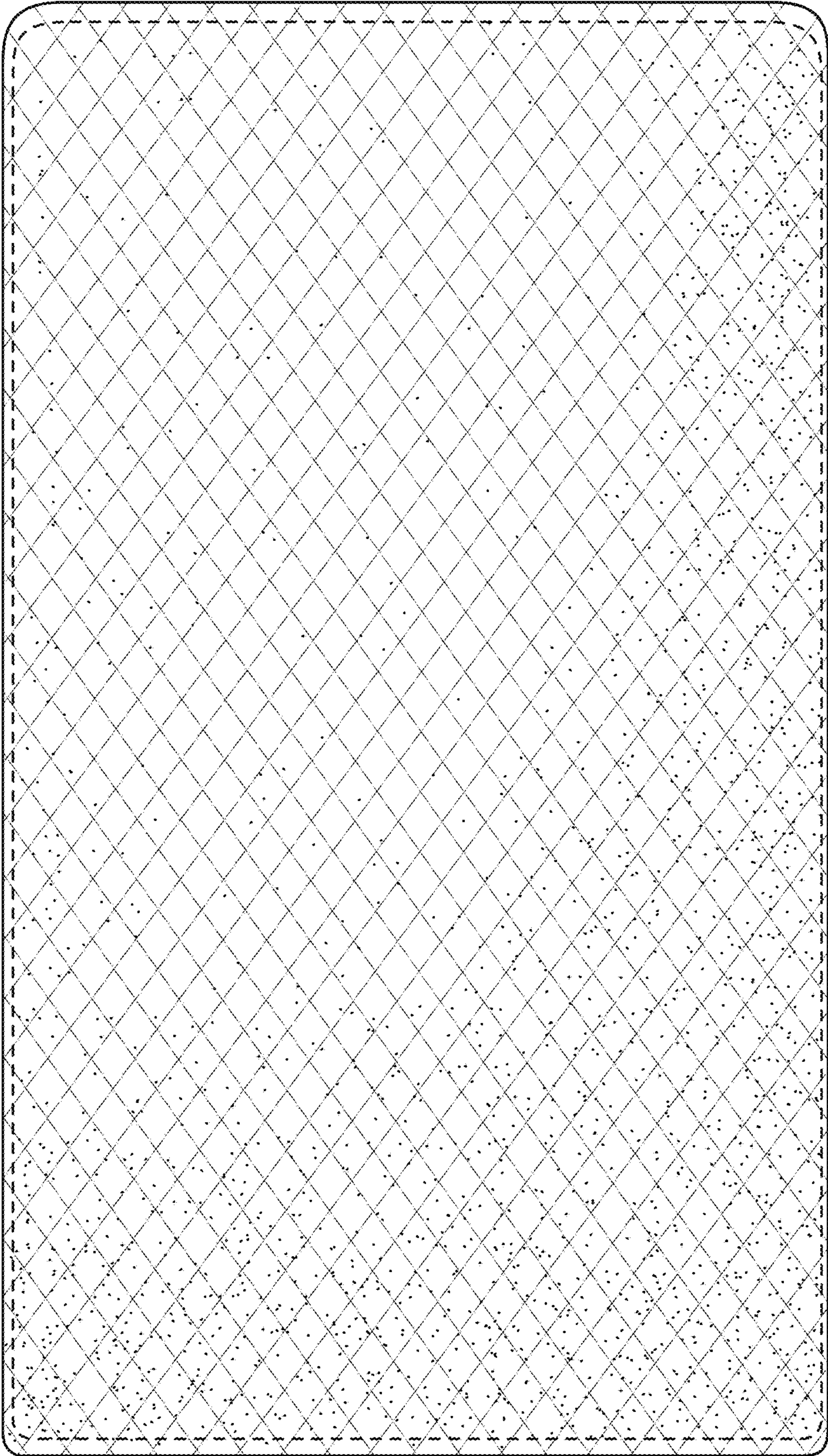

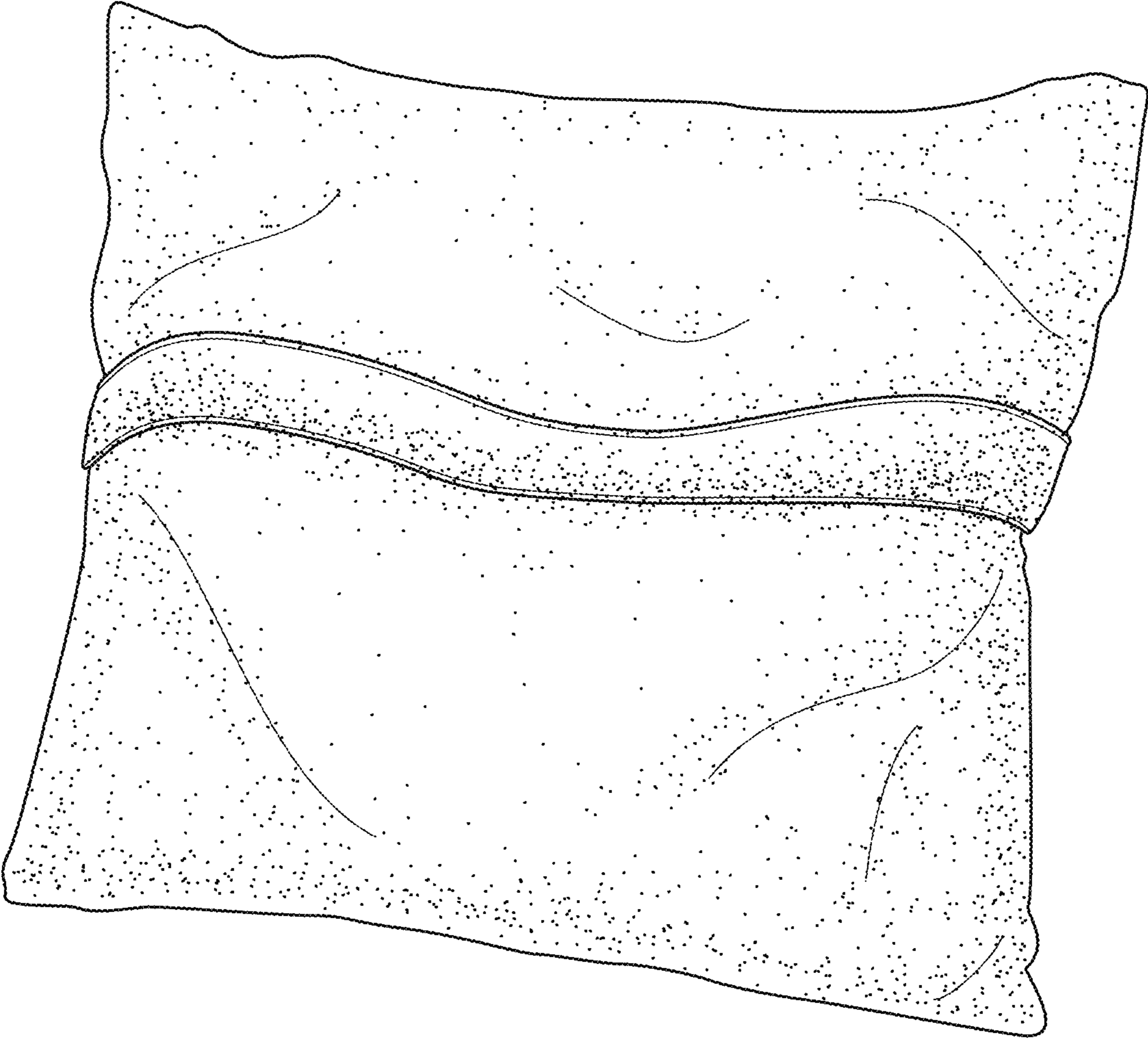

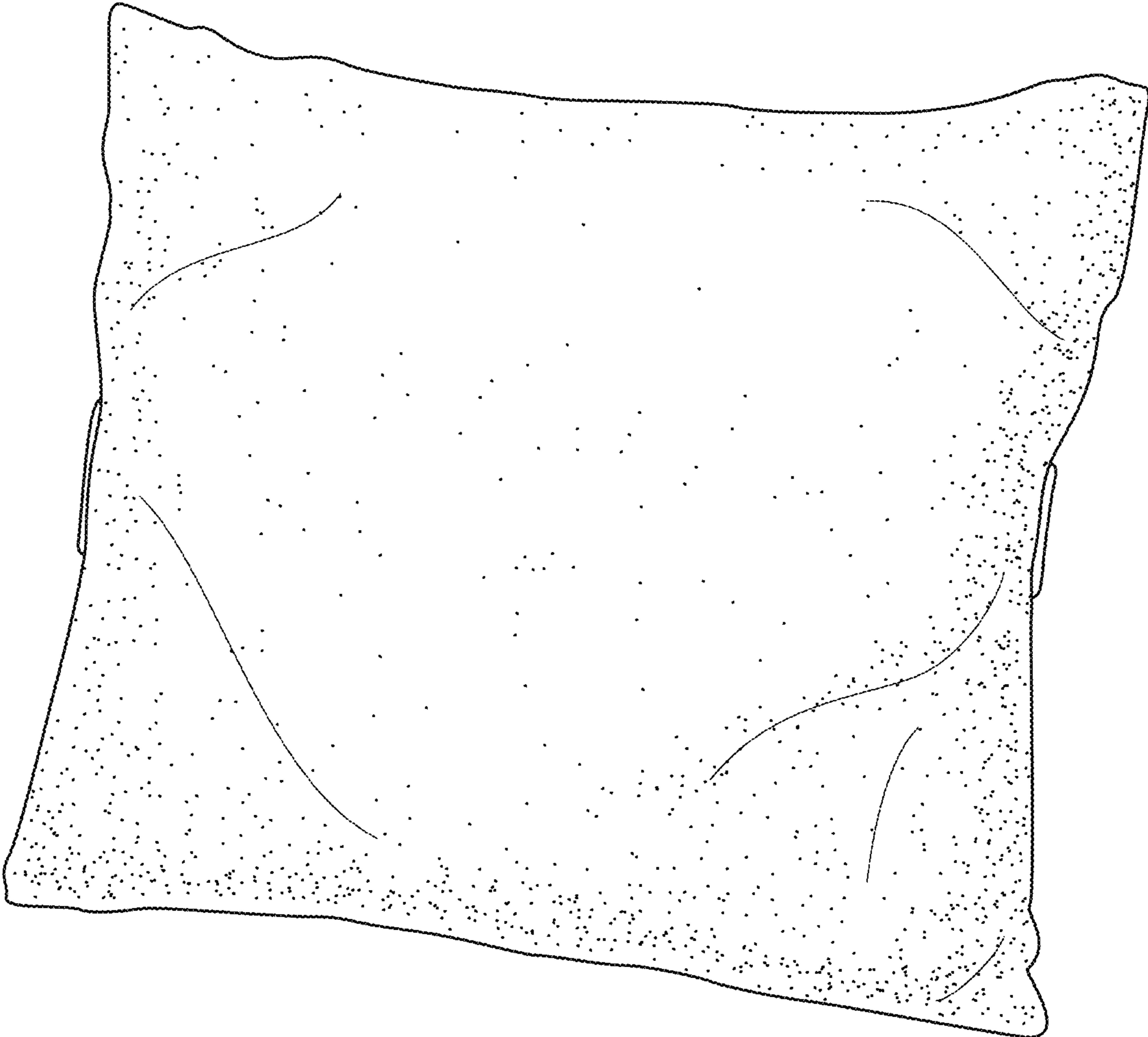
