(57) **CLAIM**

An ornamental design for a slip cover for a cake stand, as shown and described.

DESCRIPTION

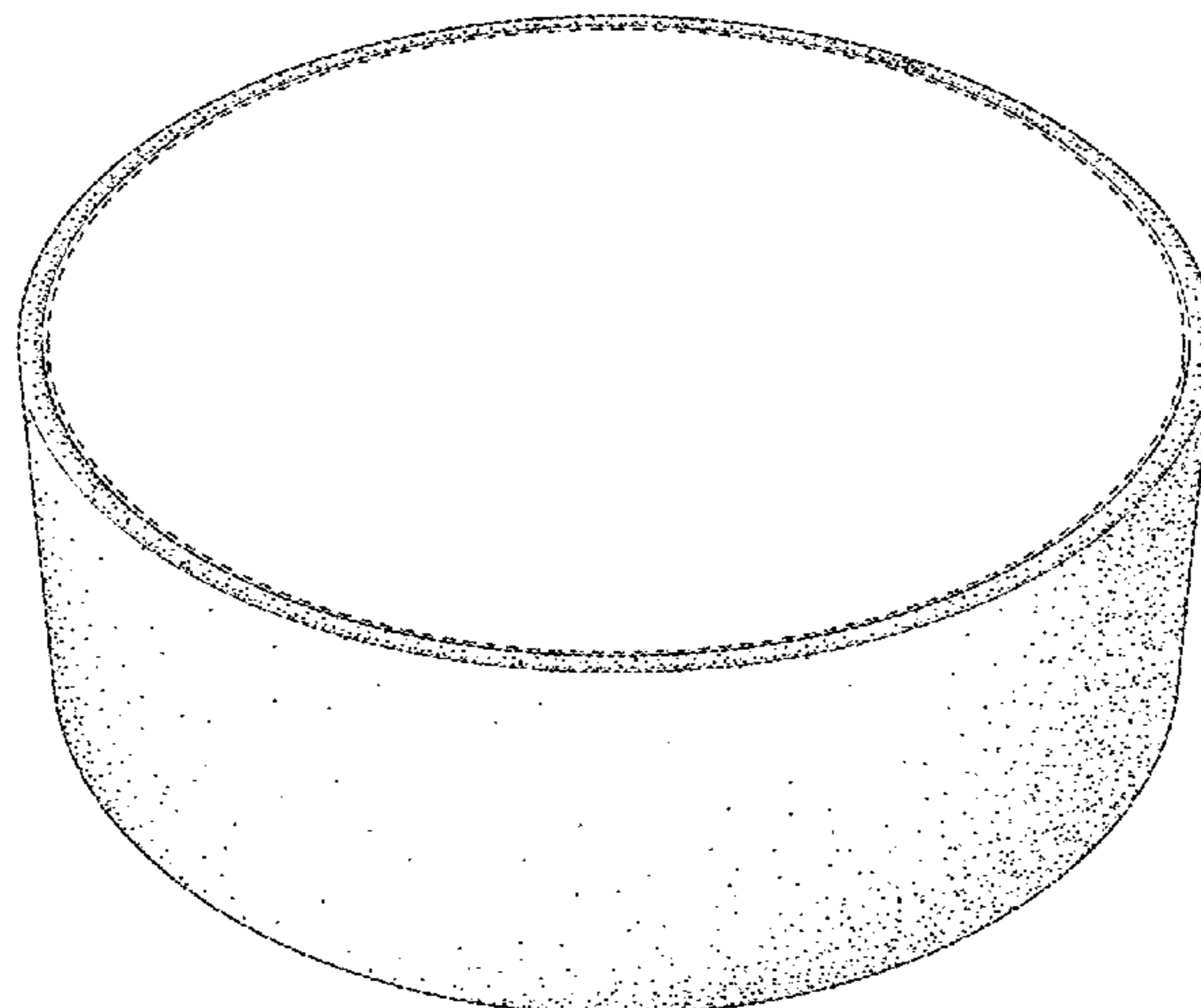
FIG. 1 is a front perspective view of the slip cover for a cake stand, the central portion of which is unclaimed. The stippled shading indicates a texture.
 FIG. 2 is a front view of the slip cover for a cake stand.
 FIG. 3 is a rear view of the slip cover for a cake stand having a sewing seam line.
 FIG. 4 is a side view of the slip cover for a cake stand.
 FIG. 5 is a side view of the slip cover for a cake stand.
 FIG. 6 is a top view of the slip cover for a cake stand, the central portion of which is unclaimed; and,
 FIG. 7 is a bottom view of the slip cover for a cake stand, the central portion of which is unclaimed.
 The broken line indicating the stitching forms part of the claim.

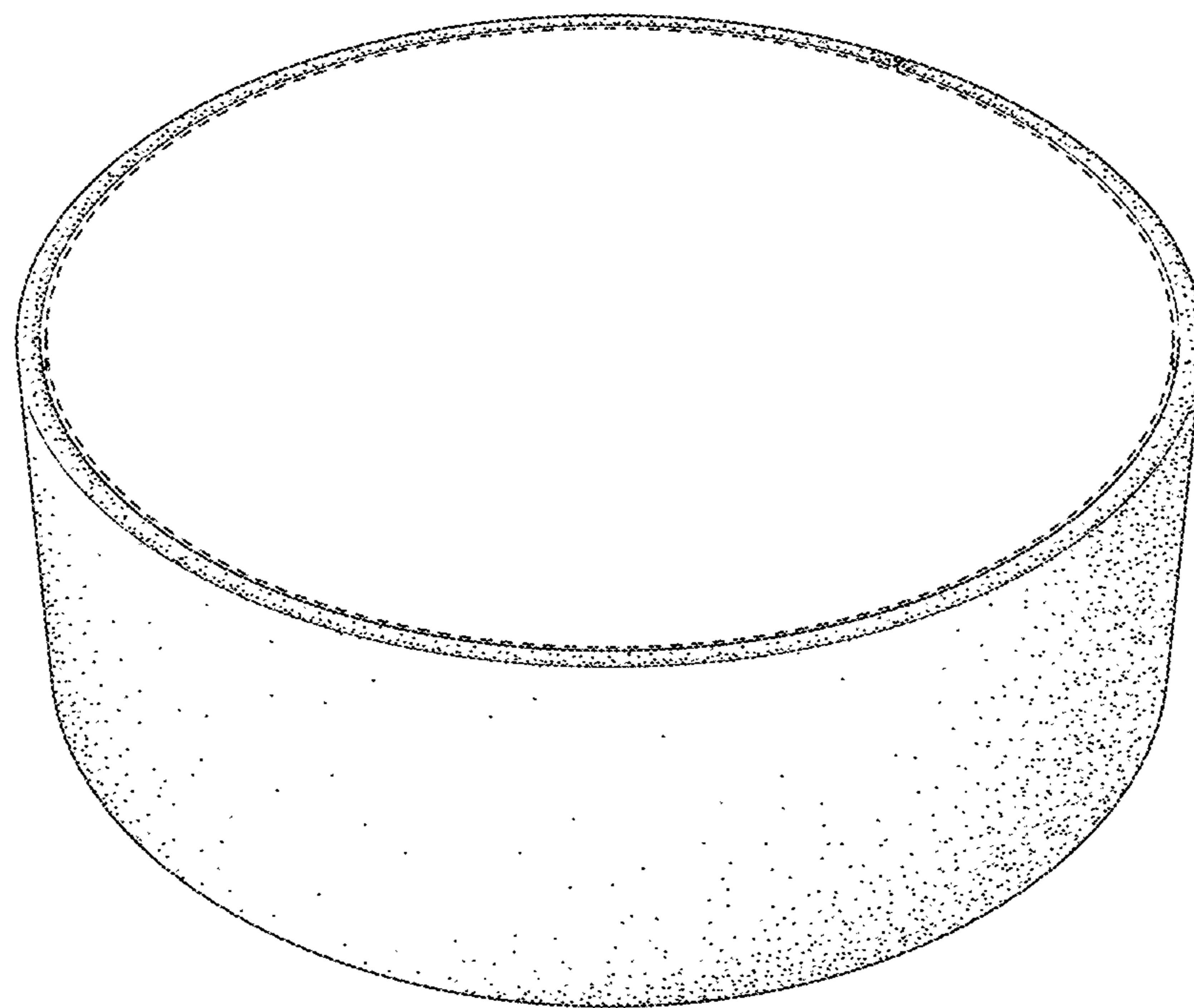

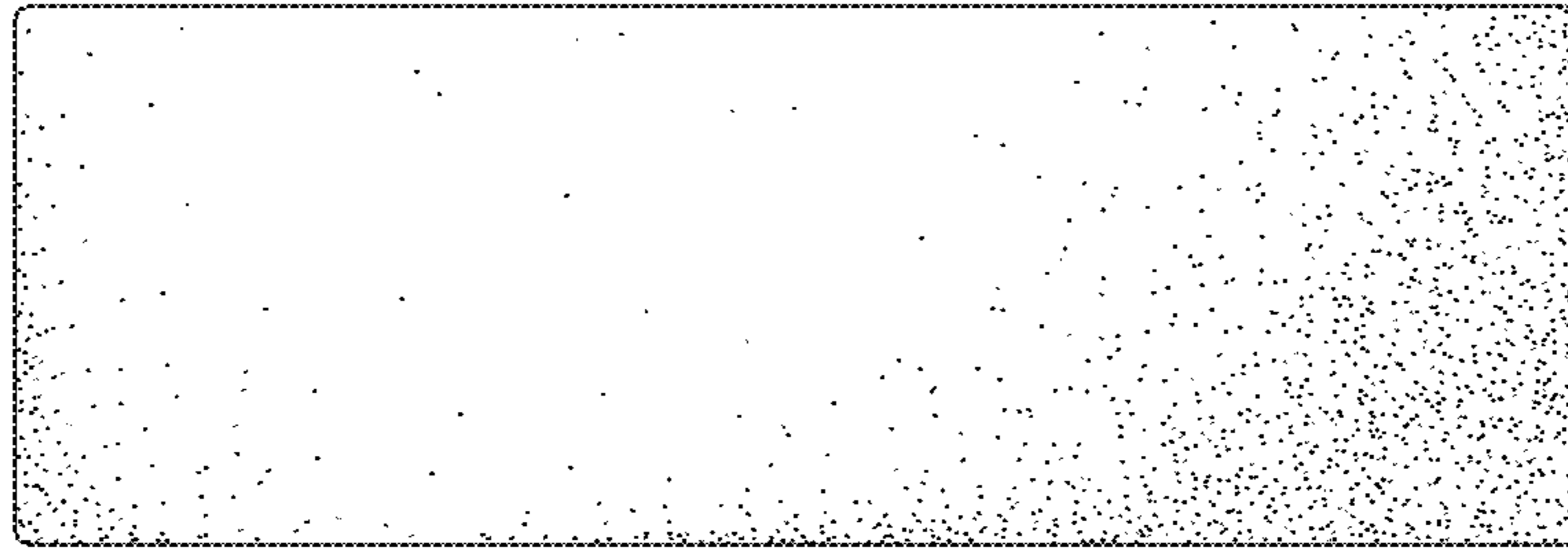

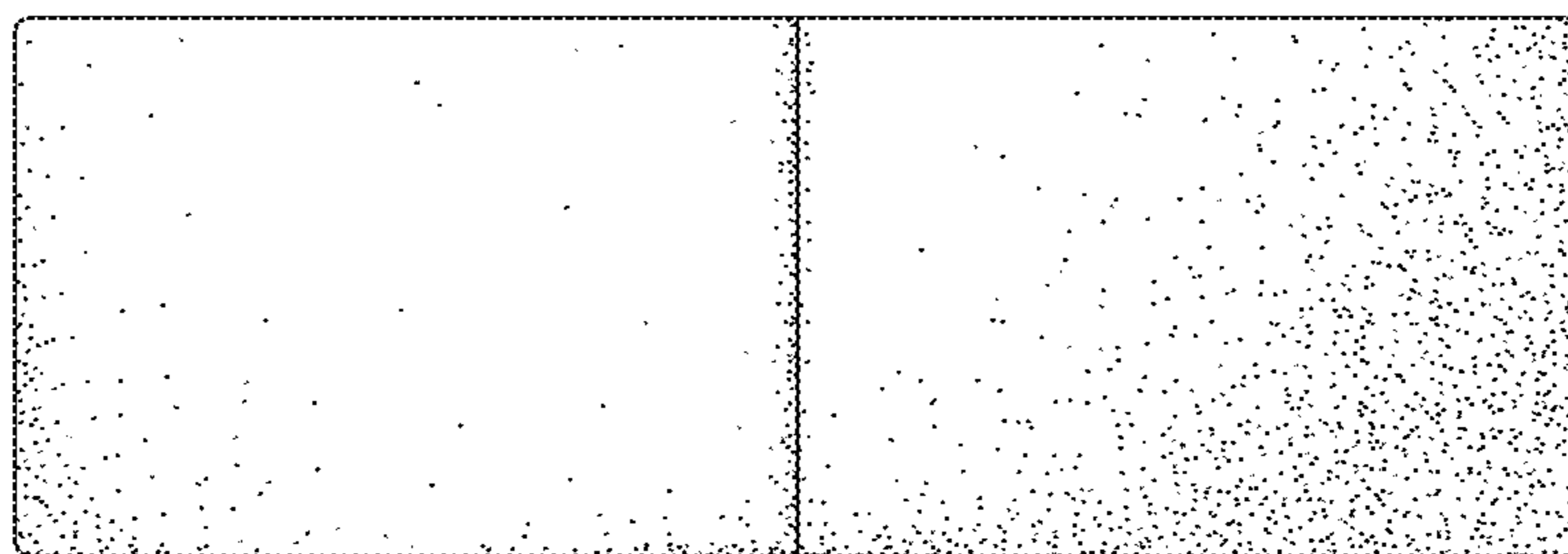

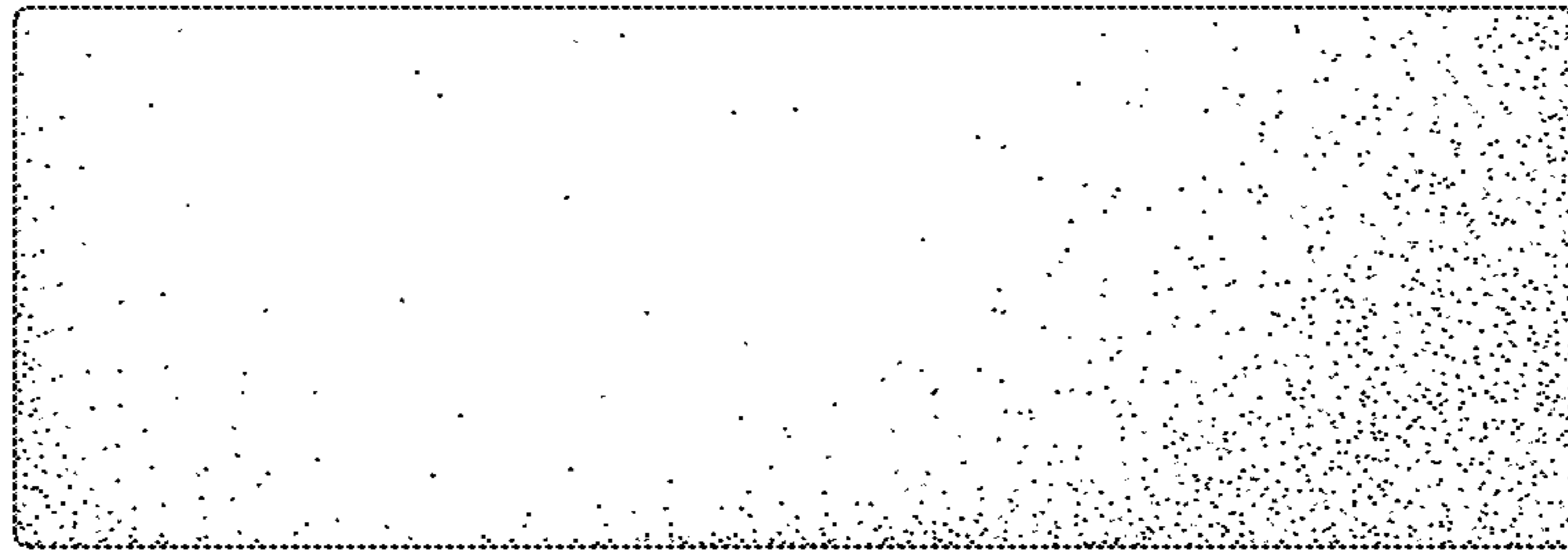

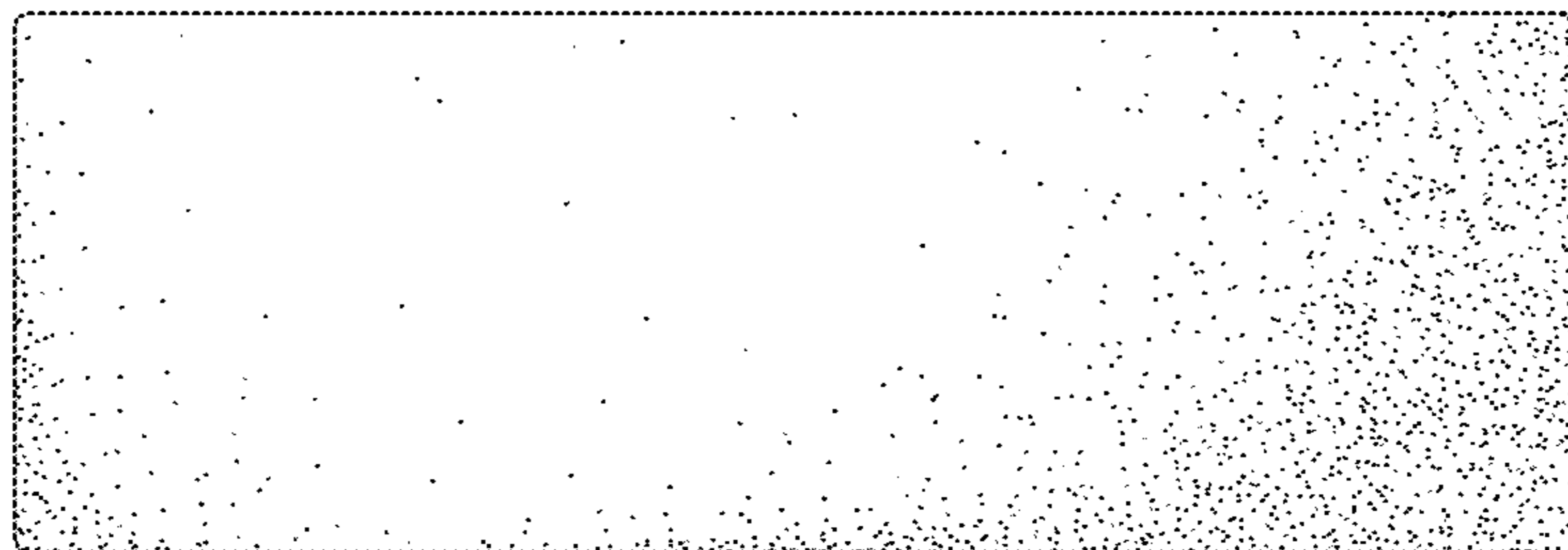

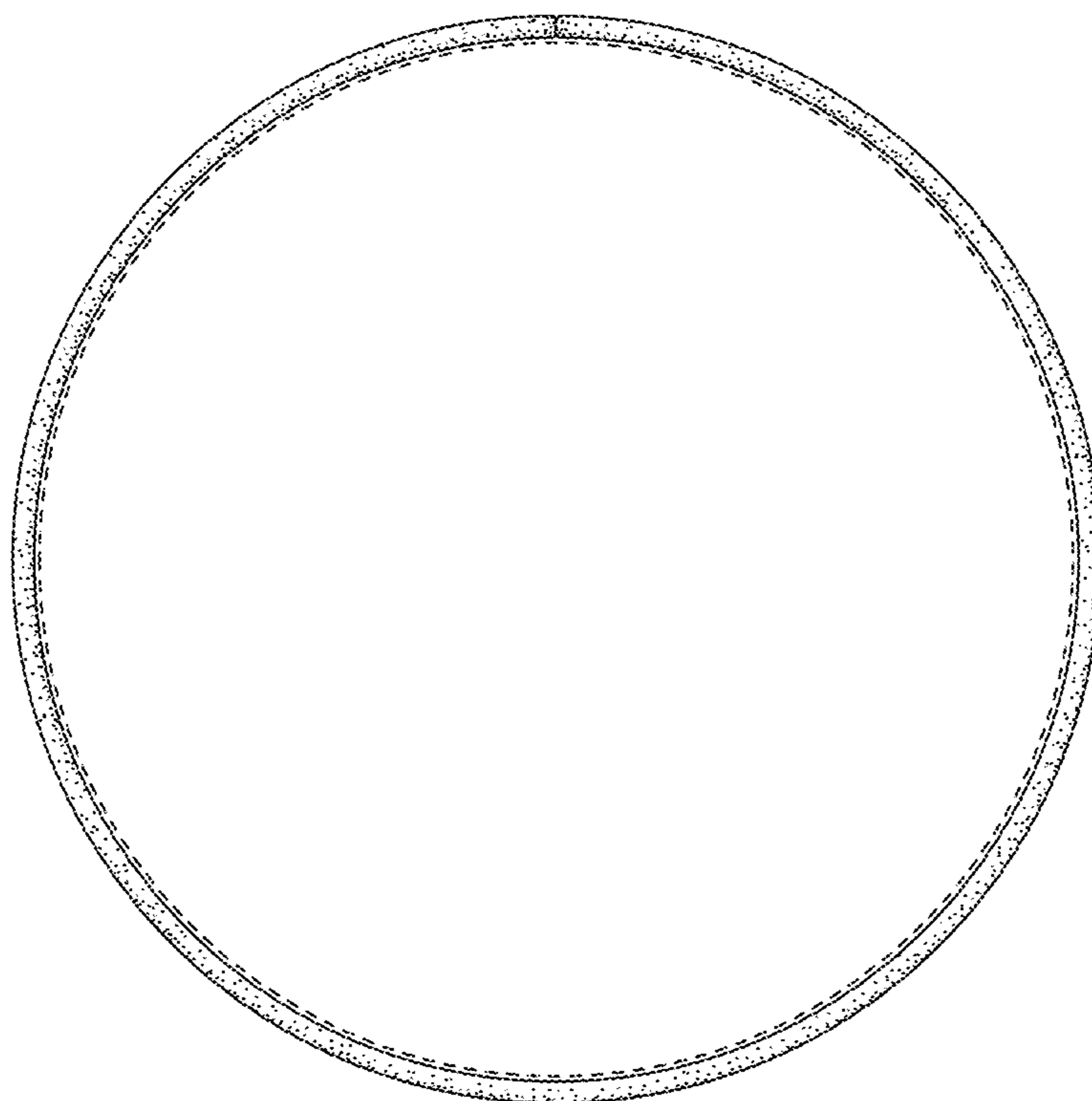

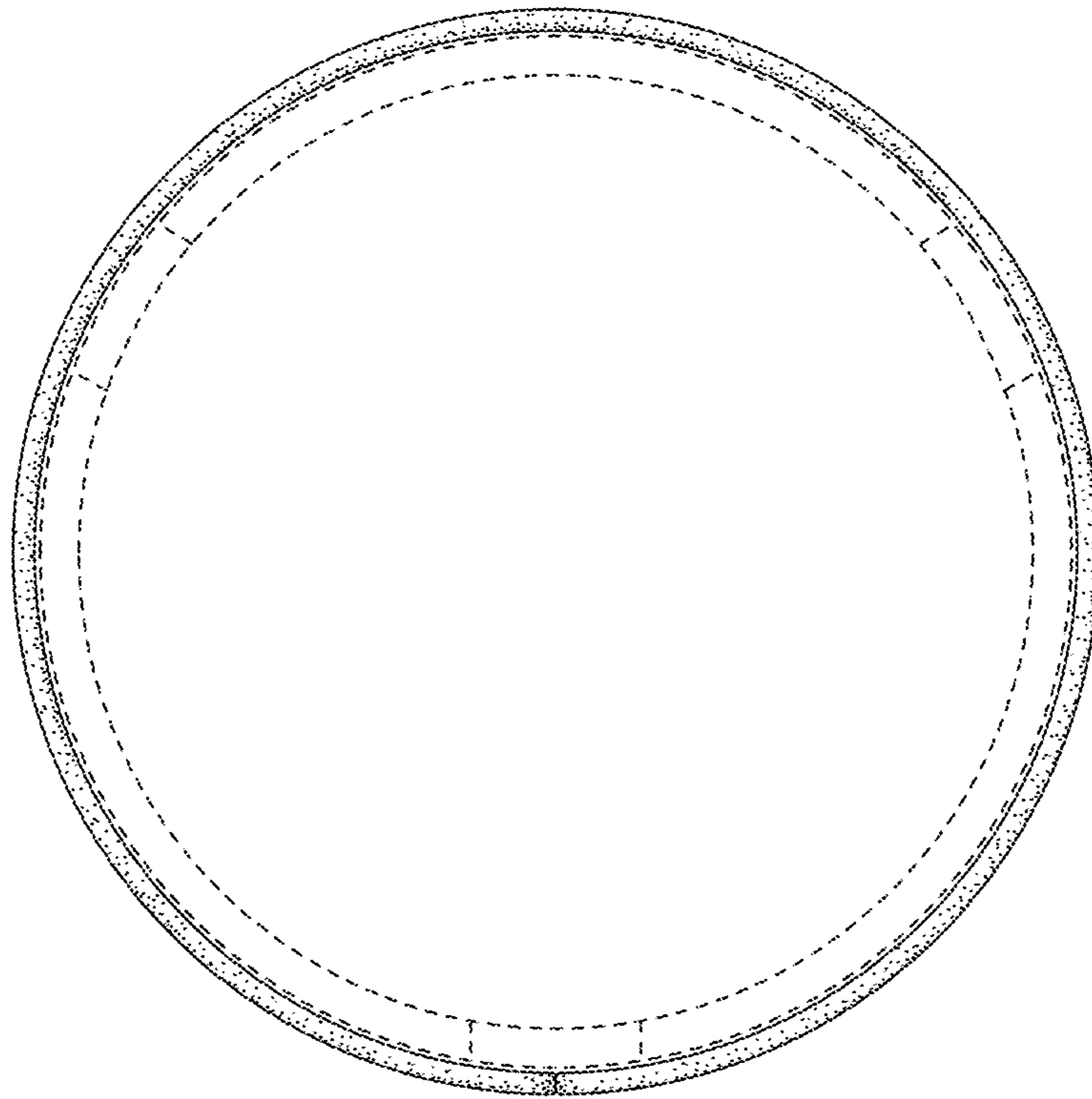
